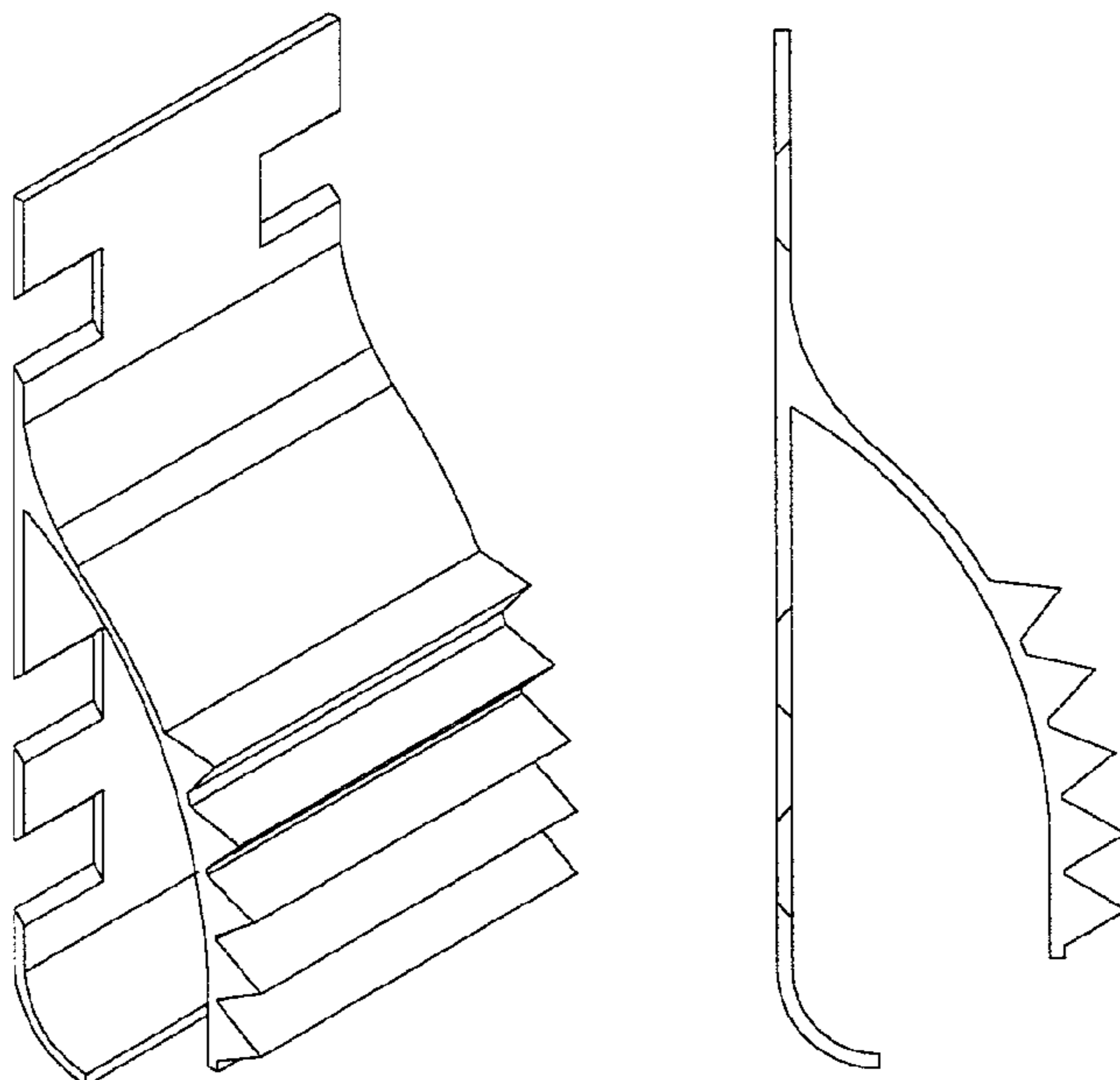
(57) **CLAIM**

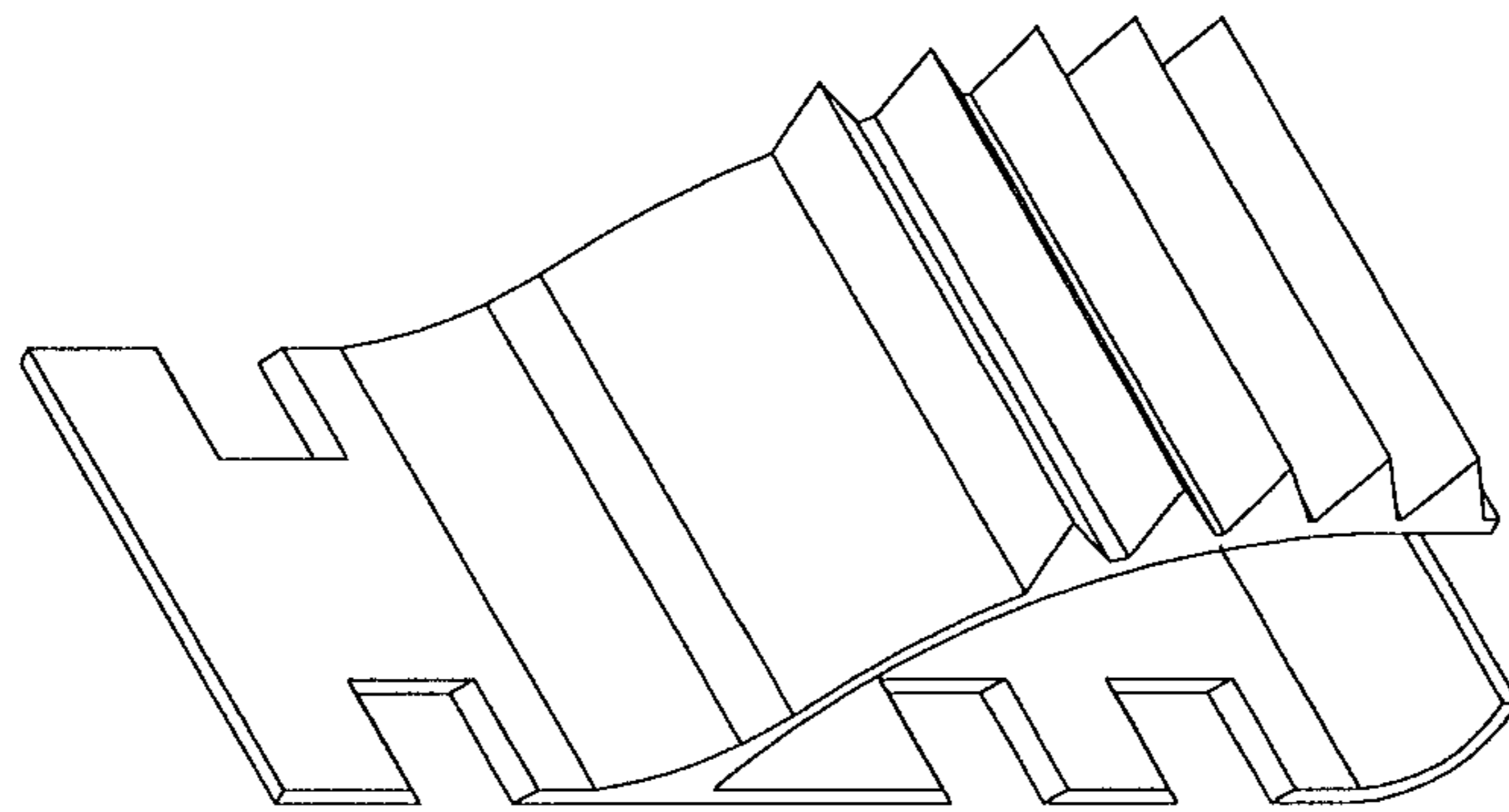
The ornamental design for a sink clip, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a sink clip in accordance with the subject invention;  
FIG. 2 is a side view of the sink clip of FIG. 1;

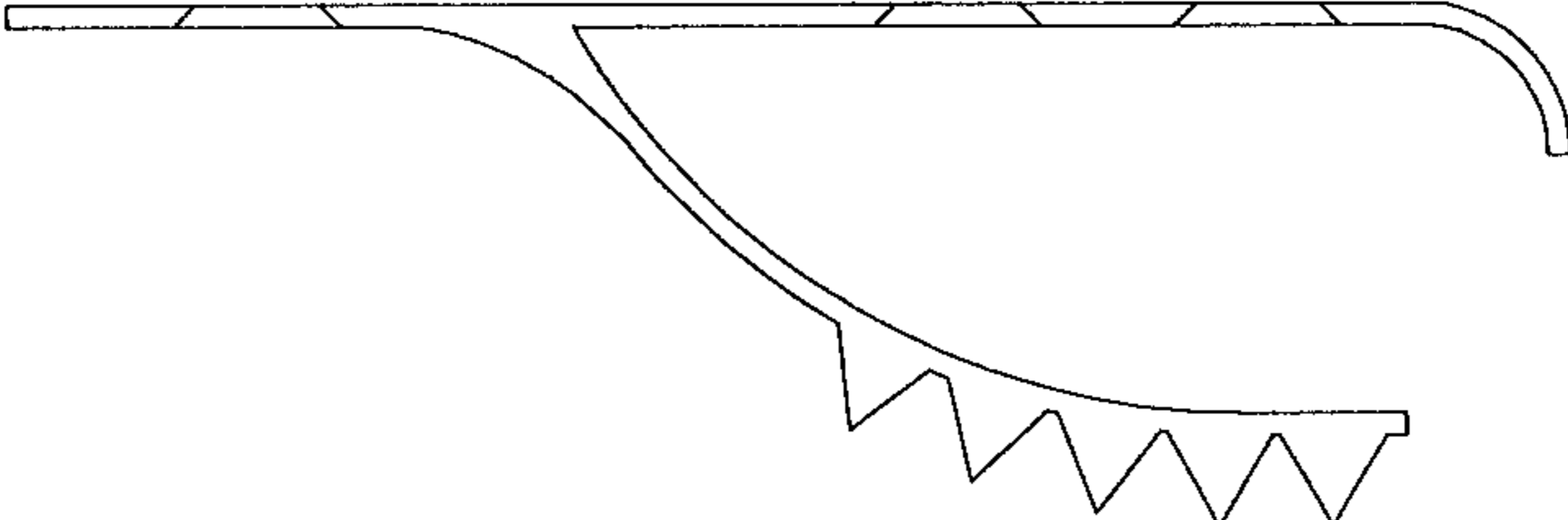

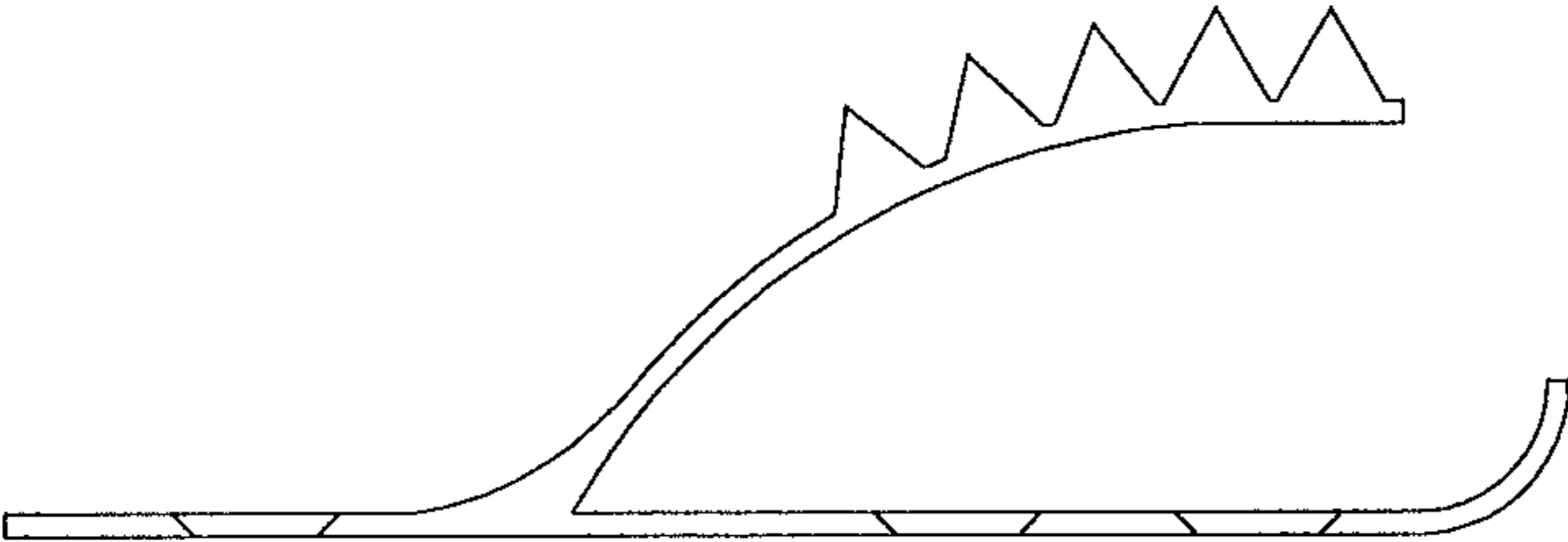

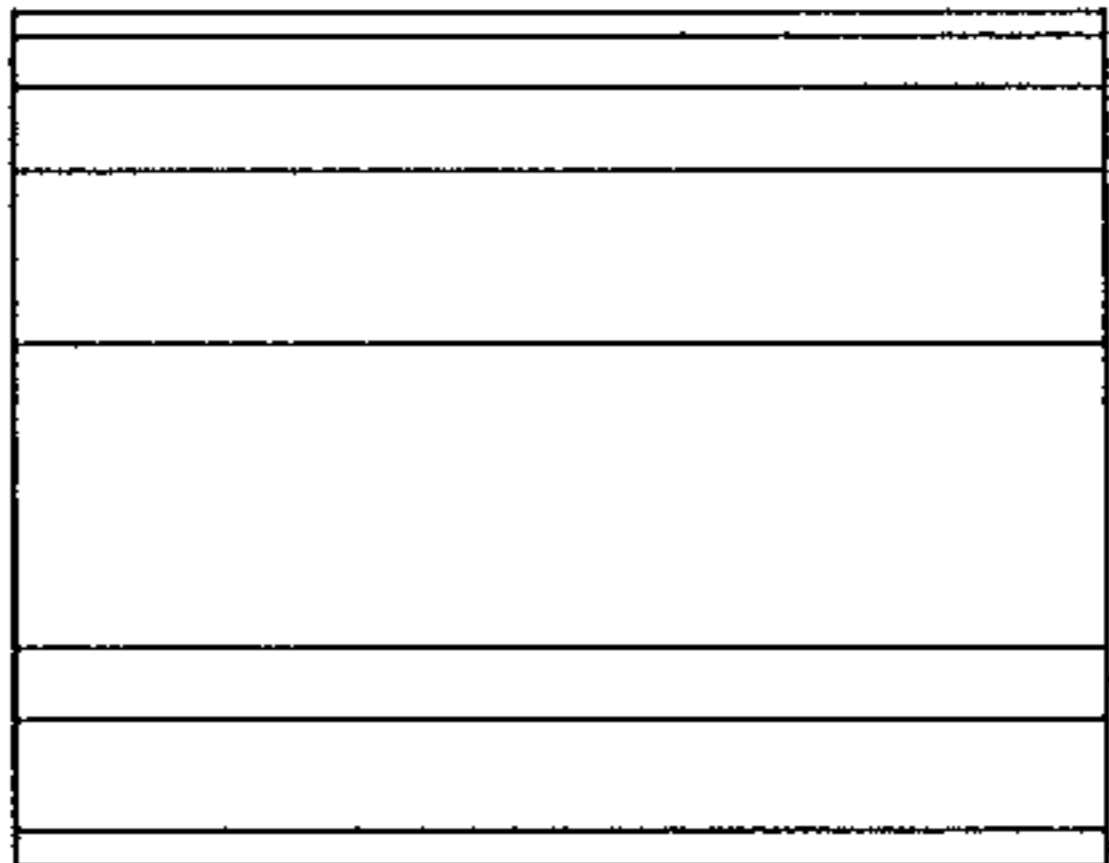

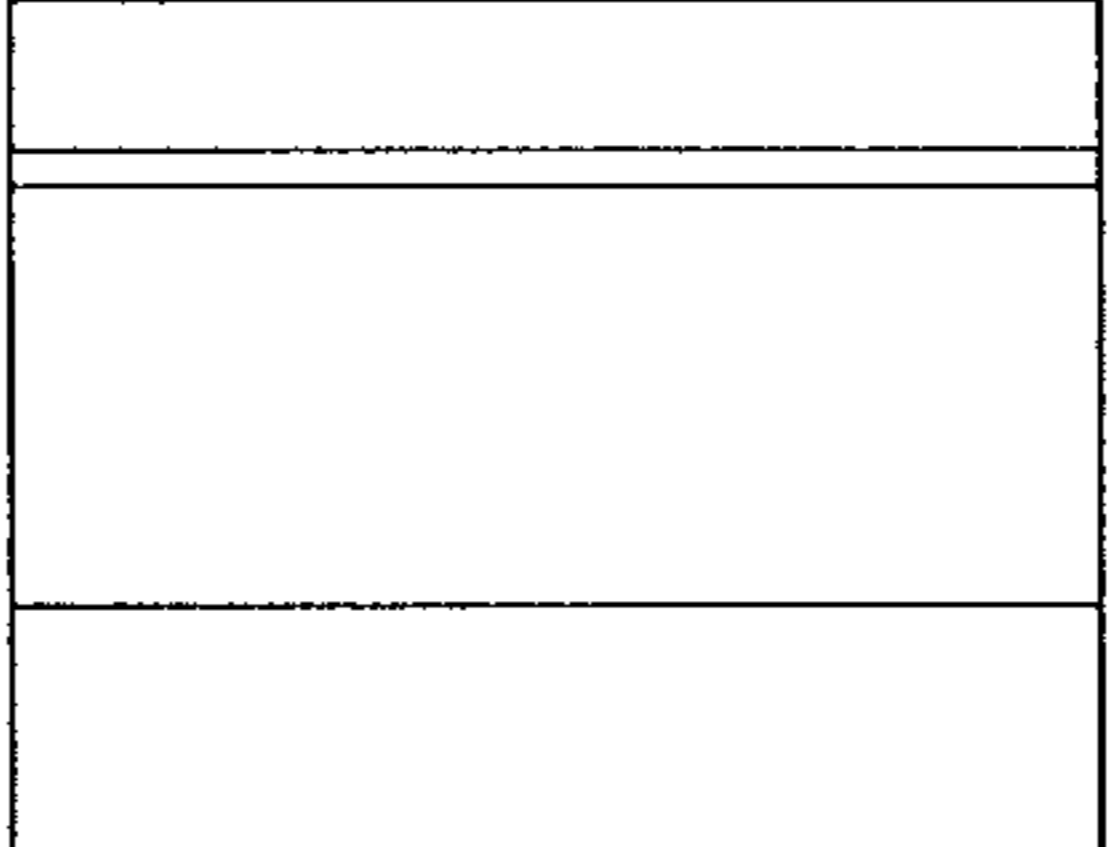

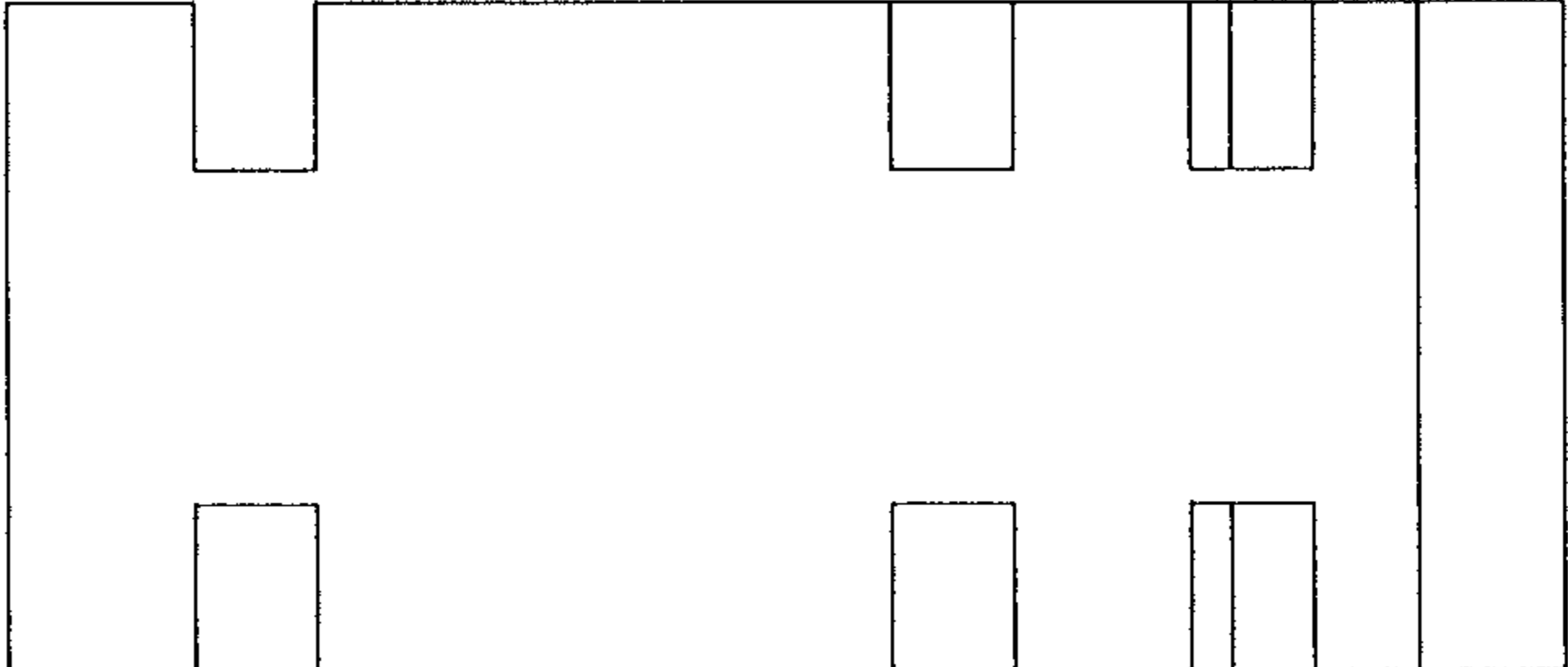
