(57) **CLAIM**

The ornamental design for a connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of the first embodiment of a connector showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front, top and right side perspective view of the second embodiment of a connector showing our new design; FIG. 9 is a front elevation view of the connector of FIG. 8; FIG. 10 is a rear elevation view of the connector of FIG. 8; FIG. 11 is a left side elevation view of the connector of FIG. 8; FIG. 12 is a right side elevation view of the connector of FIG. 8; FIG. 13 is a top plan view of the connector of FIG. 8; and, FIG. 14 is a bottom plan view of the connector of FIG. 8.

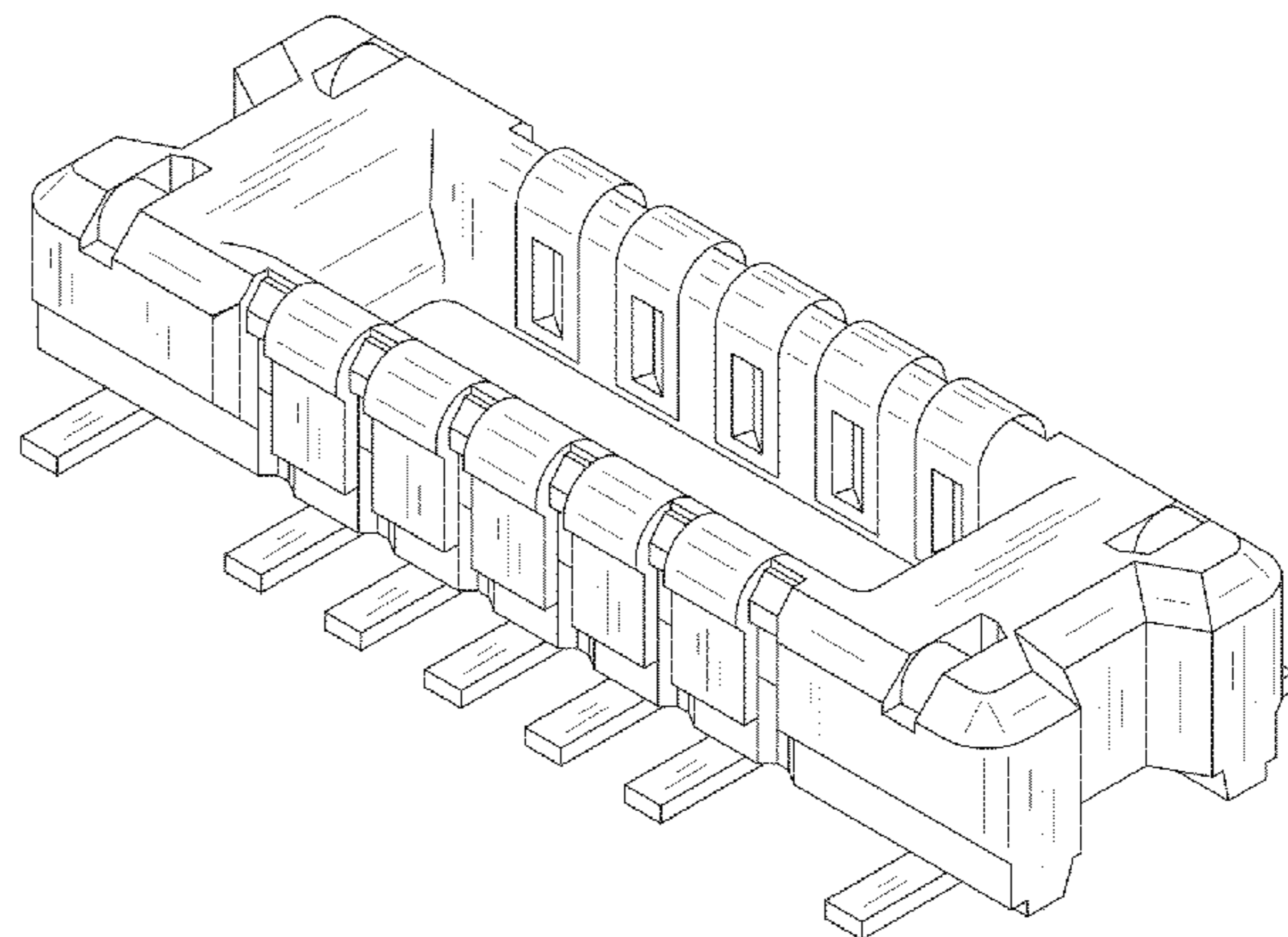
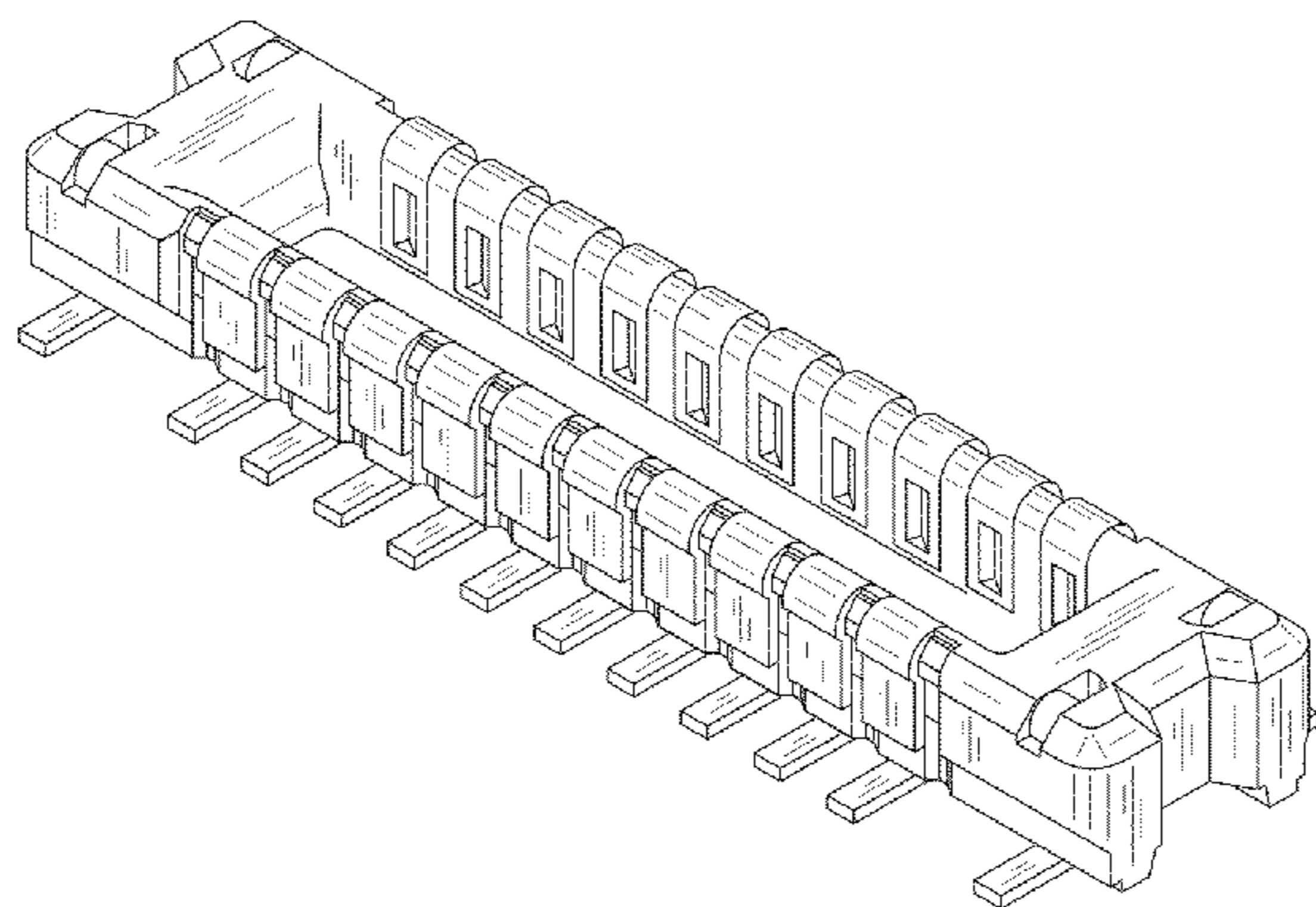

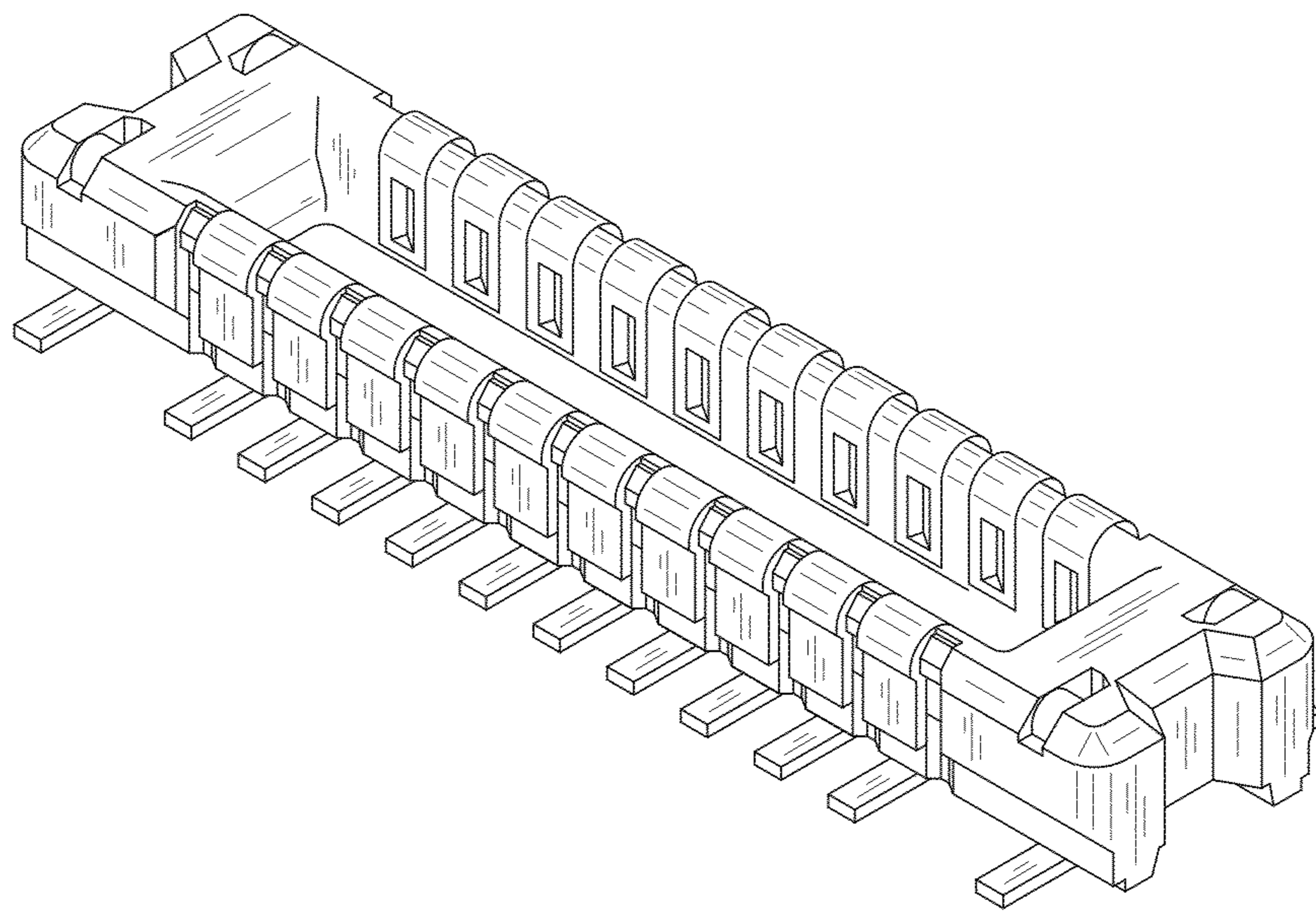

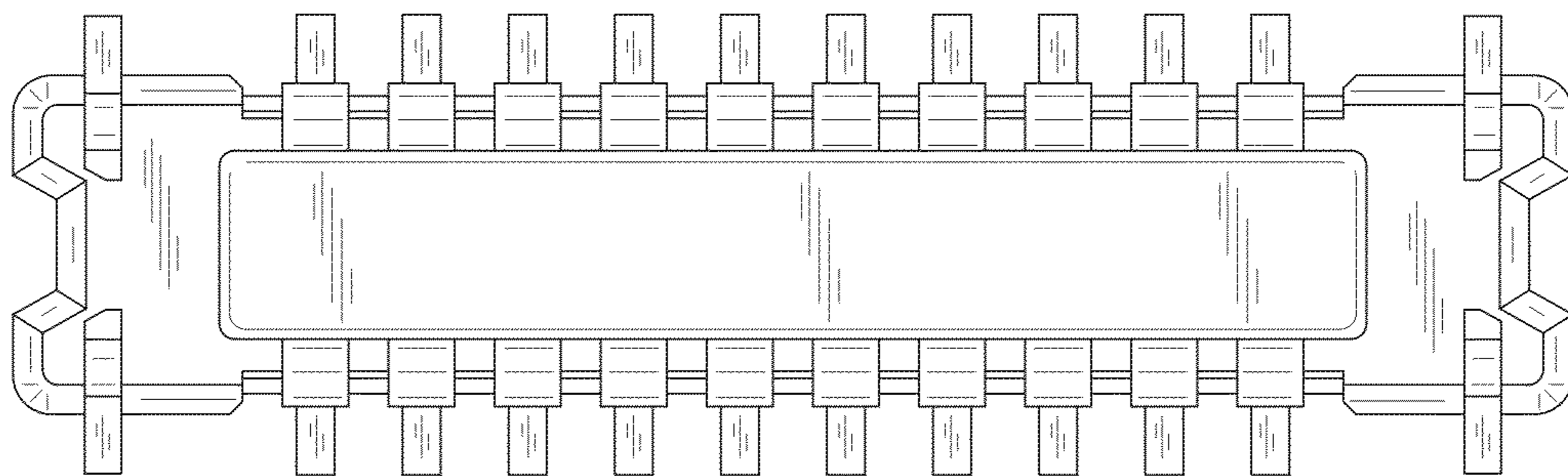

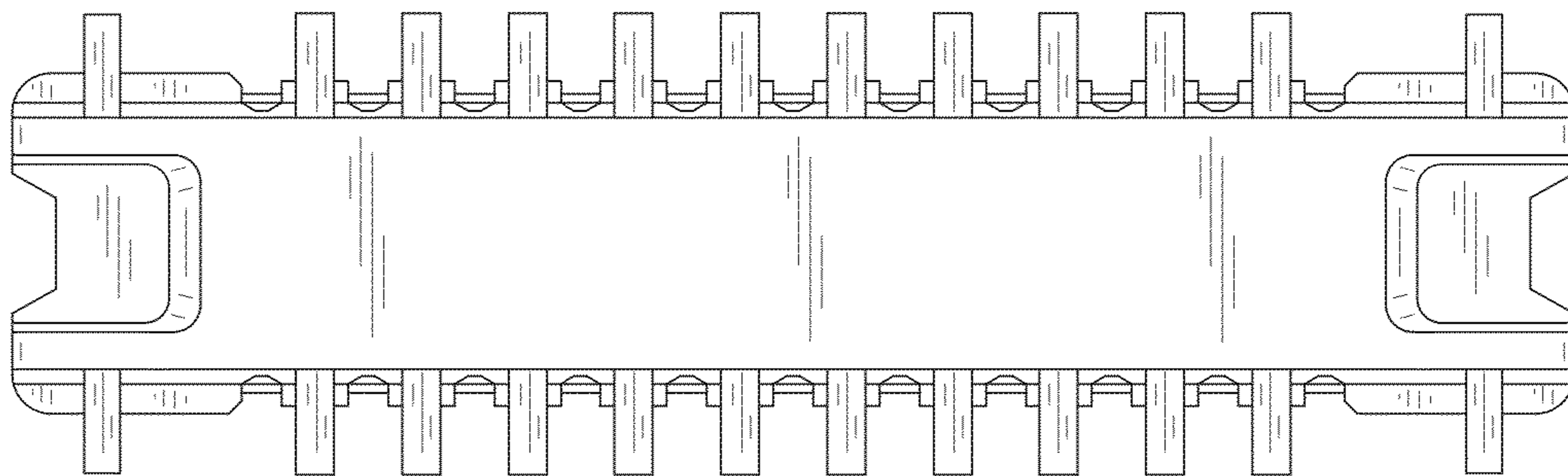

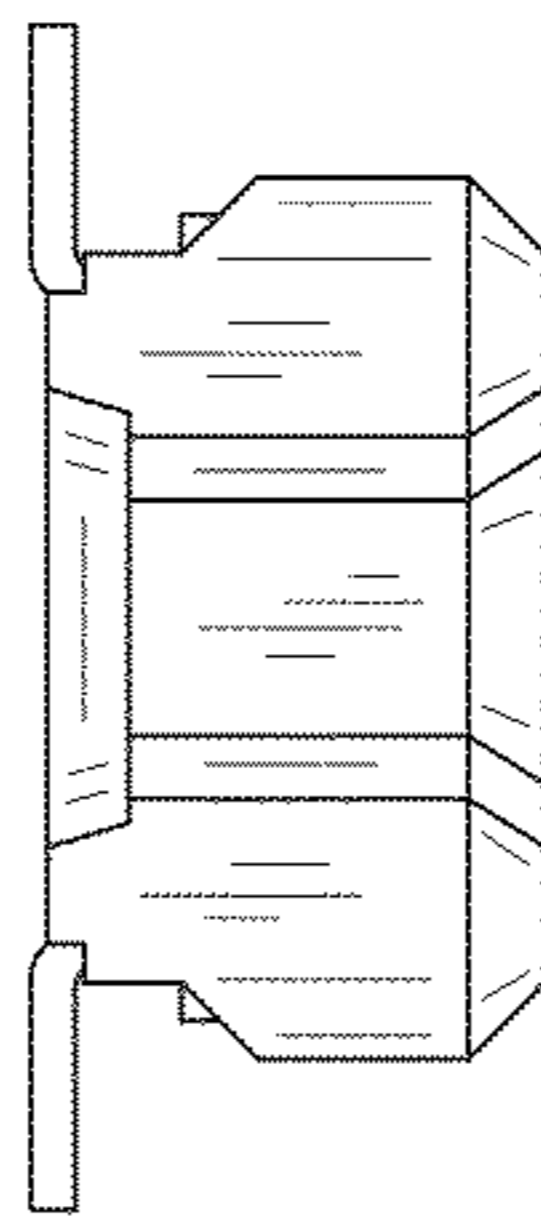

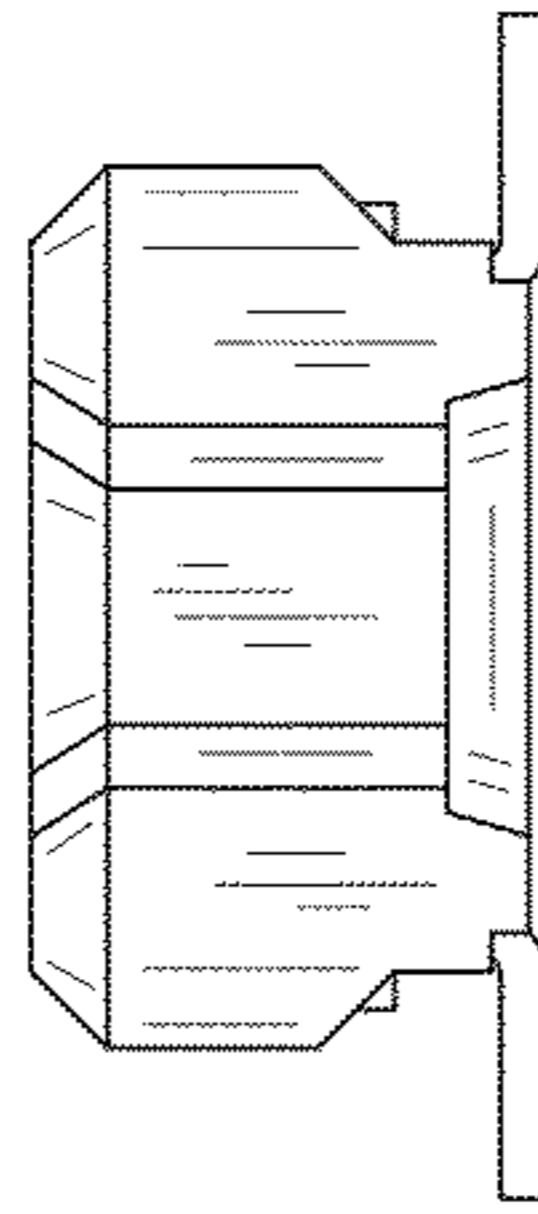

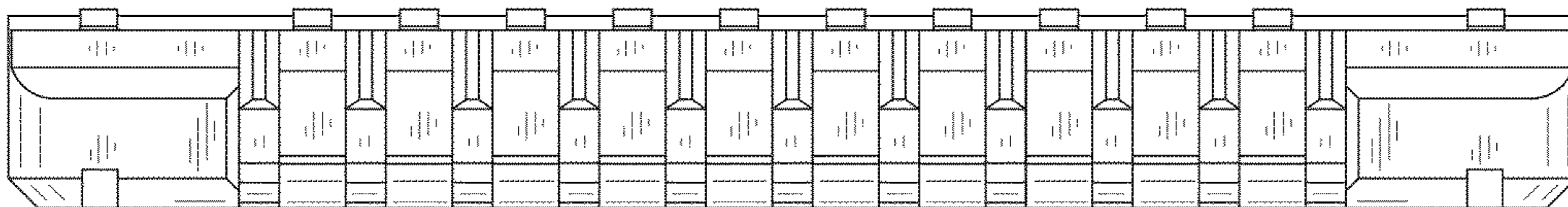

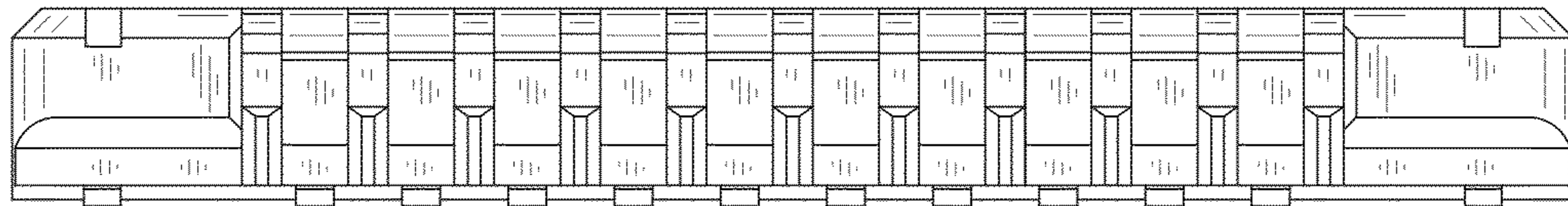

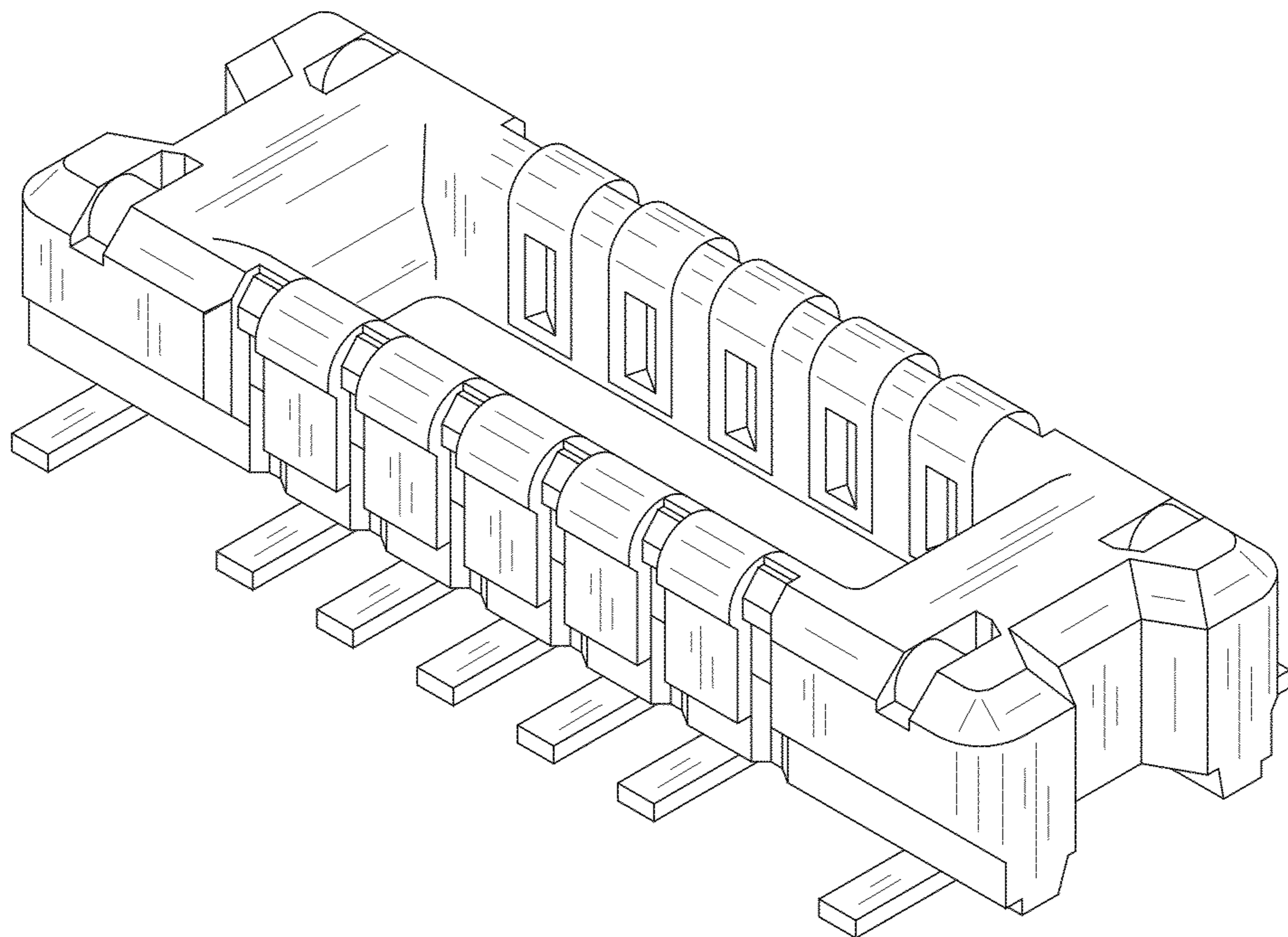

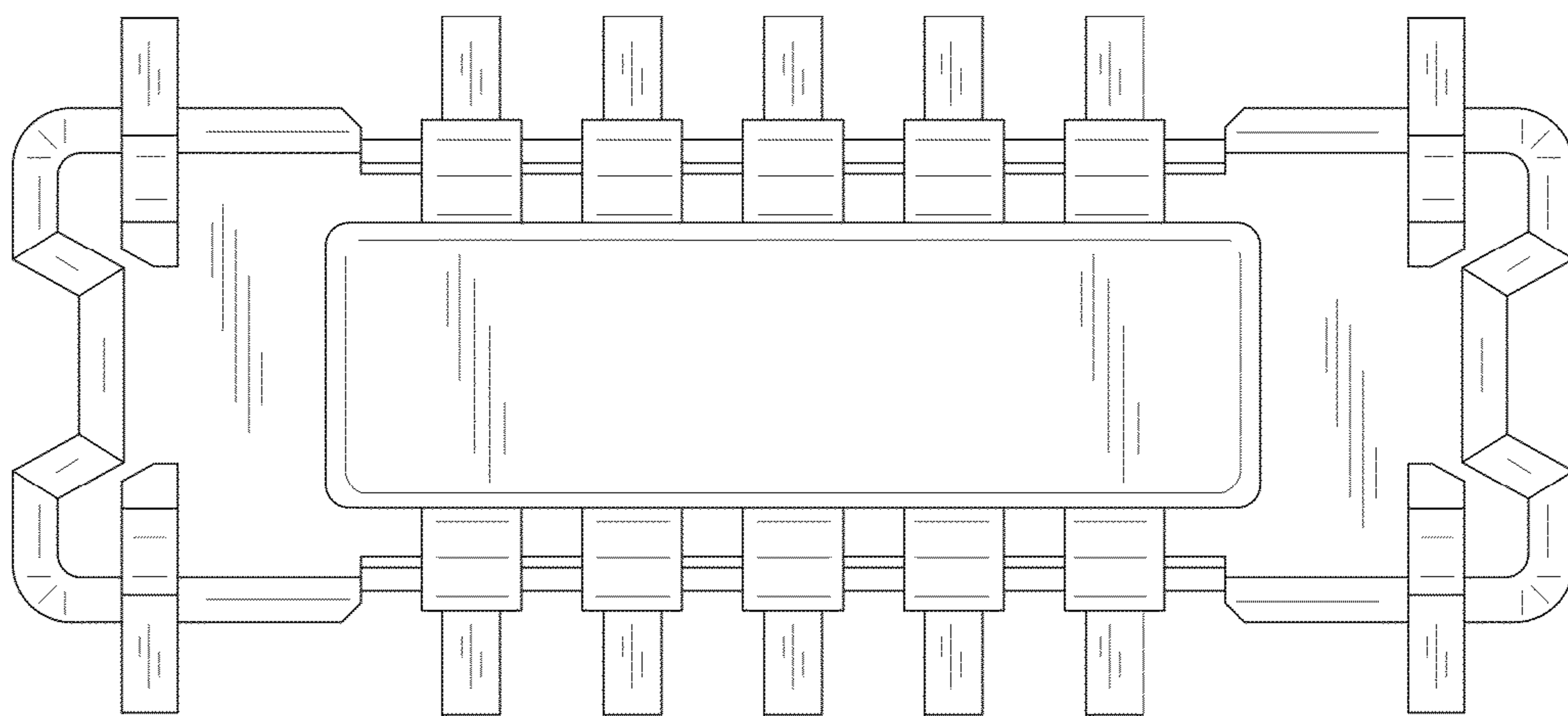

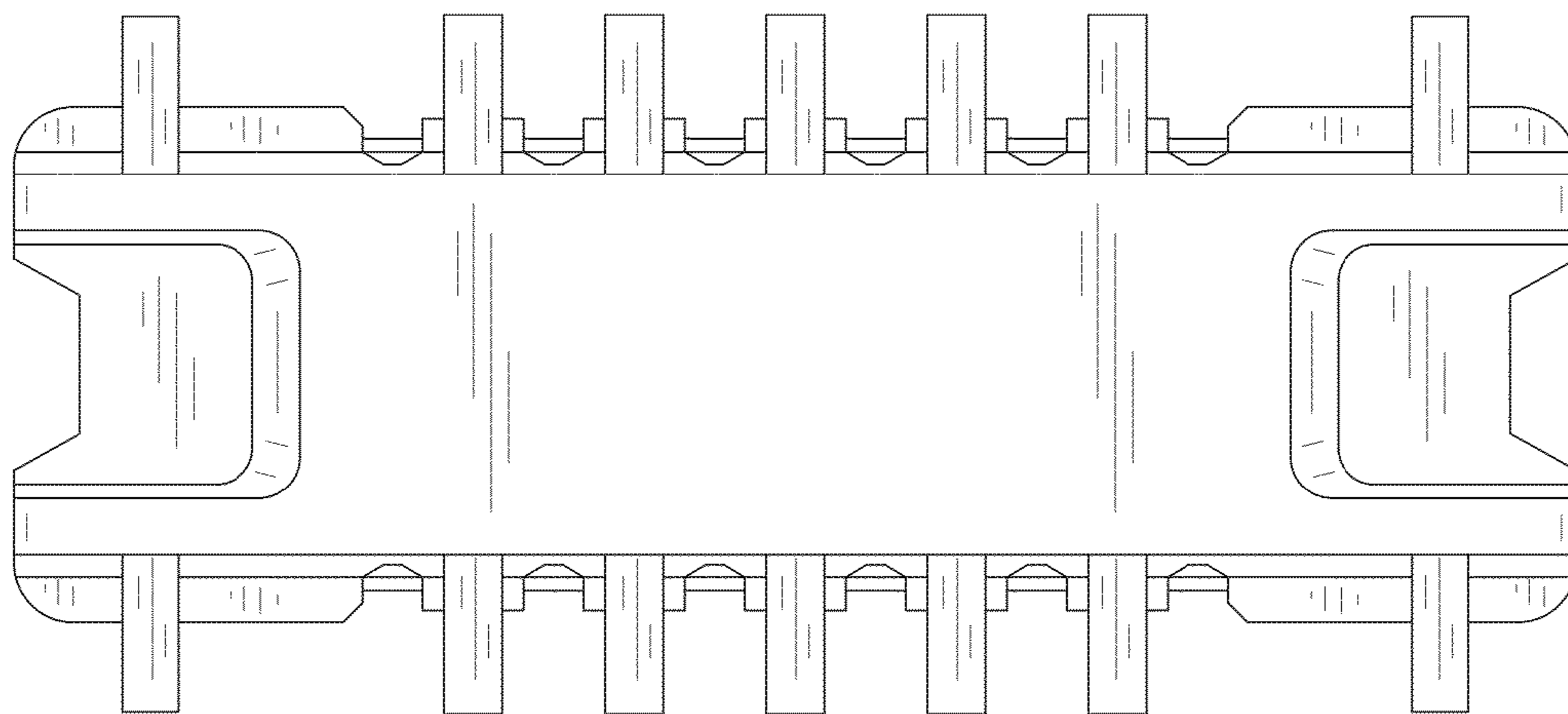

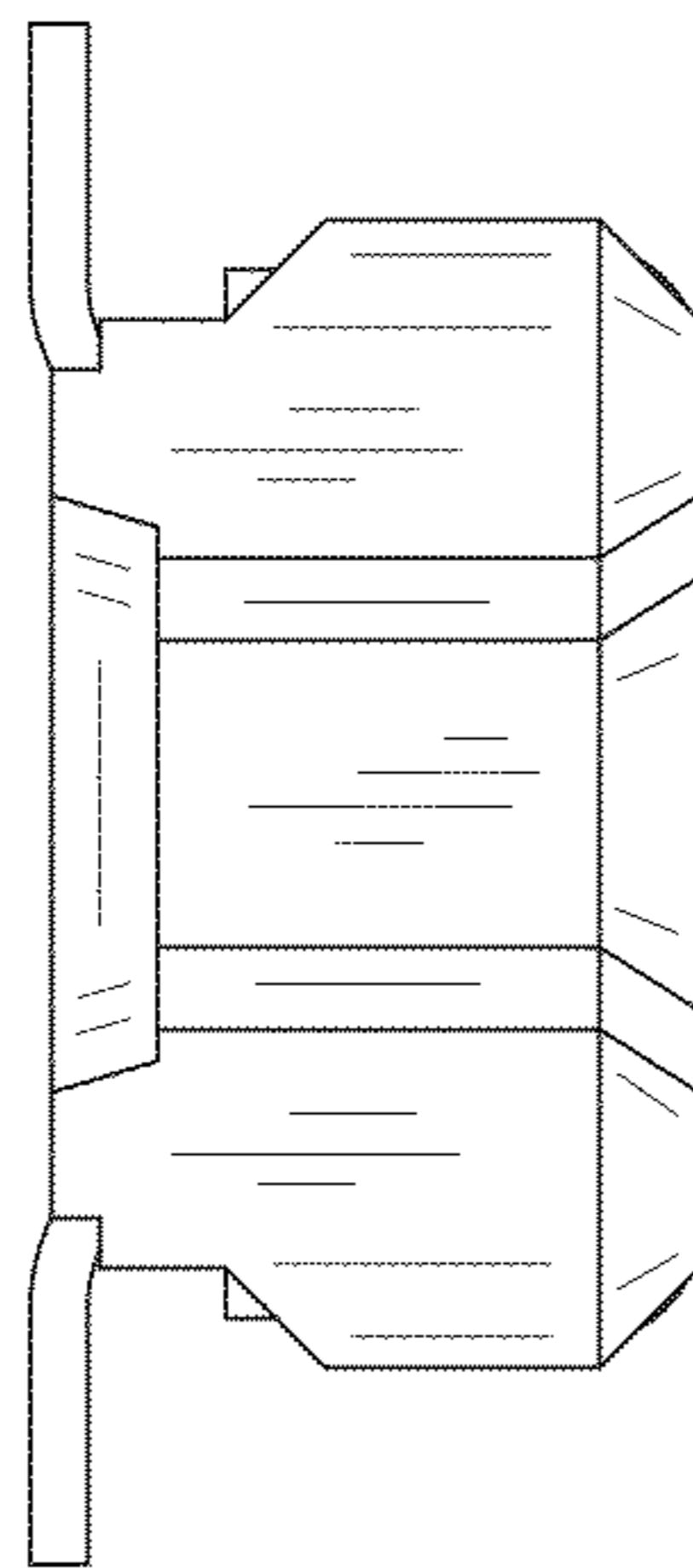

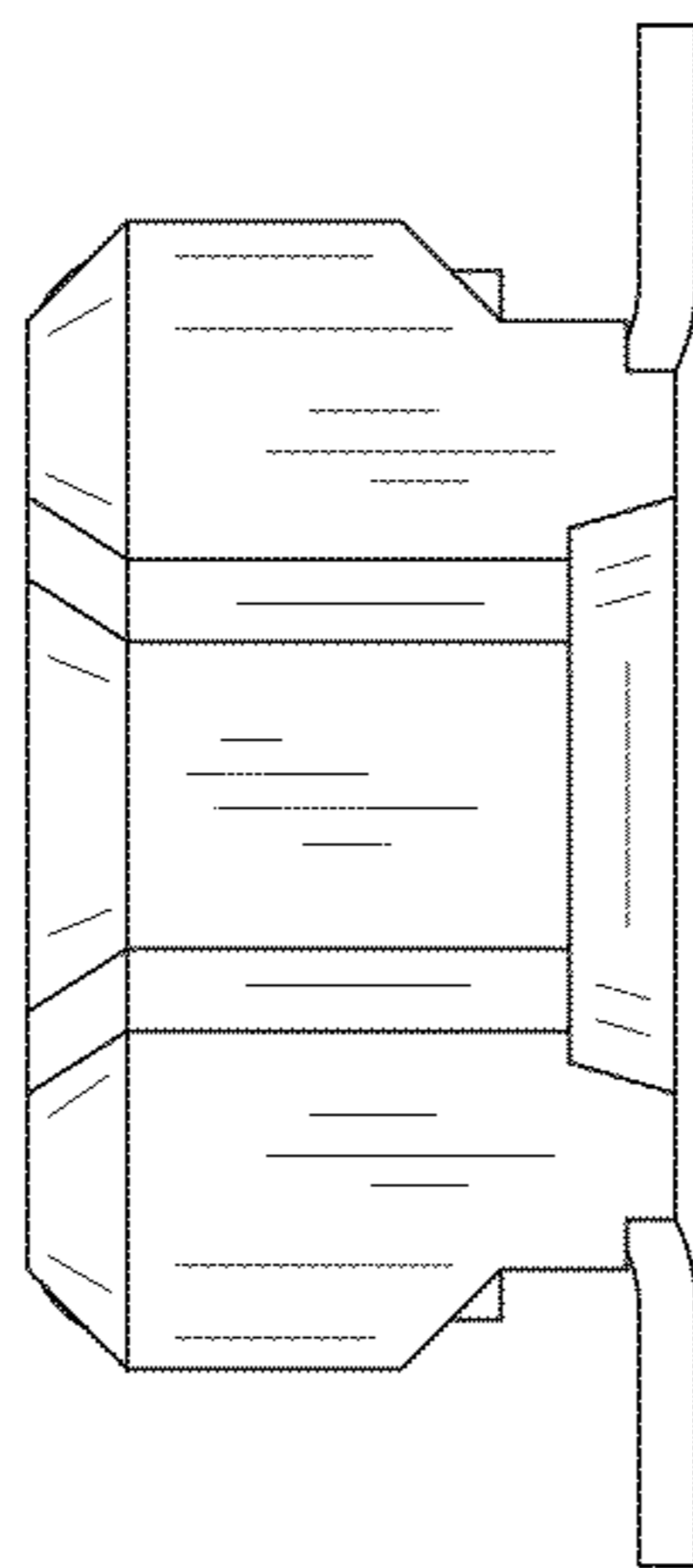

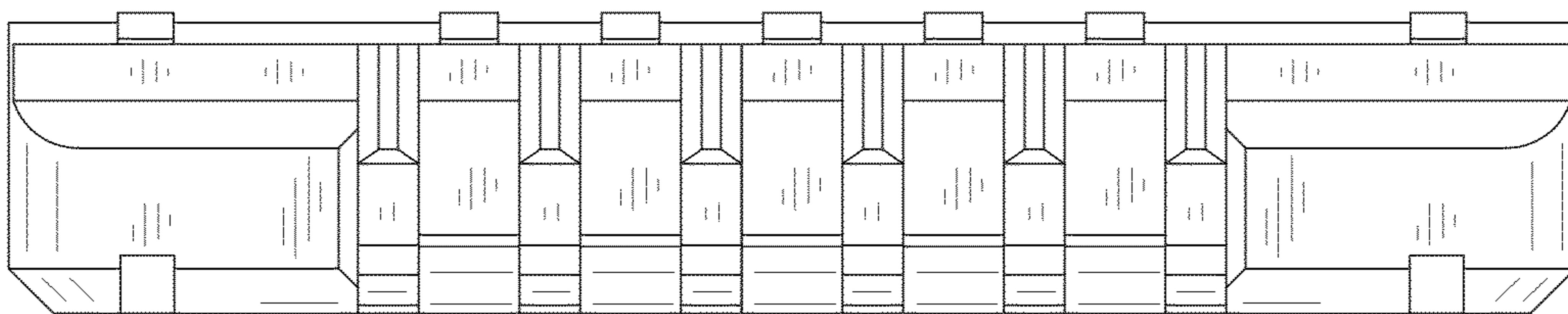
