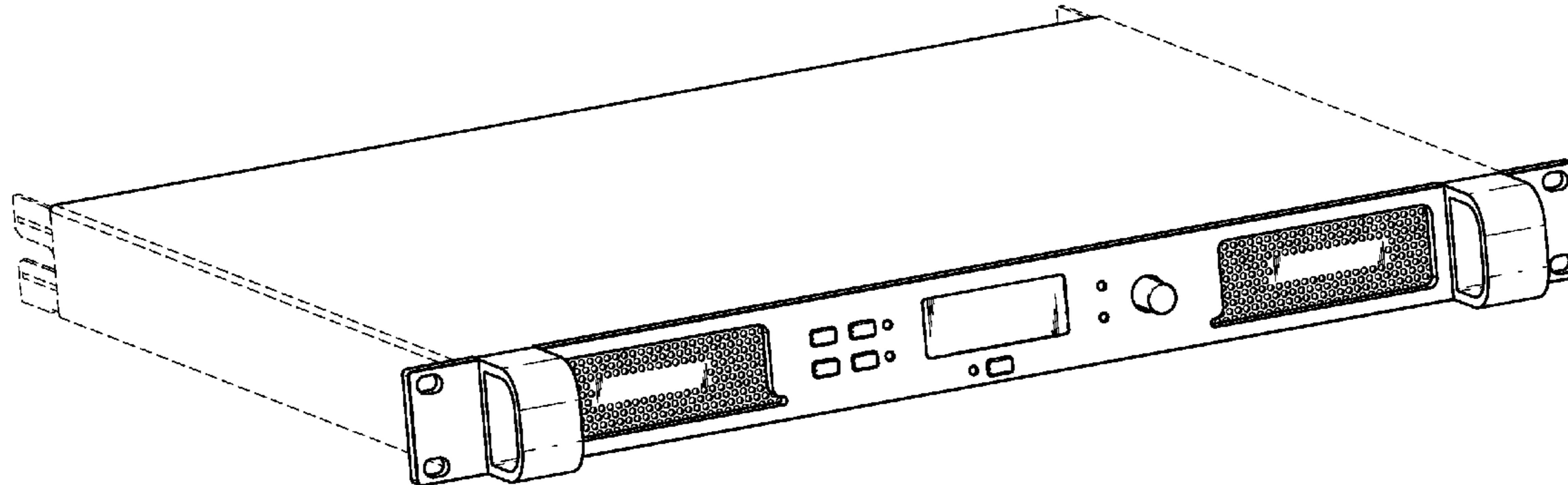
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a sound amplifier showing my new design.
FIG. 2 is a front elevational view thereof.
FIG. 3 is a rear elevational view thereof.
FIG. 4 is a top plan view thereof.
FIG. 5 is a bottom plan view thereof.
FIG. 6 is a right side elevational view thereof.

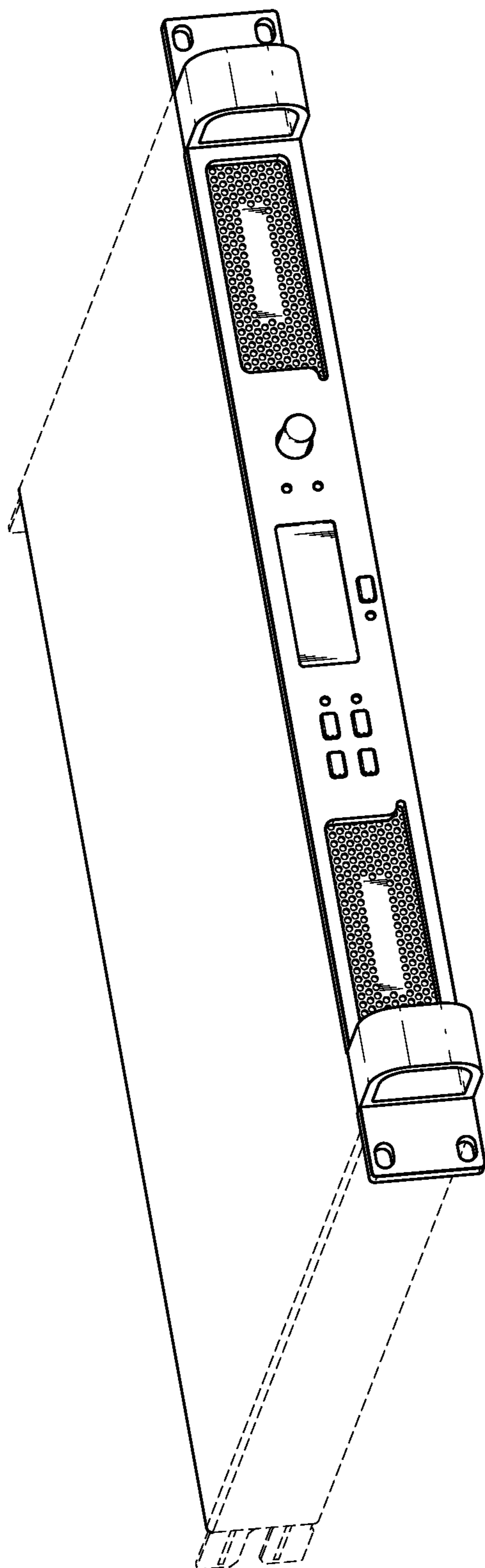

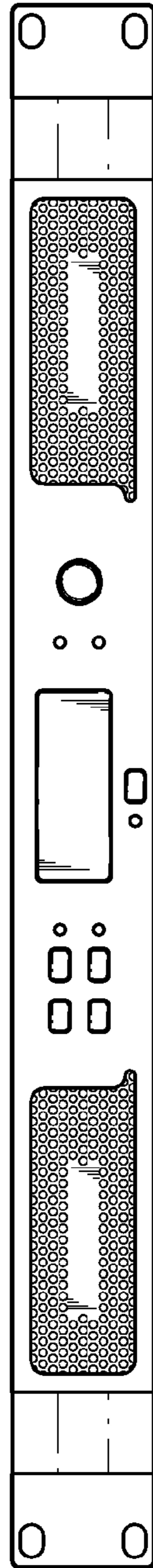

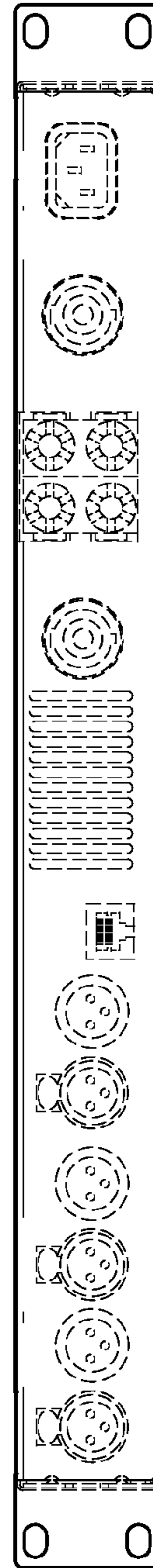

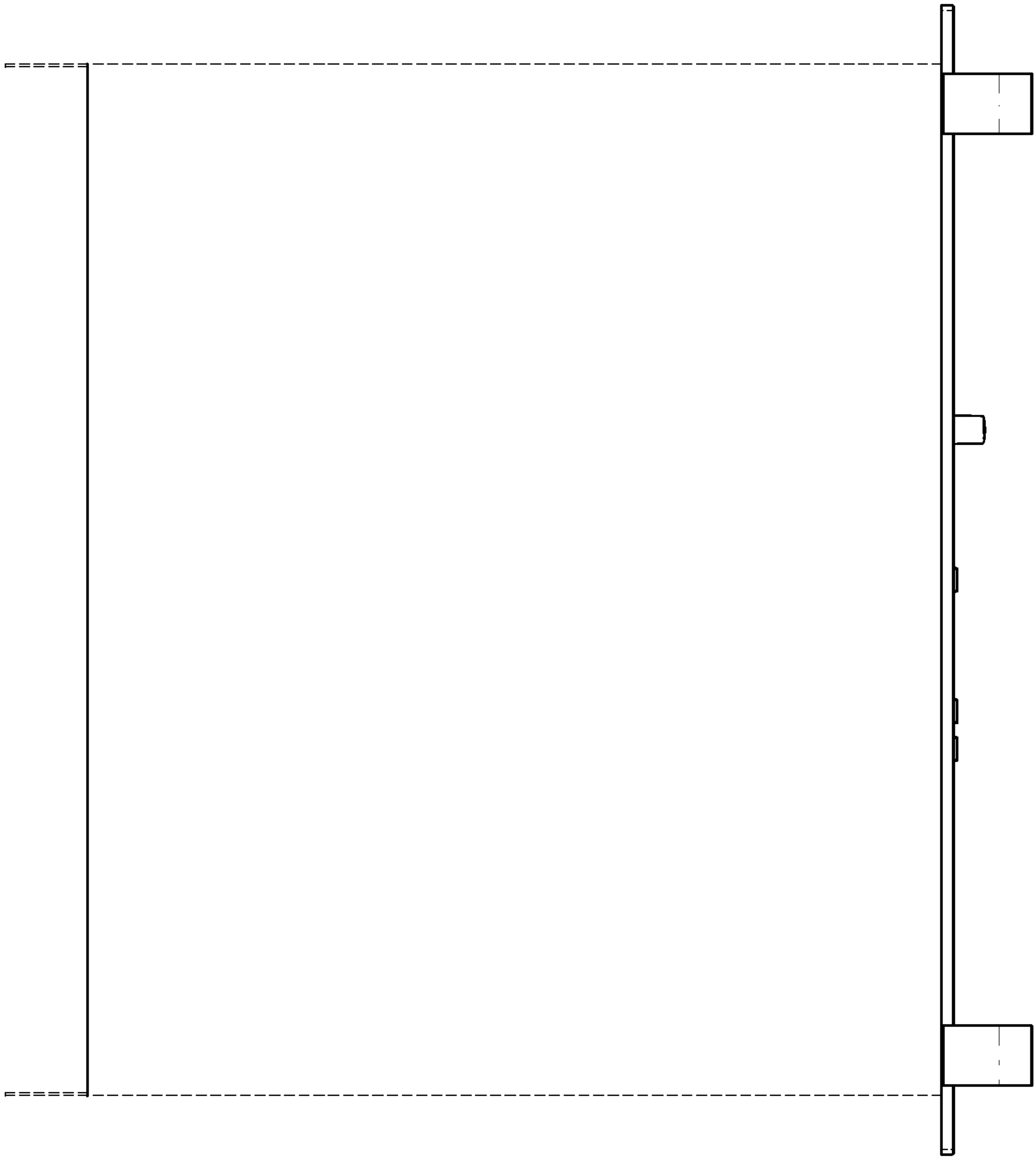

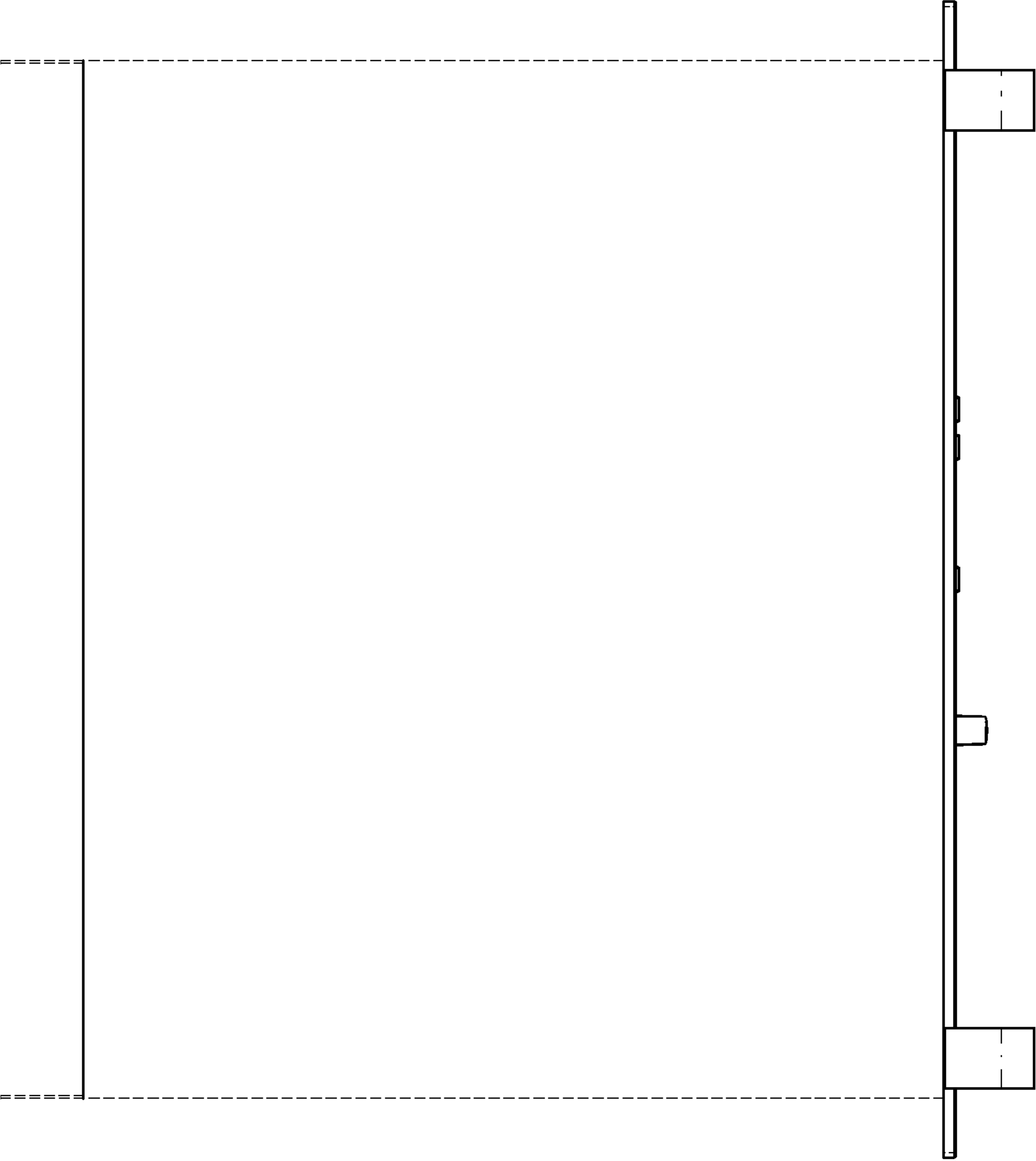

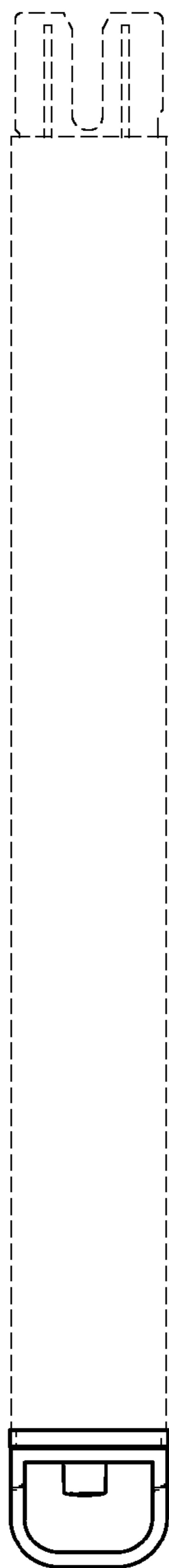

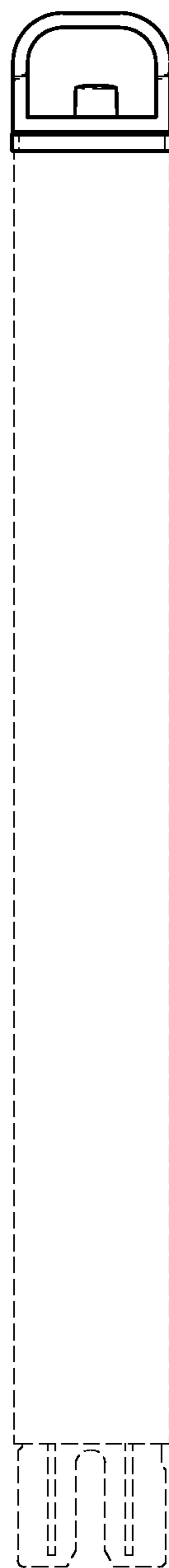

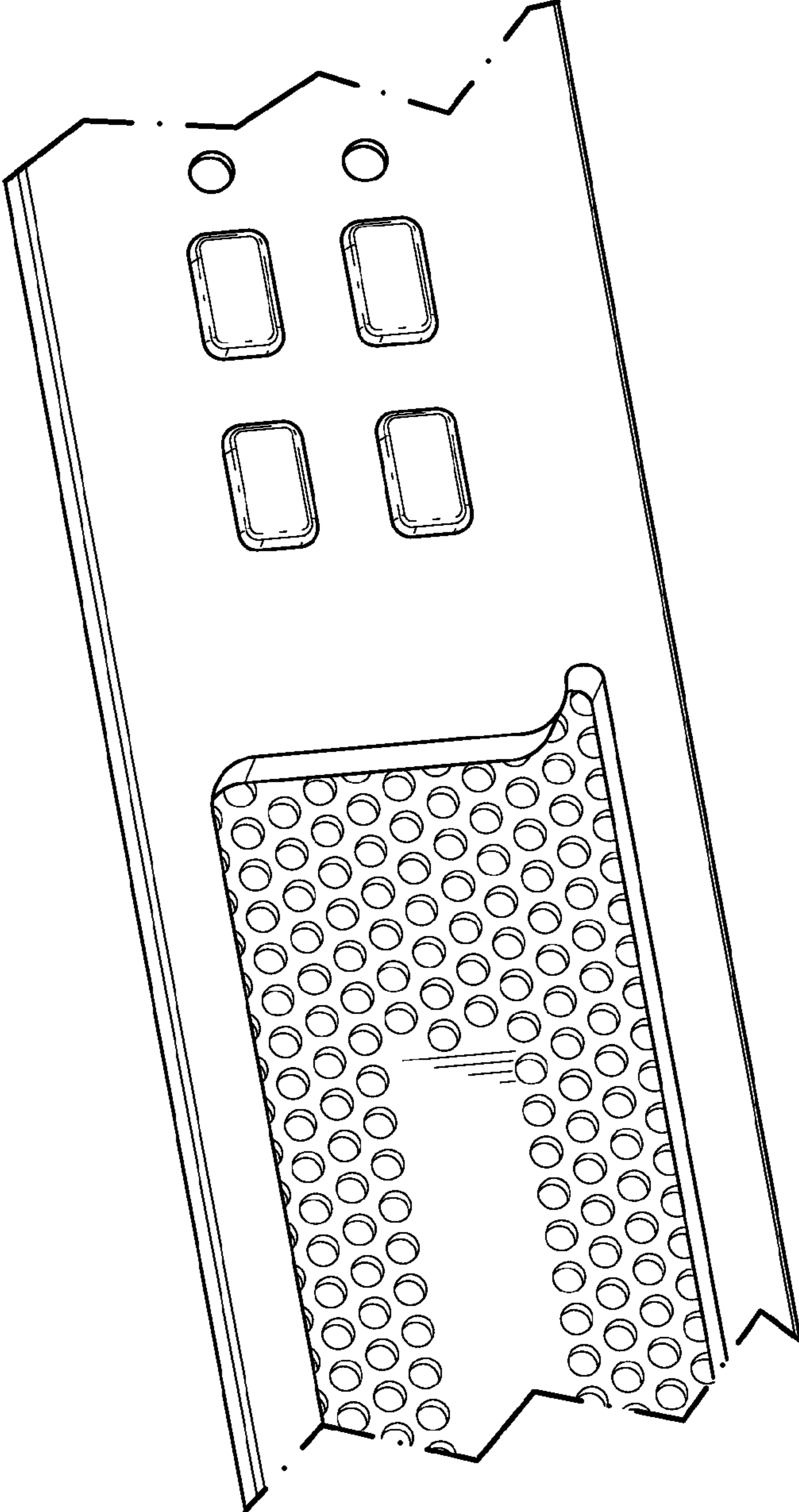
