We claim the ornamental design for a fitness equipment display screen with icon, as shown and described.

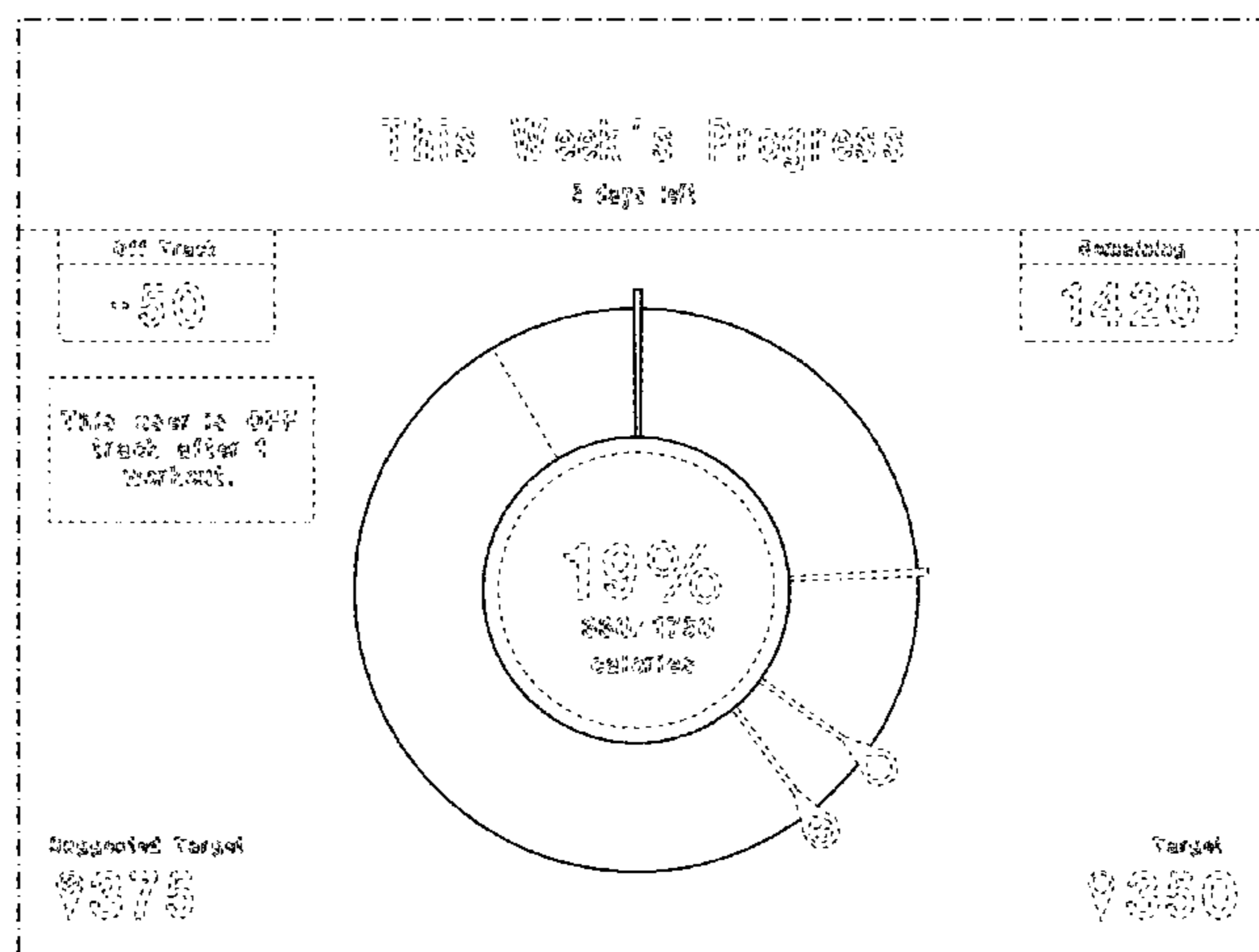
DESCRIPTION

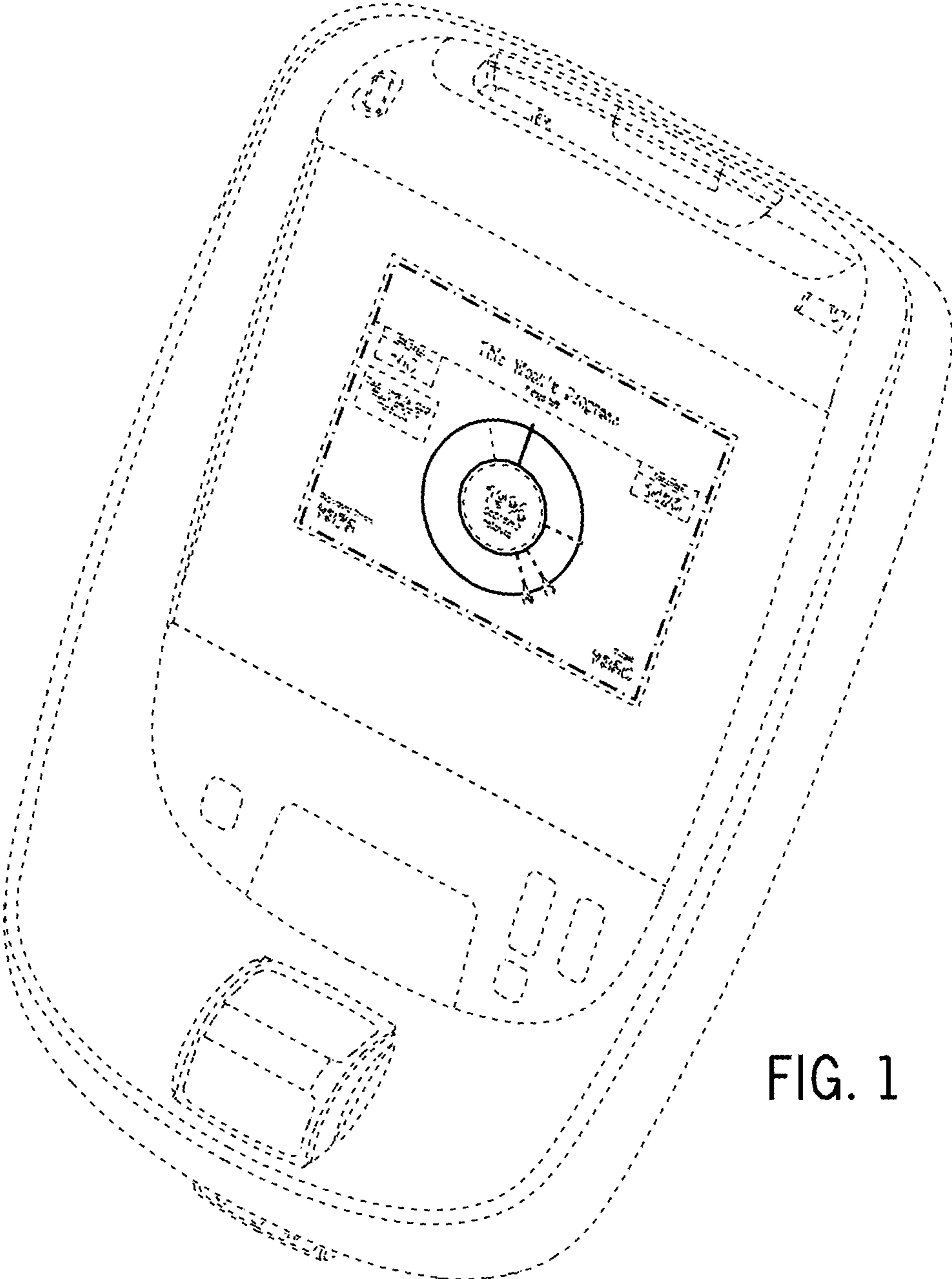

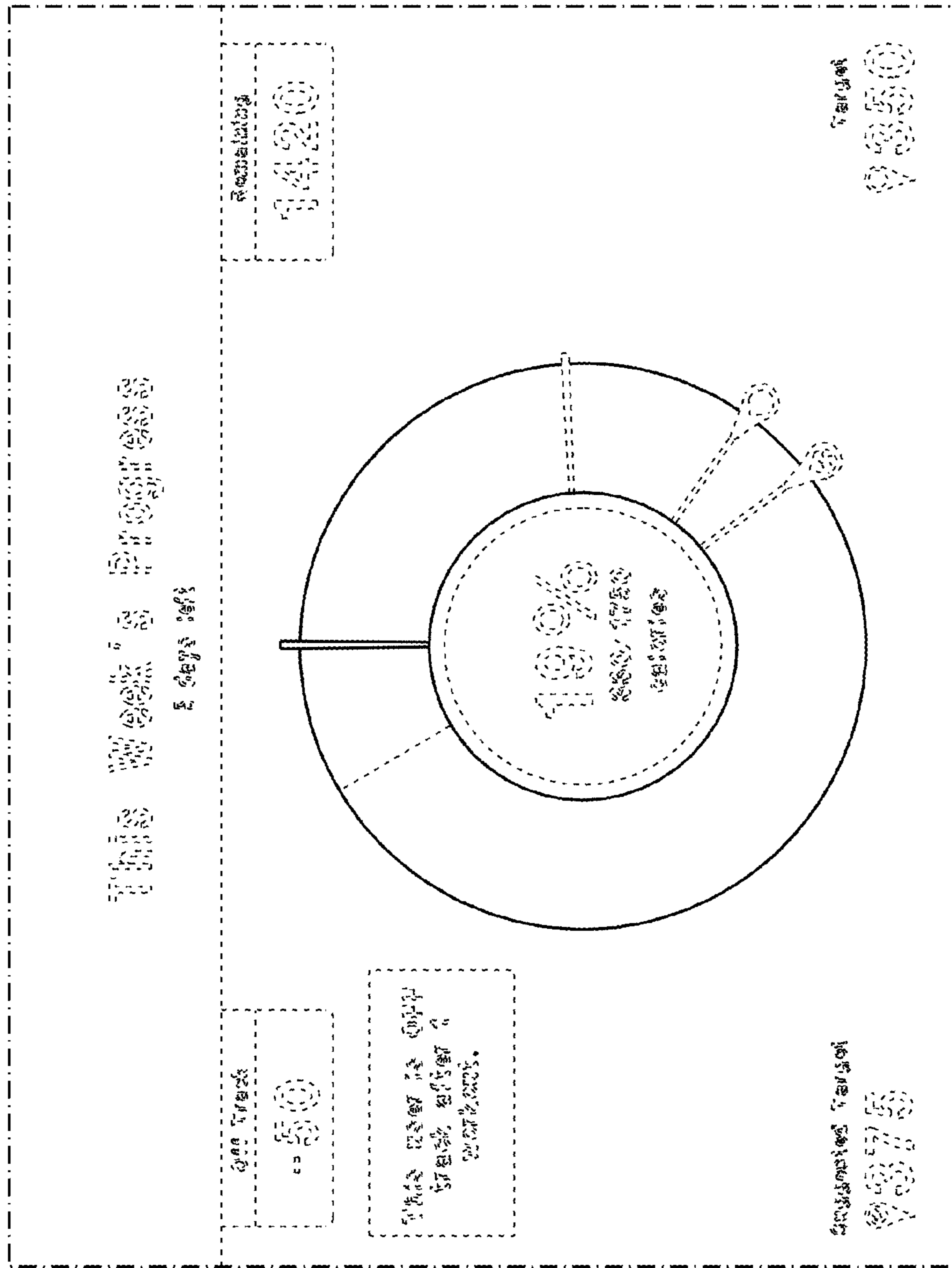
