DESCRIPTION

FIG. 1 is the front perspective view of a guide for refrigerator showing our new design;

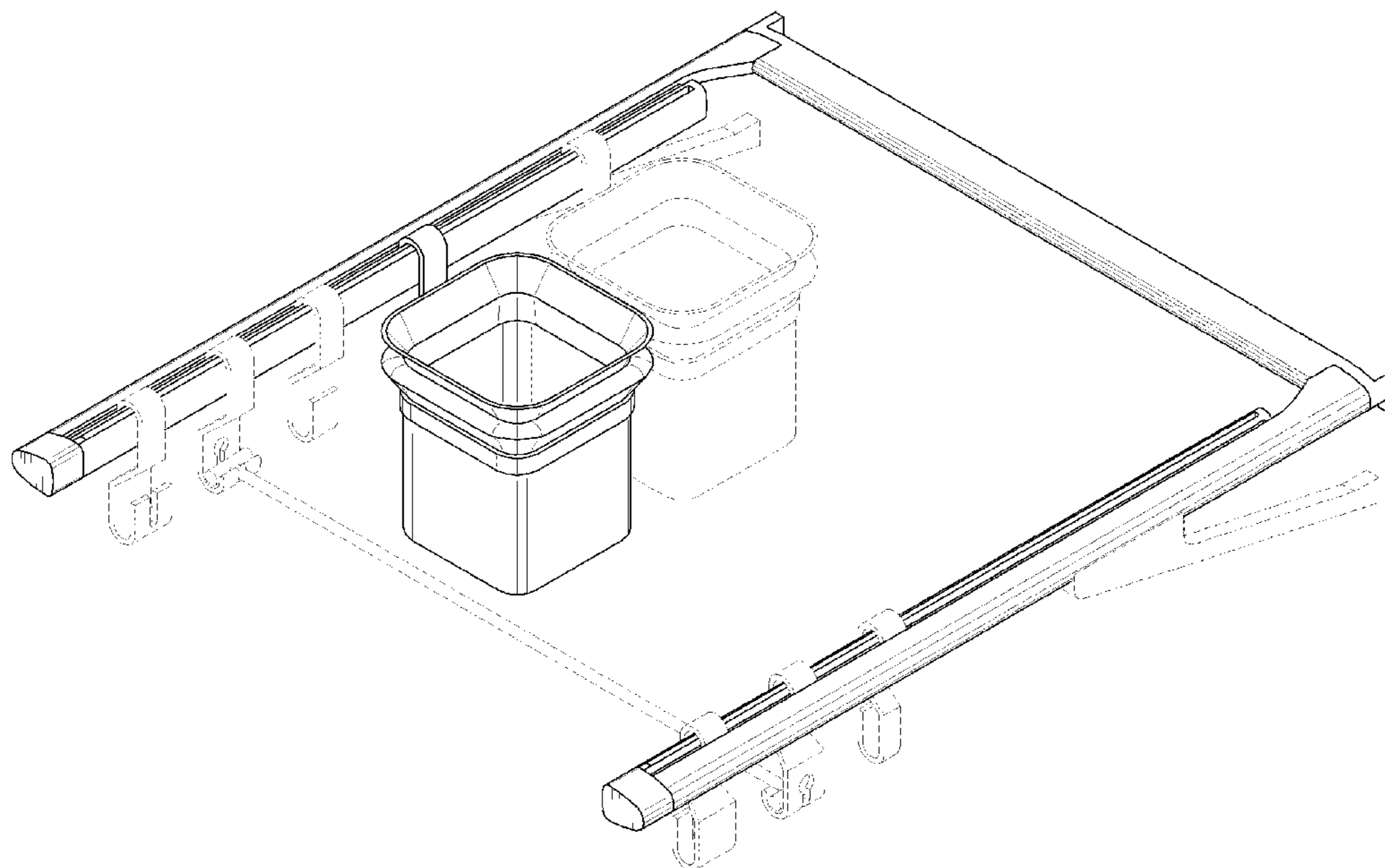

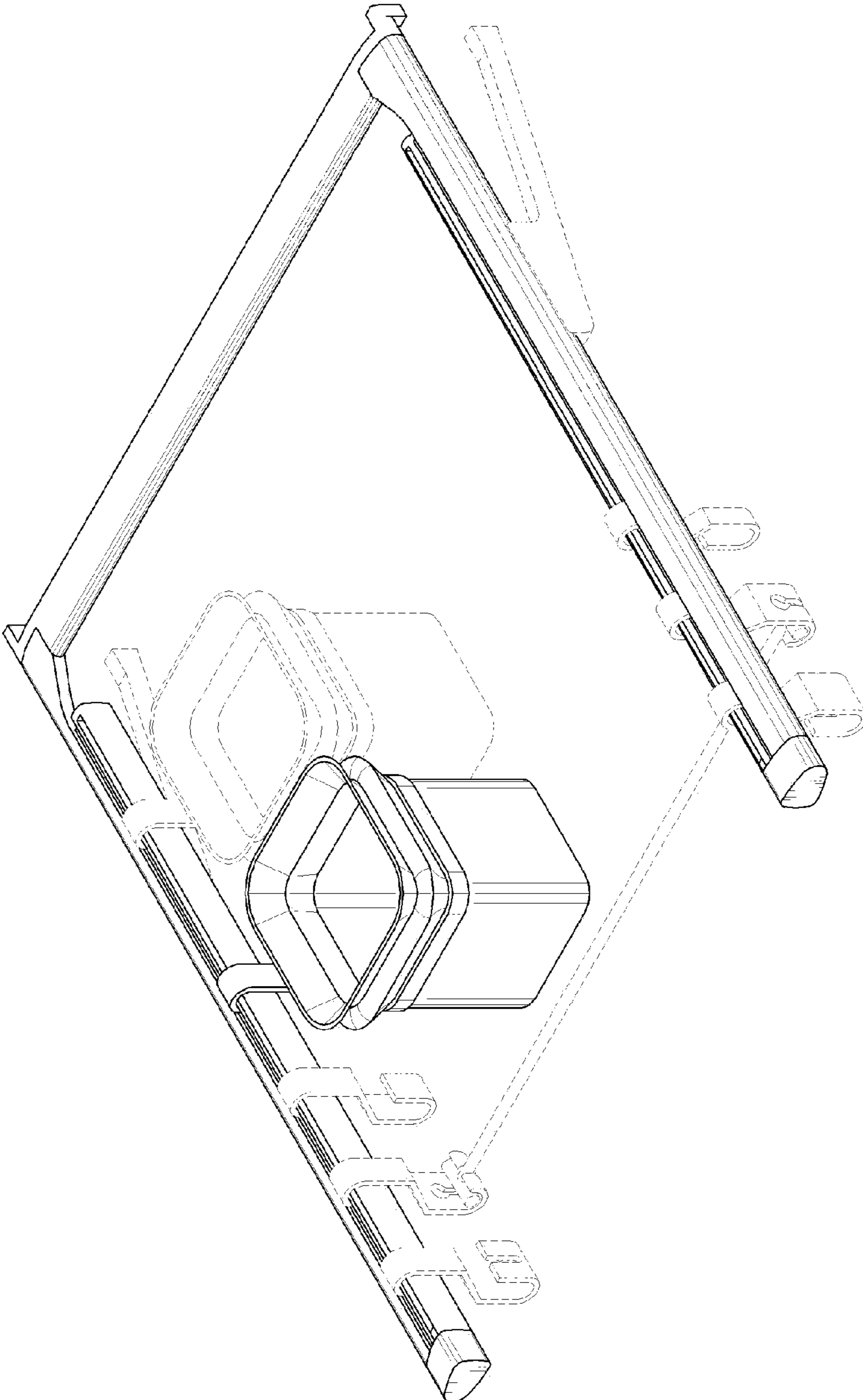

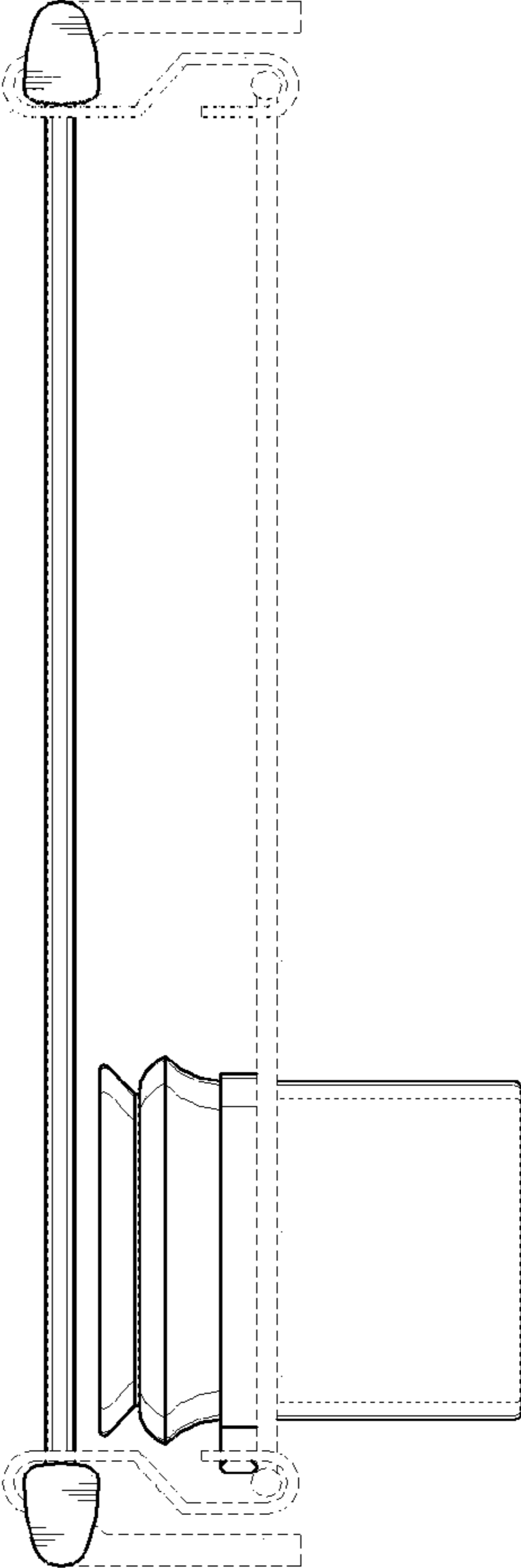

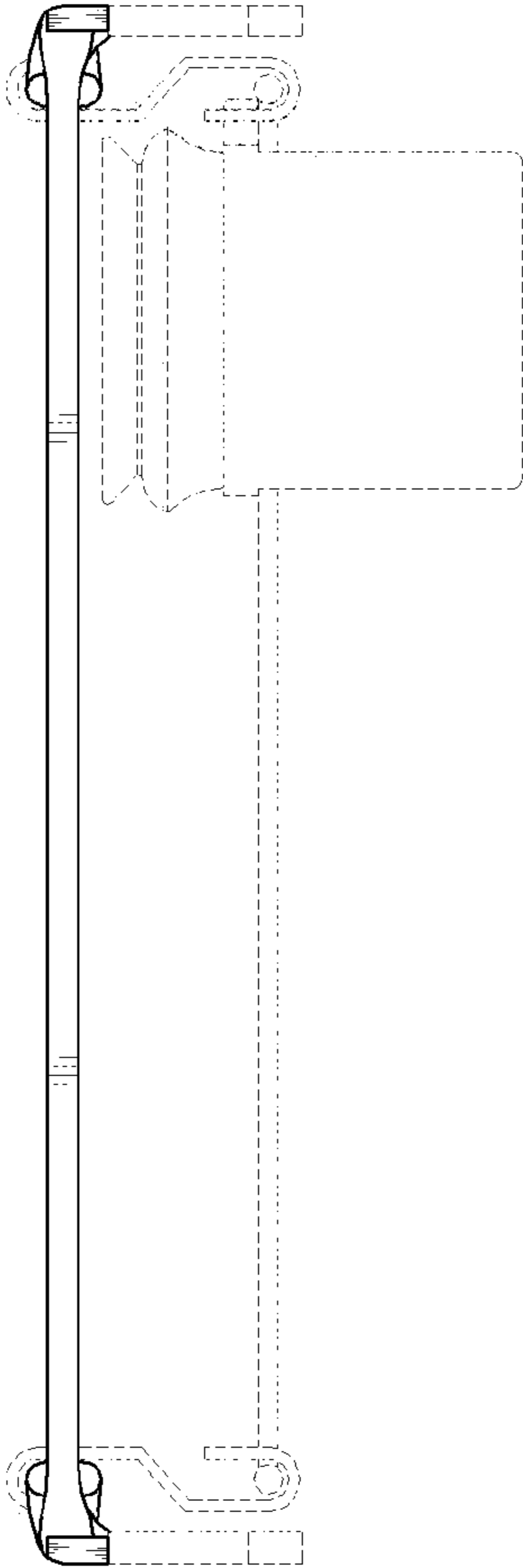

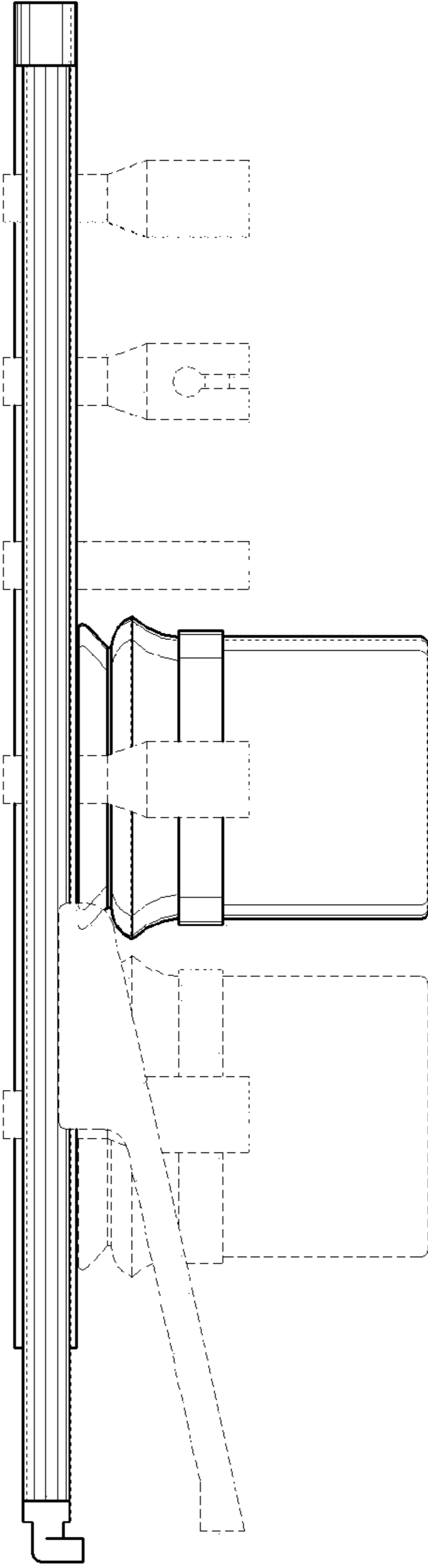

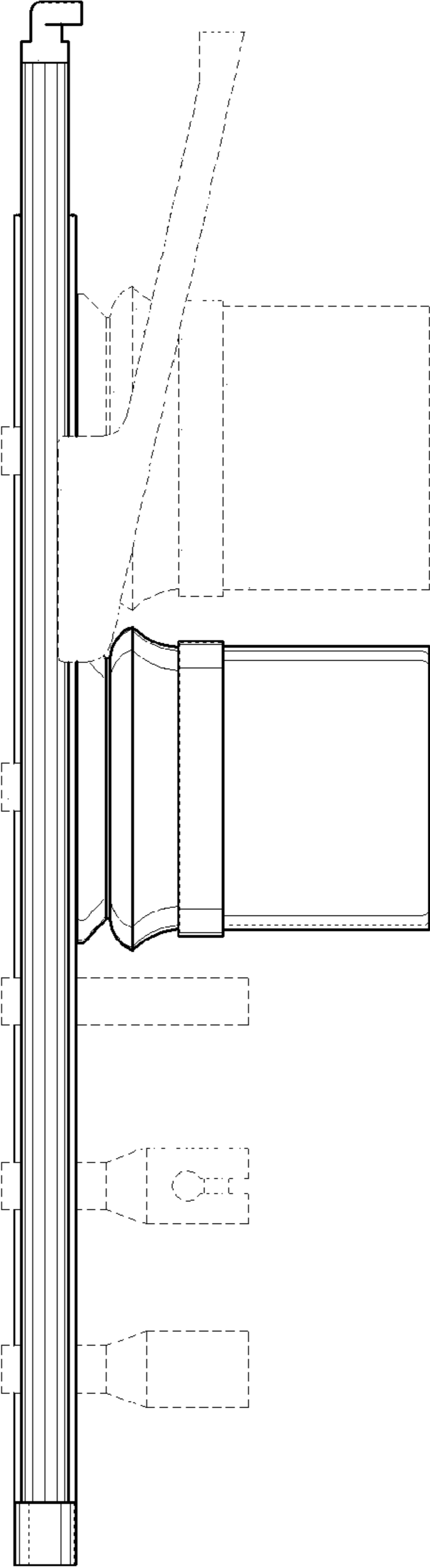

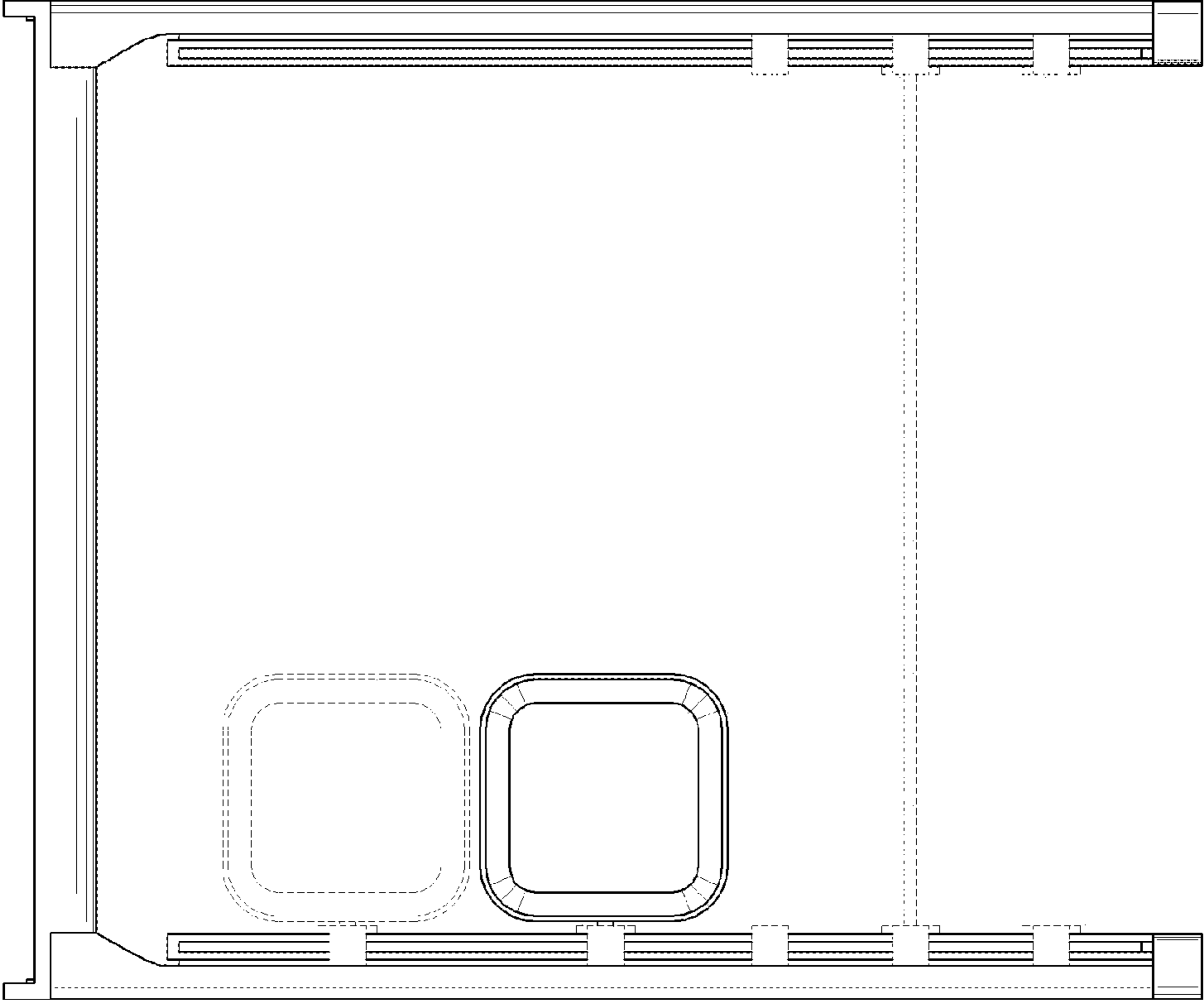

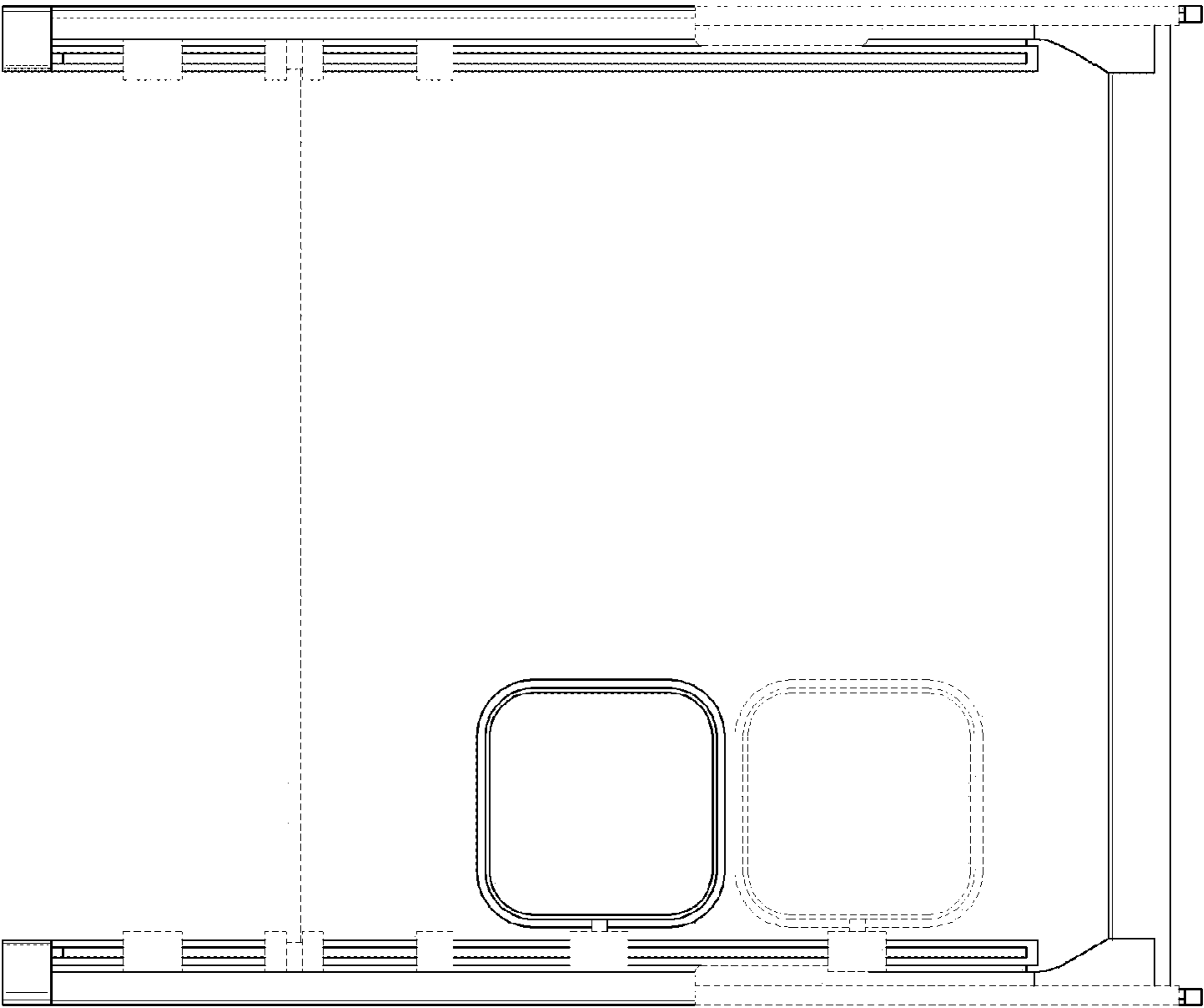
