The ornamental design for an expandable hose, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an expandable hose in a contracted state.

- FIG. 2 is a right view thereof;
- FIG. 3 is a left side view thereof;
- FIG. 4 is a top side view thereof;
- FIG. 5 is a bottom side view thereof;
- FIG. 6 is a first end view thereof; and,
- FIG. 7 is a second end view thereof.

The broken lines in the drawings illustrate portions of the article, and form no part of the claimed design.

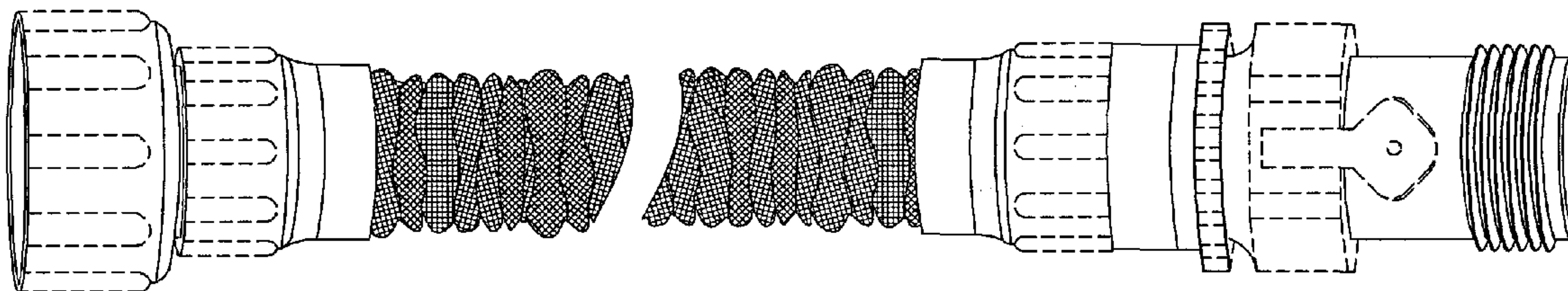
The hose is shown with a symbolic break in its length. The appearance of any portion of the hose between the break lines forms no part of the claimed design.

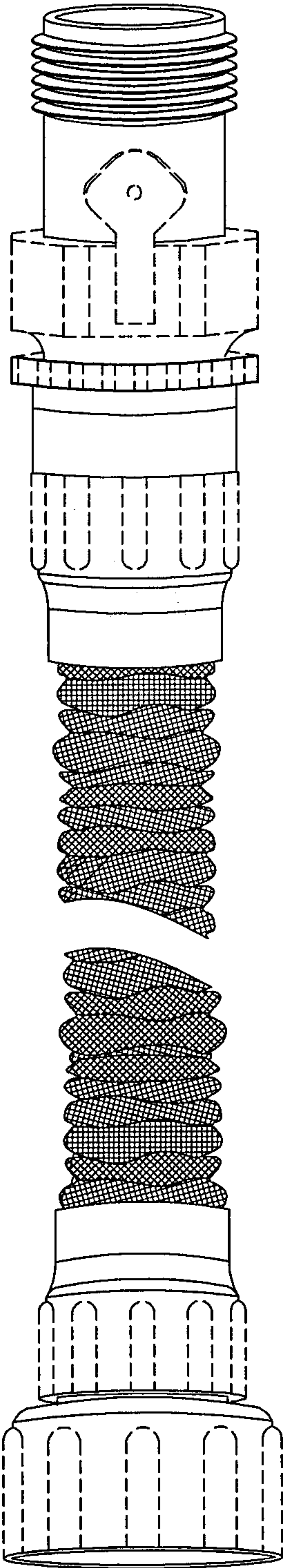

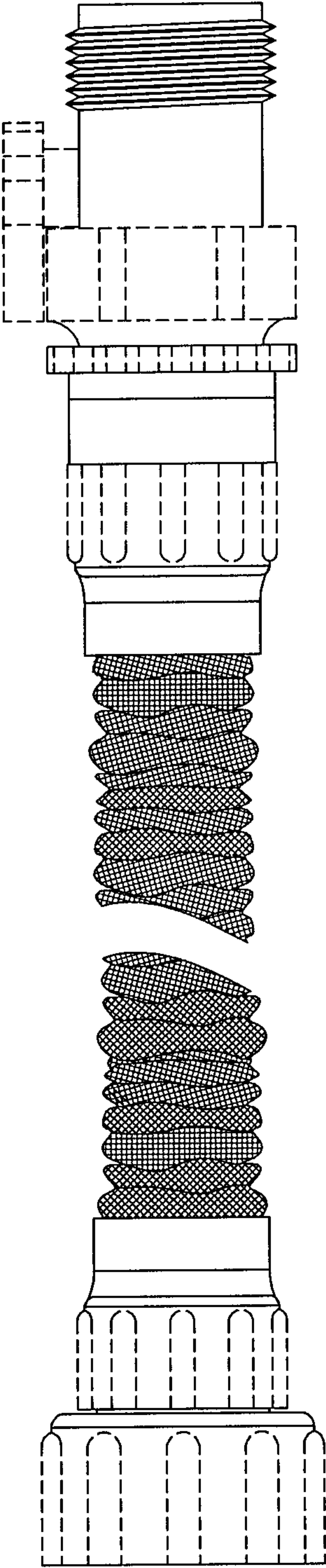

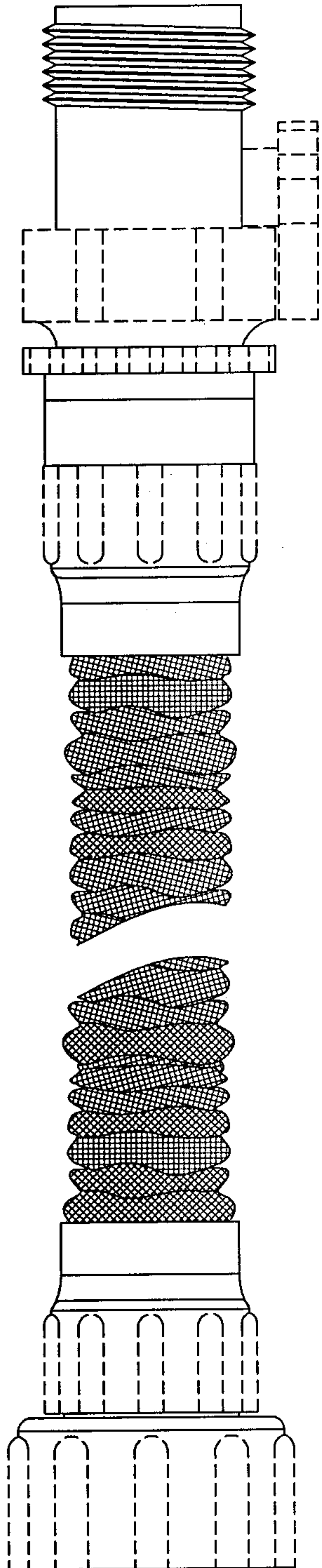

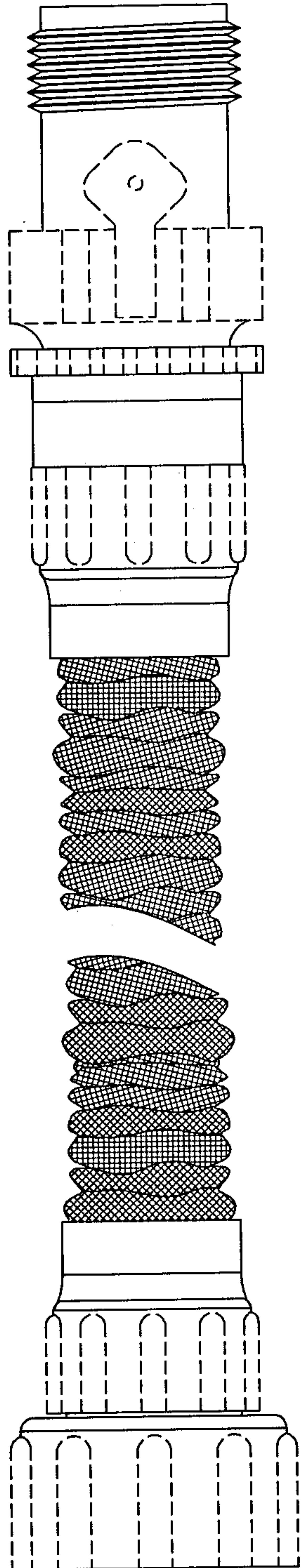

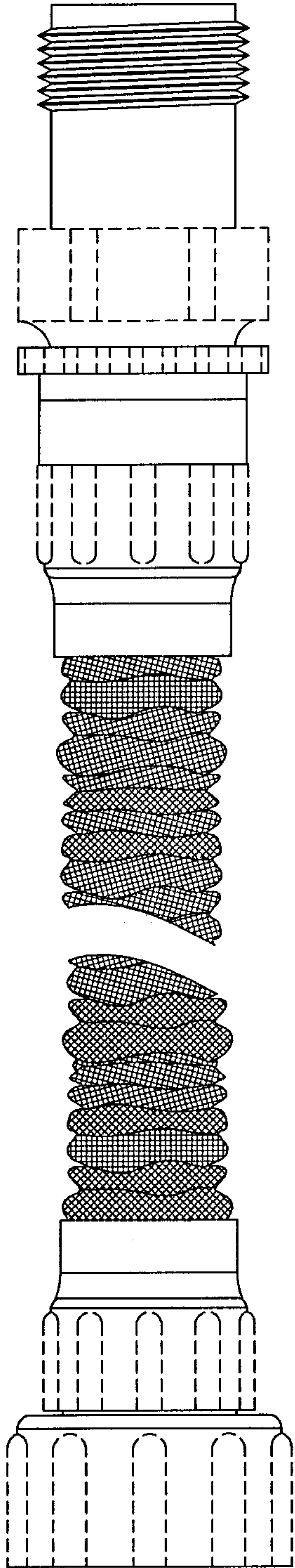

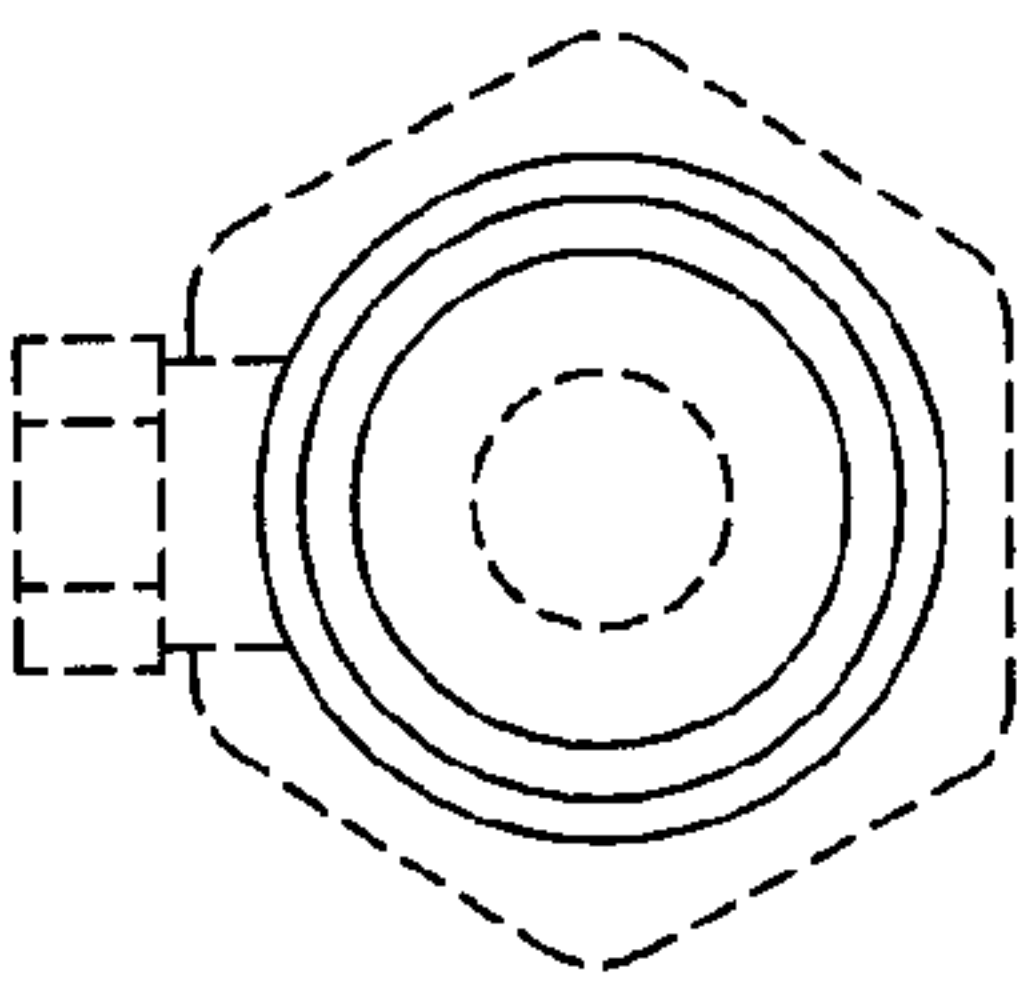

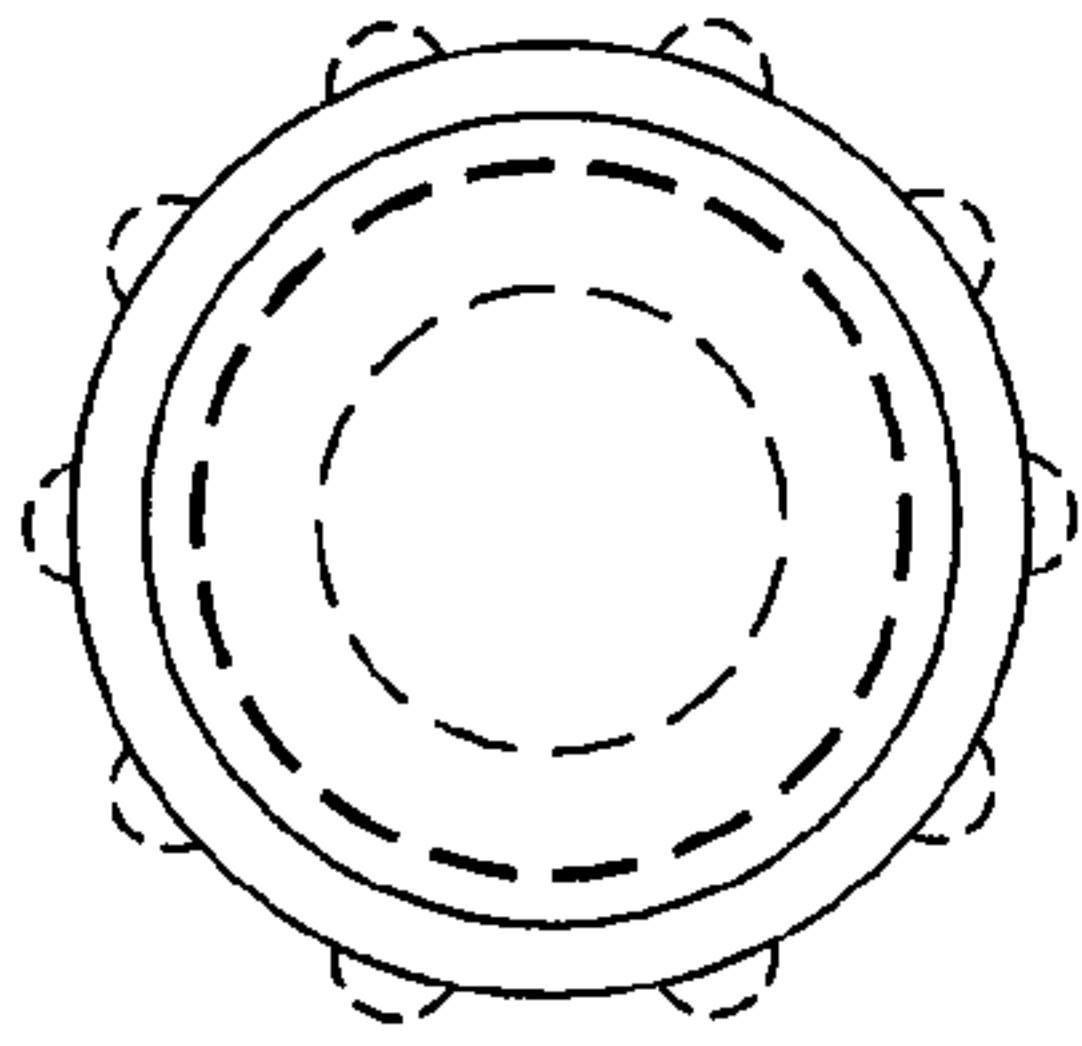
