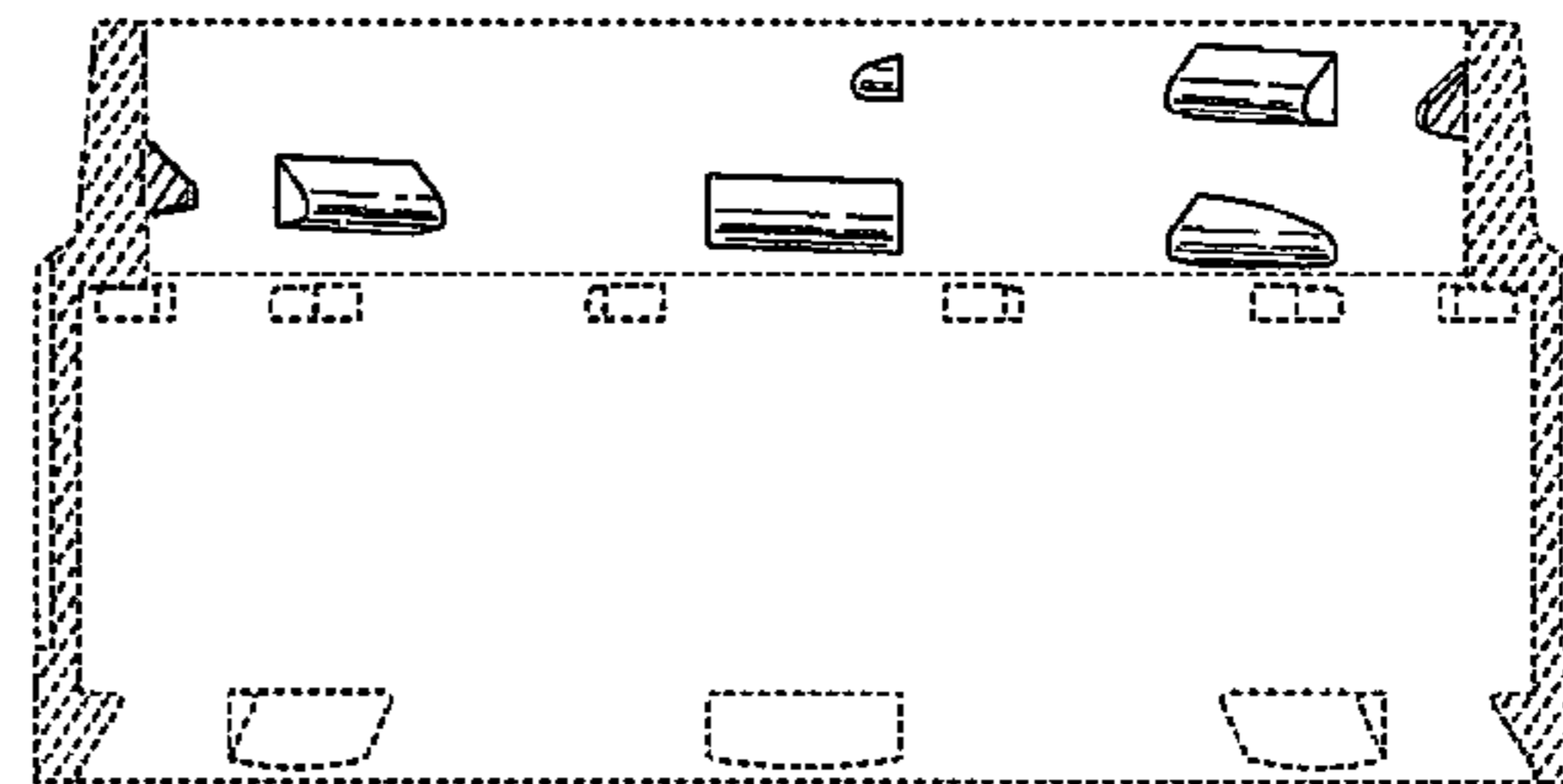
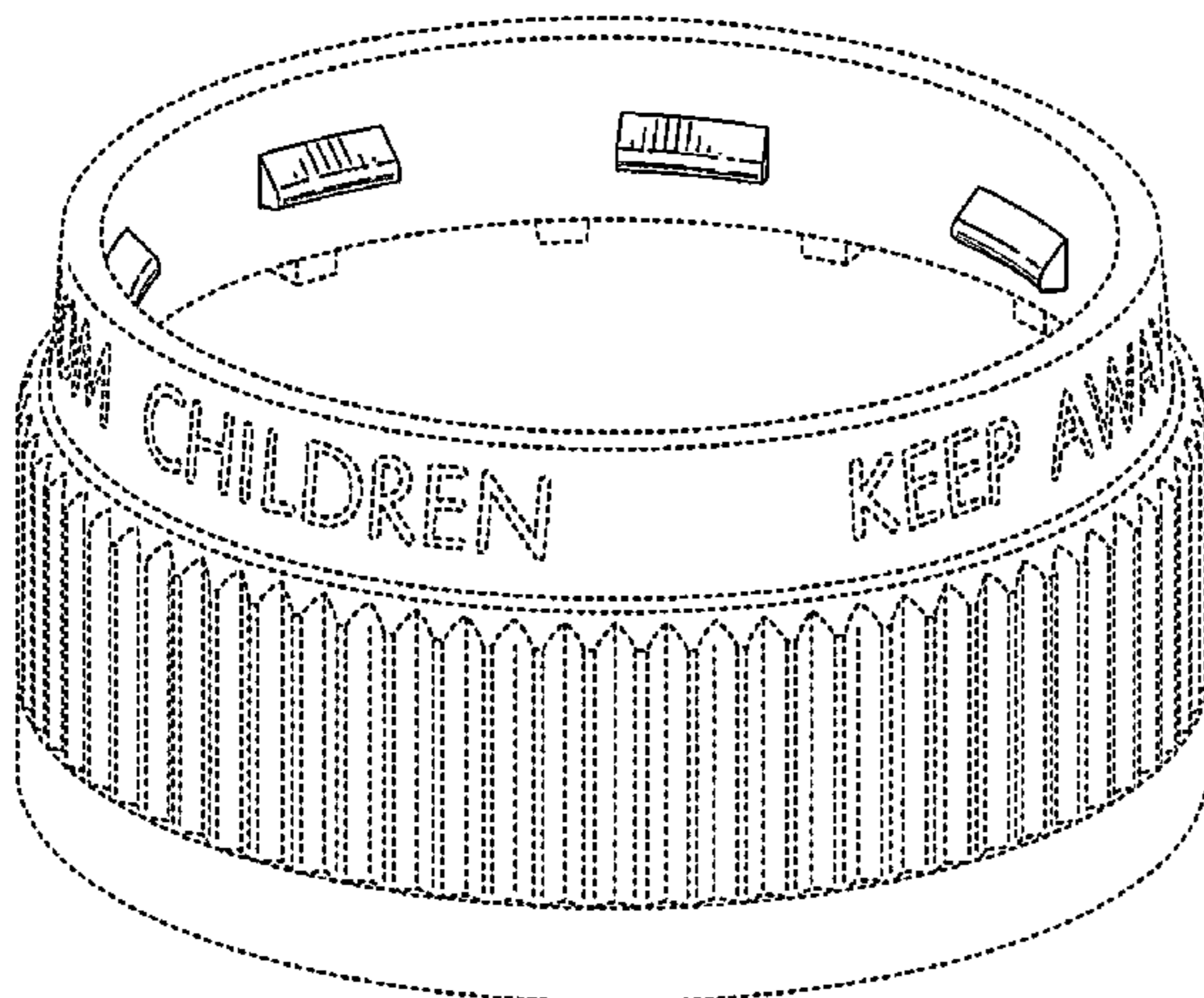
(57) **CLAIM**

The ornamental design for segmented threads for a pharmaceutical cap, as shown.

DESCRIPTION

FIG. 1 is an upper perspective view of segmented threads for a pharmaceutical cap of our new design; FIG. 2 is a lower perspective view of the segmented threads for a pharmaceutical cap of FIG. 1; FIGS. 3 and 4 are side elevation views indicating that the segmented threads for a pharmaceutical cap are not visible from these views; FIG. 5 is a top plan view of the segmented threads for a pharmaceutical cap of FIG. 1; FIG. 6 is a bottom plan view of the segmented threads for a pharmaceutical cap of FIG. 1; and, FIG. 7 is a cross-sectional side view of the segmented threads for a pharmaceutical cap of FIG. 1. The broken line showing of the pharmaceutical cap in FIGS. 1-7 illustrates the environment of the claimed design and forms no part thereof.

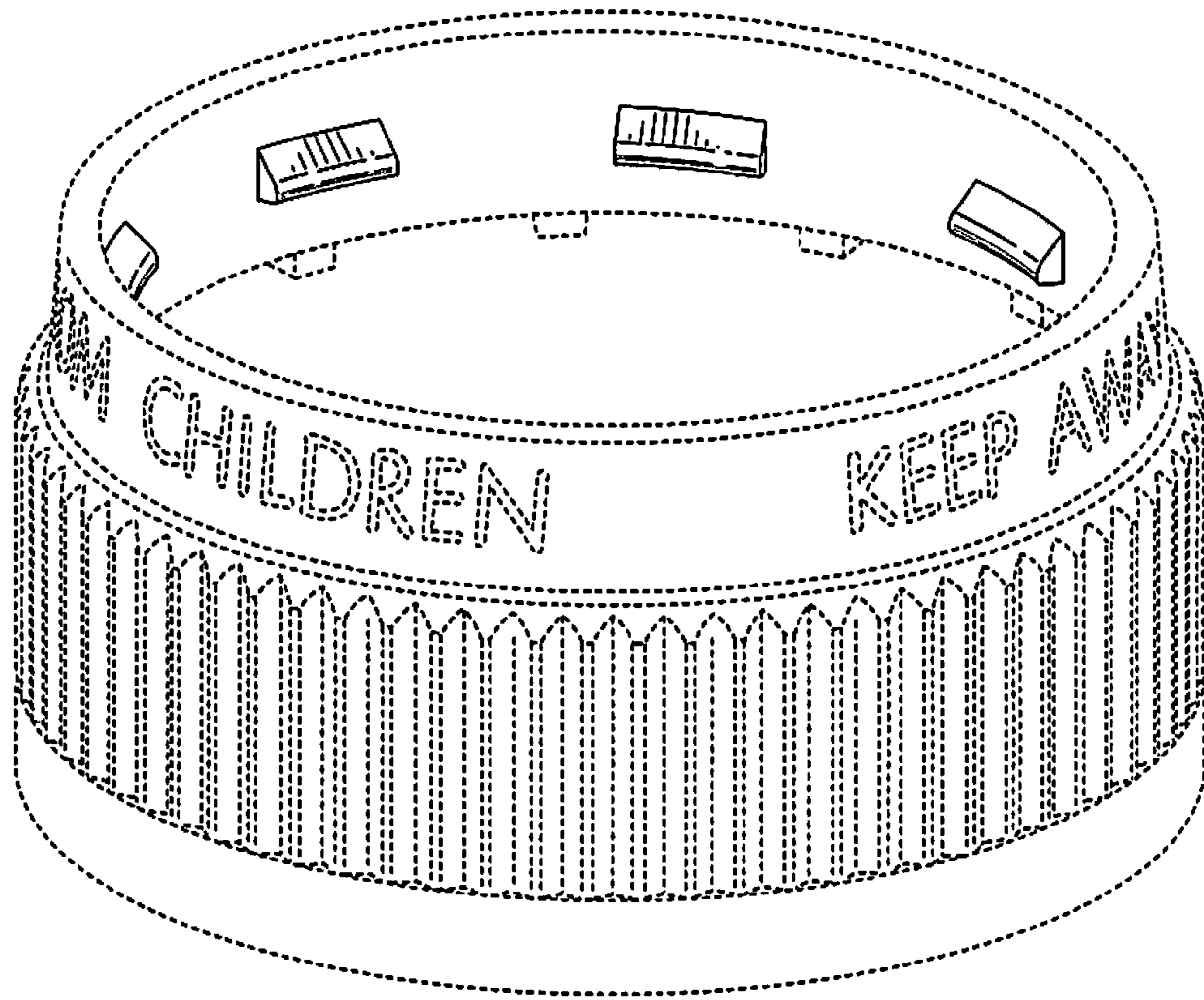

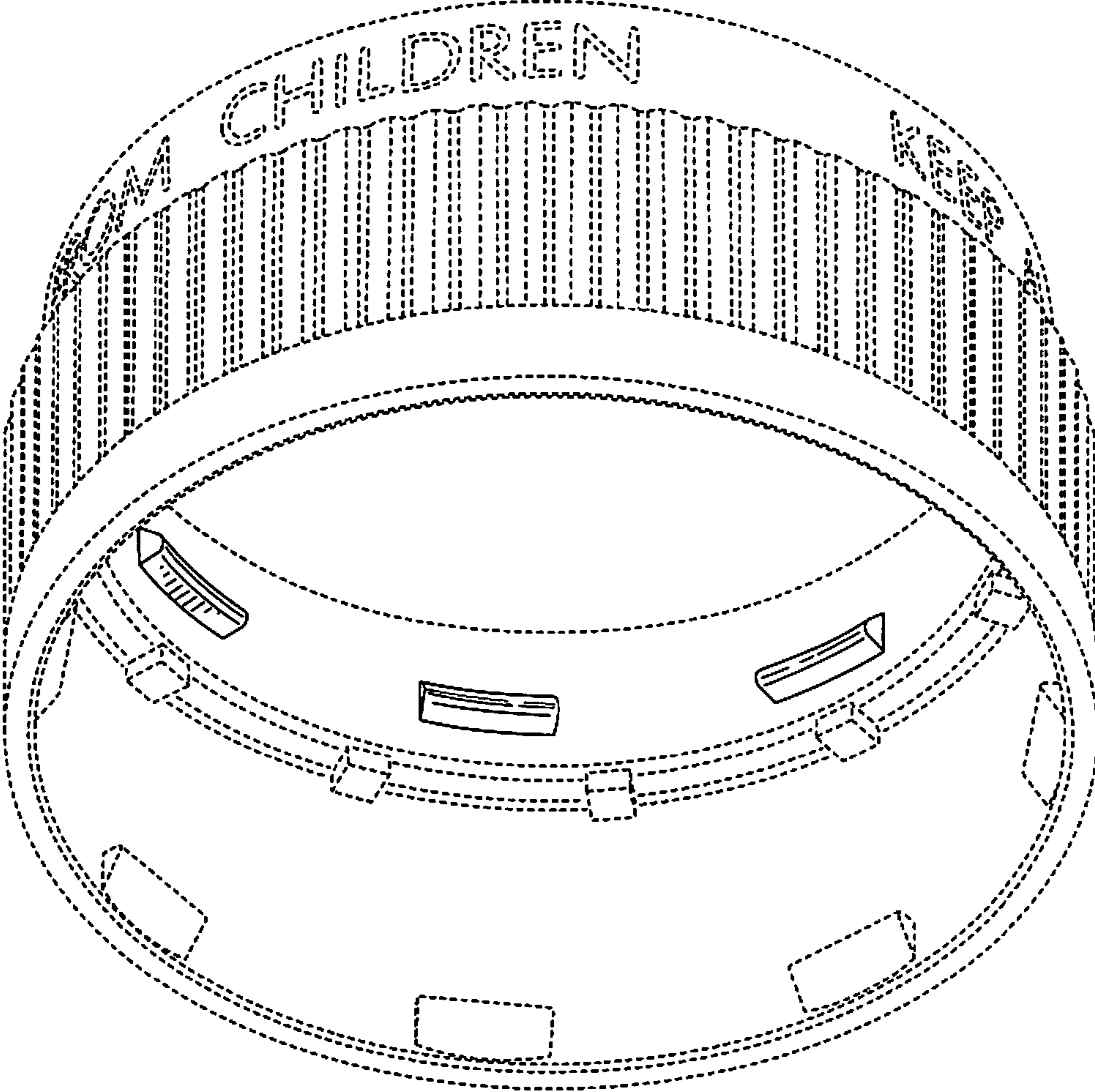

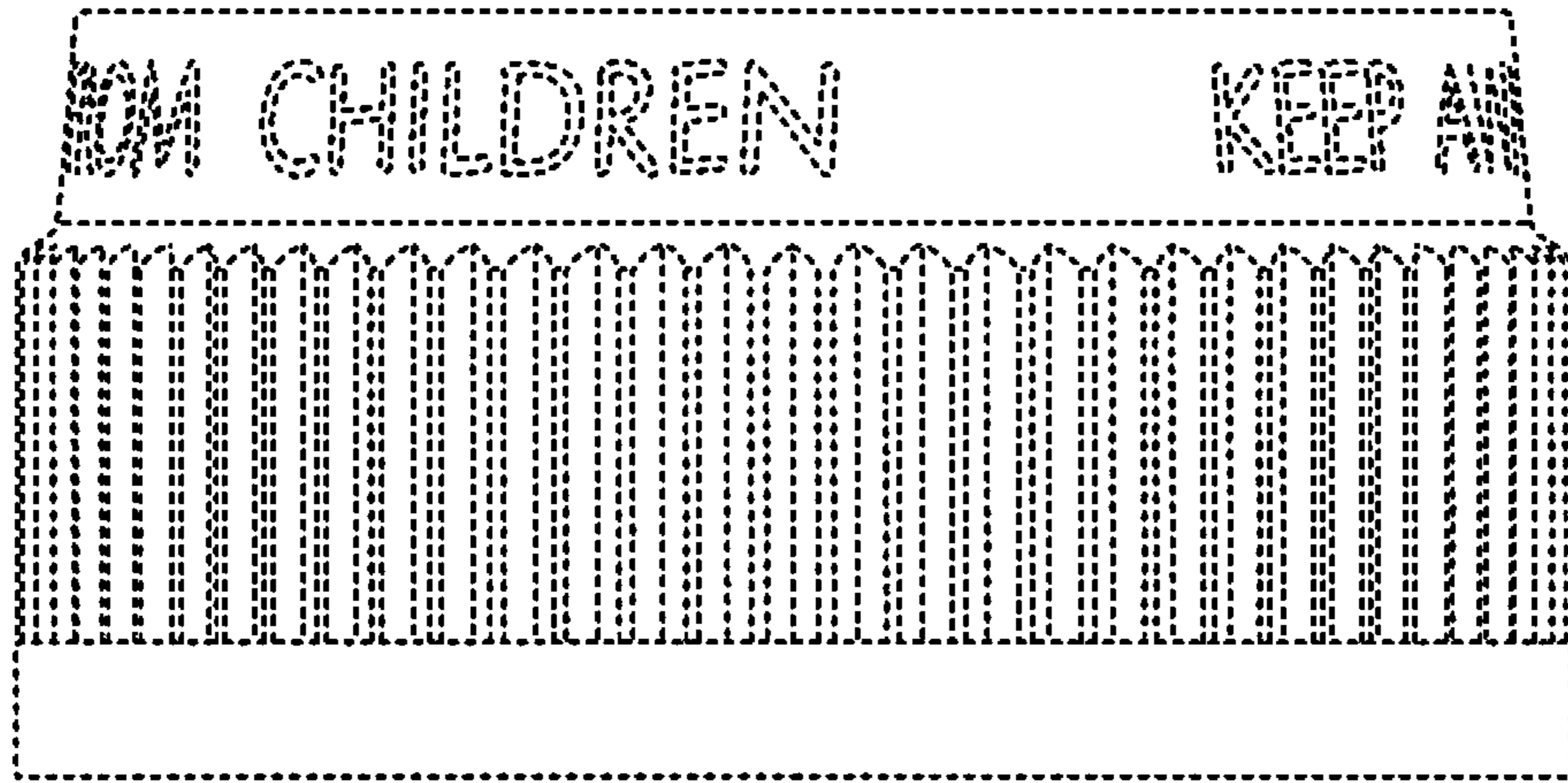

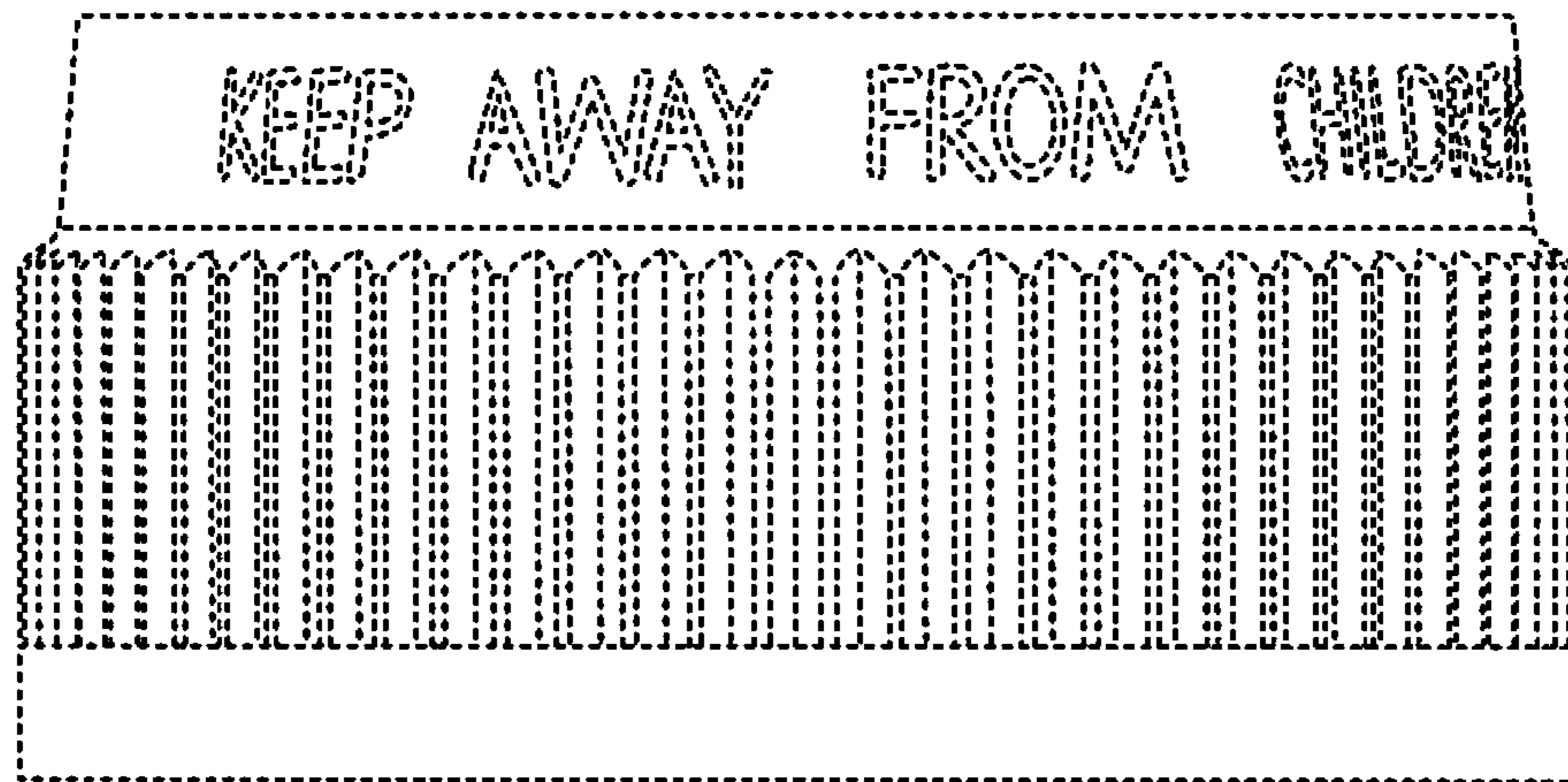

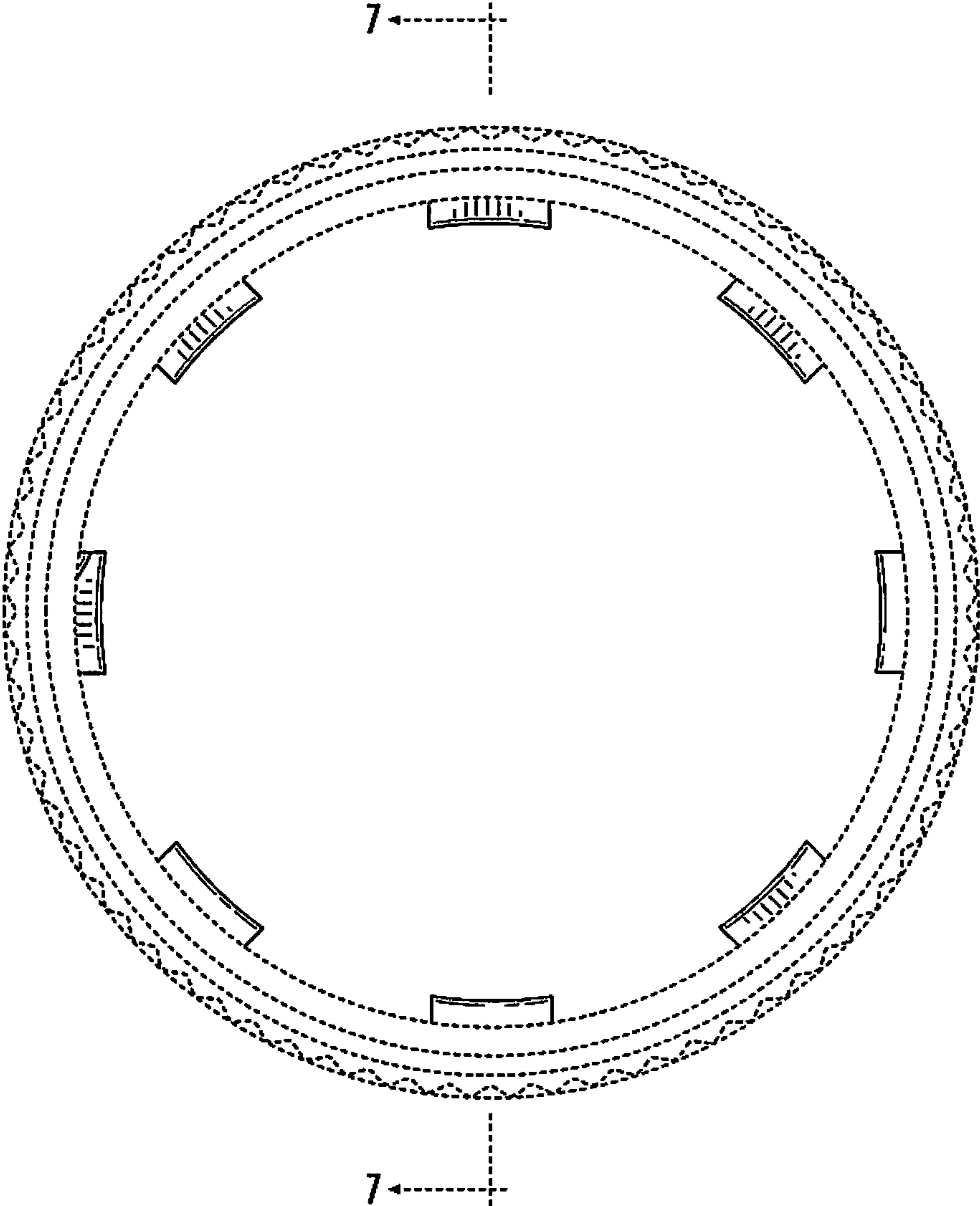

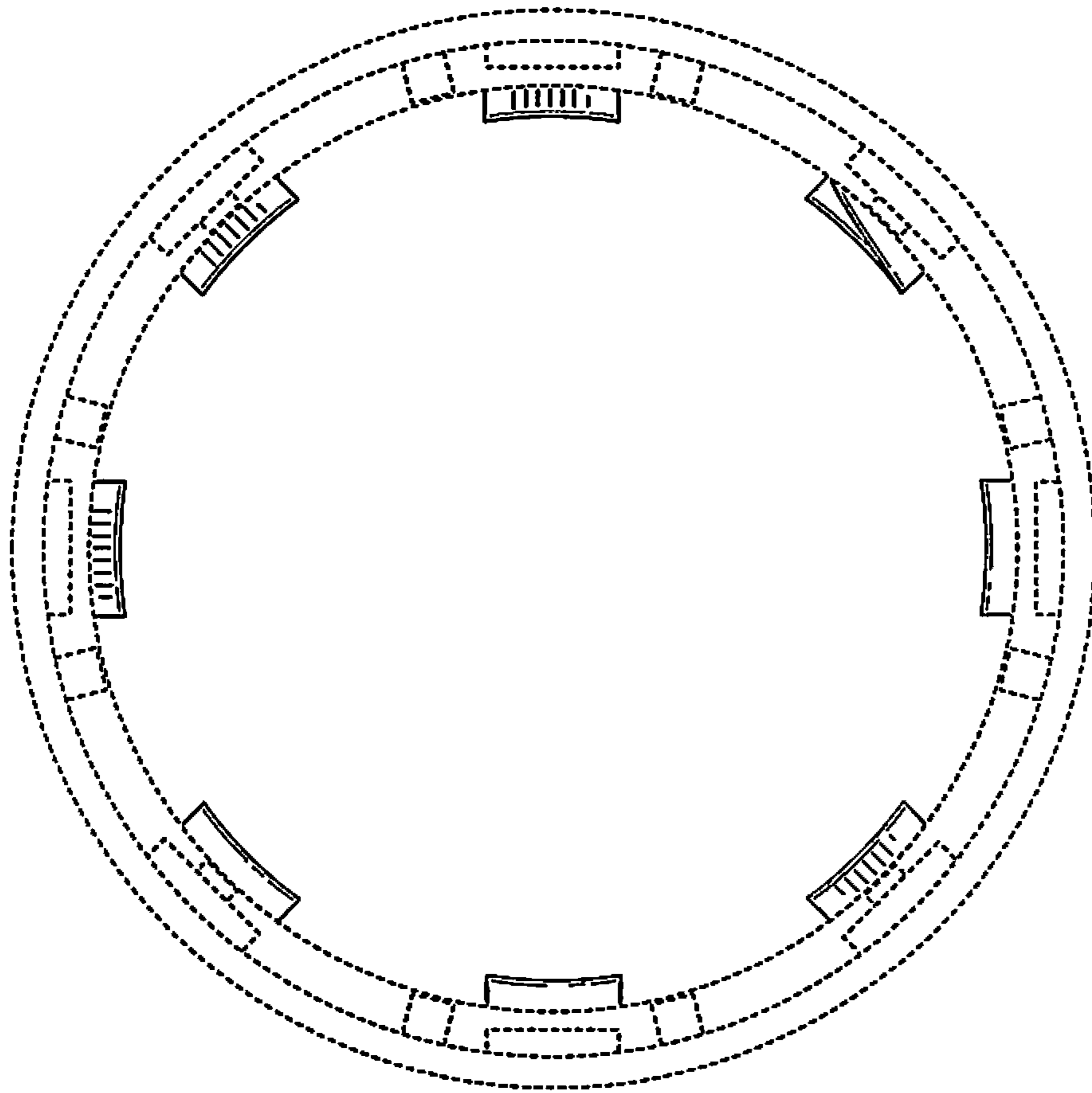

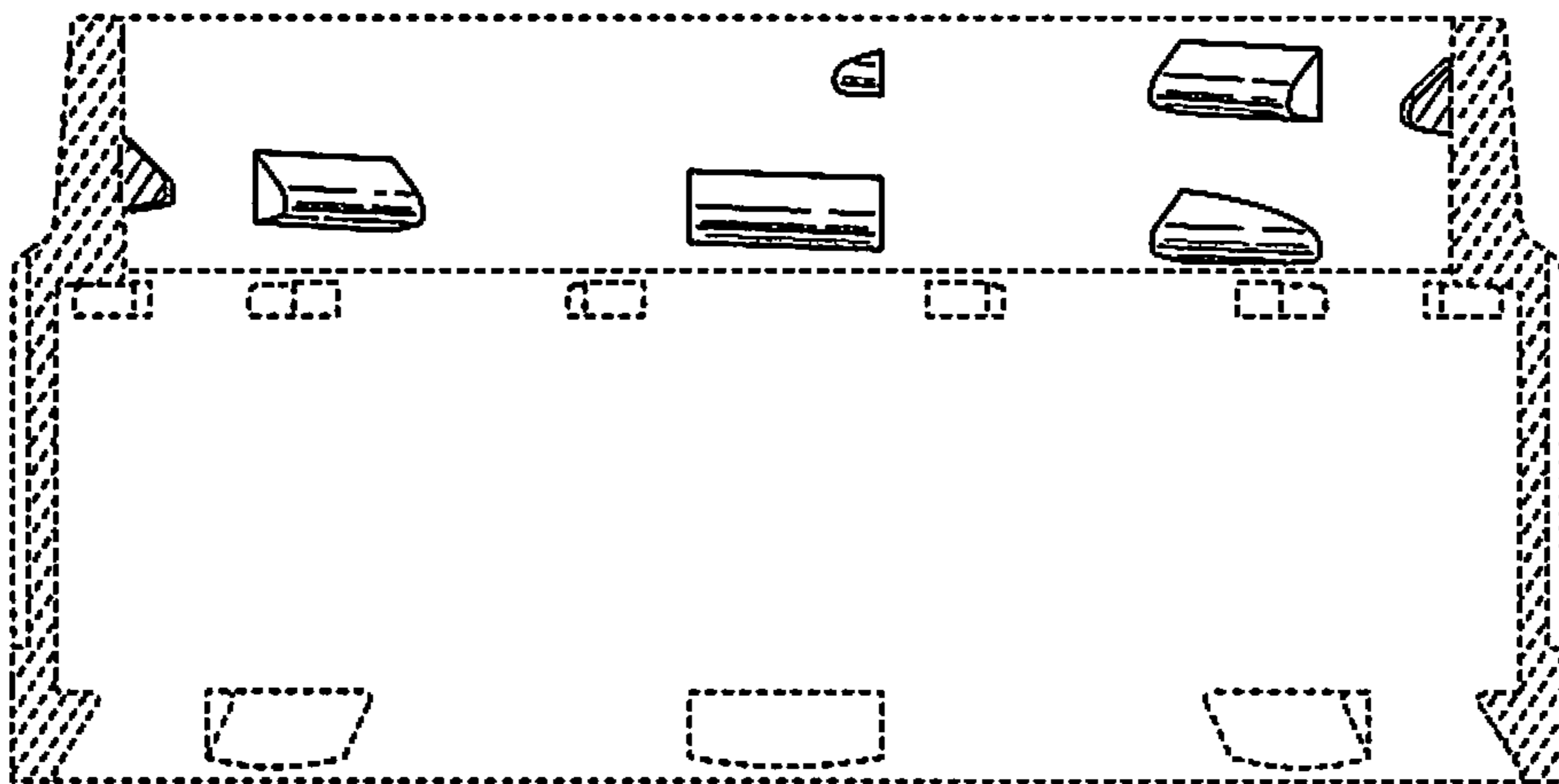
