FIG. 3 is a front view thereof;

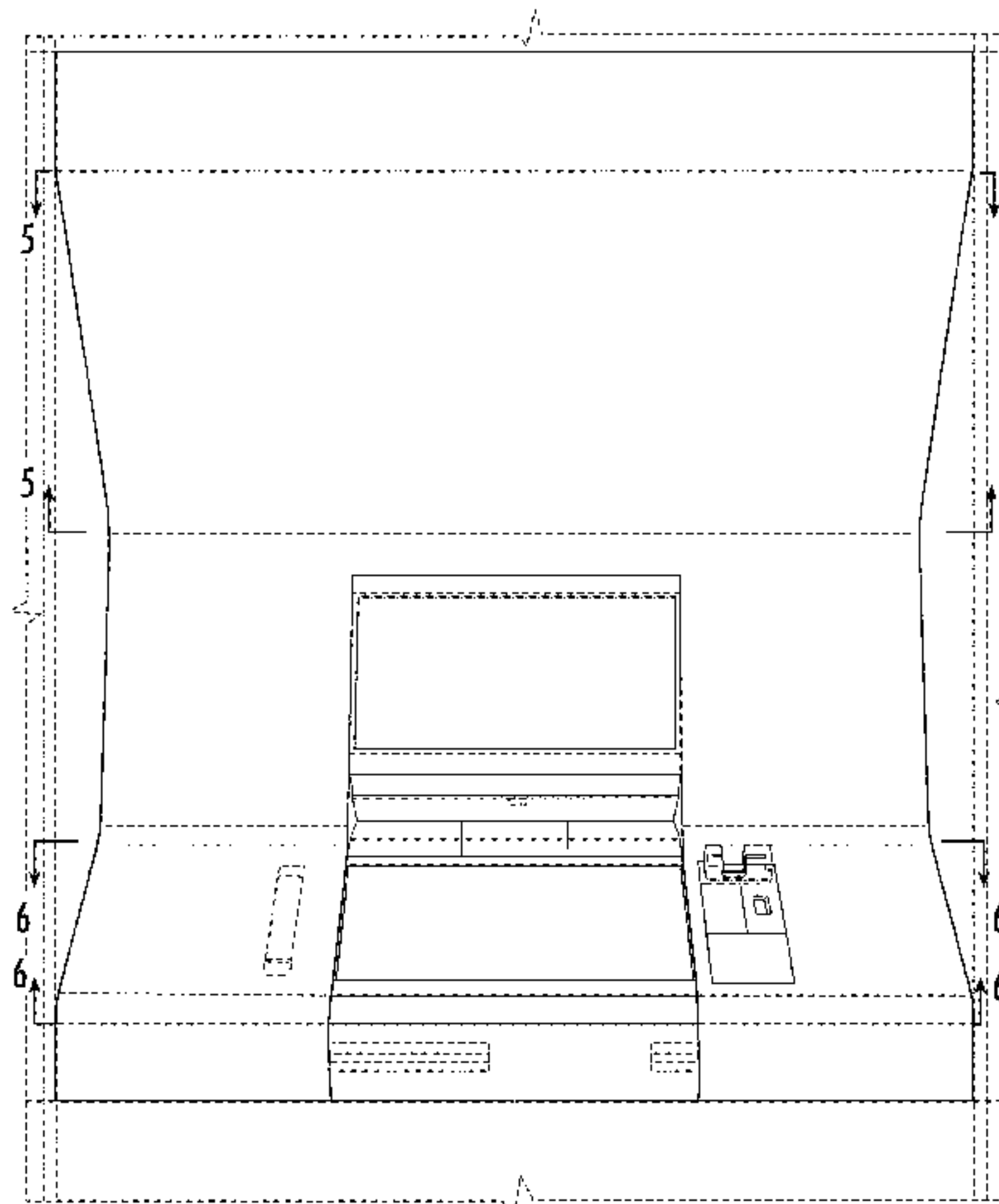
FIG. 4 is an enlarged portion of the perspective view taken along lines 4-4 in FIG. 1;

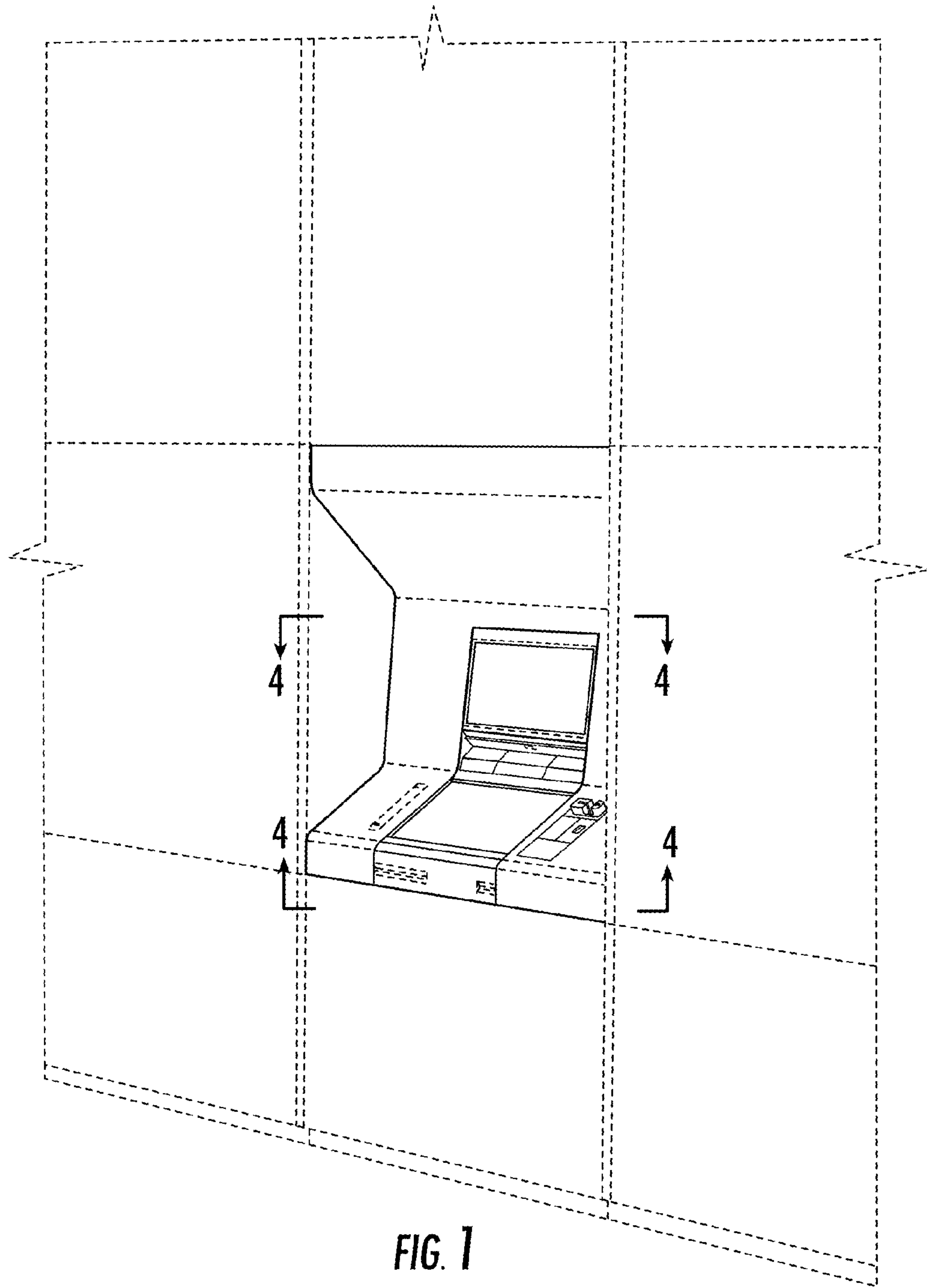

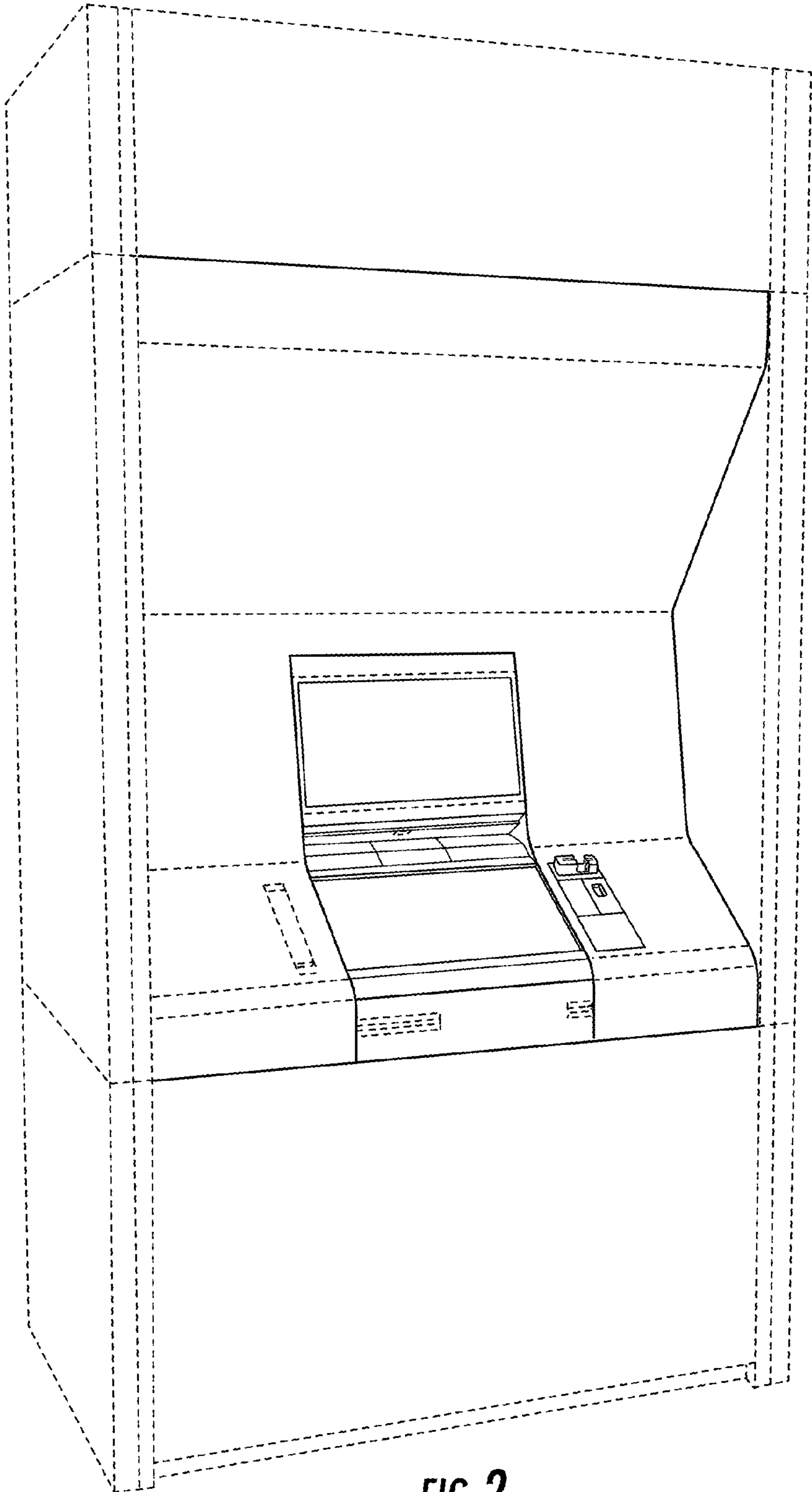

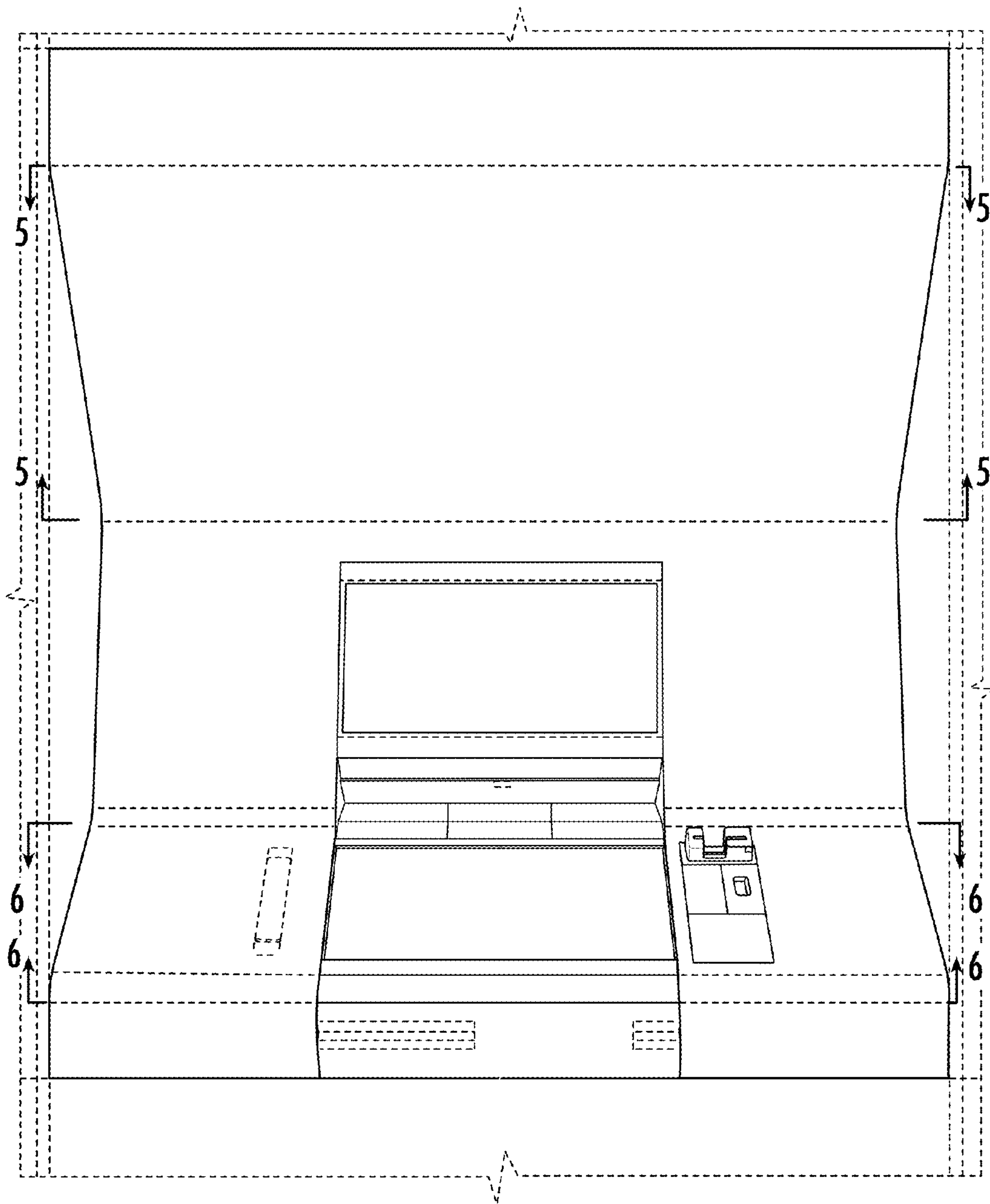

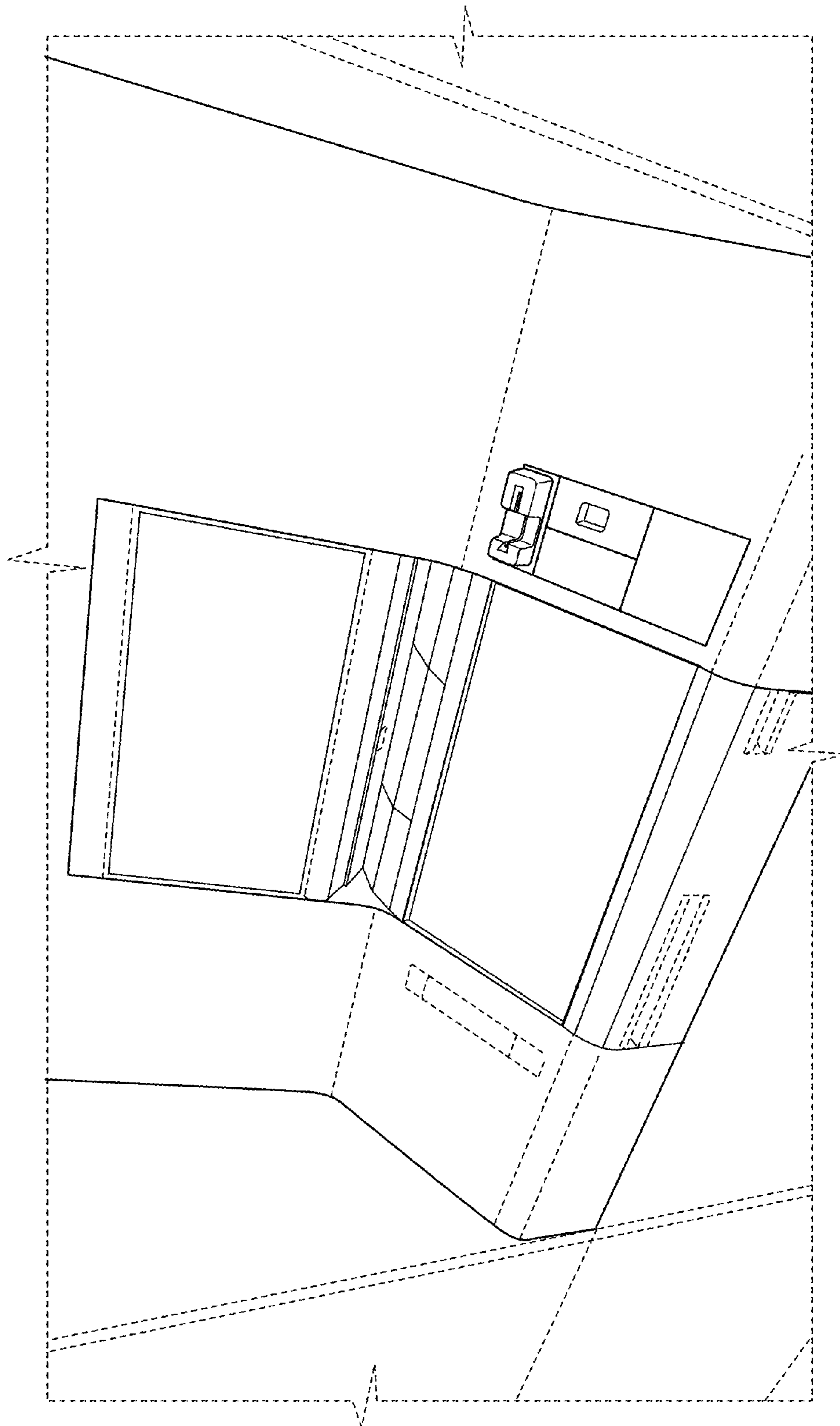

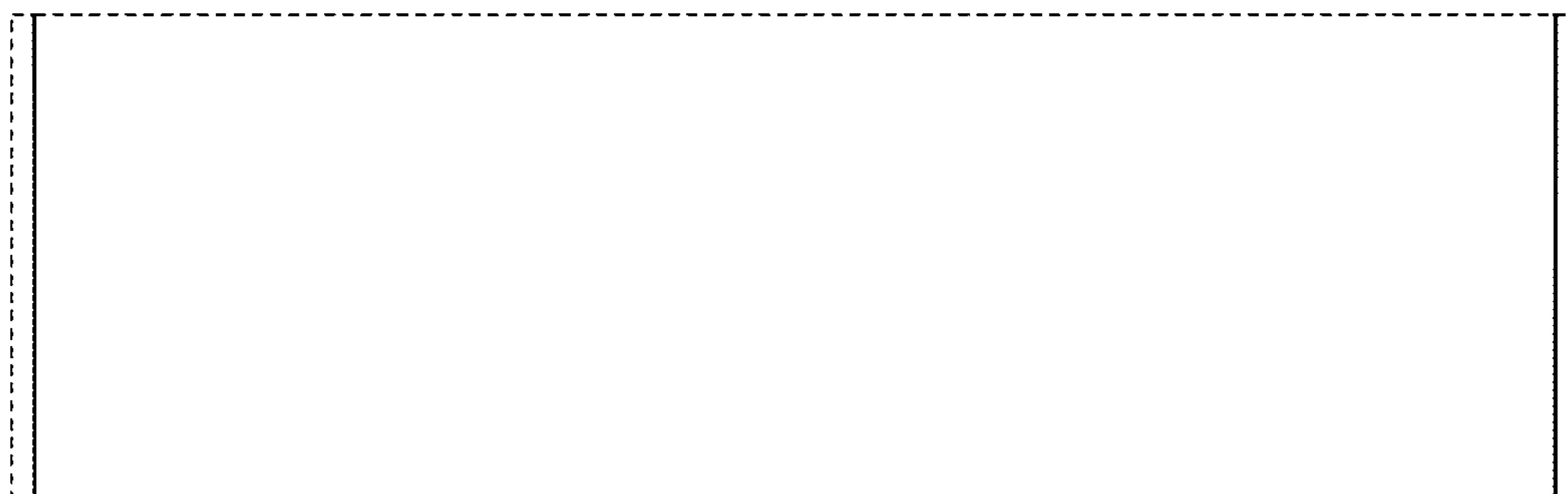

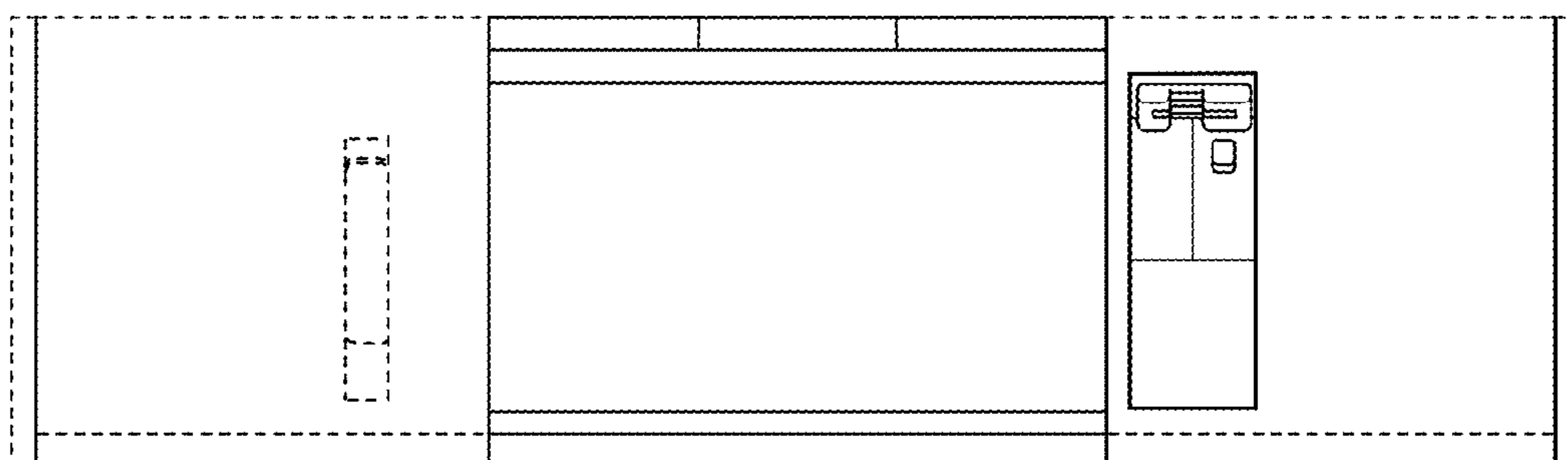
