The ornamental design for a protective undergarment, as shown and described.

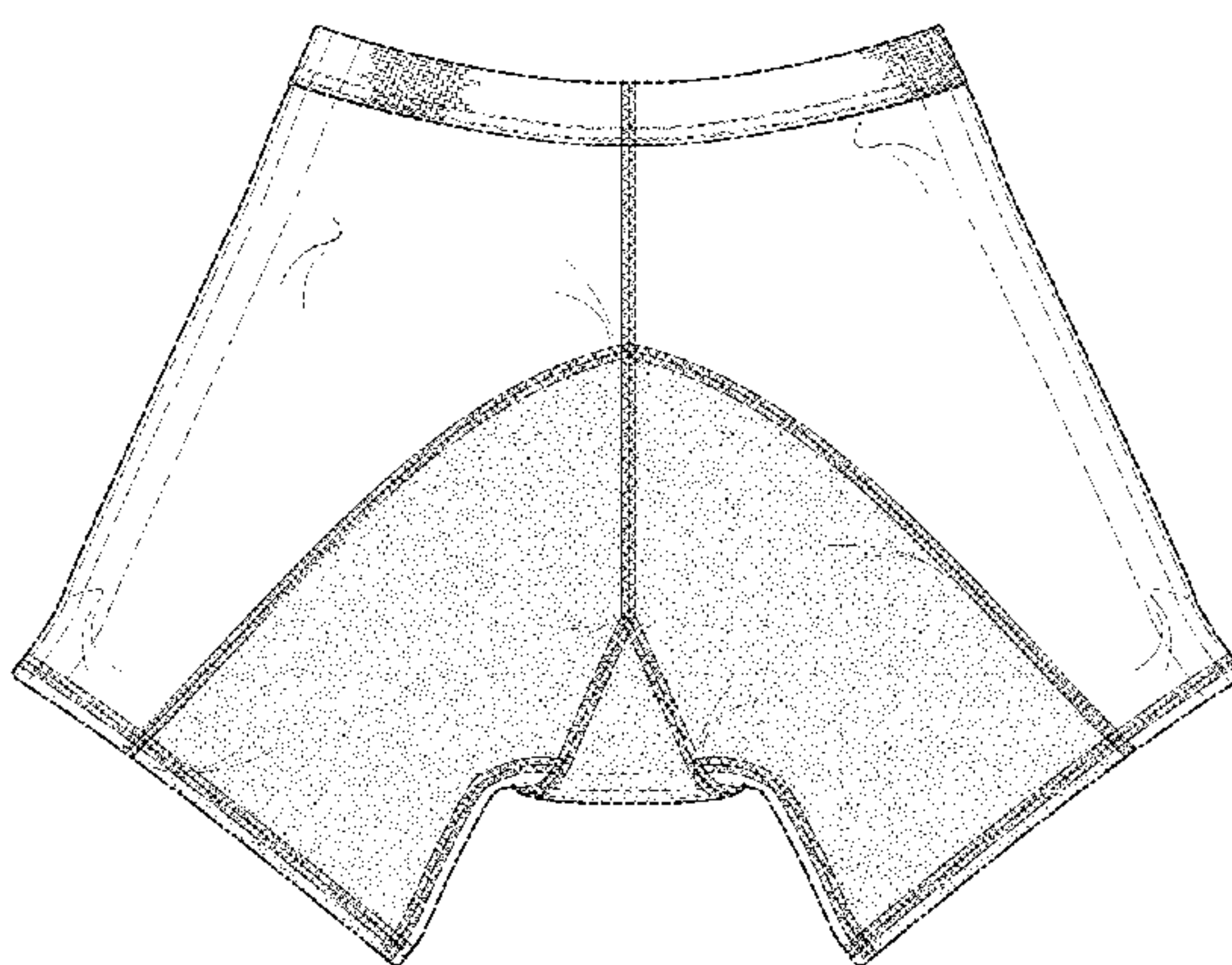
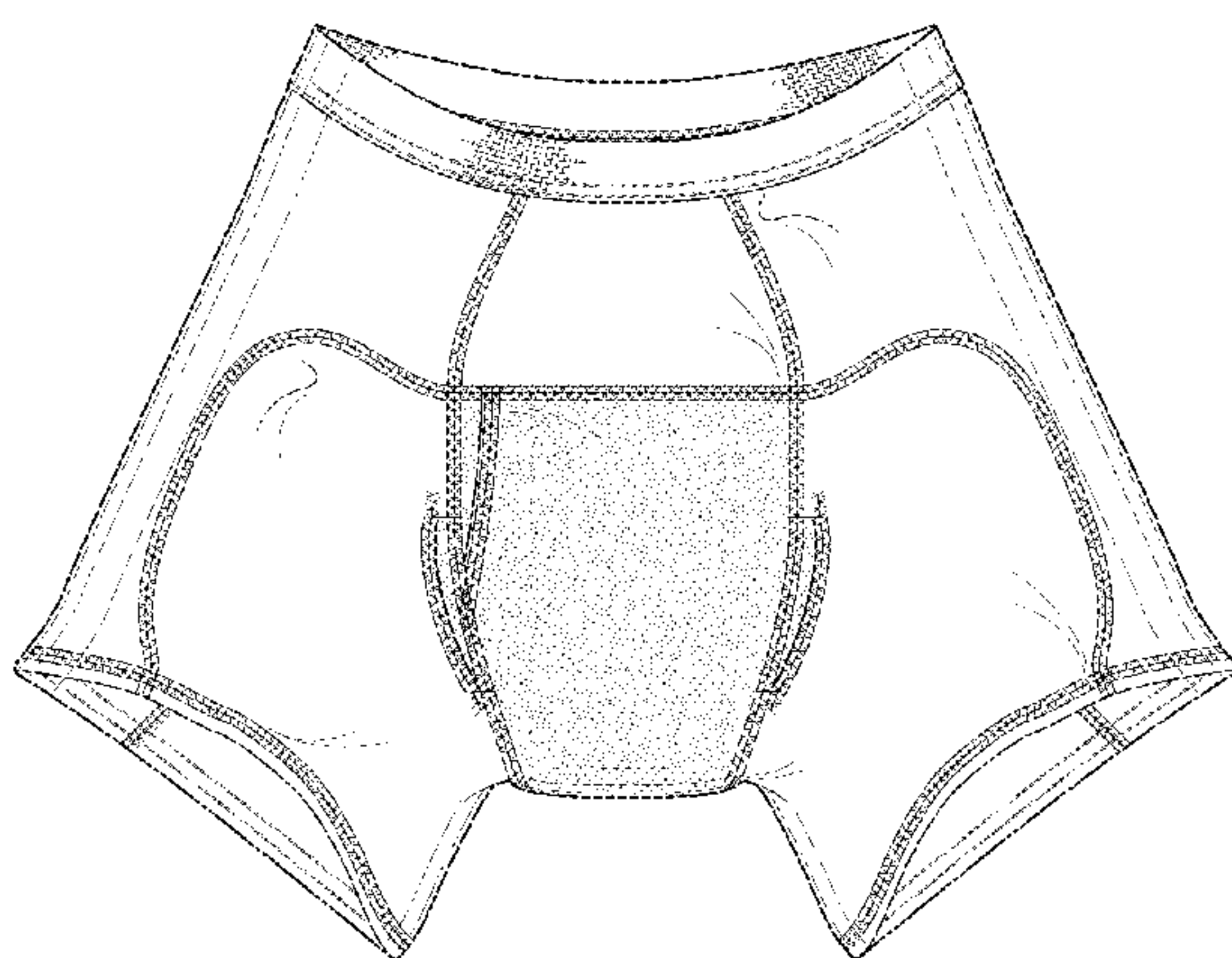
DESCRIPTION

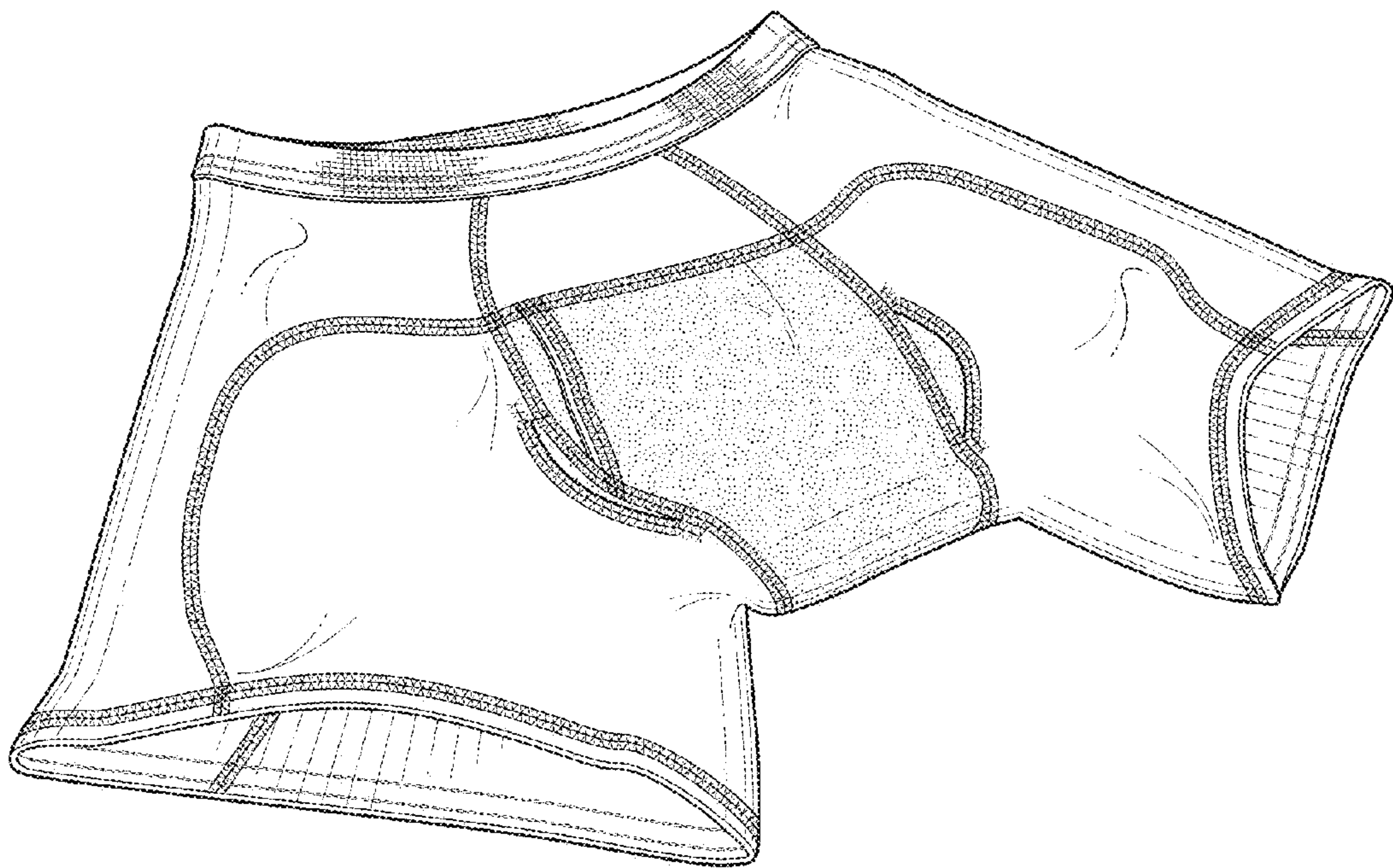

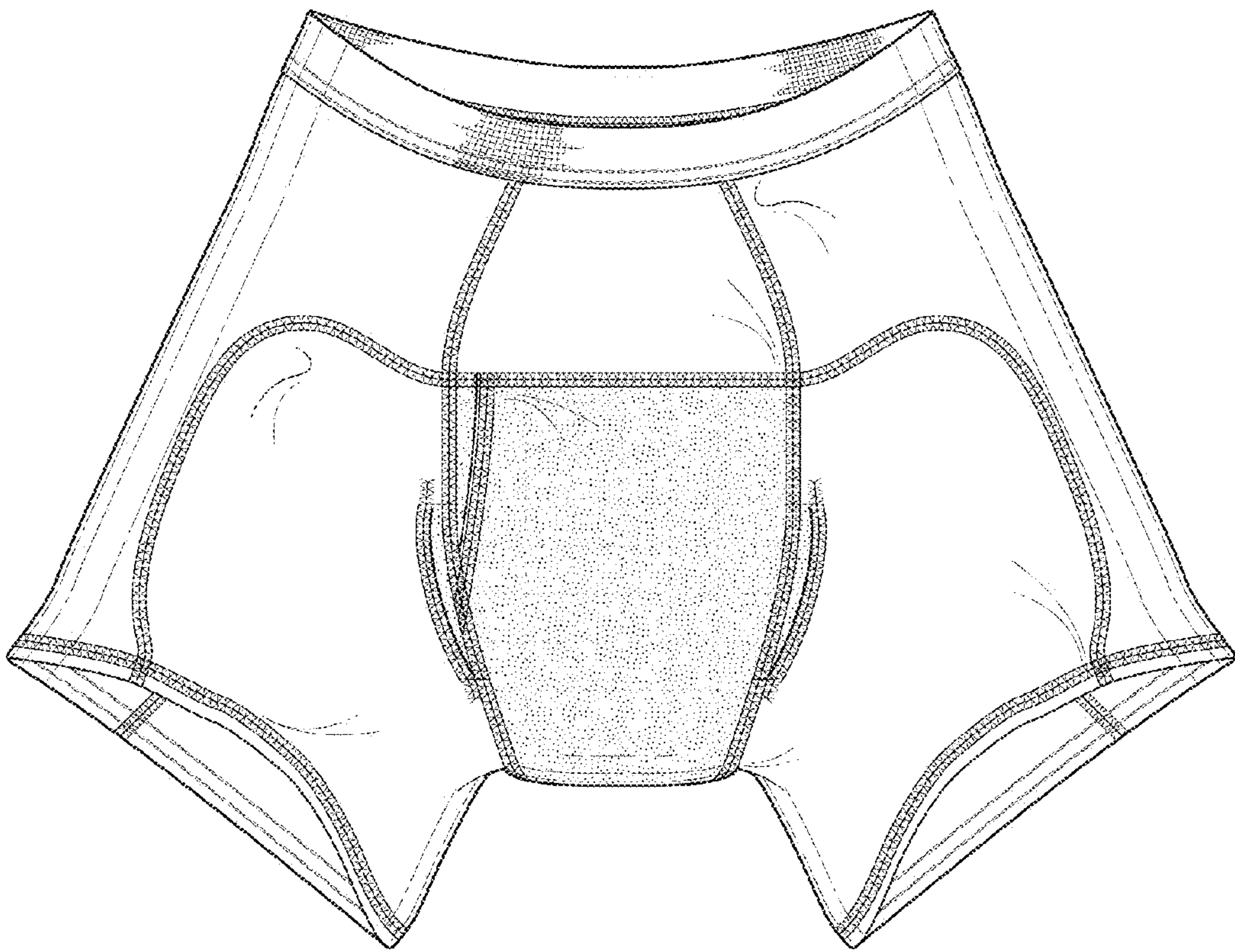

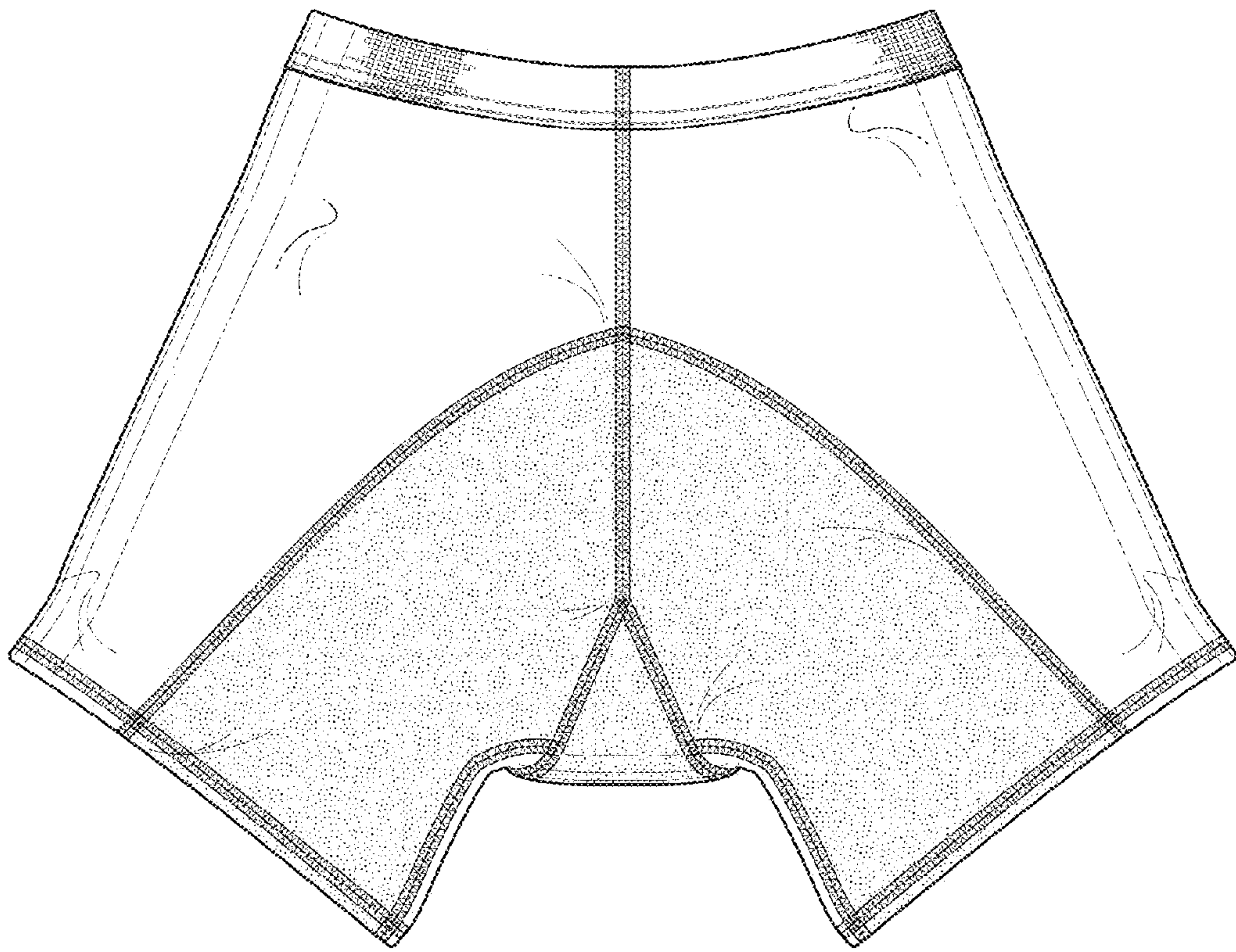
