(57) **CLAIM**

The ornamental design for a footwear upper, as shown and
described.

DESCRIPTION

FIG. 1 is a top perspective view of a footwear upper showing
my new design;

FIG. 2 is a lateral elevational view thereof;

FIG. 3 is a medial elevational view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a top plan view thereof;

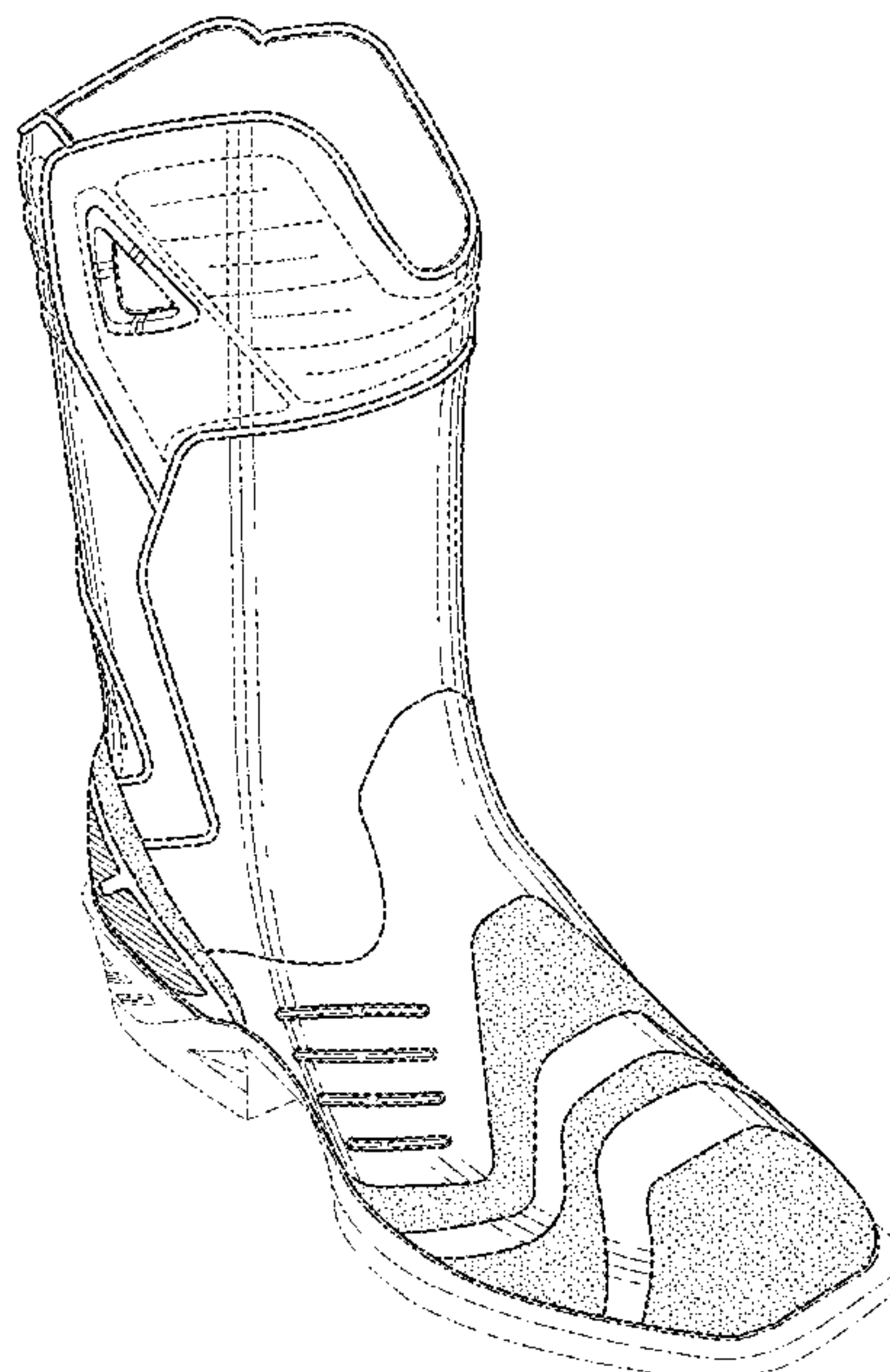
FIG. 6 is a front elevational view thereof; and,

FIG. 7 is a rear elevational view thereof.

The shaded areas of the toe and heel cap, illustrate a contrast-
ing appearance.

The even-length broken lines showing on the drawing disclo-
sure within the shaded area represent stitching, a claimed
element of the design. The uneven-length broken lines imme-
diately adjacent to the shaded area represent unclaimed
boundaries of the design and form no part of the claimed
design. The shading lines shown in the drawings represent the
three-dimensional contour of the design, and are not intended
to indicate surface decoration.

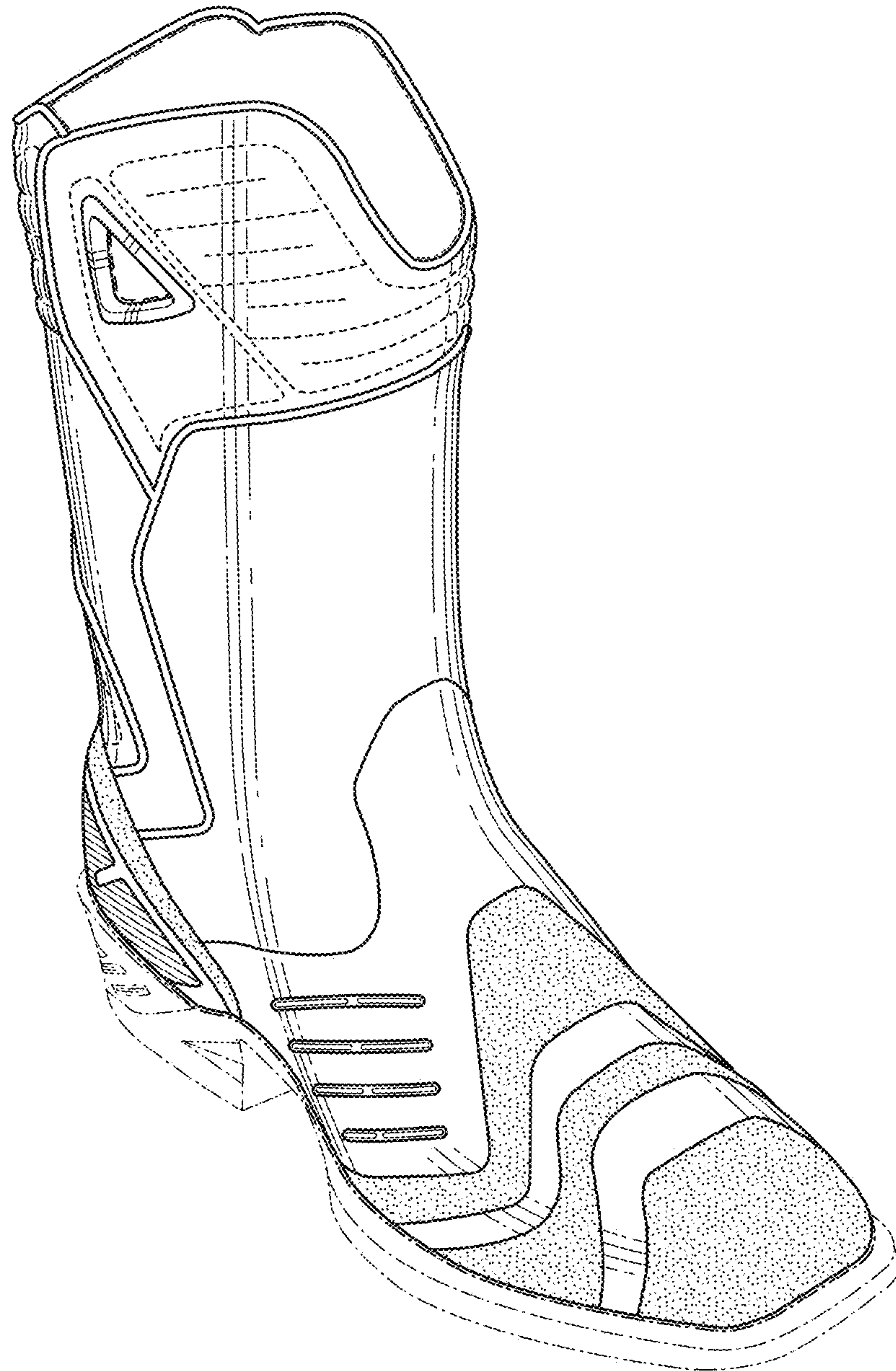

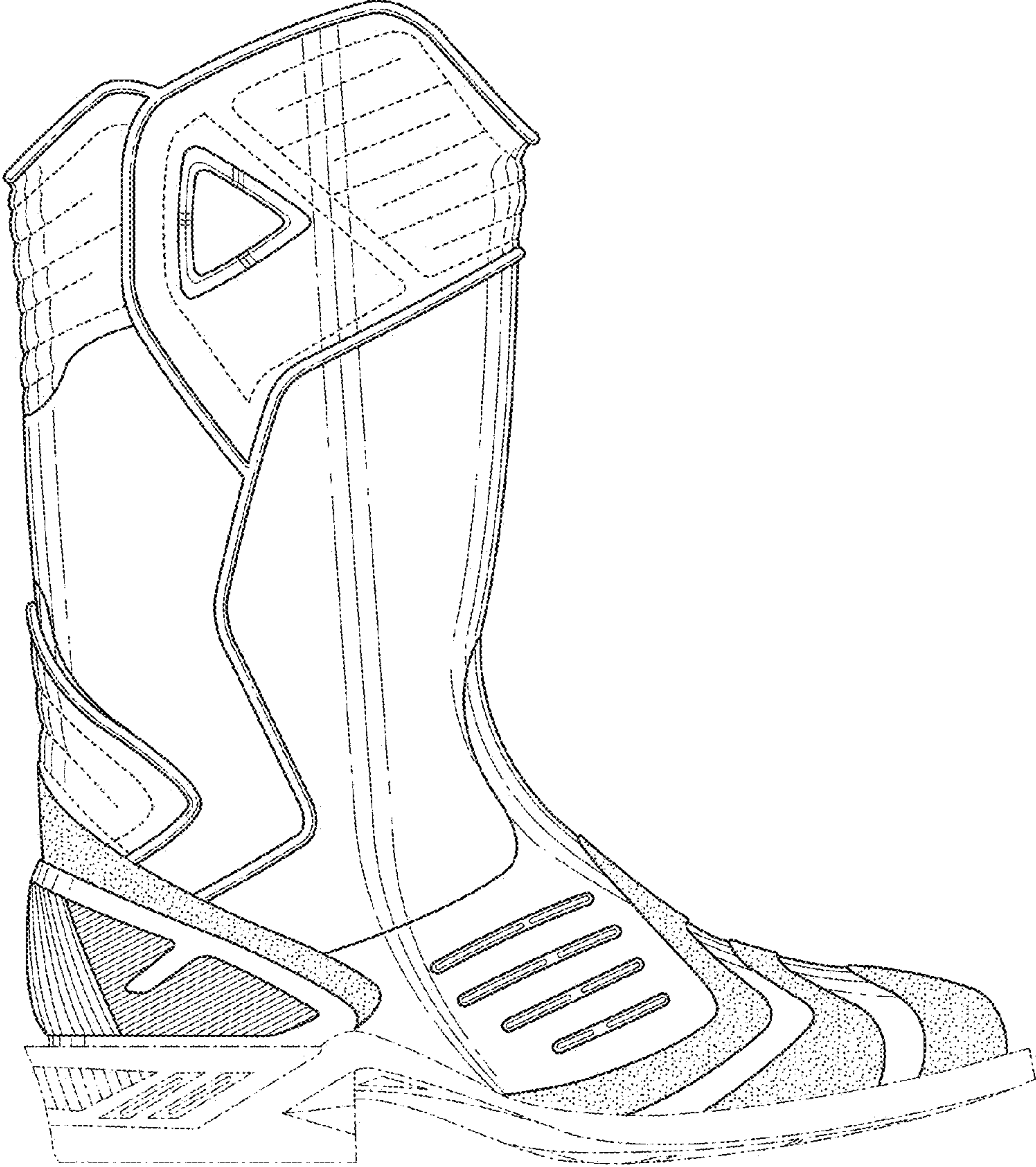

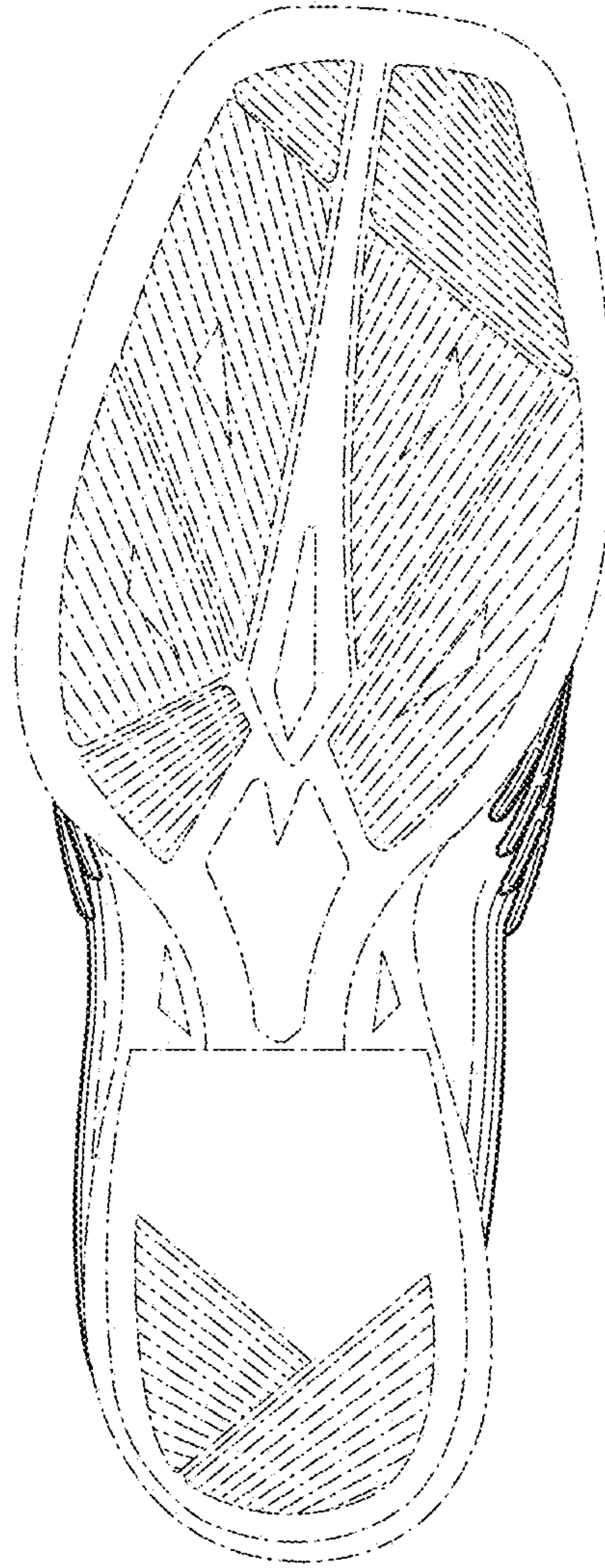

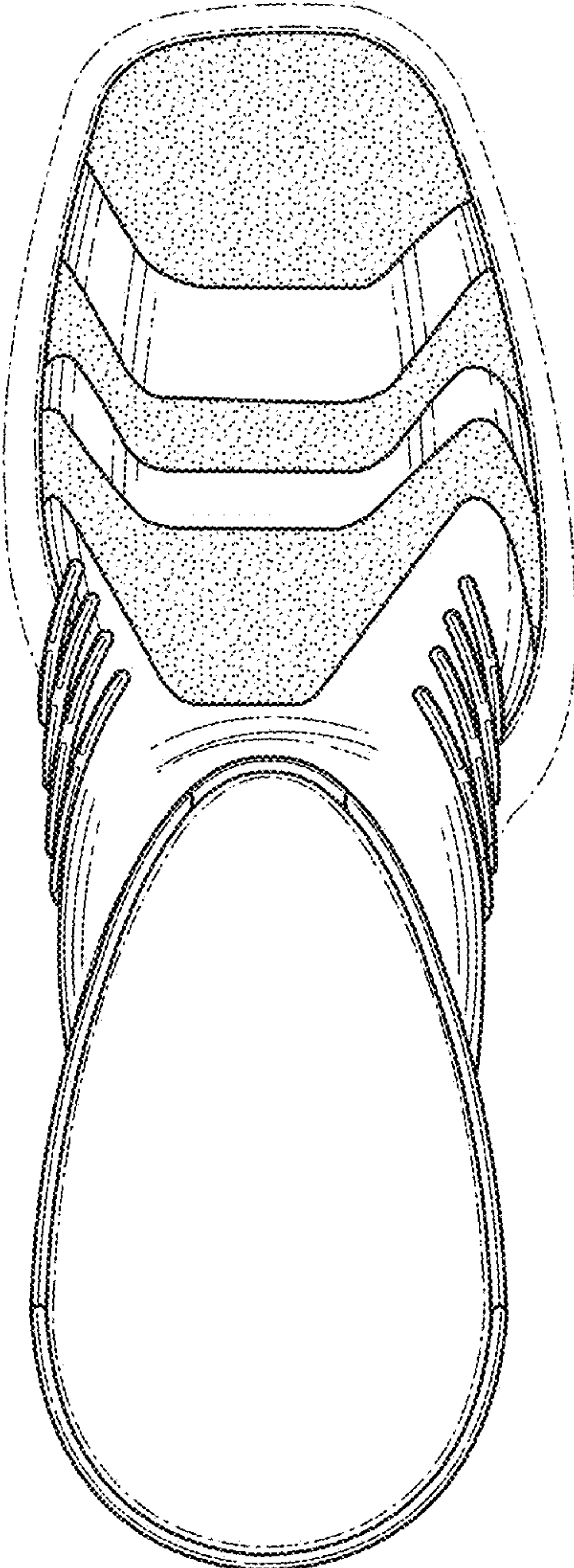

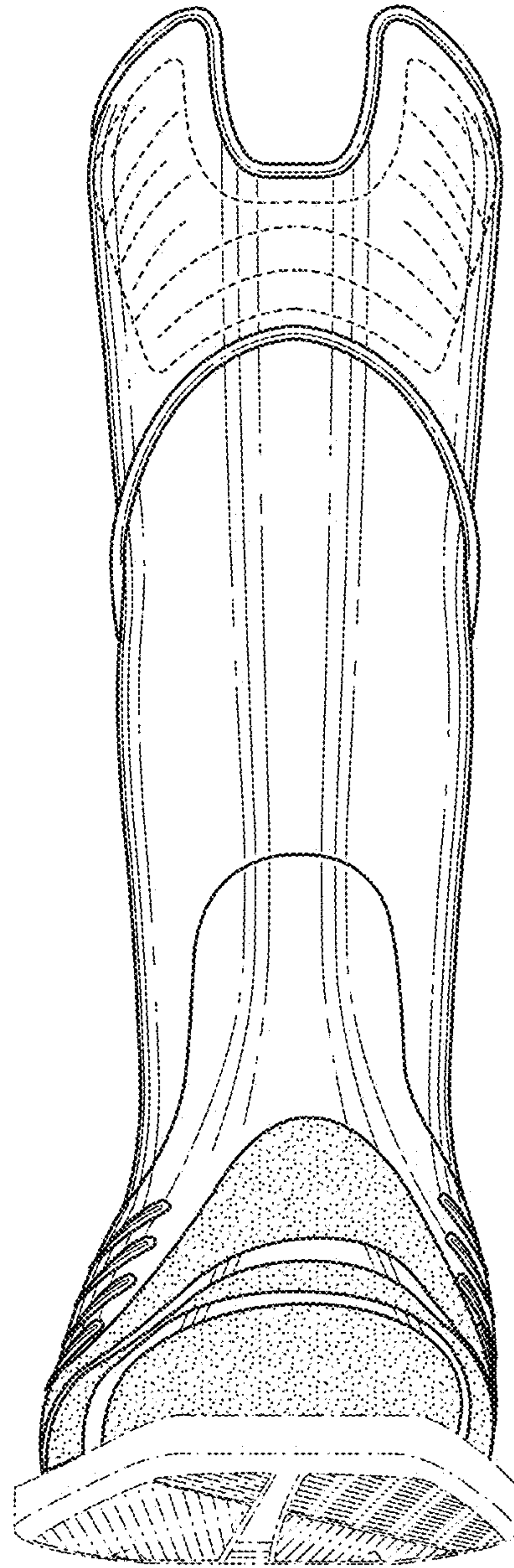

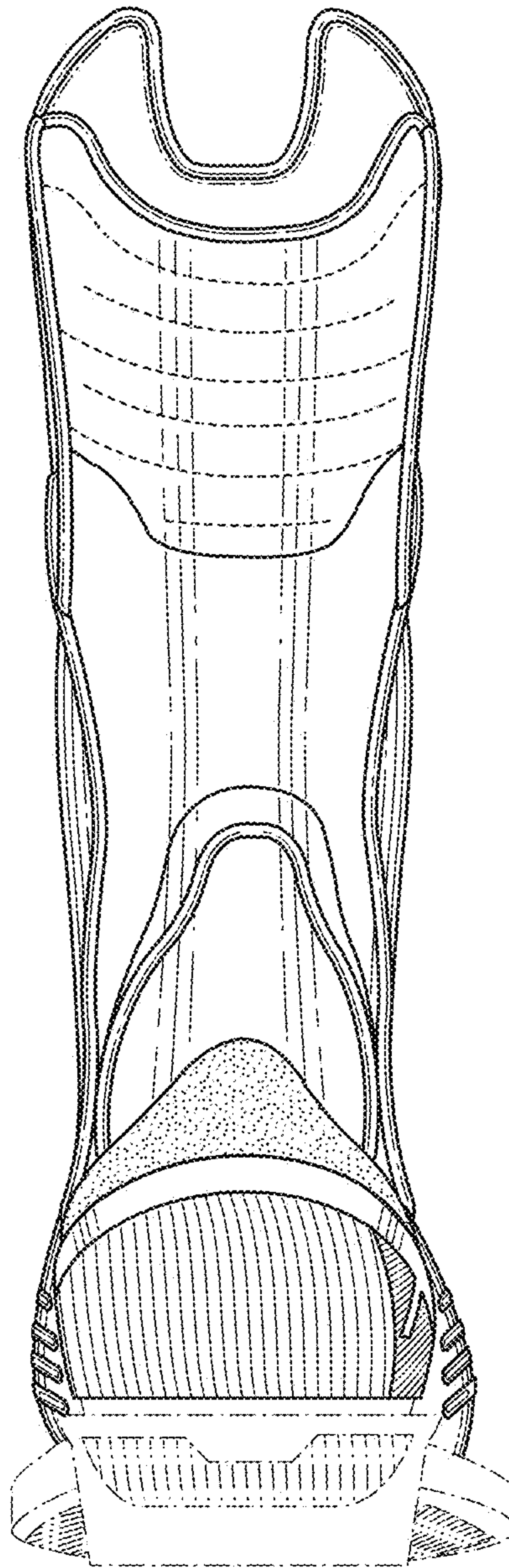
