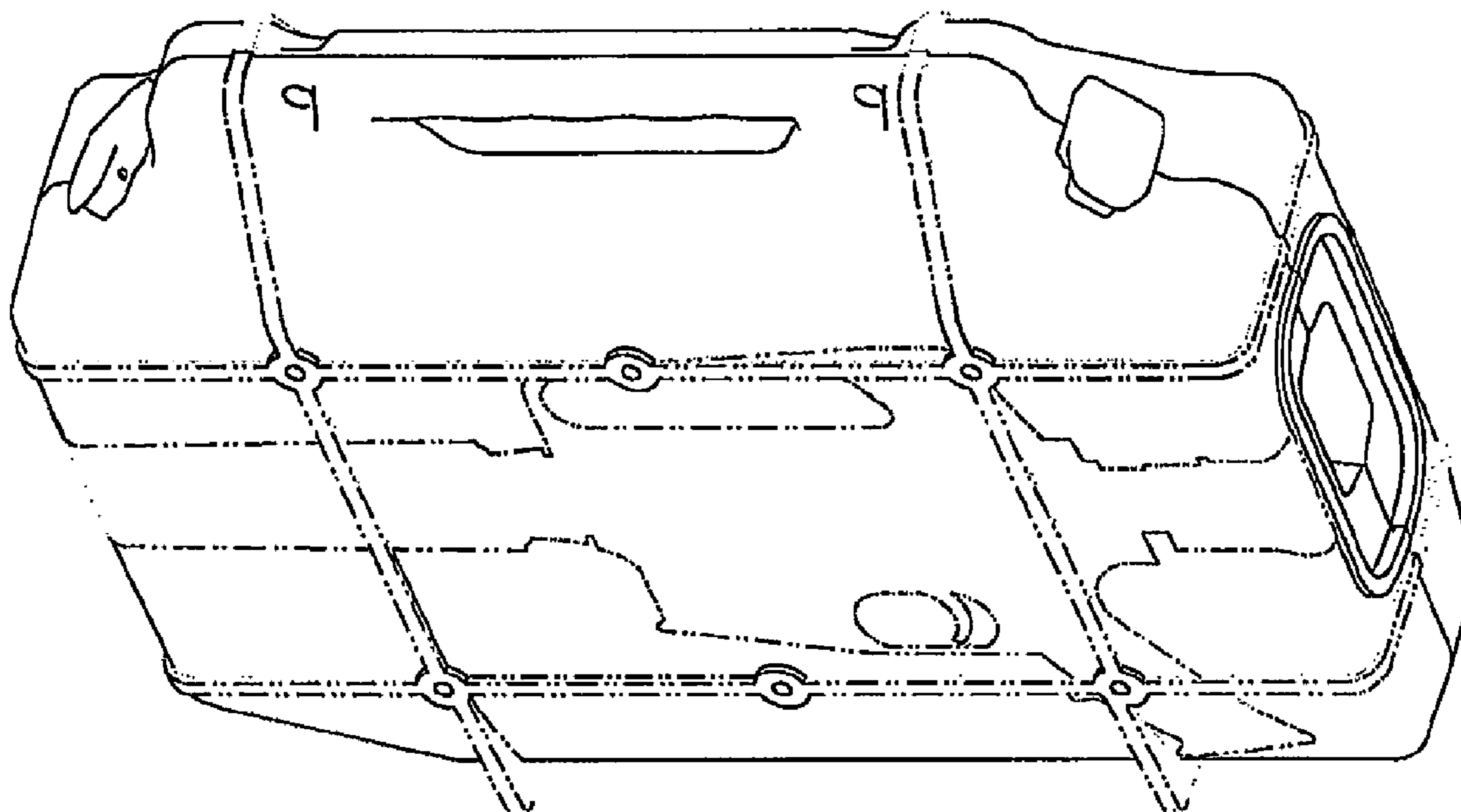
(57) **CLAIM**

The ornamental design for a compact case for tactical firearm, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of the inventive design. FIG. 2 is a second perspective view of the design in FIG. 1. FIG. 3 is a front view of the design in FIG. 1. FIG. 4 is a right view of the design in FIG. 1. FIG. 5 is a top view of the design in FIG. 1; and, FIG. 6 is a bottom view of the design in FIG. 1. 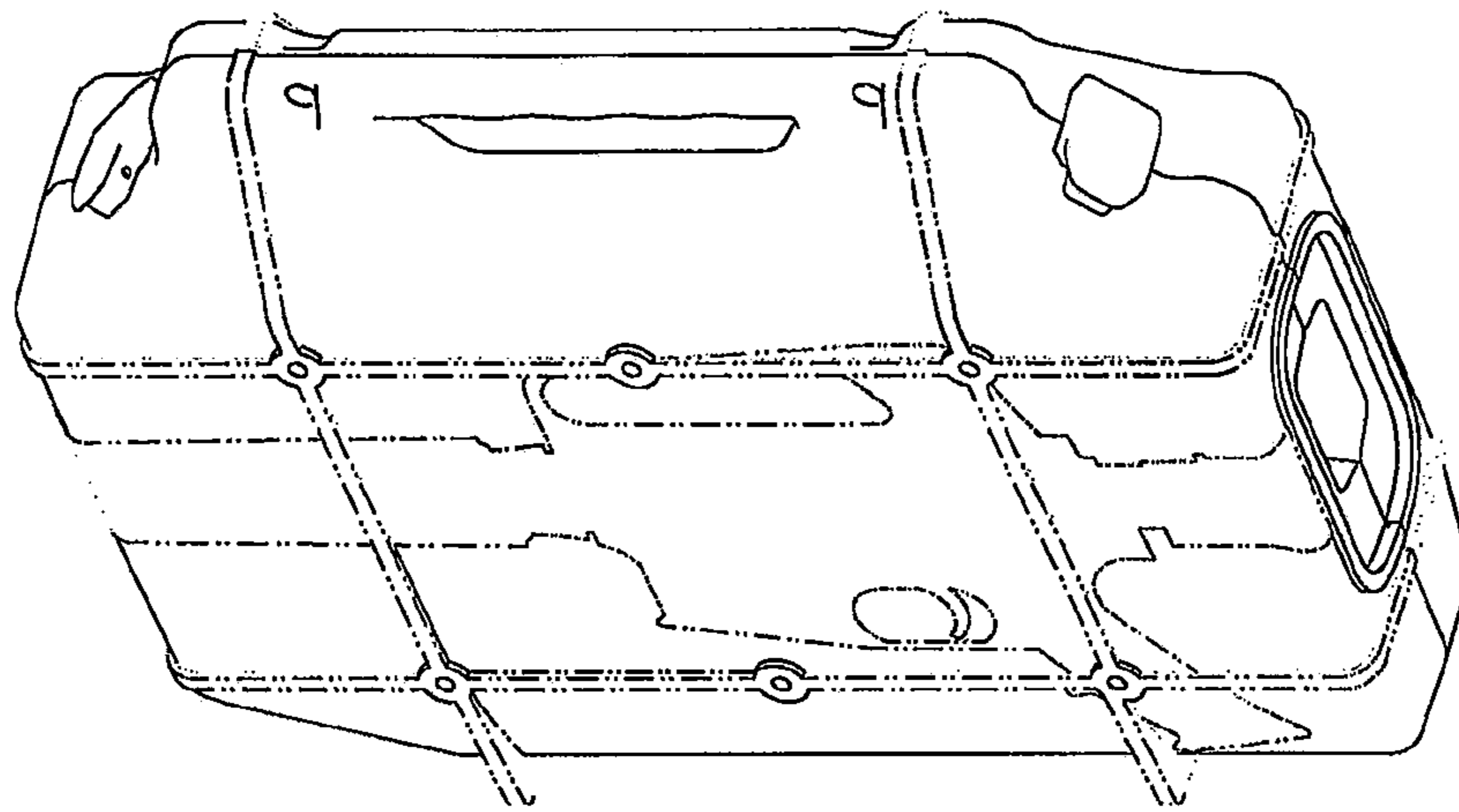

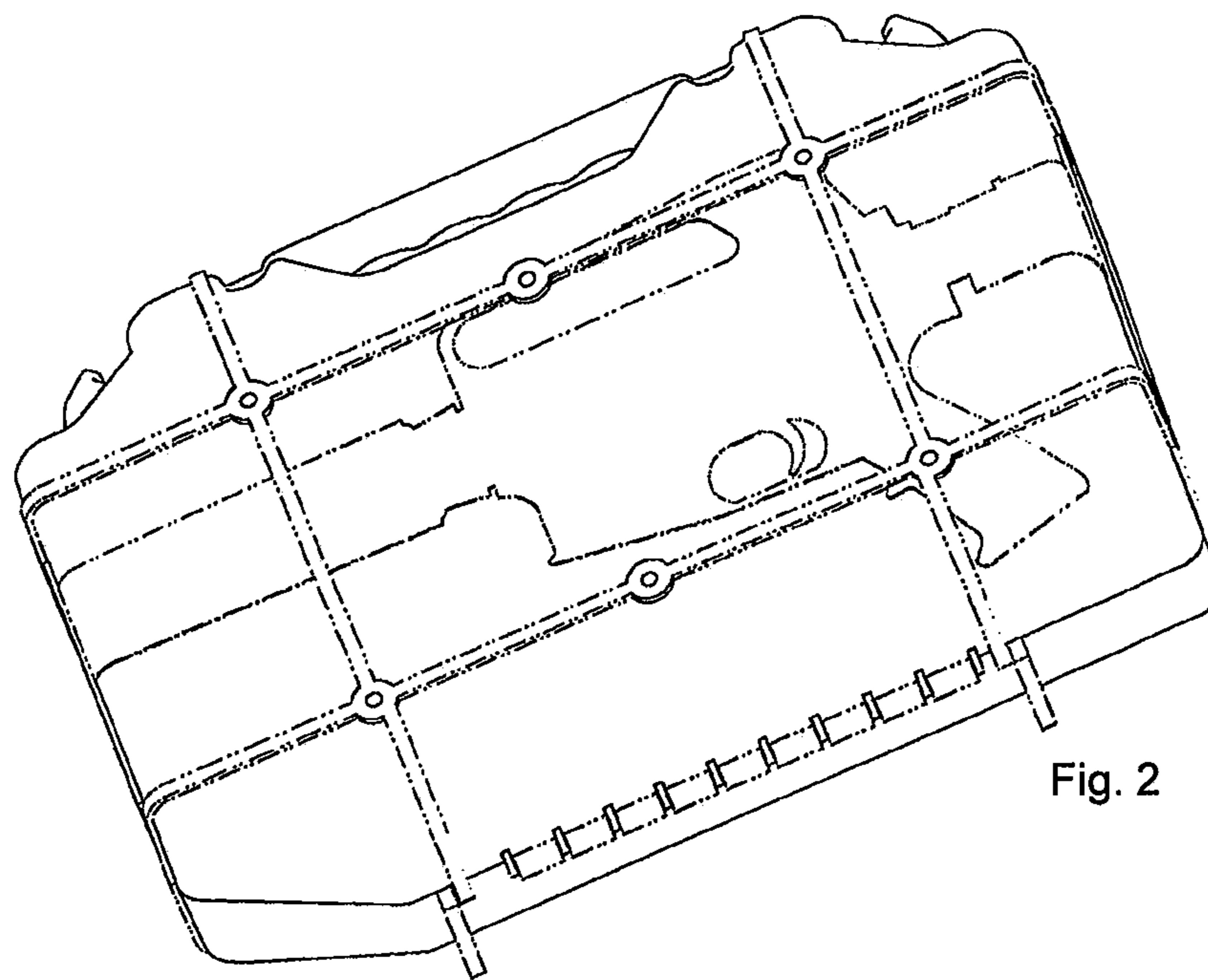

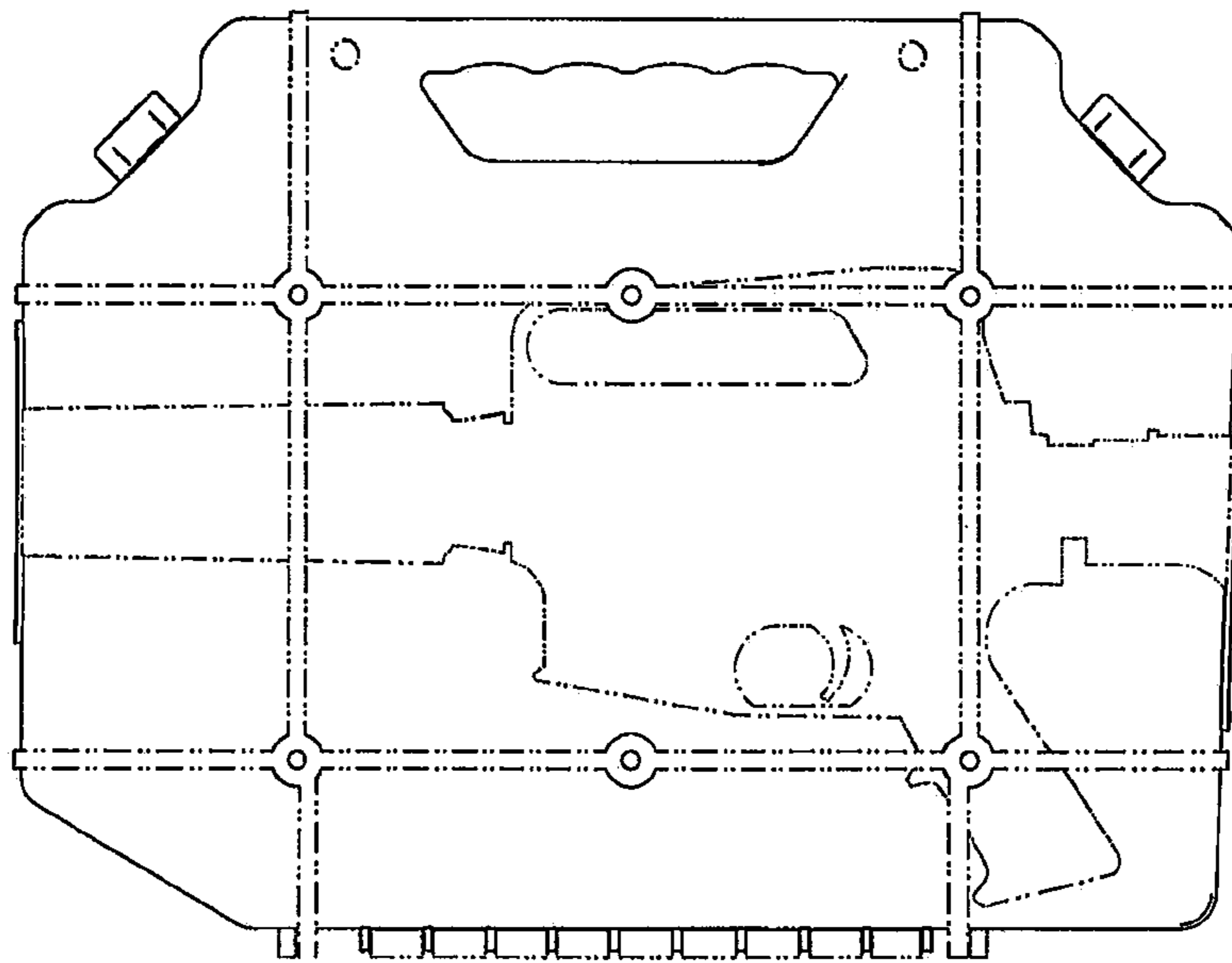

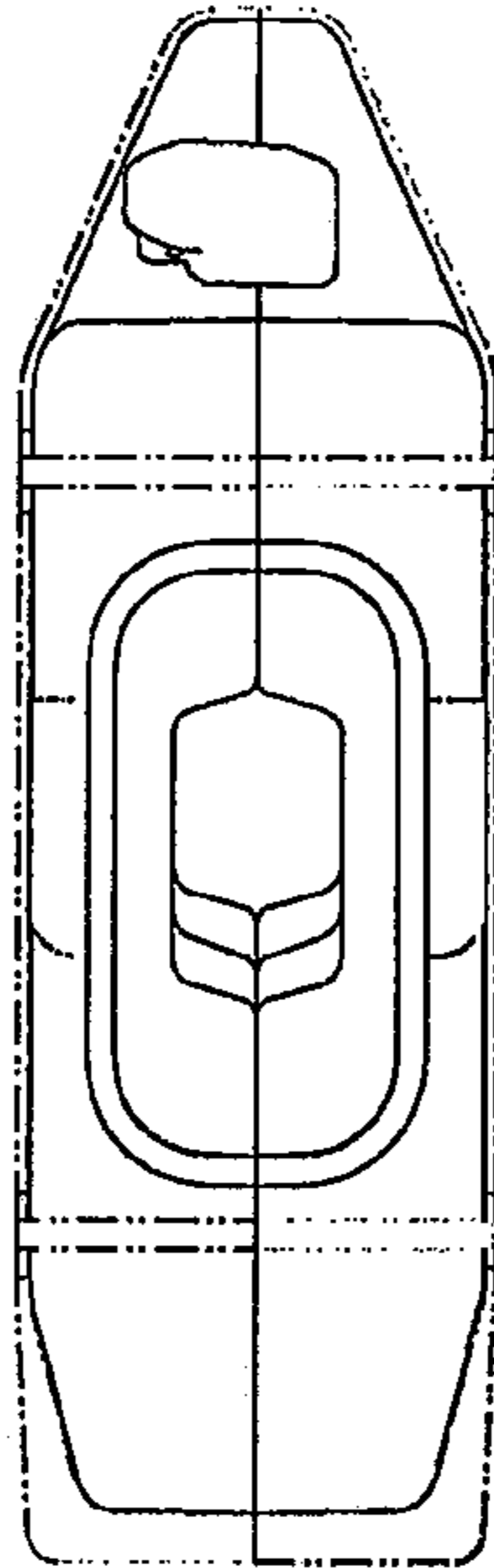

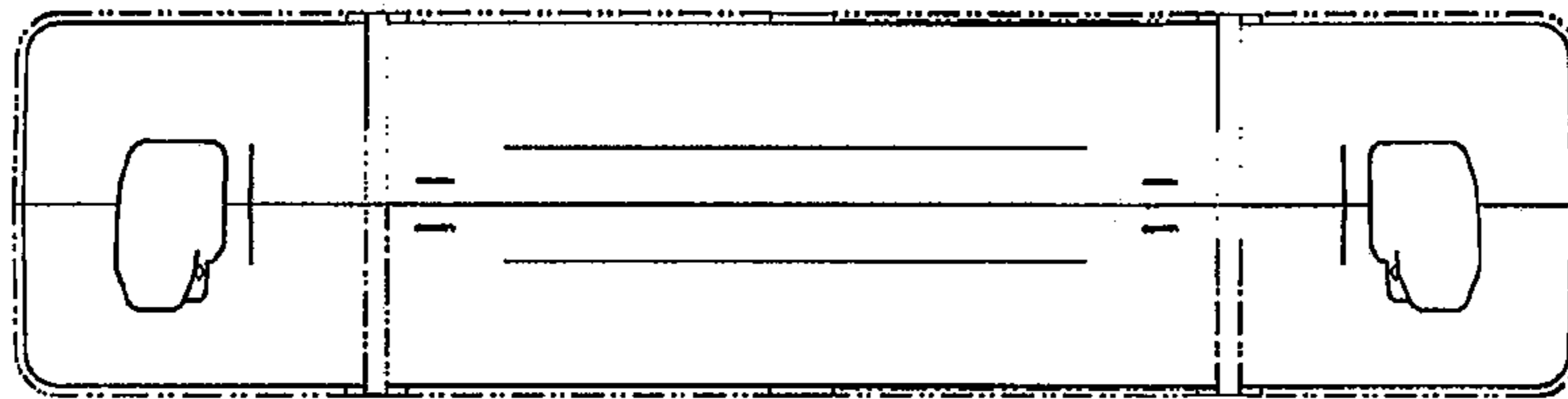

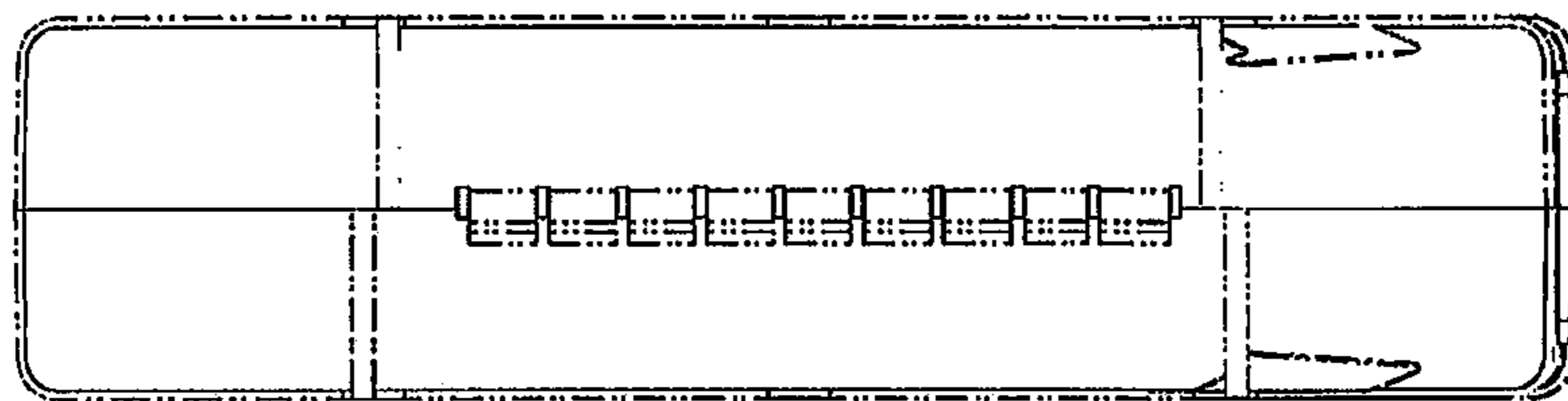
