described.

DESCRIPTION

FIG. 1 is a left perspective view of the spa chair of the present
invention, with the center portion of the footrest shown in a
raised position;

FIG. 2 is a left side view of the spa chair of the present
invention, with the center portion of the footrest shown in a
lowered position;

FIG. 3 is a right side view thereof;

FIG. 4 is a front view thereof;

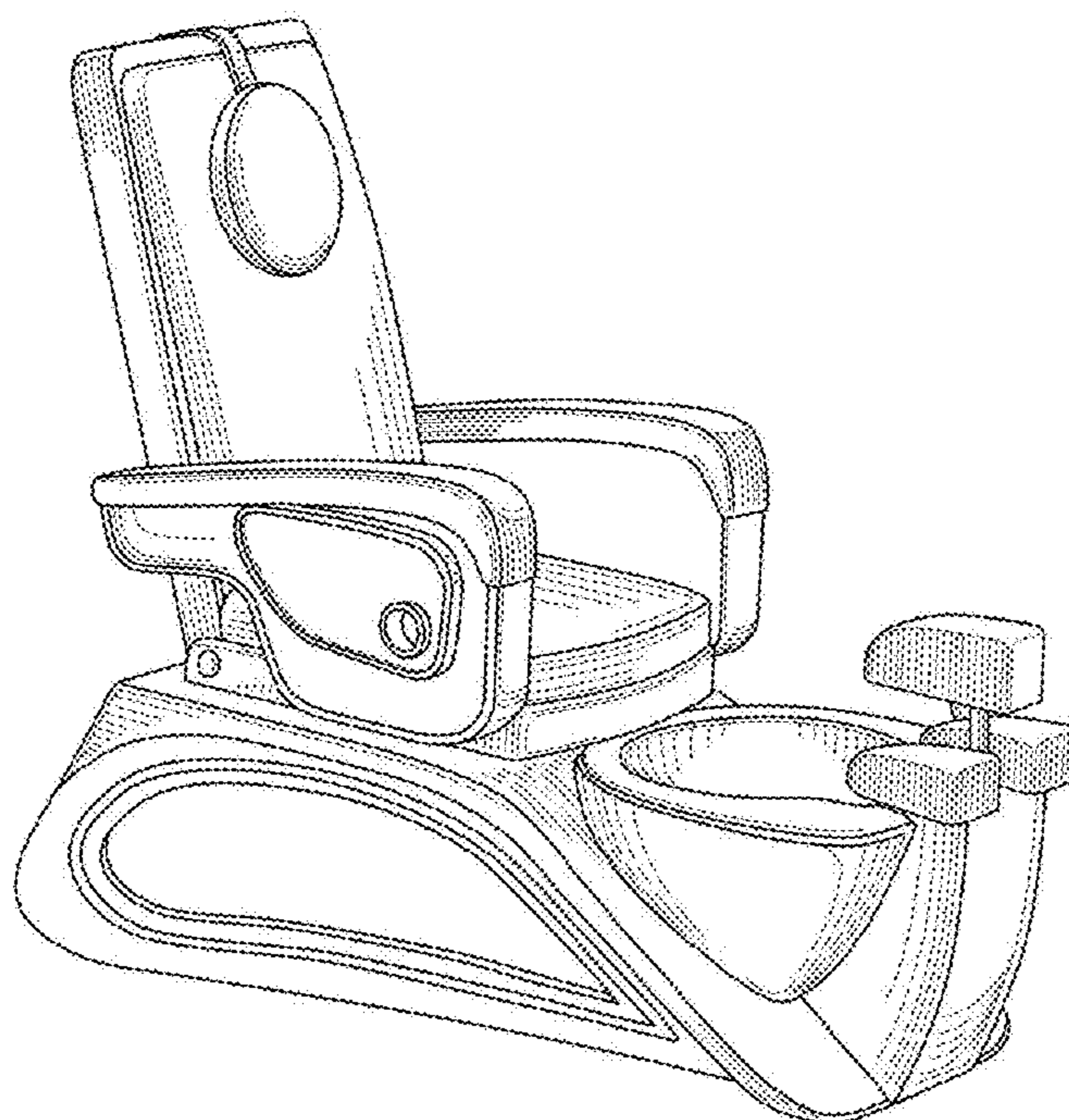
FIG. 5 is a rear view thereof;

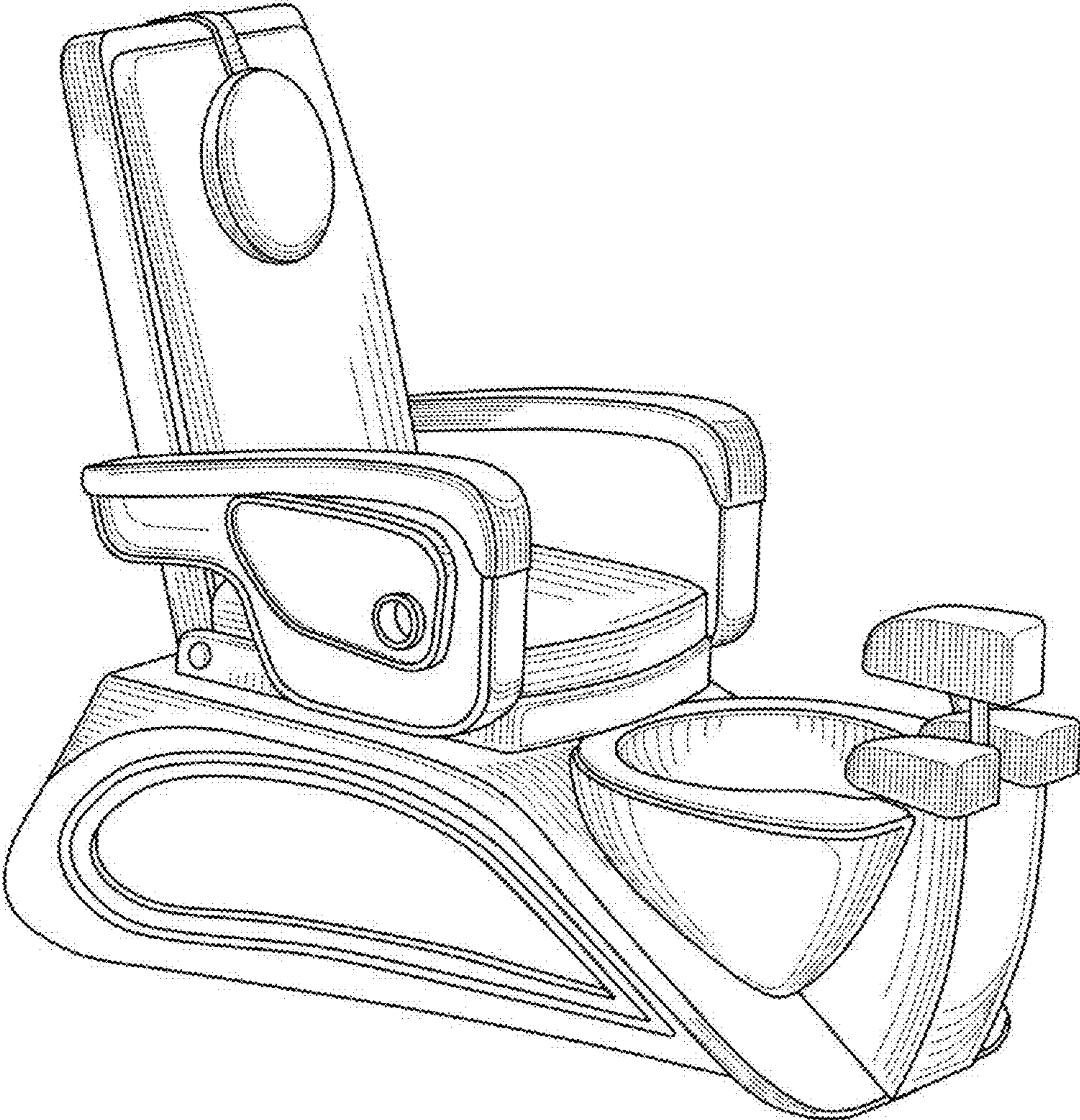

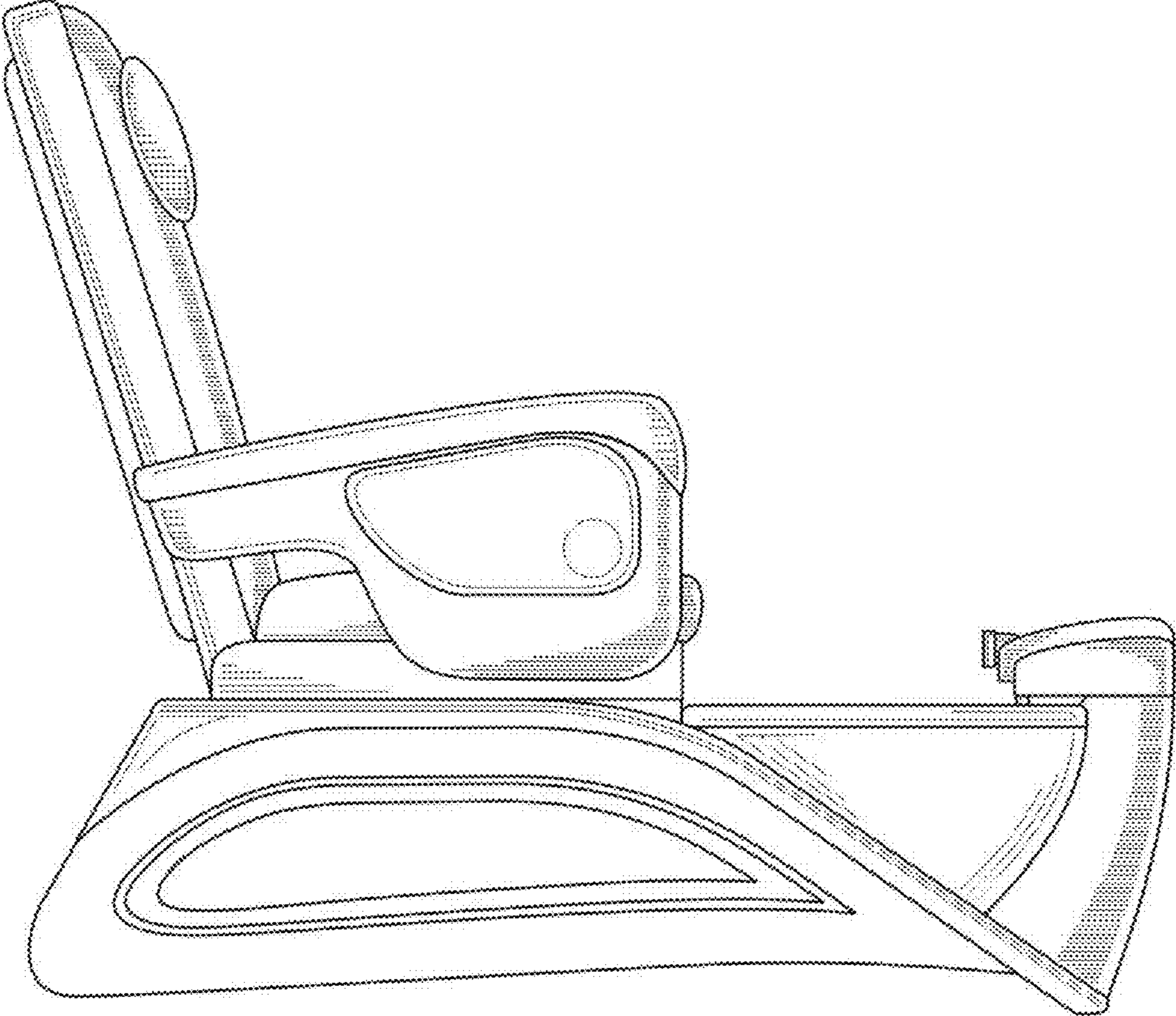

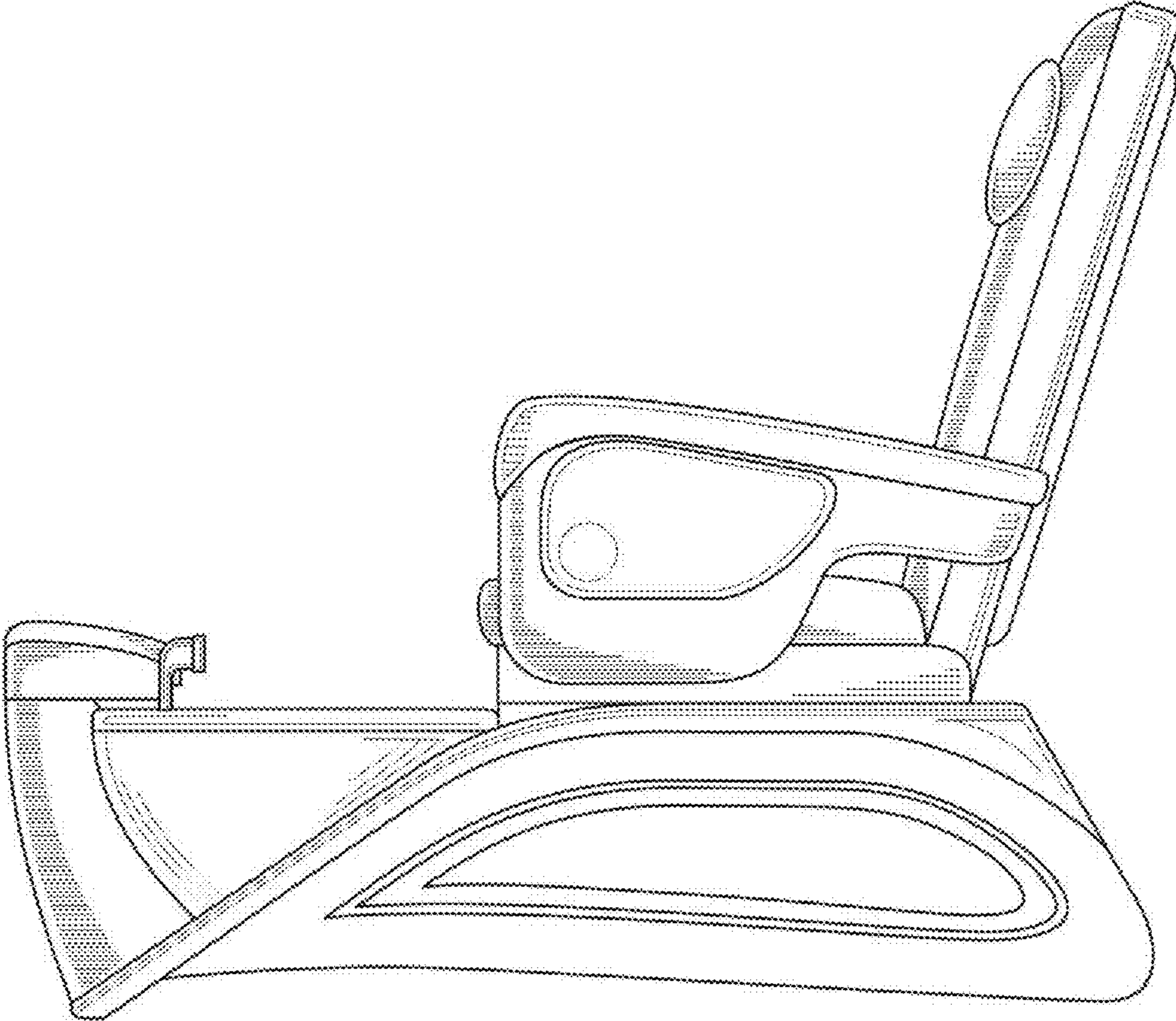

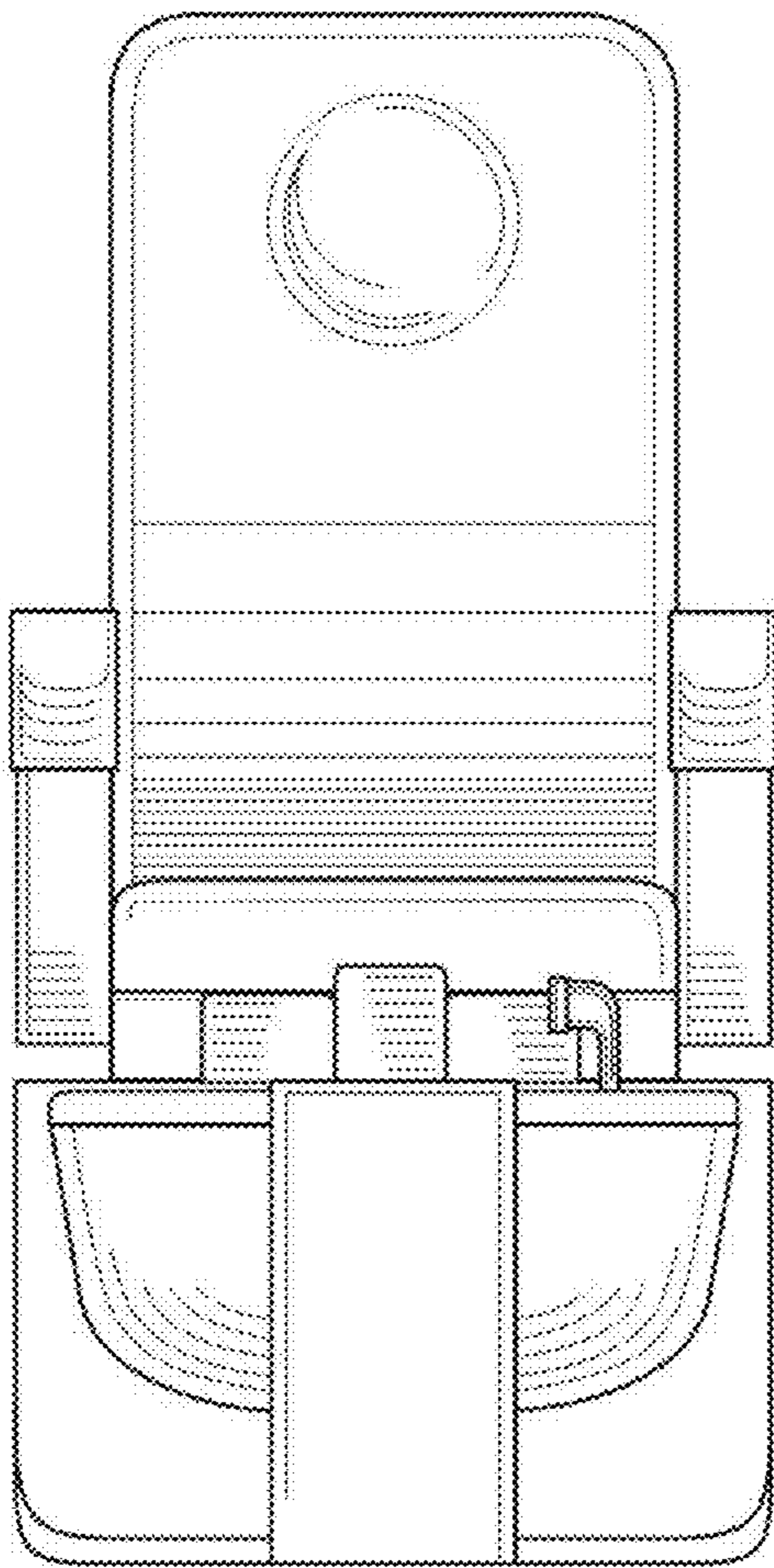

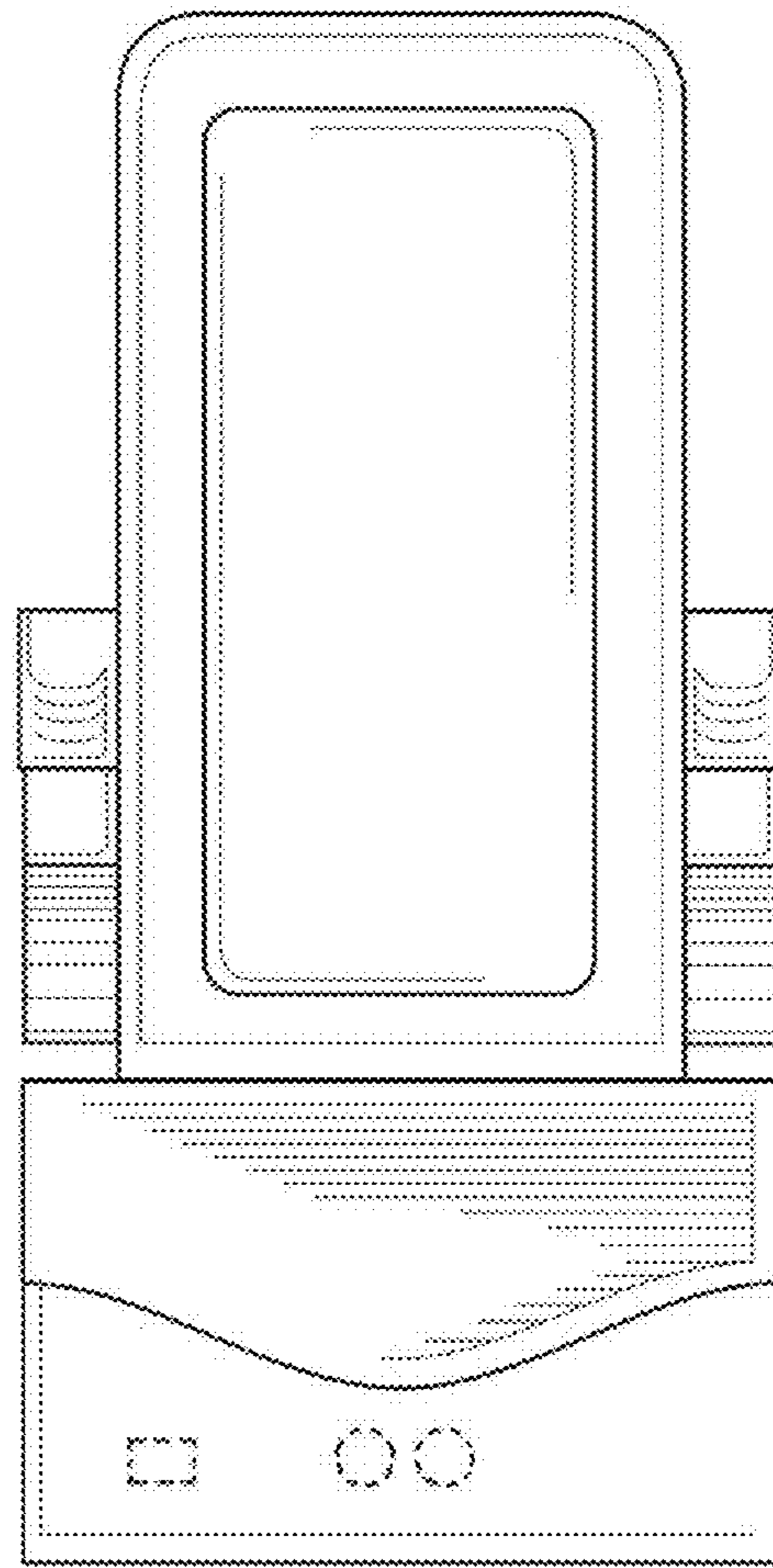

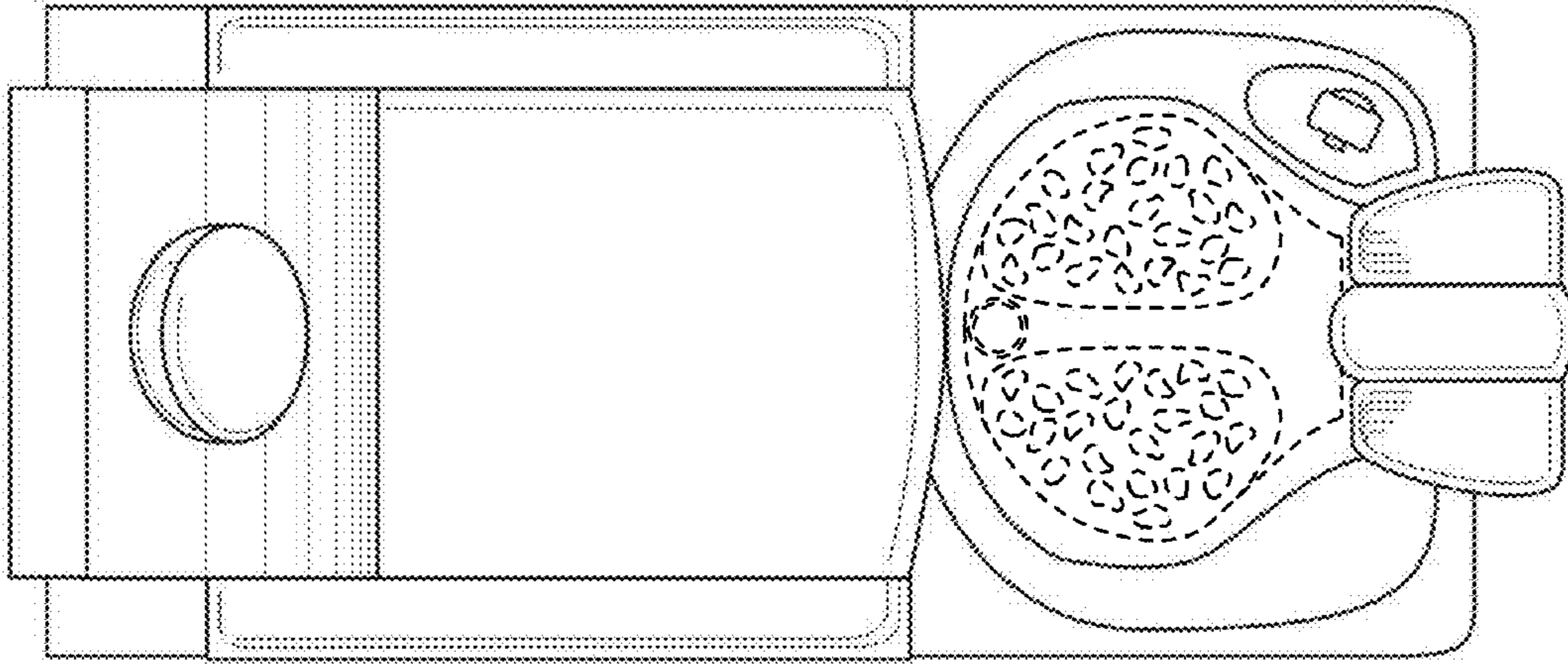

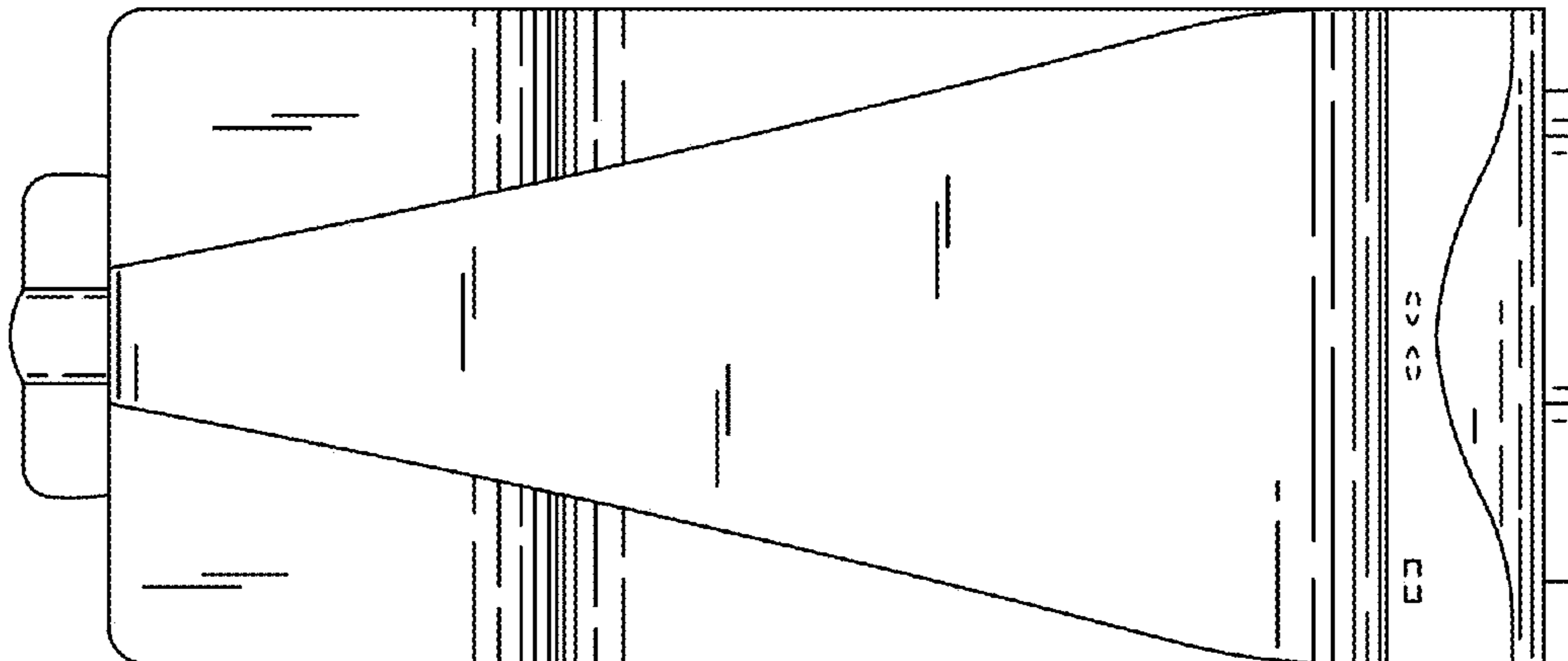
