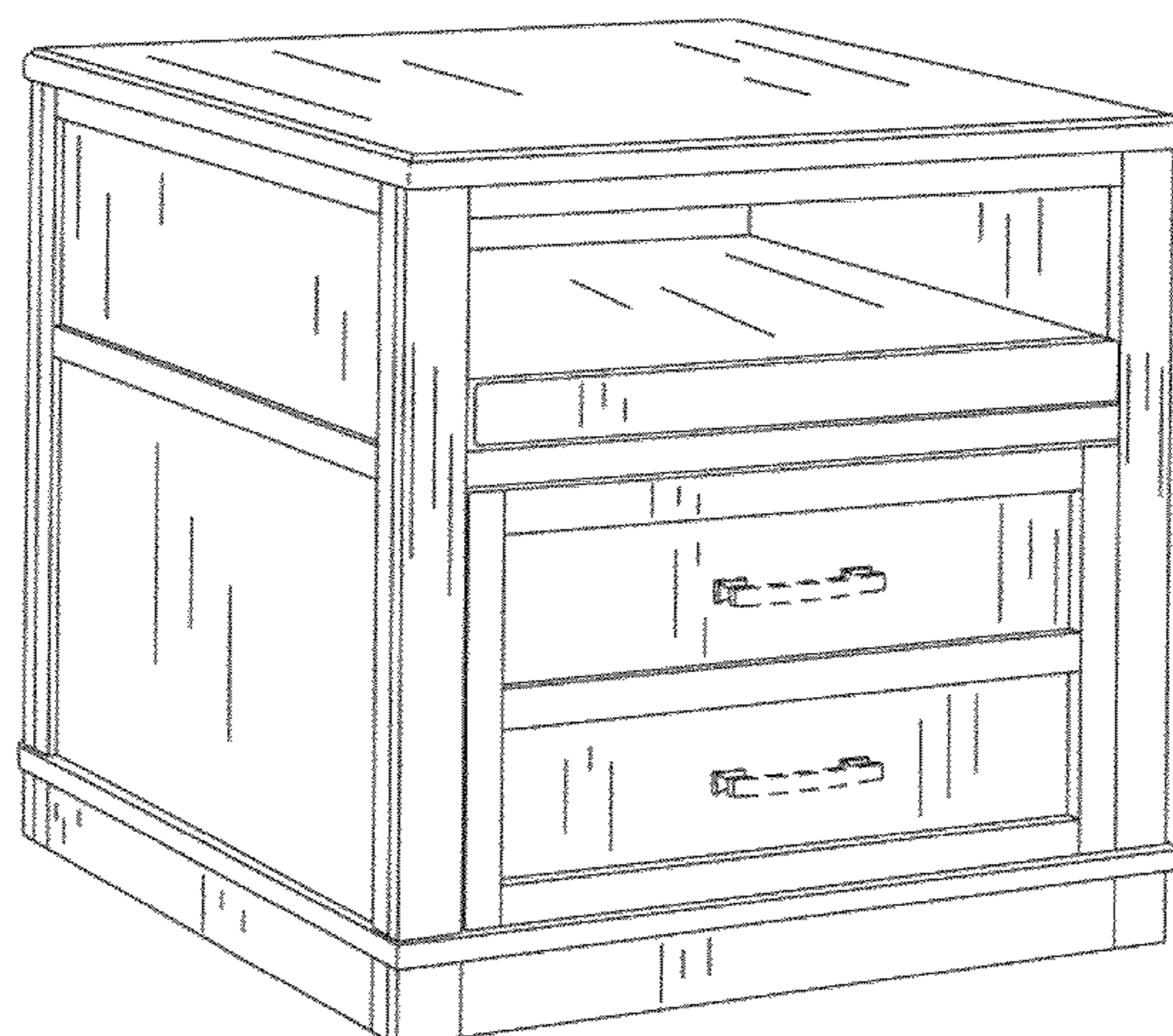
(57) **CLAIM**

The ornamental design for a table, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a table showing our new design with a pull-out tray in closed position;
FIG. 2 is a right side elevation view thereof with the pull-out tray in an open position;
FIG. 3 is a top plan view with the pull-out tray in closed position;
FIG. 4 is a front perspective view with the pull-out tray in closed position; and,
FIG. 5 is a front perspective view with the pull-out tray in an open position.
The dashed broken lines illustrating portions of the table are for environmental purposes only and form no part of the claimed design. Views of the table not shown in the figures form no part of the claimed design.

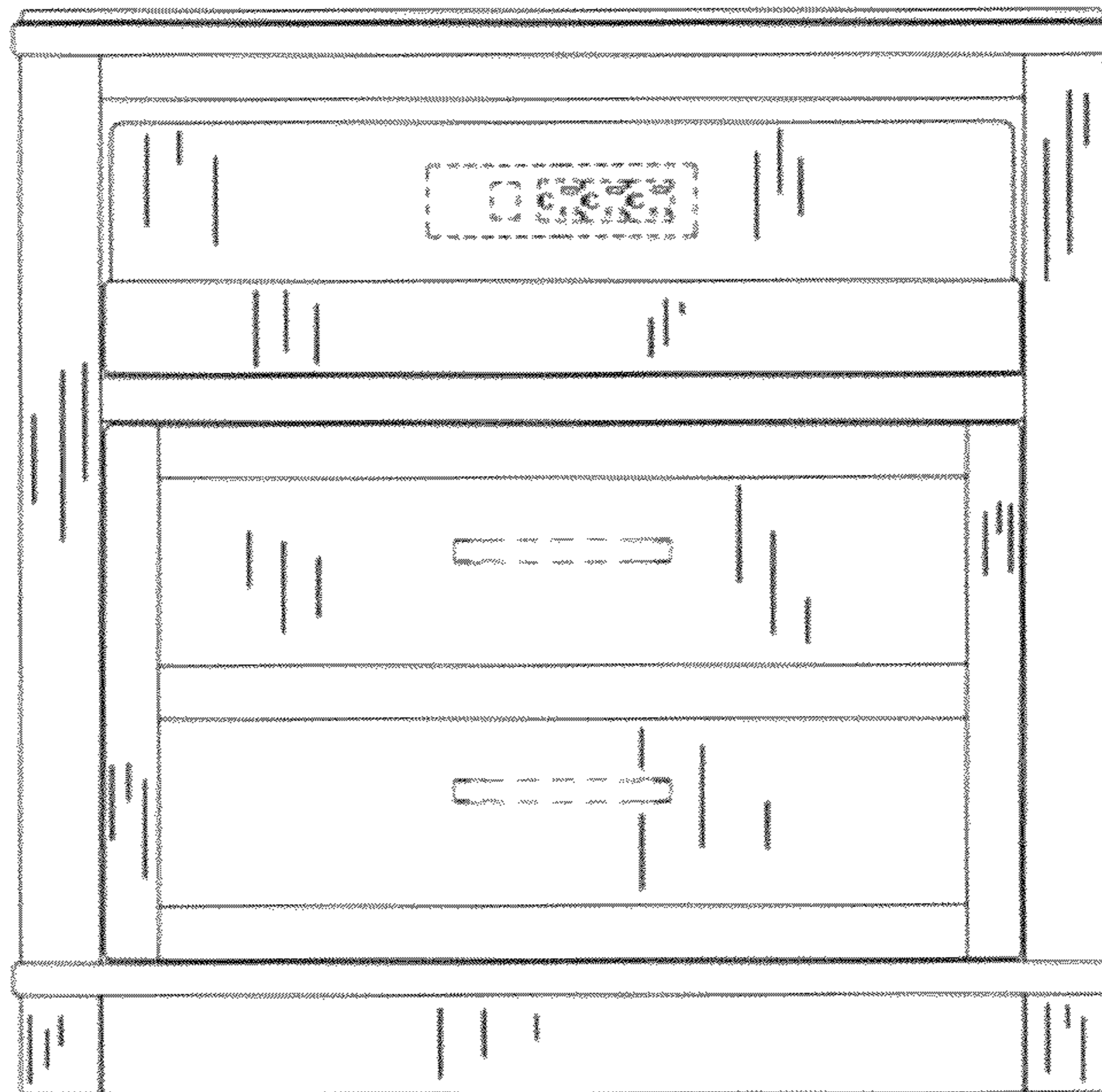

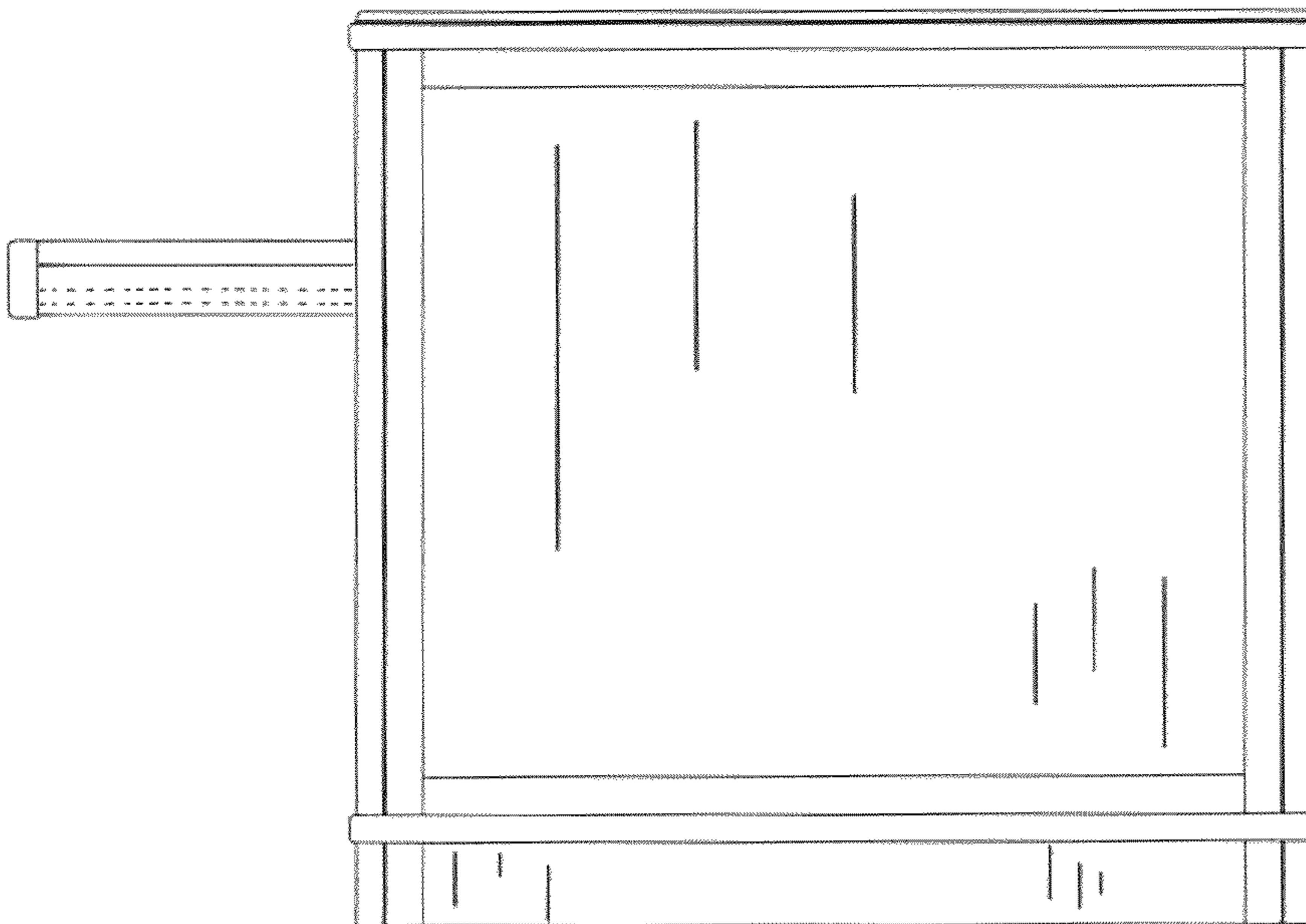

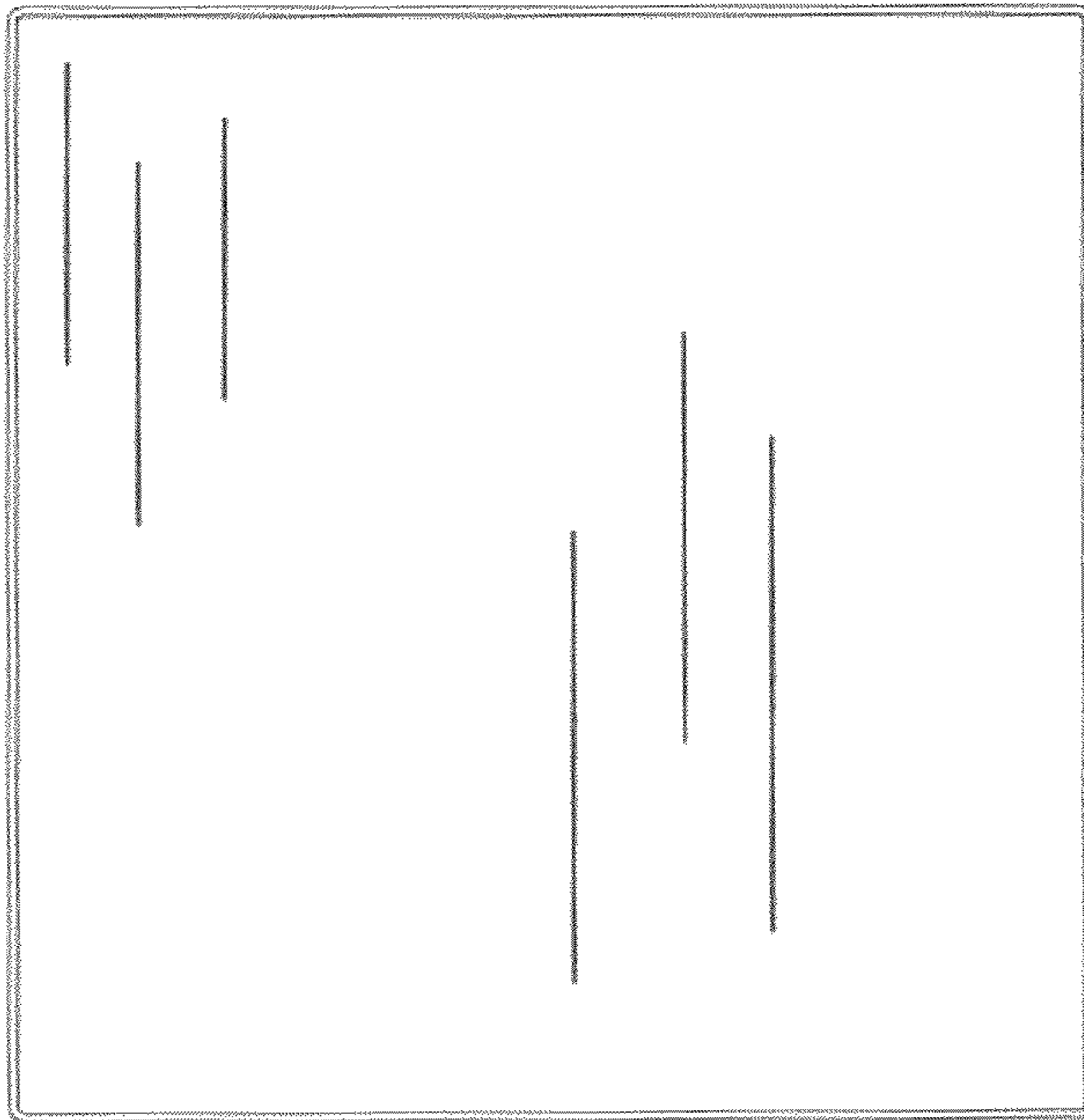

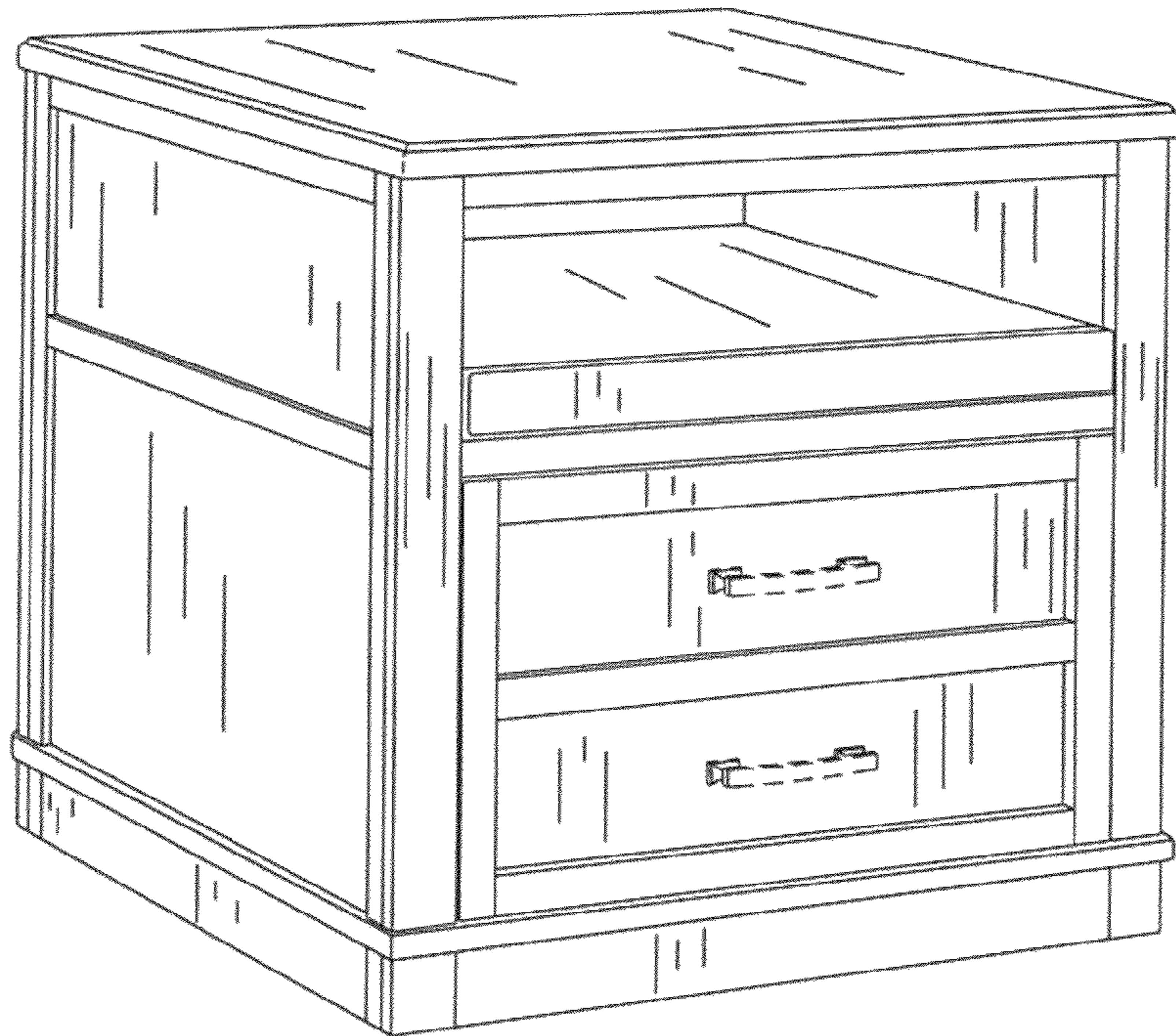

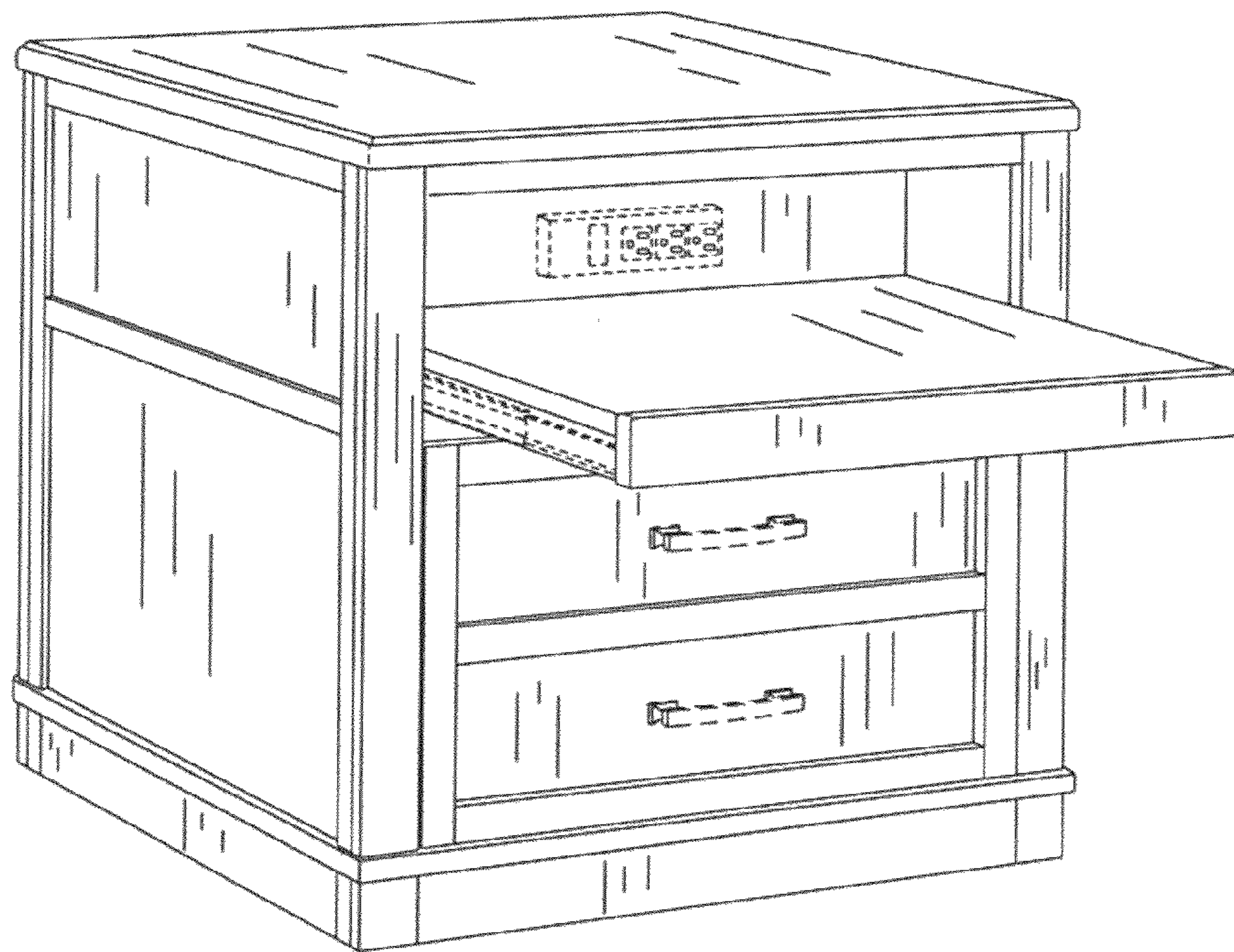
