FIG. 7 is a bottom view thereof;

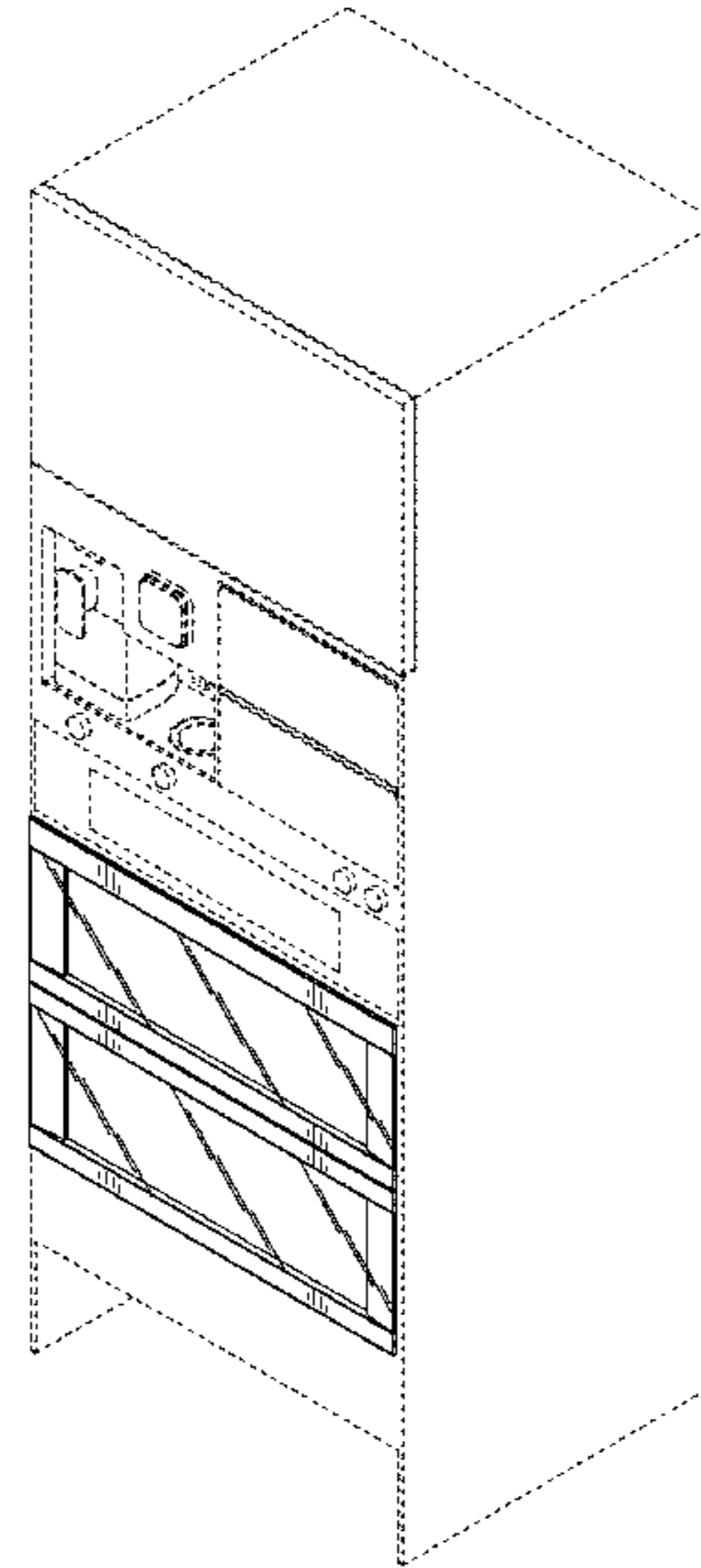
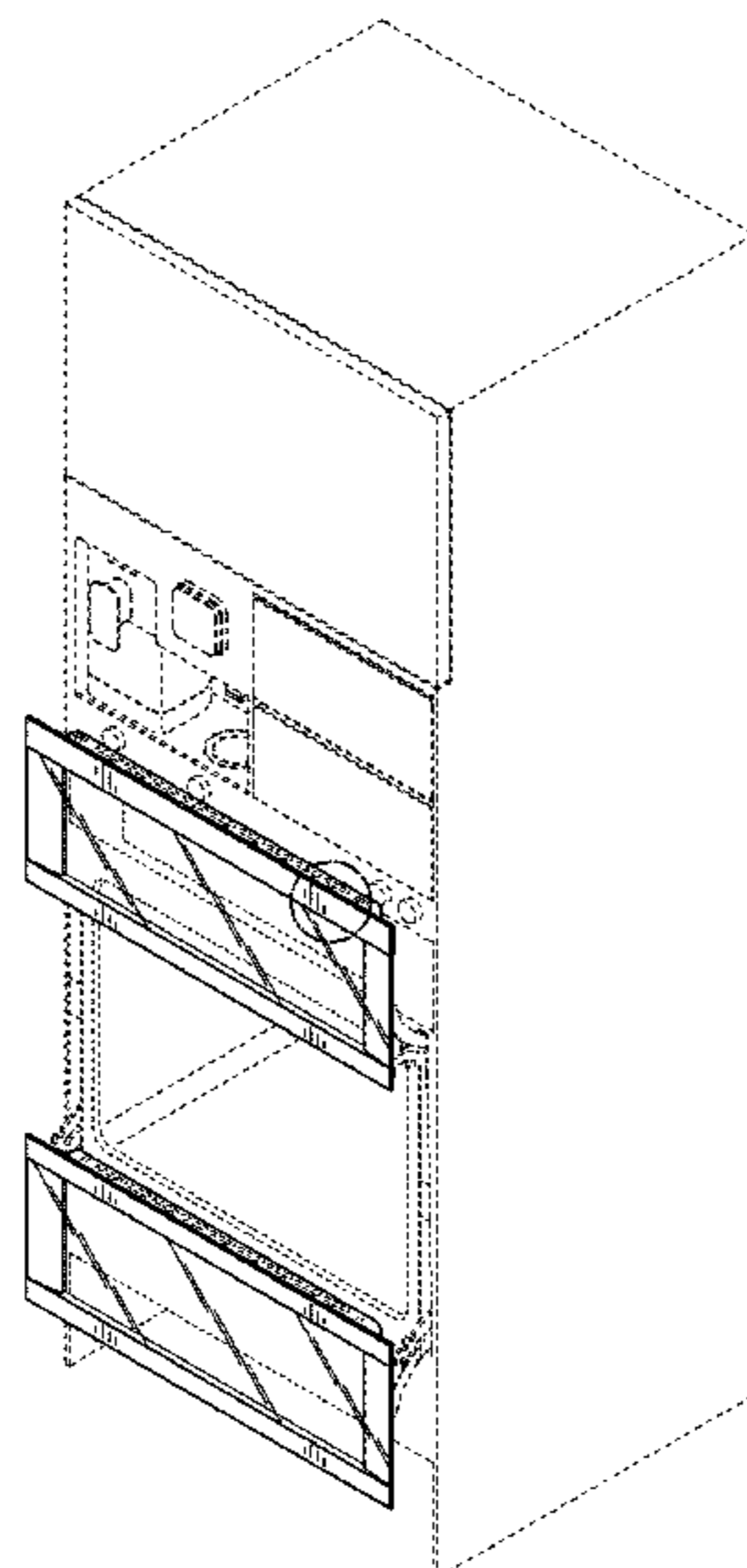
FIG. 8 is another front perspective view, in which the oven is provided in an alternate position; and,

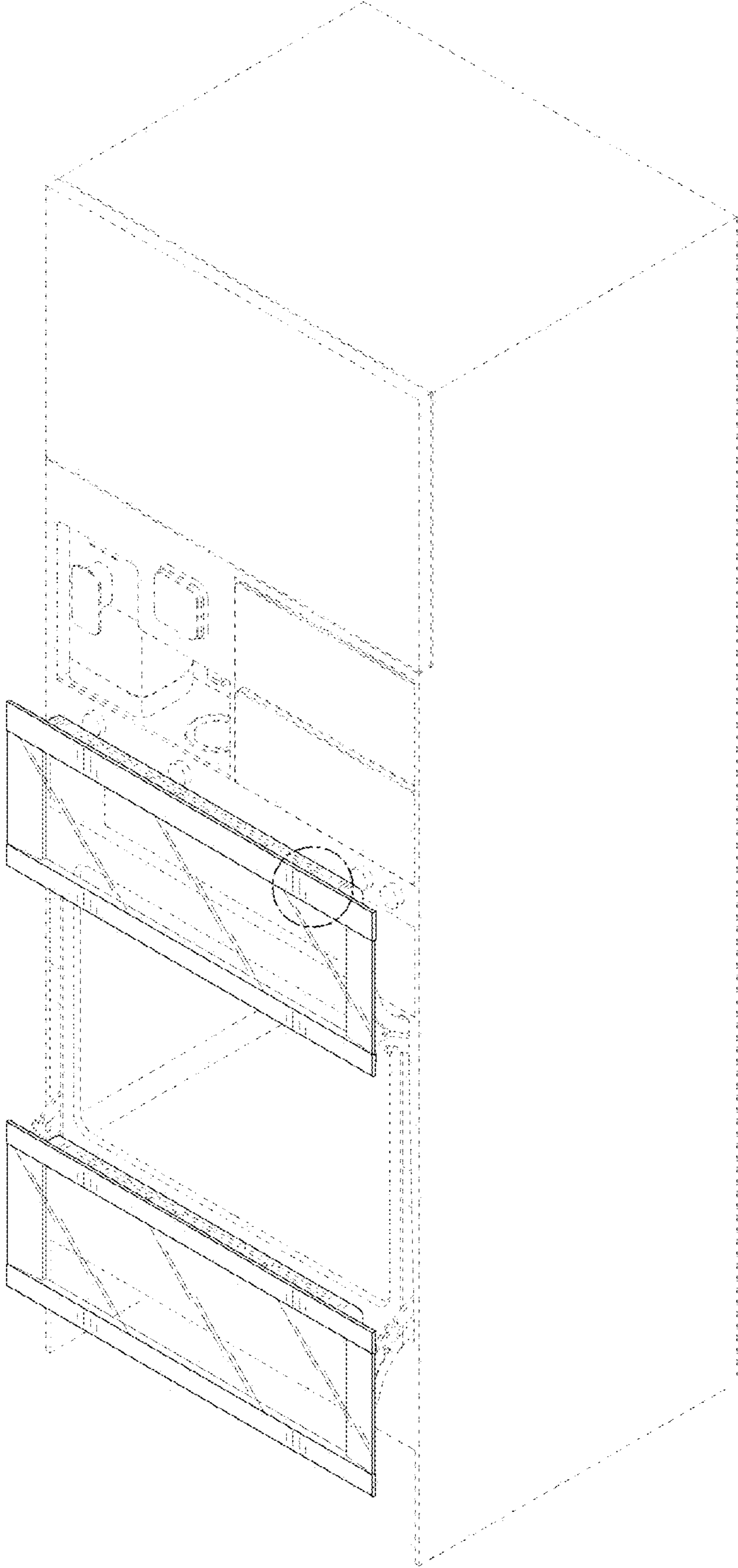

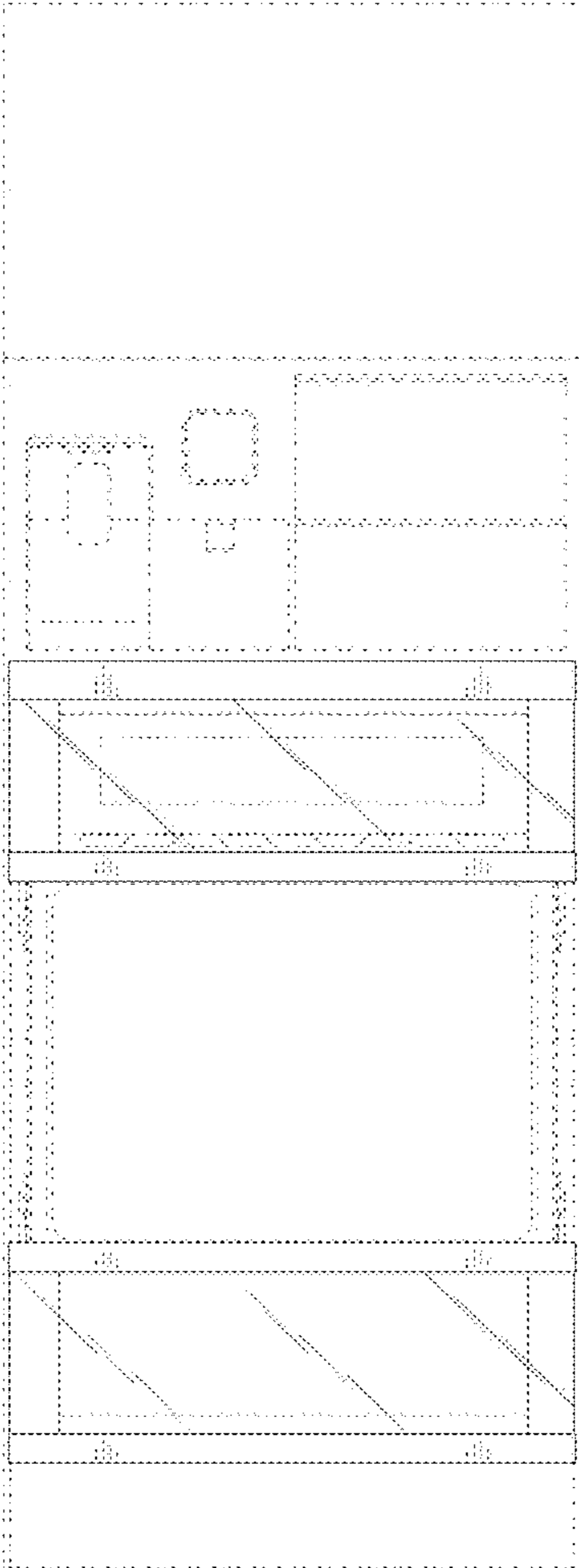

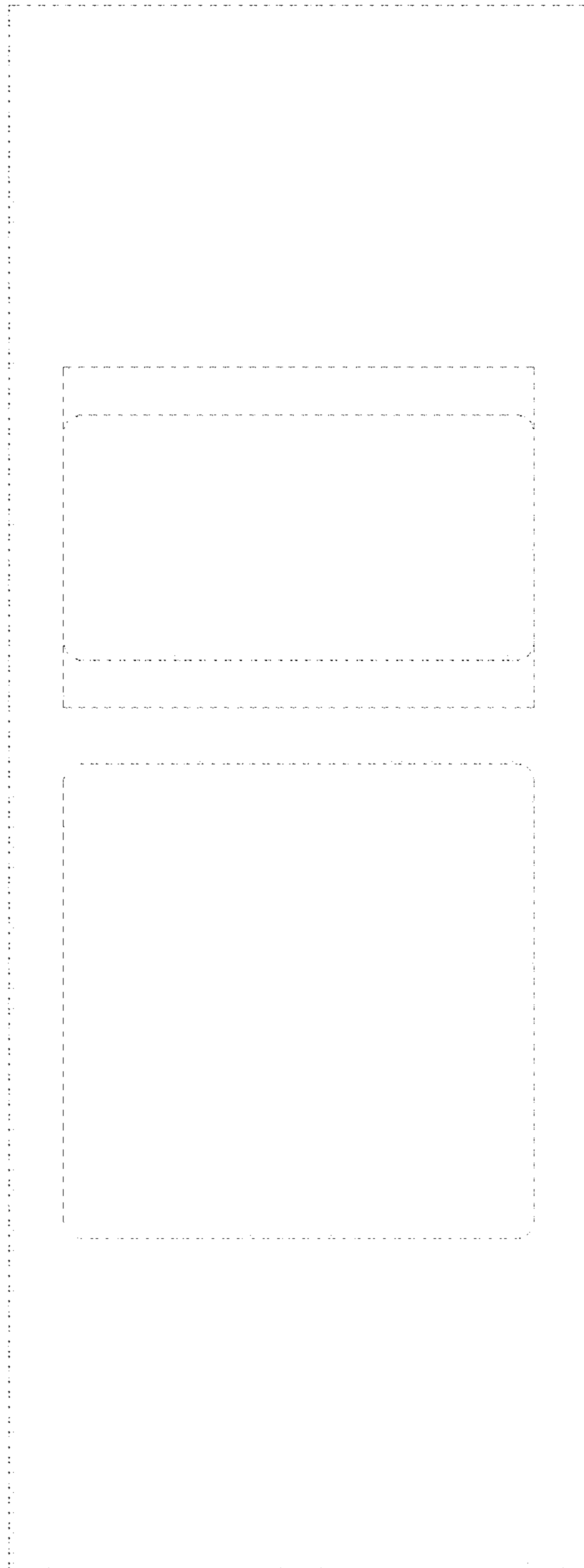

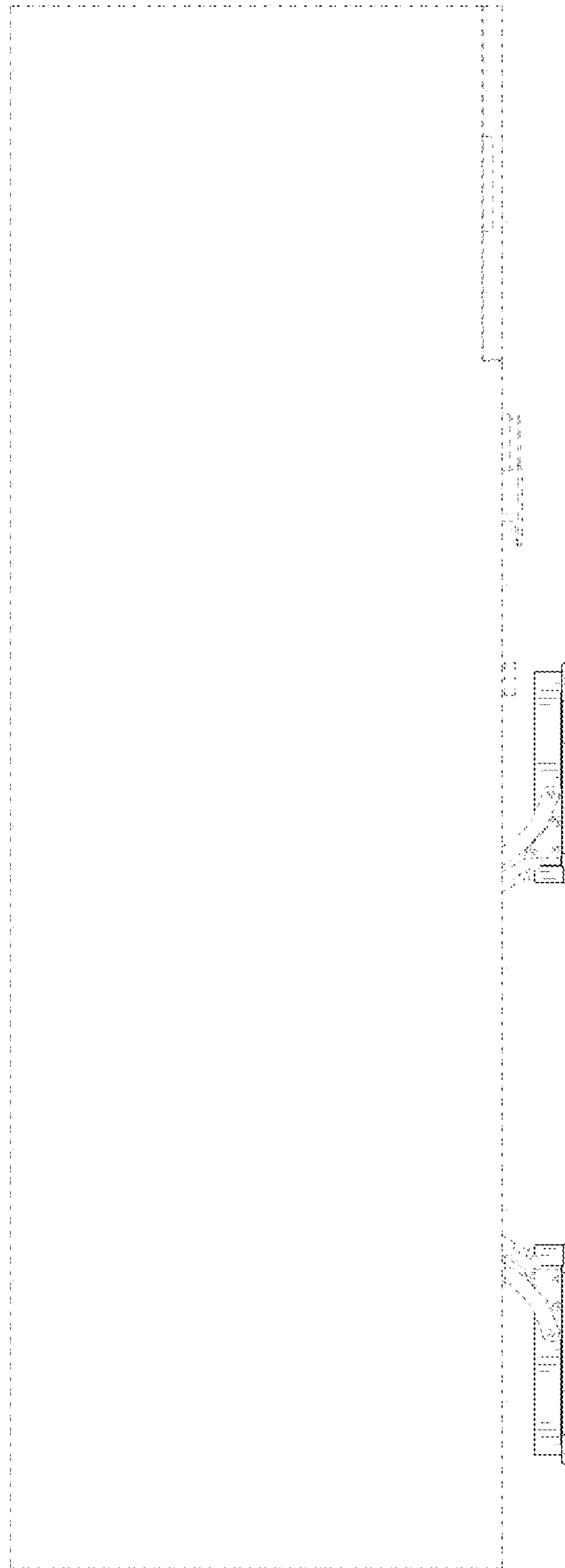

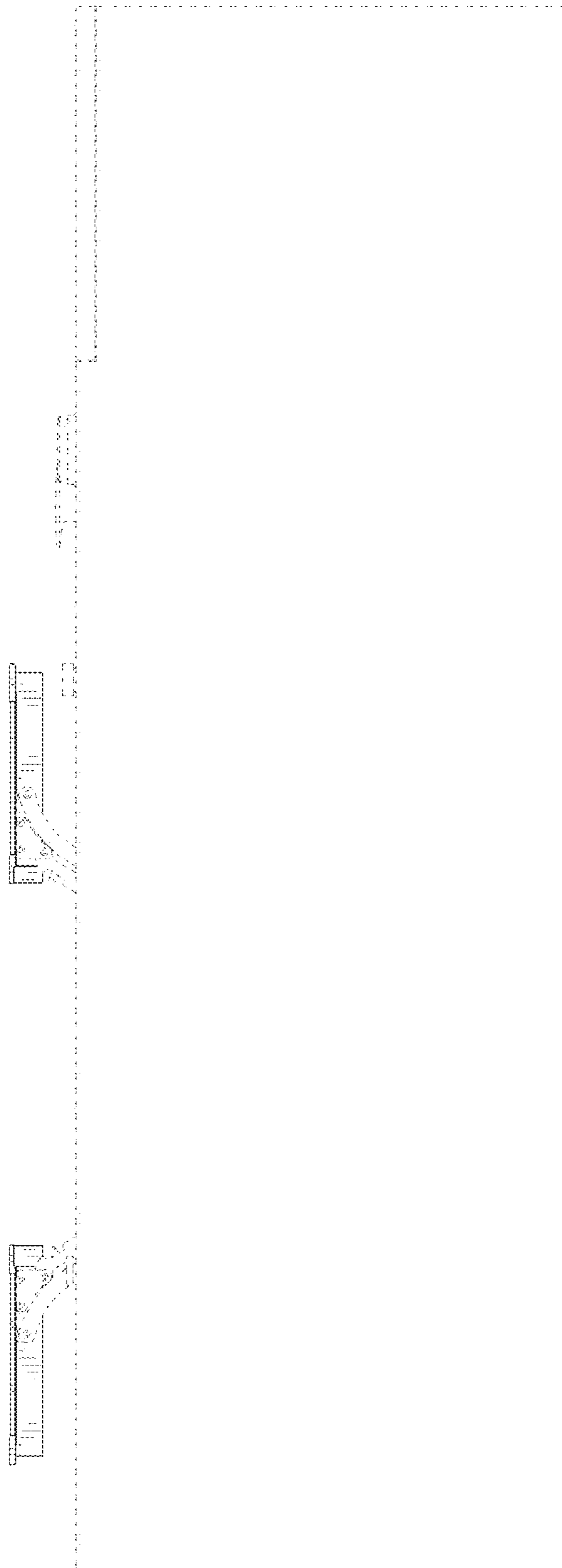

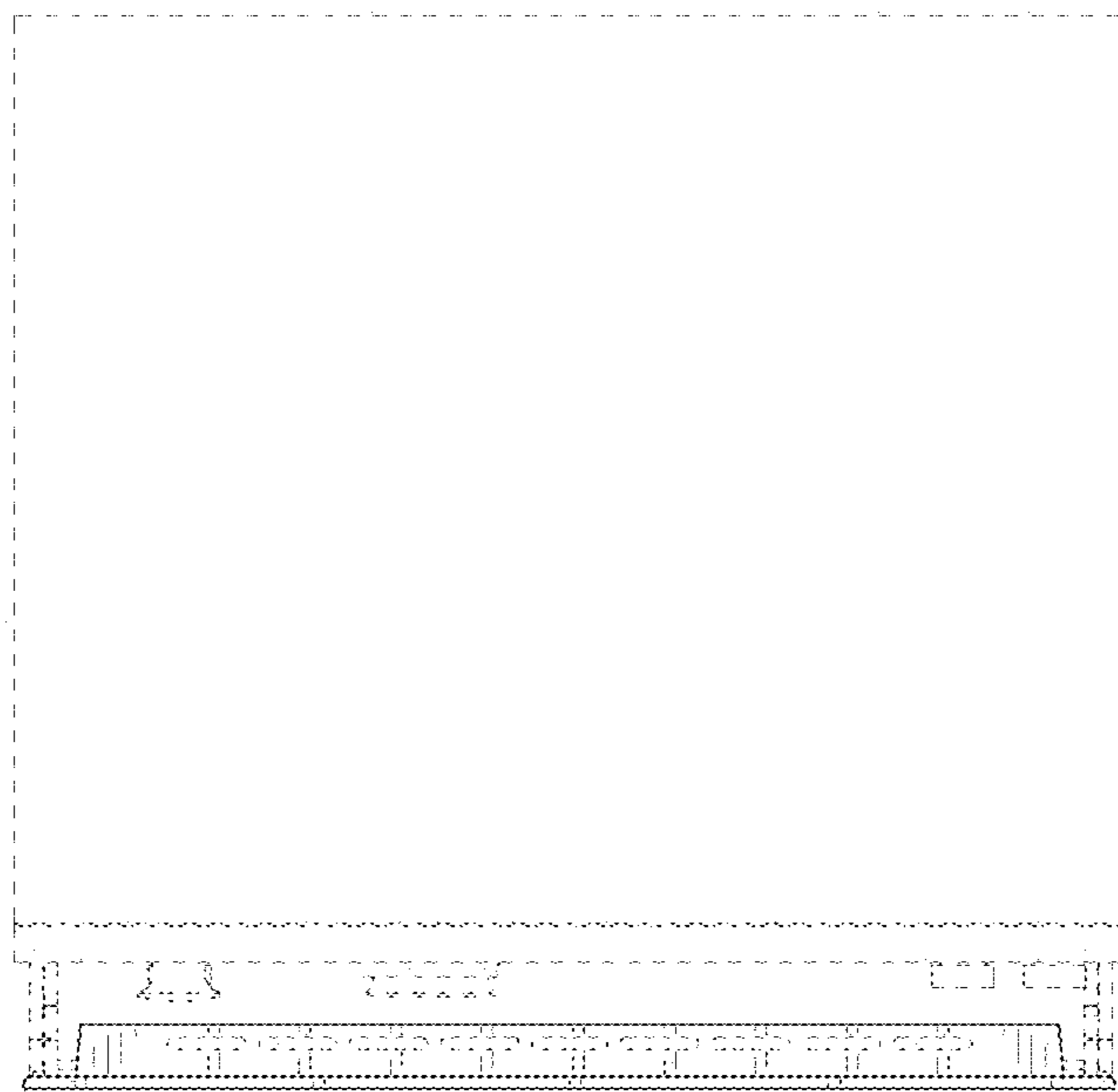

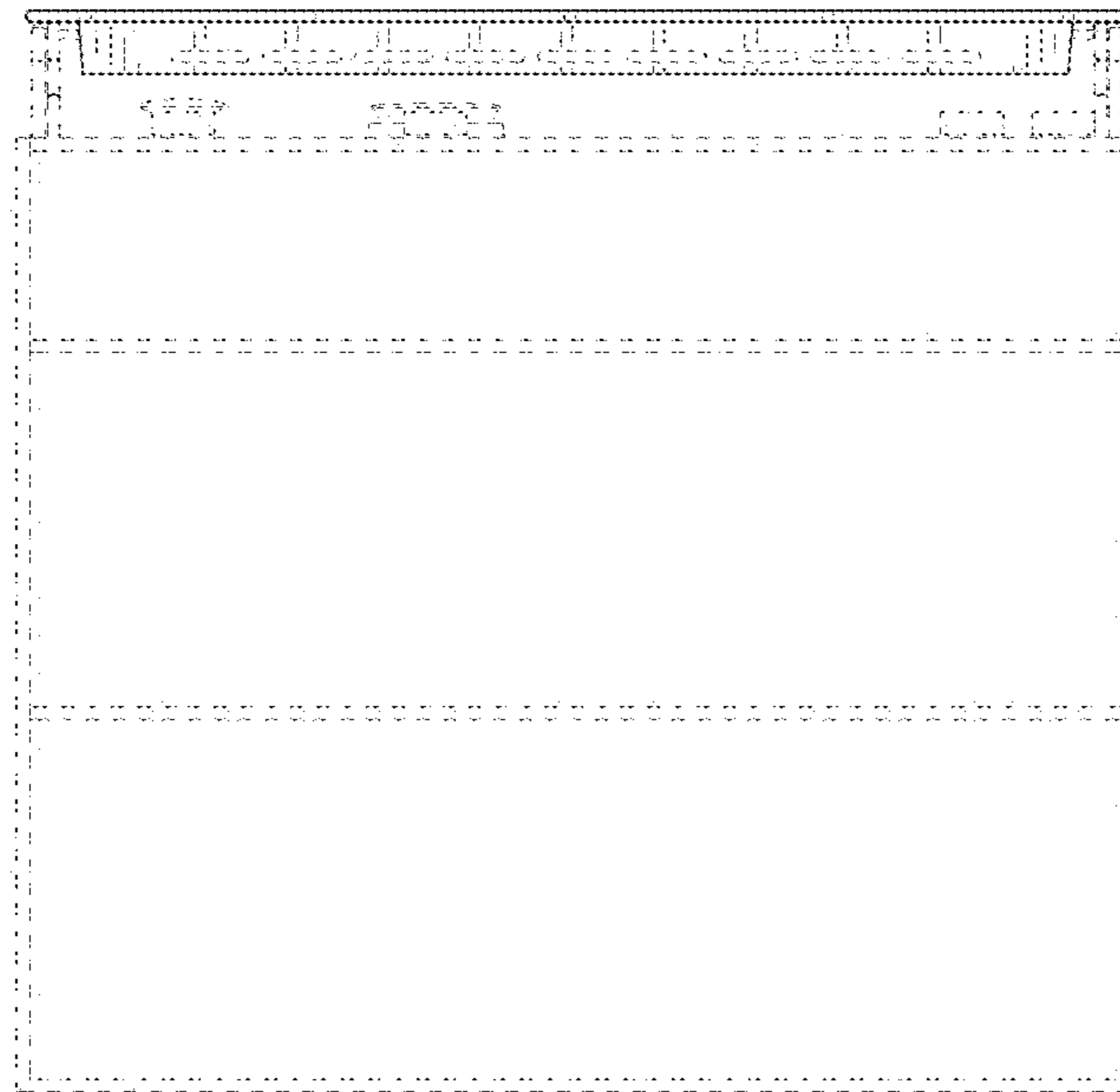

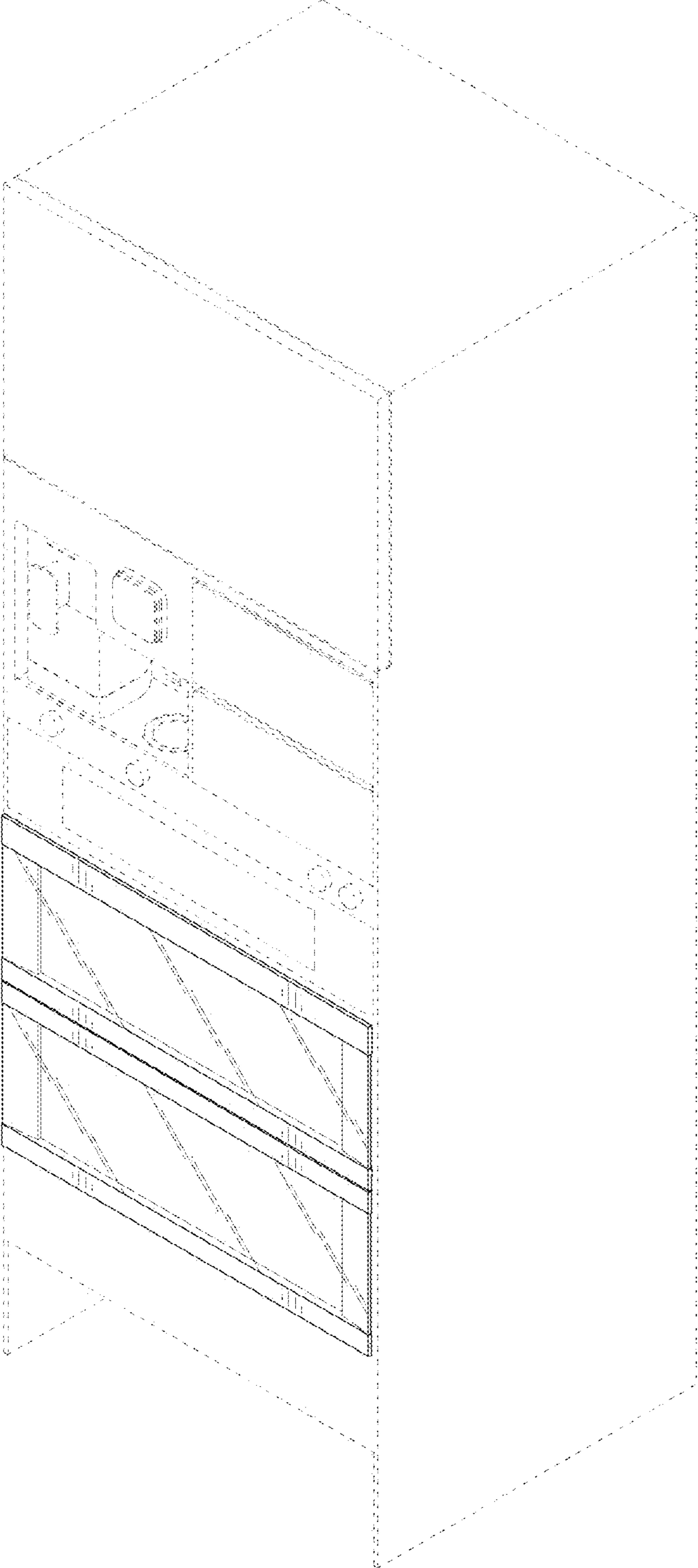
