DESCRIPTION

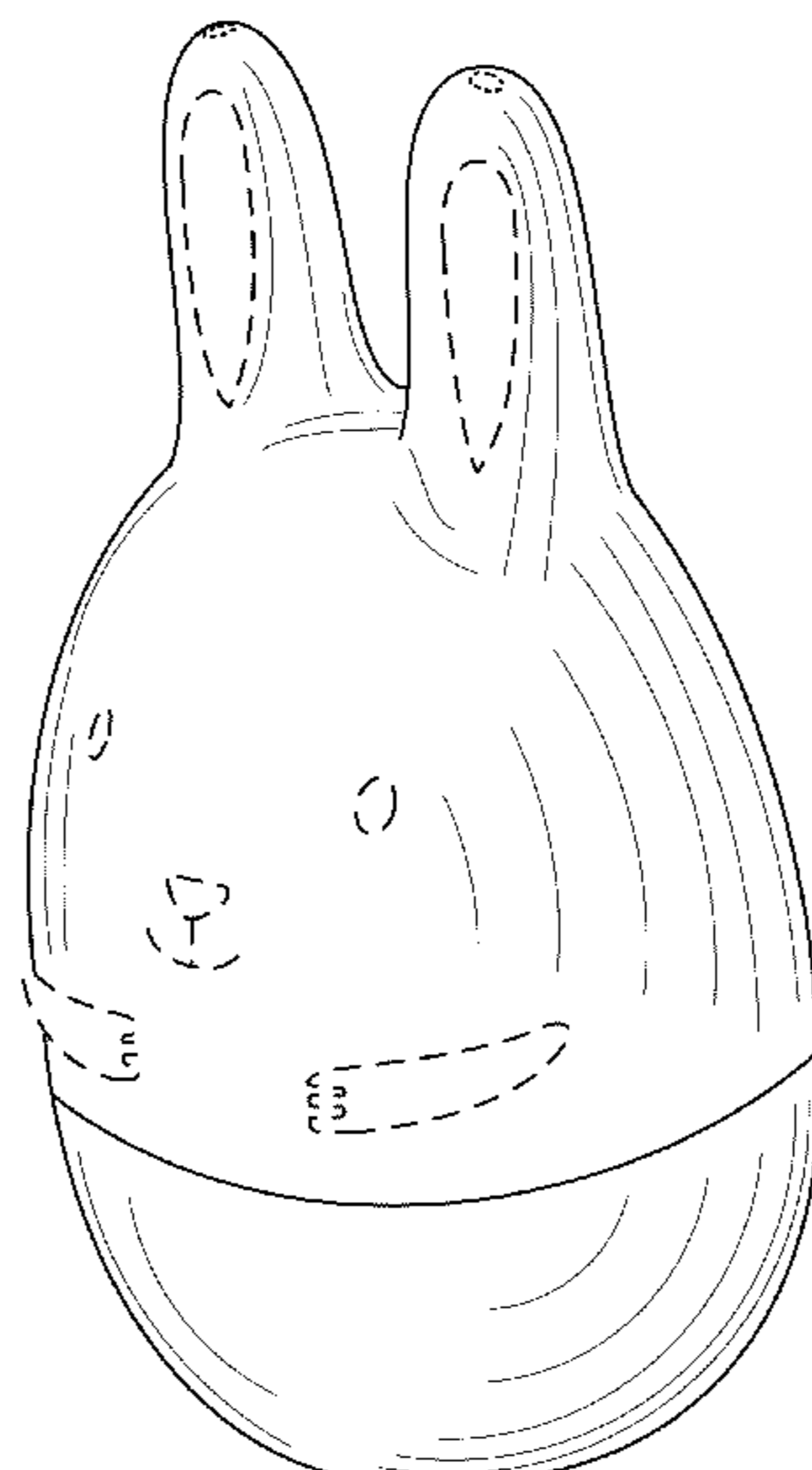
FIG. 1 is a perspective view of a package showing our new design;

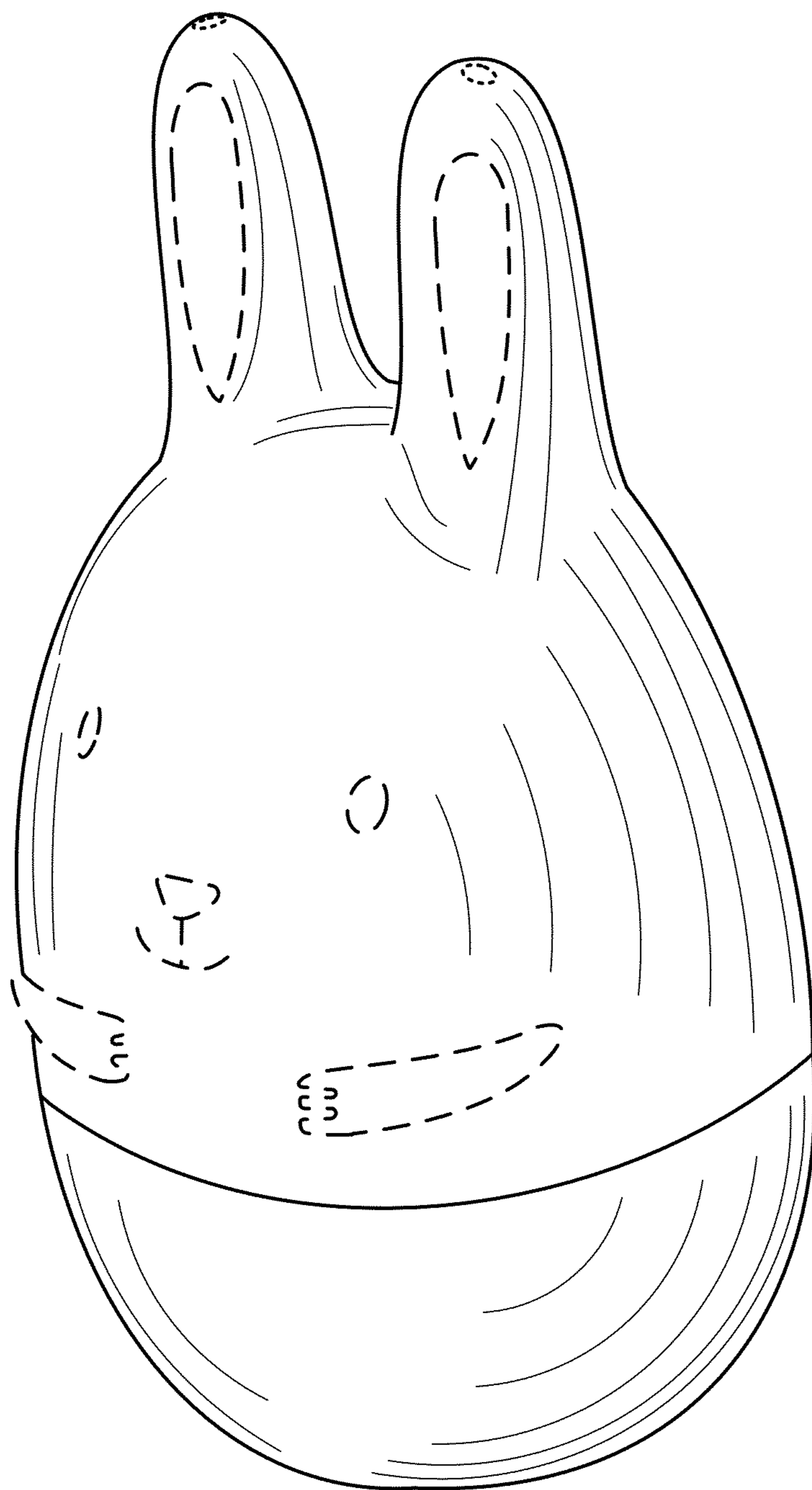

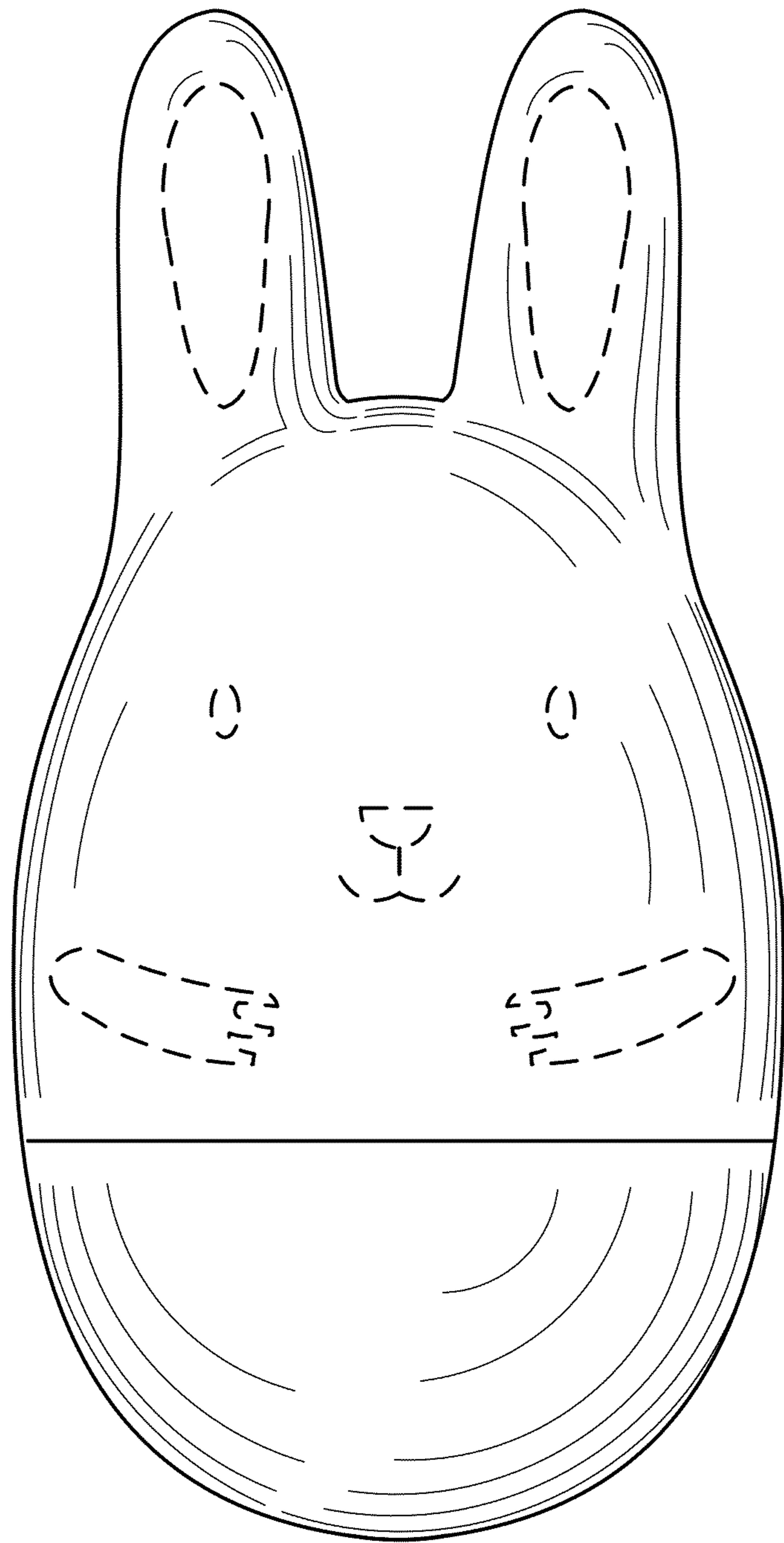

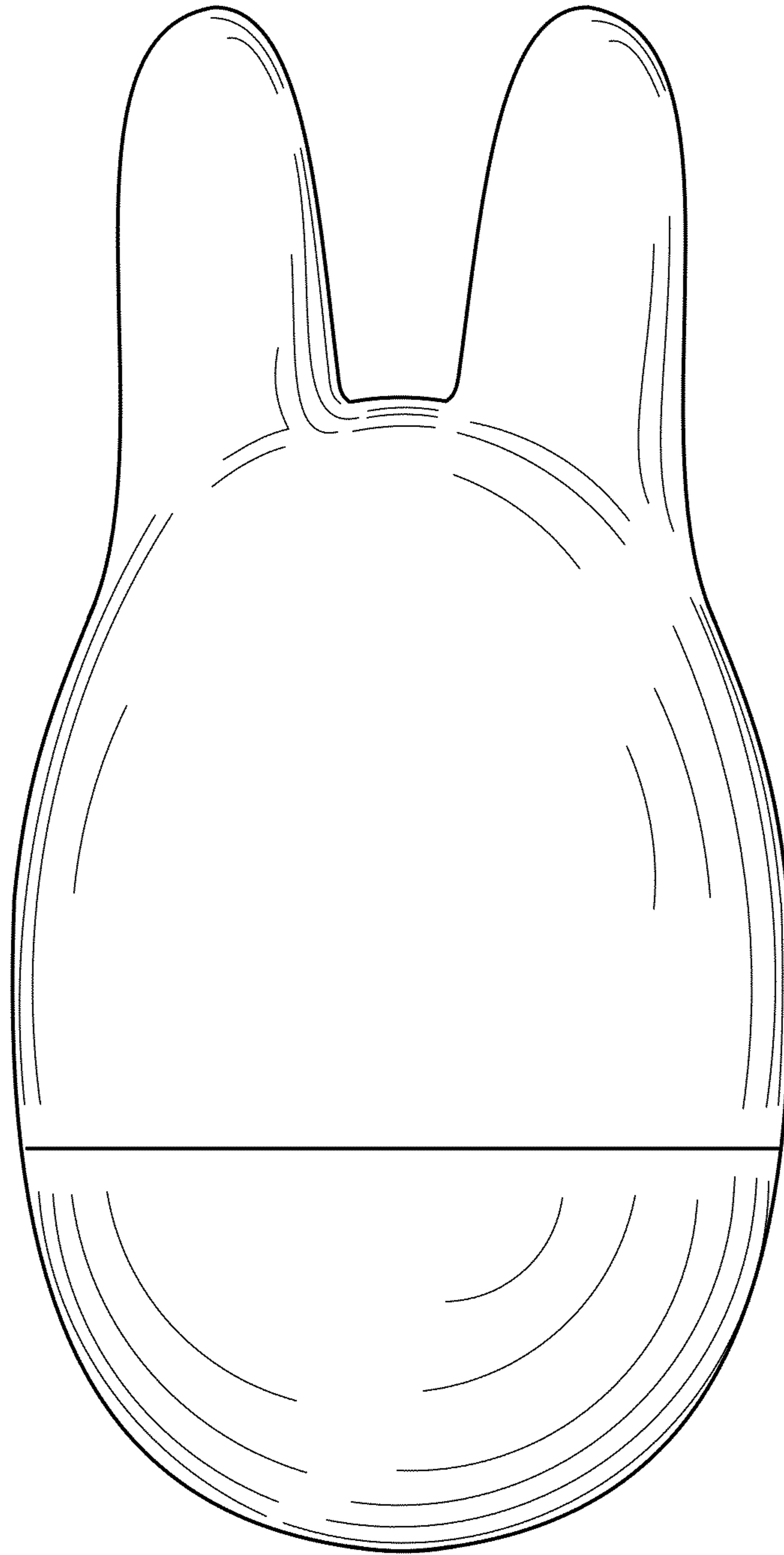

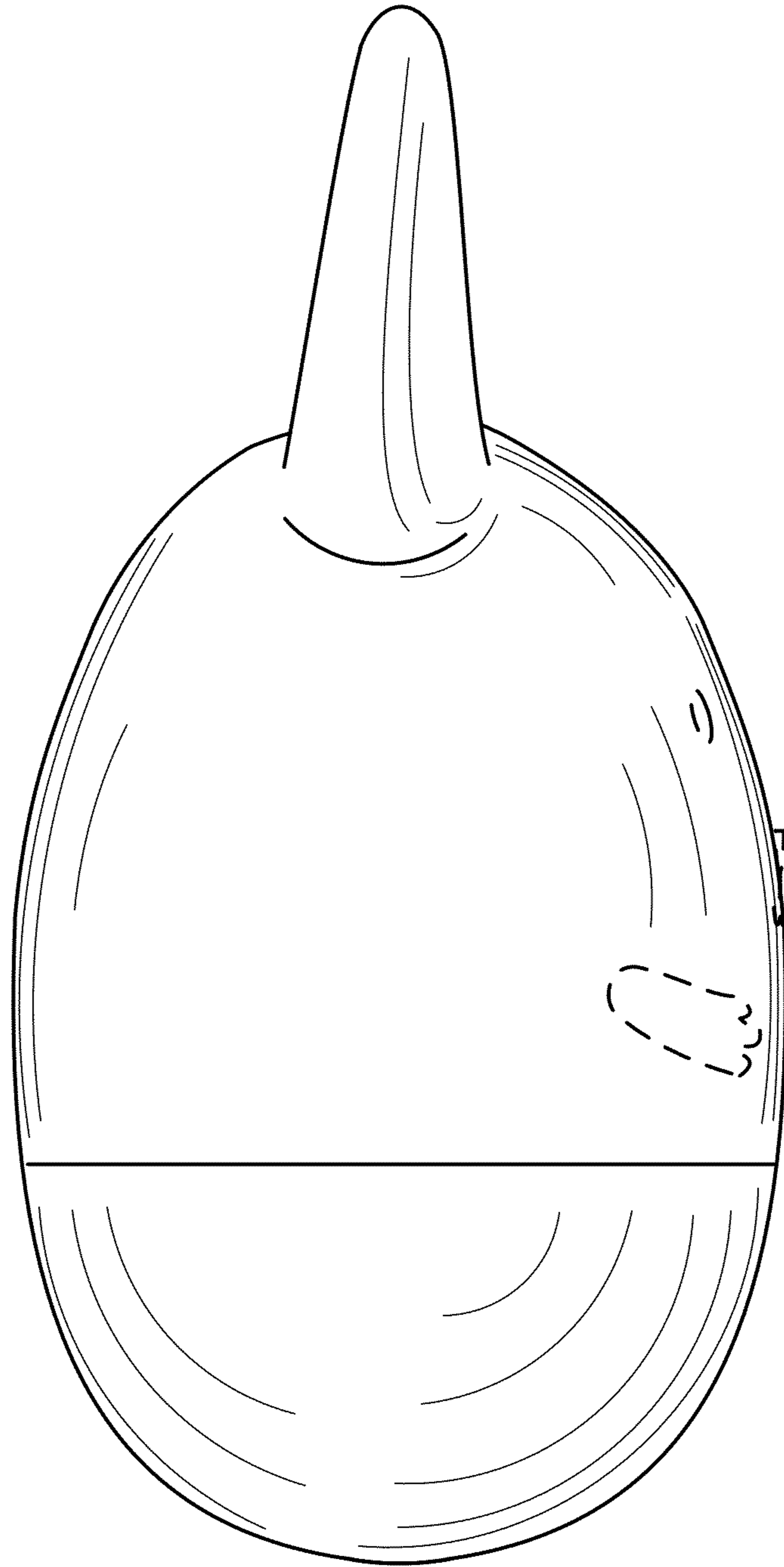

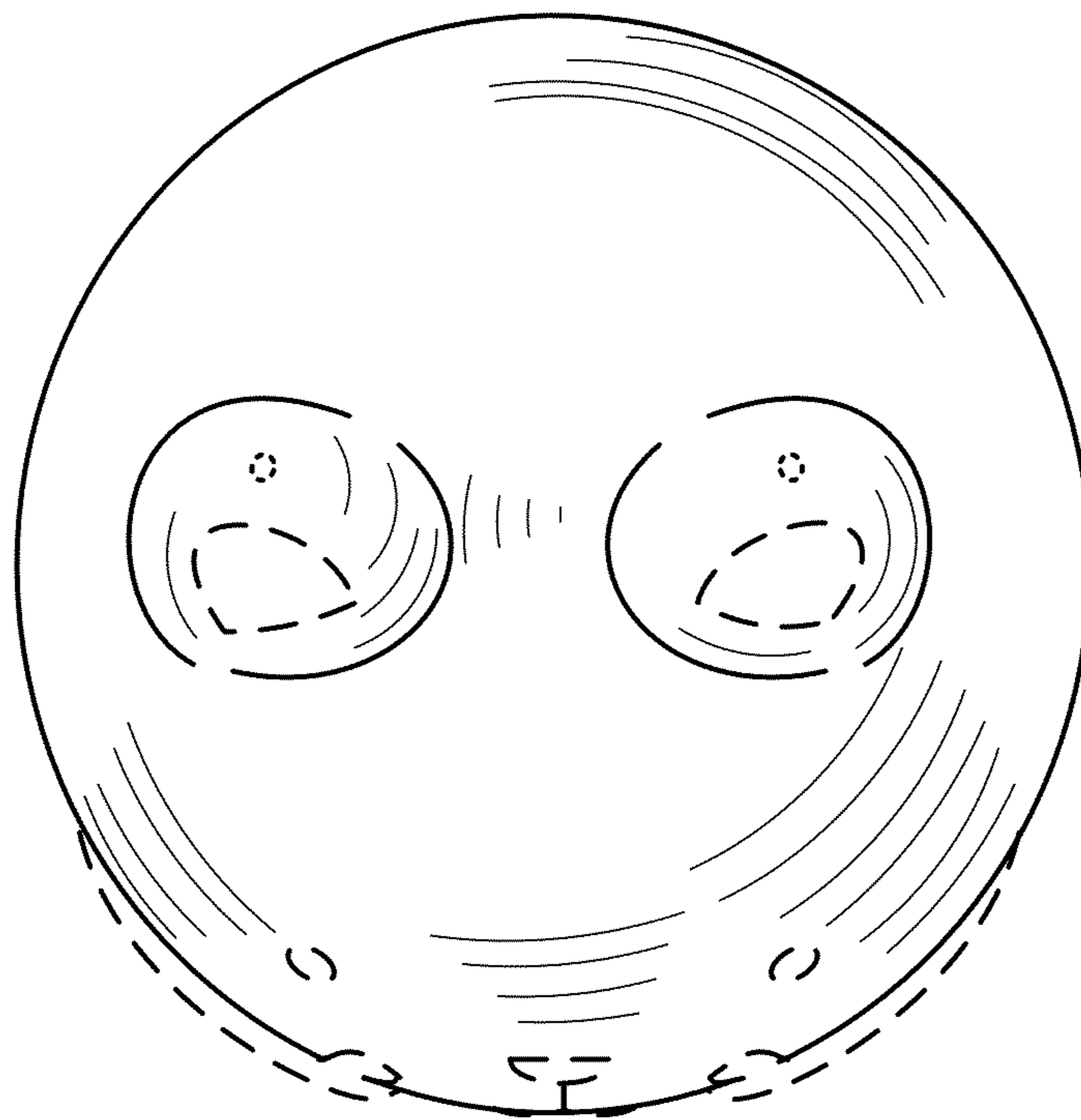

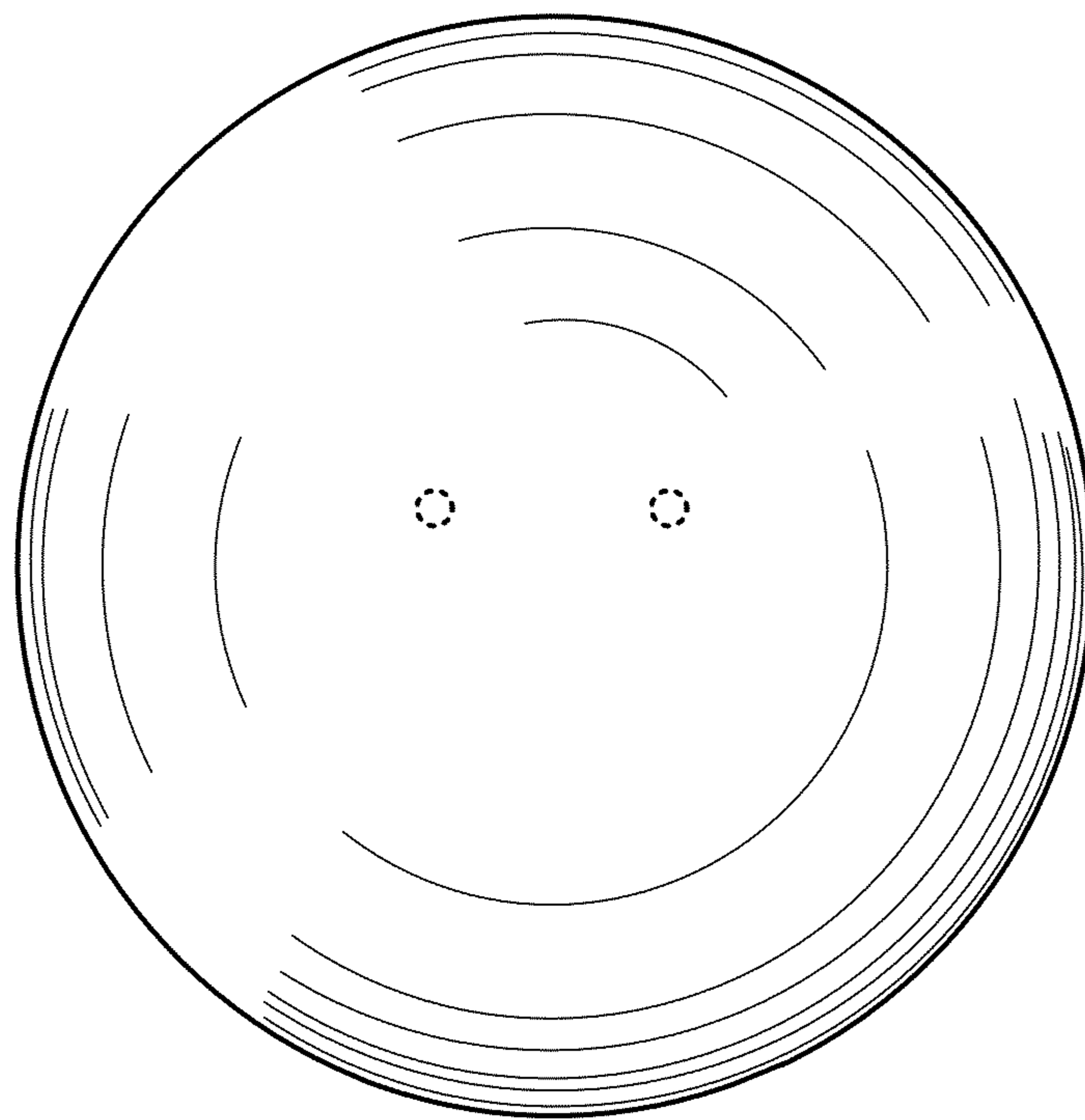
