**DESCRIPTION**

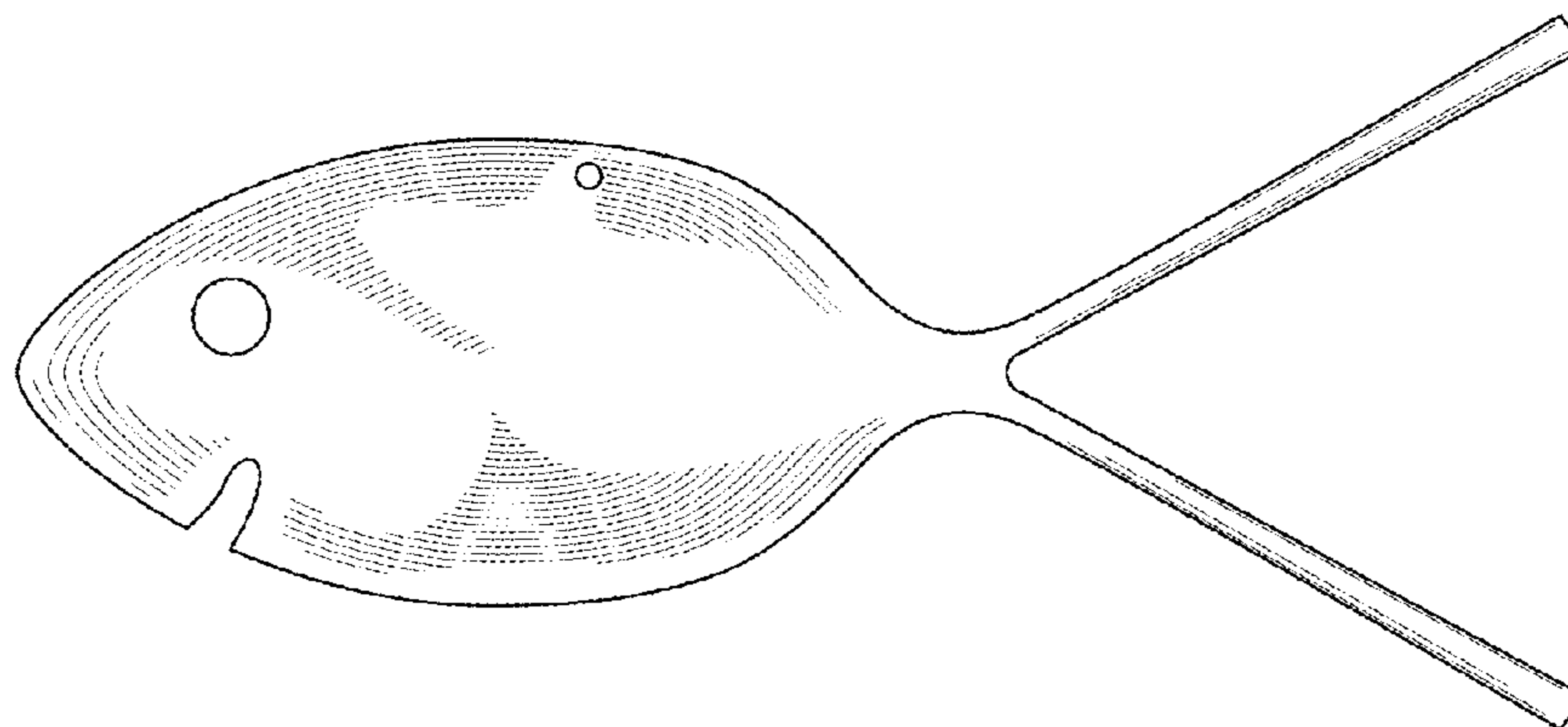
FIG. 1 is a perspective view of a fish mobile ornament, showing my new design;

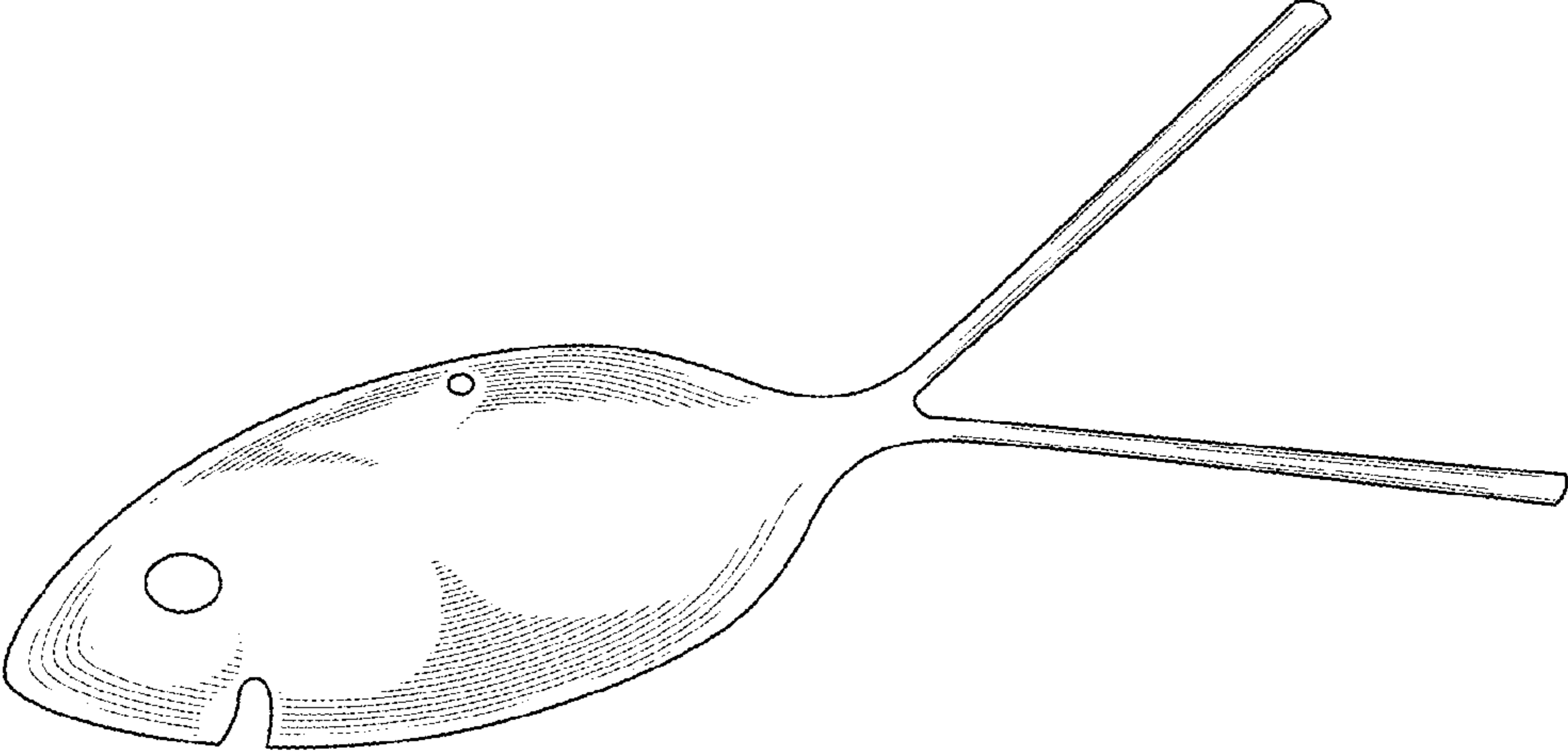

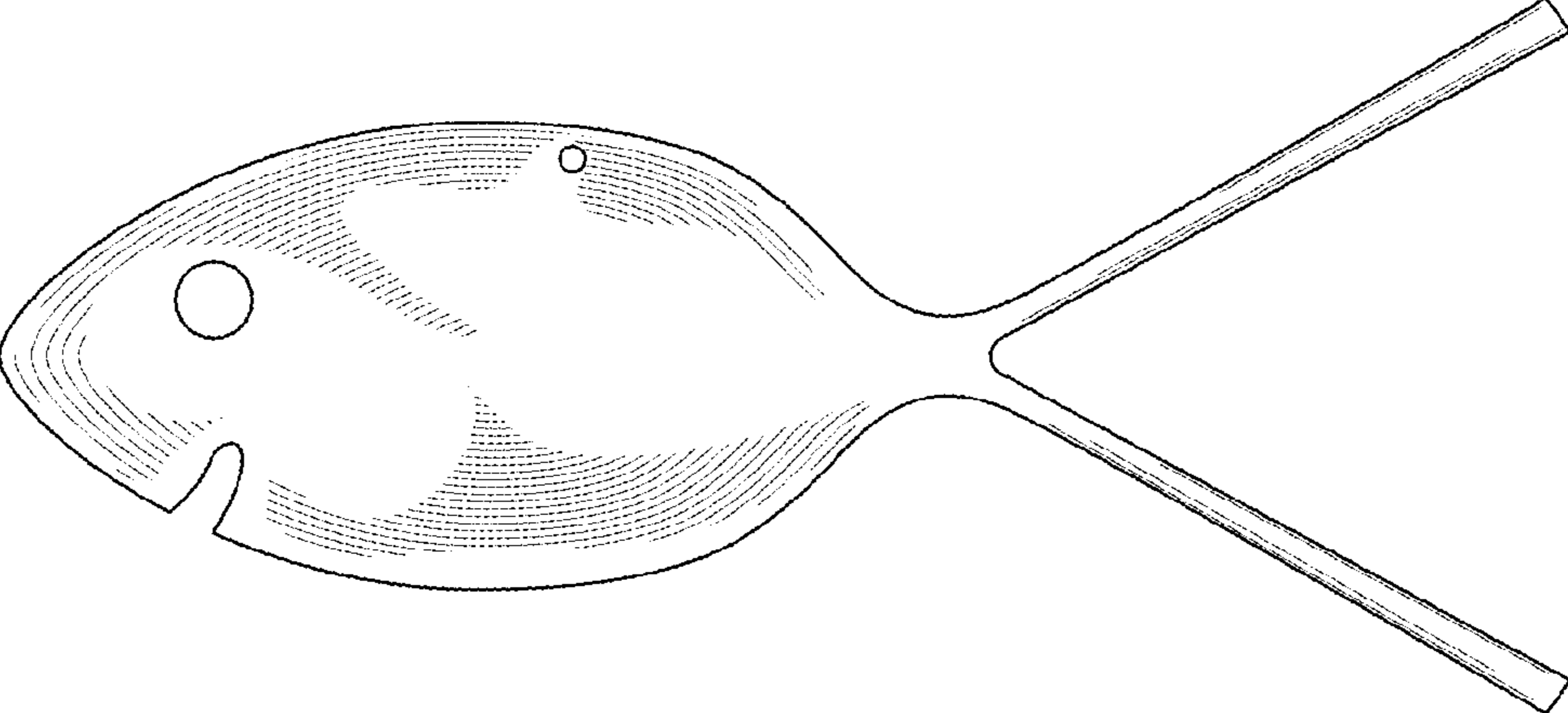

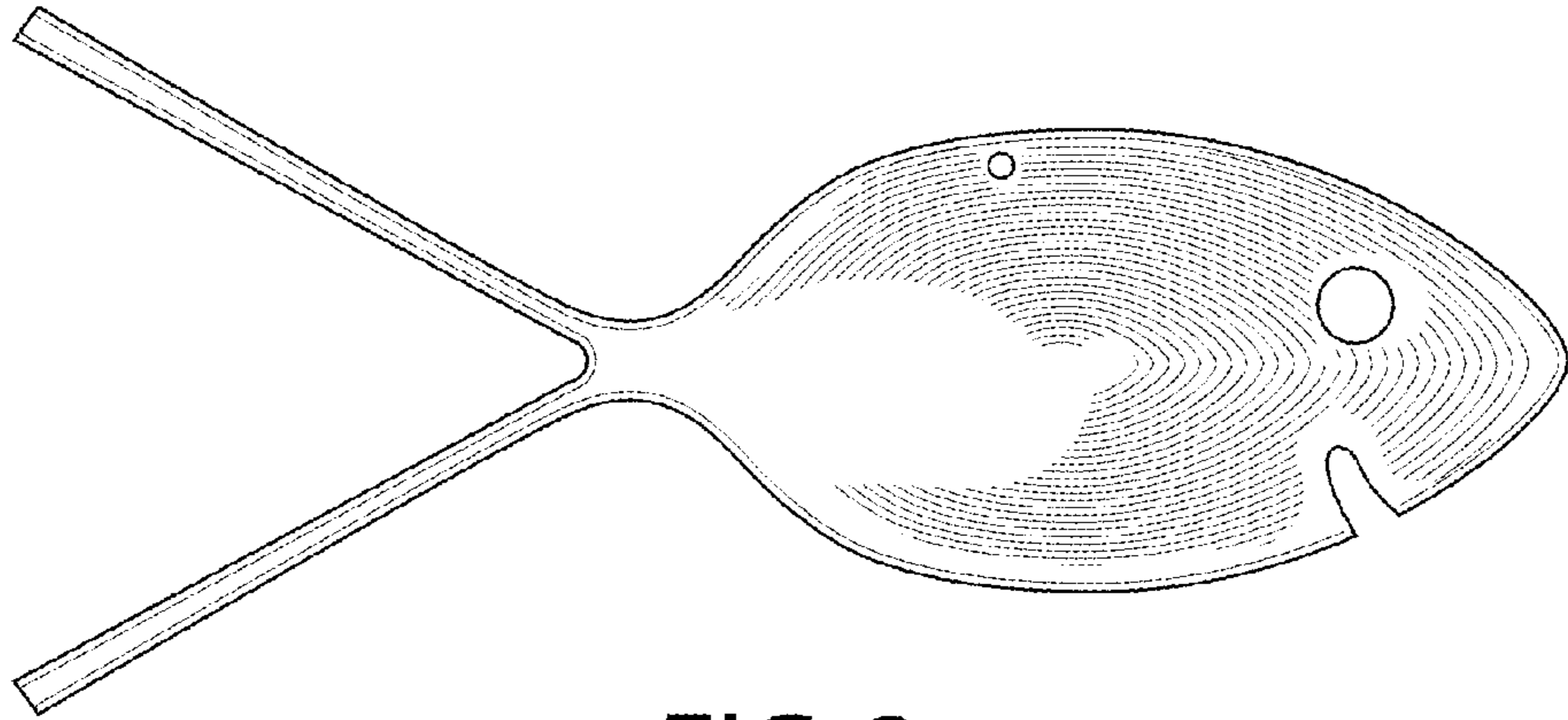

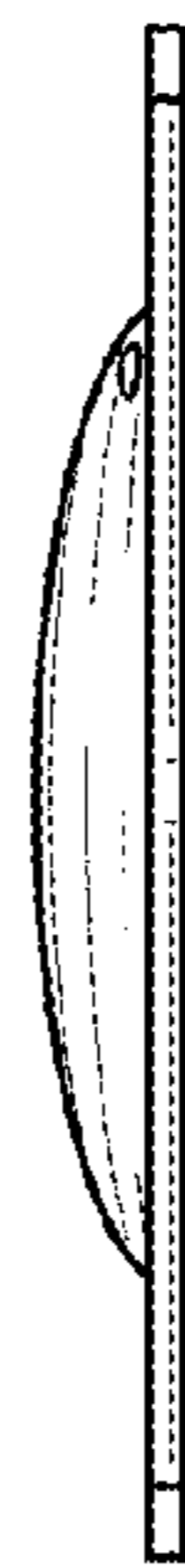

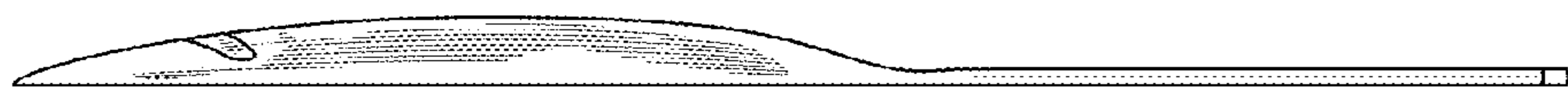
