(57) **CLAIM**

The ornamental design for an automobile and/or a toy replica thereof, as shown and described.

DESCRIPTION

FIG. 1 is a front-right side perspective view of an automobile and/or a toy replica thereof in accordance with an embodiment of my new design; and,

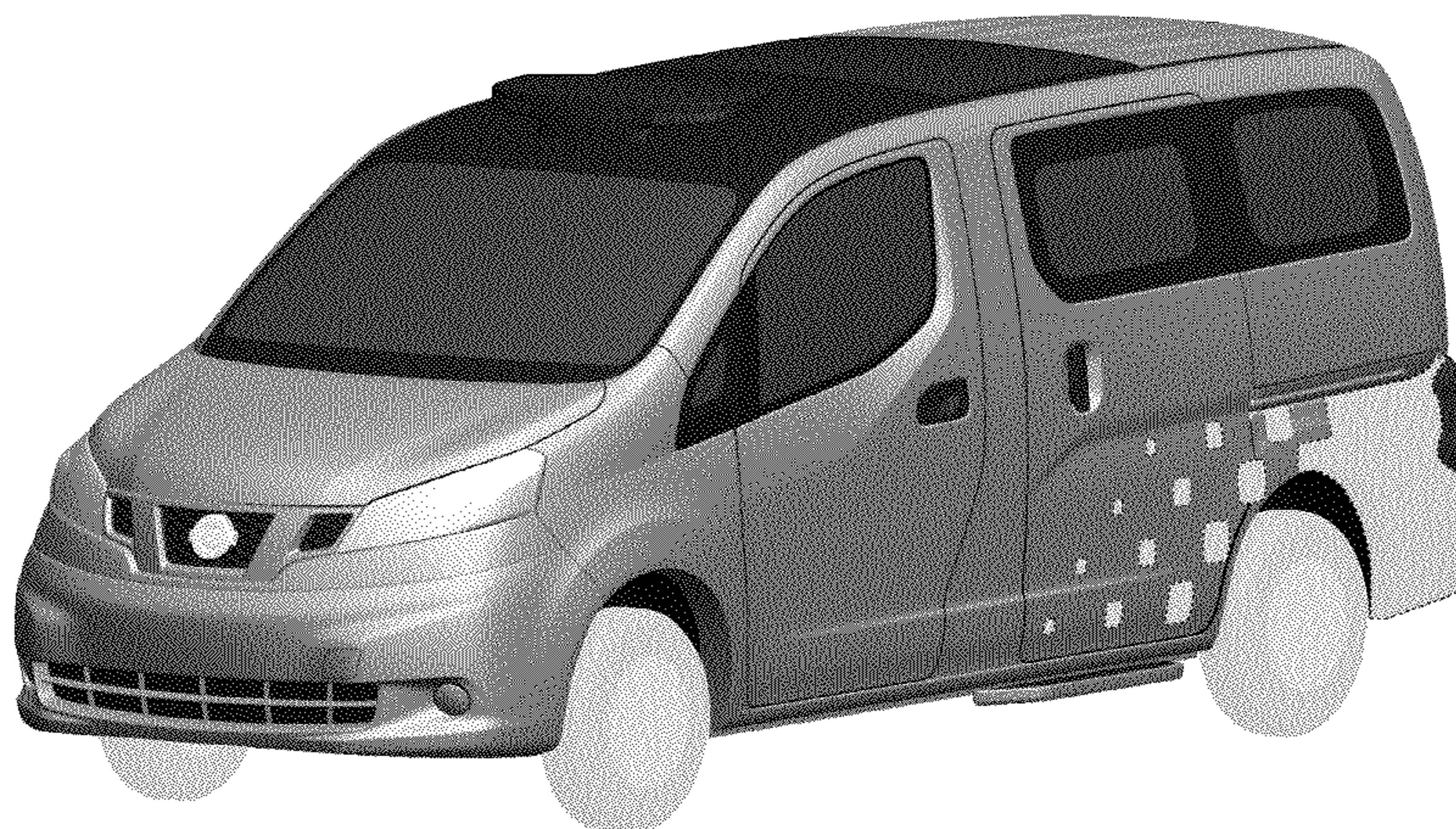
FIG. 2 is a rear-left side perspective view of the automobile and/or the toy replica thereof in accordance with the embodiment of my new design of FIG. 1.

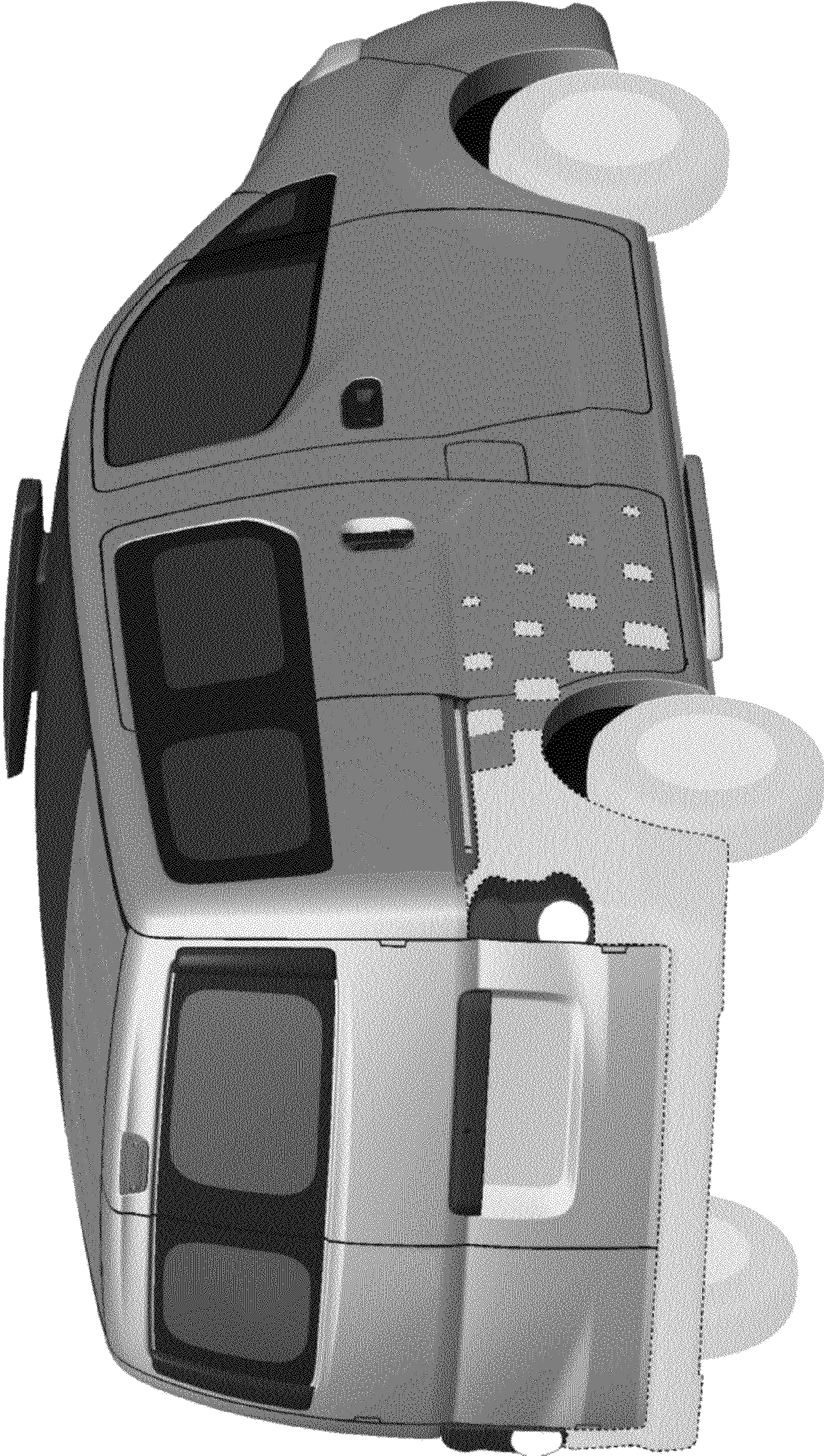
