FIG. 7 is a rear elevational view of the hood ornament of FIG. 1.

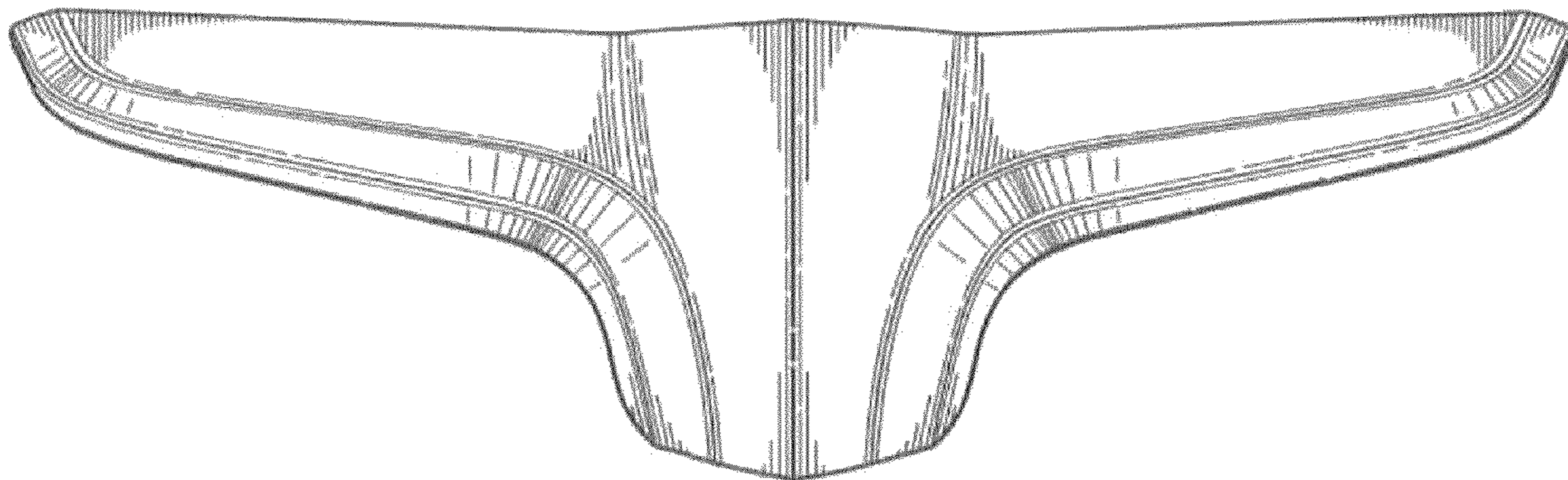

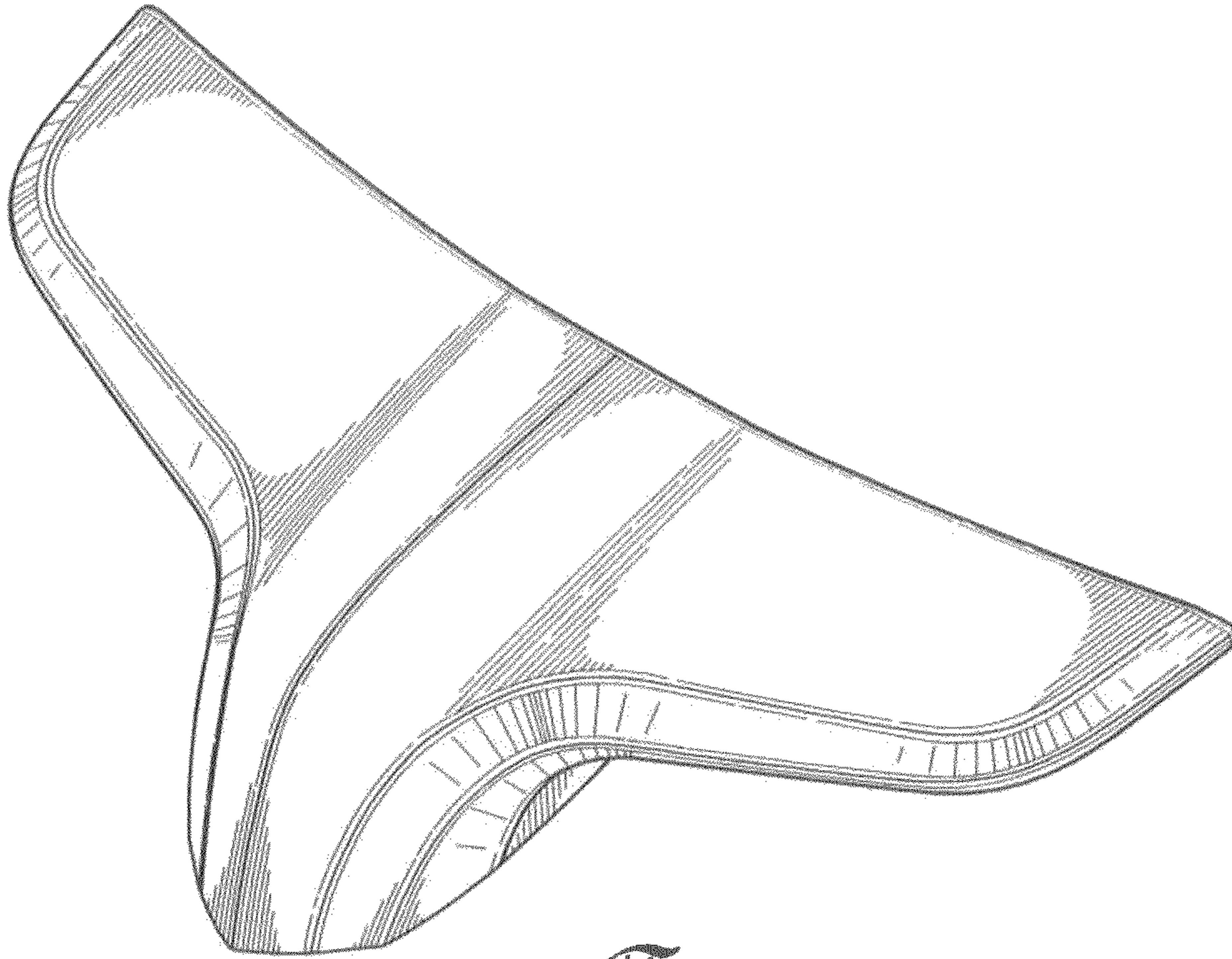

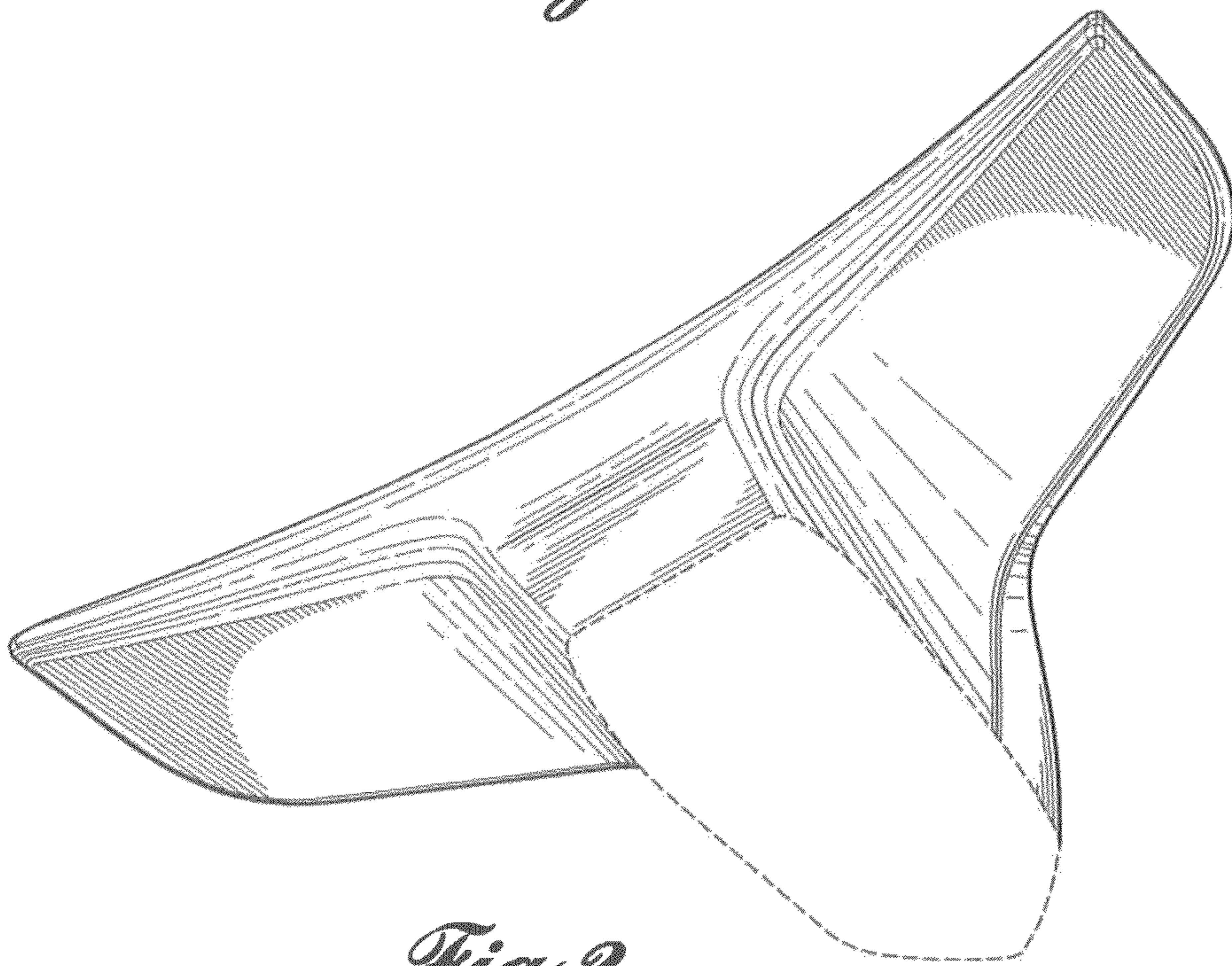

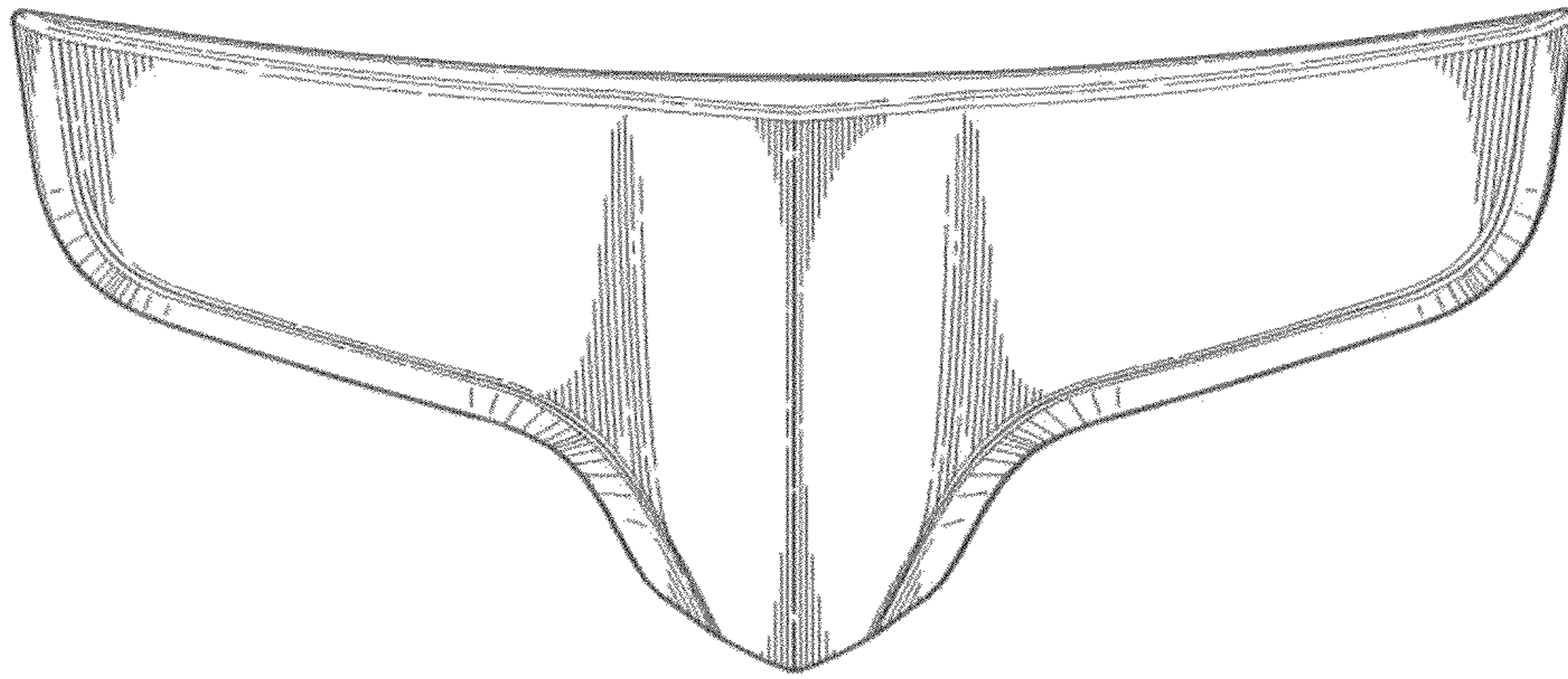

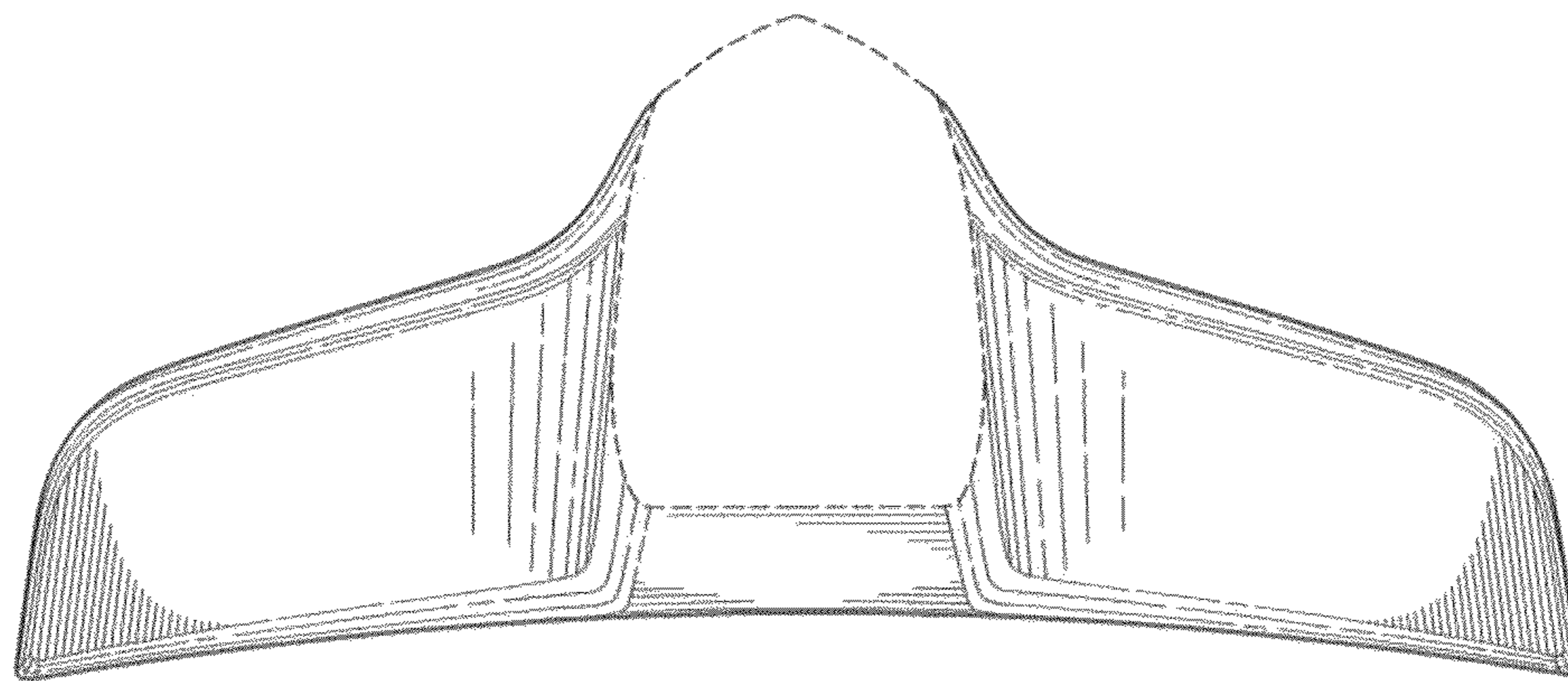

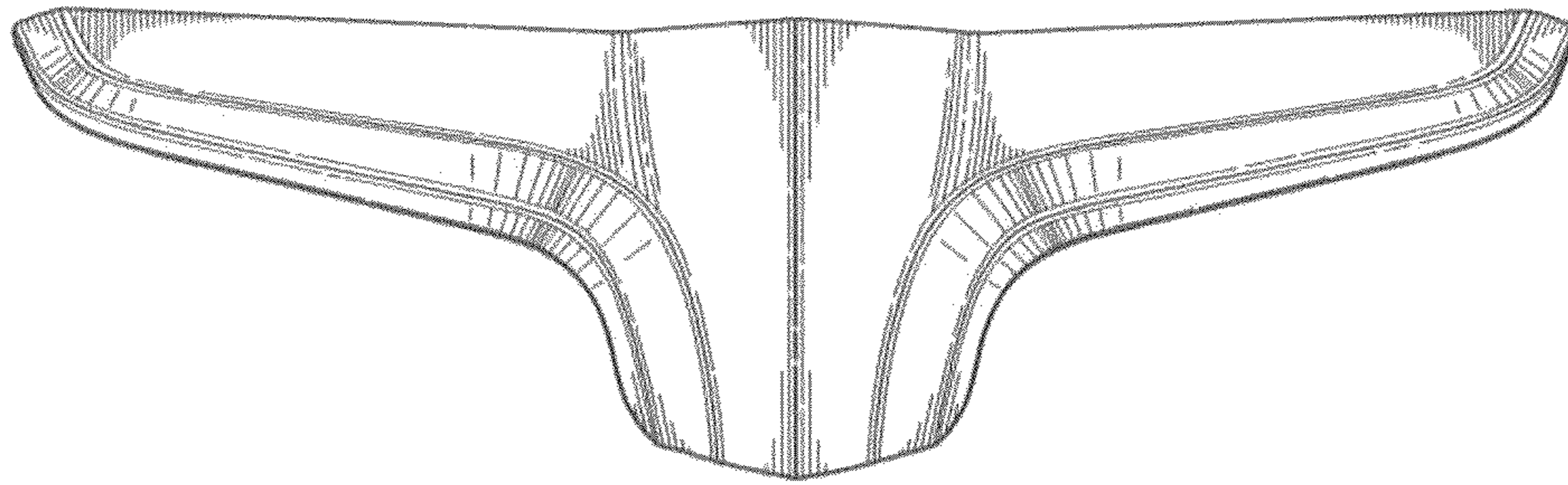




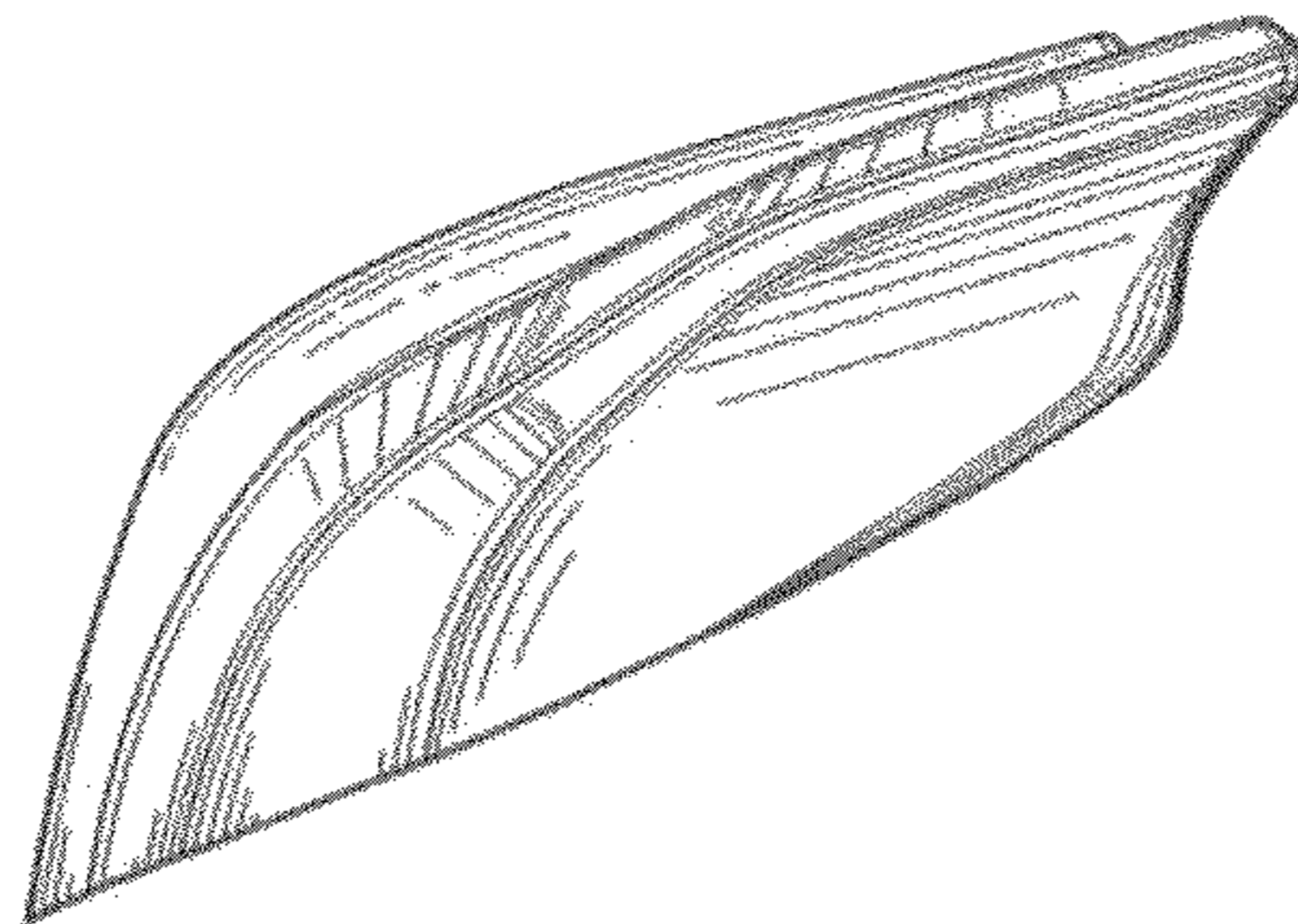

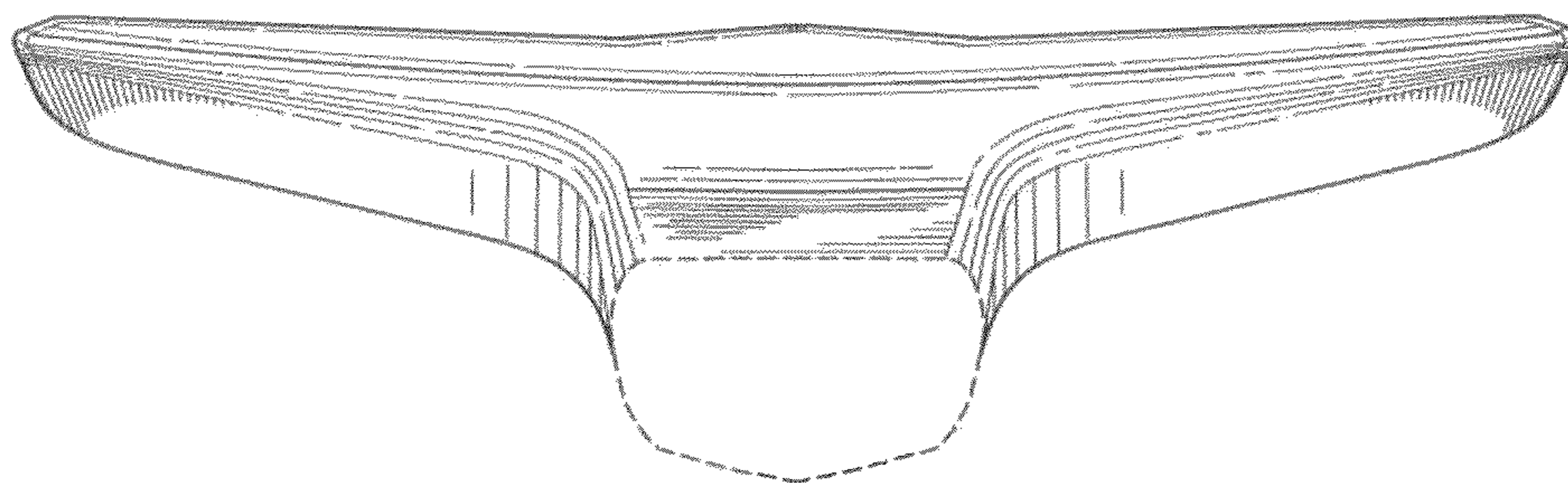
