(57) **CLAIM**

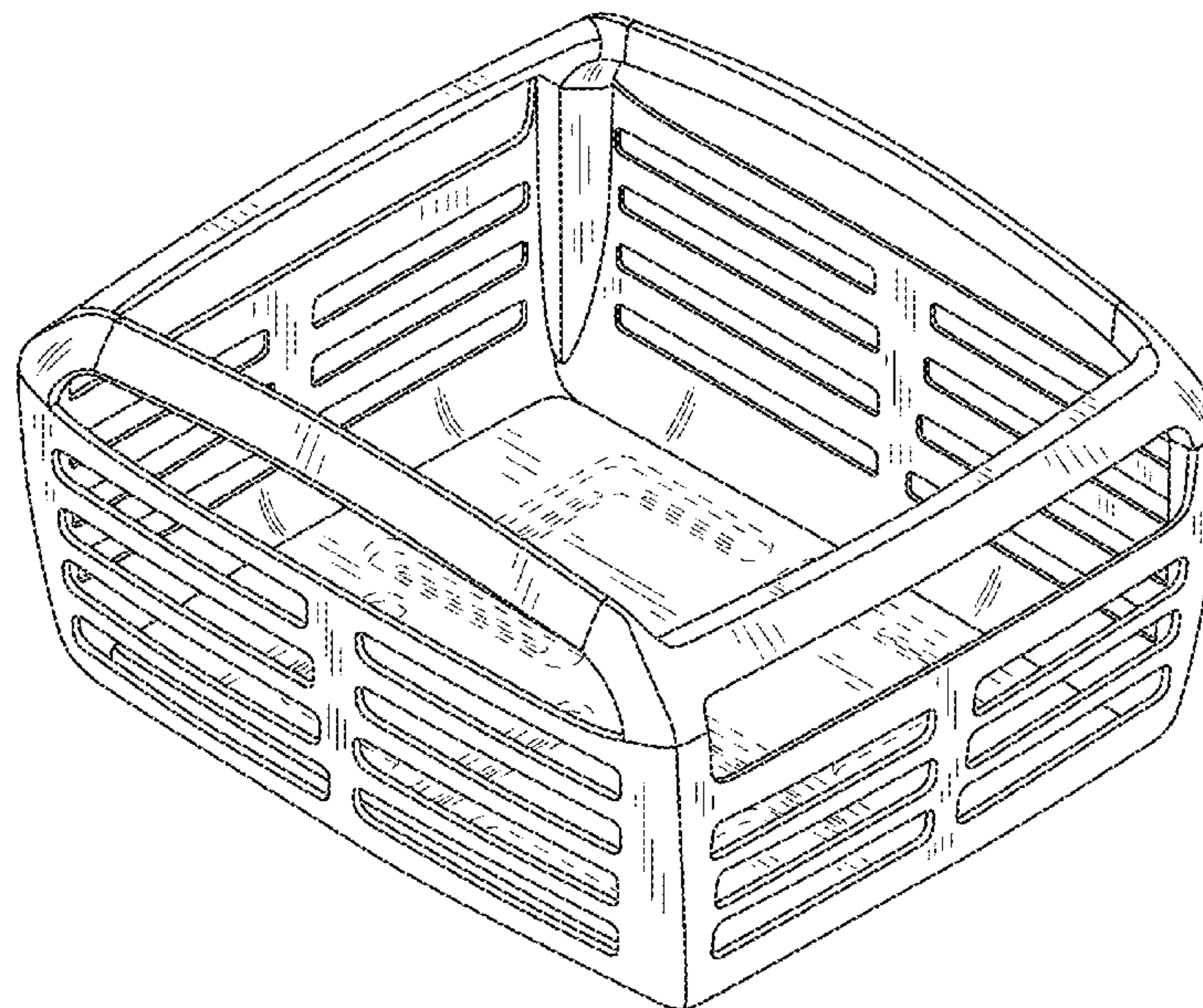
The ornamental design for a bike basket, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the bike basket;

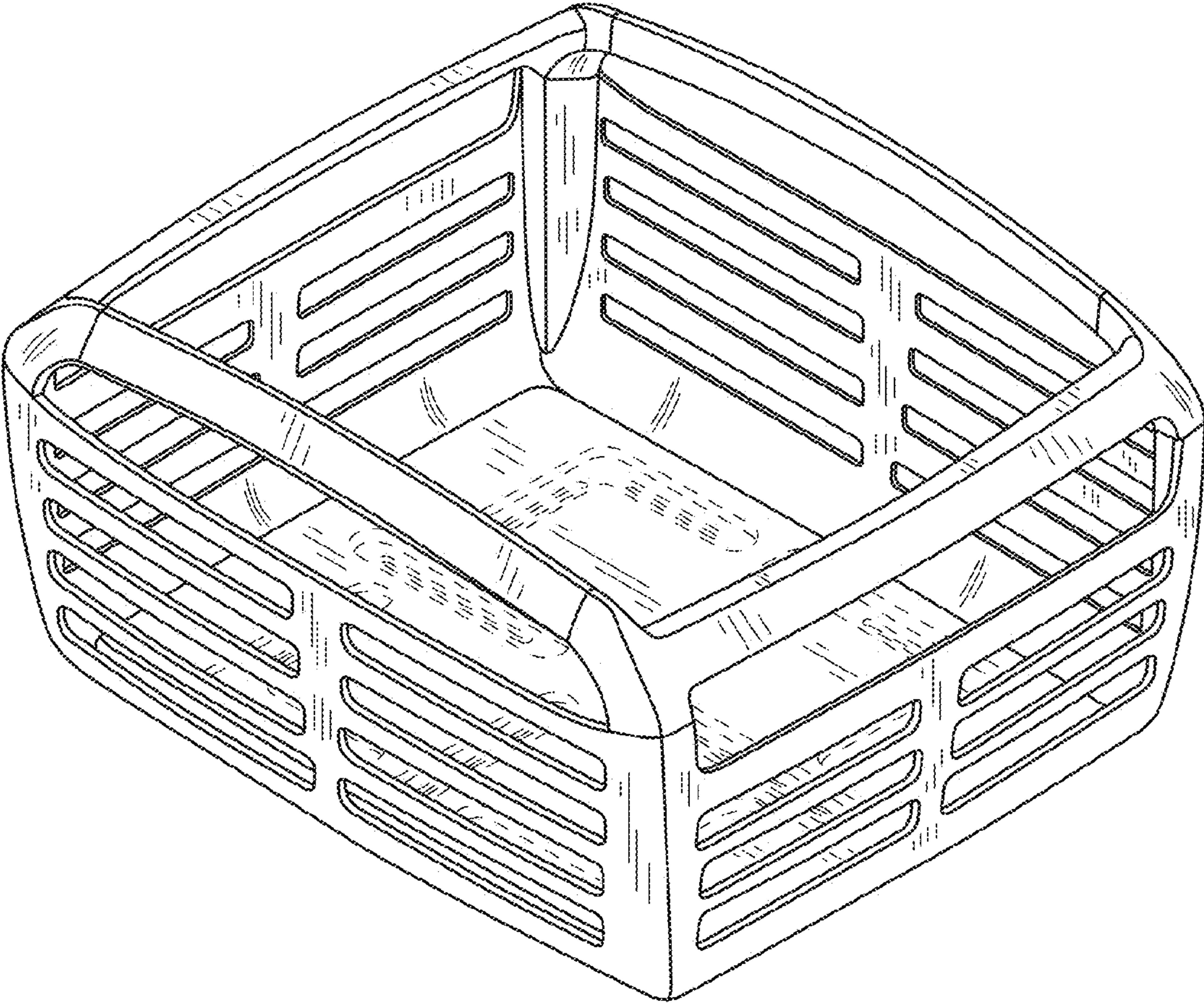

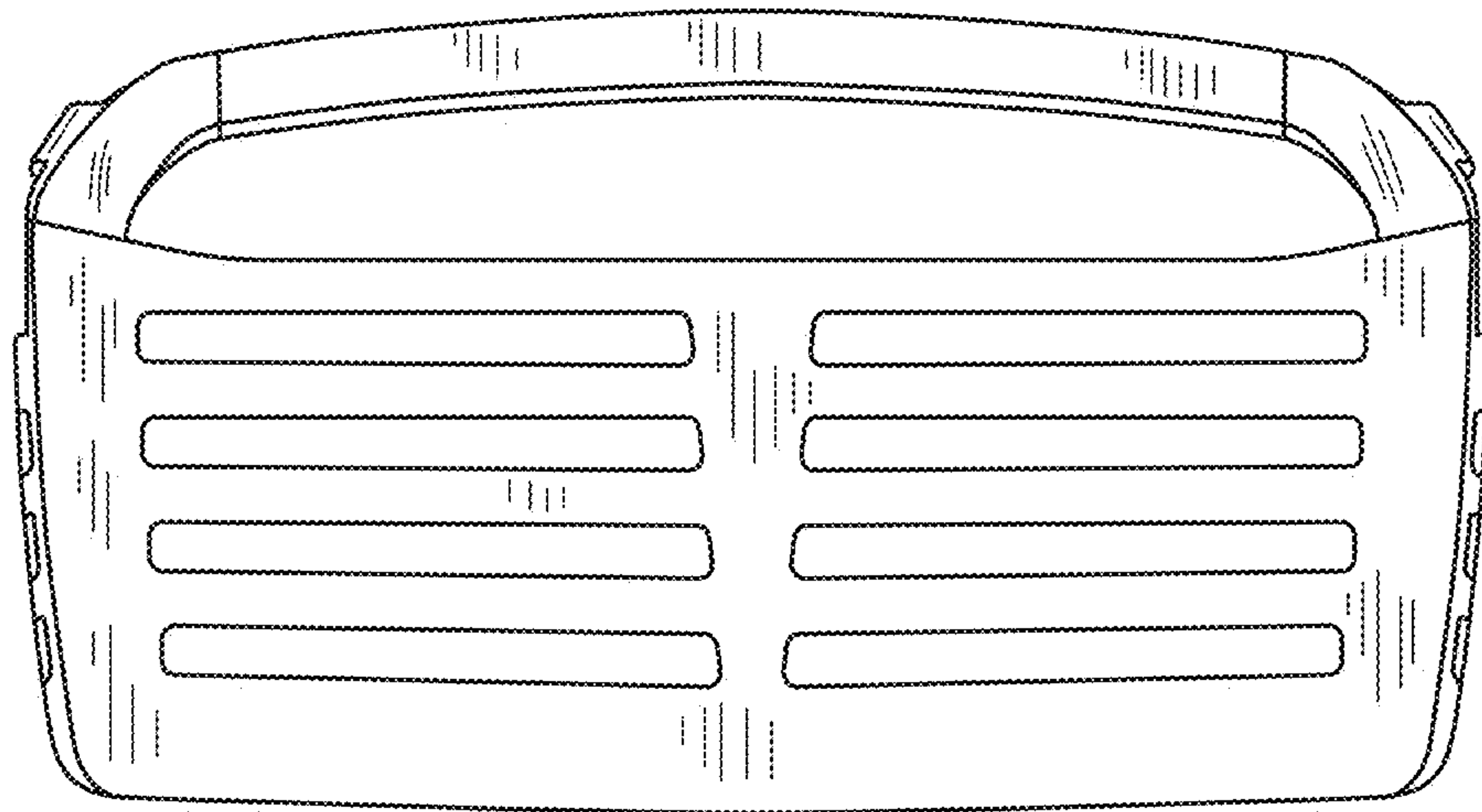

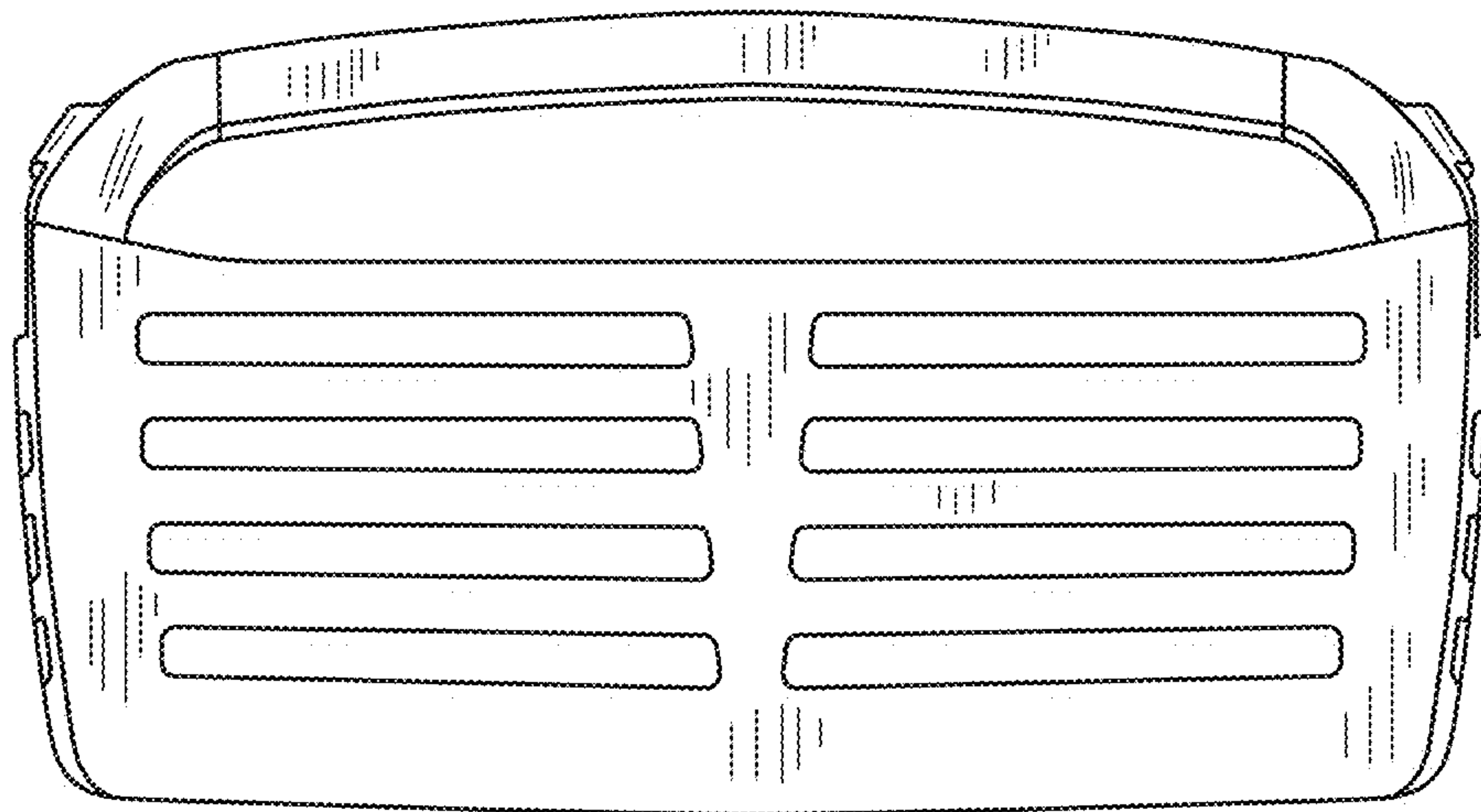

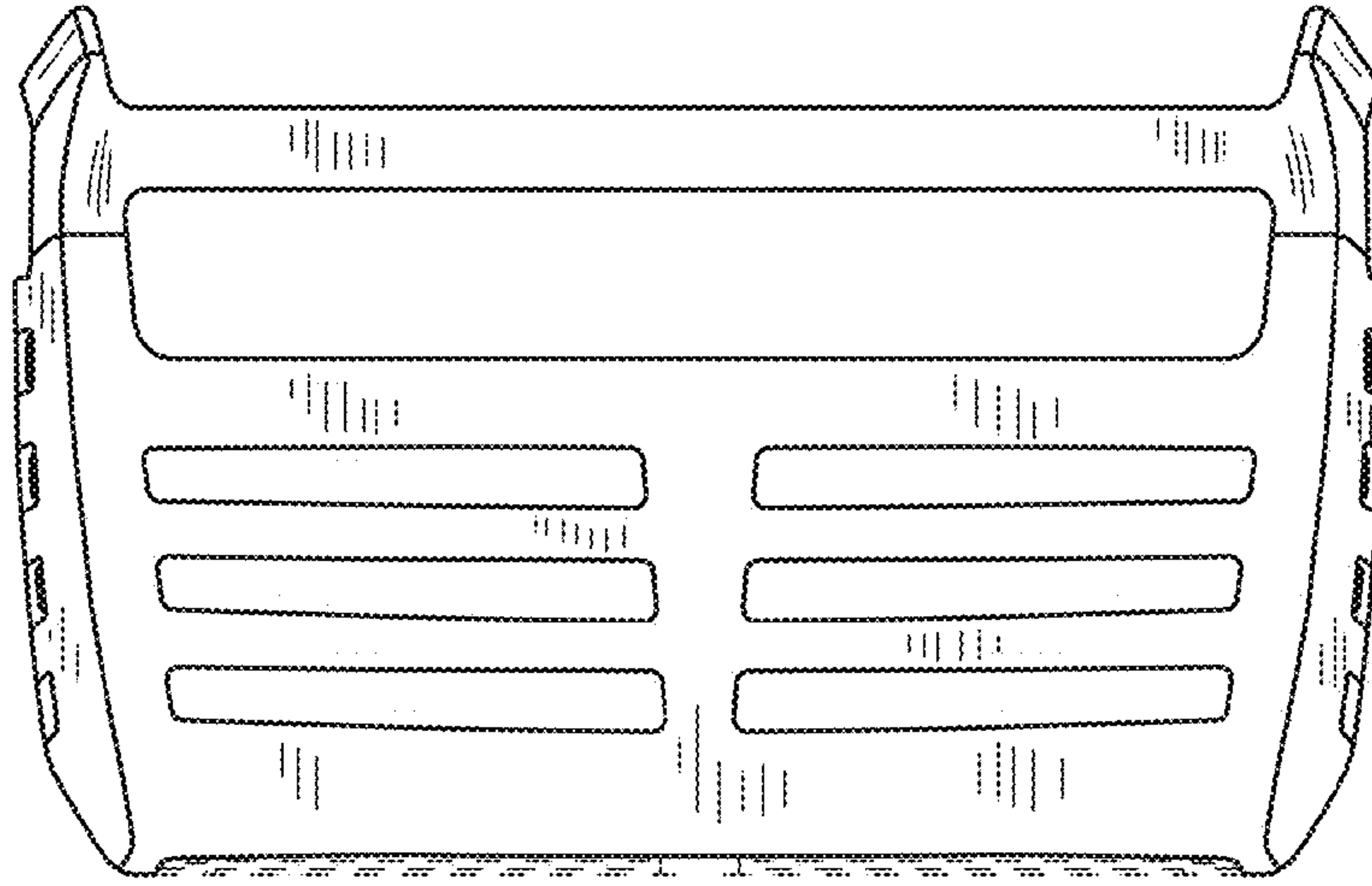

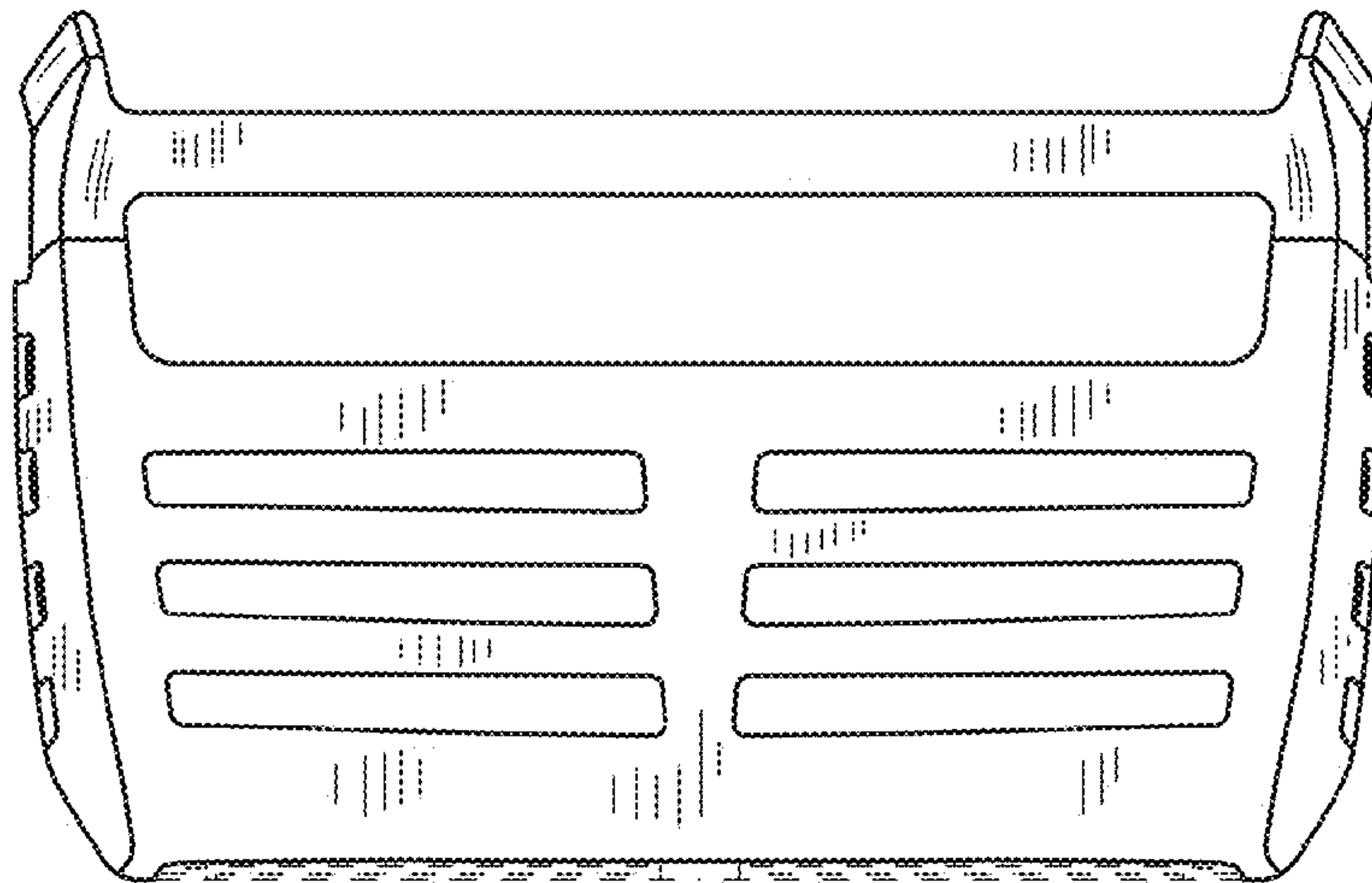

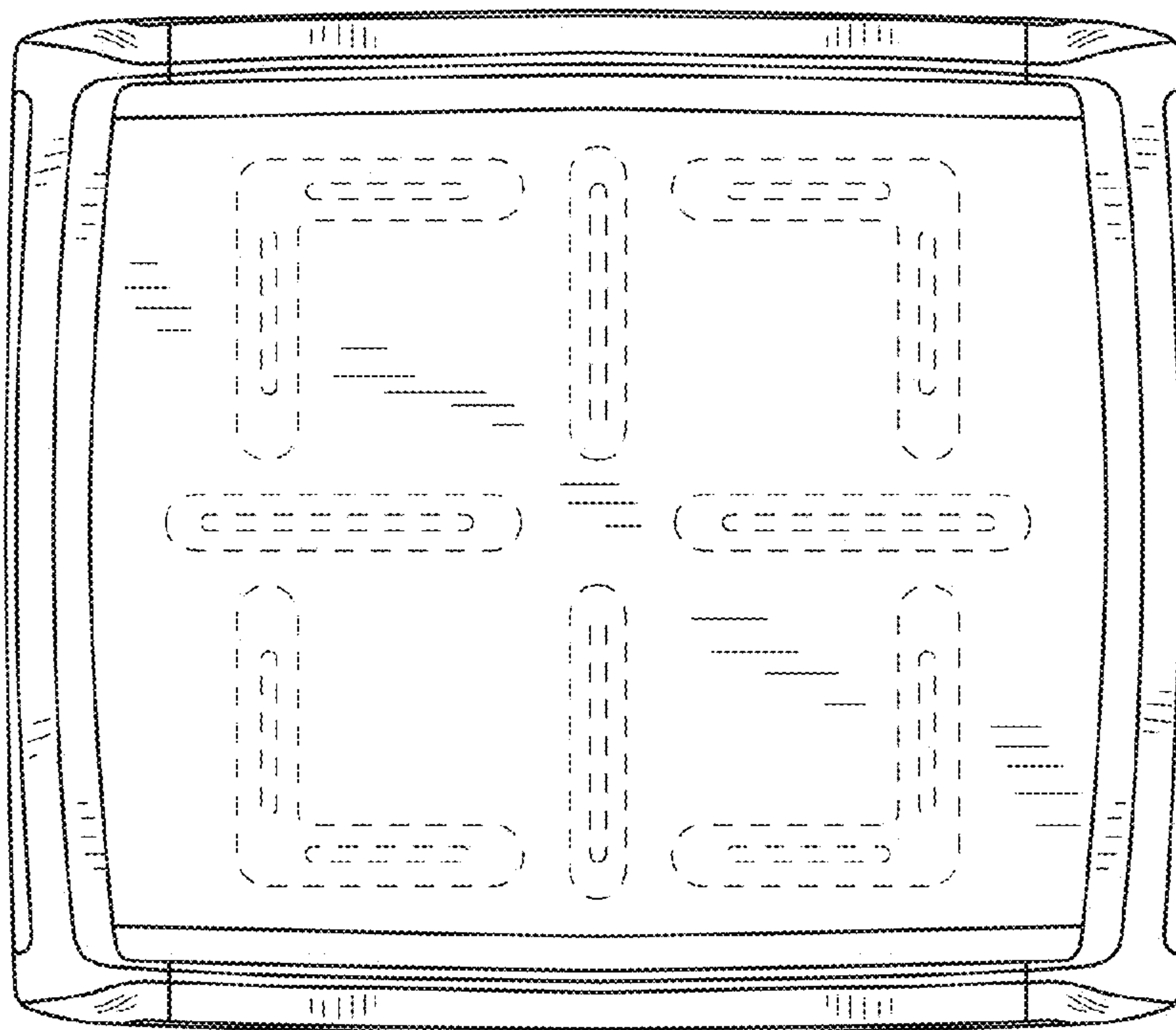

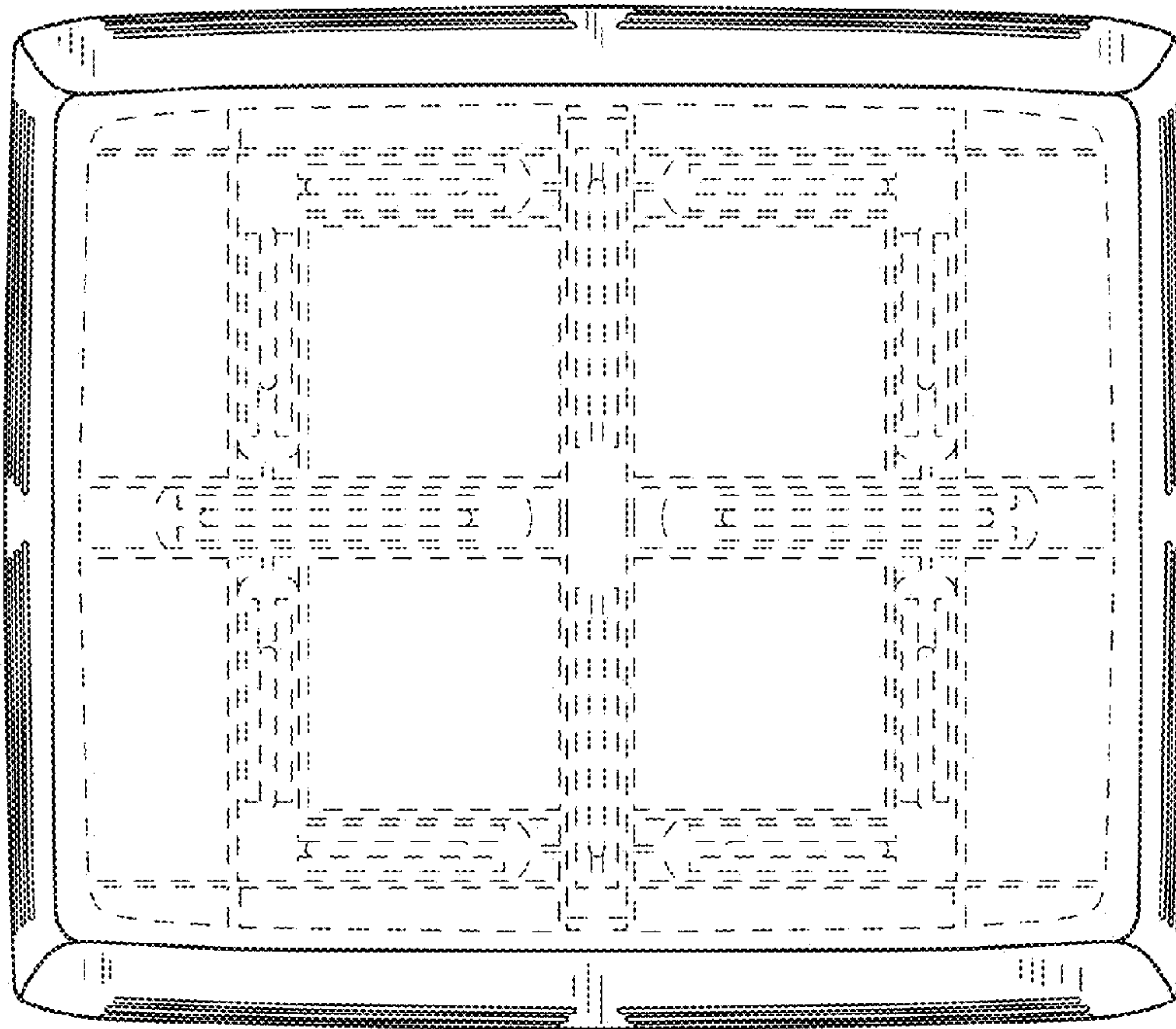
