FIG. 11 is an exemplary diagram illustrating the use of the claimed design.

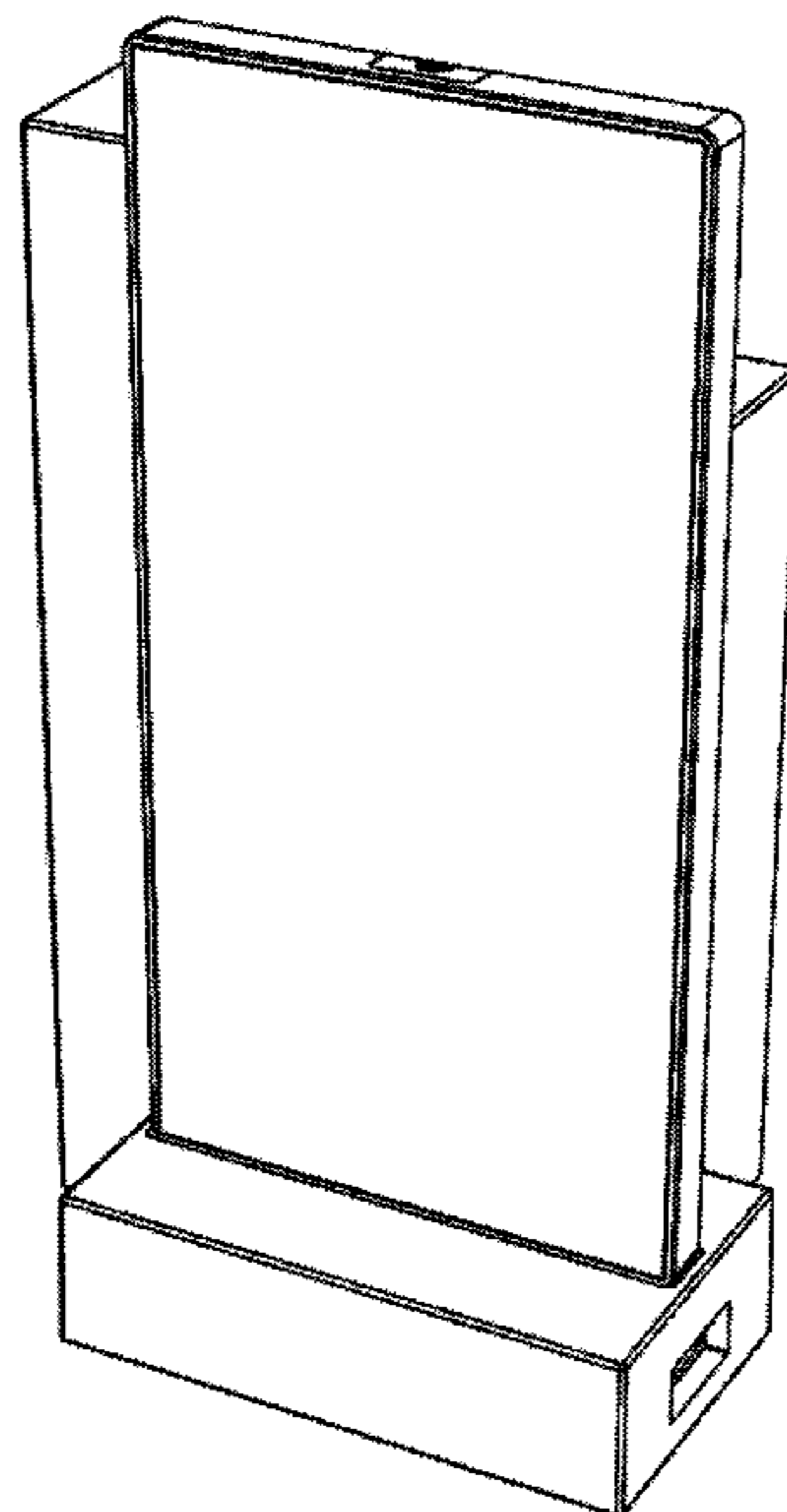
The dotted lines showing of user and a table in the figure merely illustrate the environment for the operation of the present design and therefore forms no part of the claimed design.

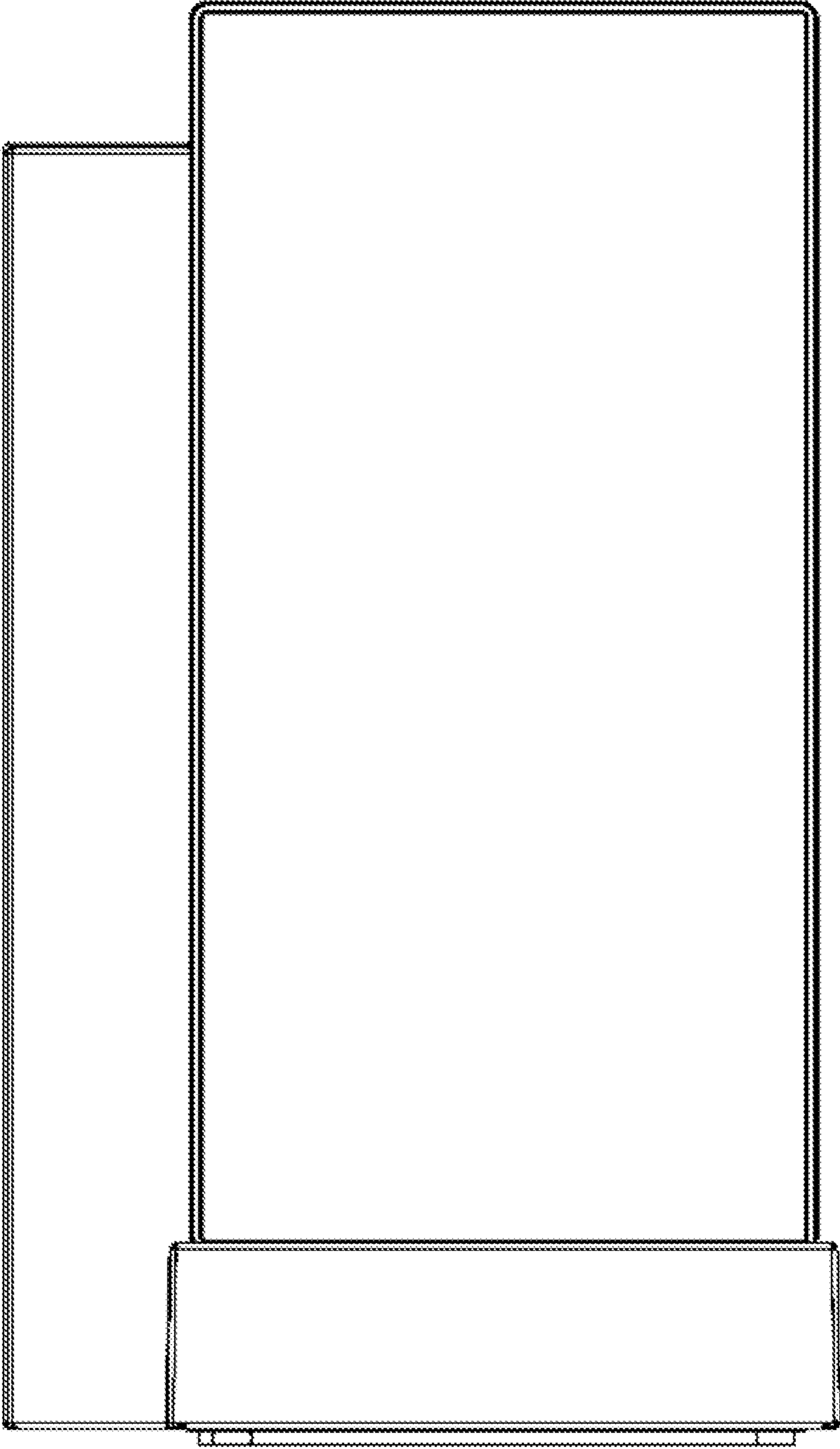

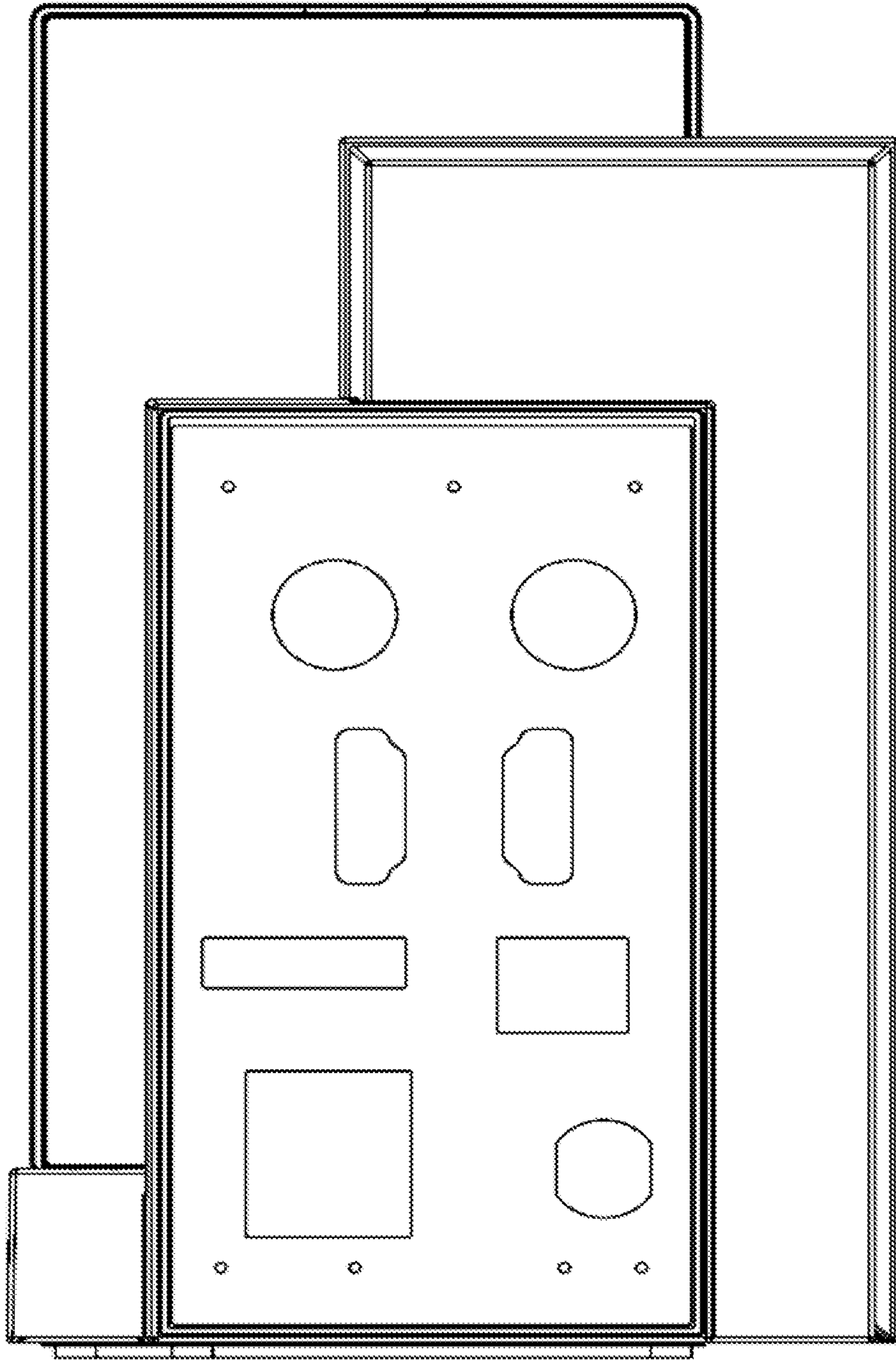

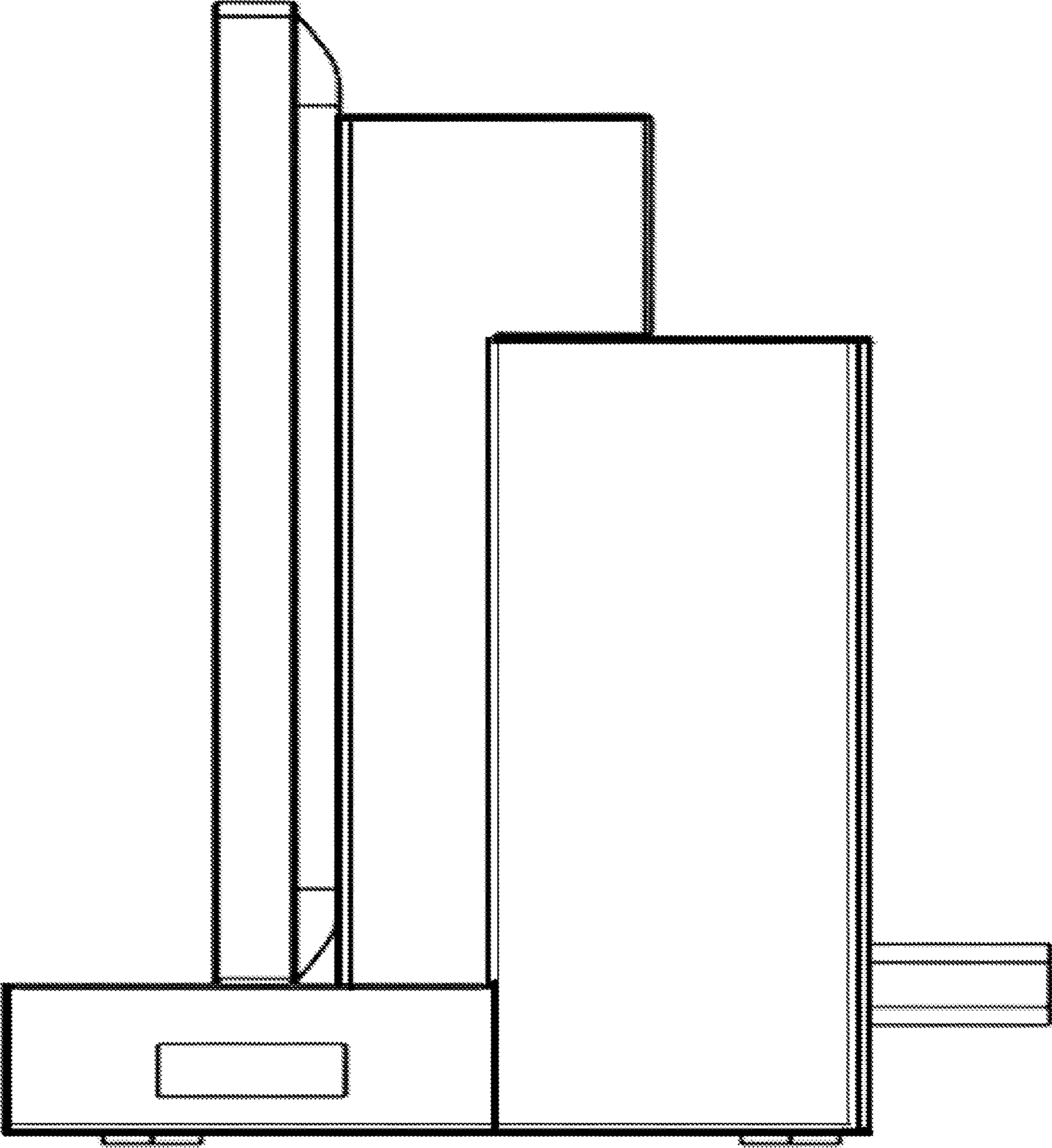

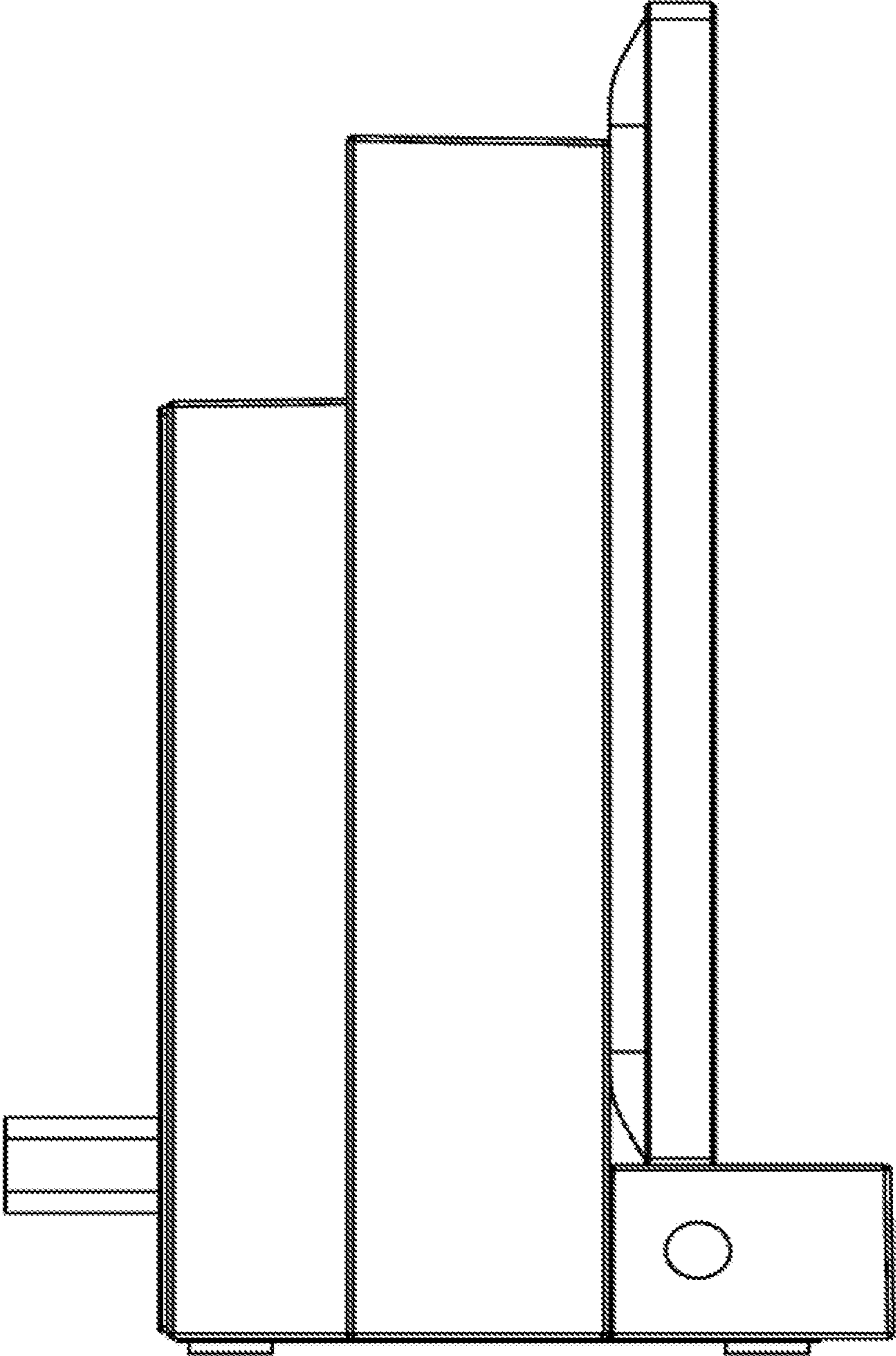

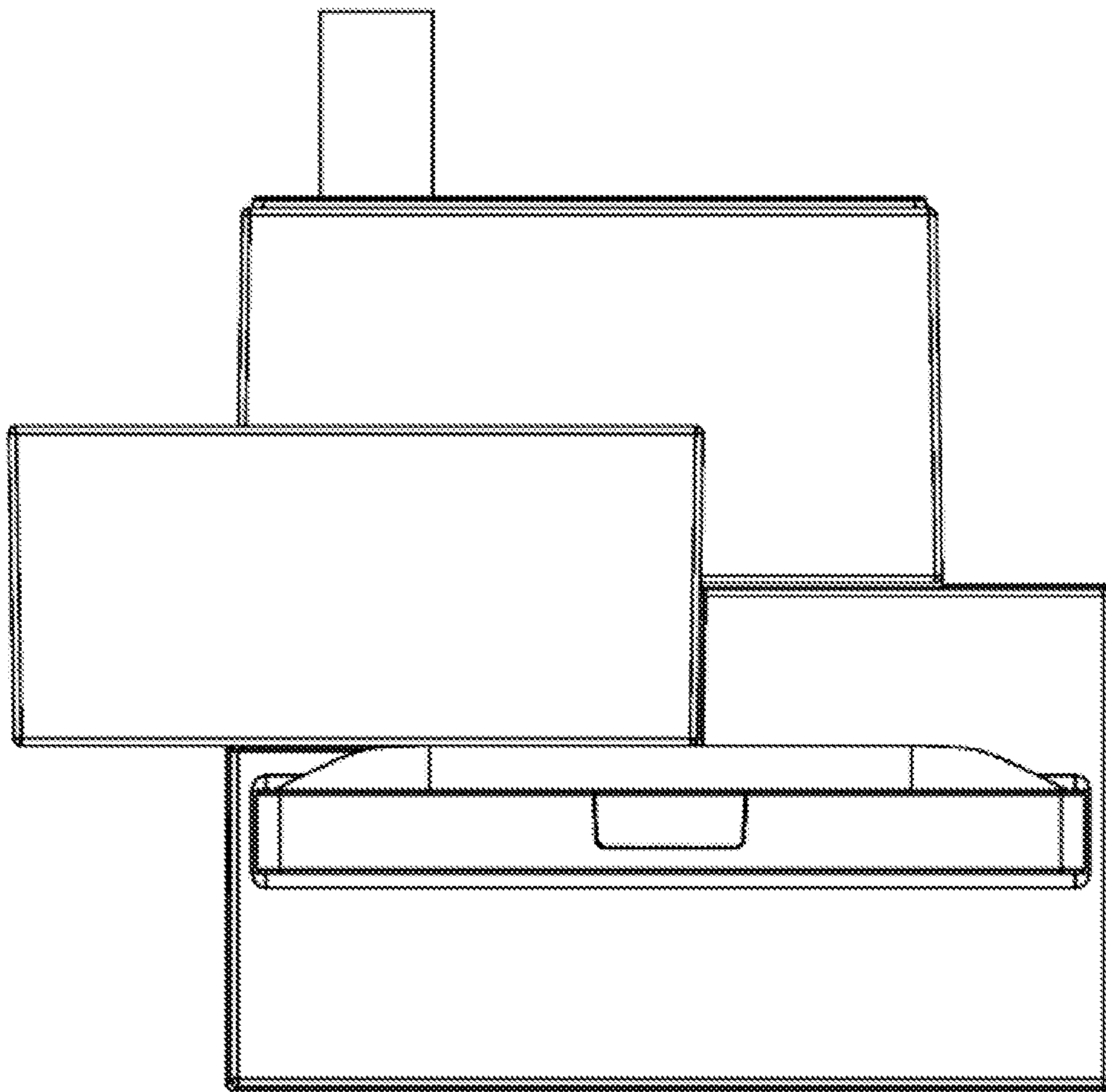

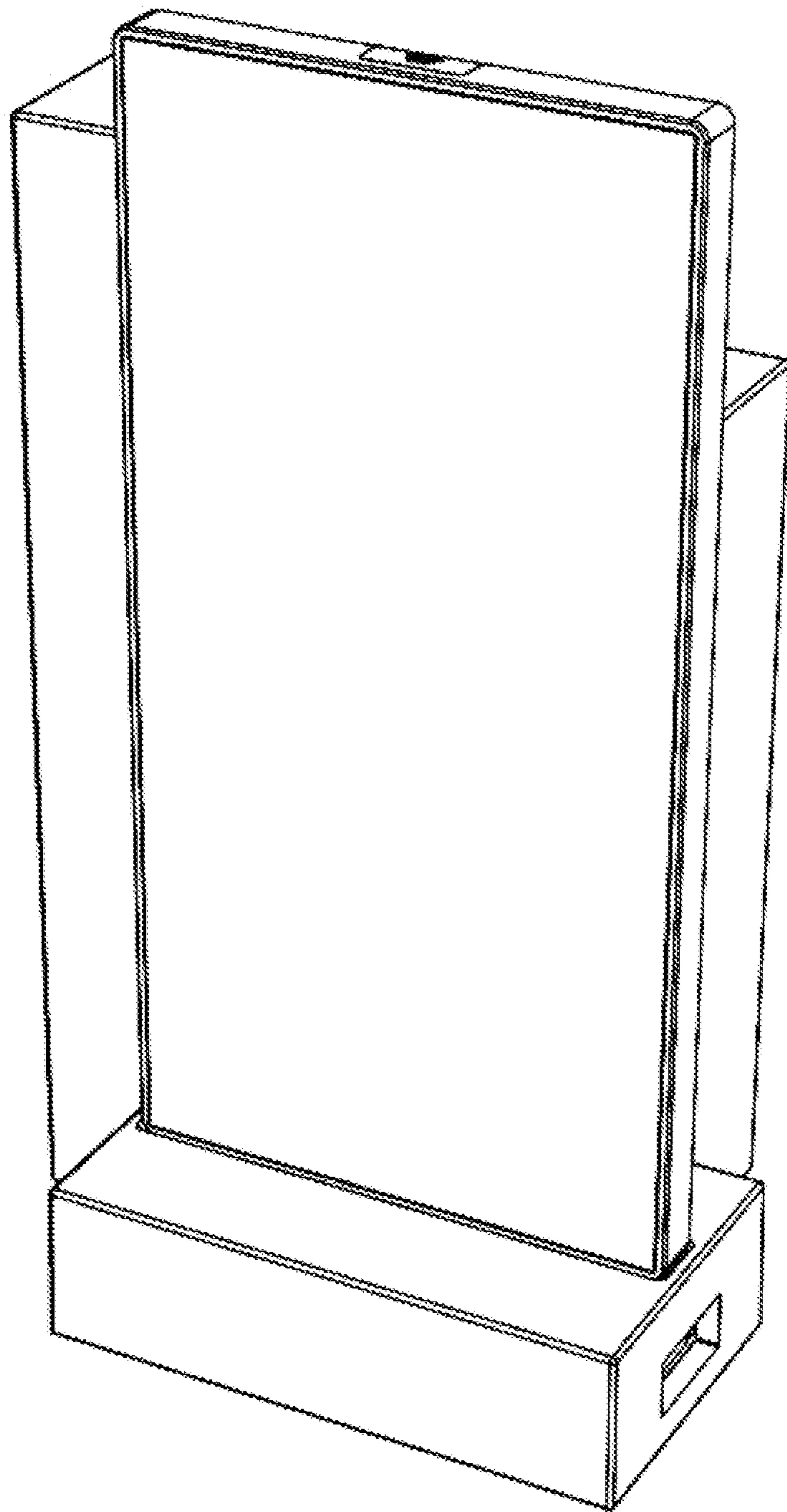

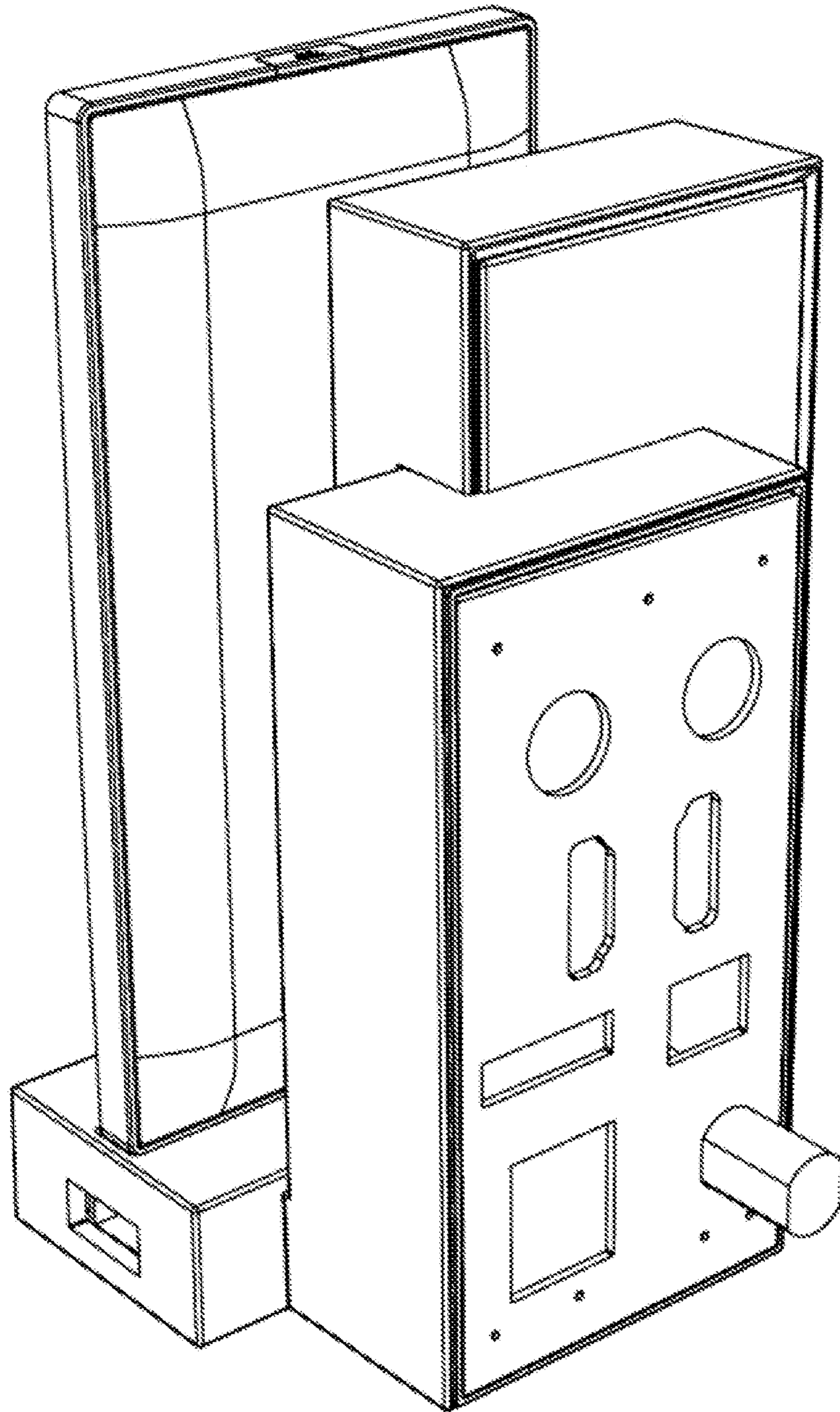

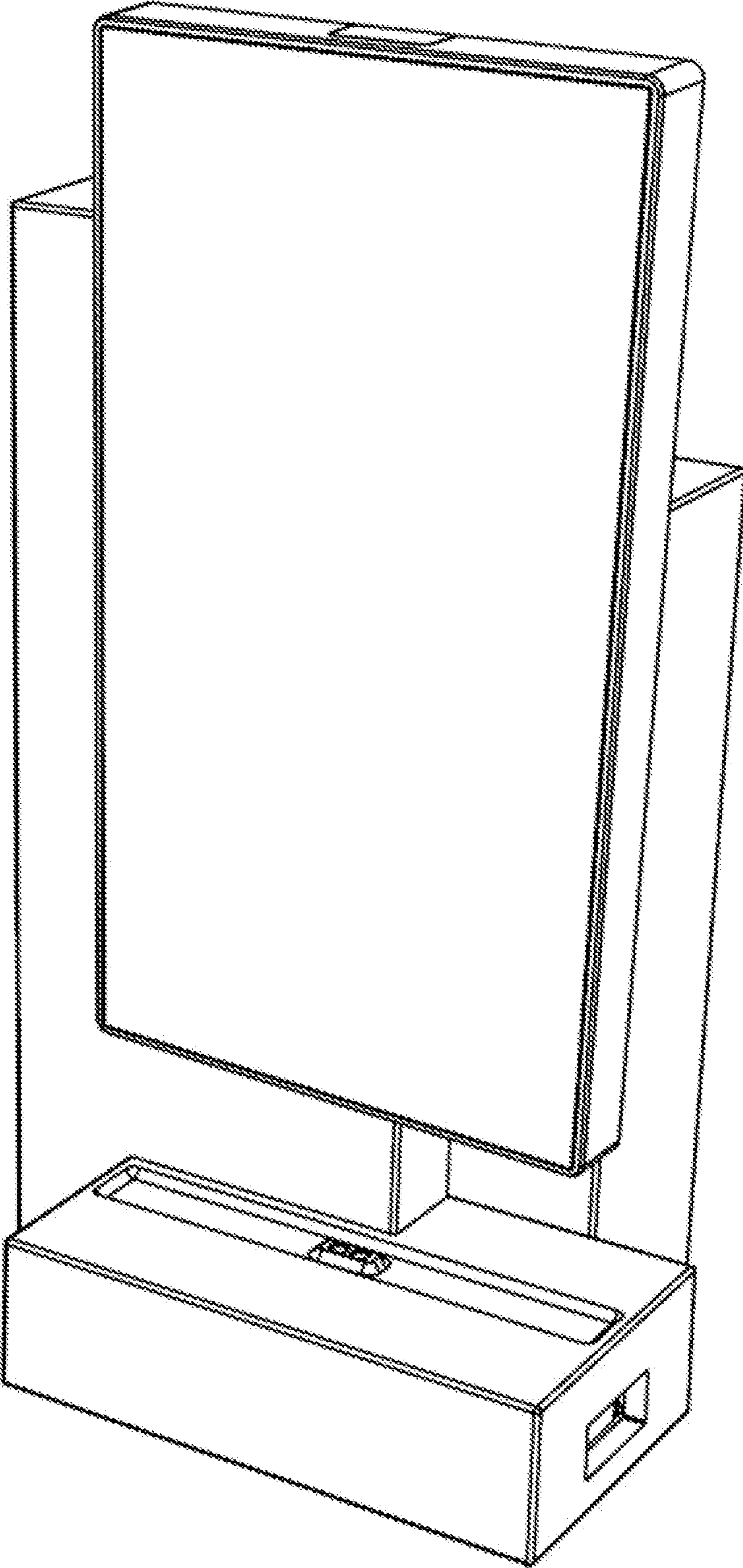

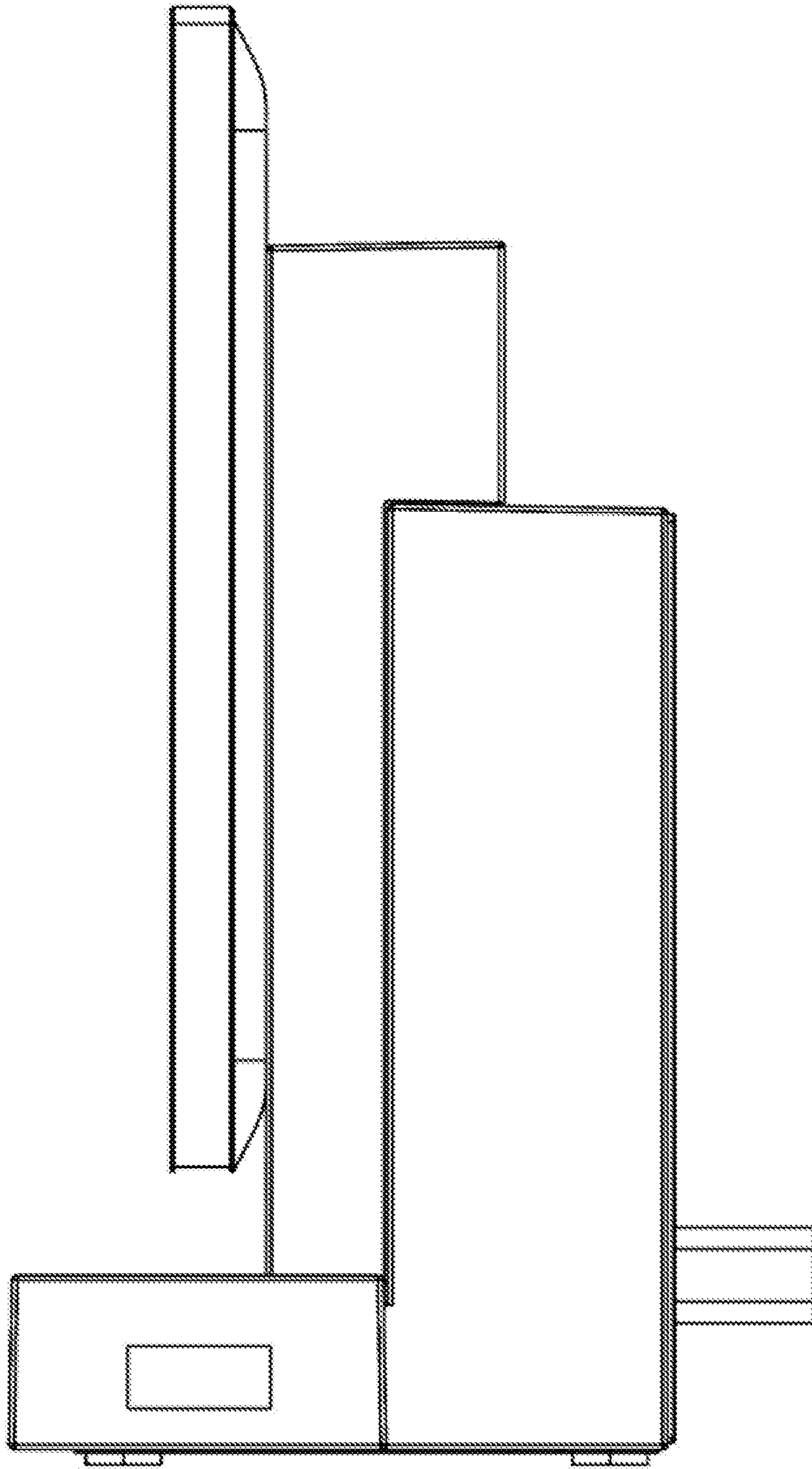

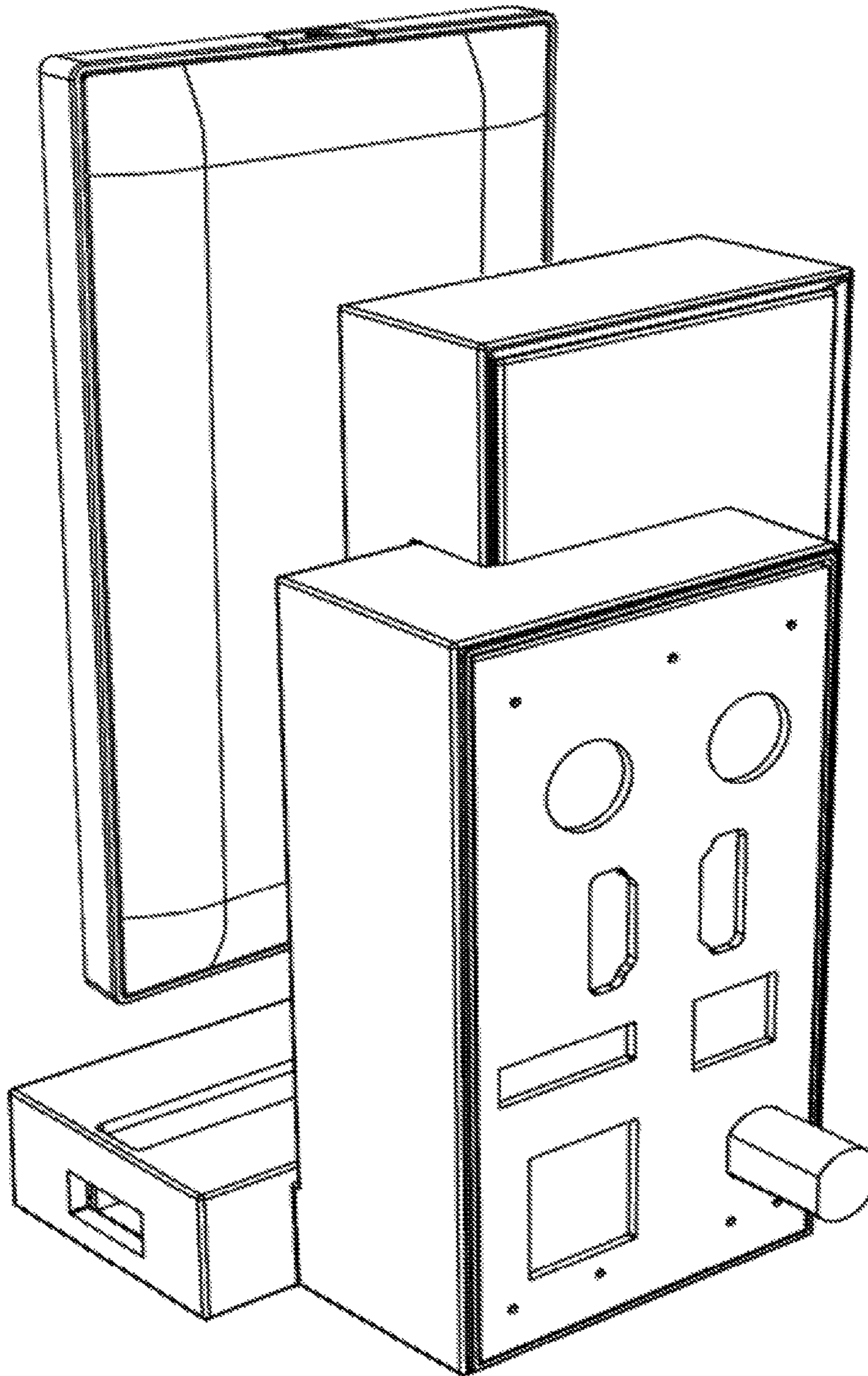

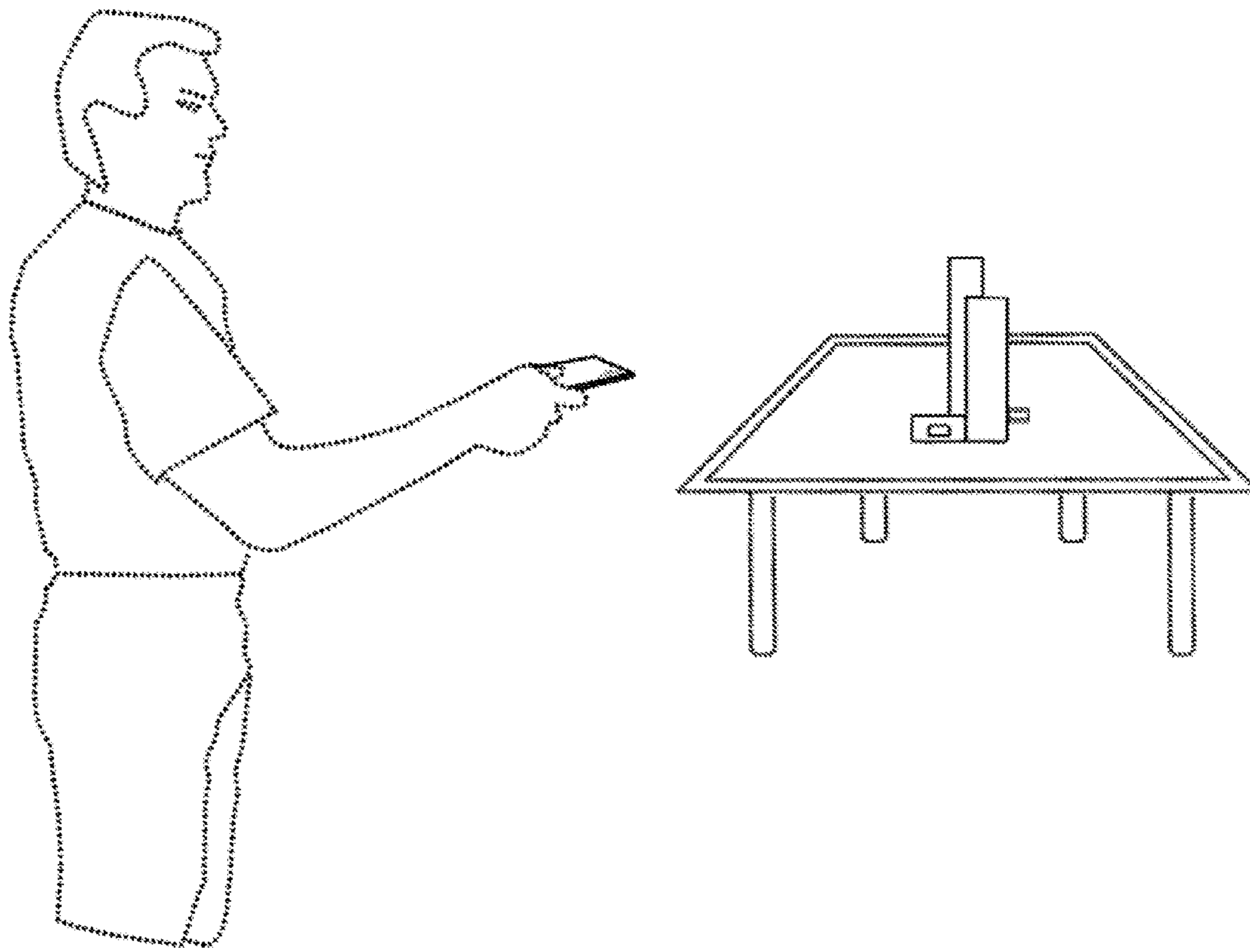
