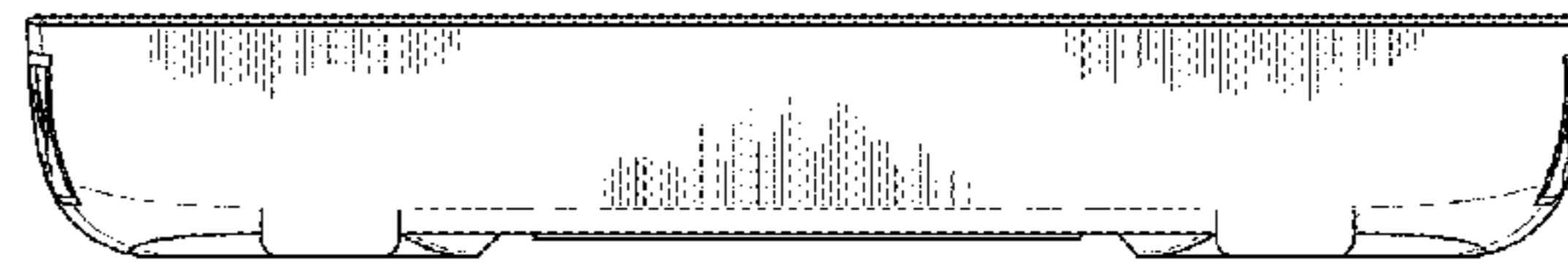
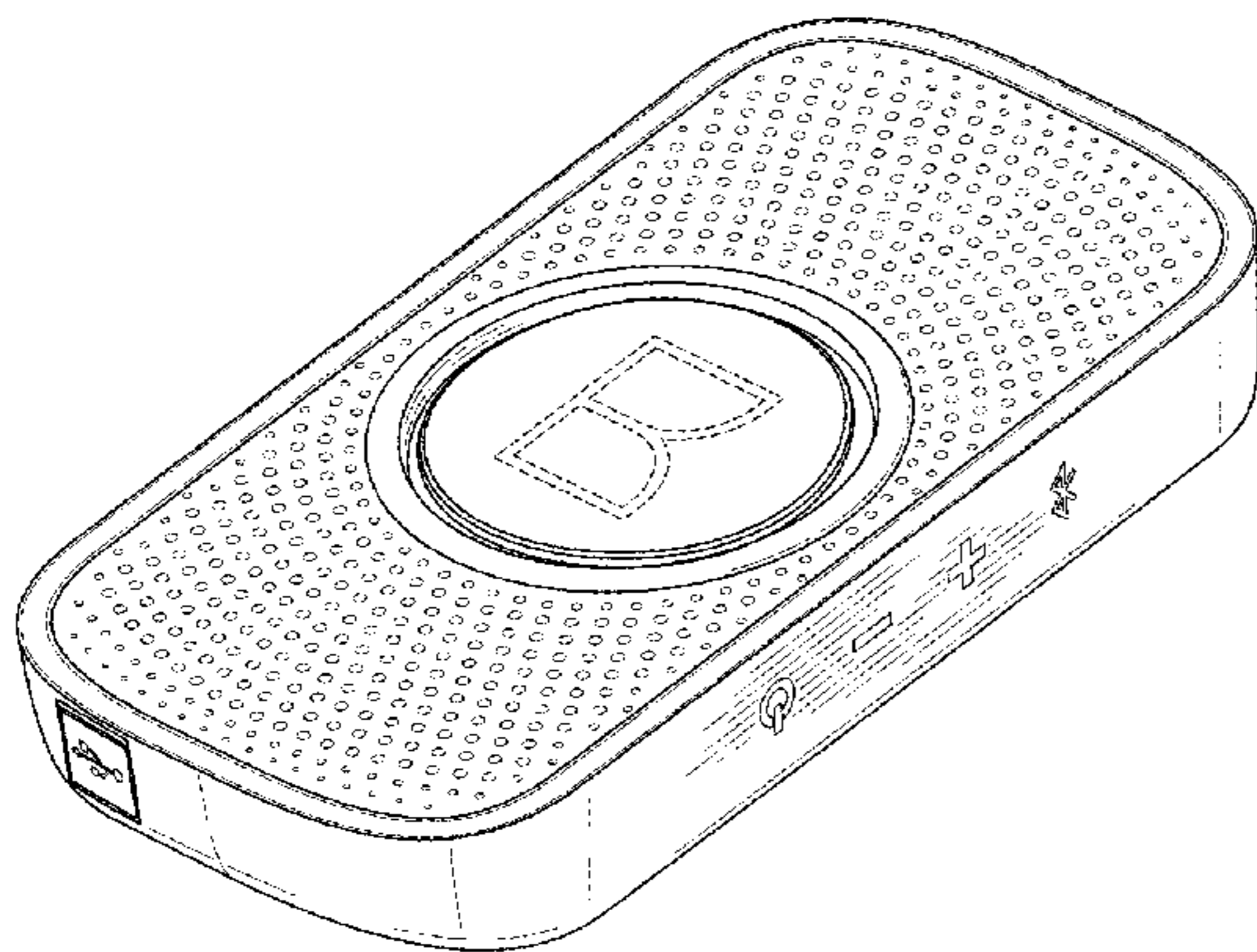
The ornamental design for an audio speaker, as shown and described.

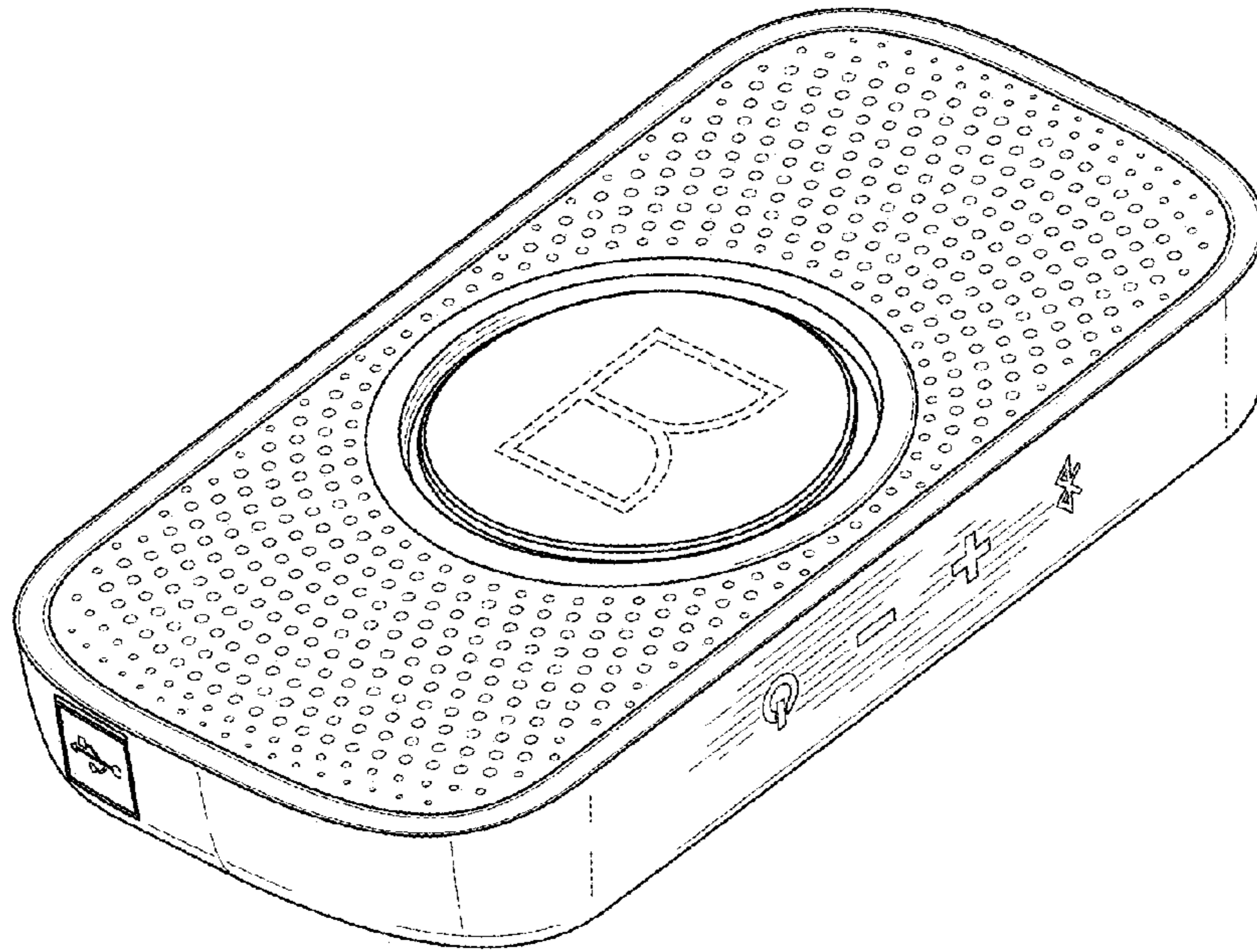

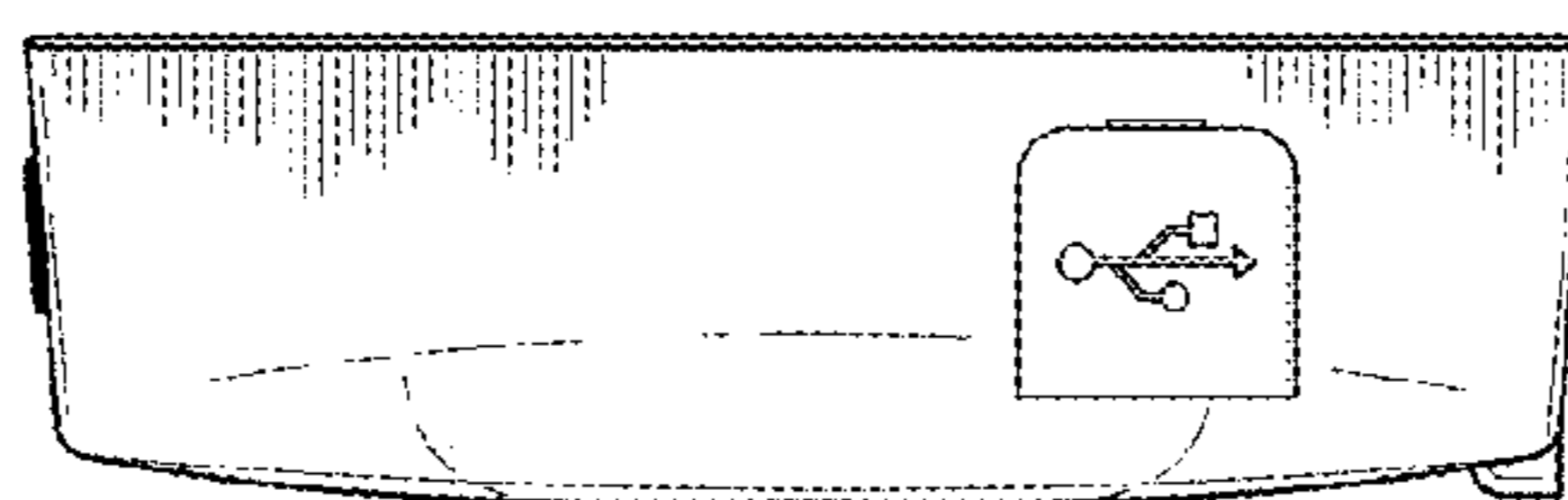

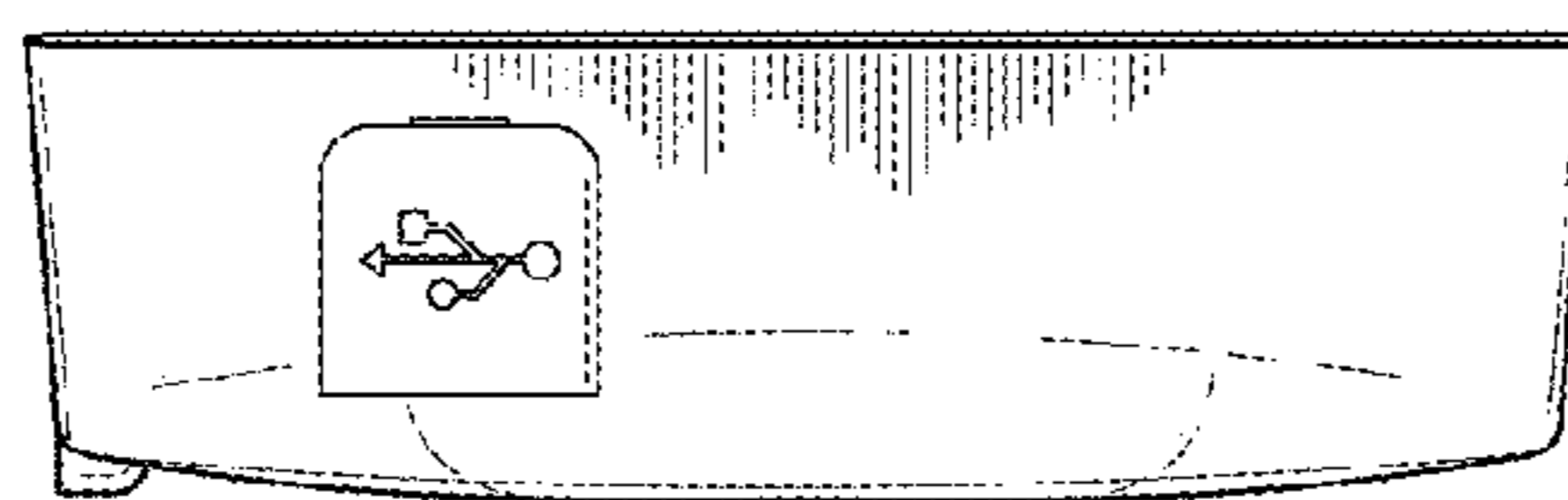

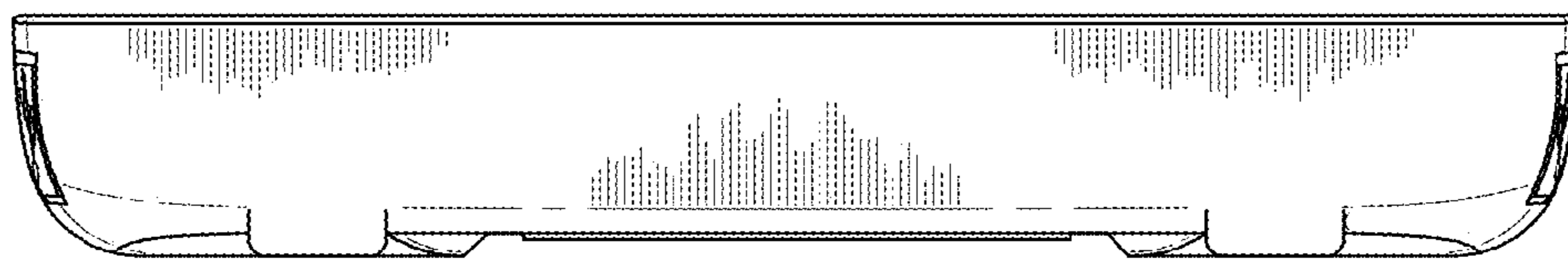

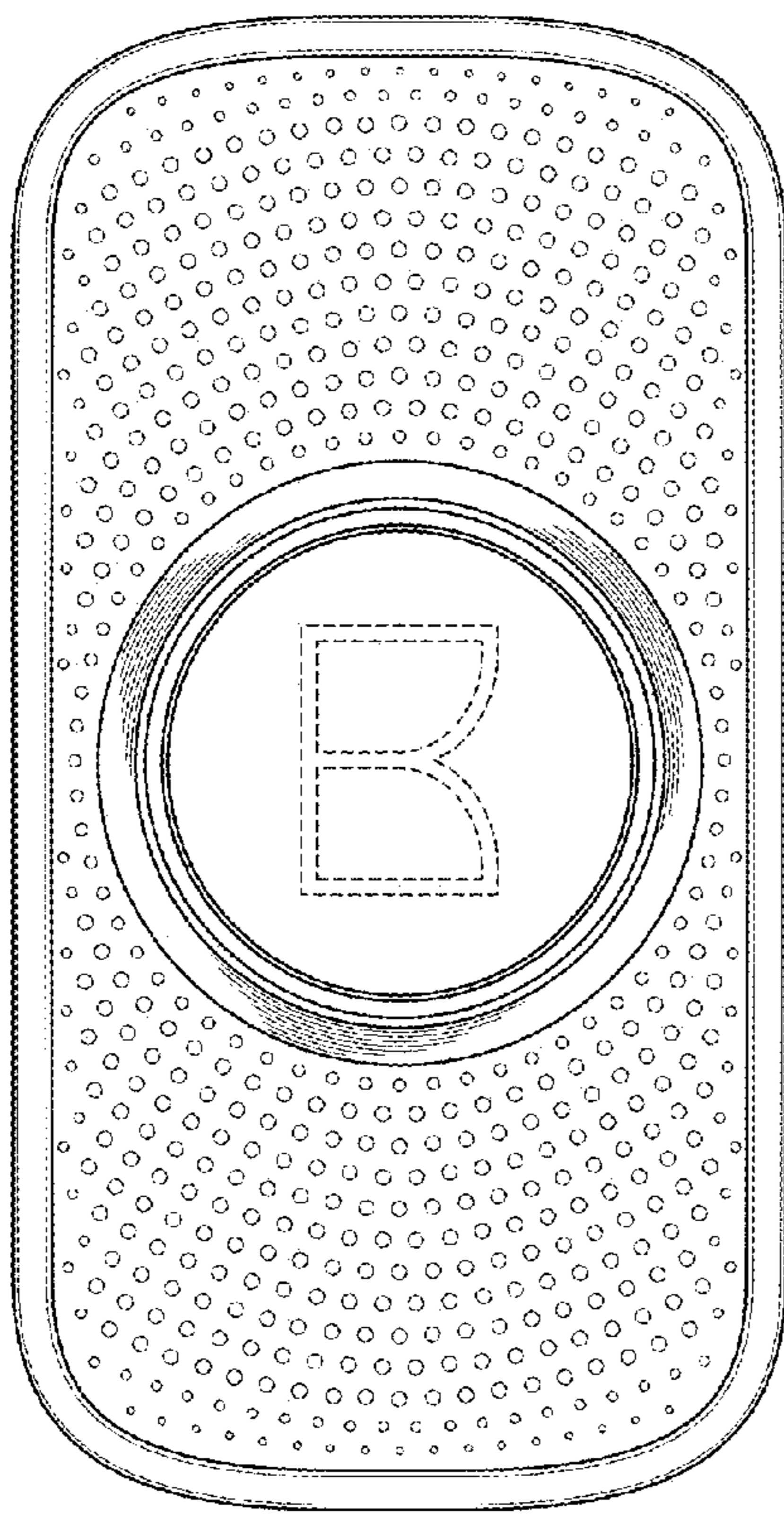

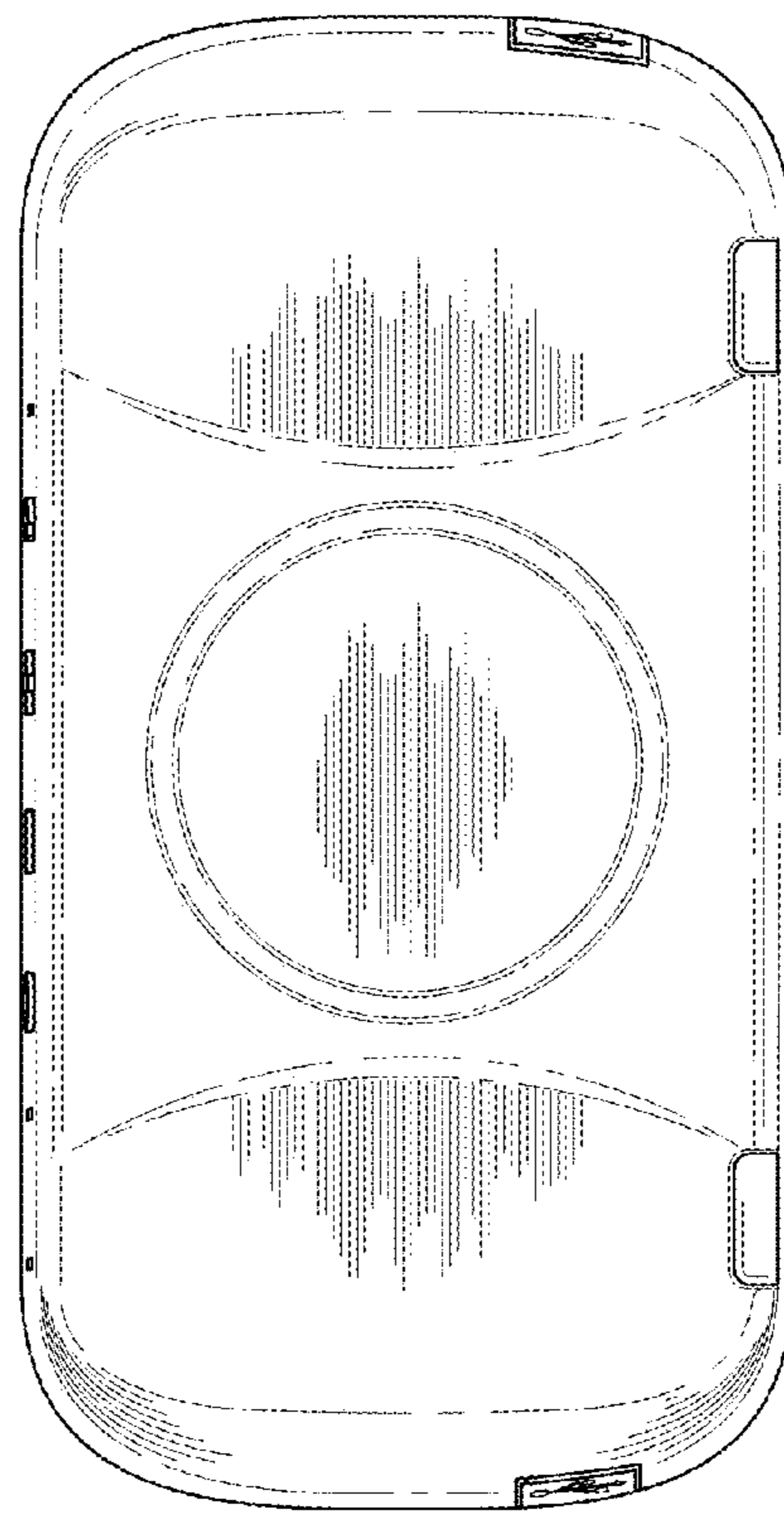
