(57) **CLAIM**

We claim, the ornamental design for a supporter for portable terminal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a supporter for portable terminal, showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is another side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is another perspective view thereof, as shown in an alternate configuration; and,
FIG. 9 is another perspective view thereof, as shown in a portable terminal environment.

The dash-dot-dash broken lines in the drawings represent bounds of the claim and the dash-dash broken lines depict environmental subject matter; all broken lines form no part of the claimed design.

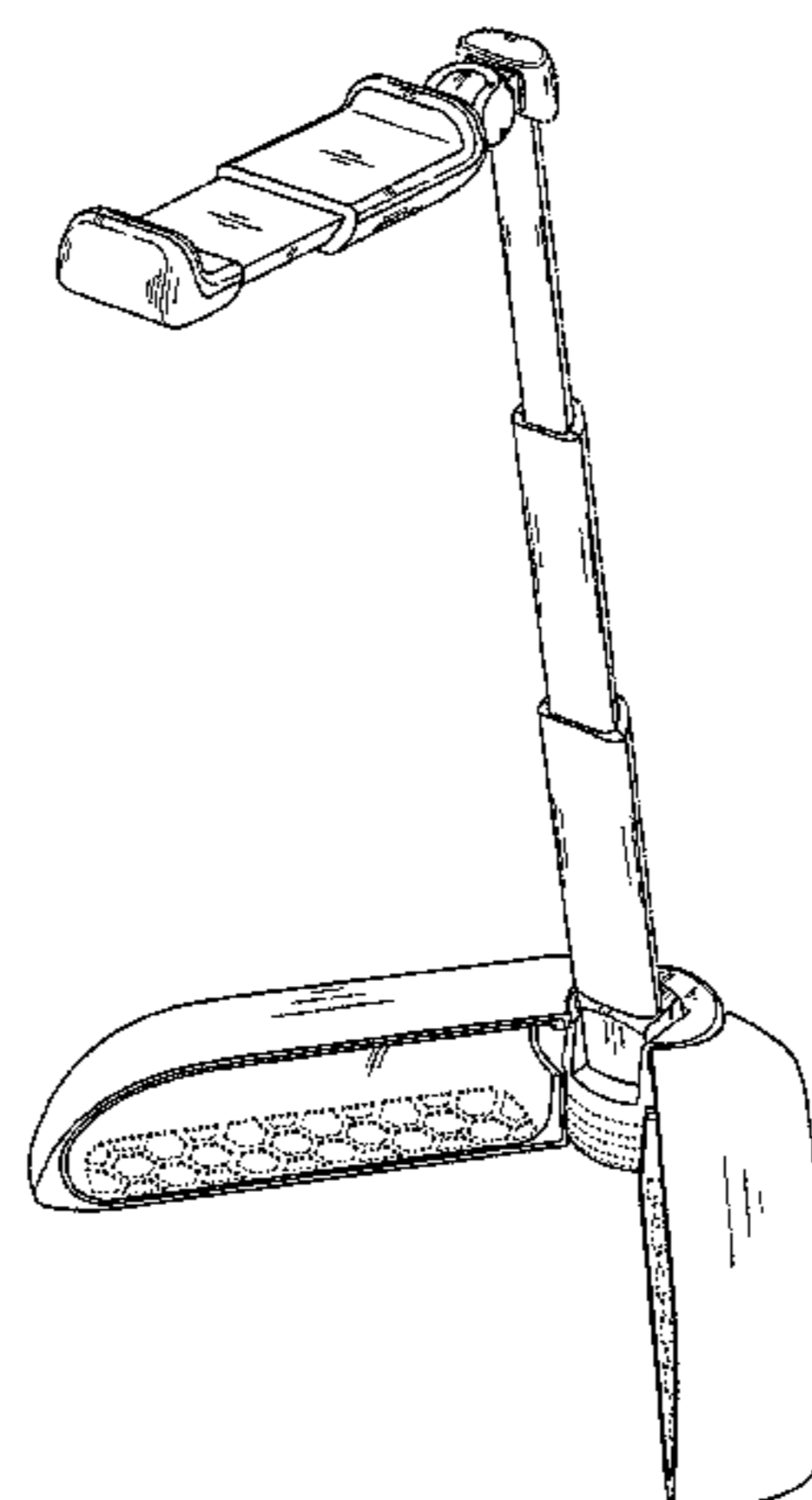
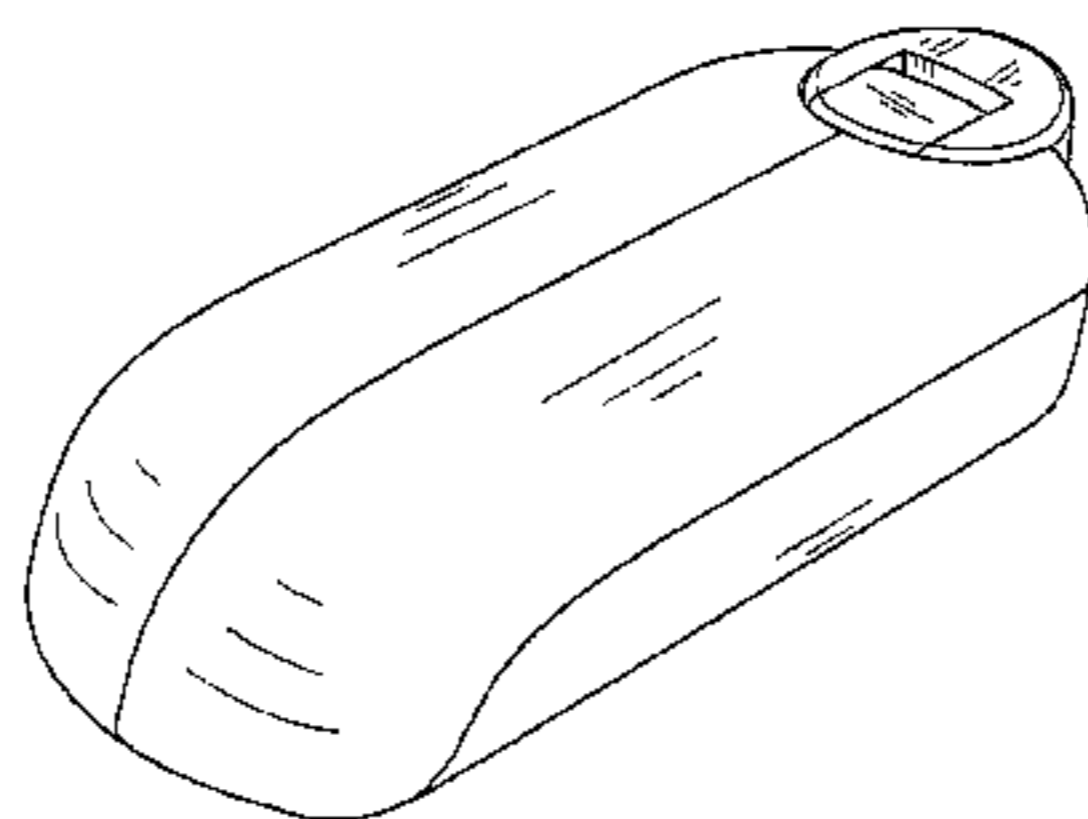

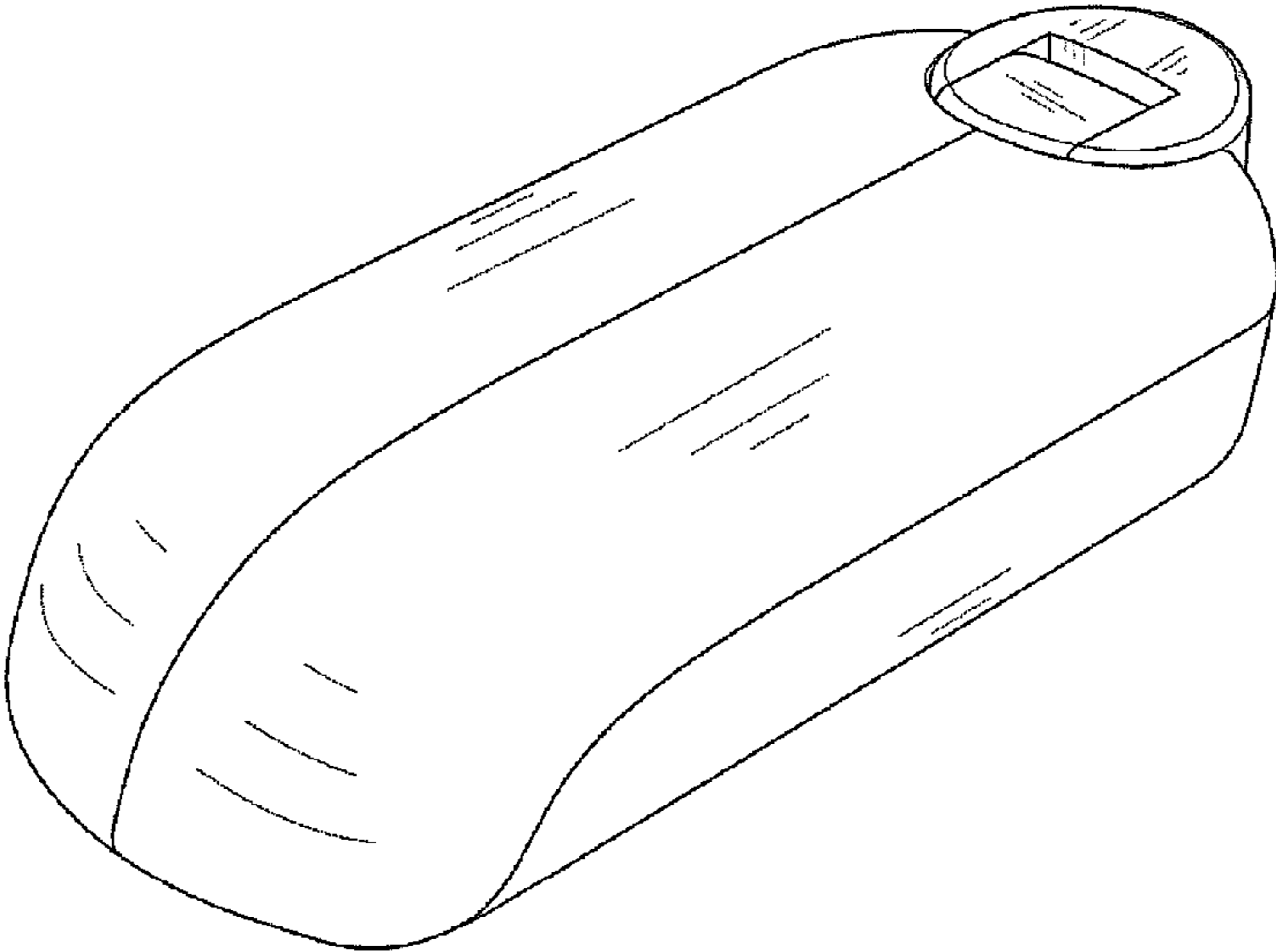

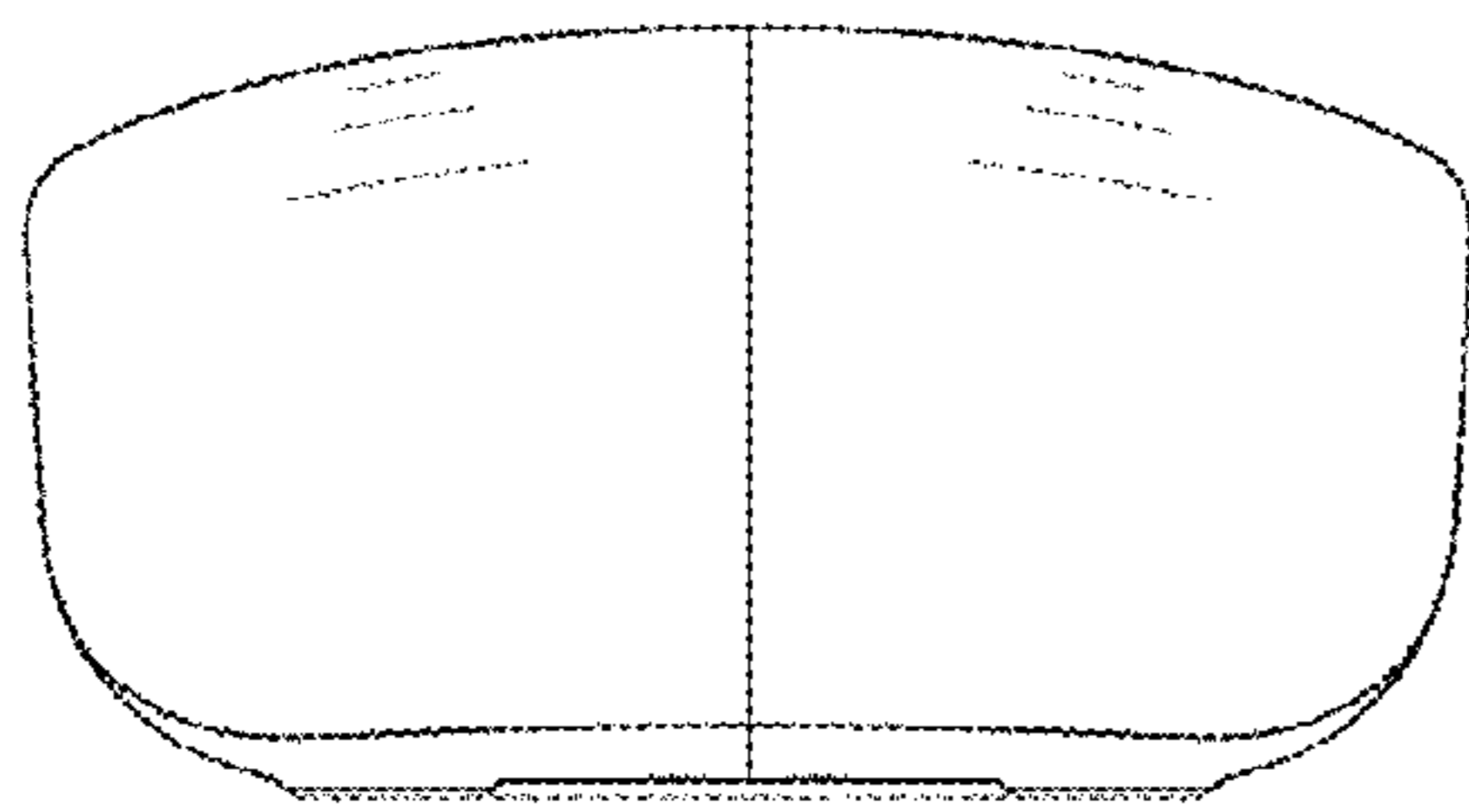

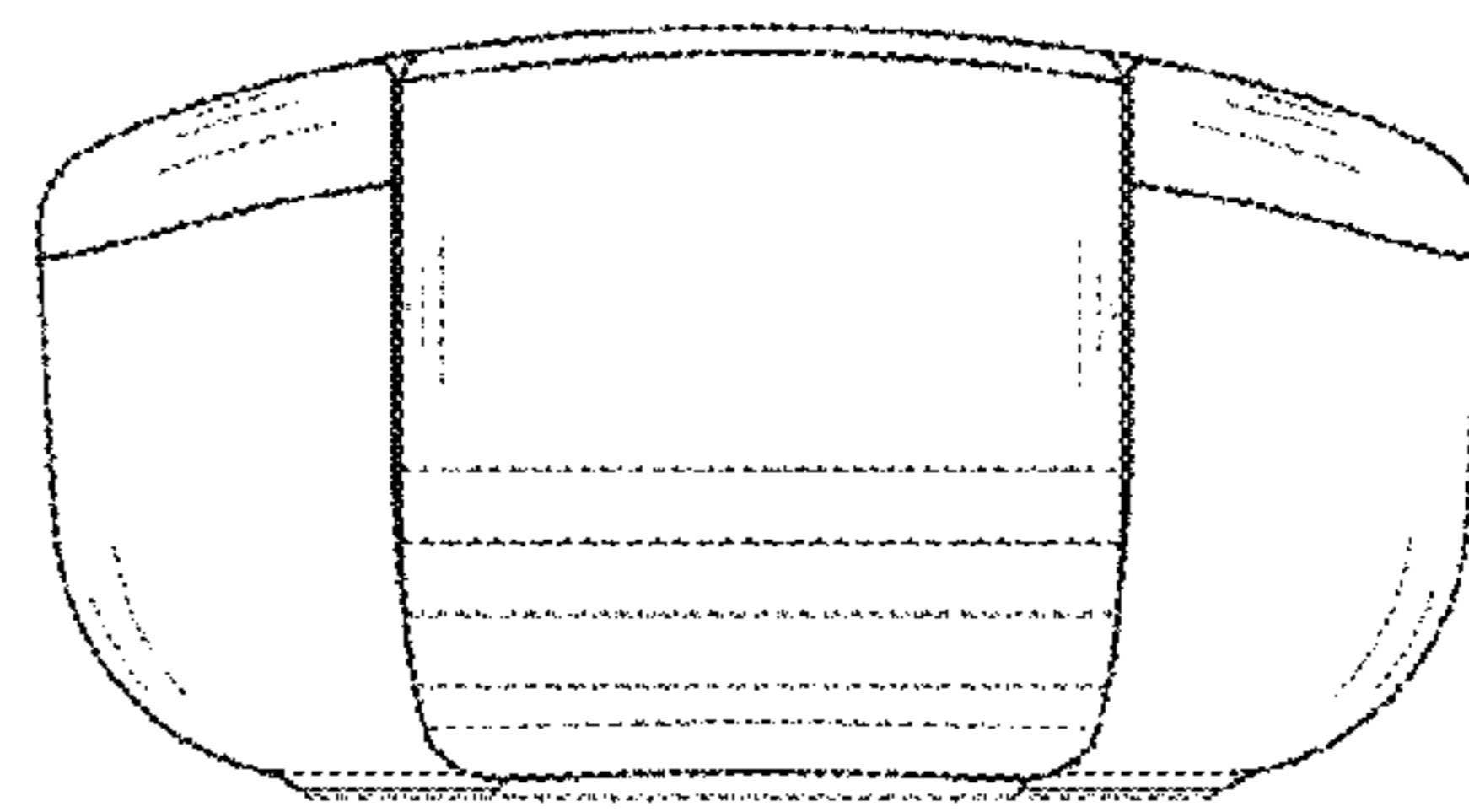

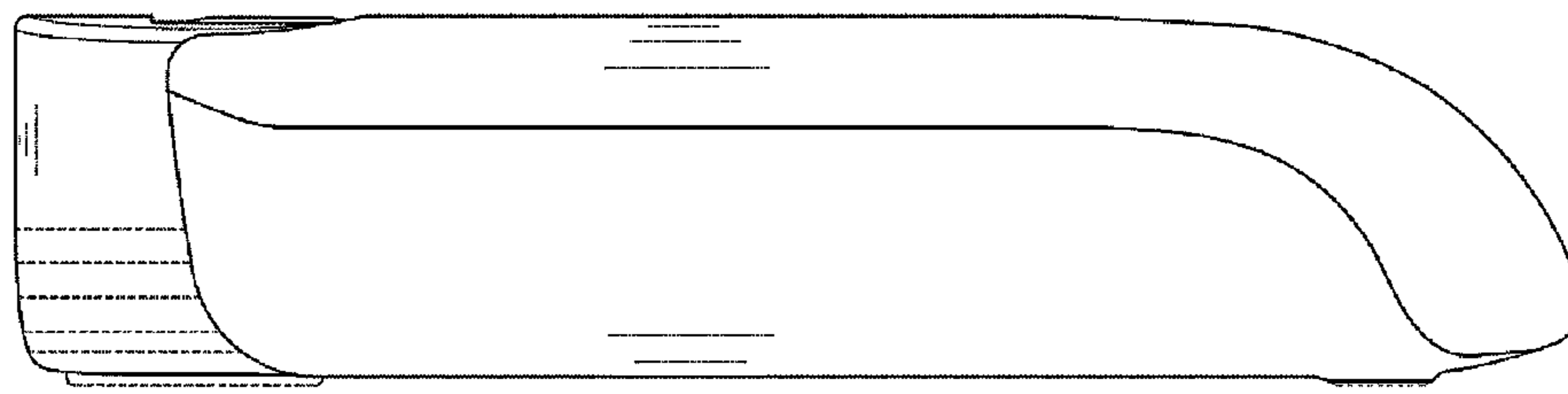

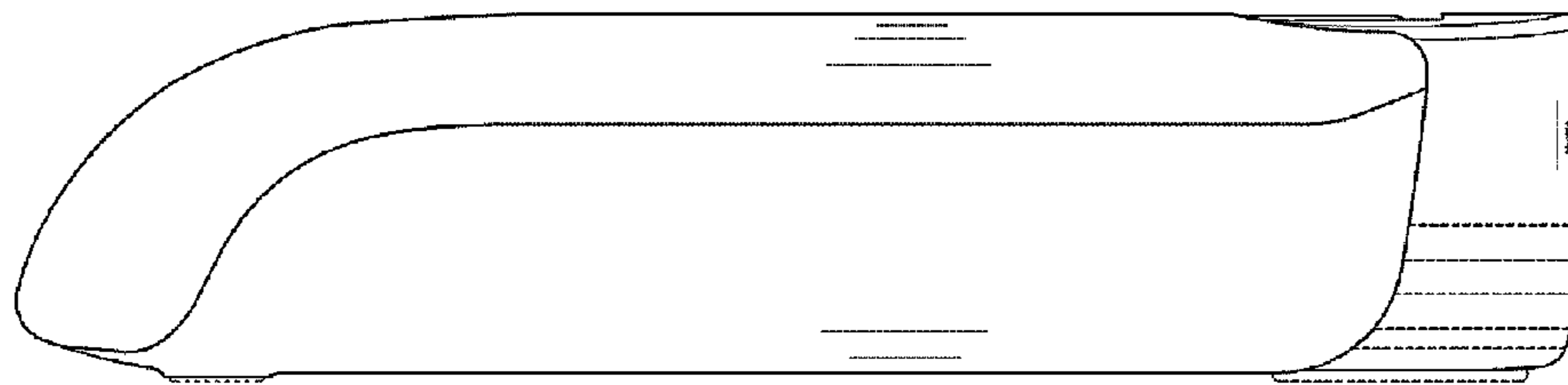

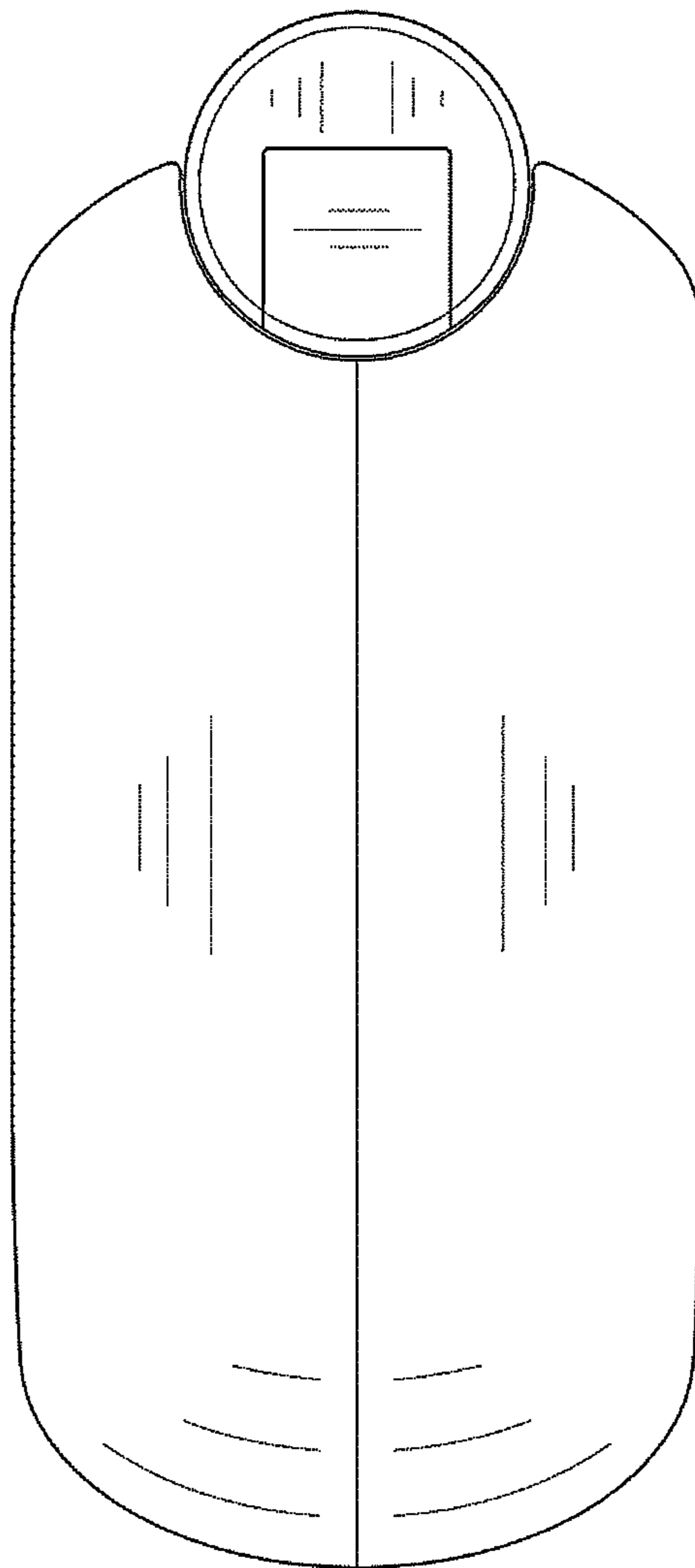

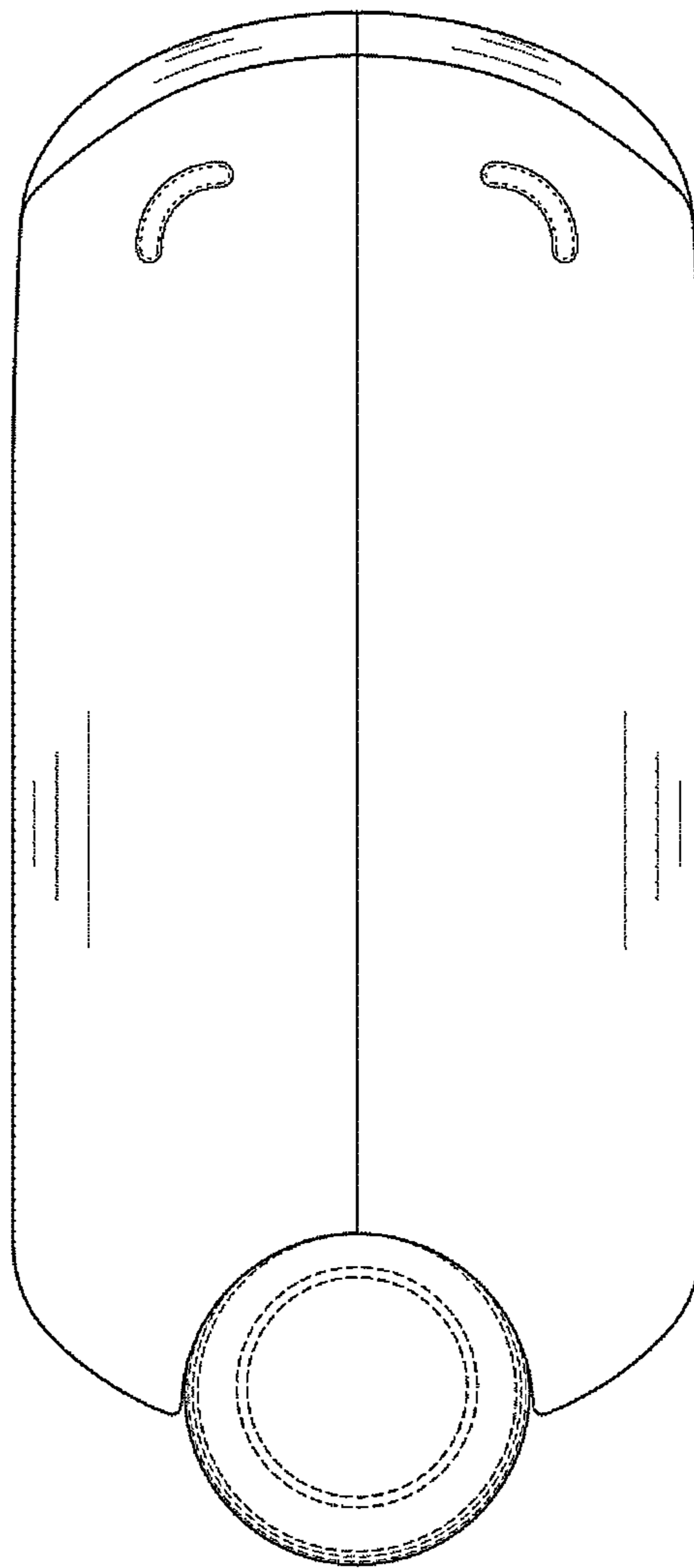

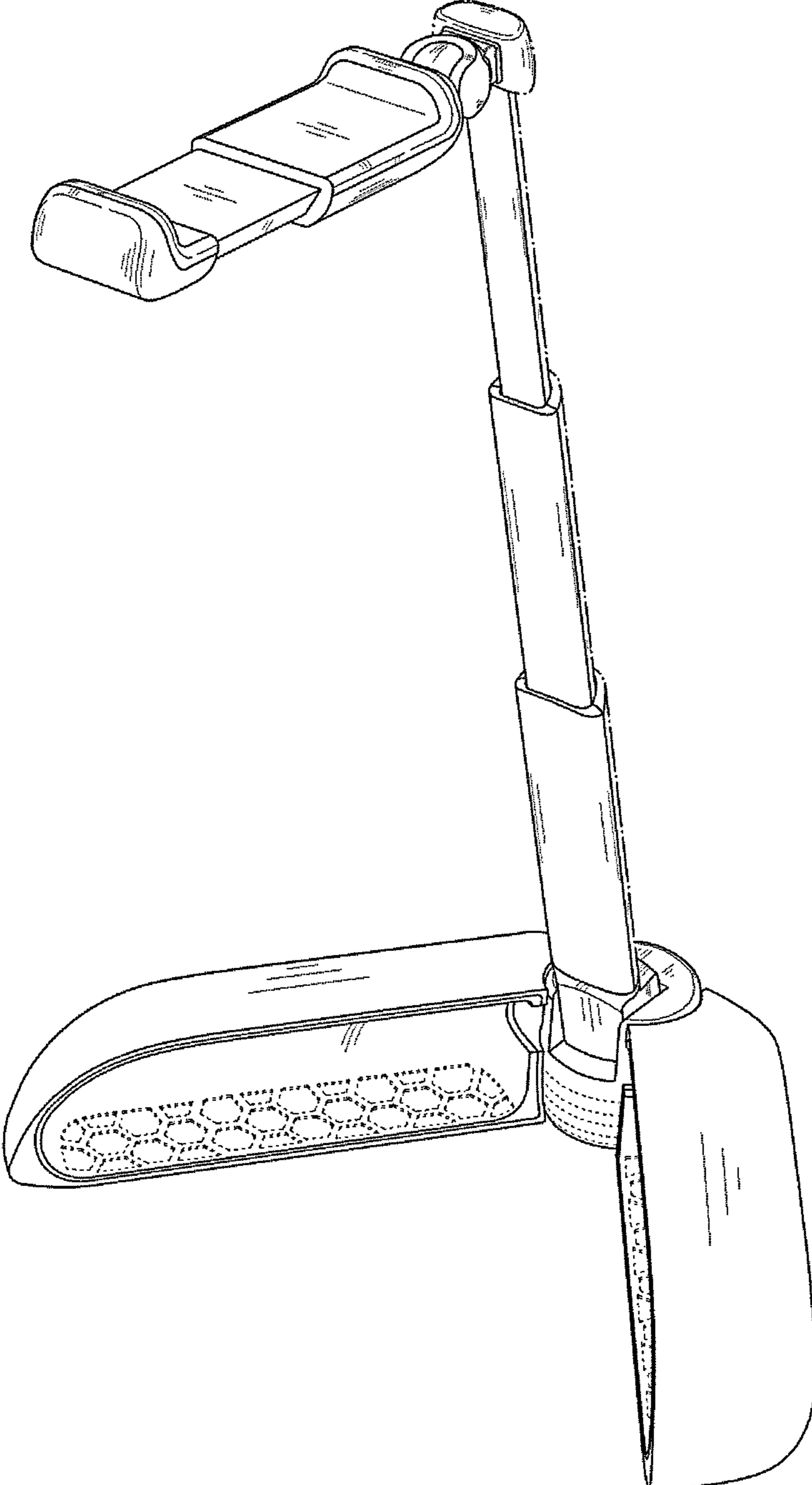
