FIG. 3 is a rear elevation view of the elastic resistance training device;

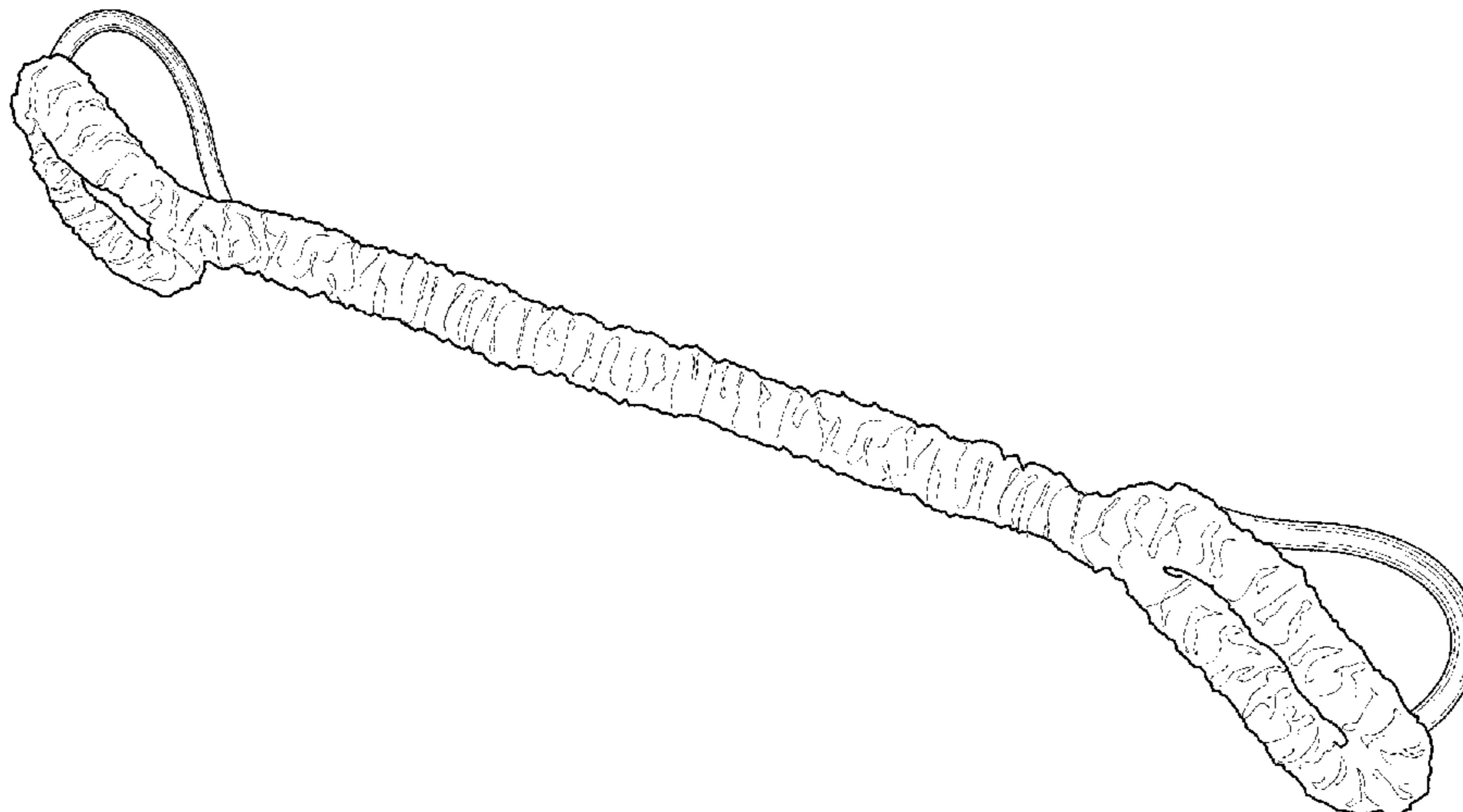
FIG. 4 is a left side elevation view of the elastic resistance training device;

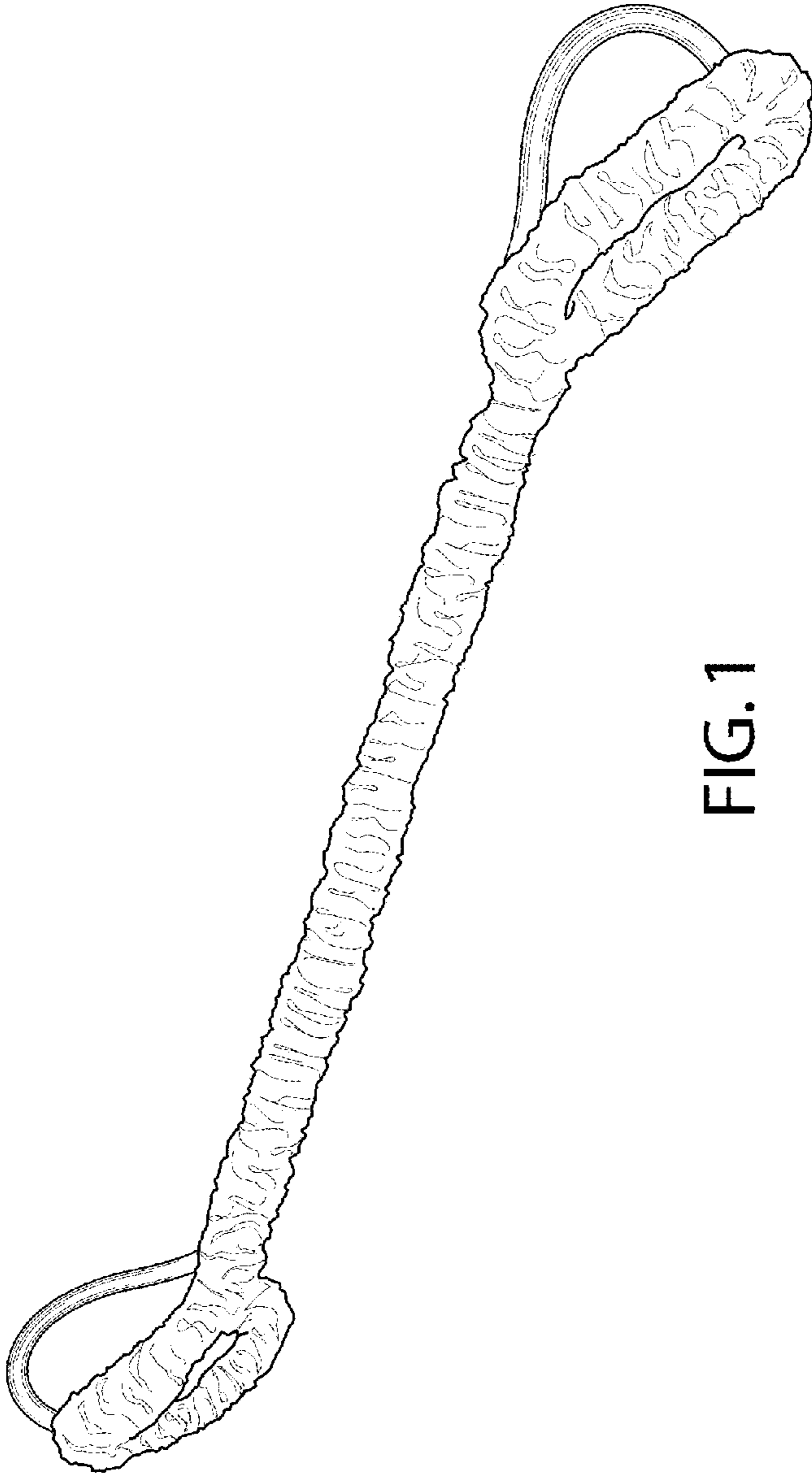

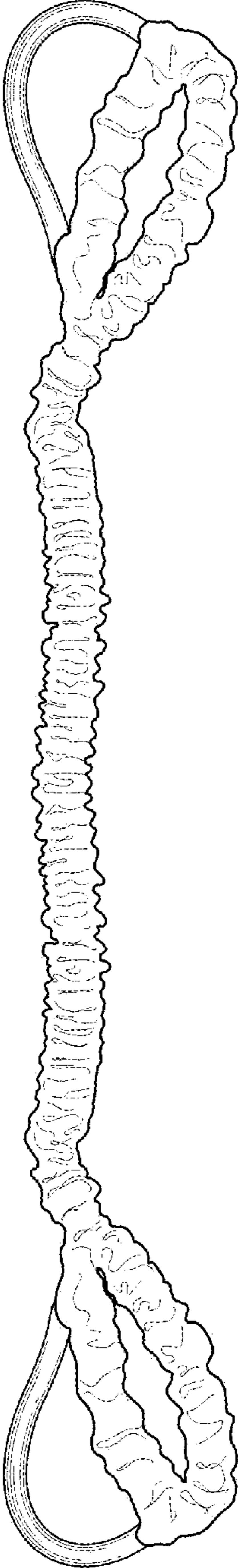

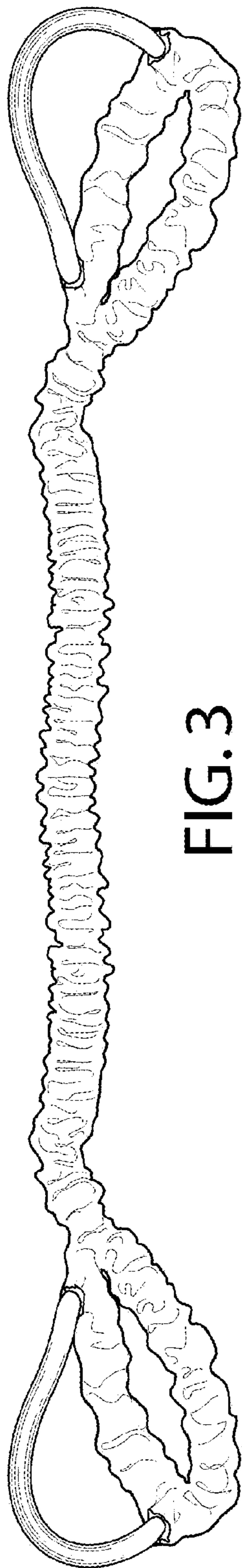

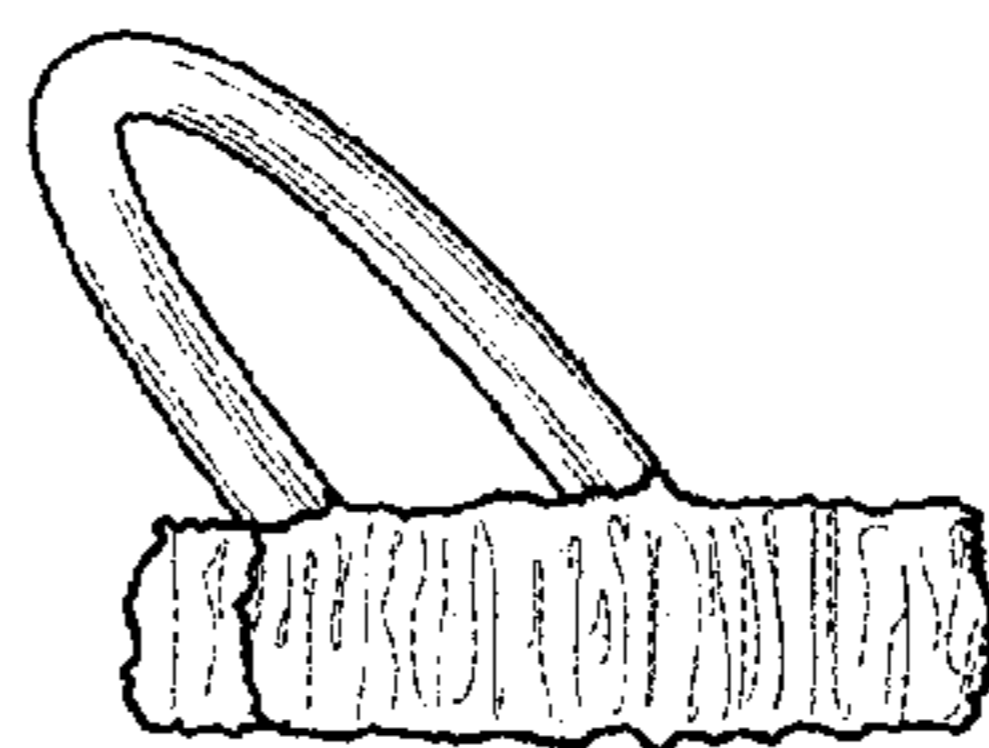

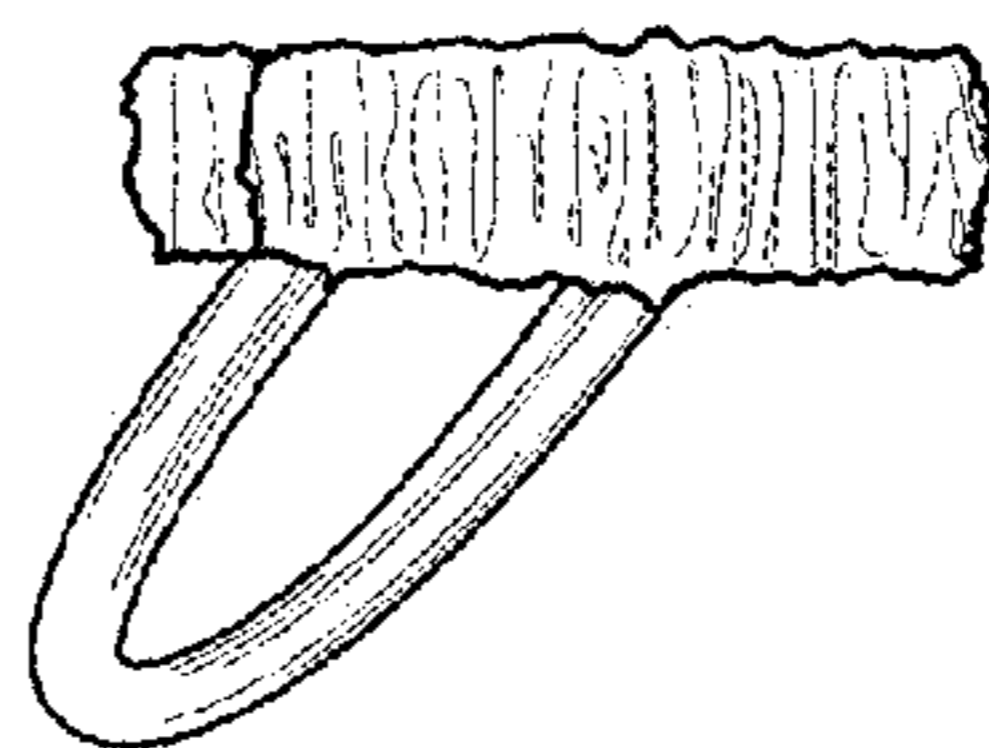

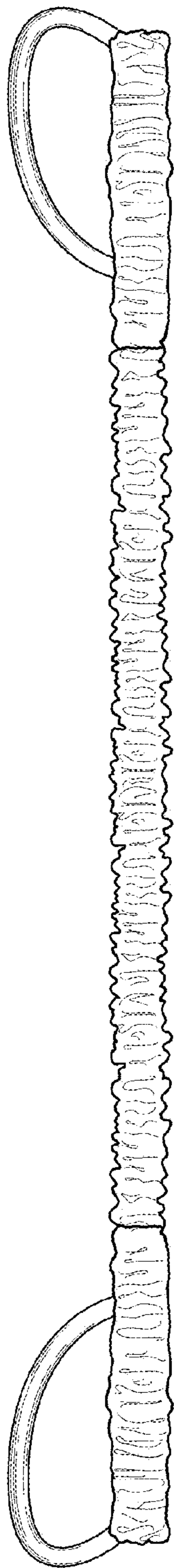

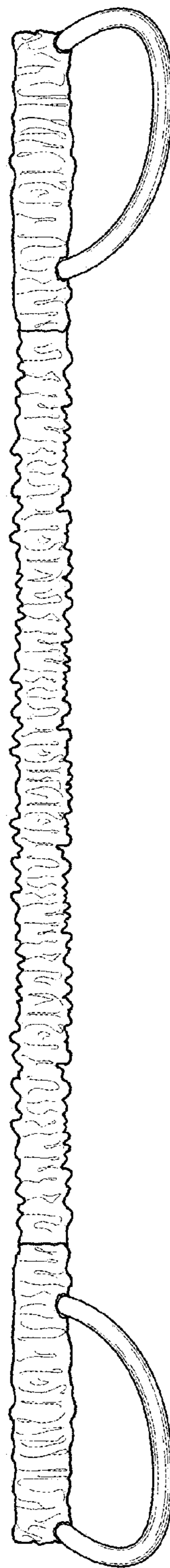
