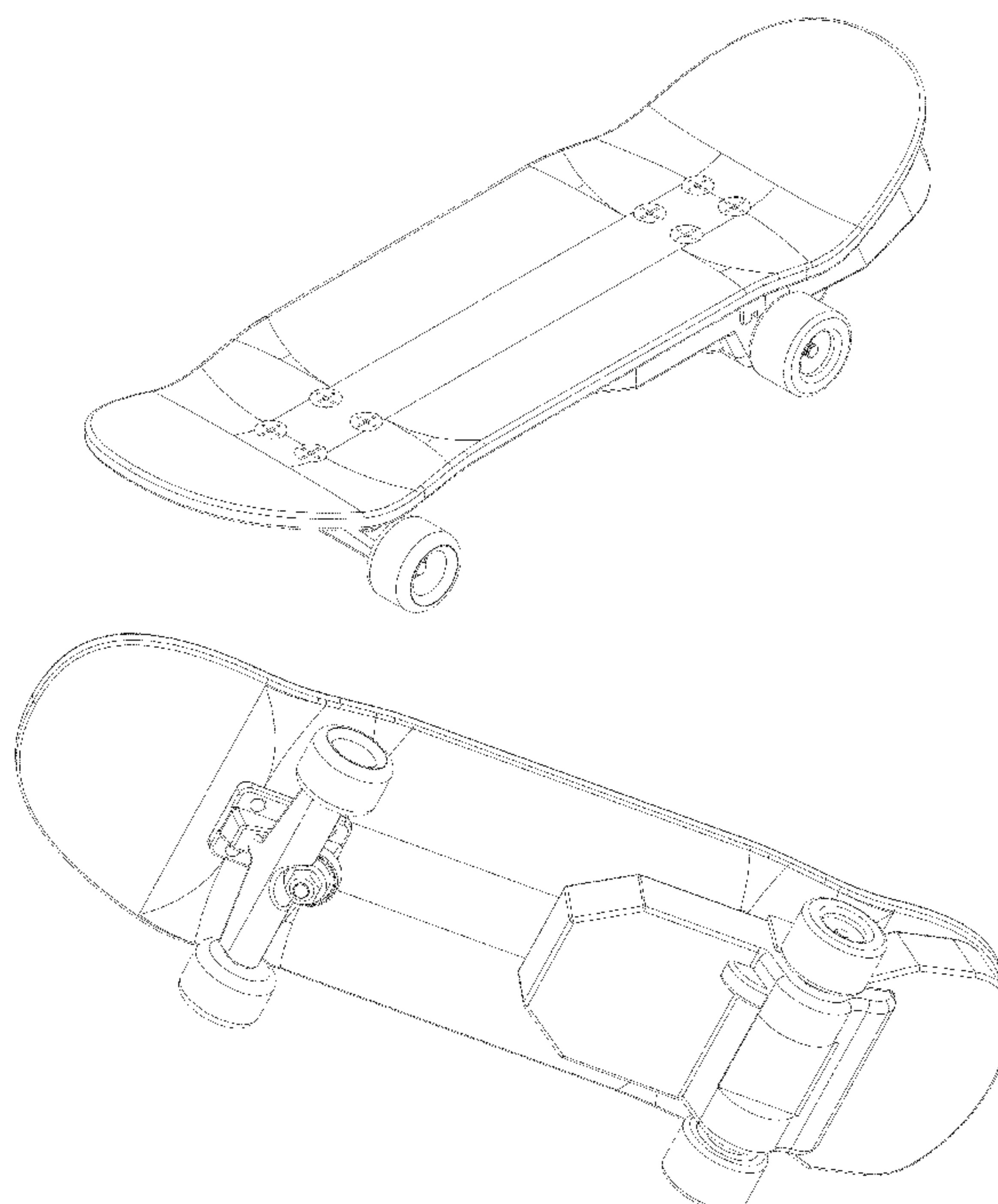
(57) **CLAIM**

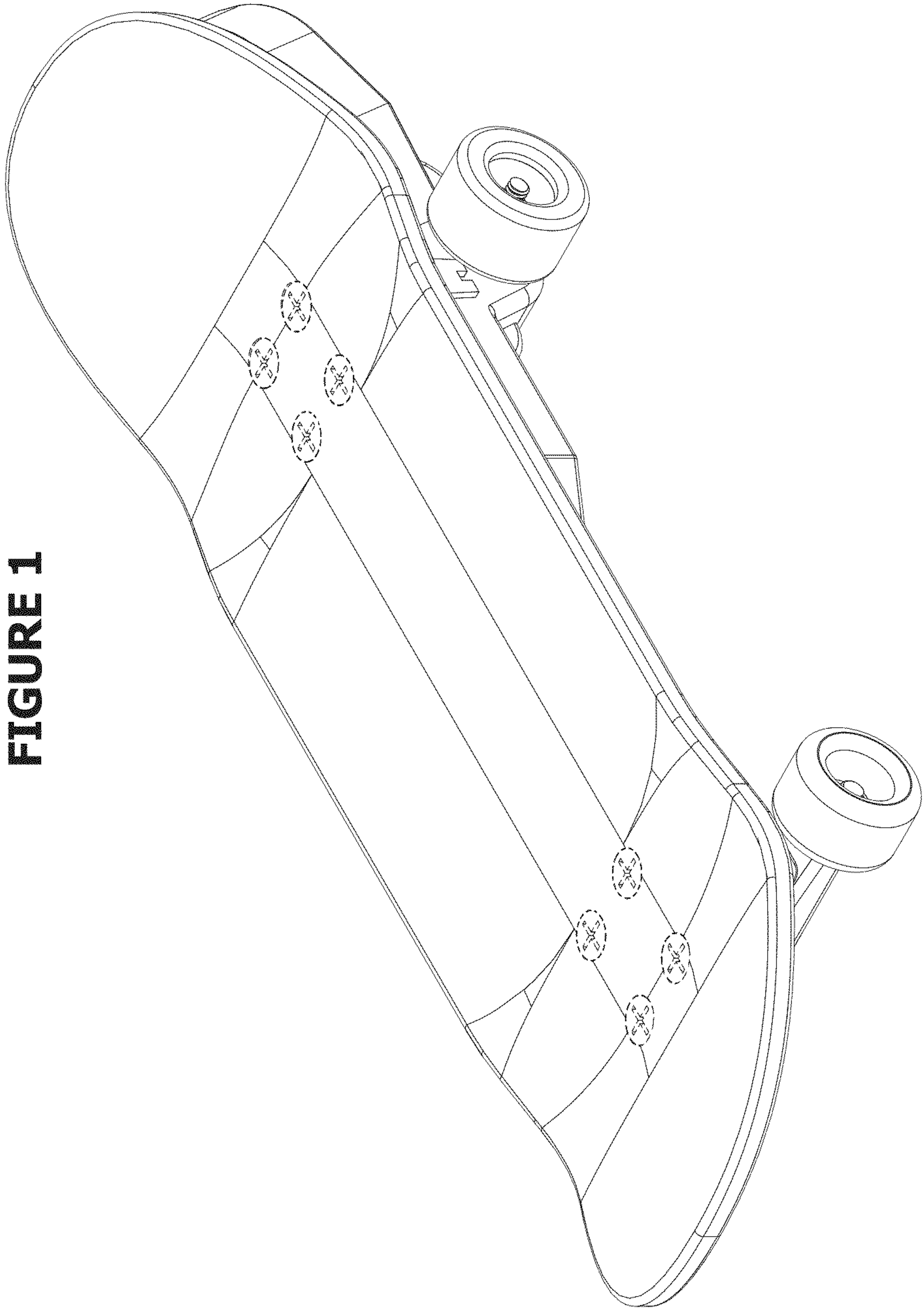
The ornamental design for a toy skateboard, as shown and described.

**DESCRIPTION**

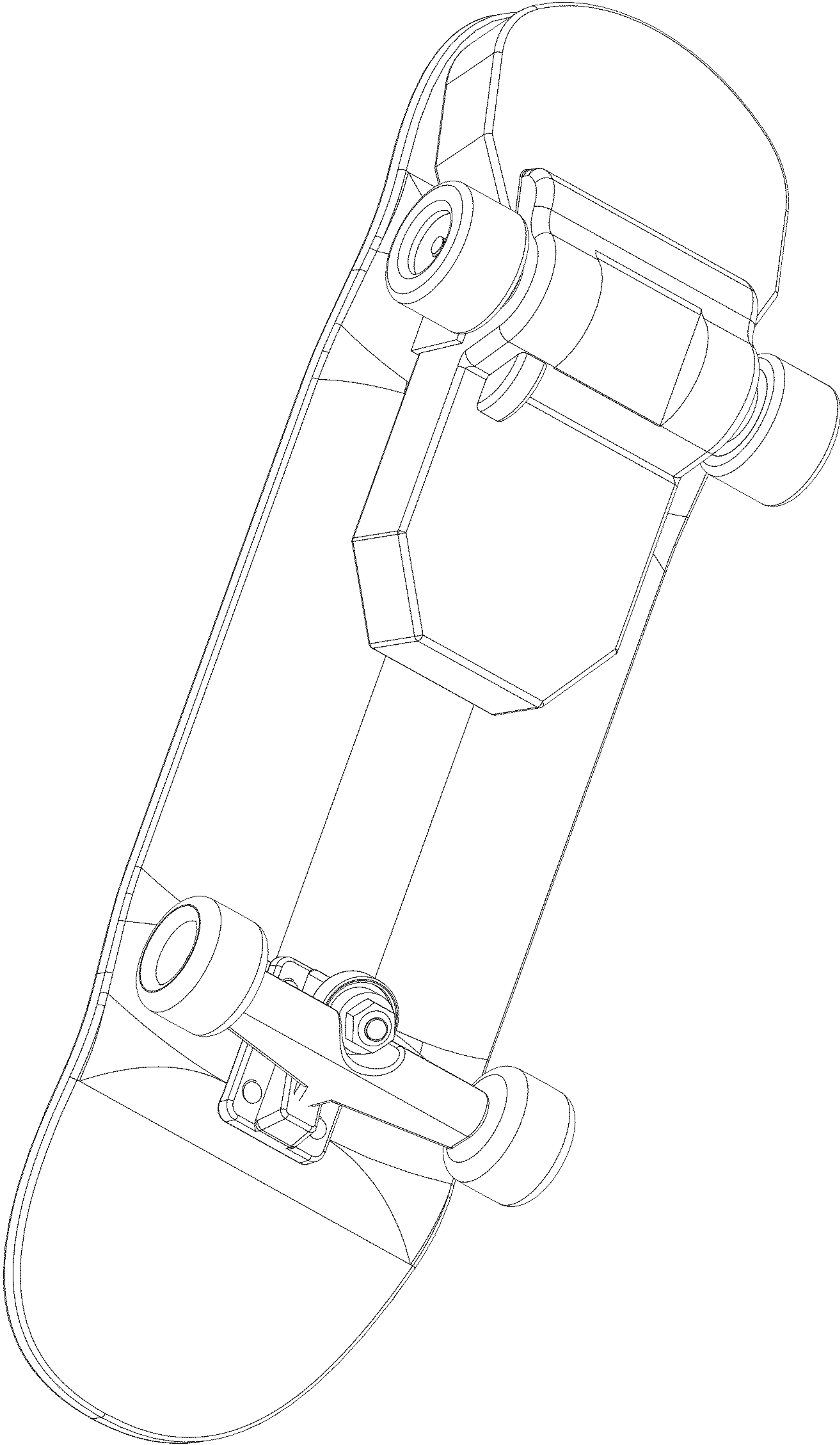

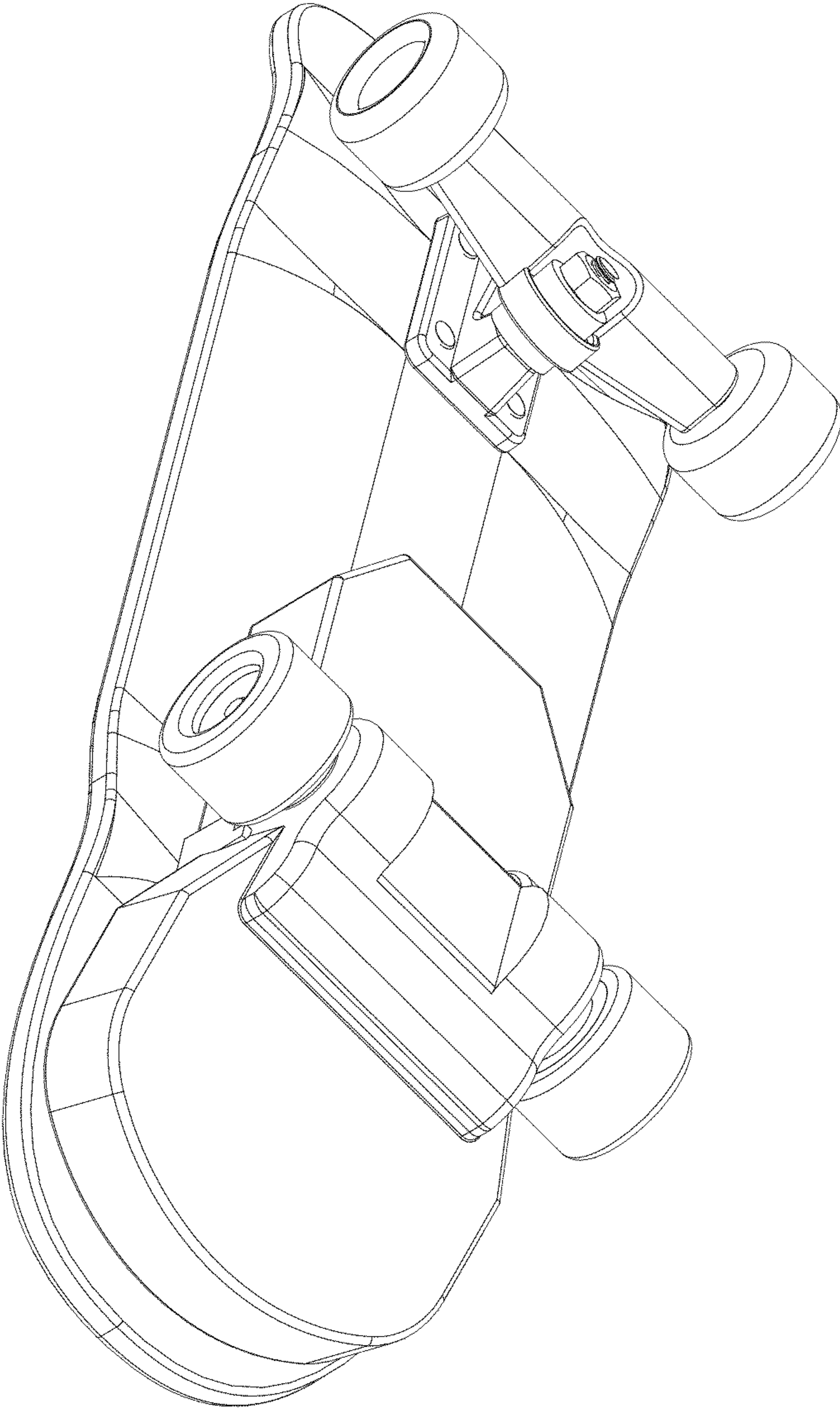

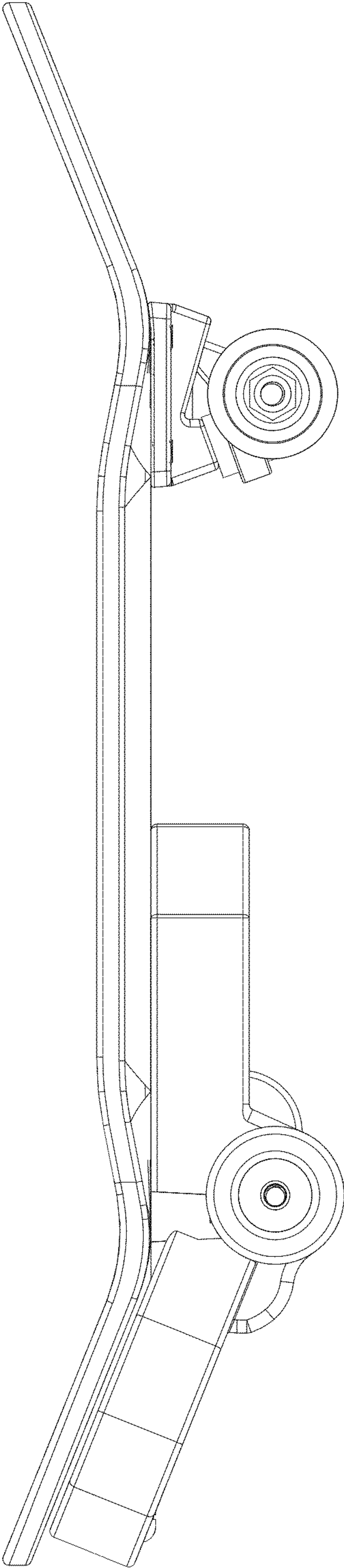
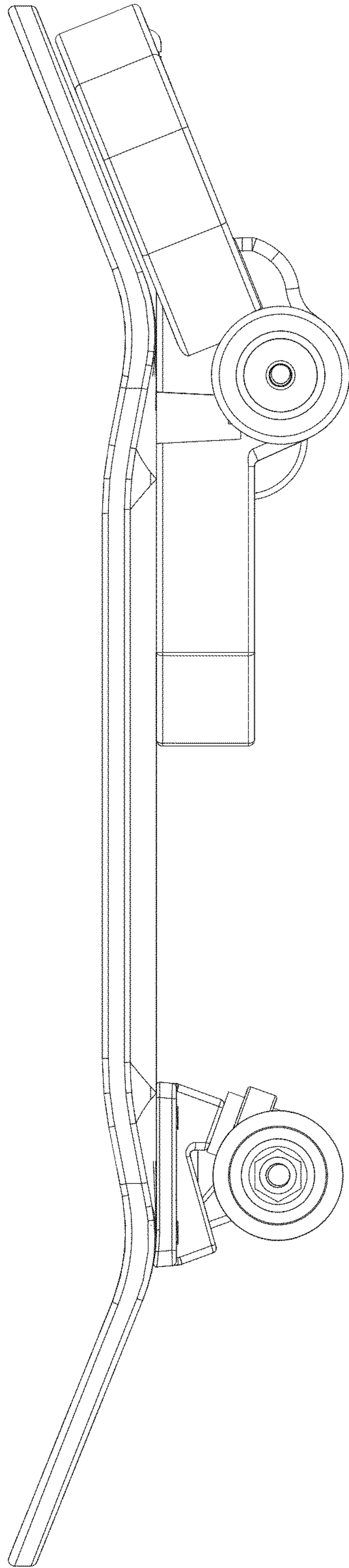
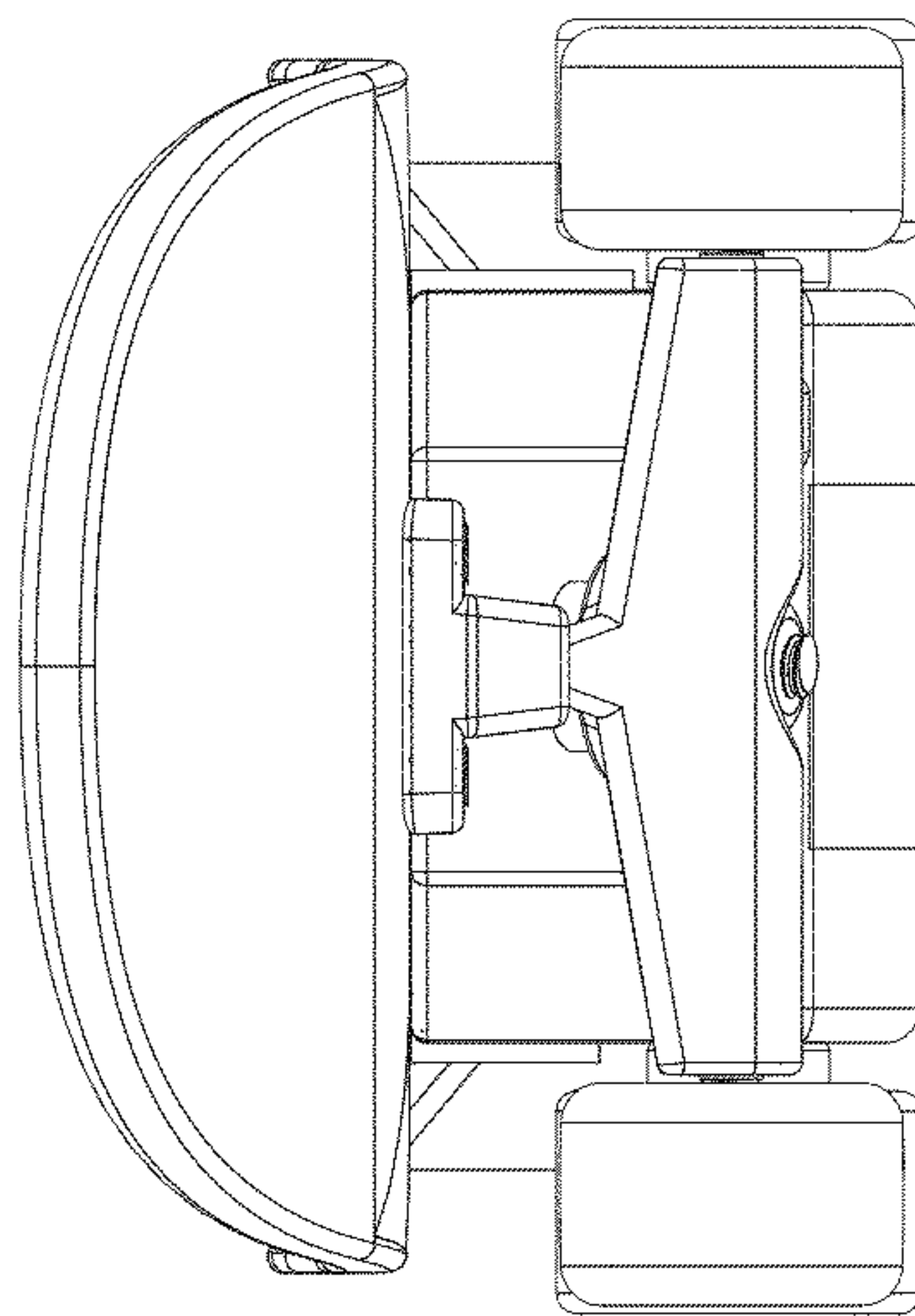

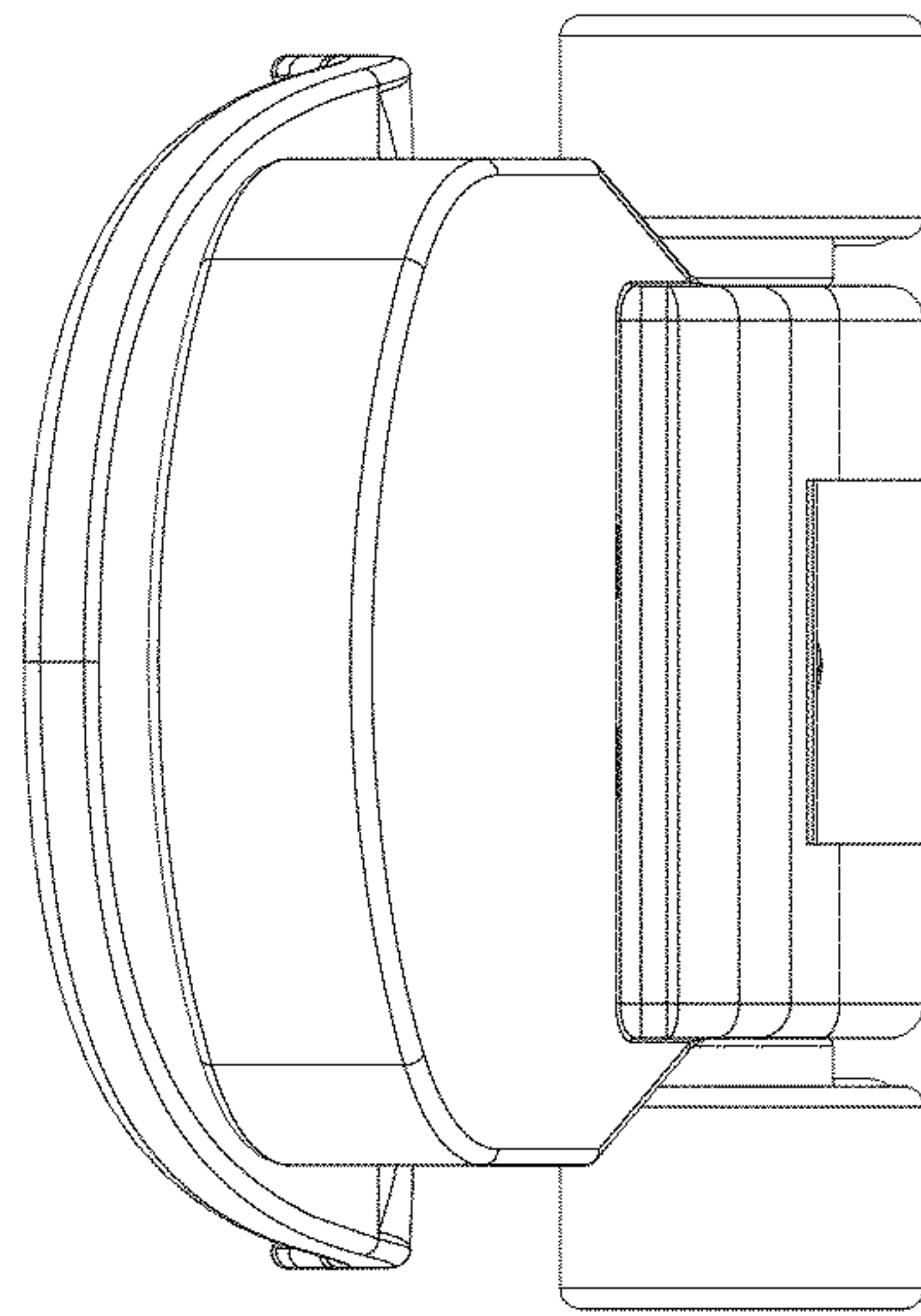

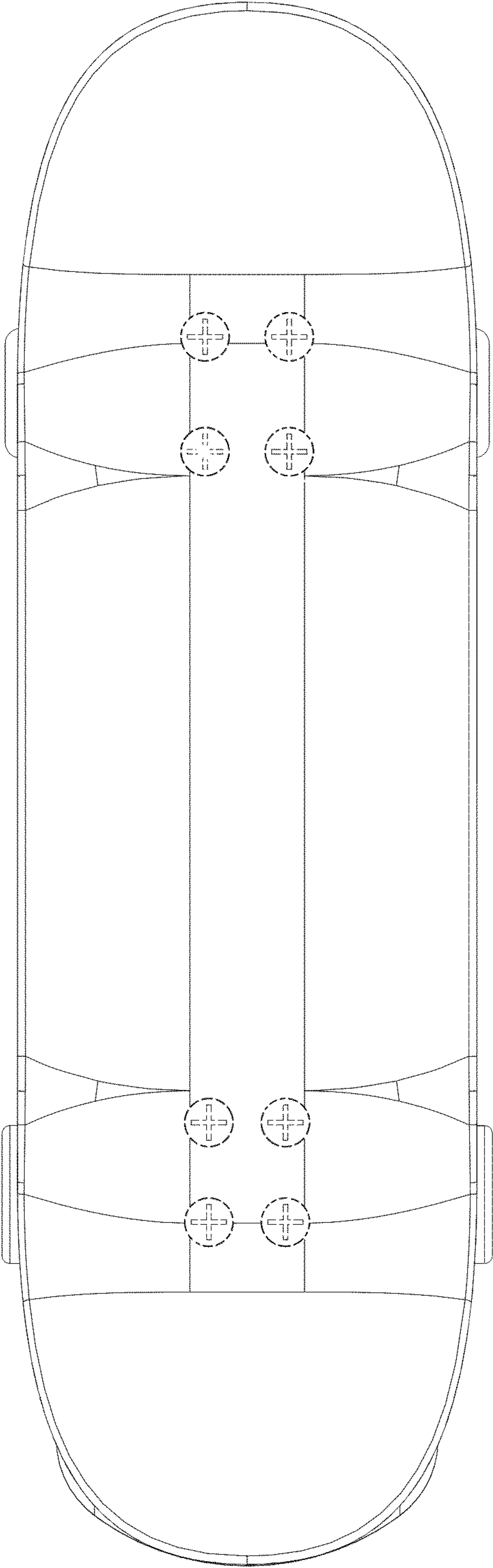
