DESCRIPTION

FIG. 10 is a left side elevational view thereof;

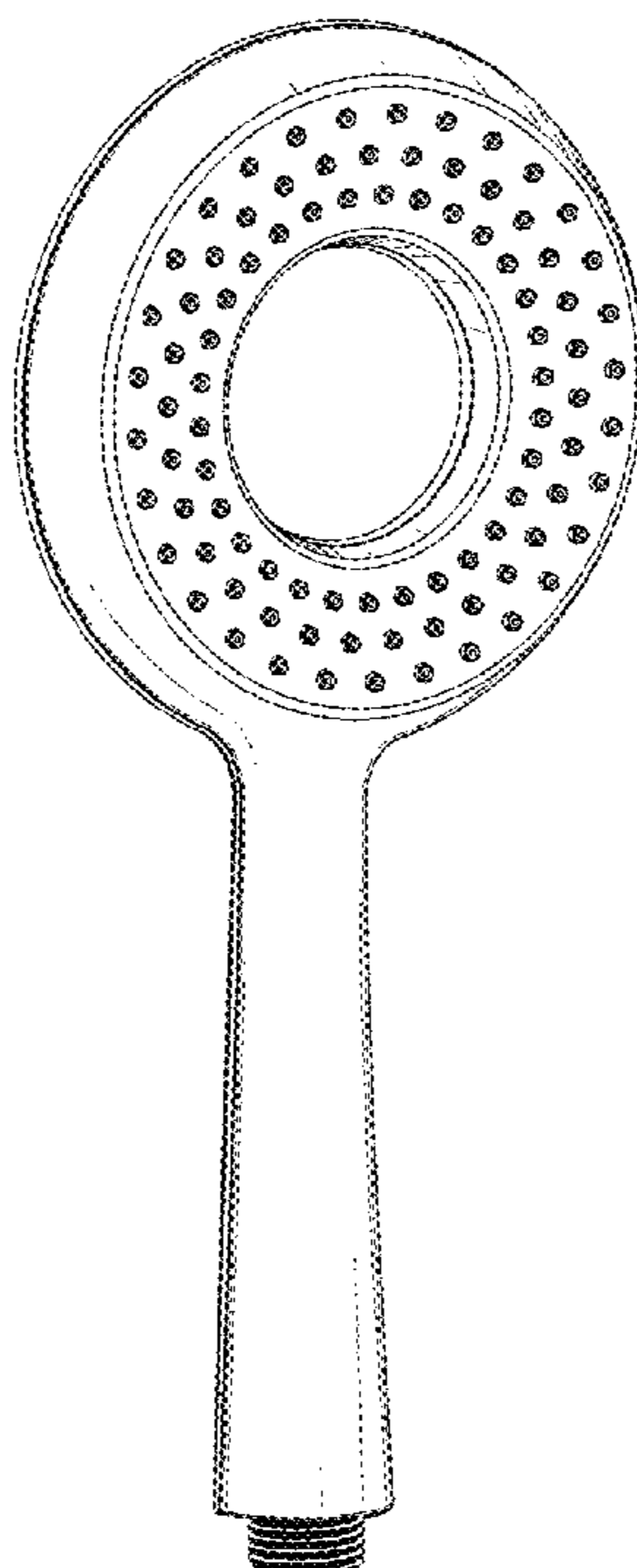
FIG. 11 is a perspective top view thereof;

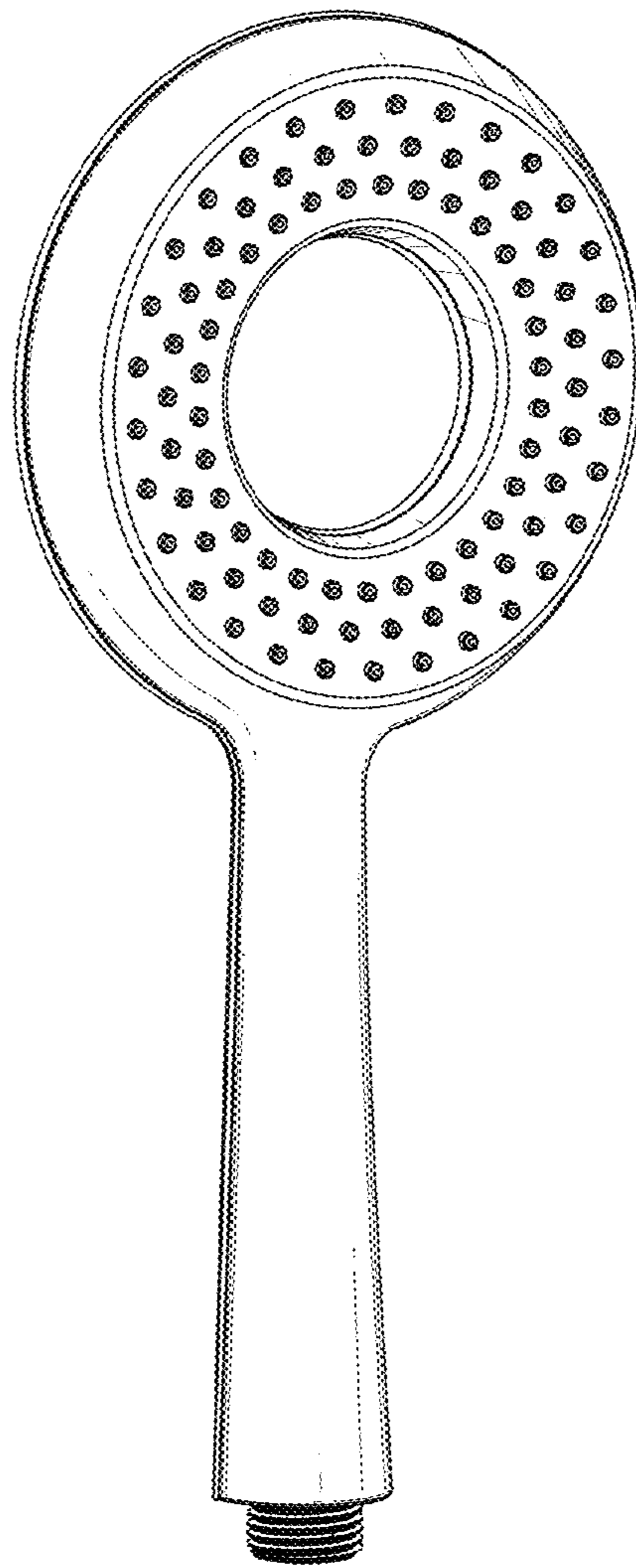

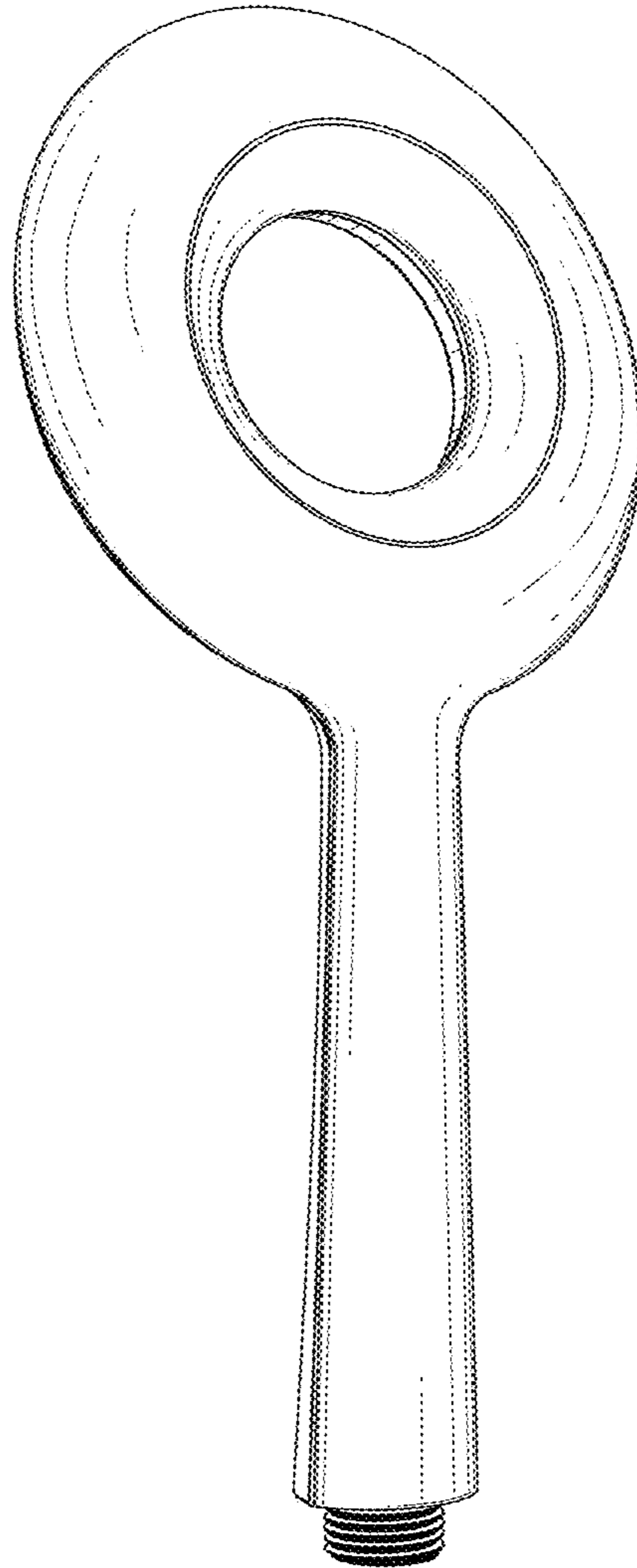

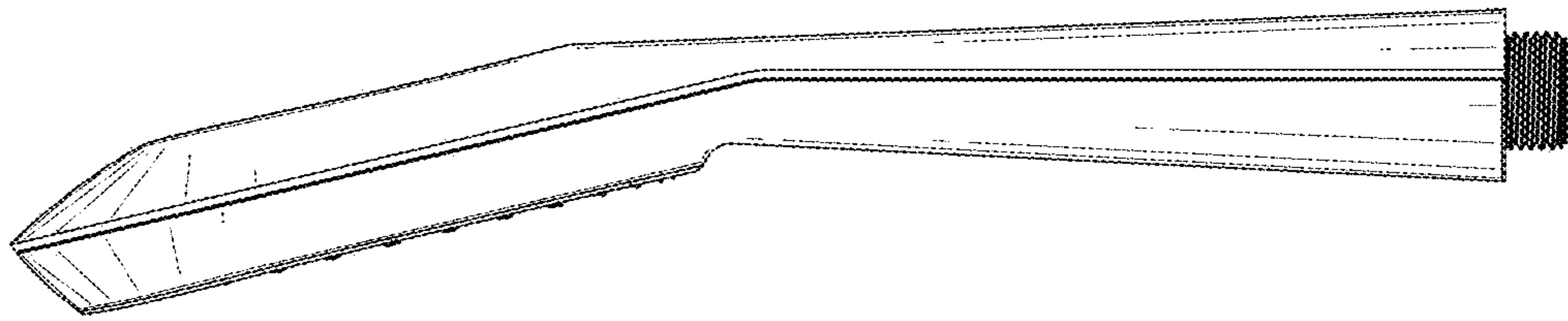

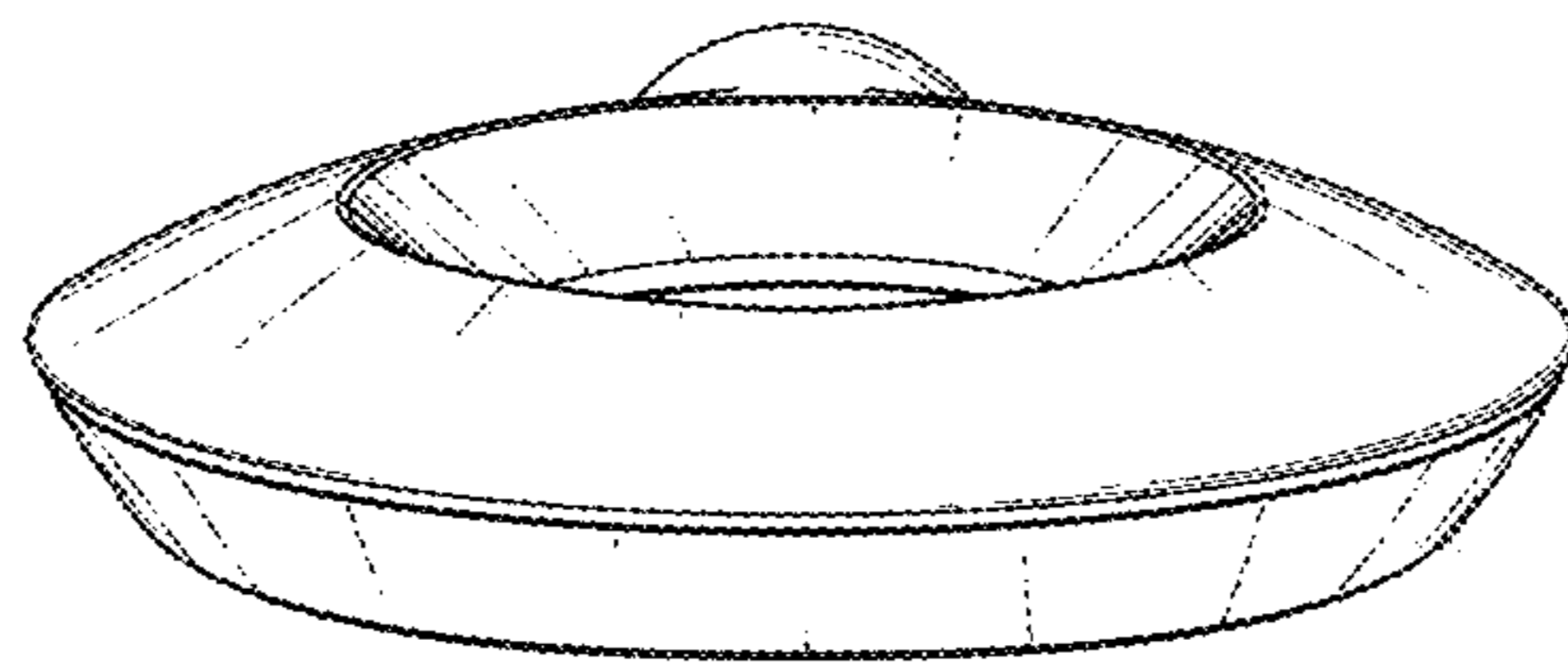

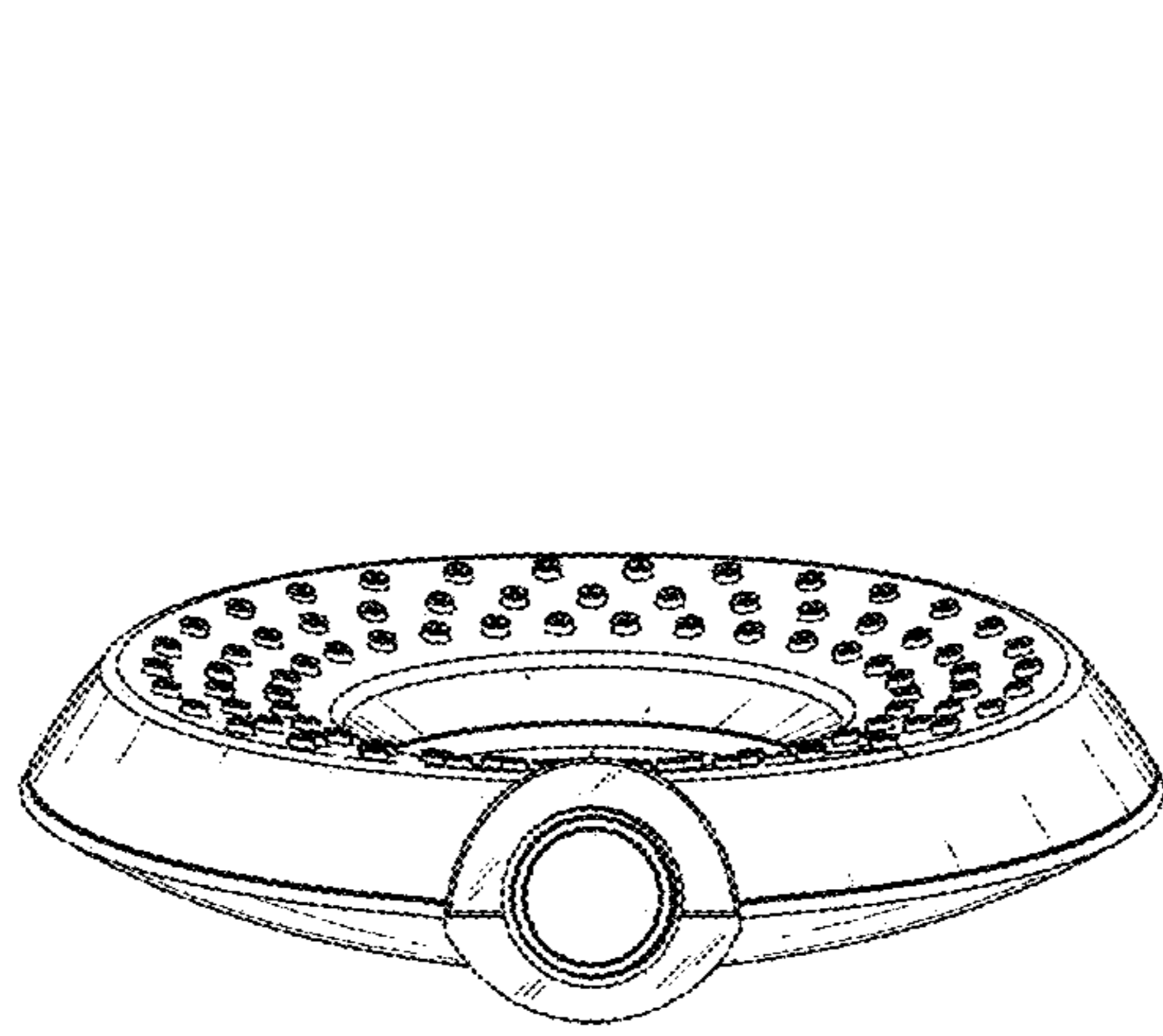

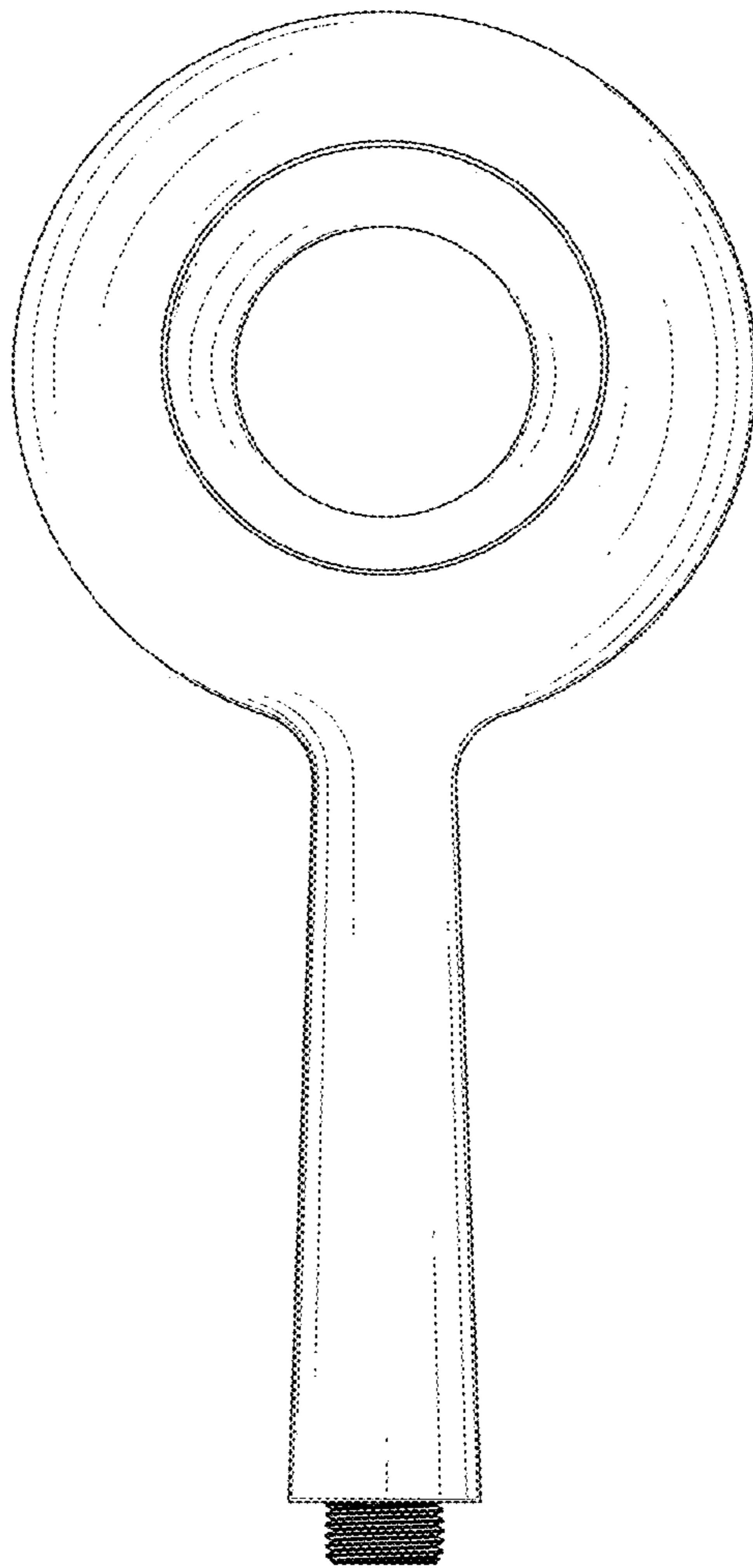

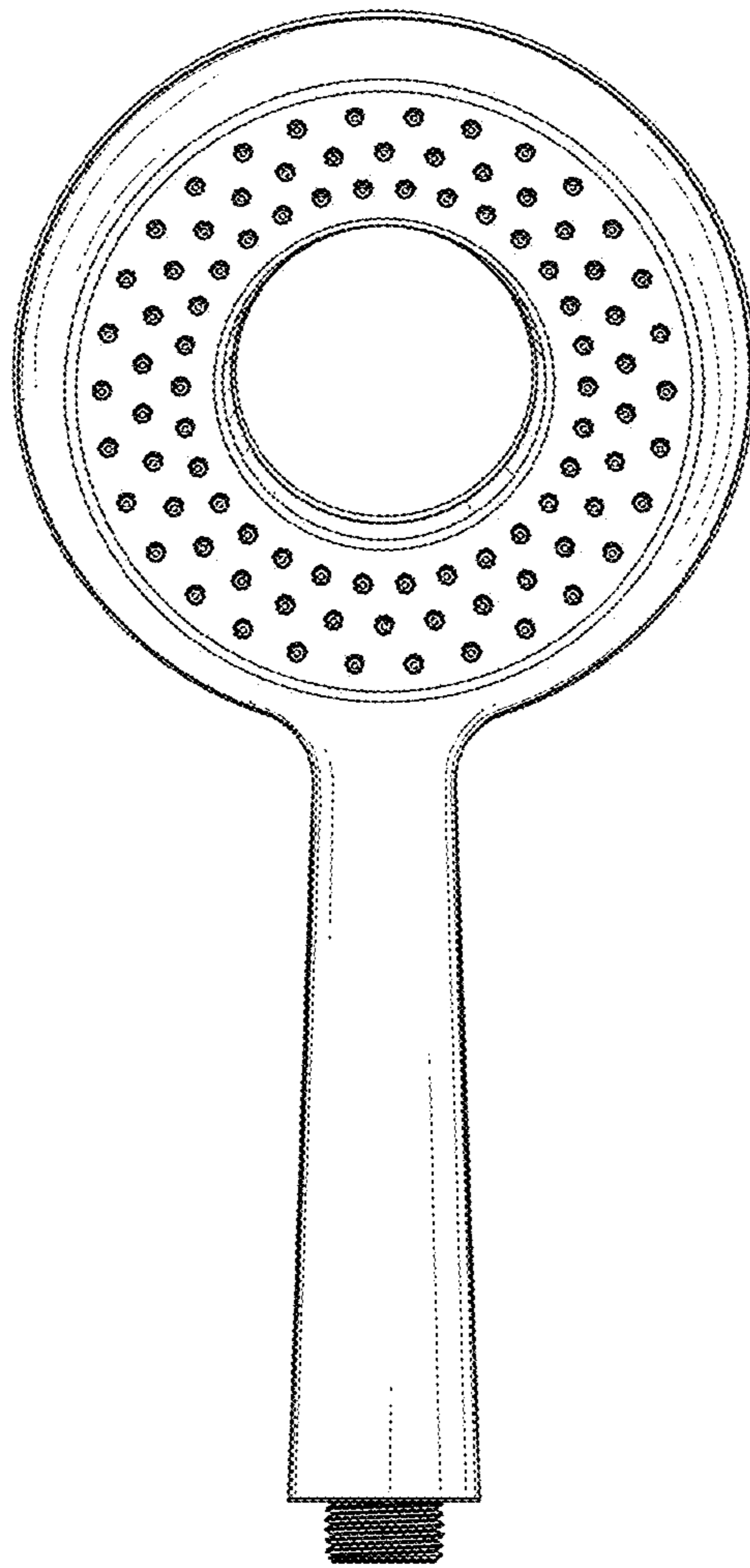

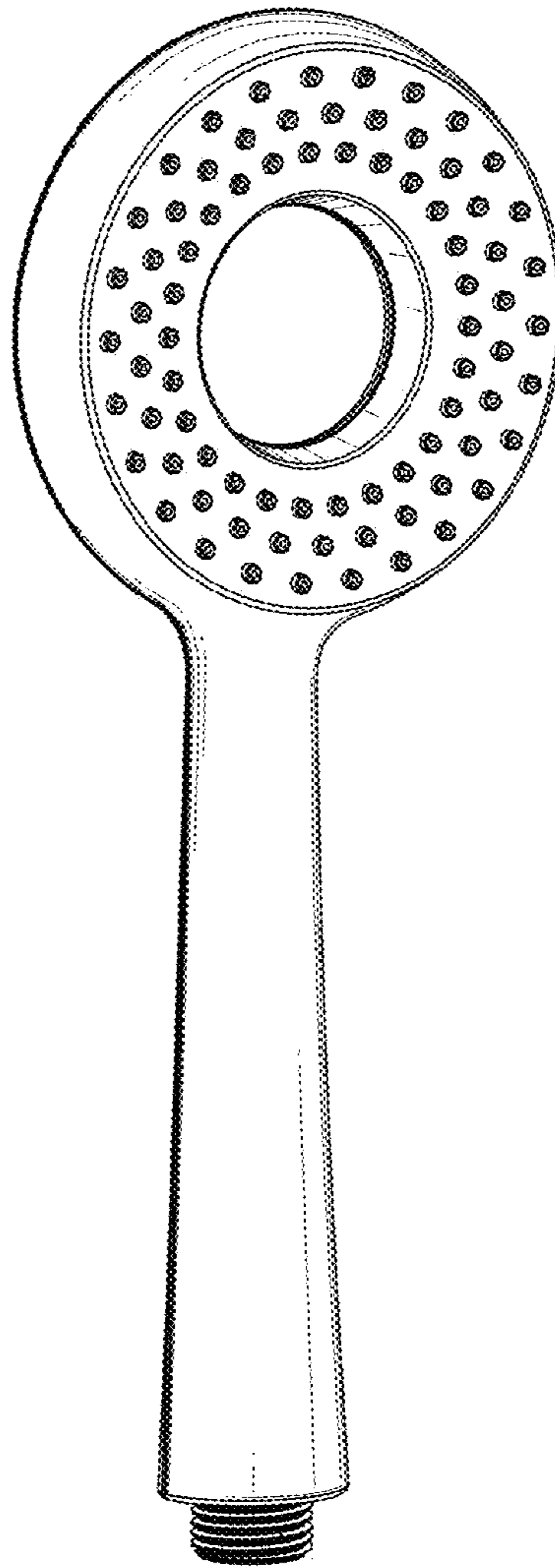

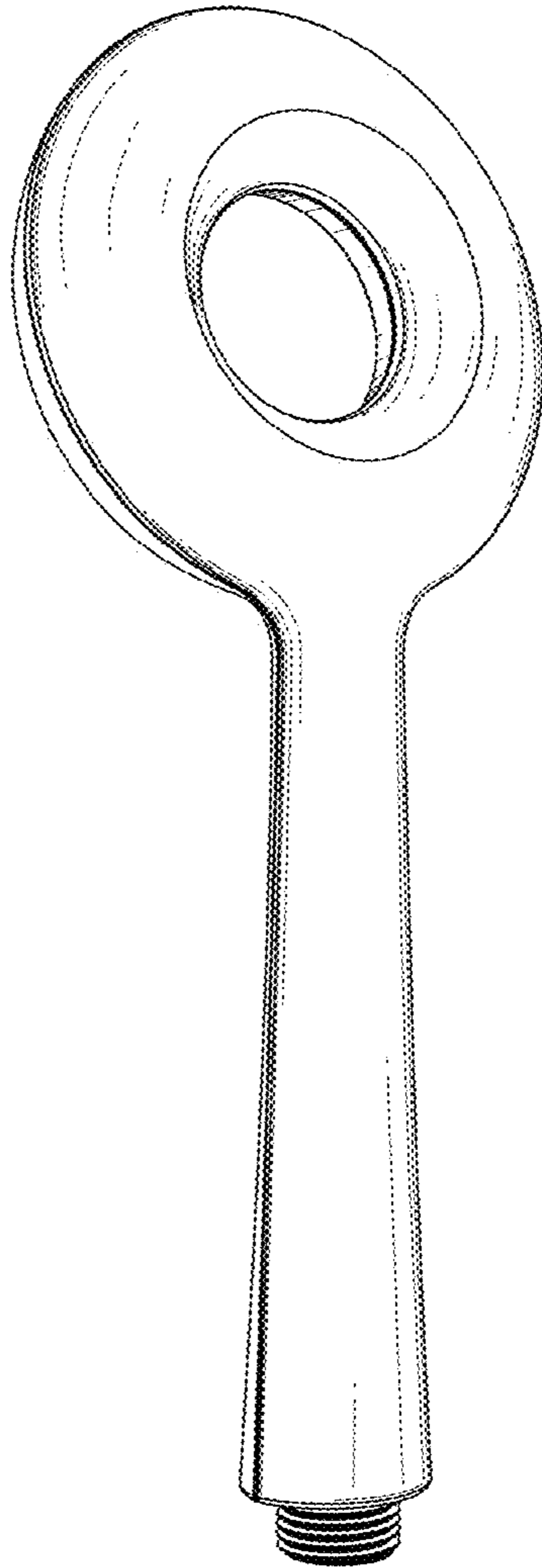

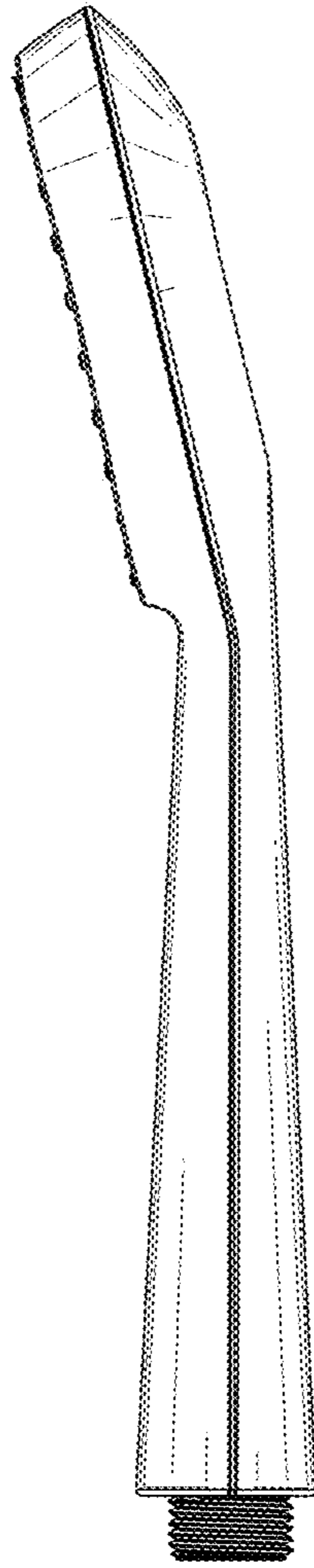

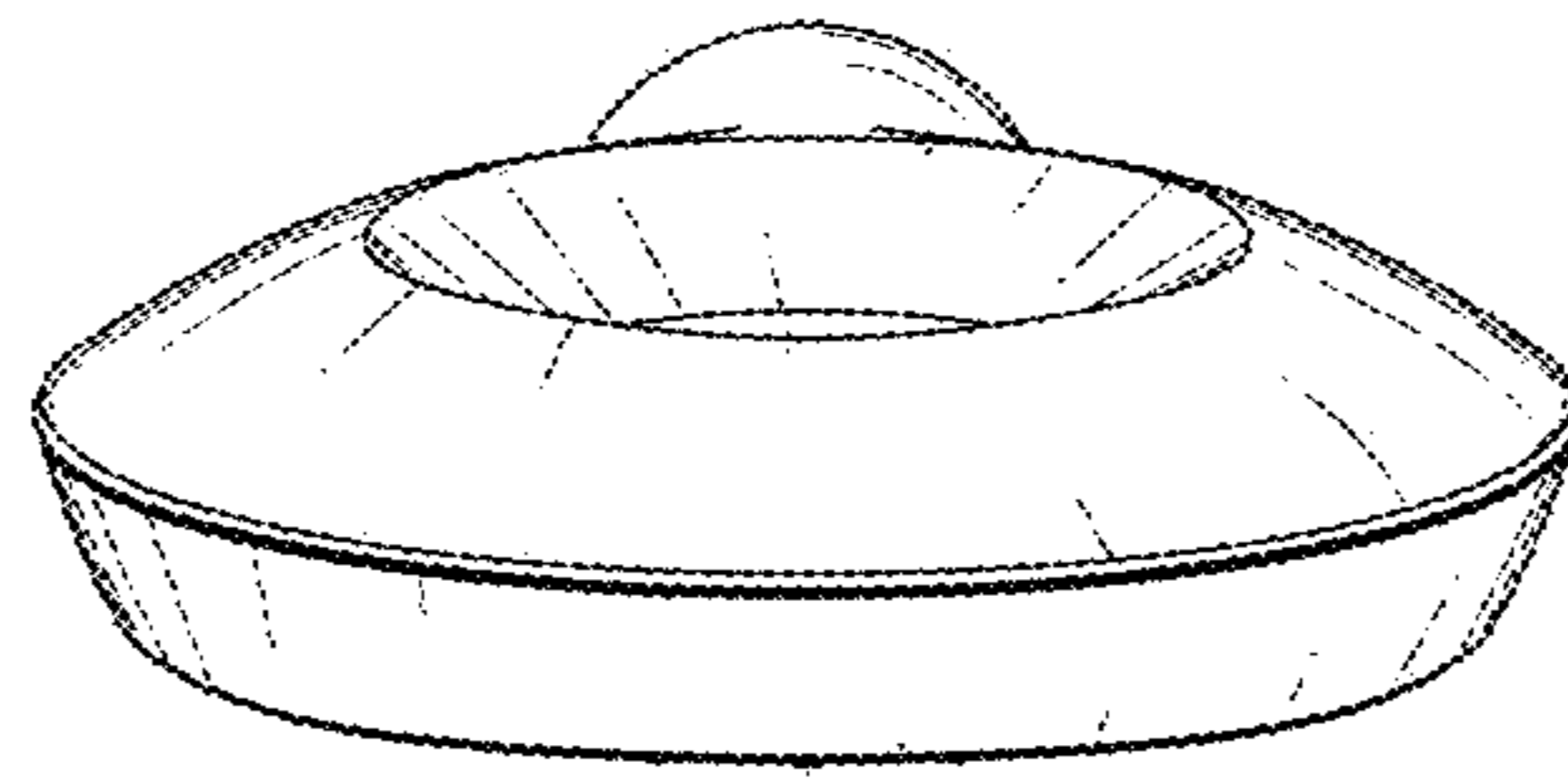

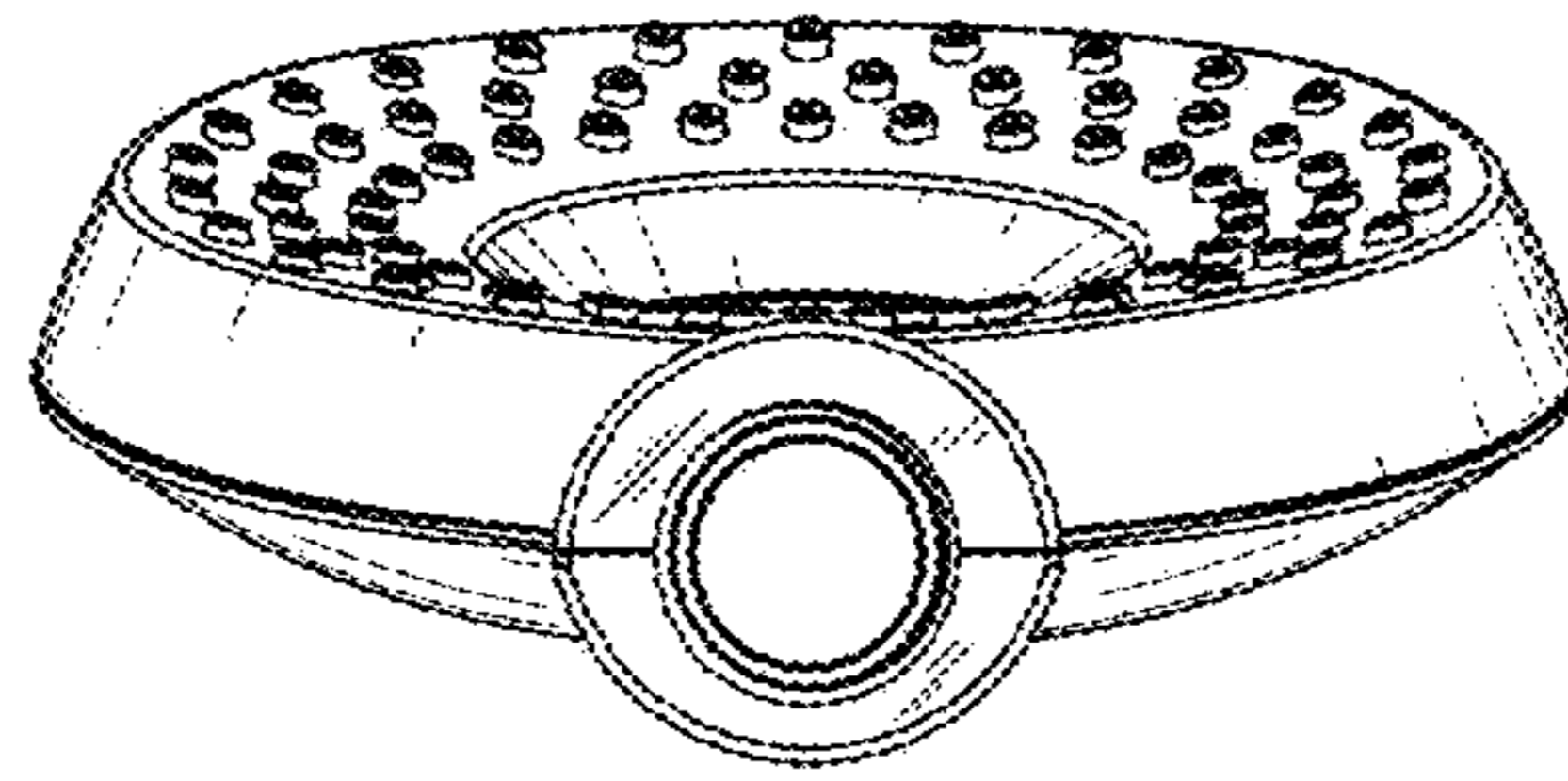

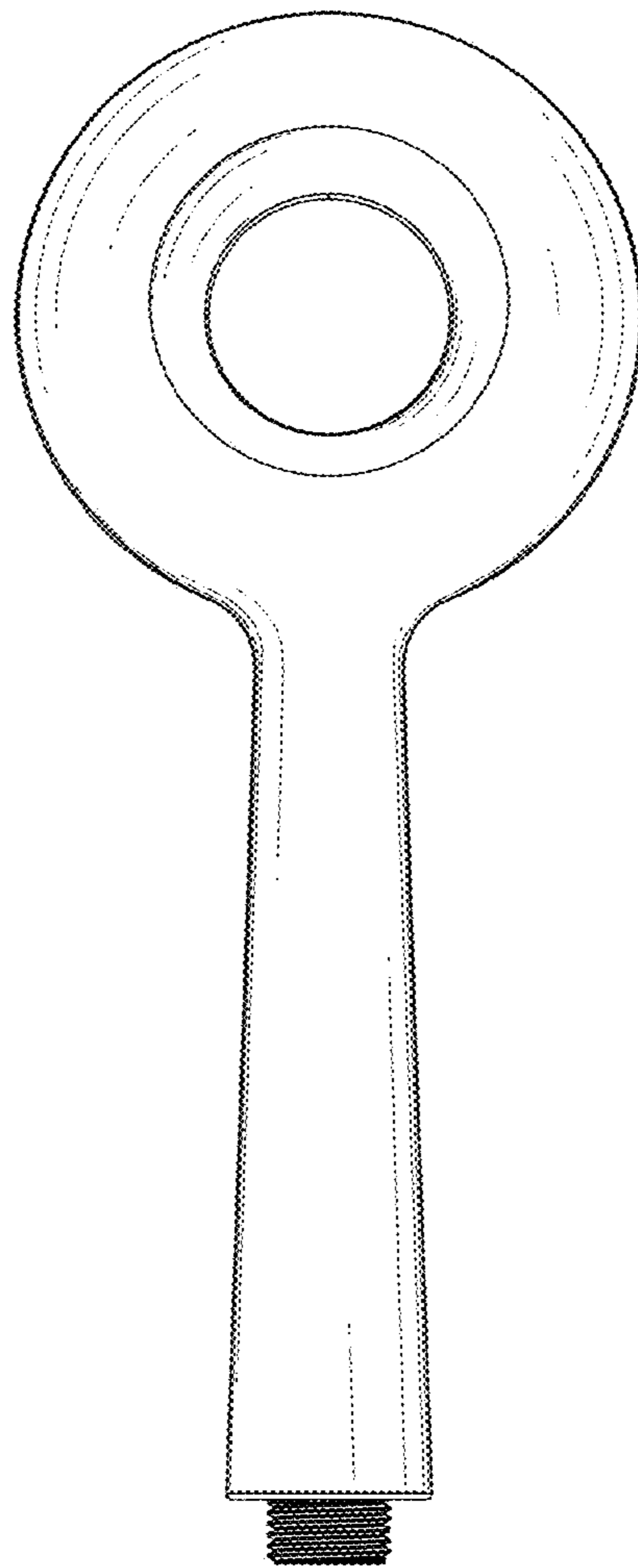

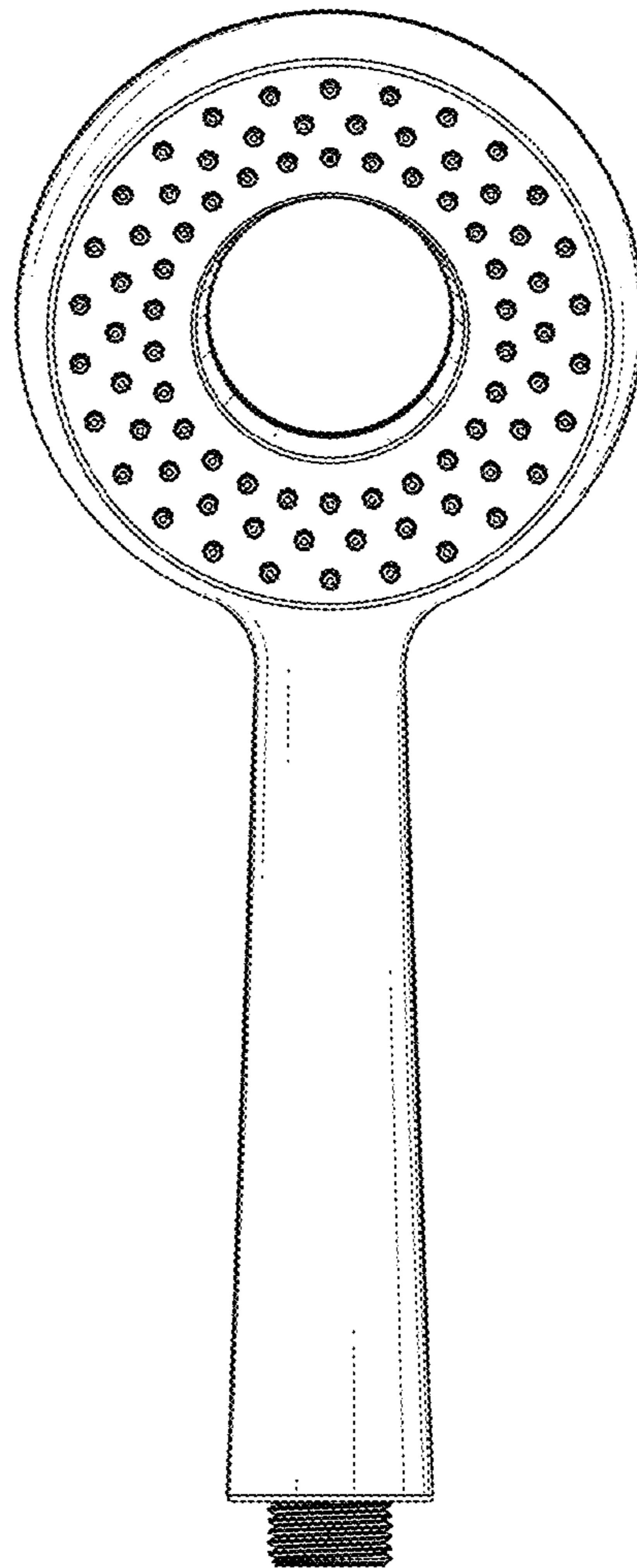
