 FIG. 6 is a top plan view of the housing of FIG. 1, a bottom plan view being a mirror image thereof.

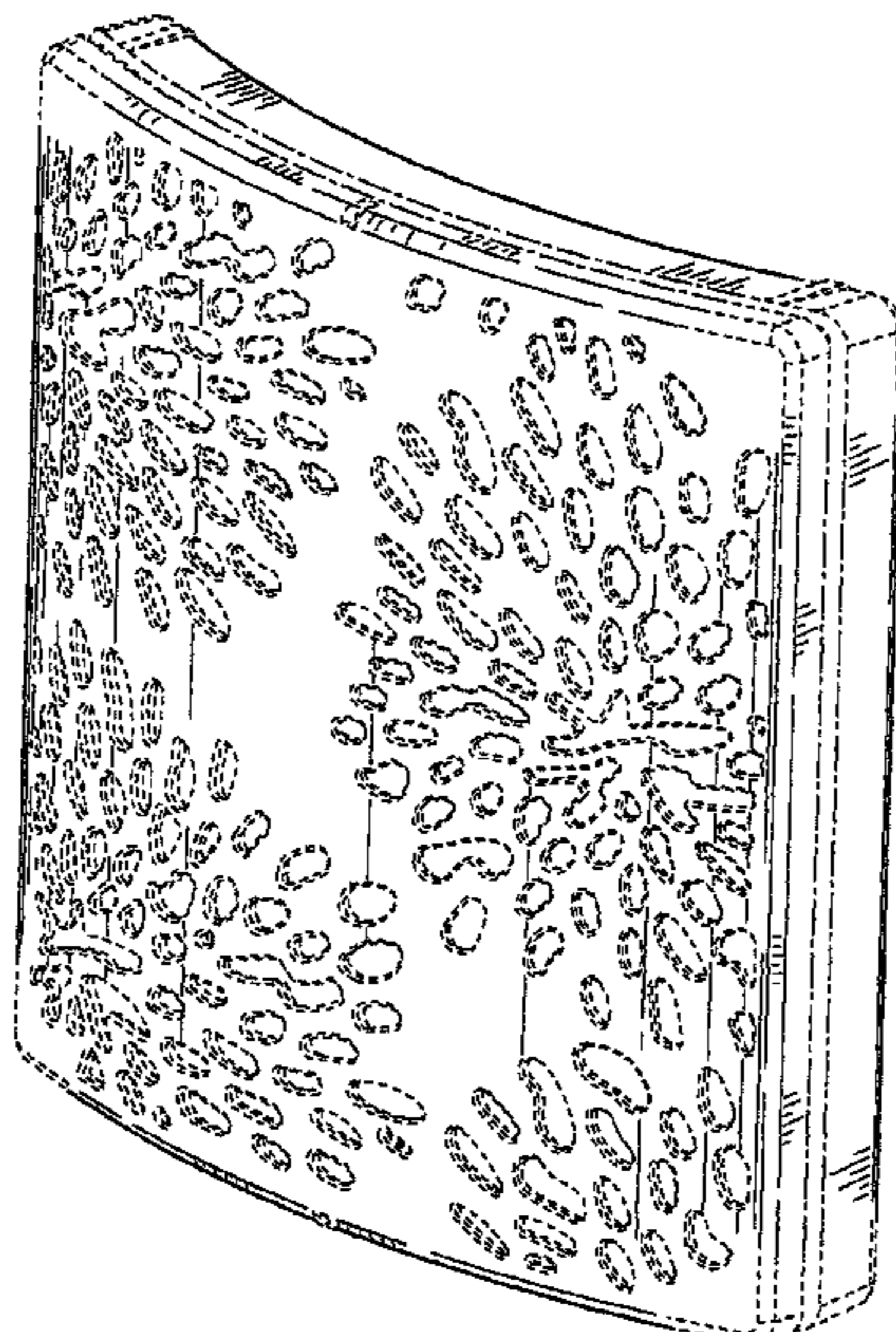

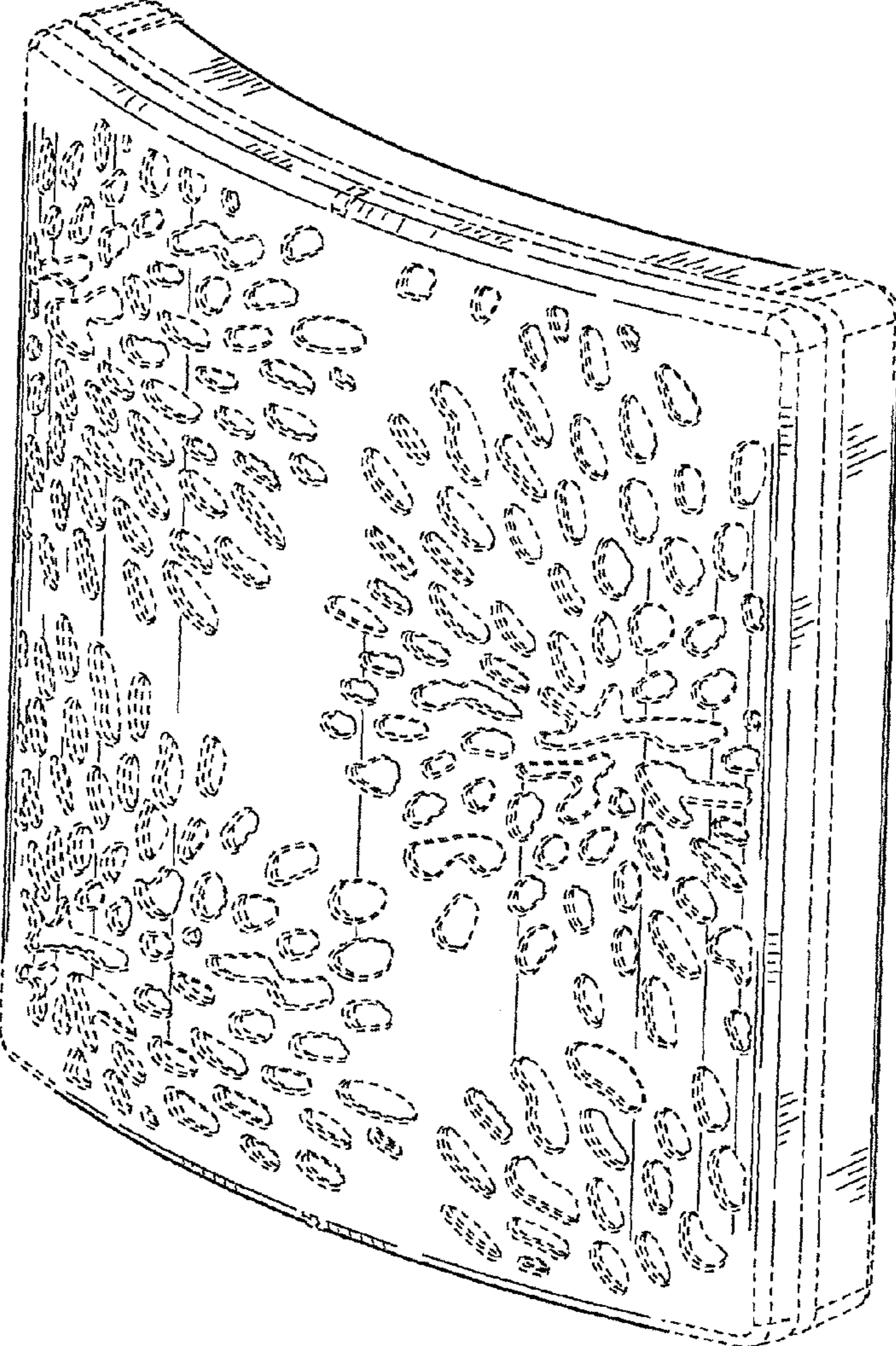

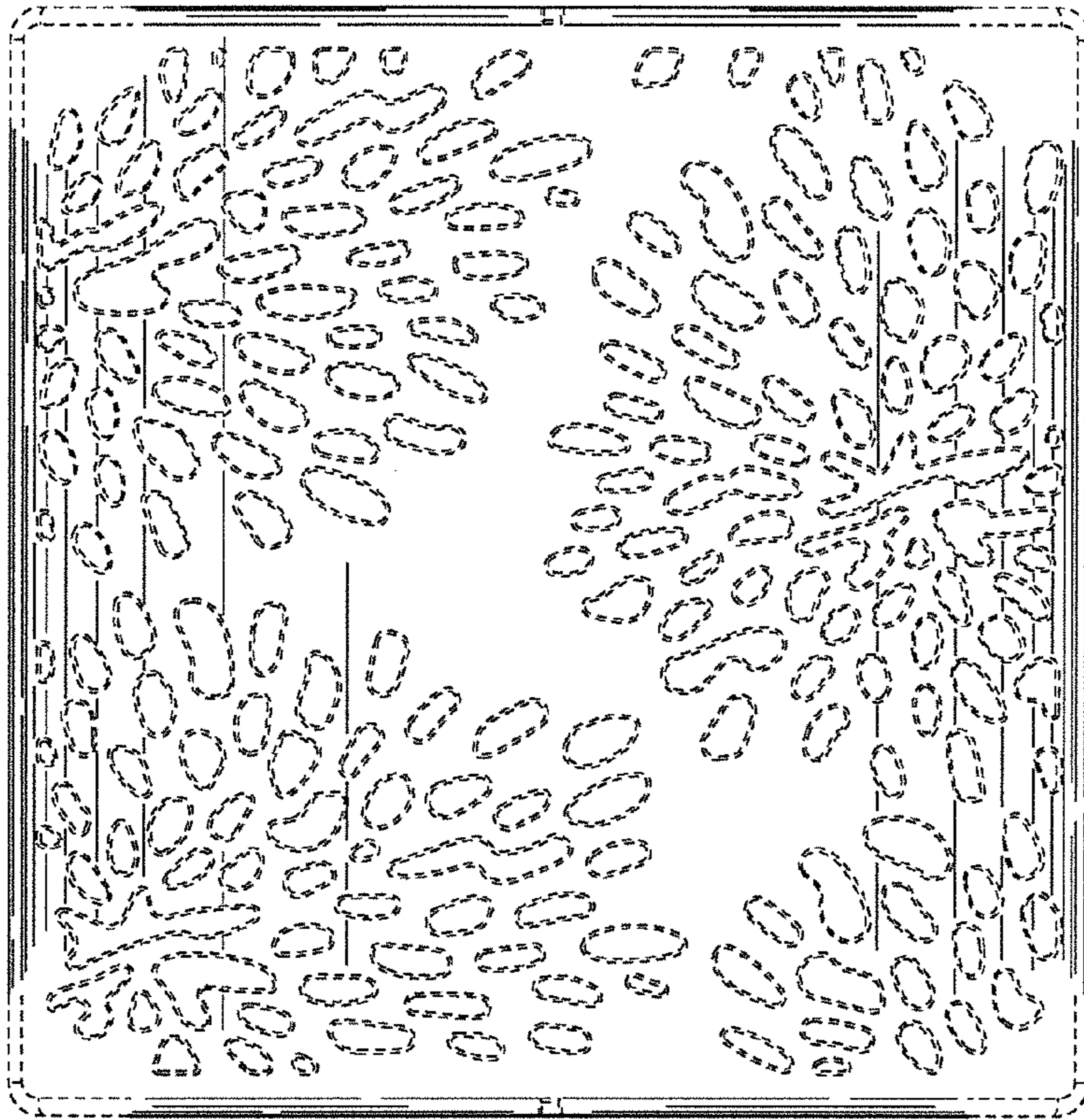

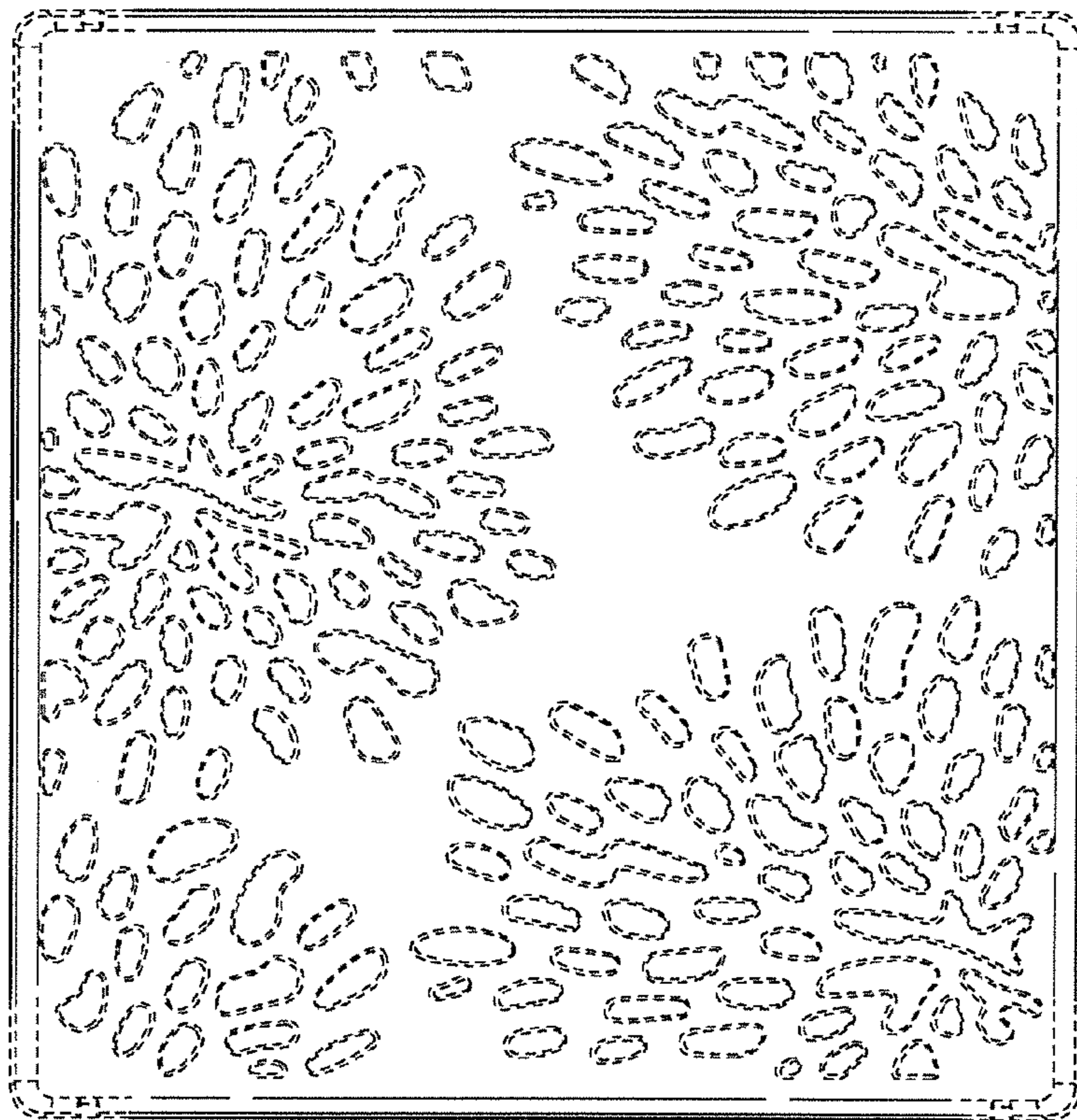

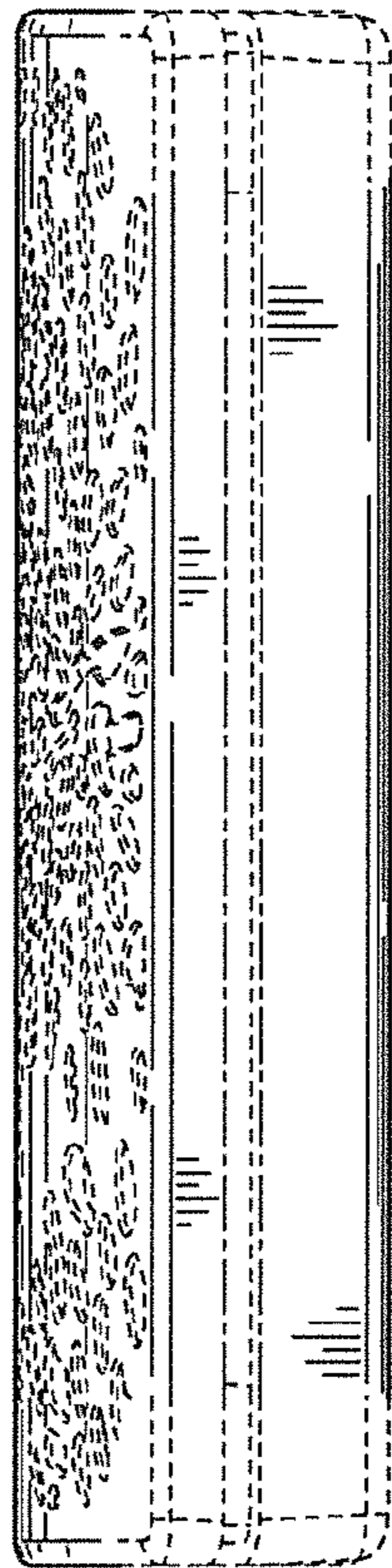

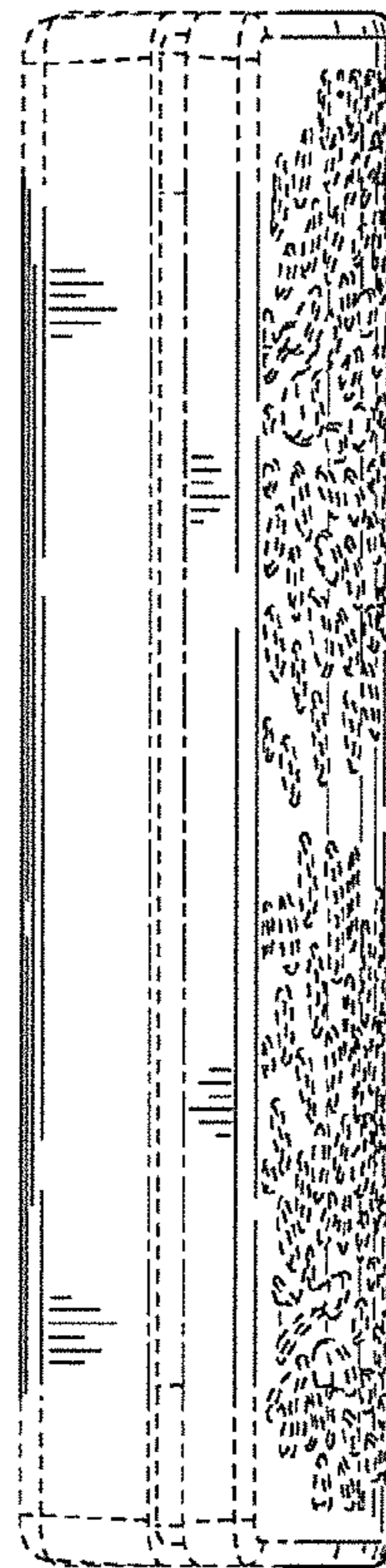

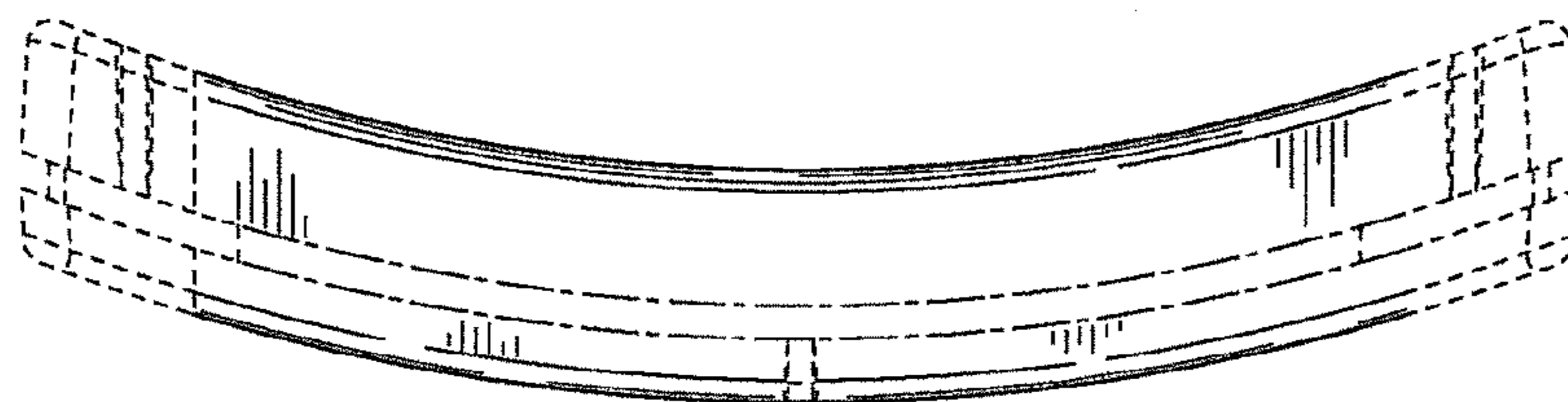
