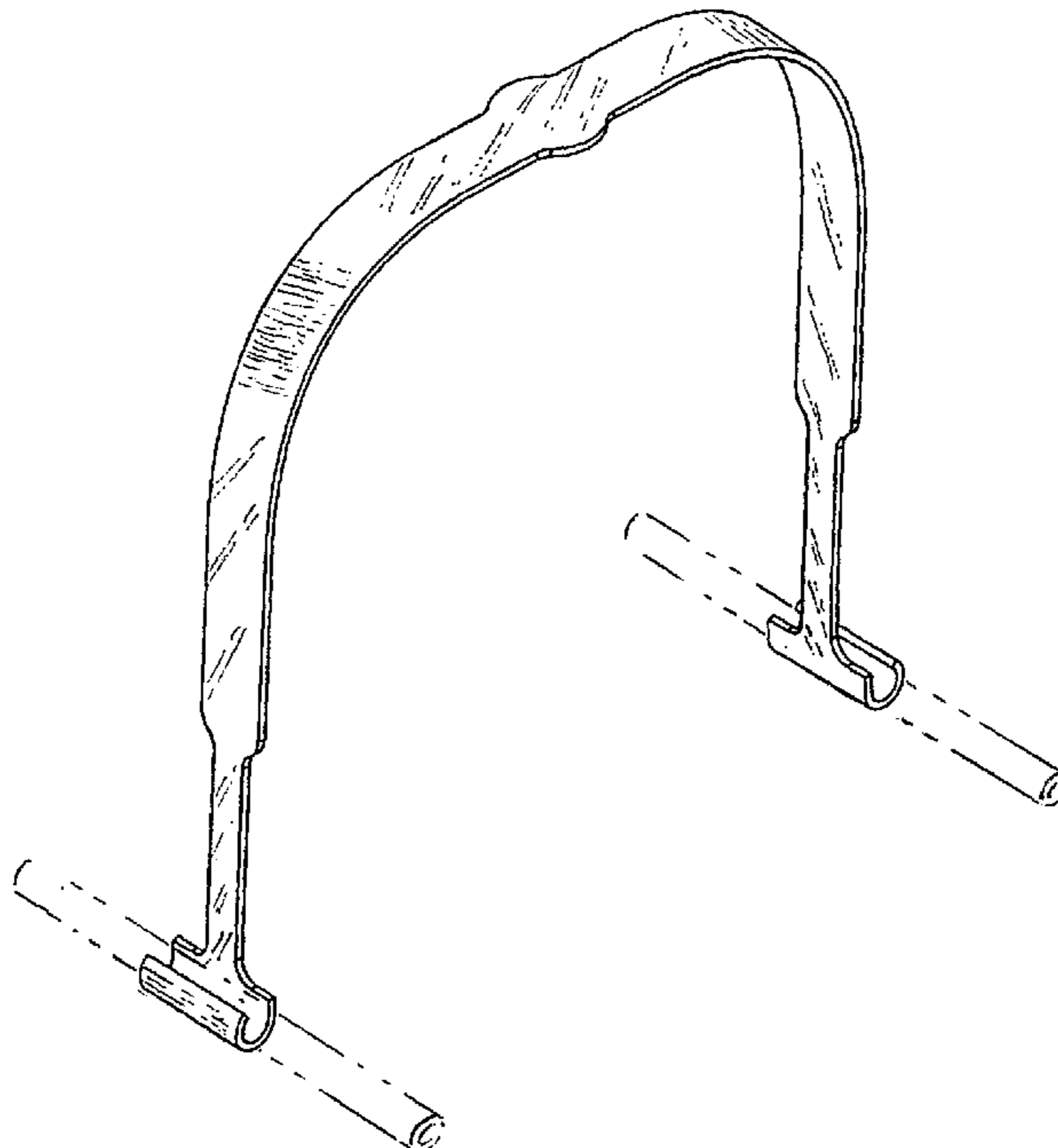
(57) **CLAIM**

I claim, the ornamental design for an oxygen tube headband,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front and side perspective view of the oxygen tube headband, showing my new design

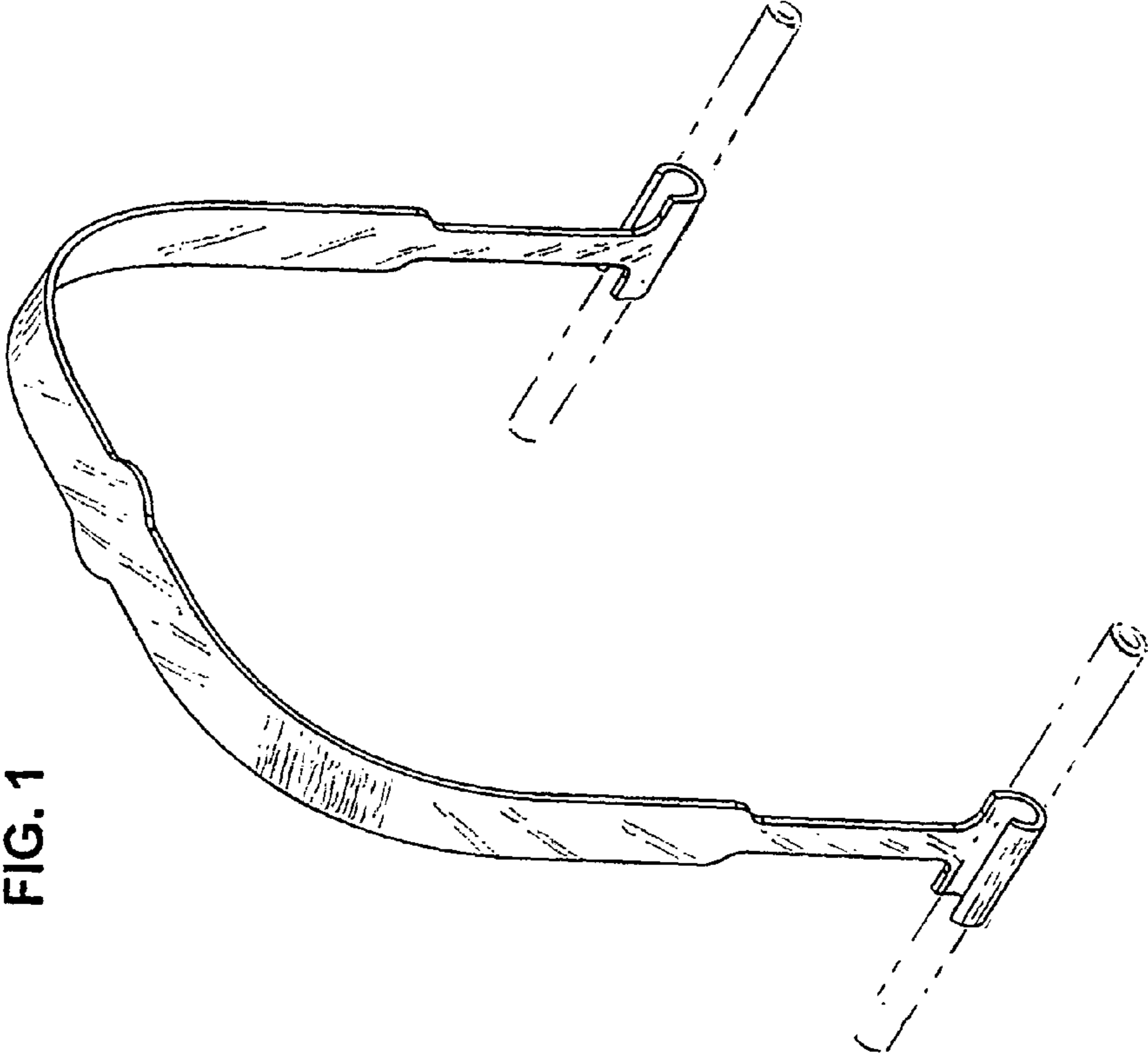

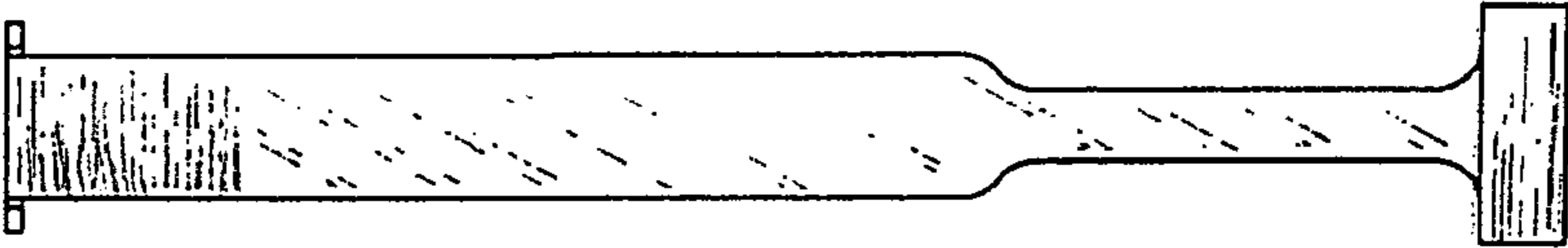

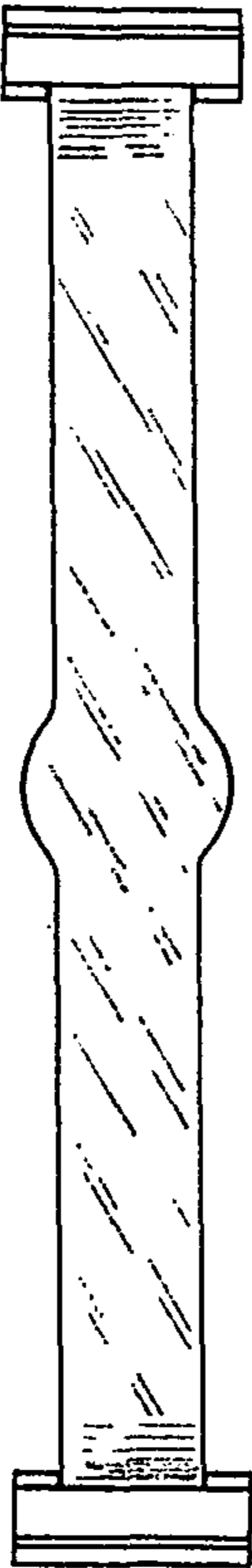
