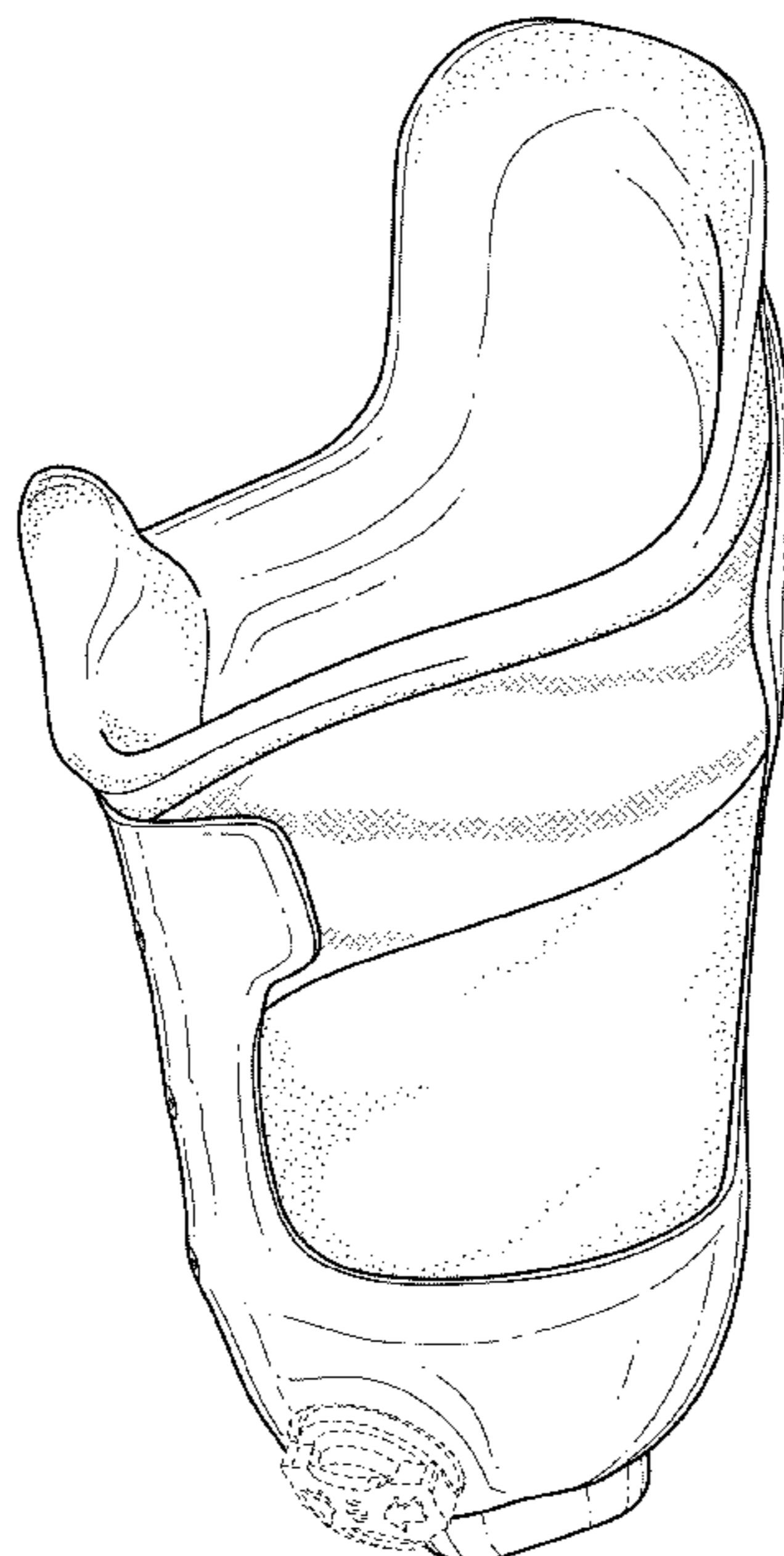

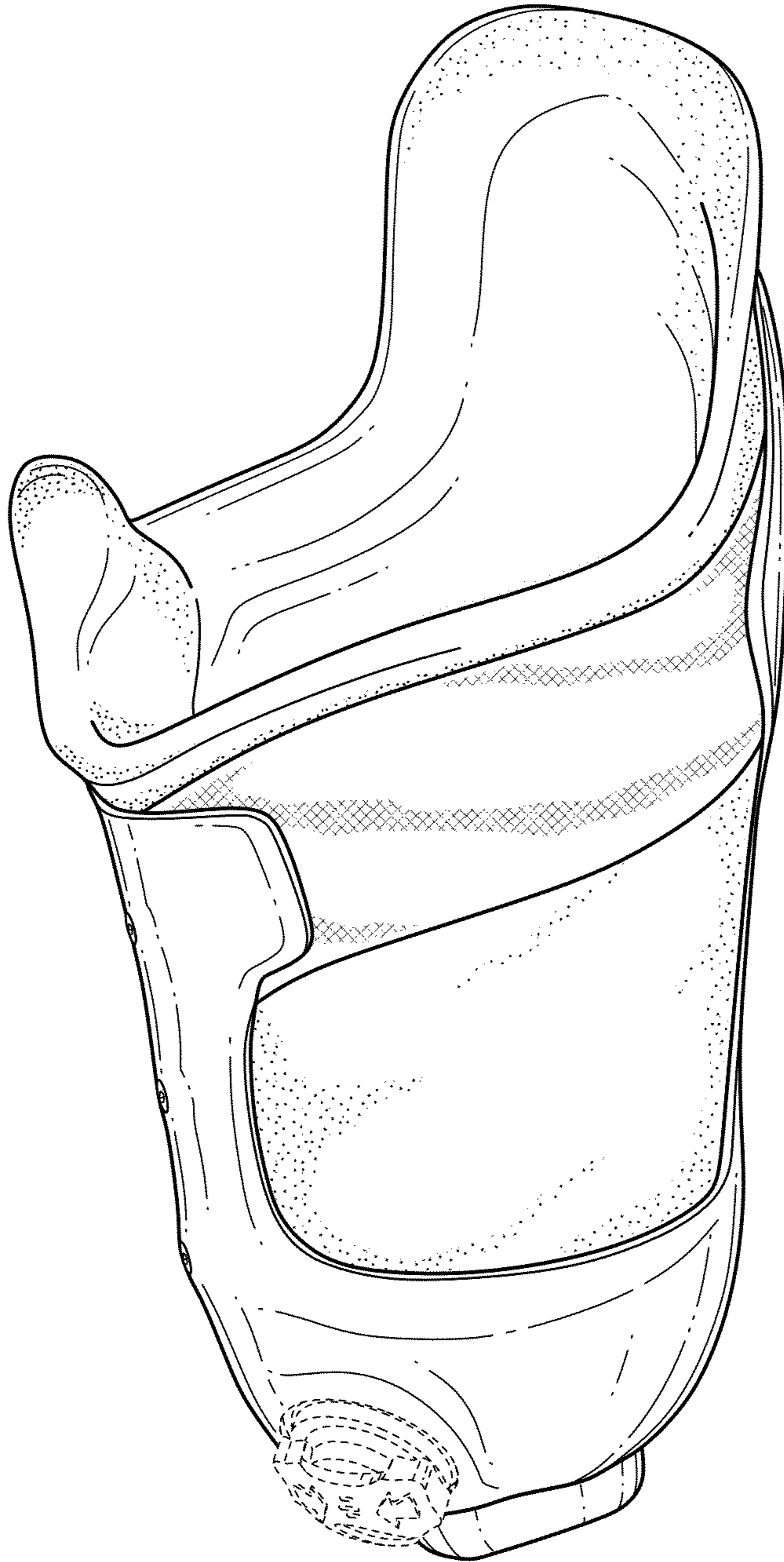
The ornamental design for a prosthesis socket, as shown and described.

**DESCRIPTION**

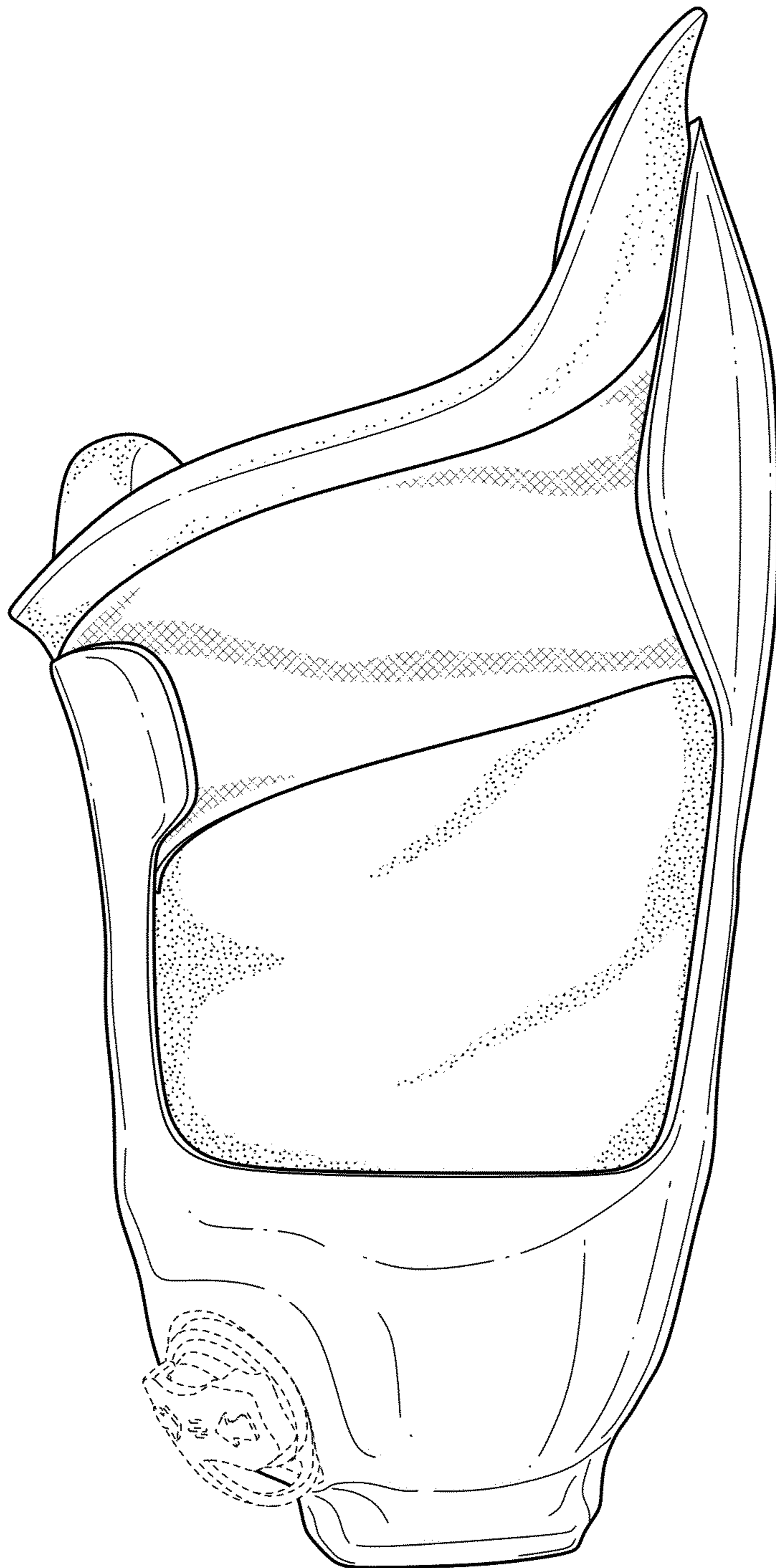
FIG. 1 is a perspective view of a prosthesis socket according to the present invention;

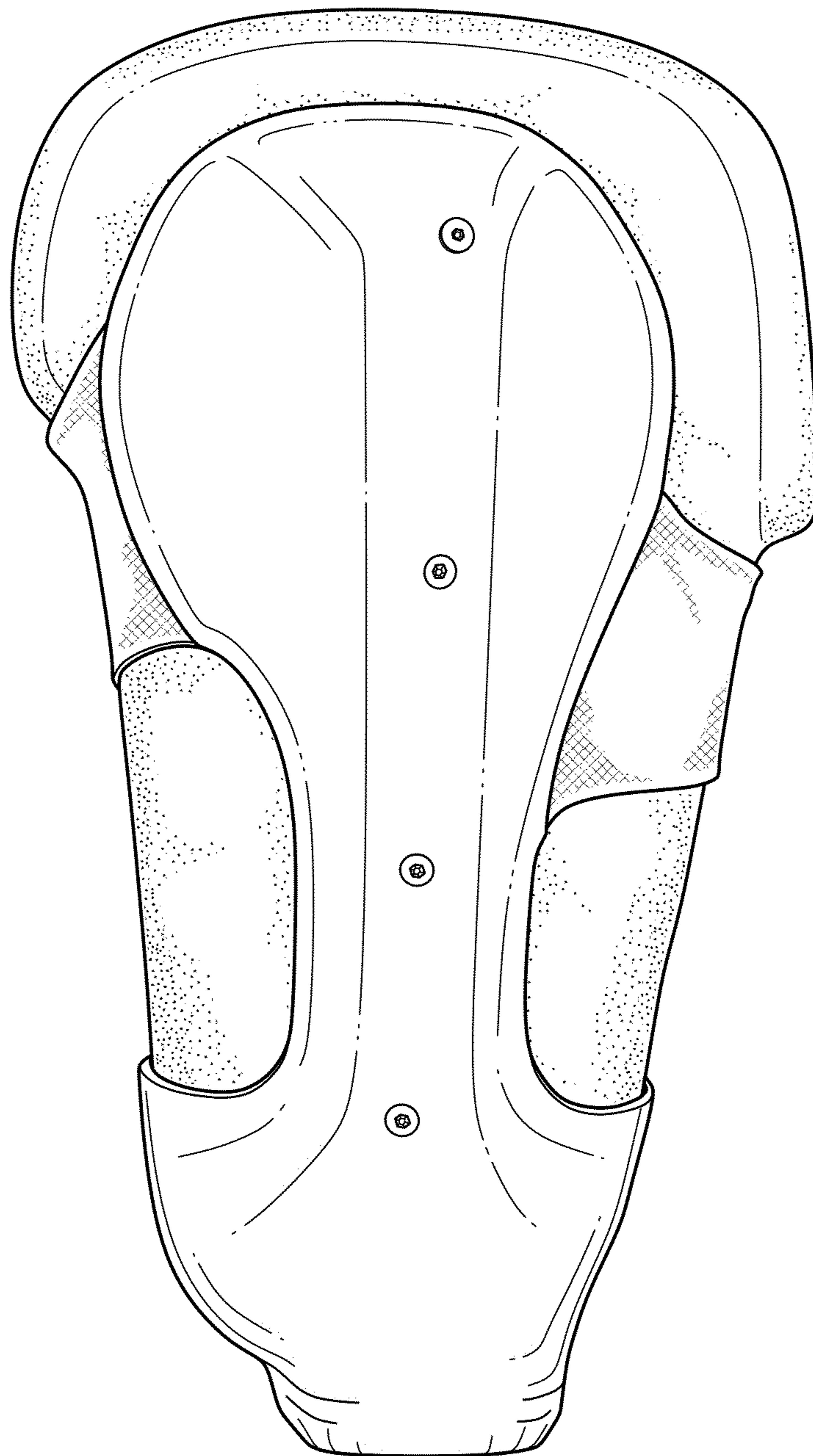

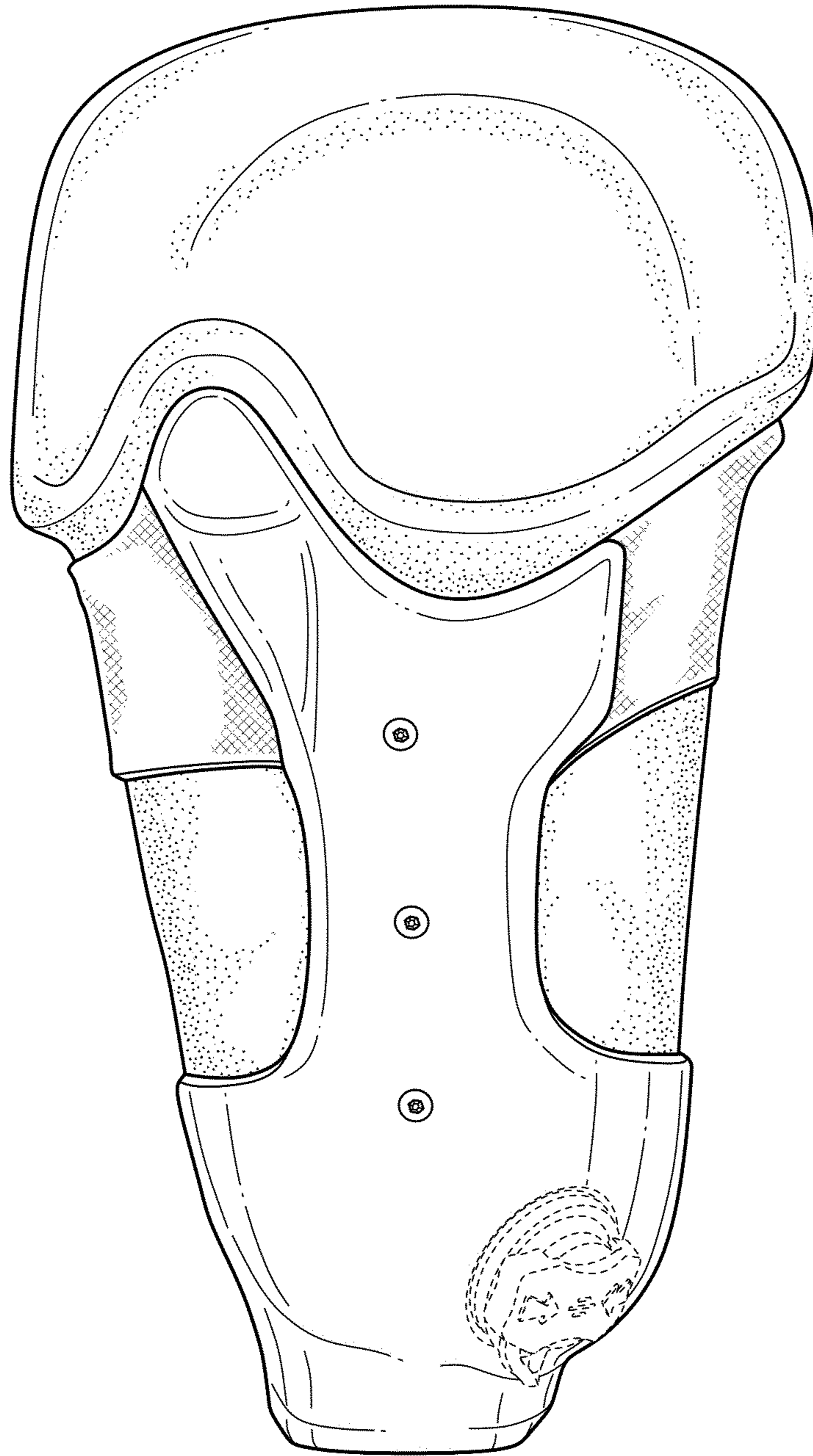

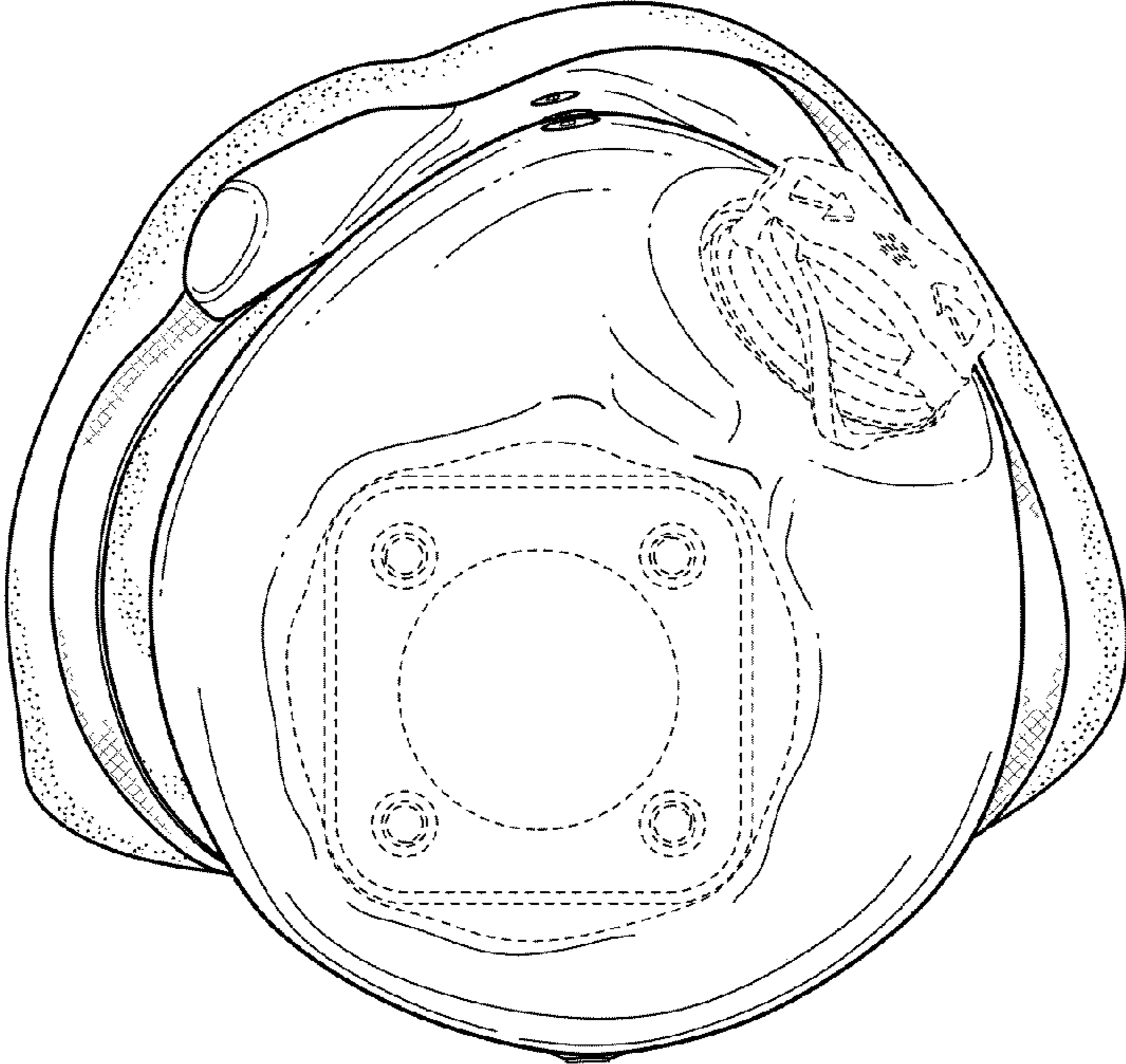

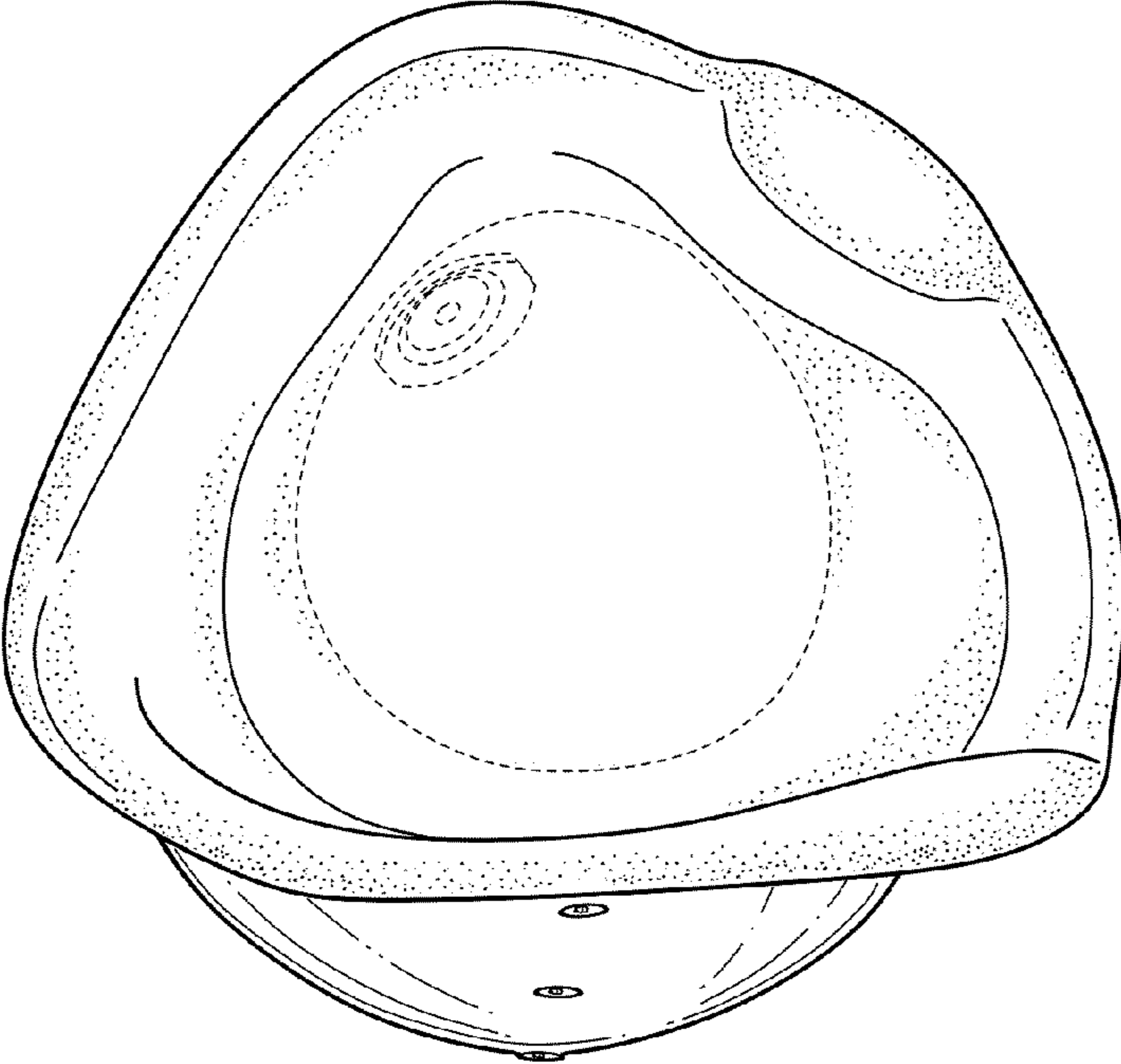
