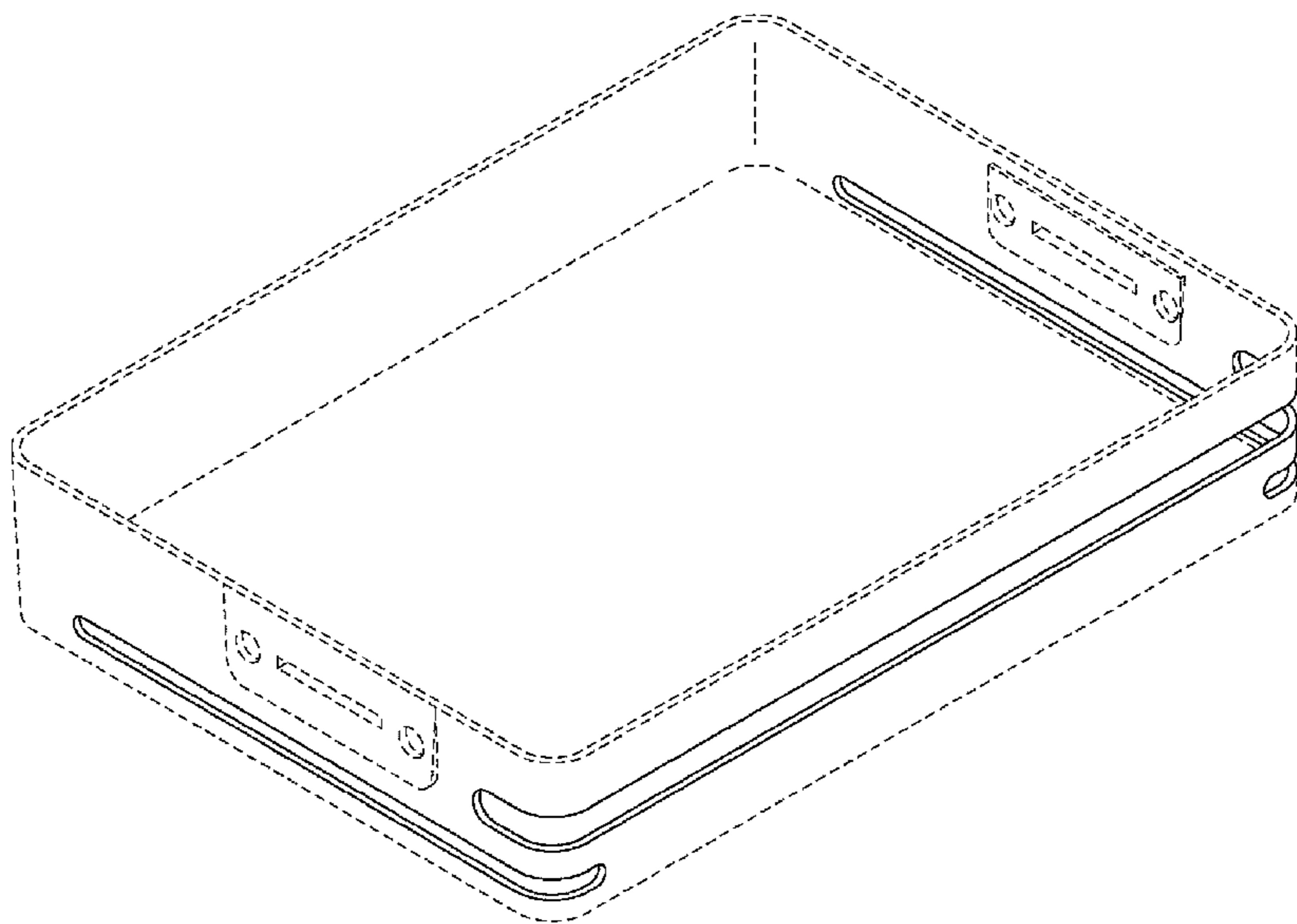
(57) **CLAIM**

The ornamental design for a breast compression plate for radiation-image capturing device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a breast compression plate for radiation-image capturing device showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a cross-section view thereof, taken along line 7-7 in FIG. 4; FIG. 8 is a cross-section view thereof, taken along line 8-8 in FIG. 4; and, FIG. 9 is a side view thereof, shown in condition of use. The portions of the breast compression plate for radiation-image capturing device shown in broken lines do not form part of the claimed design.

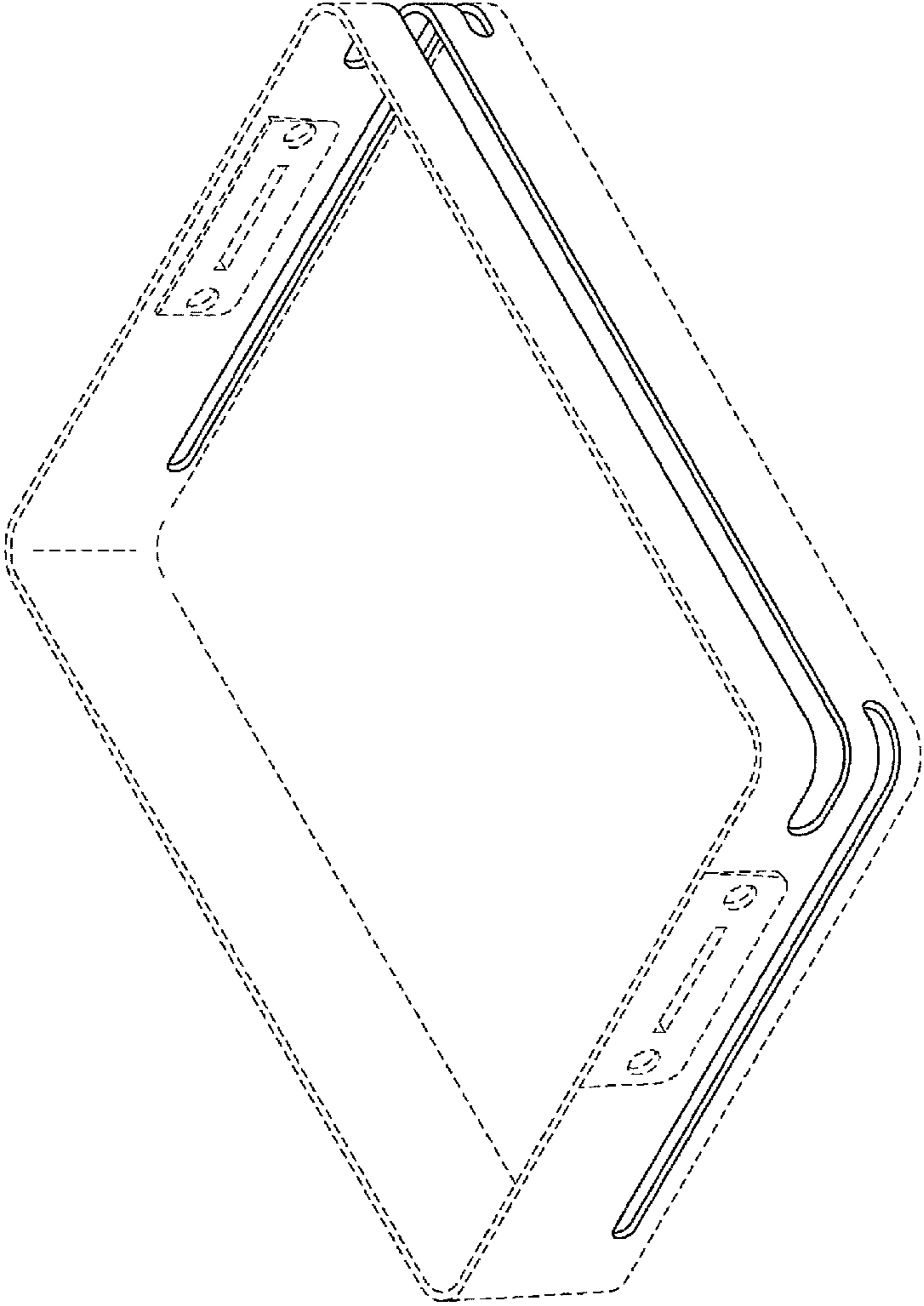

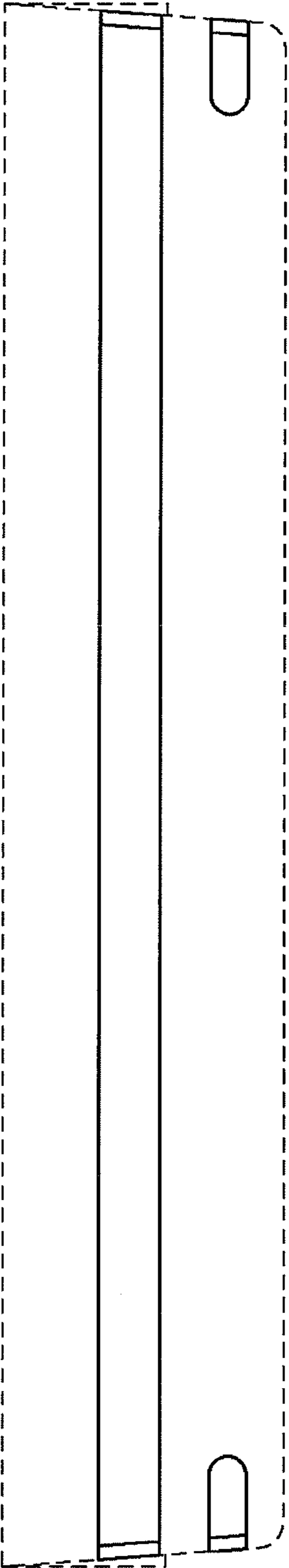

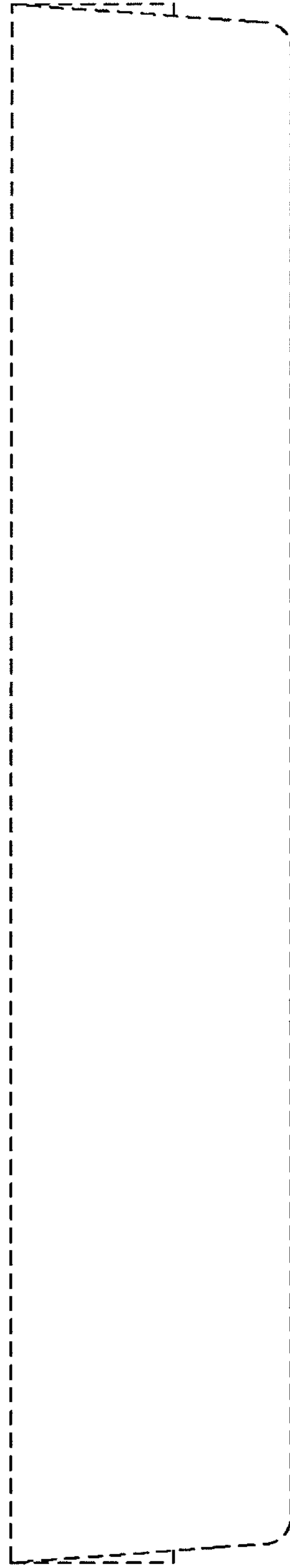

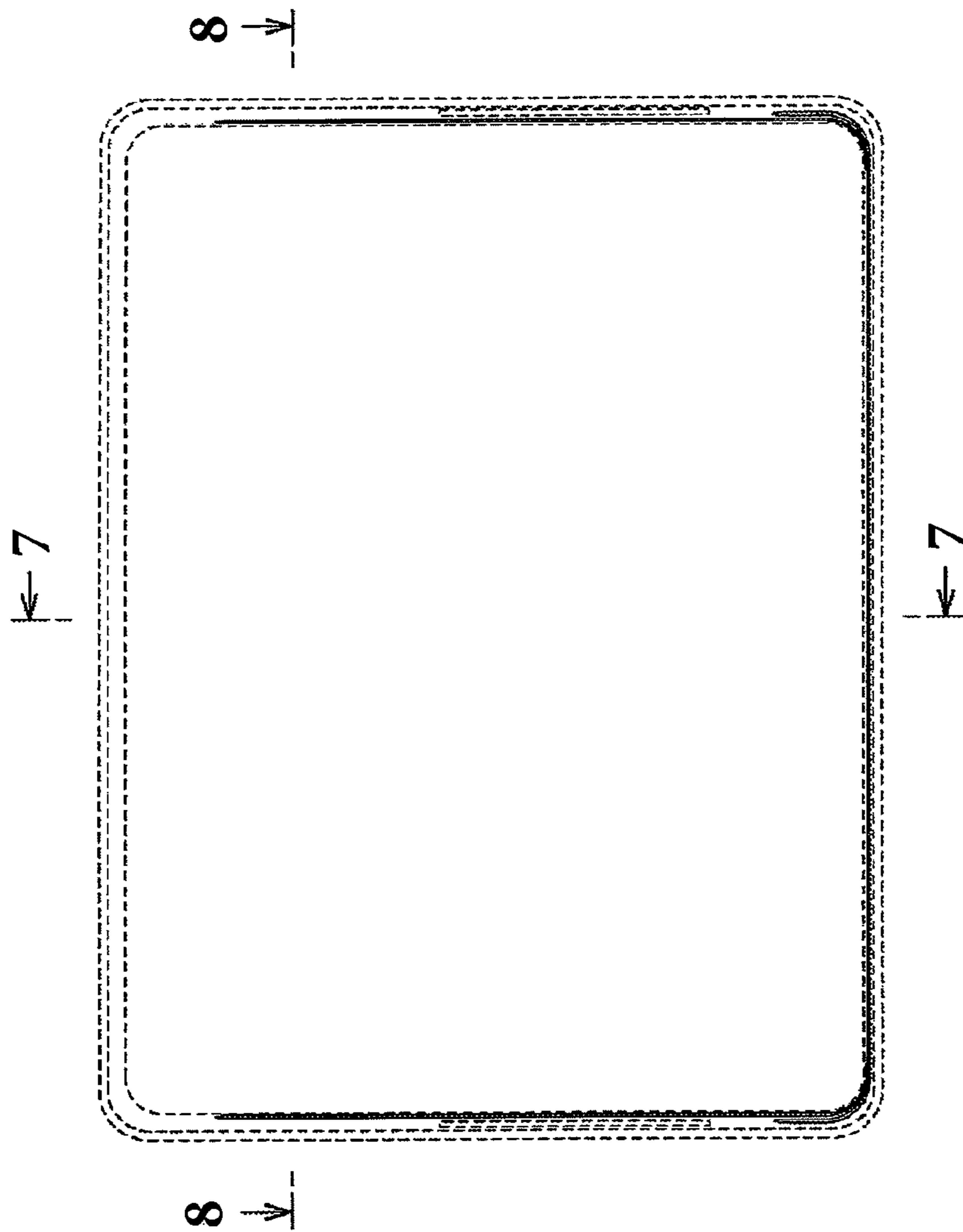

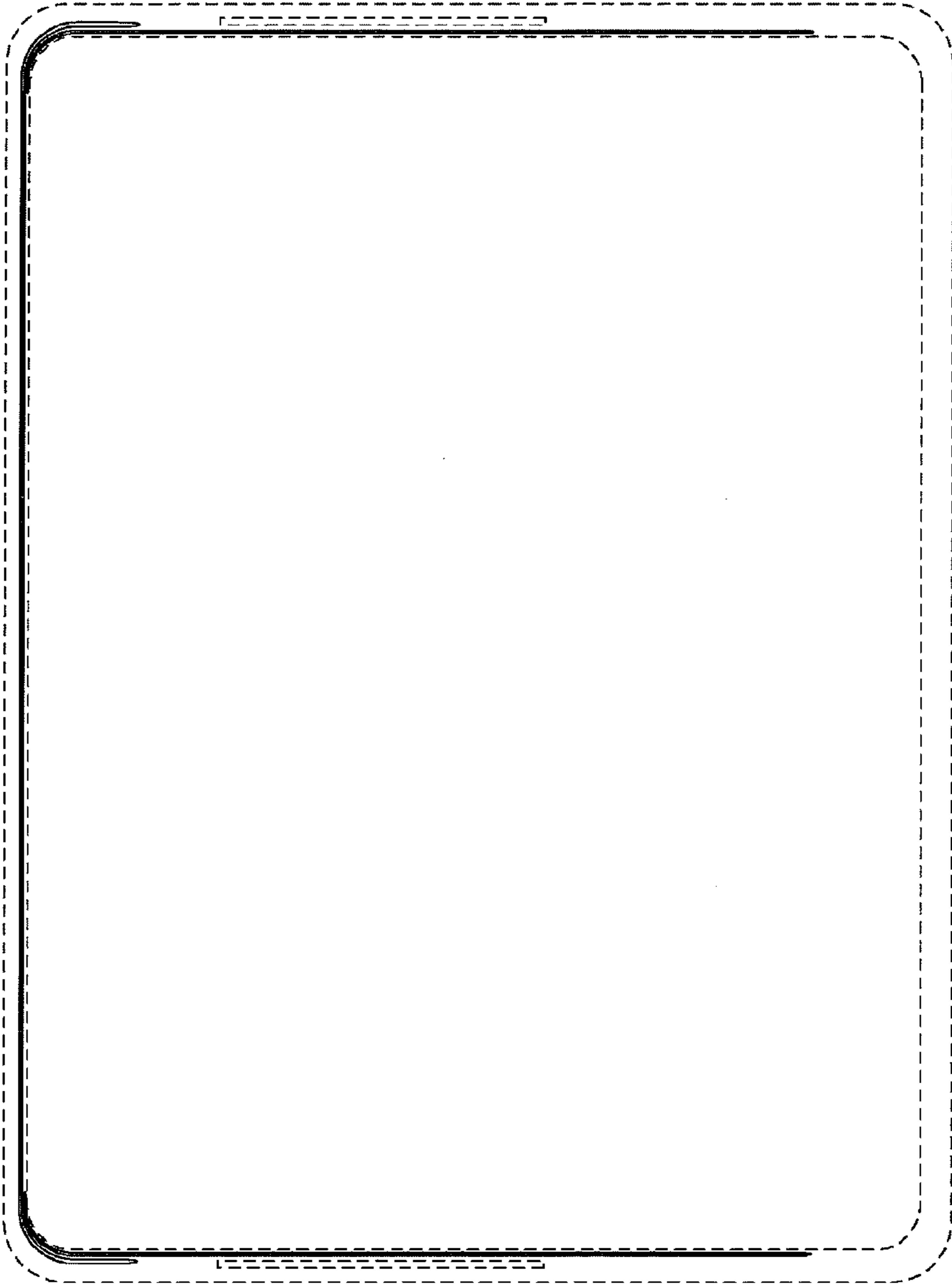

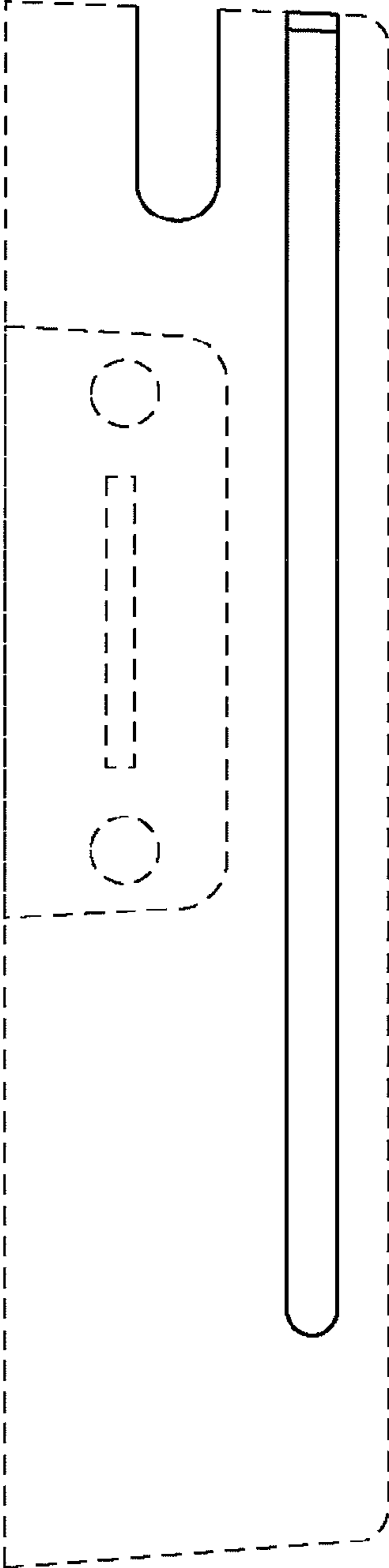

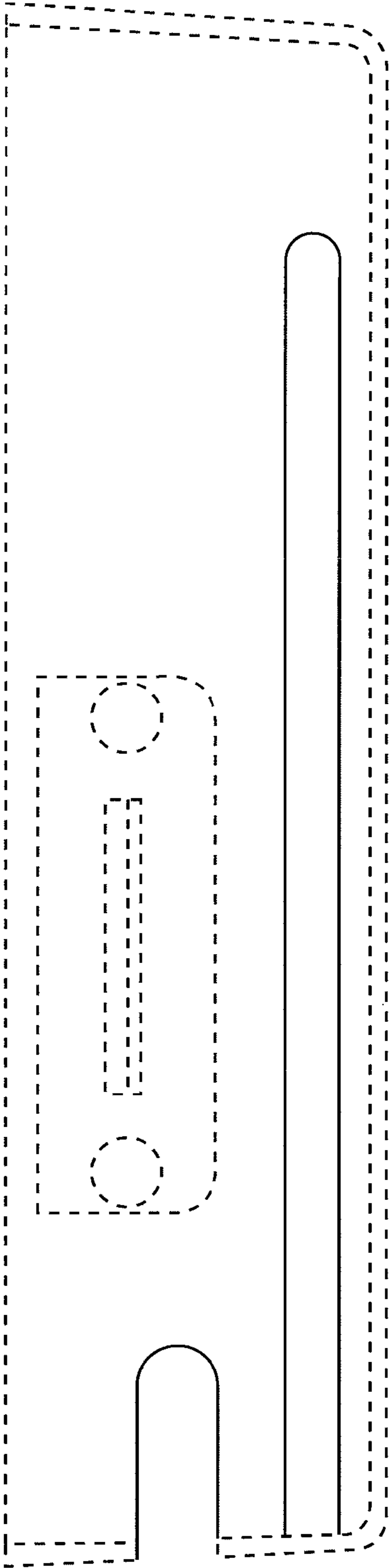

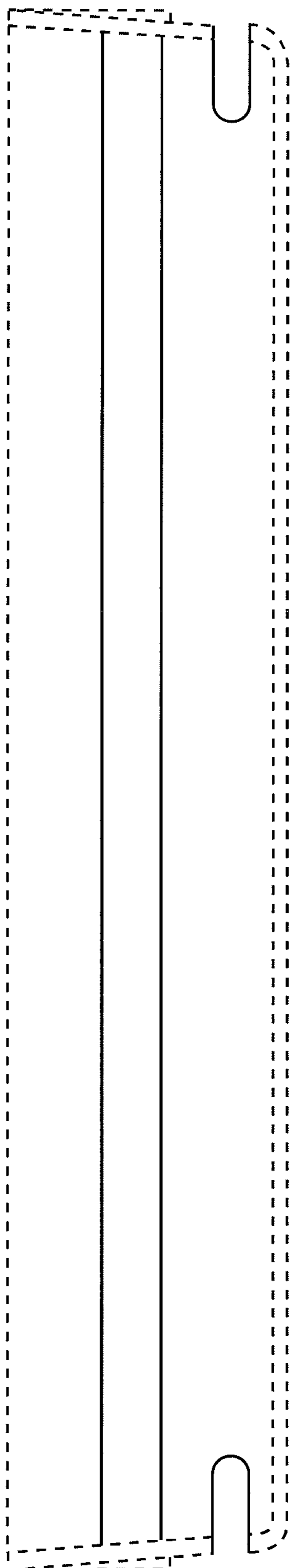

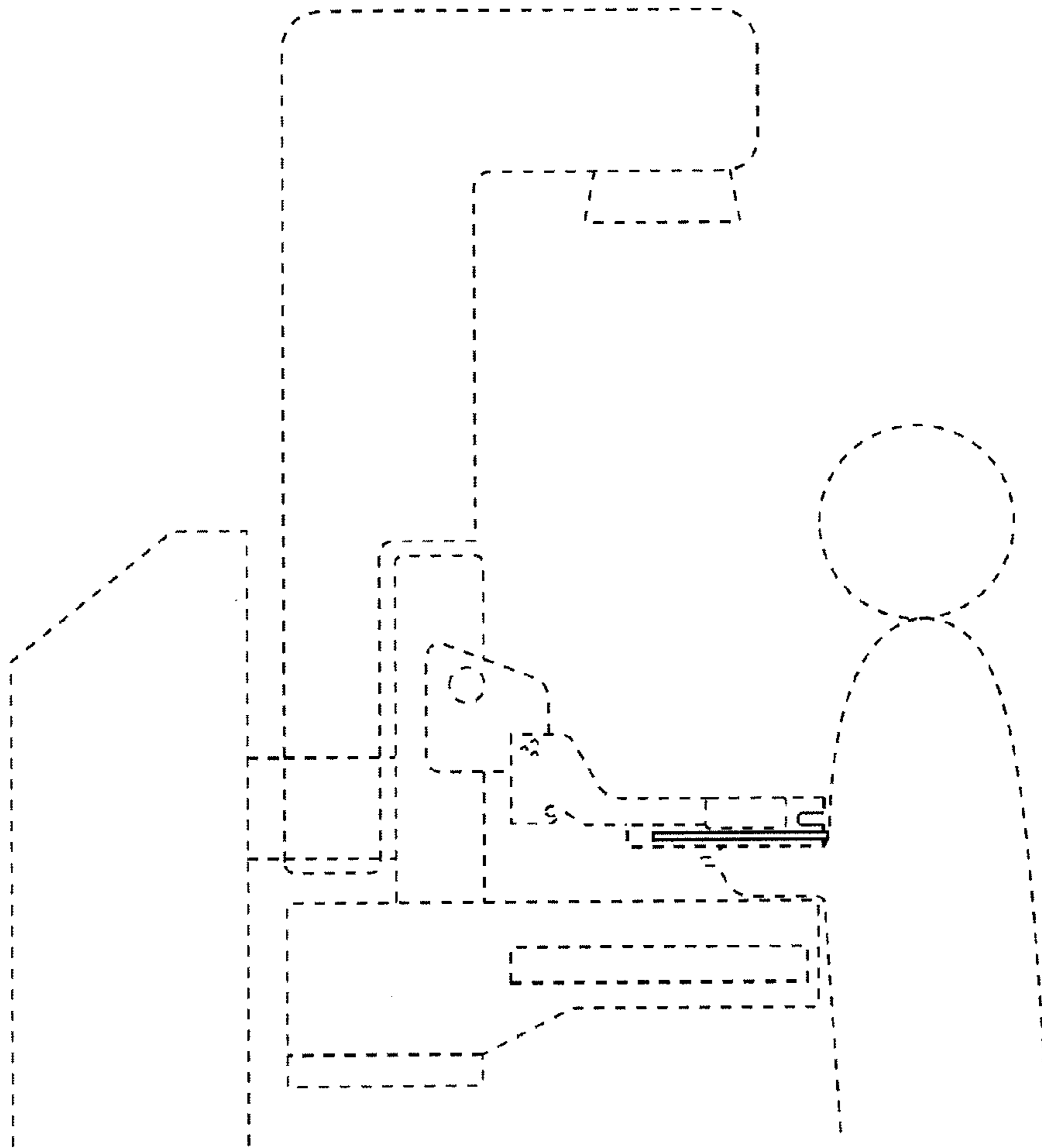
