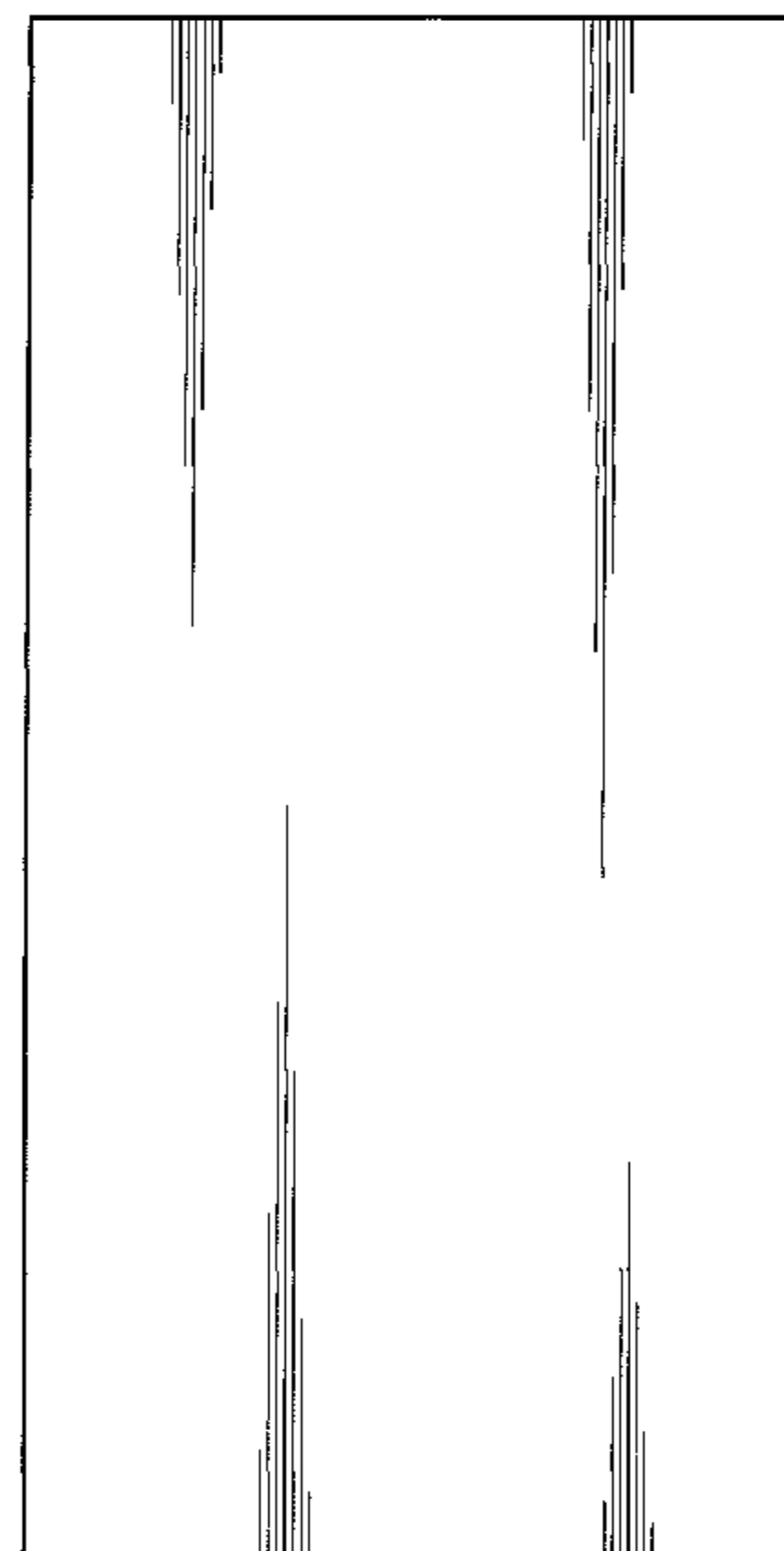
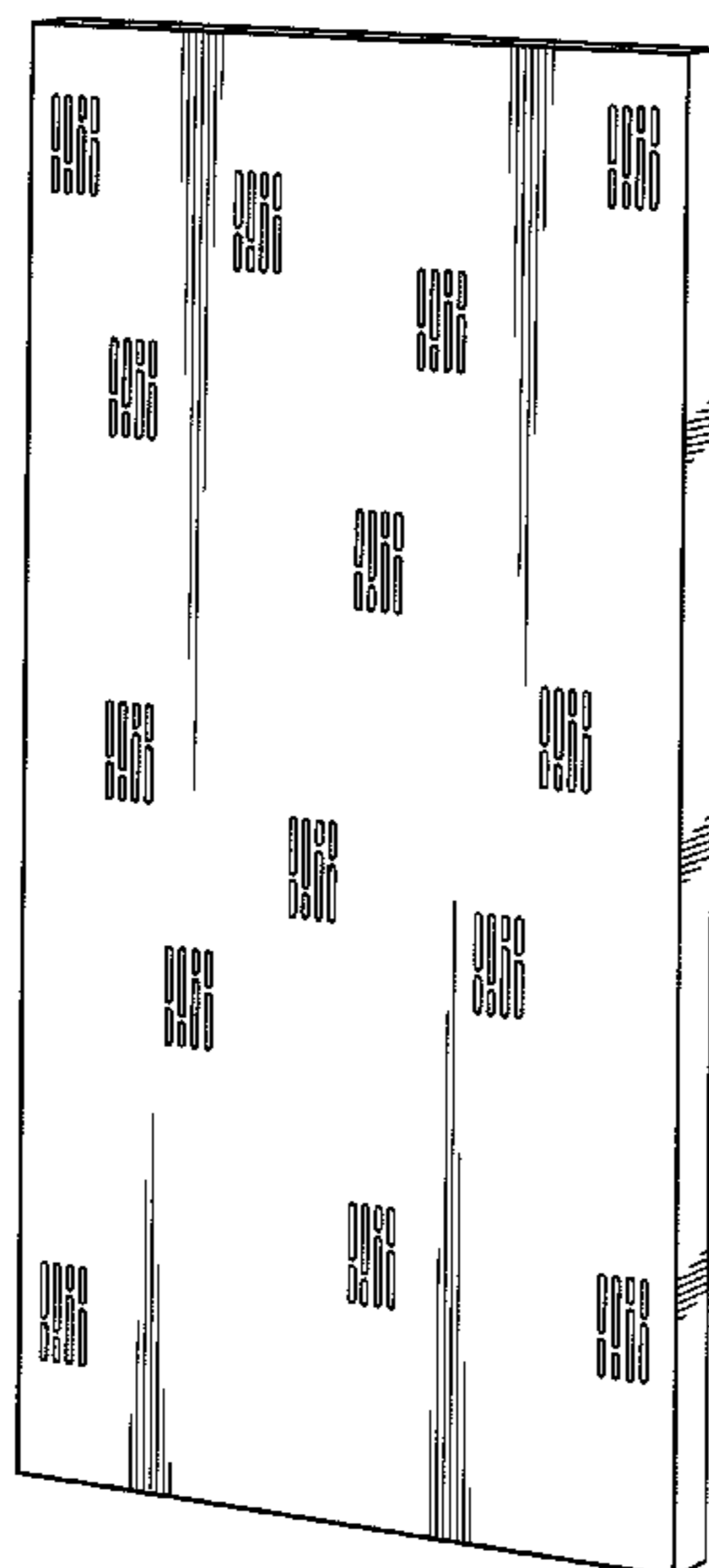
(57) **CLAIM**

The ornamental design for a sound control panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the front, top and right side of a sound control panel showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a right side view thereof, the left side being a mirror image;  
FIG. 5 is a top plan view thereof, the bottom being a mirror image;  
FIG. 6 is an enlarged cross sectional view at 6-6 shown in FIG. 2;  
FIG. 7 is an enlarged view at 7-7 shown in FIG. 2;  
FIG. 8 is an enlarged view at 8-8 shown in FIG. 6; and,  
FIG. 9 is a perspective reference view of the sound control panel to which the legs are attached.  
The broken lines in FIG. 9 represent the portions of the sound control panel, which form no part of the claimed design.

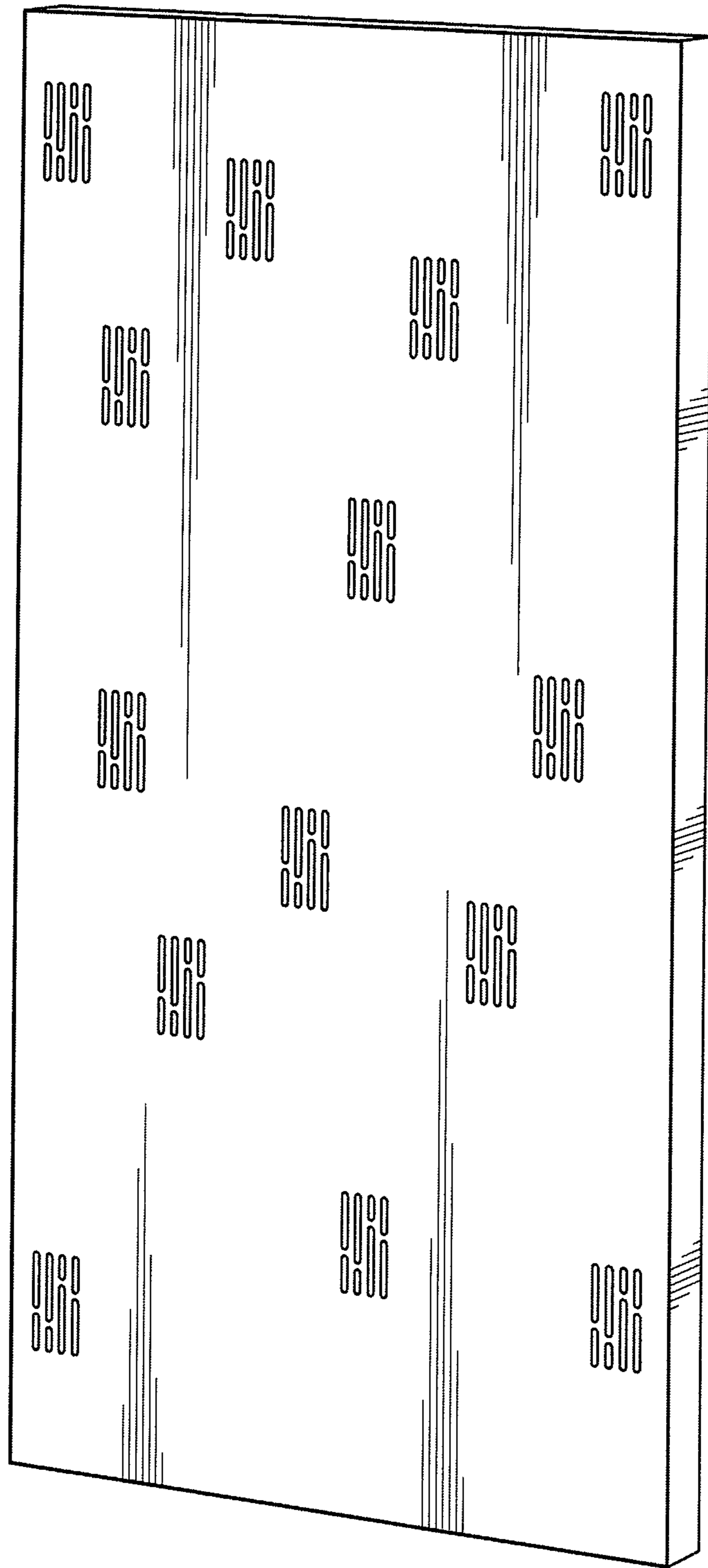

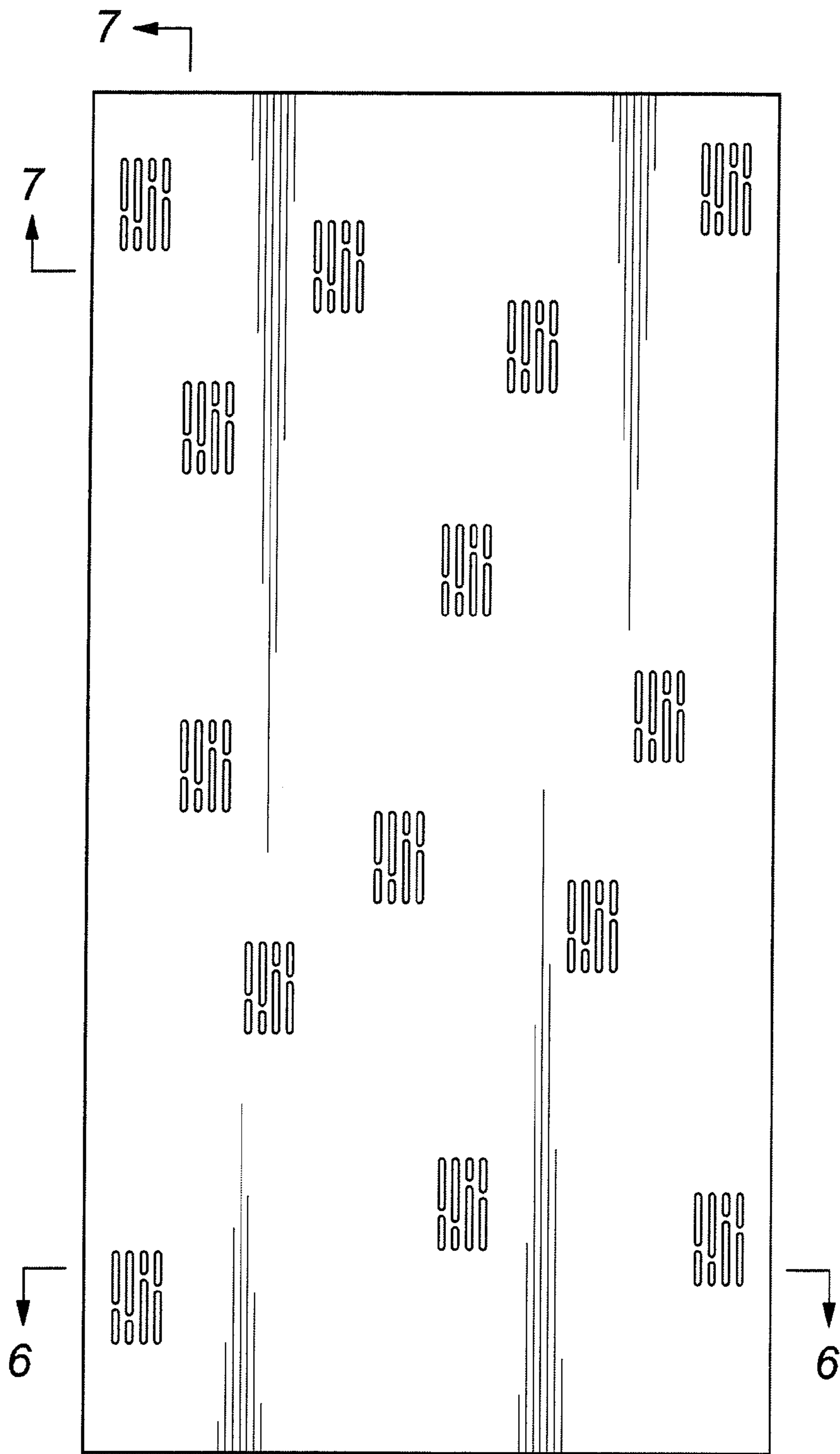

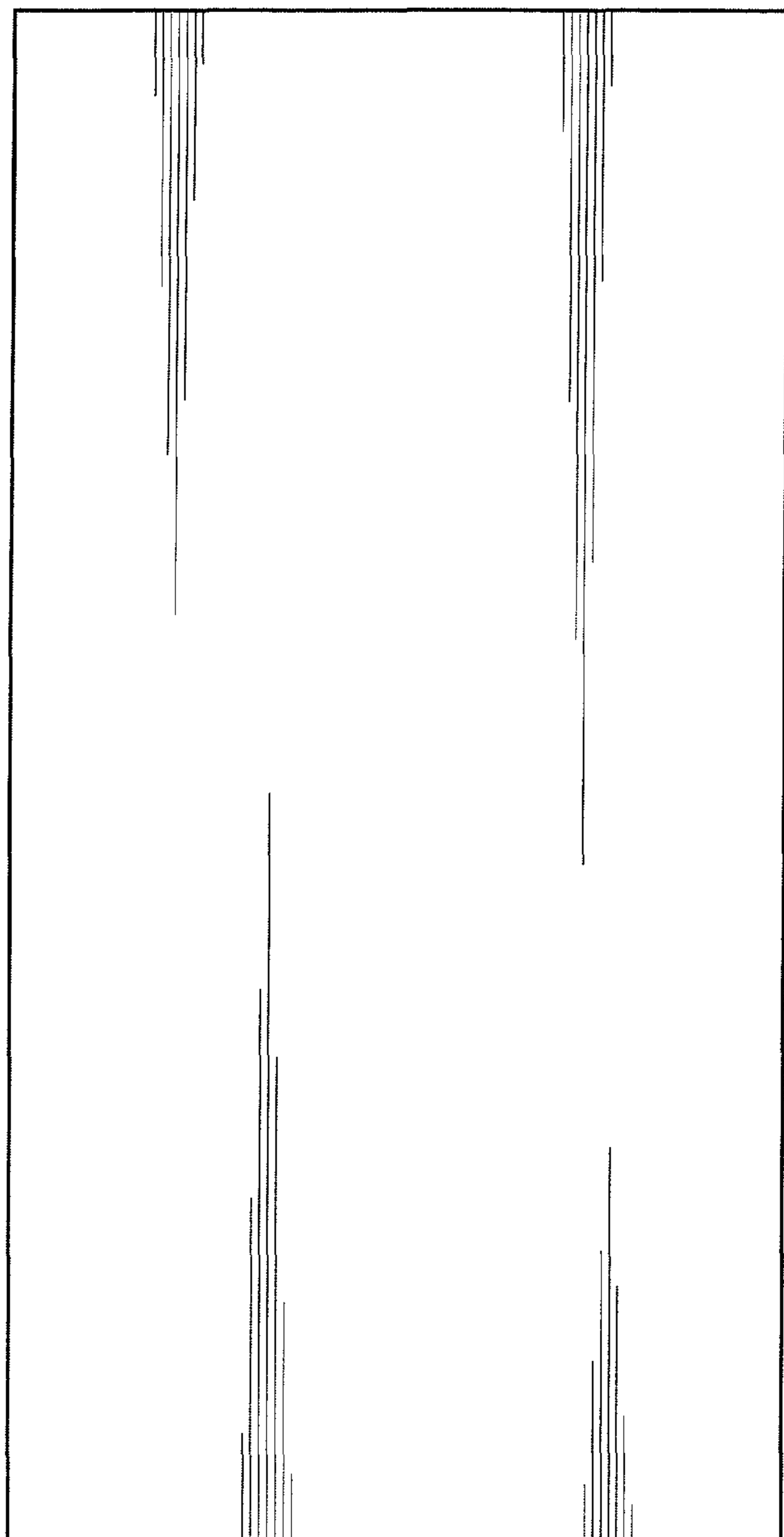

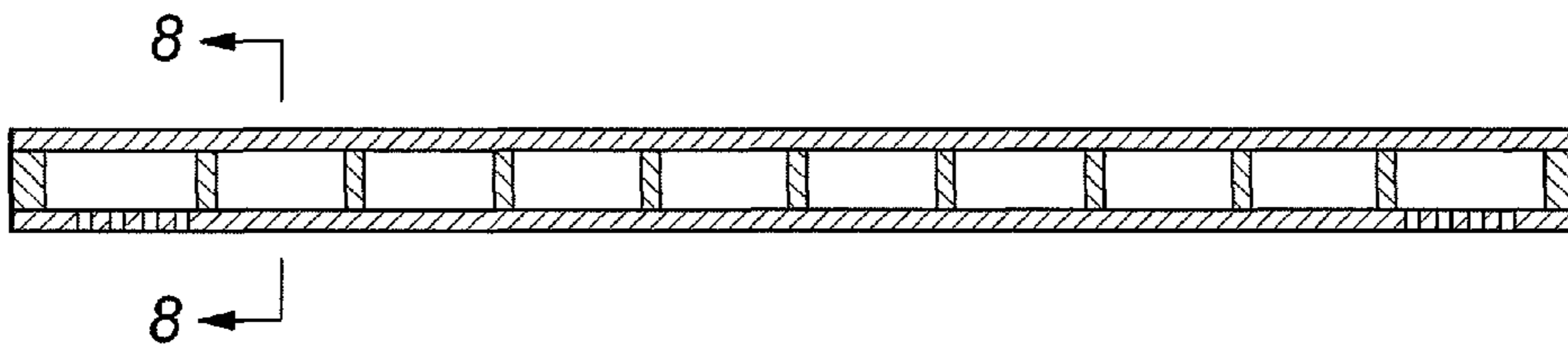
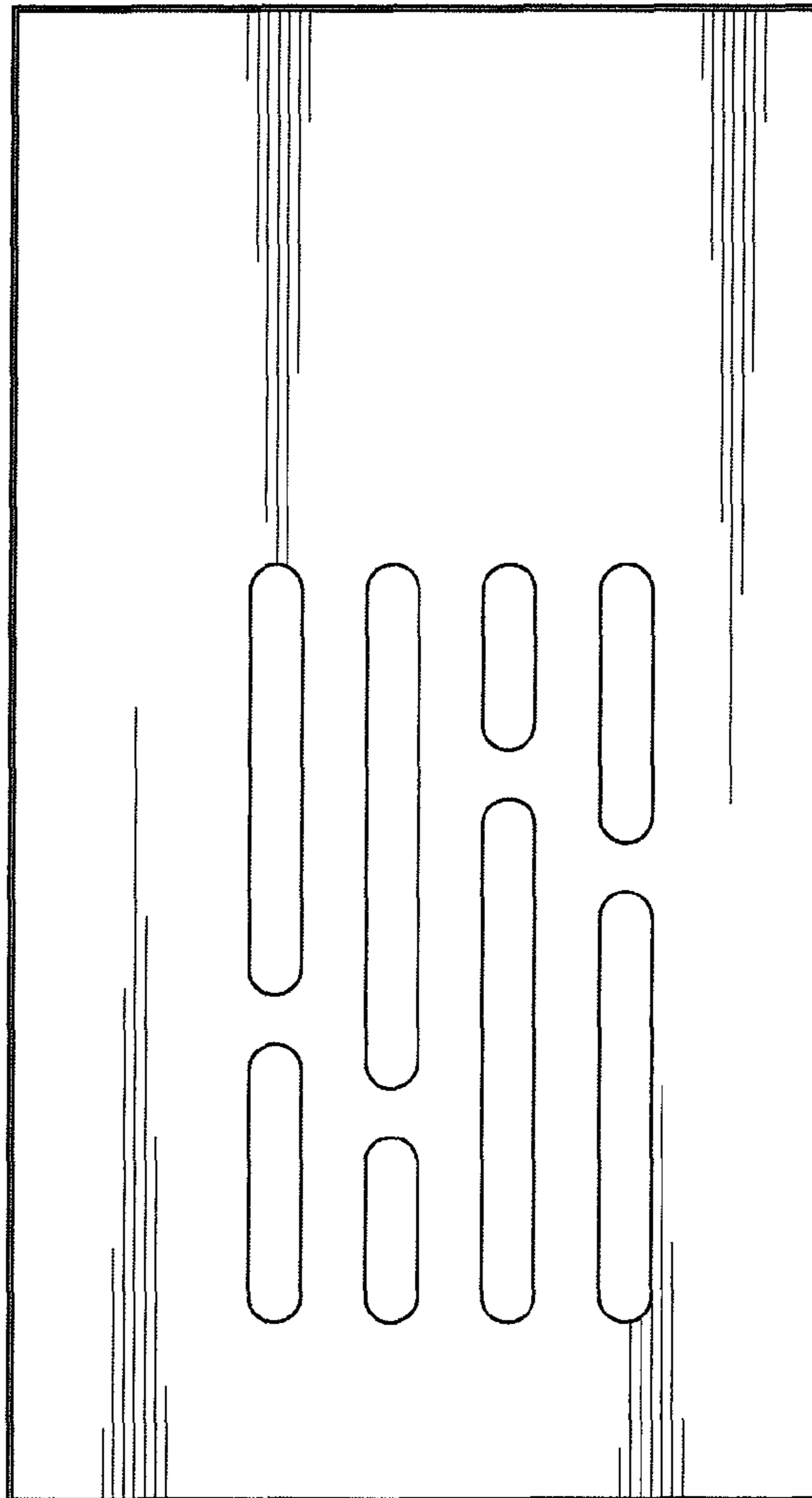
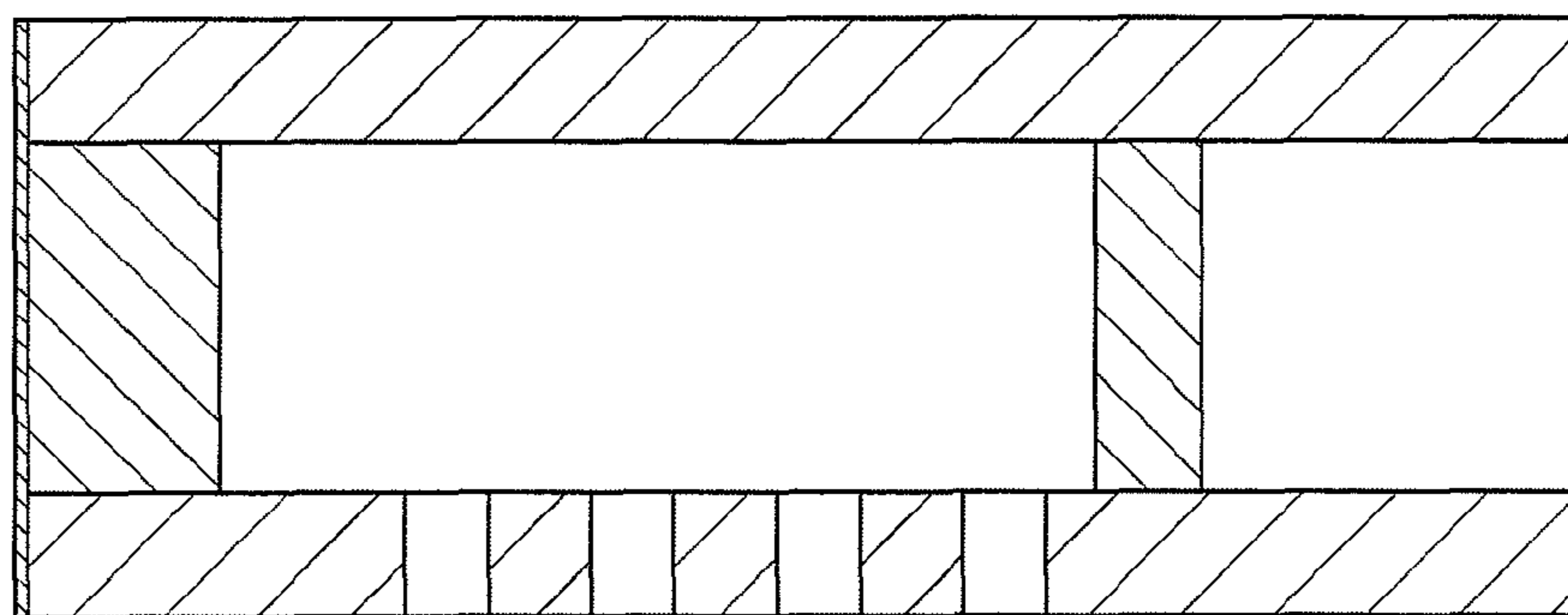

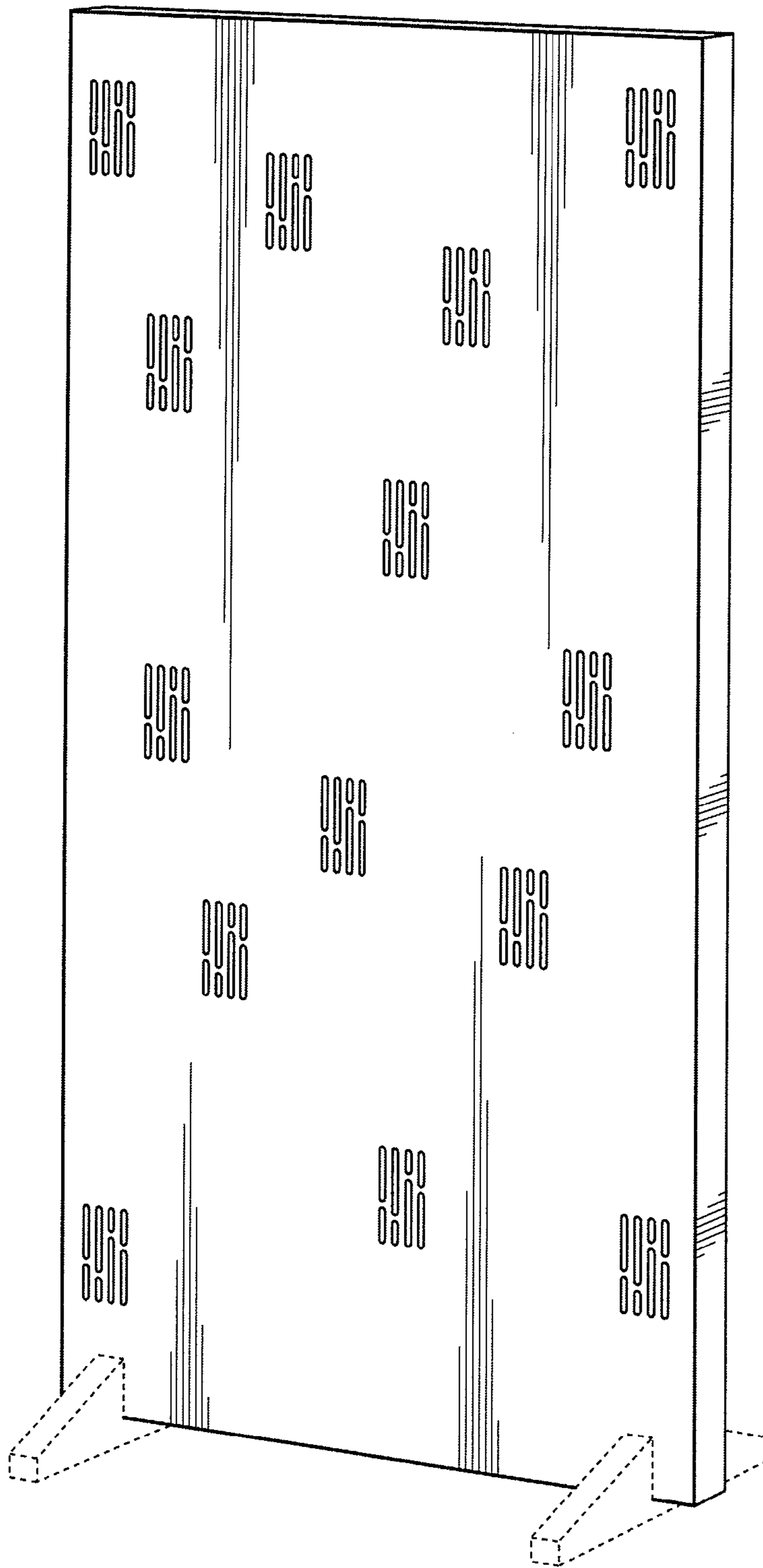
