DESCRIPTION

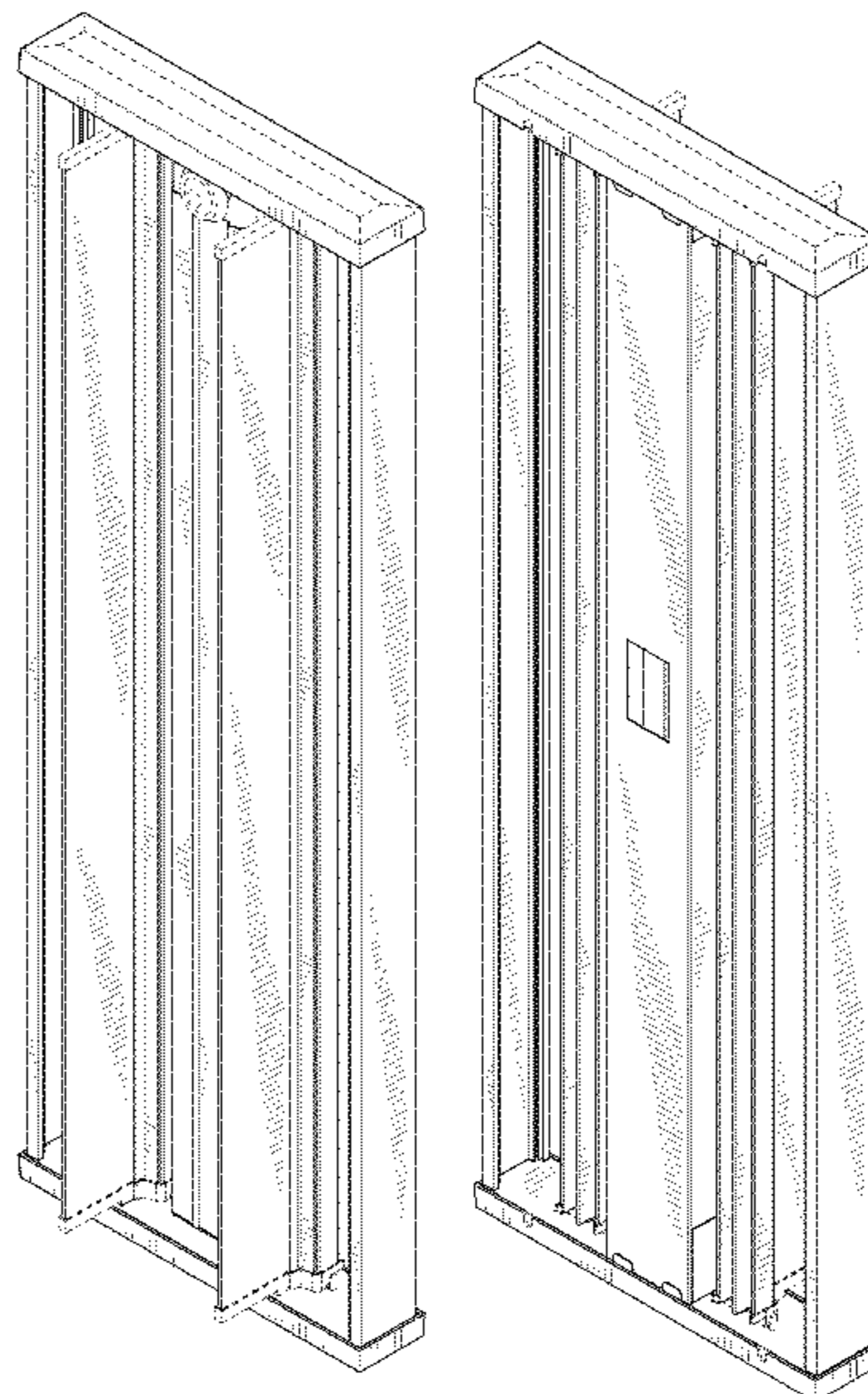

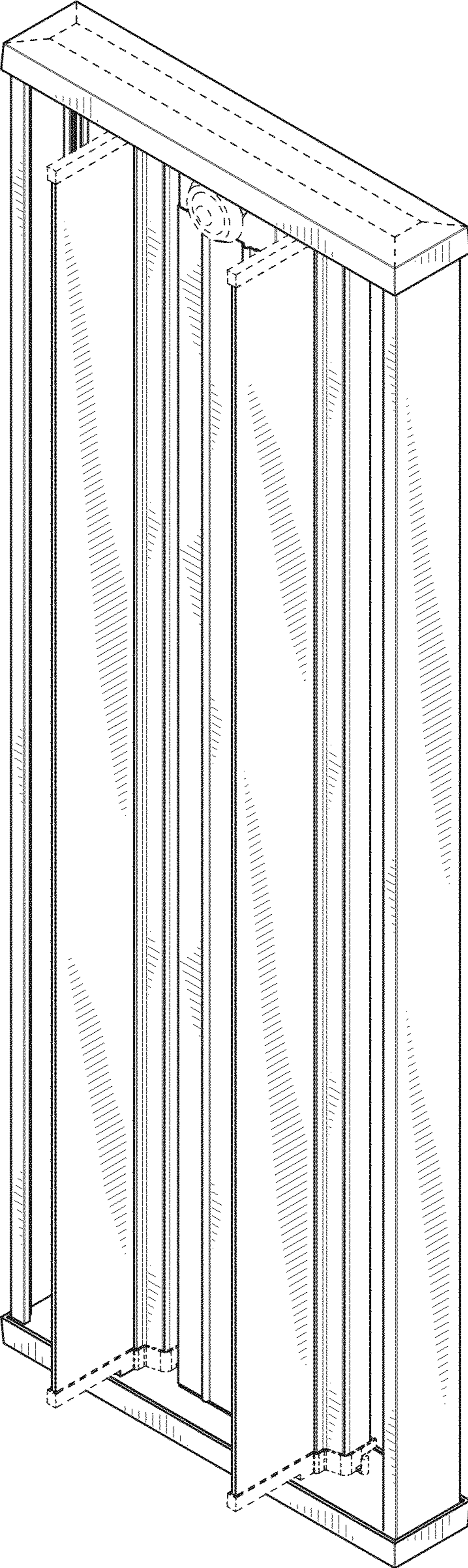

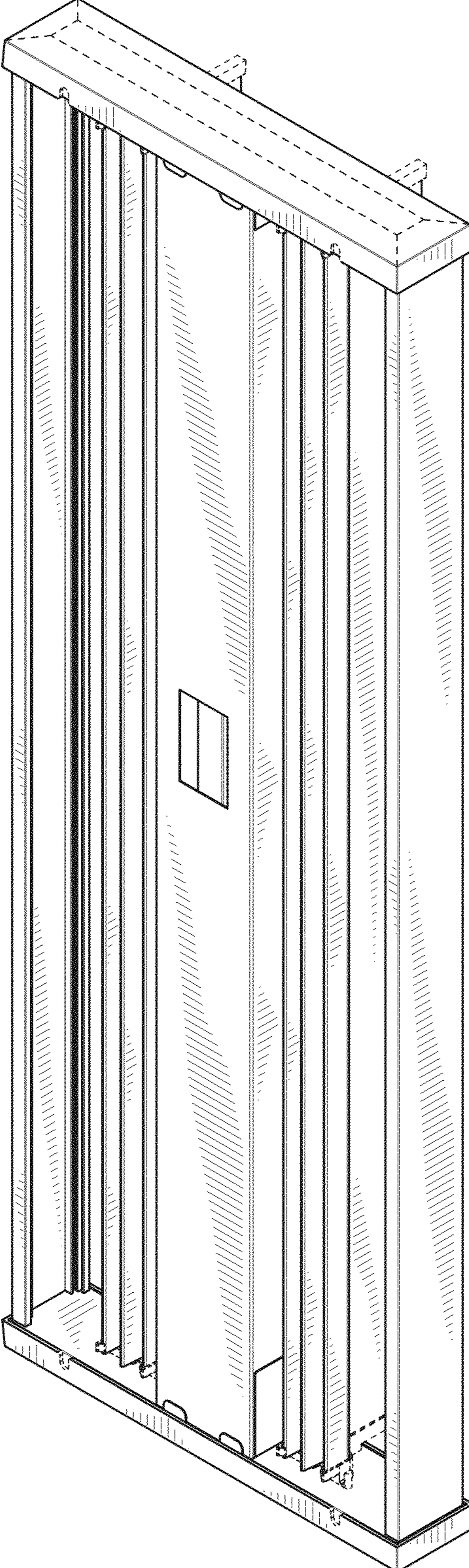

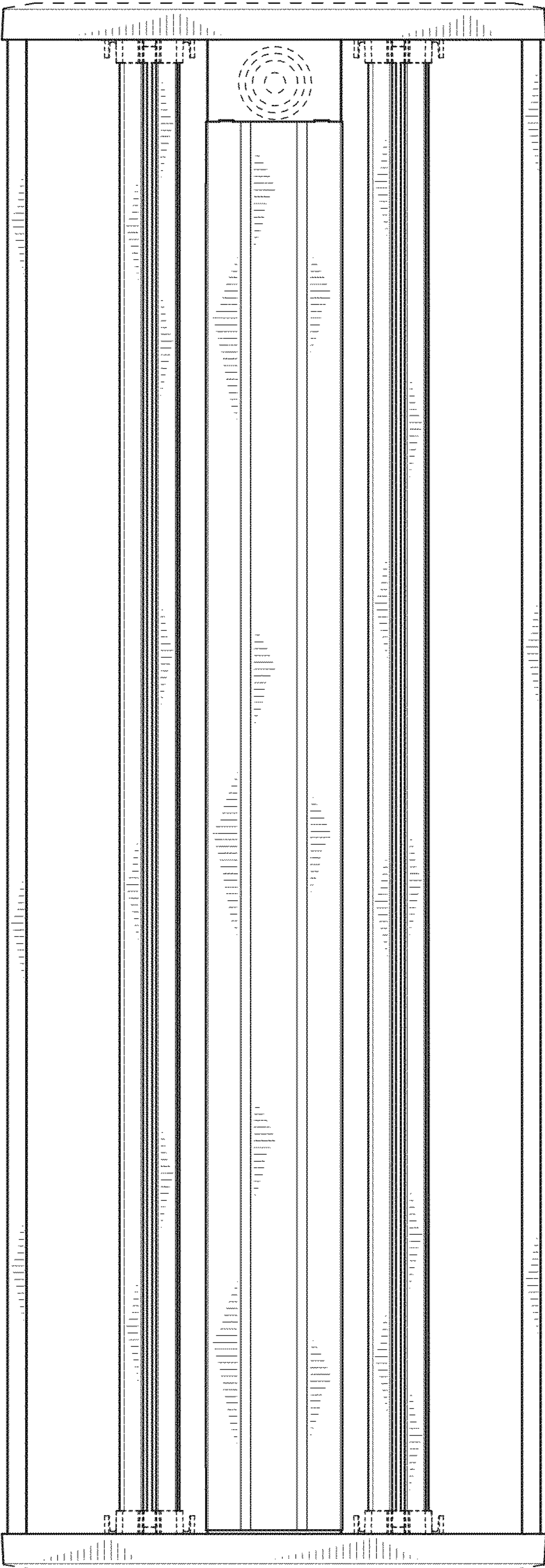

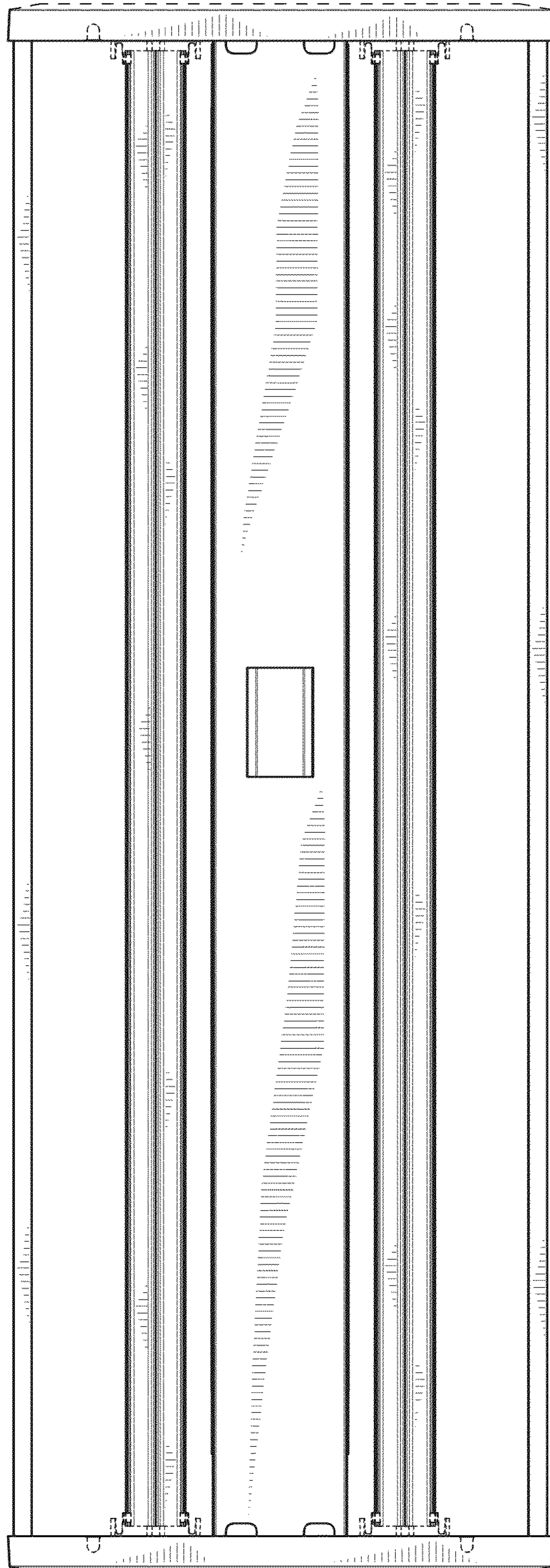

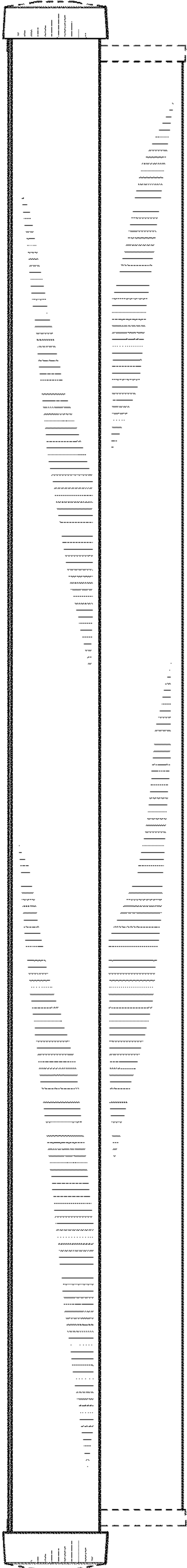

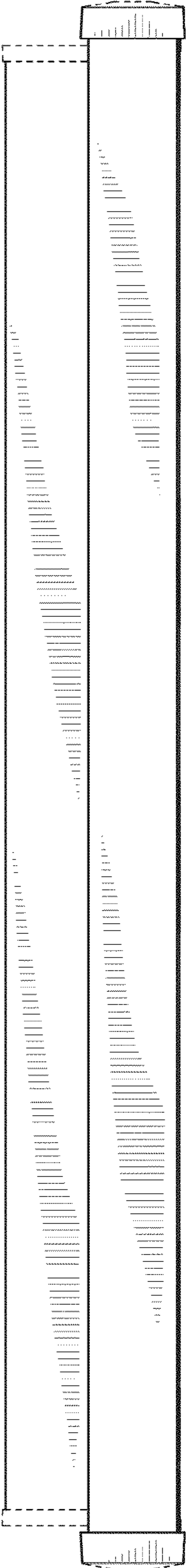

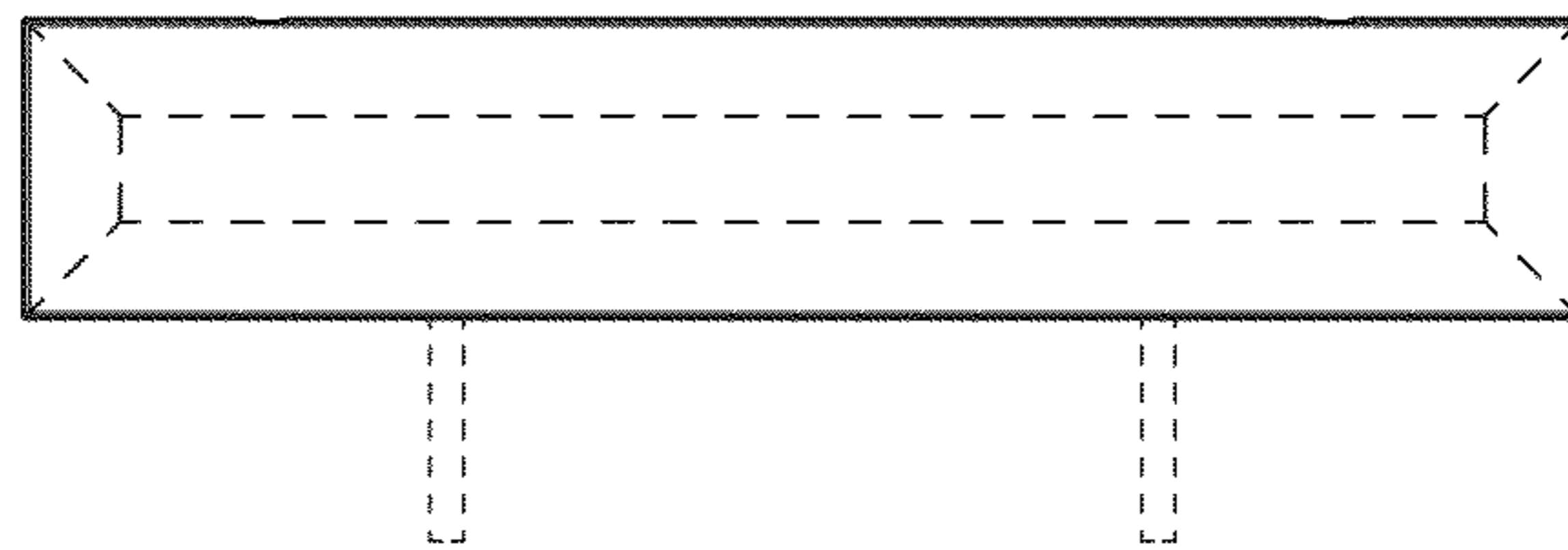

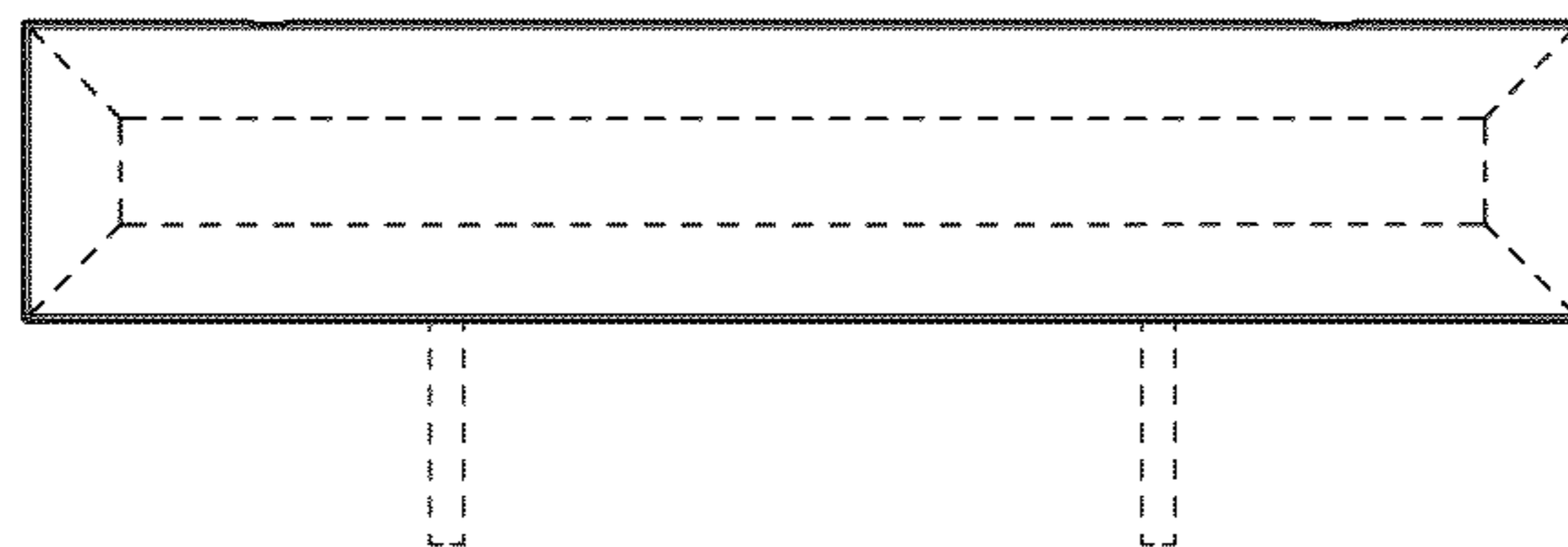

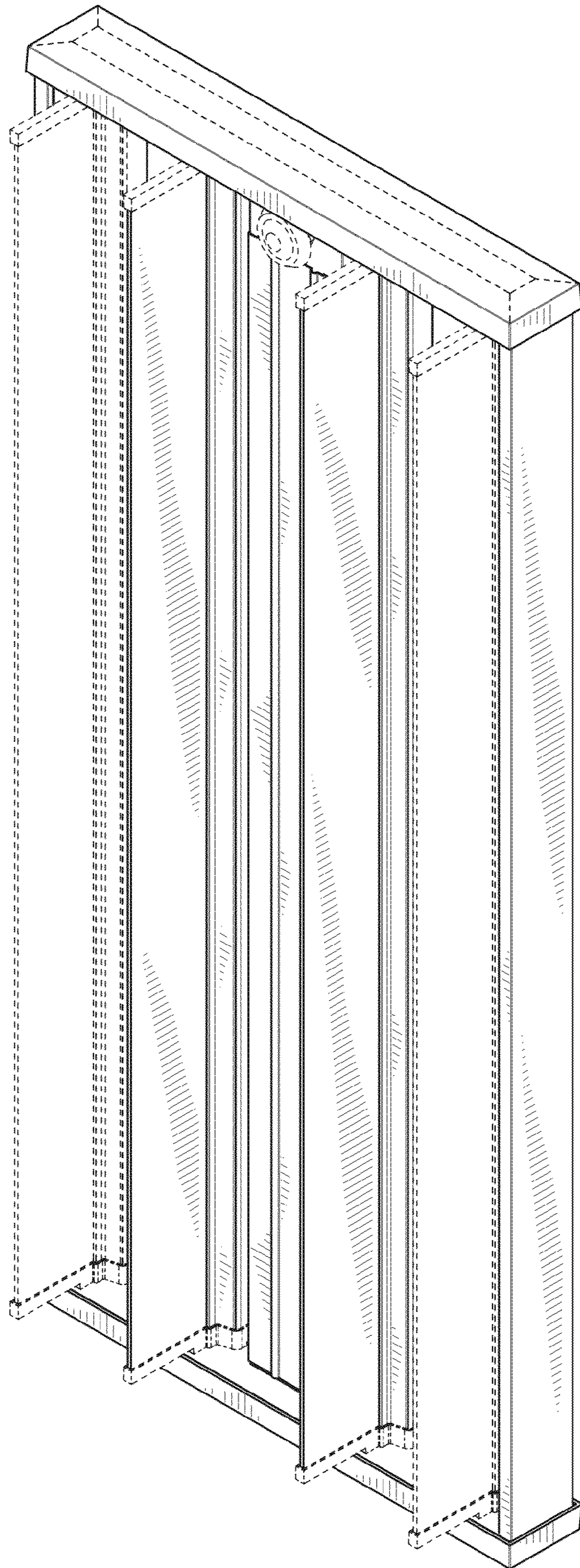

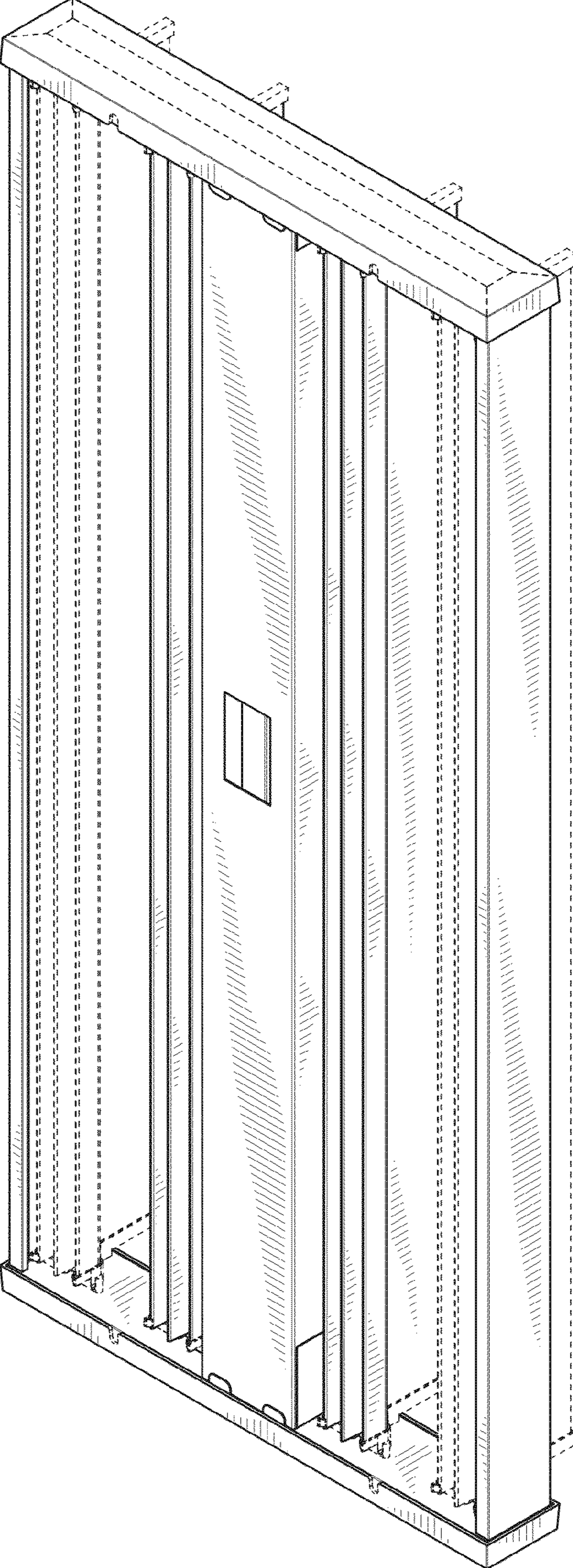

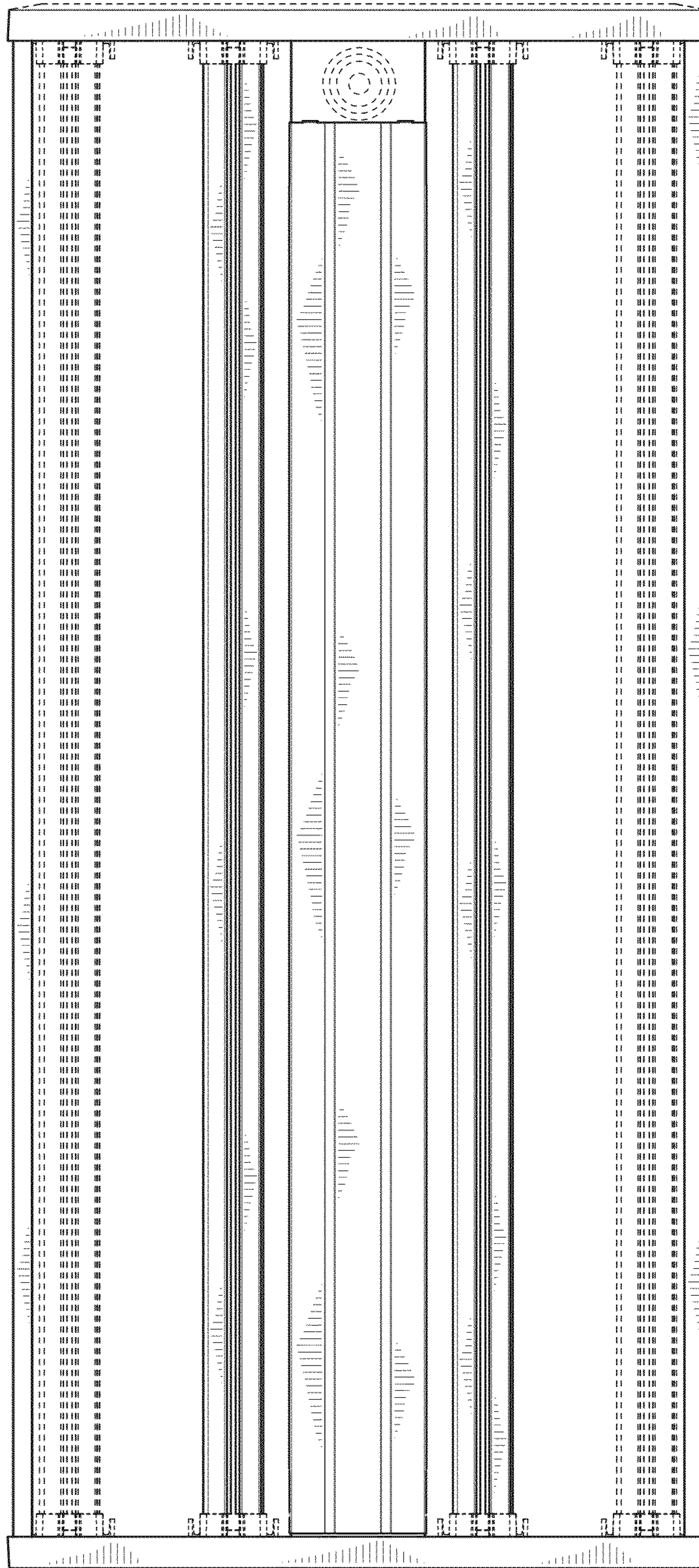

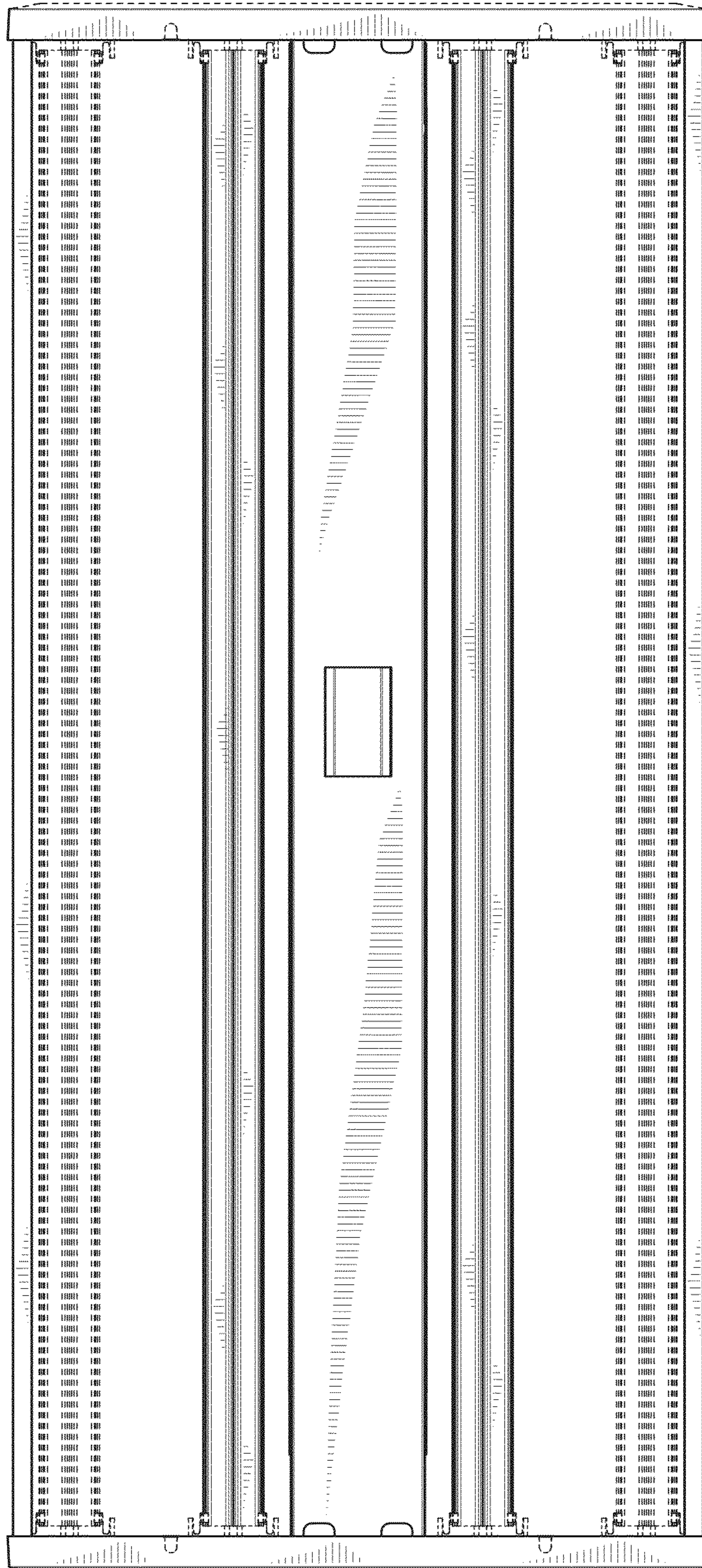

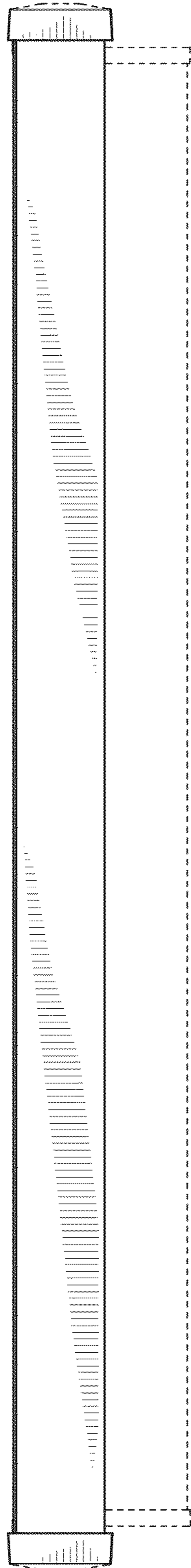

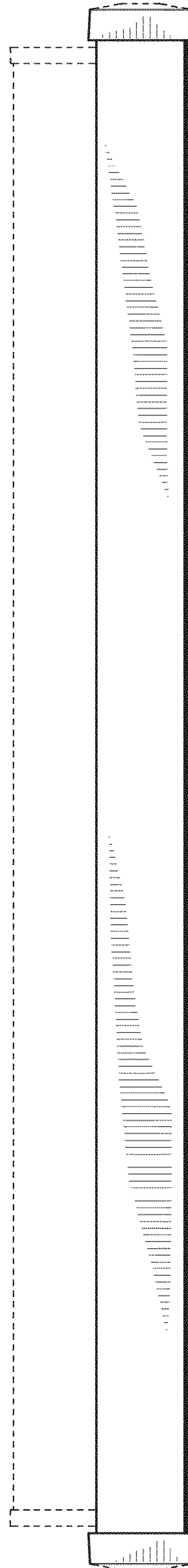
