(57) **CLAIM**

The ornamental design for a light fixture, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a light fixture embodying the design of the present invention.

FIG. 2 is a front side elevational view of the light fixture illustrated in FIG. 1, with the back side elevational view being identical thereto.

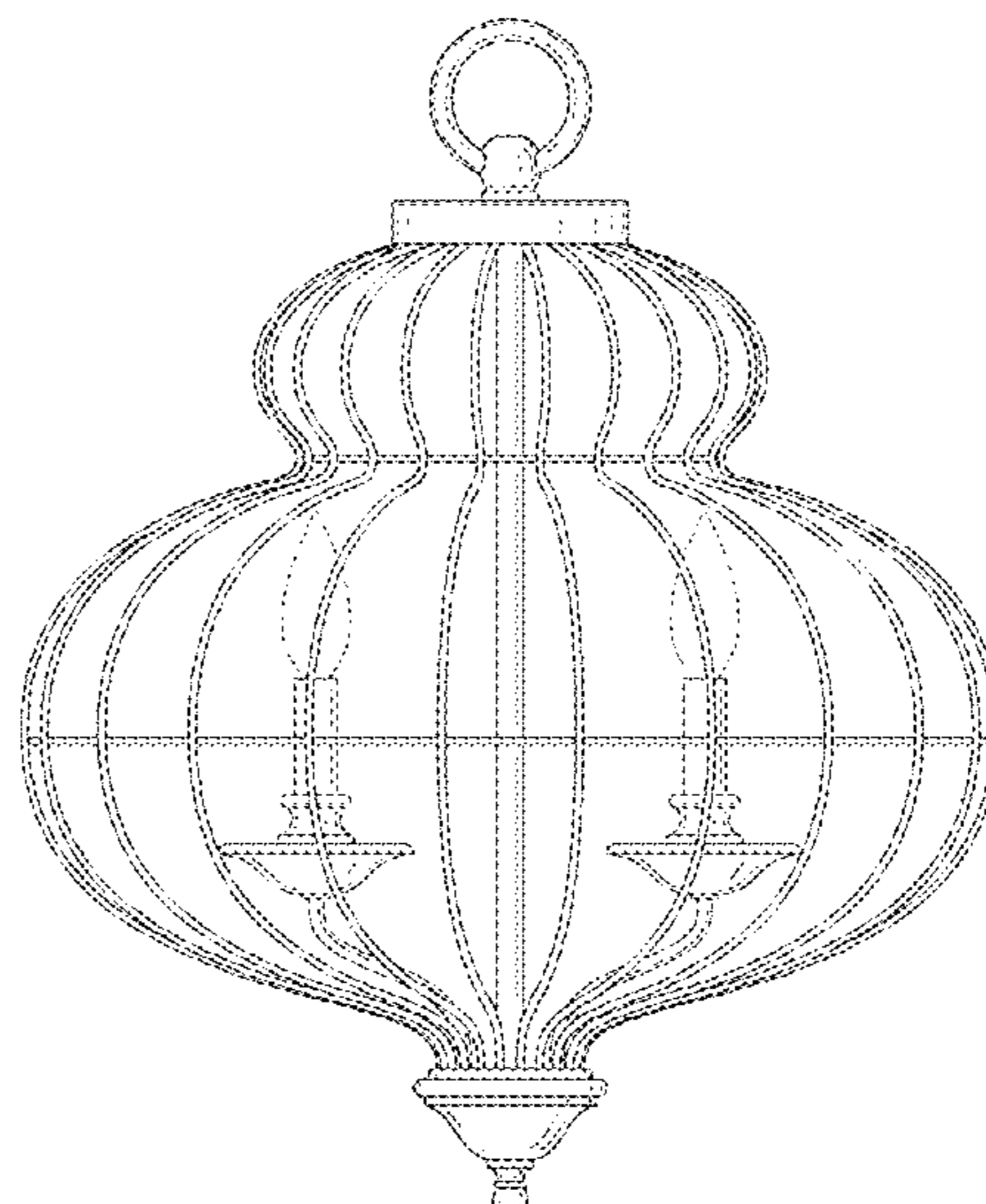
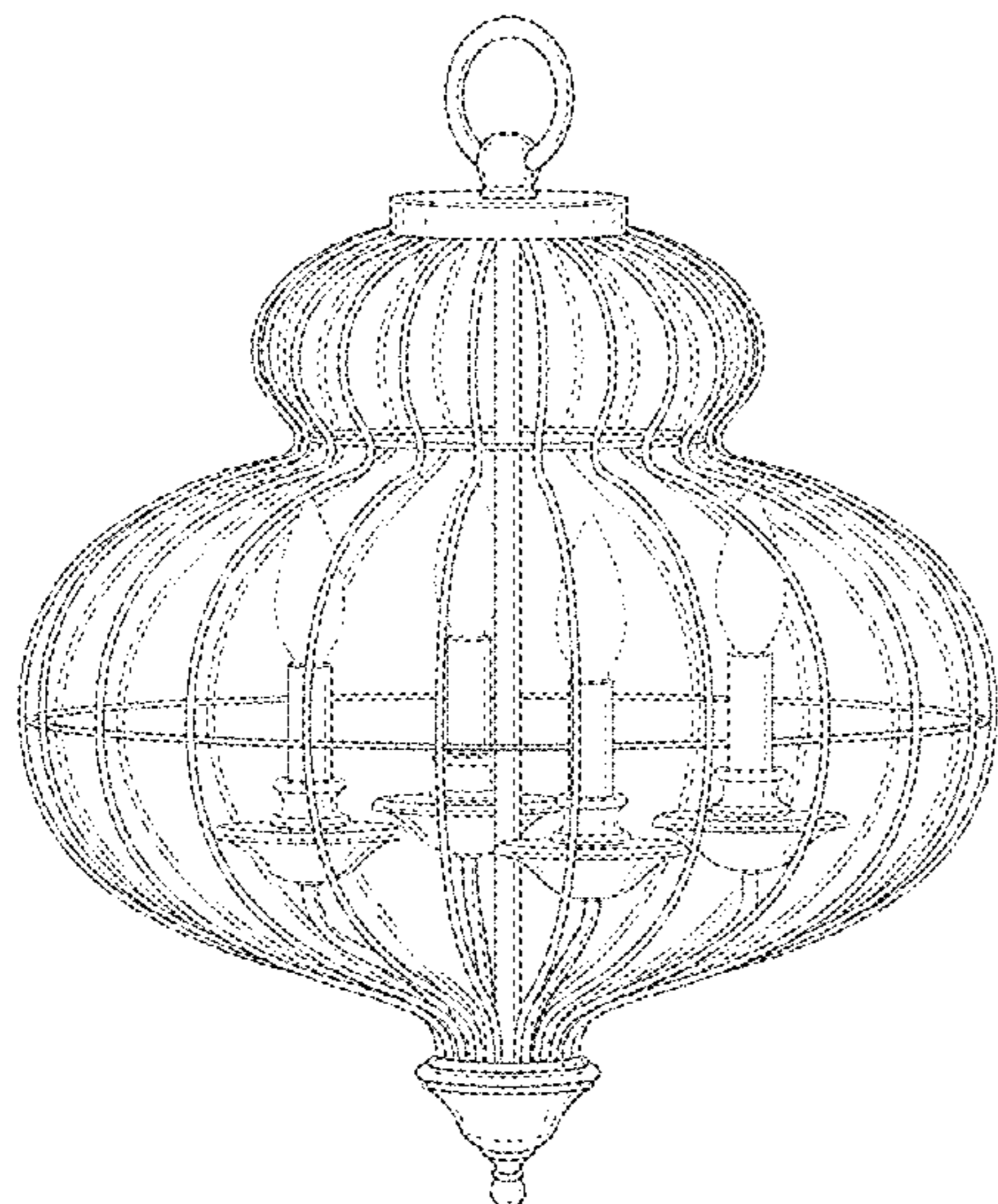
FIG. 3 is a left side elevational view of the light fixture illustrated in FIG. 1, with the right side elevational view being identical thereto.

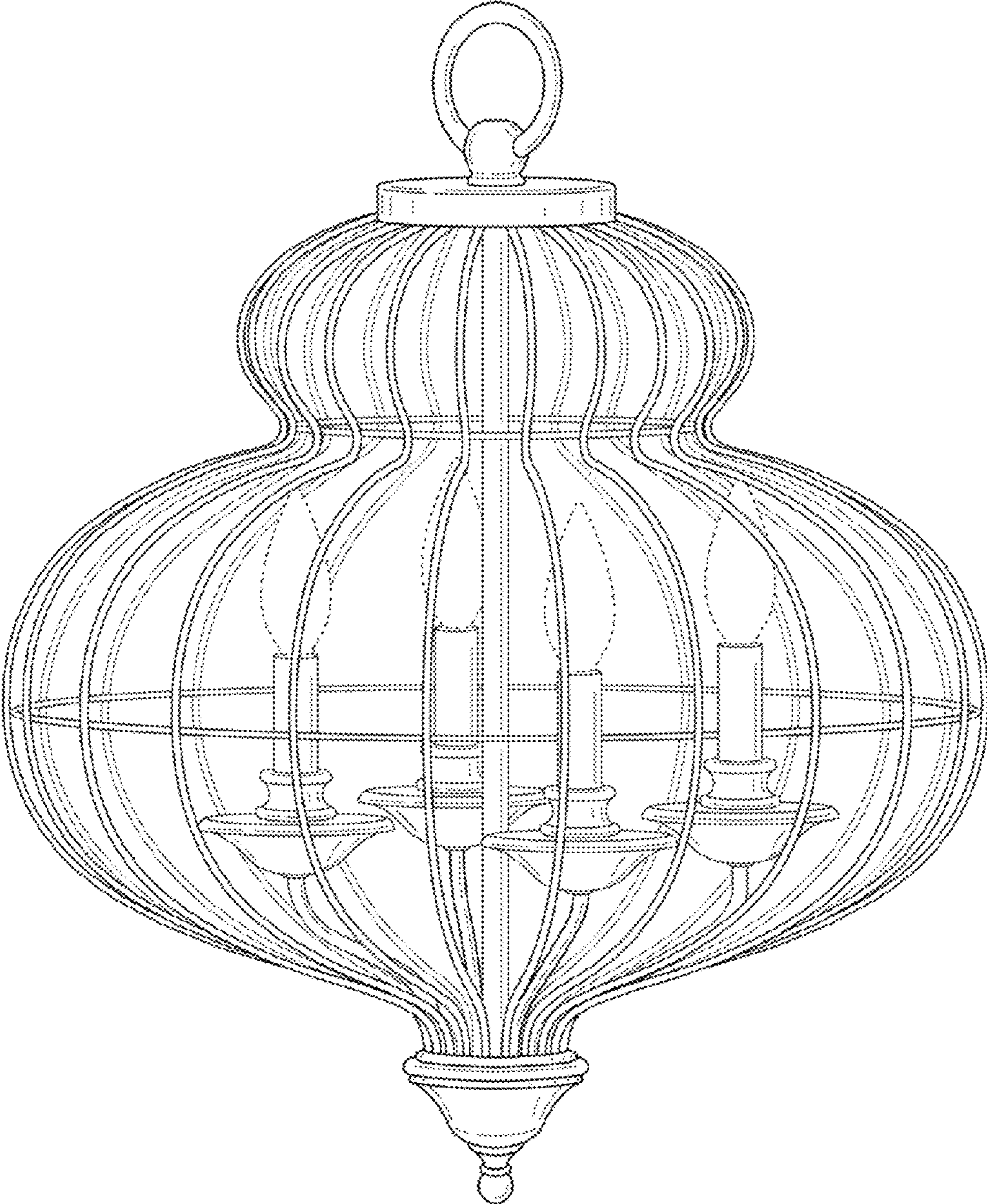

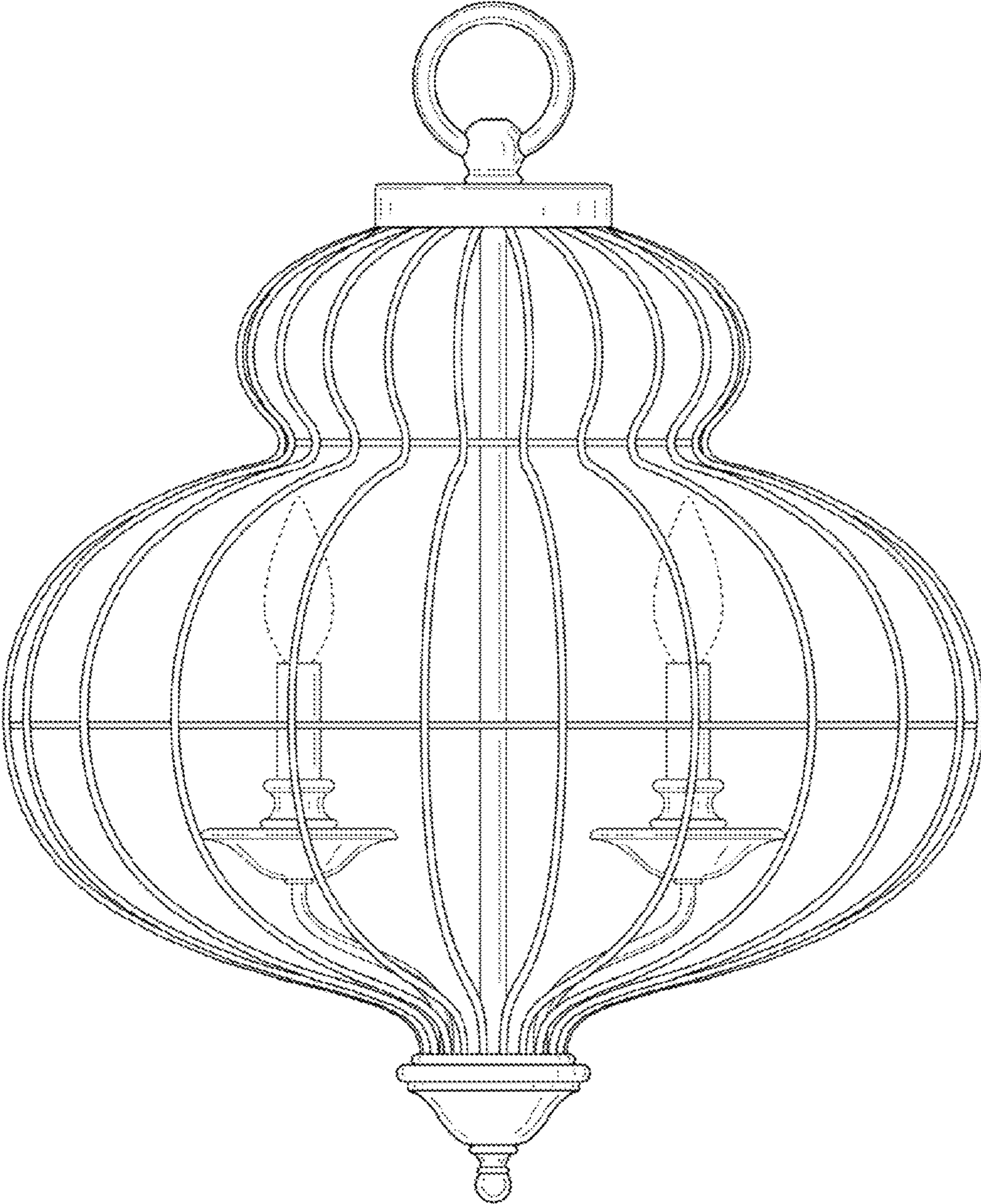

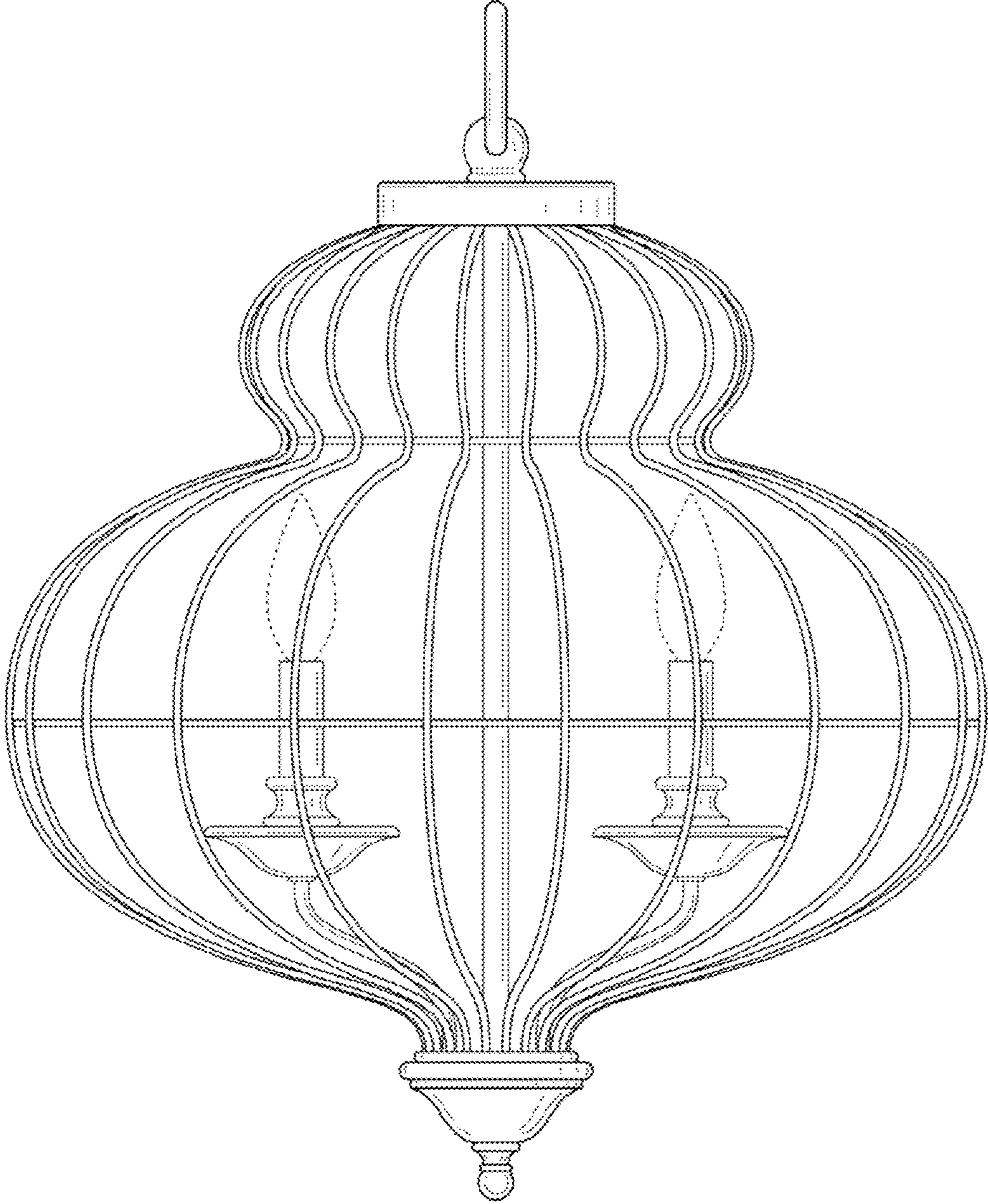

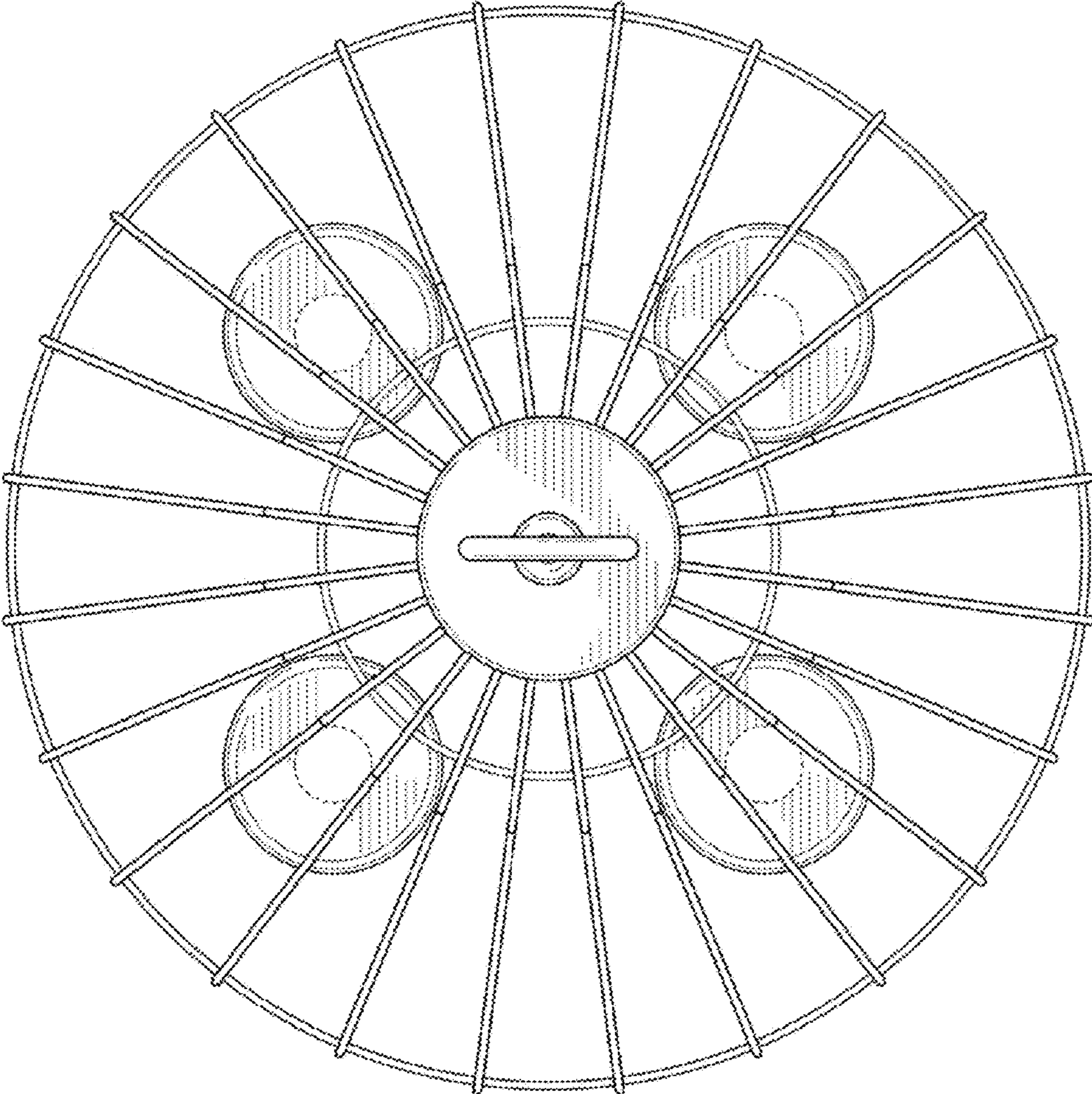

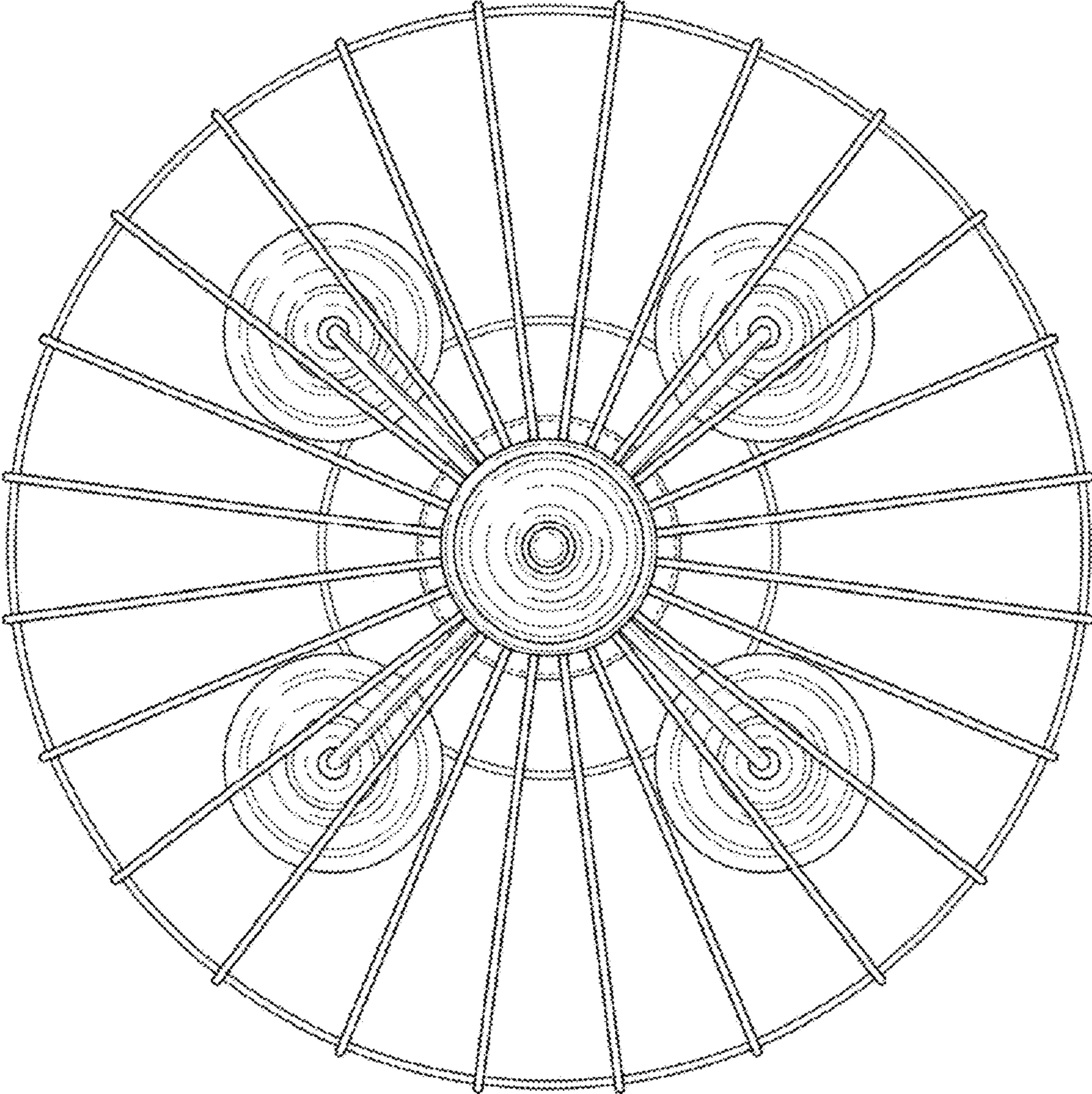
