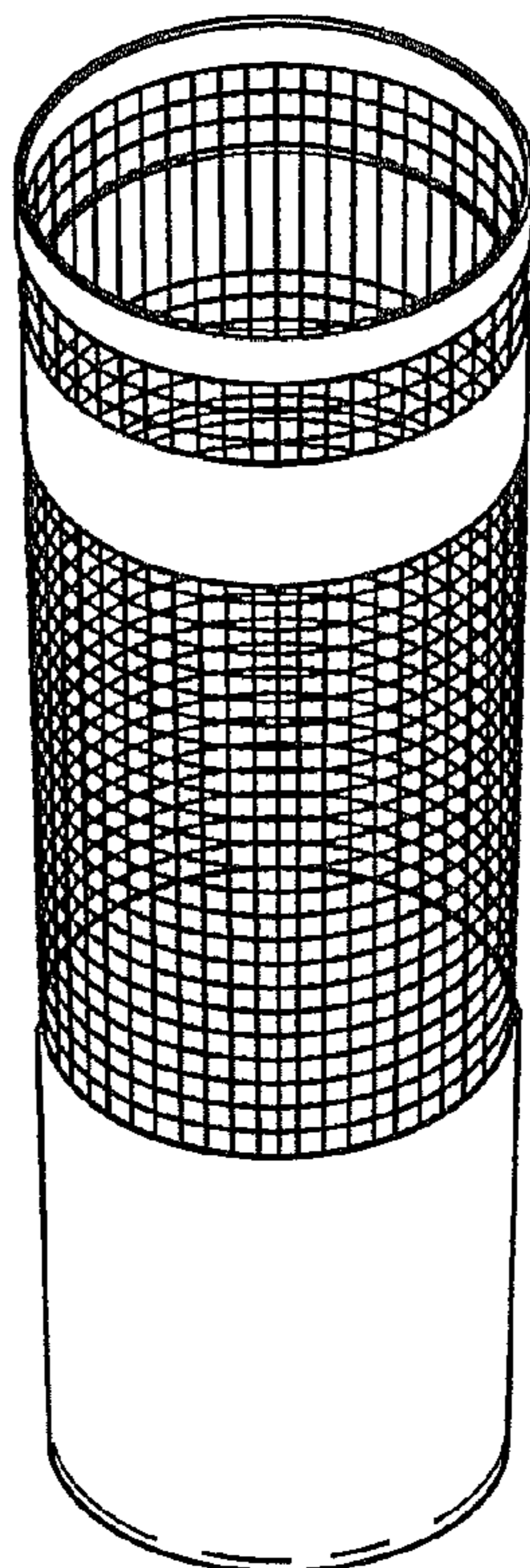
(57) **CLAIM**

The ornamental design for a receptacle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a receptacle;
FIG. 2 is a front view of the receptacle of FIG. 1, the opposite side and left and right side being identical thereof; and,
FIG. 3 is a top view of the receptacle of FIG. 1.
The bottom of the receptacle is flat and devoid of surface ornamentation.

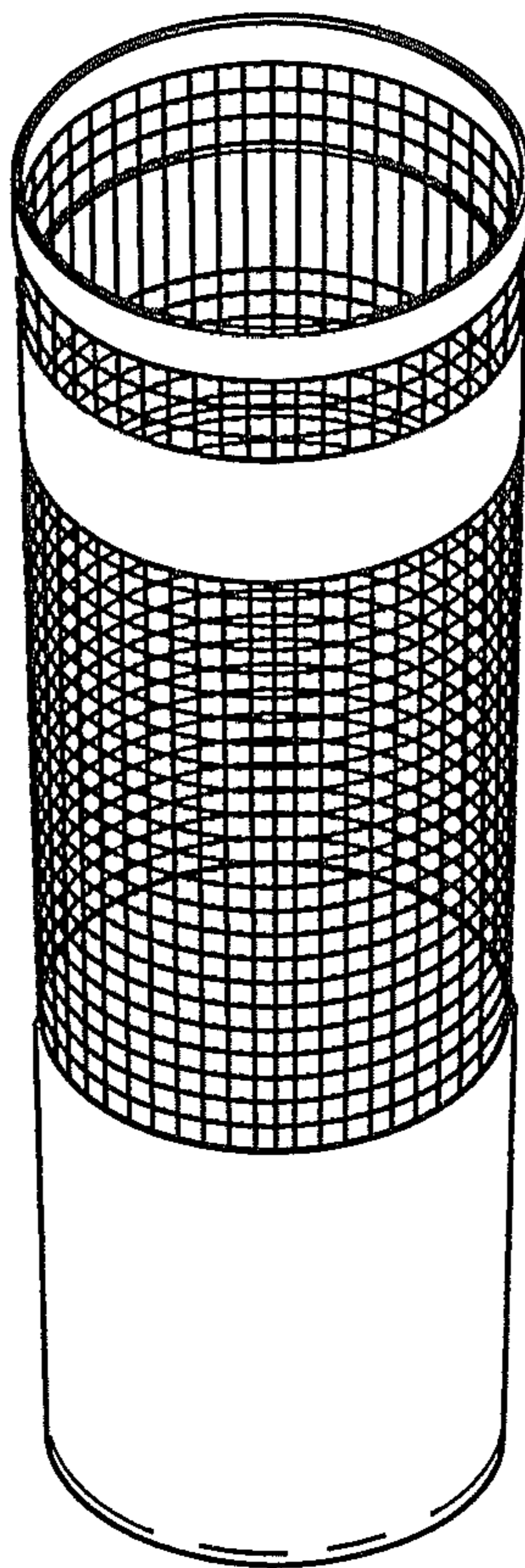

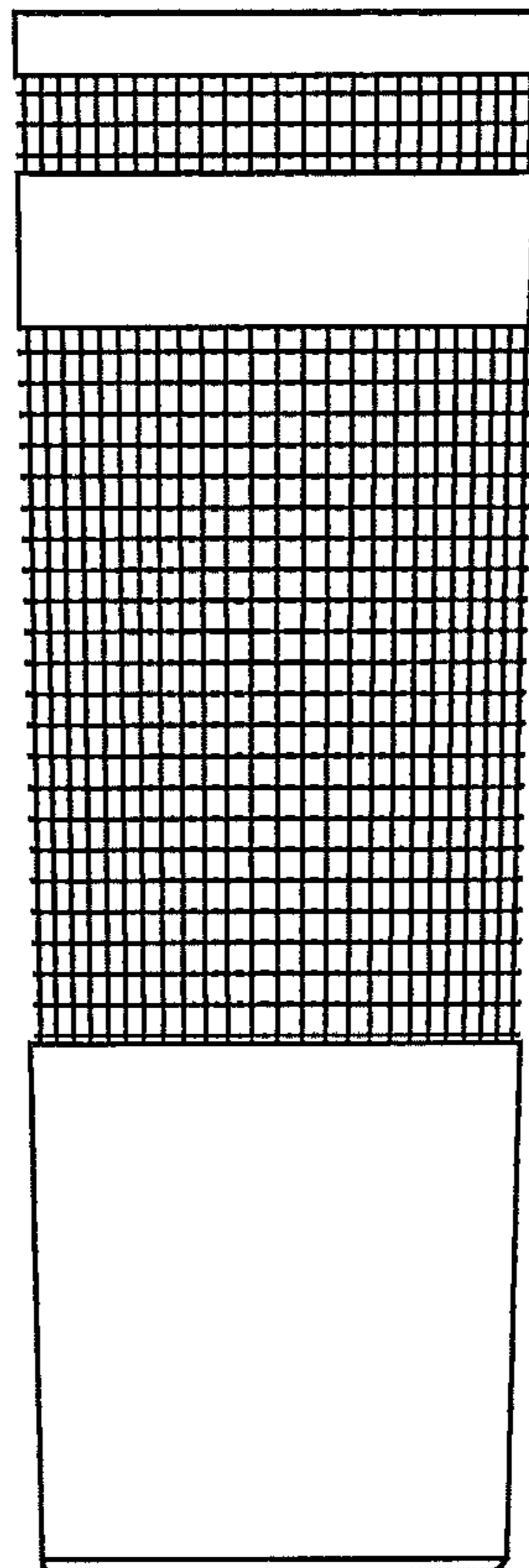

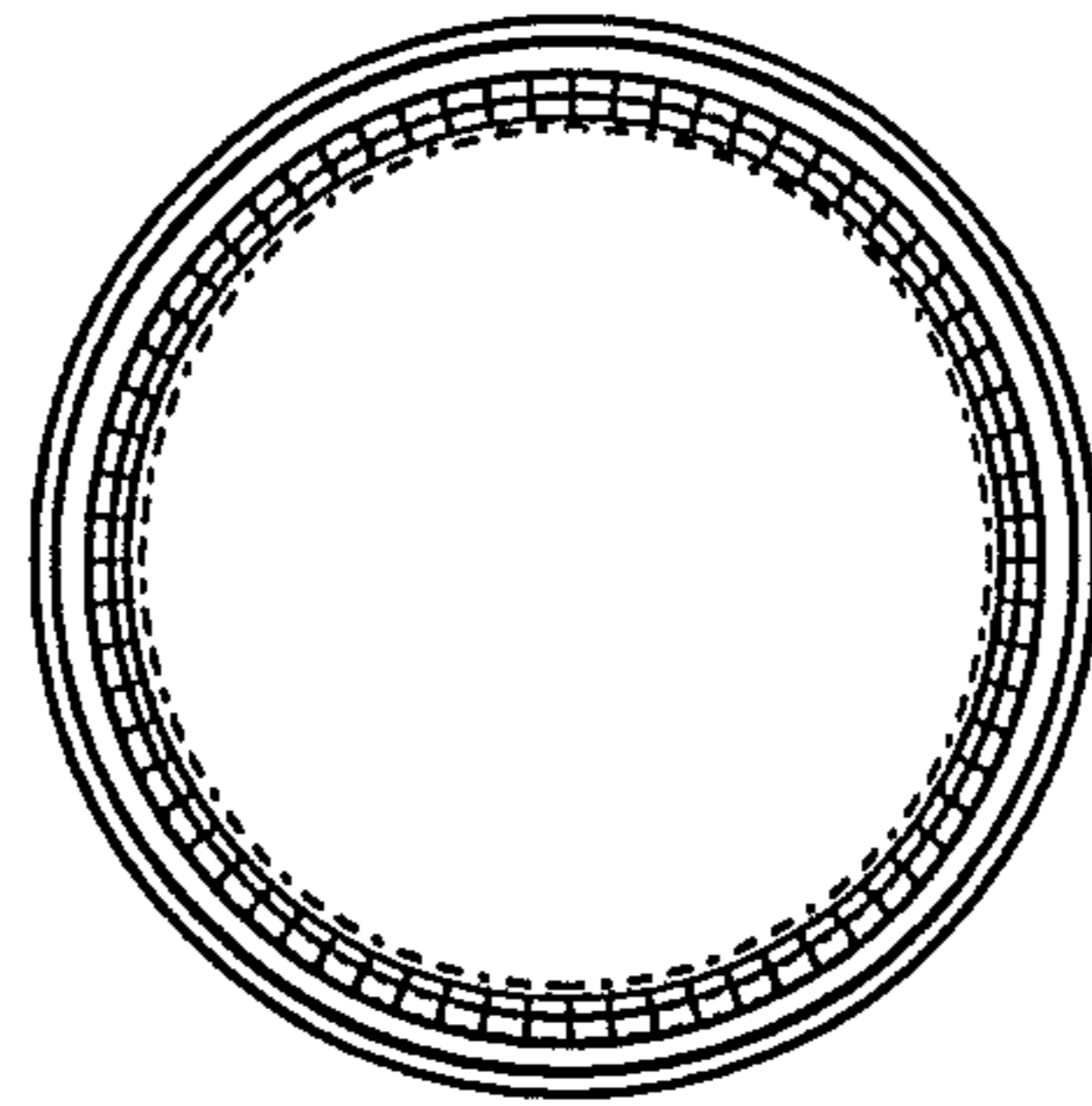
