(57) **CLAIM**

The ornamental design for a dual spout mop bucket with agitator, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a dual spout mop bucket with agitator in accordance with the present design; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The broken lines are for illustrative purposes only and form no part of the claimed design. The shading represents contour of the claimed design.

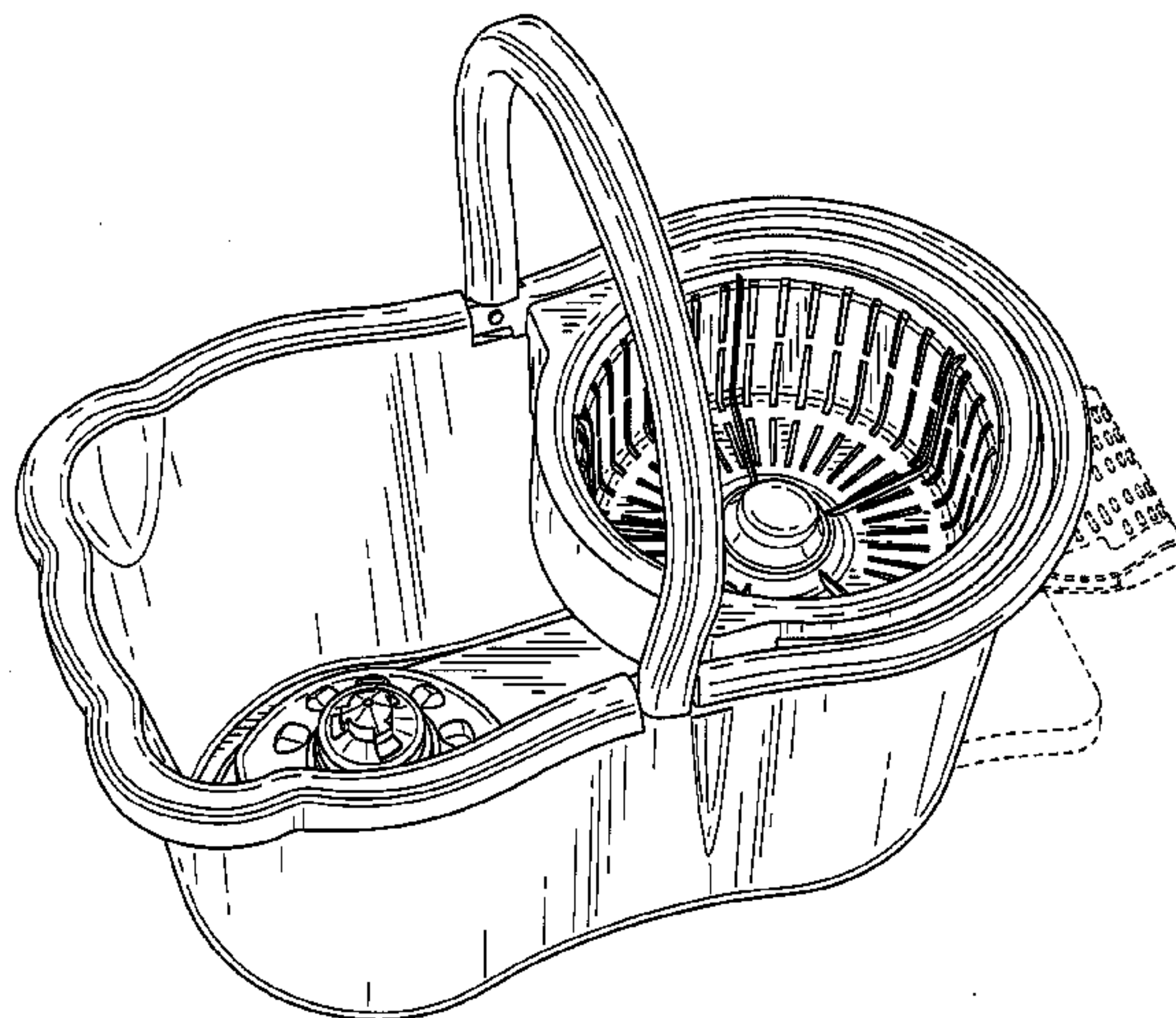

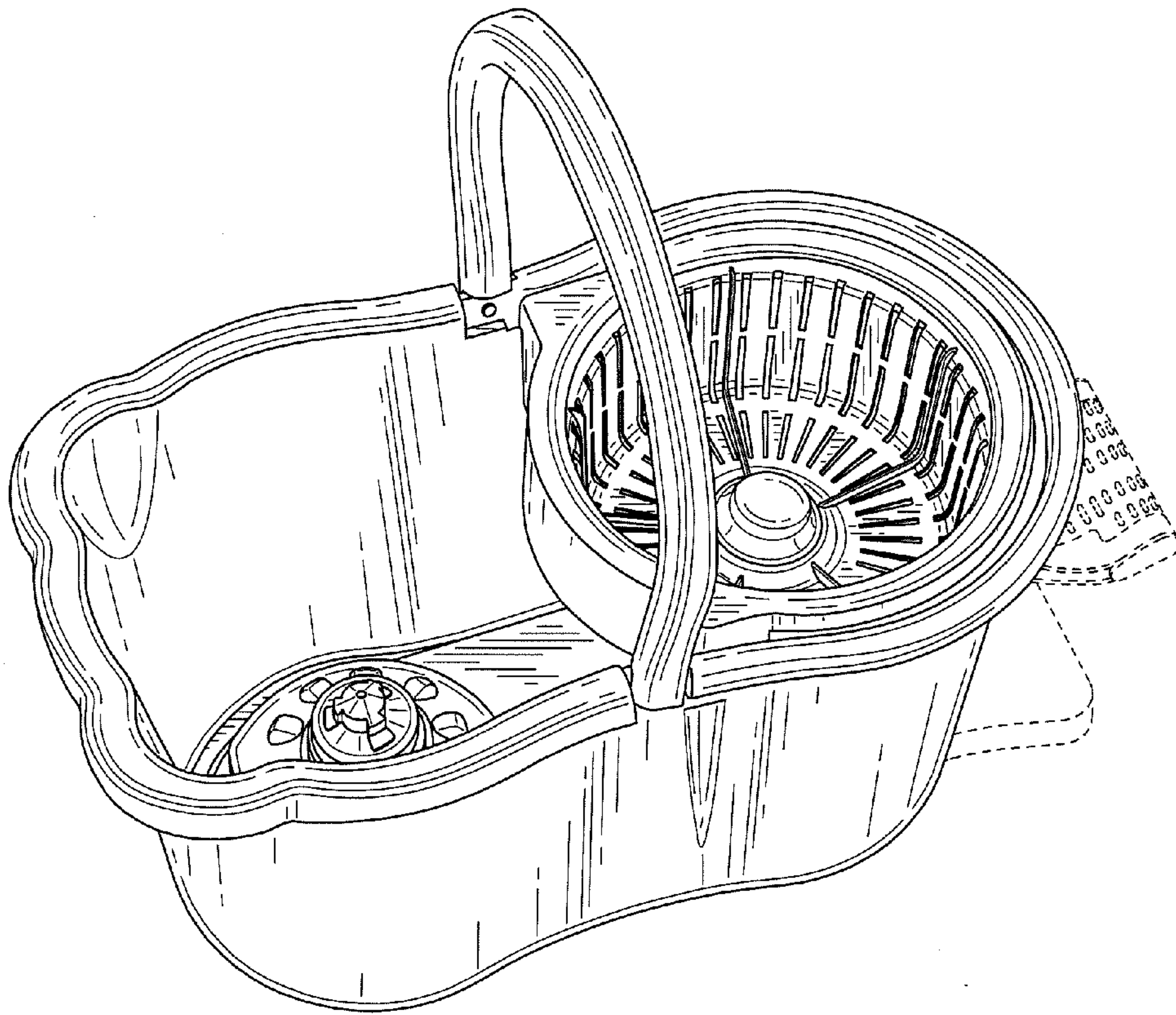

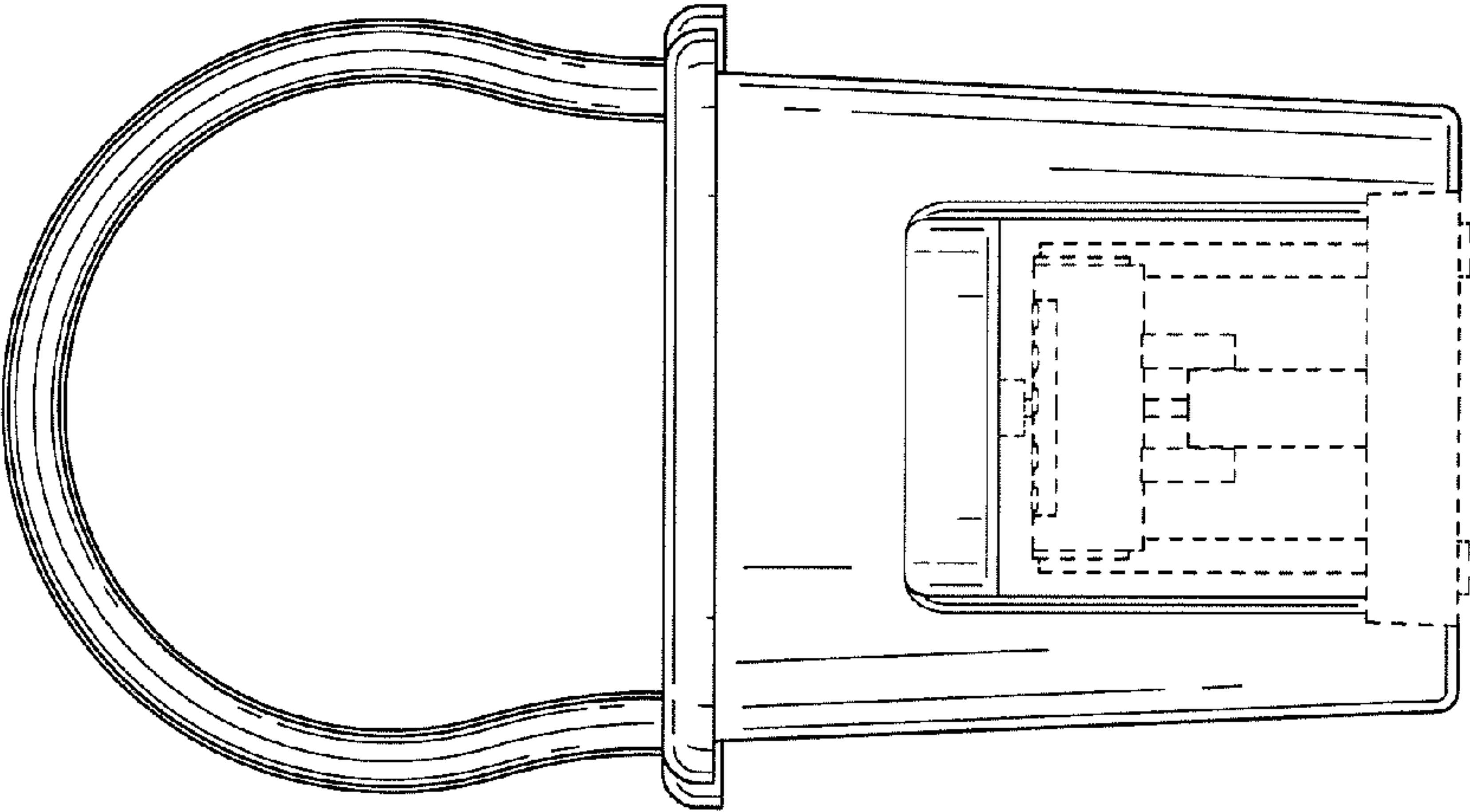

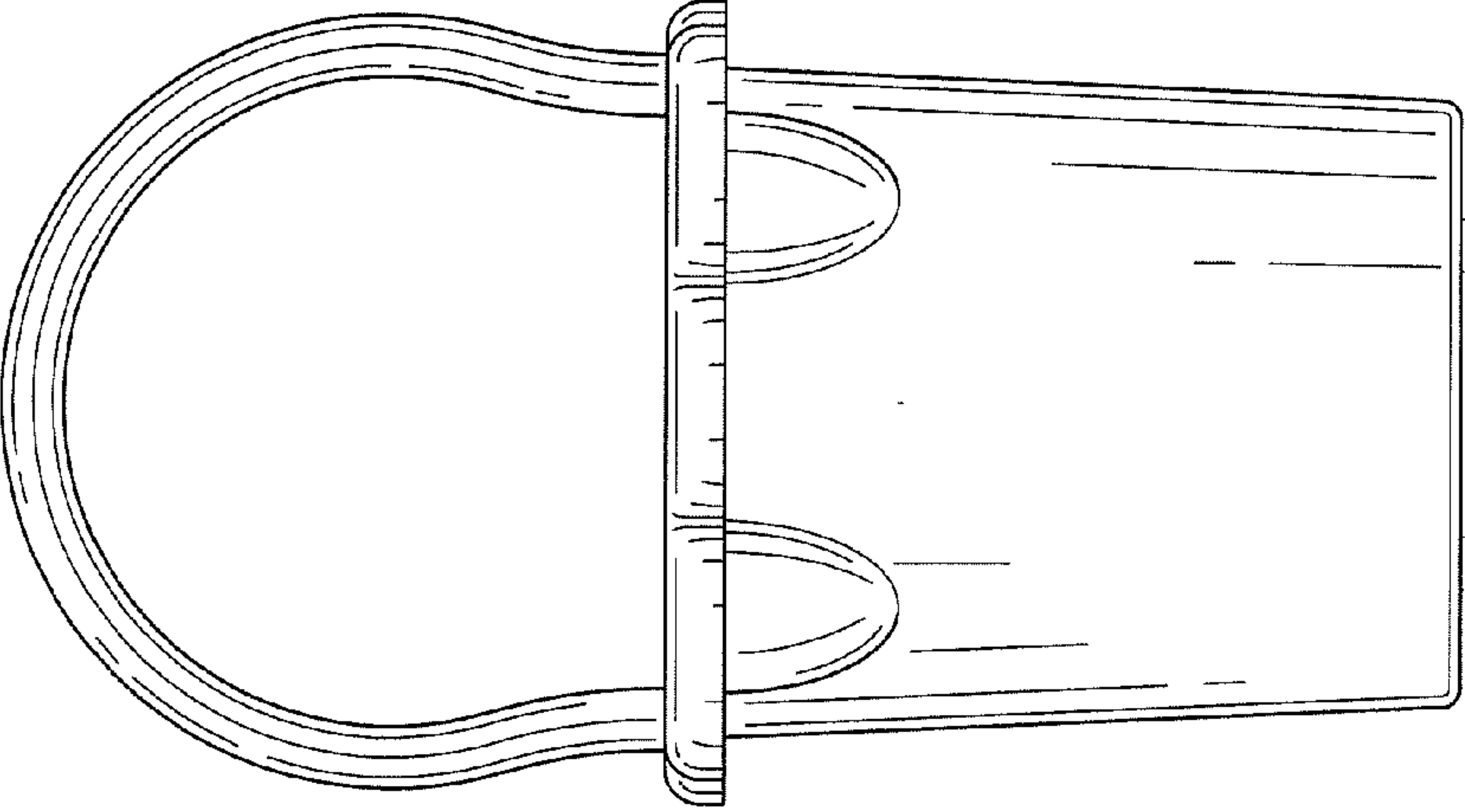

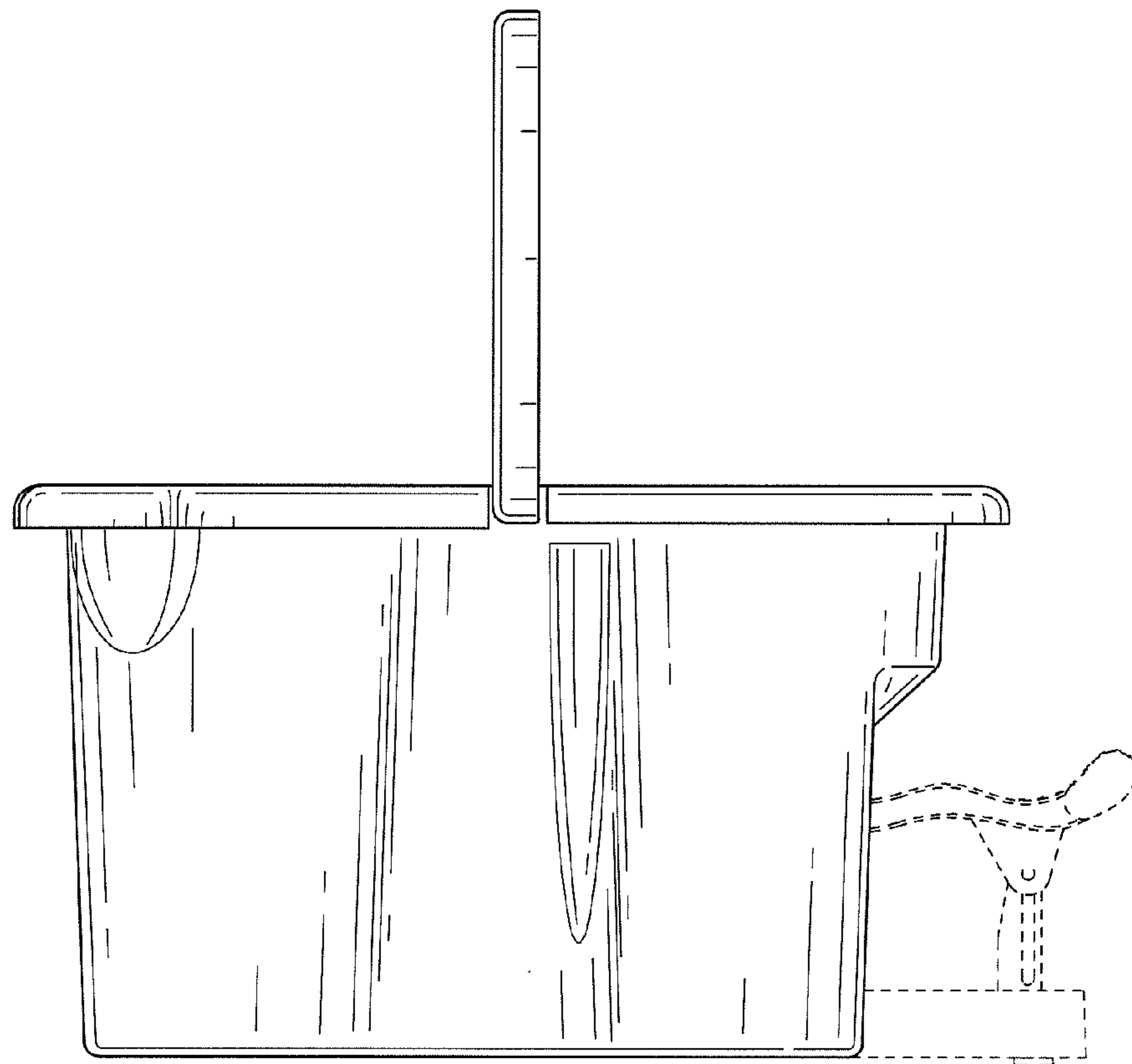

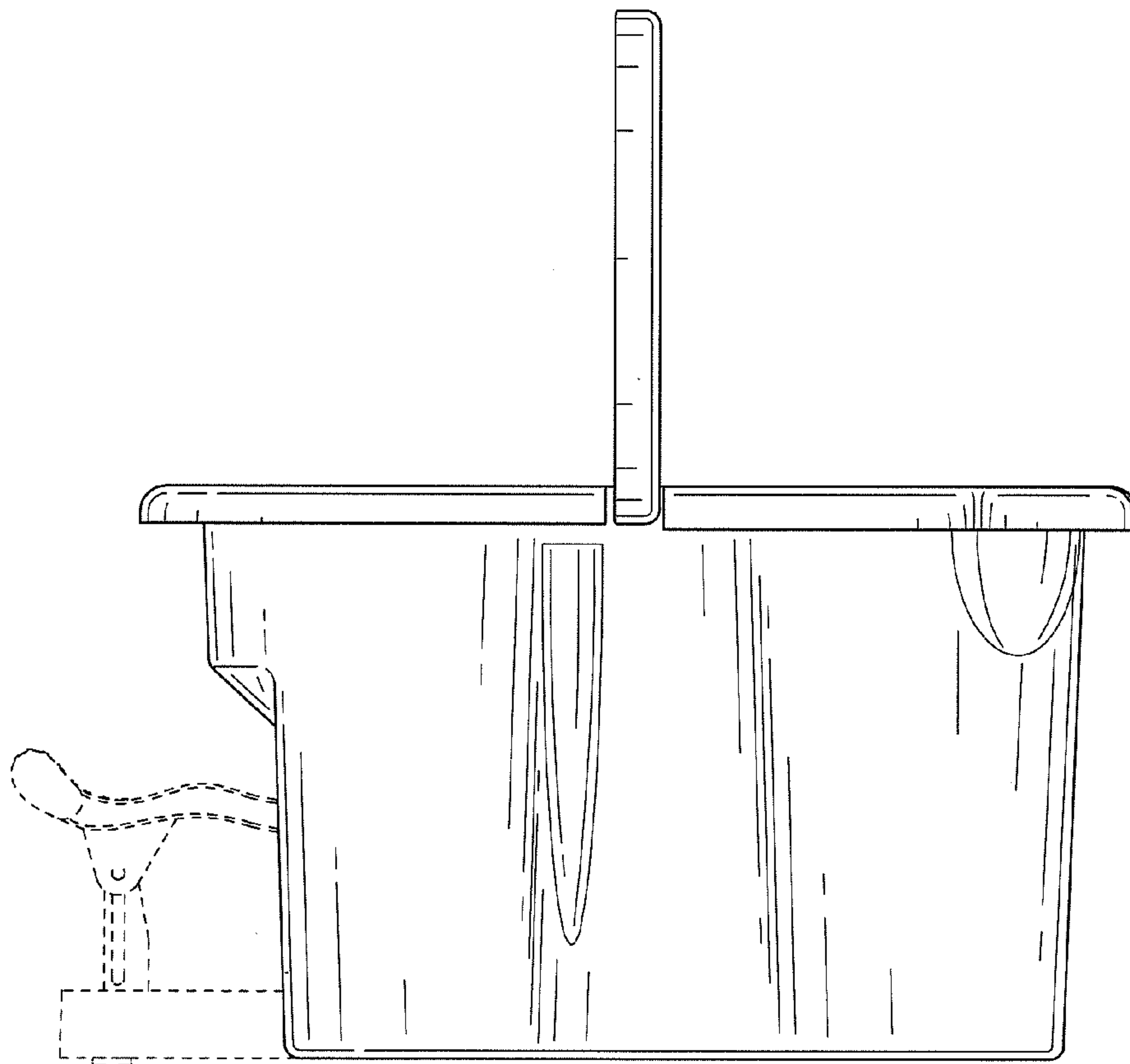

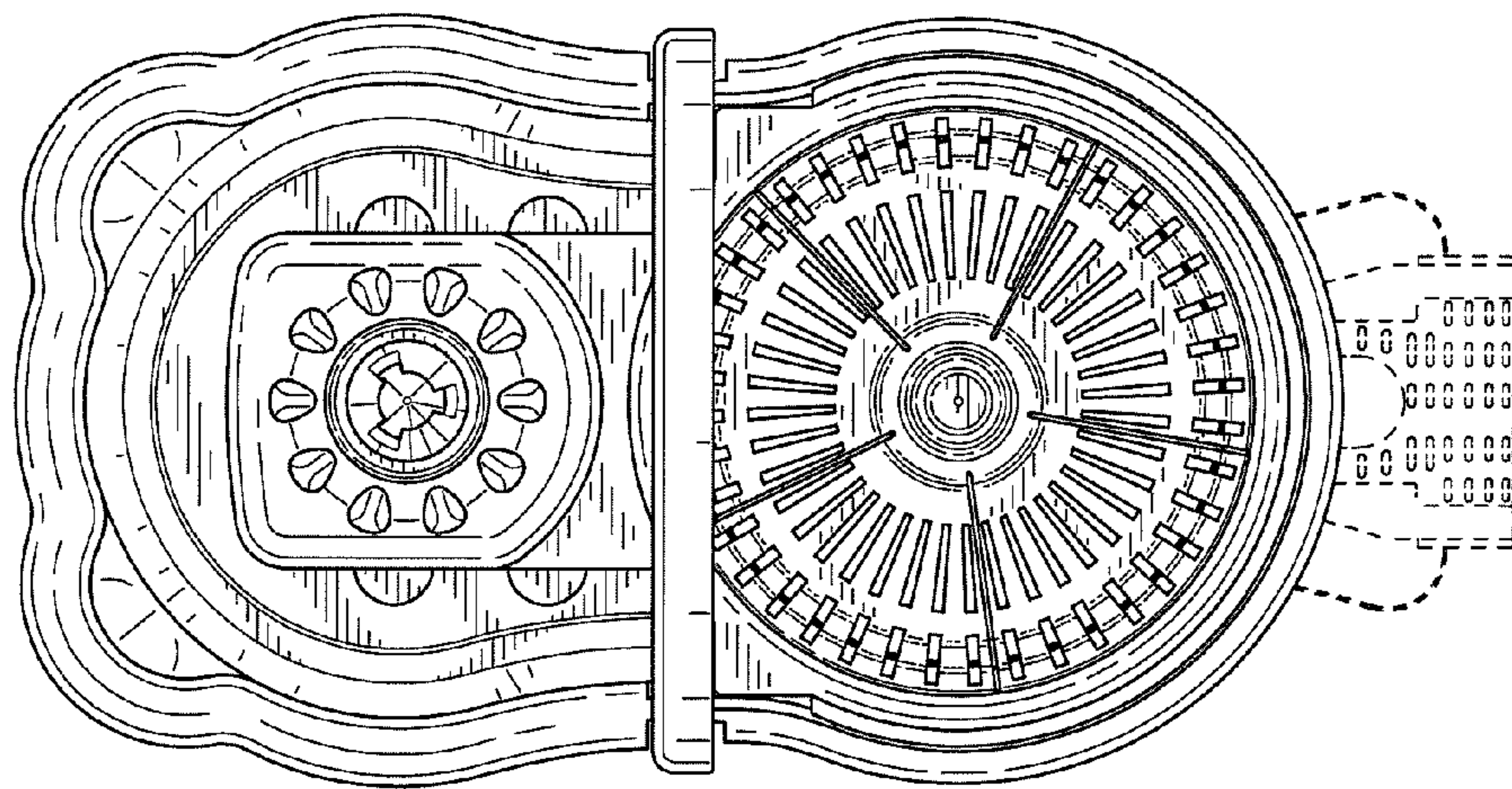
