(57) **CLAIM**

We claim the ornamental design for wafer carrier ring, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a wafer carrier ring according to an embodiment of the invention. The view from the opposite side being identical thereto.

FIG. 2 is a bottom perspective view of the wafer carrier ring depicted in FIG. 1. The view from the opposite side being identical thereto.

FIG. 3 is a top plan view of the wafer carrier ring.

FIG. 4 is a bottom plan view of the wafer carrier ring.

FIG. 5 is a front elevational view of the wafer carrier ring.

FIG. 6 is a side elevational view of the wafer carrier ring.

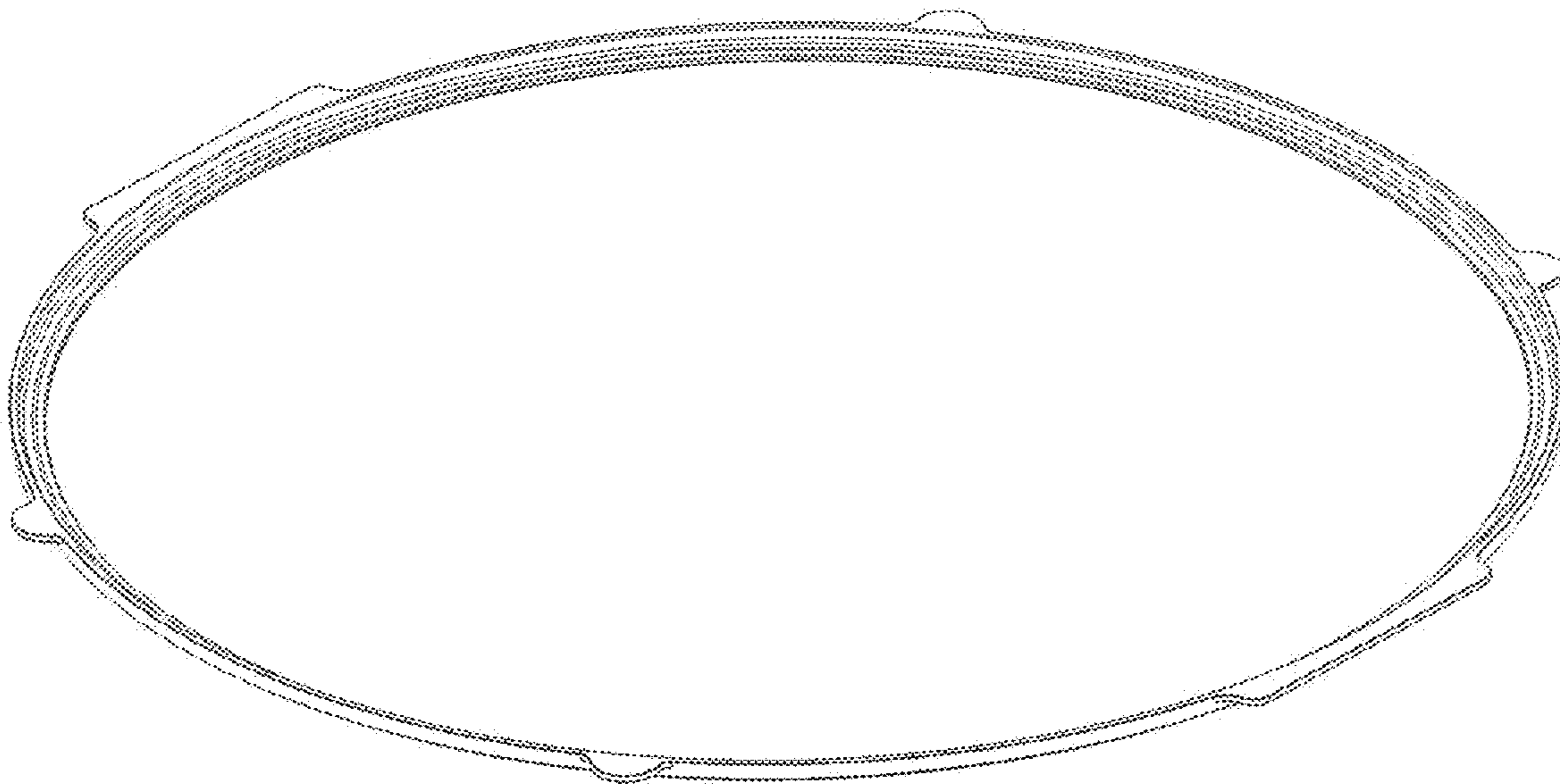
FIG. 7 is a cross sectional view taken at line 7-7 of FIG. 4.

FIG. 8 is a cross sectional view taken at line 8-8 of FIG. 4.

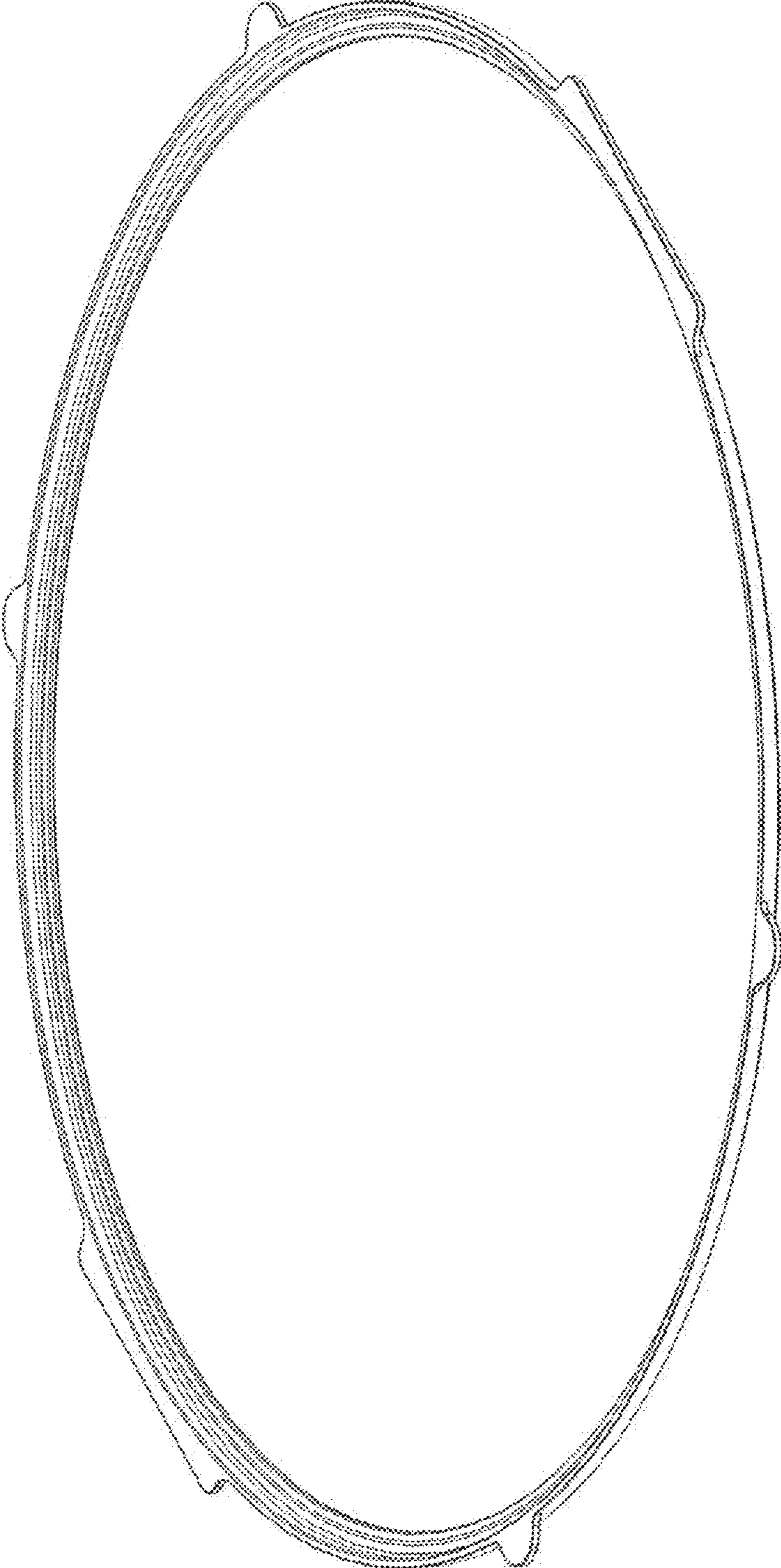

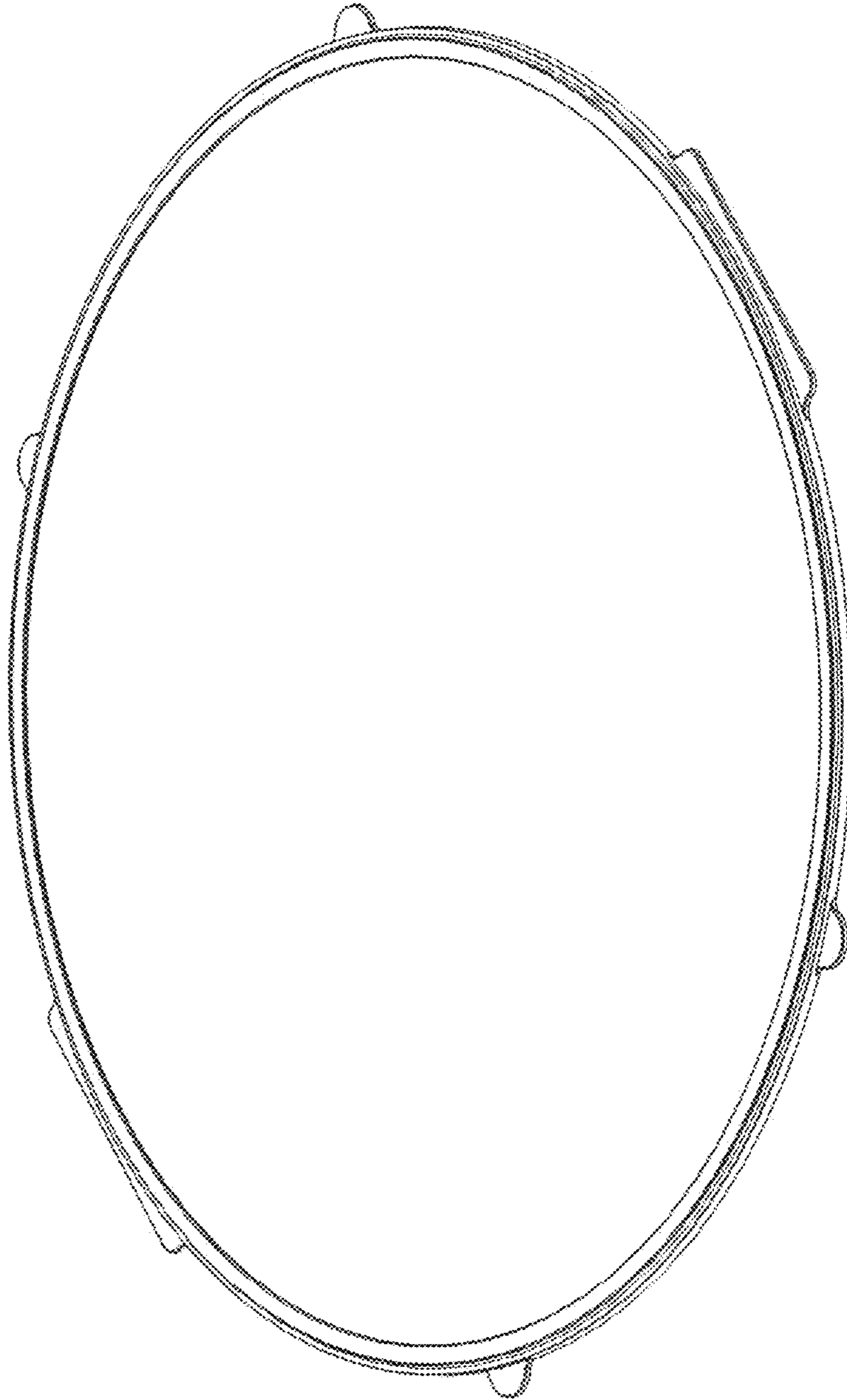

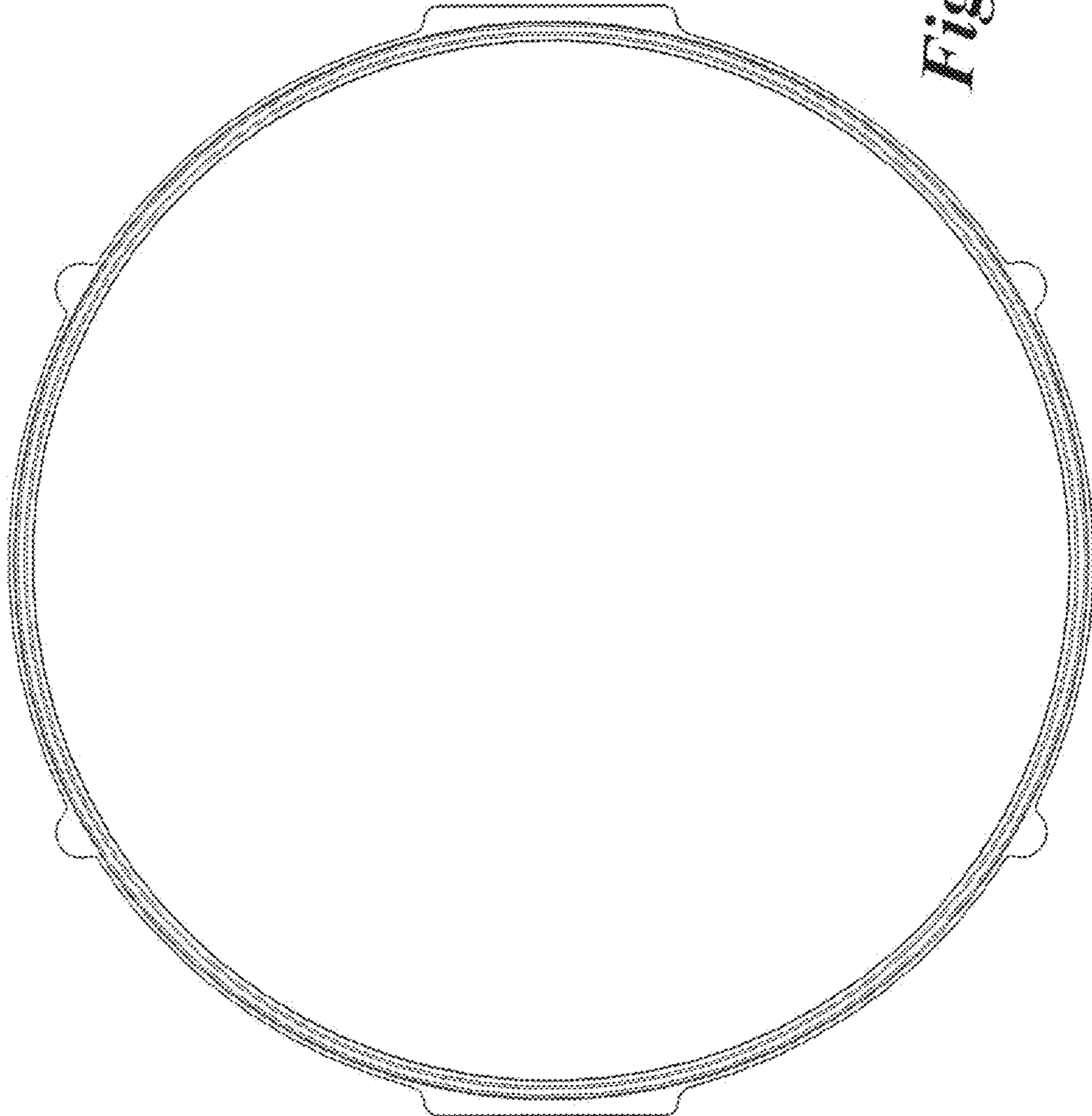

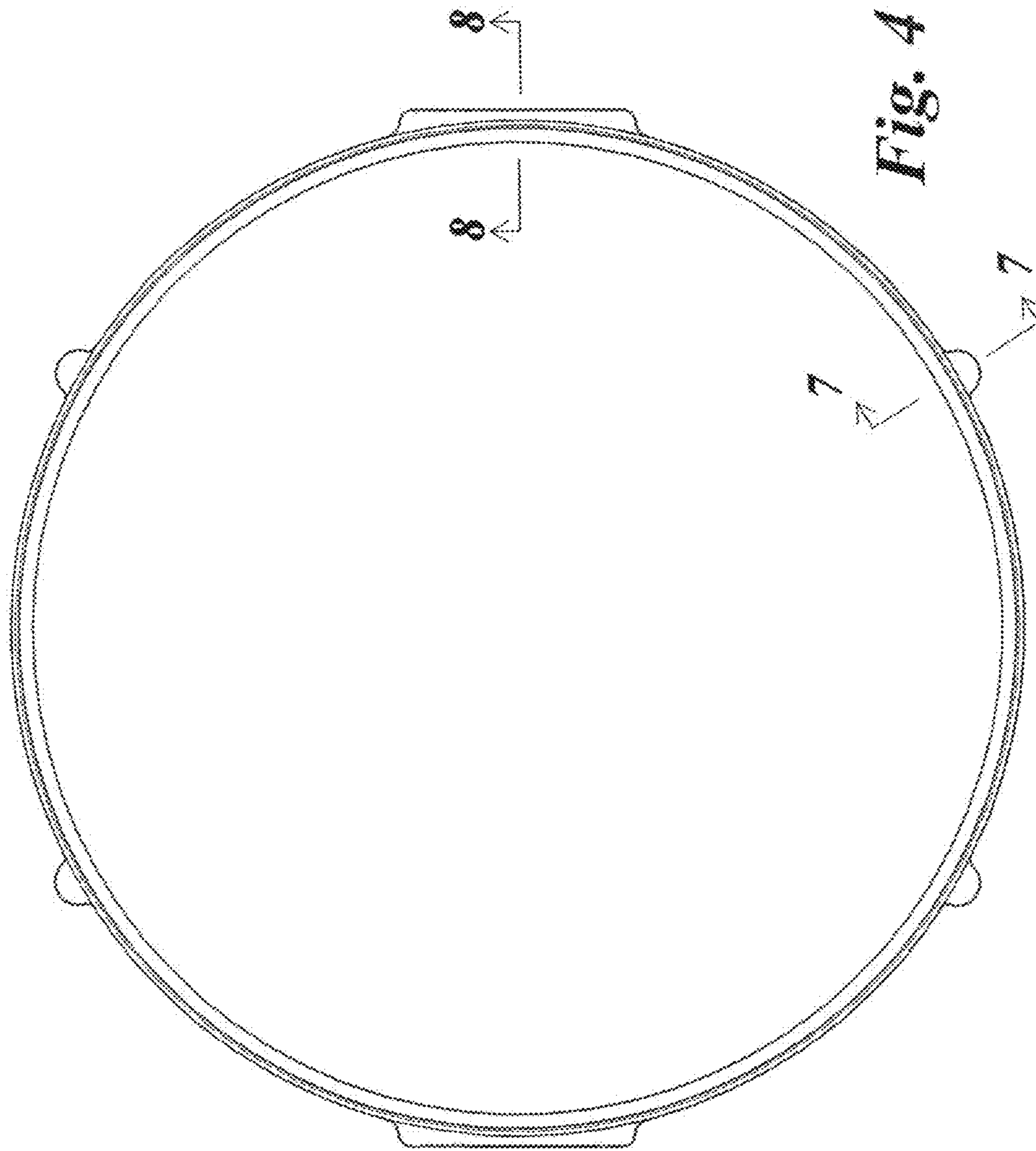

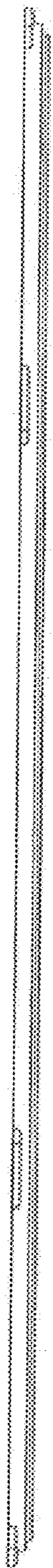

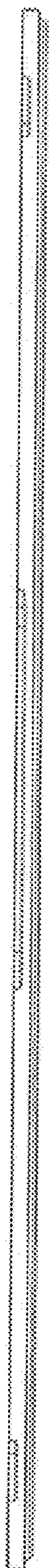

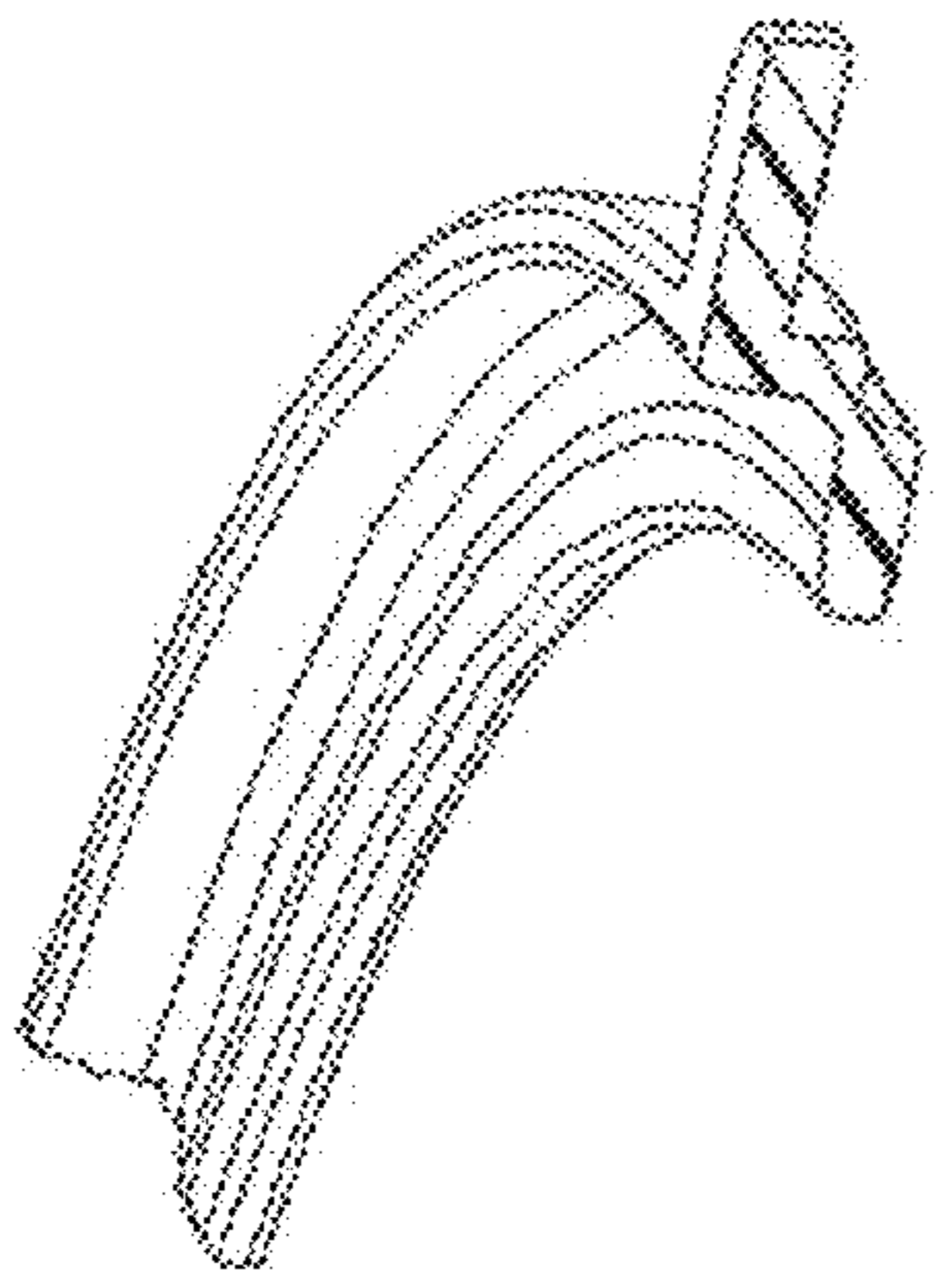
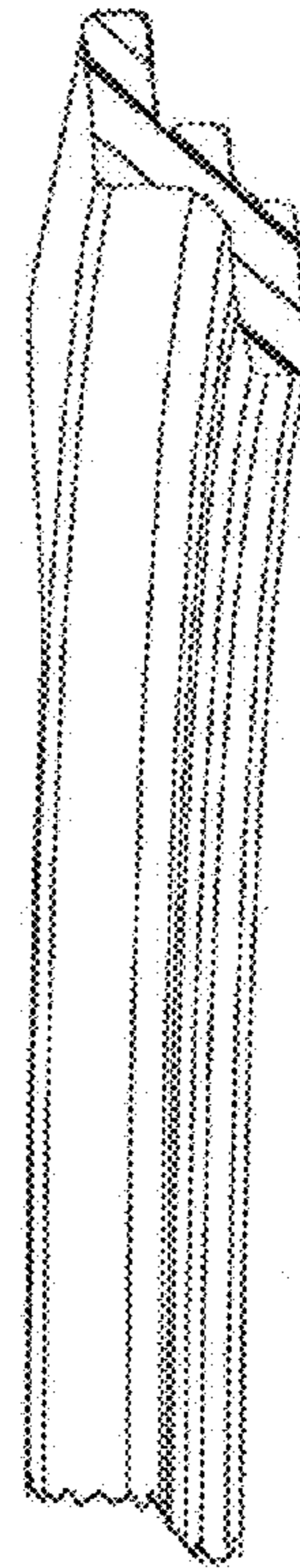

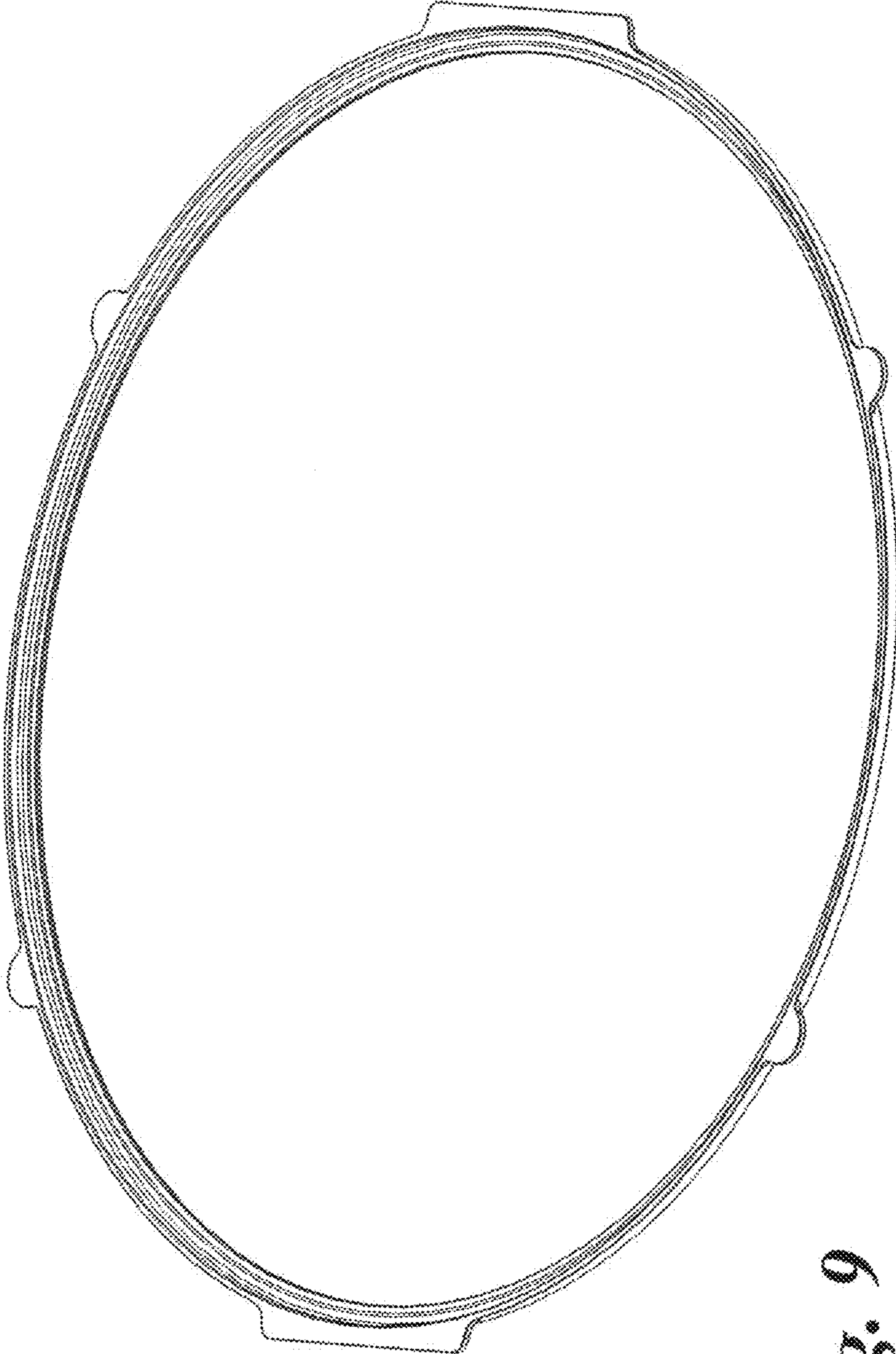

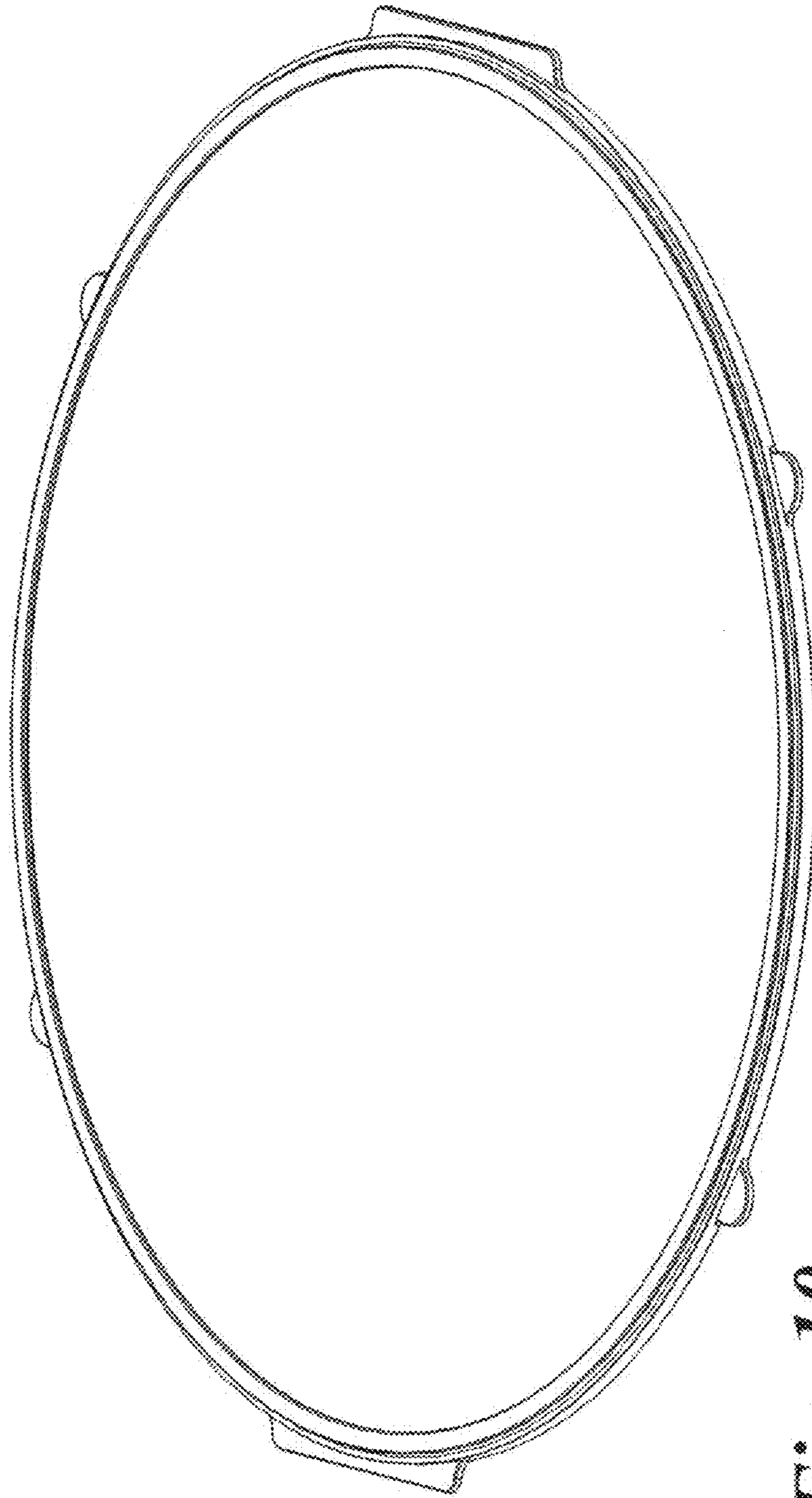
