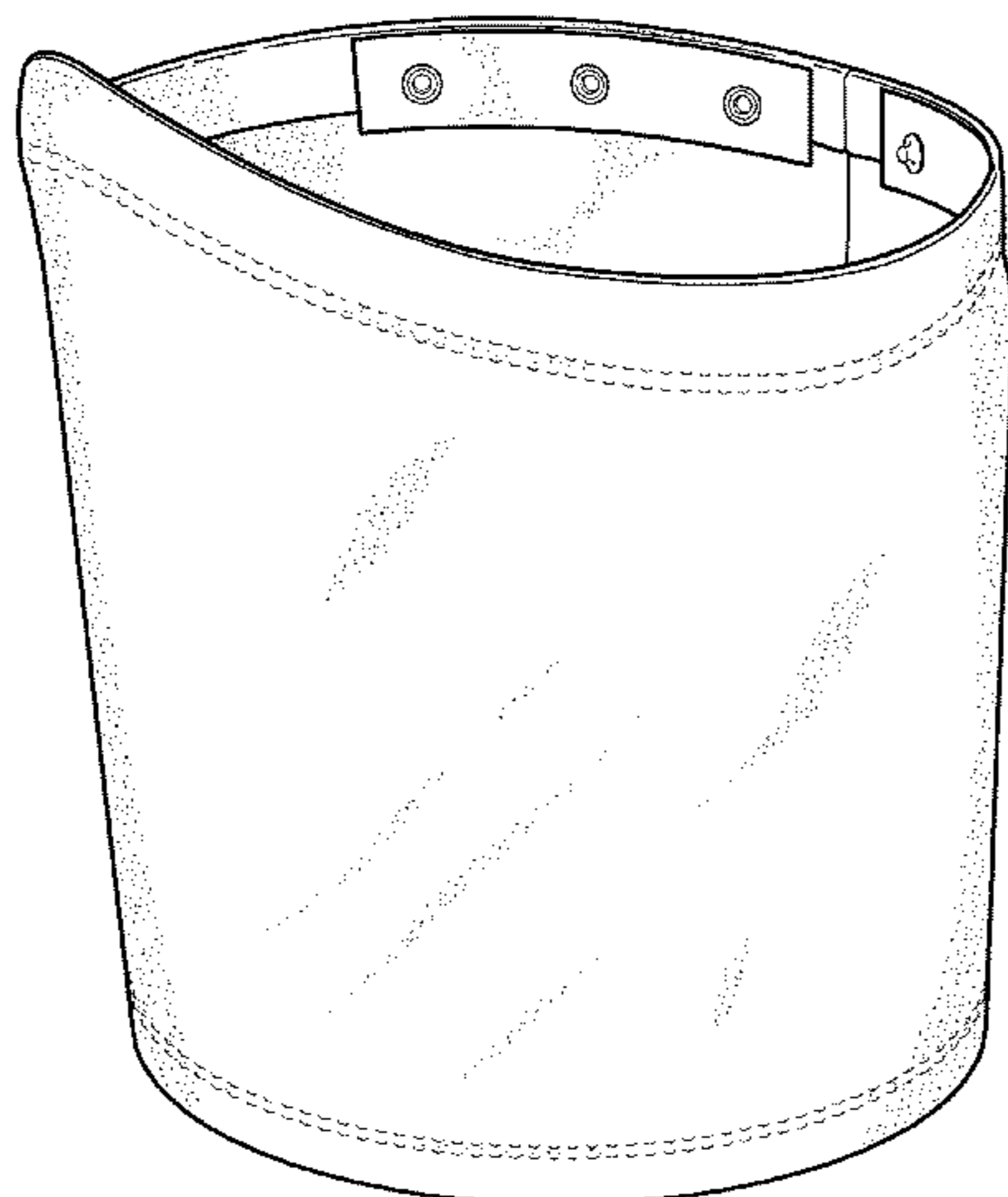
(57) **CLAIM**

I claim the ornamental design for an adjustable wrap, as shown and described.

DESCRIPTION

FIG. 1 is a top, right perspective view of an adjustable wrap as described herein;
 FIG. 2 is a front side view thereof.
 FIG. 3 is a back side view thereof.
 FIG. 4 is a left side view thereof.
 FIG. 5 is a right side view thereof.
 FIG. 6 is a top side view thereof.
 FIG. 7 is a bottom side view thereof.
 FIG. 8 is a perspective view of an adjustable wrap in a position of use as worn by a person;
 FIG. 9 is a perspective view of an adjustable wrap in an alternate position of use as worn by a person;
 FIG. 10 perspective view of an adjustable wrap in a second alternate position of use as worn by a person; and,
 FIG. 11 perspective view of an adjustable wrap in a third alternate position of use as worn by a person.
 In FIGS. 1-5, 8 and 11, the broken-dash lines on the surface of the adjustable wrap represent stitching. In FIGS. 8-11, the dot-dashed broken lines represent a person wearing the adjustable wrap and form no part of the claimed design.

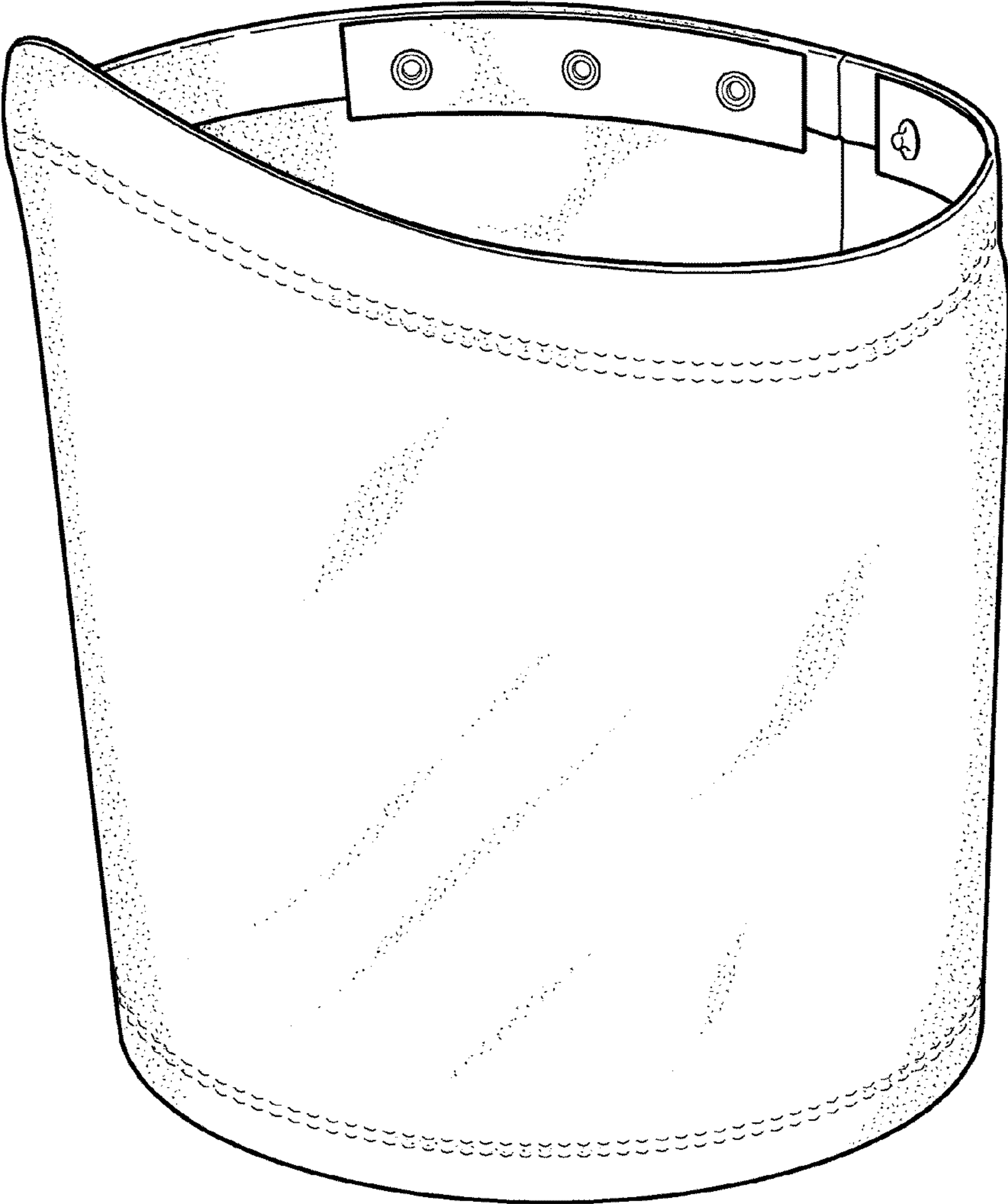

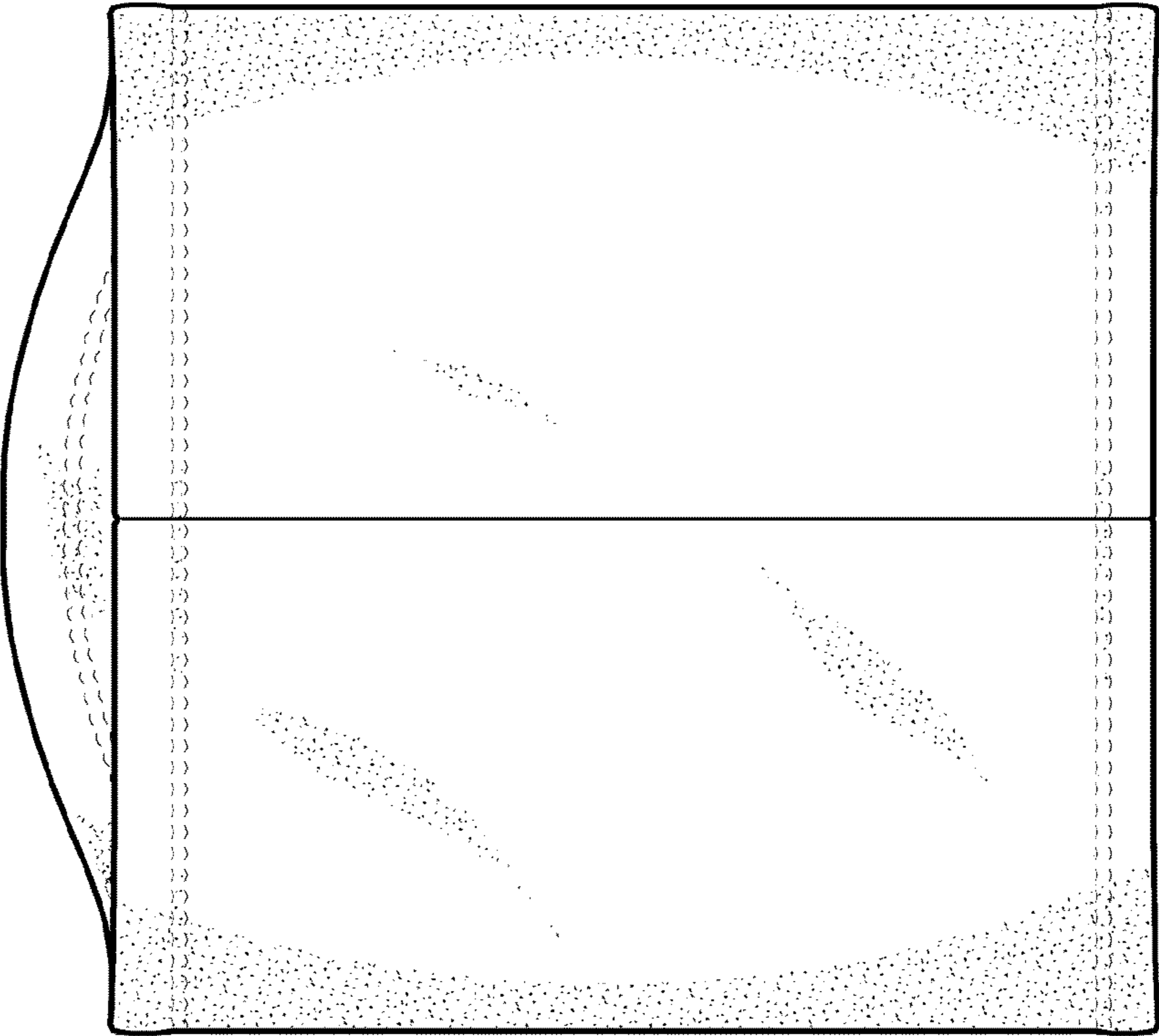

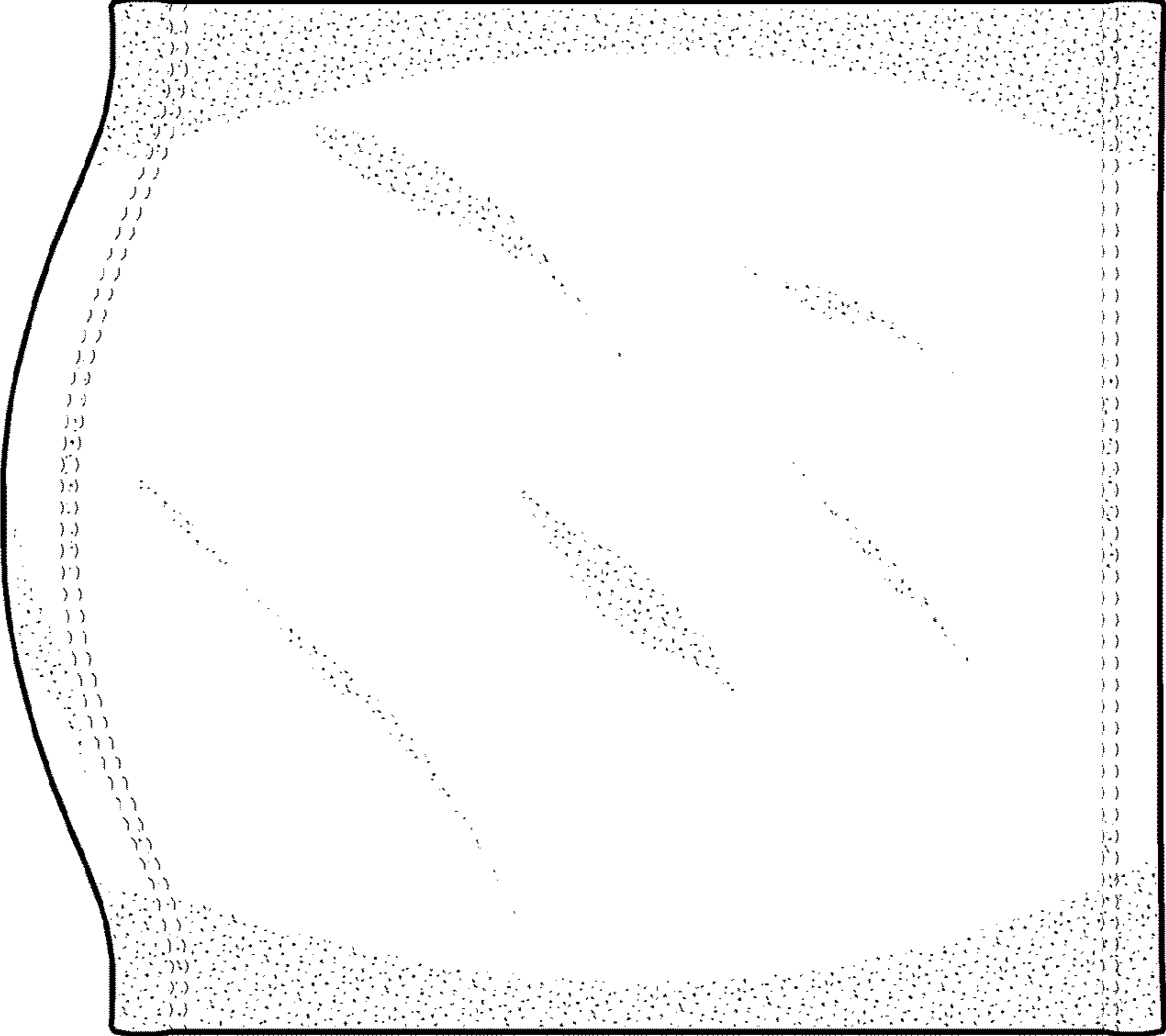

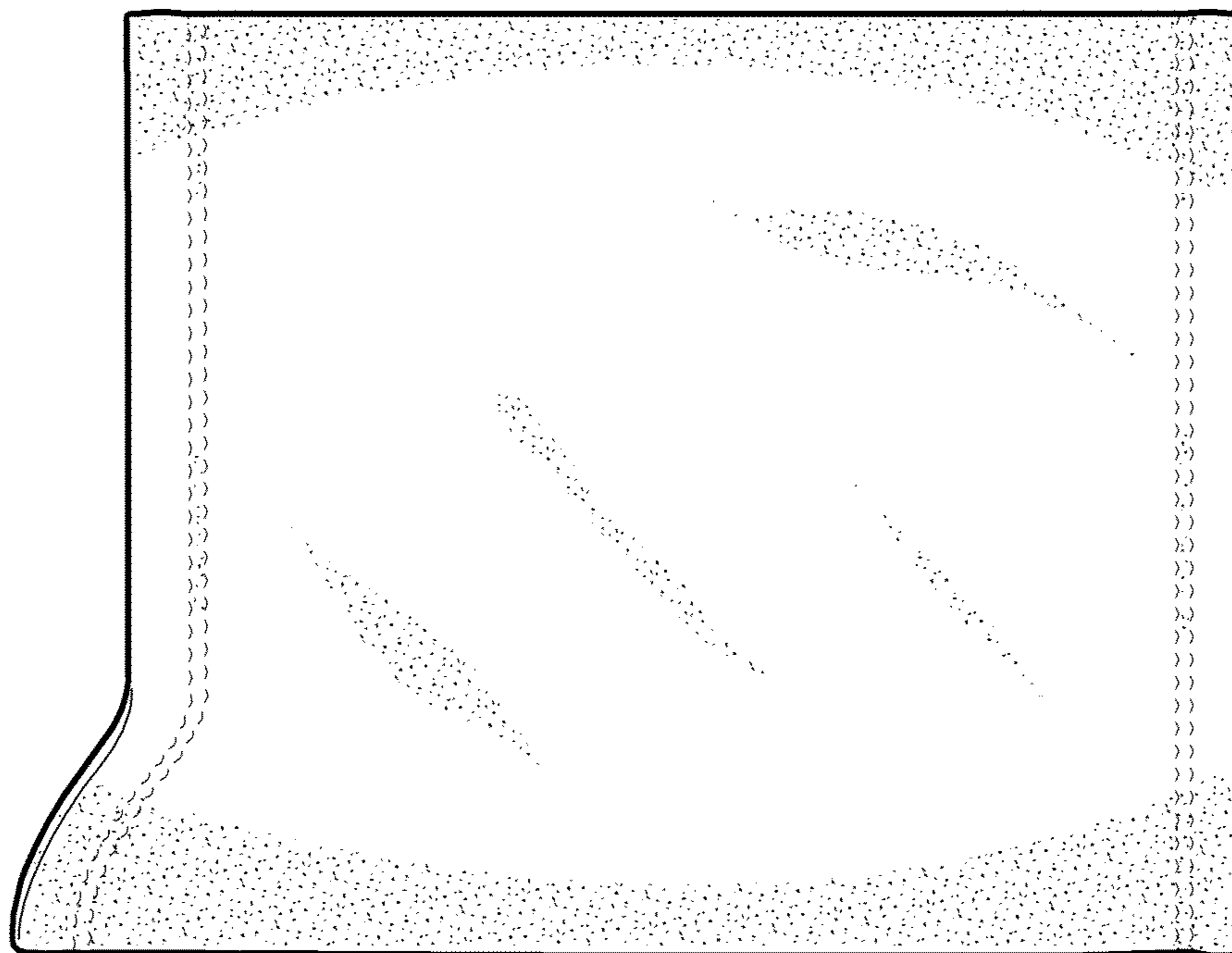

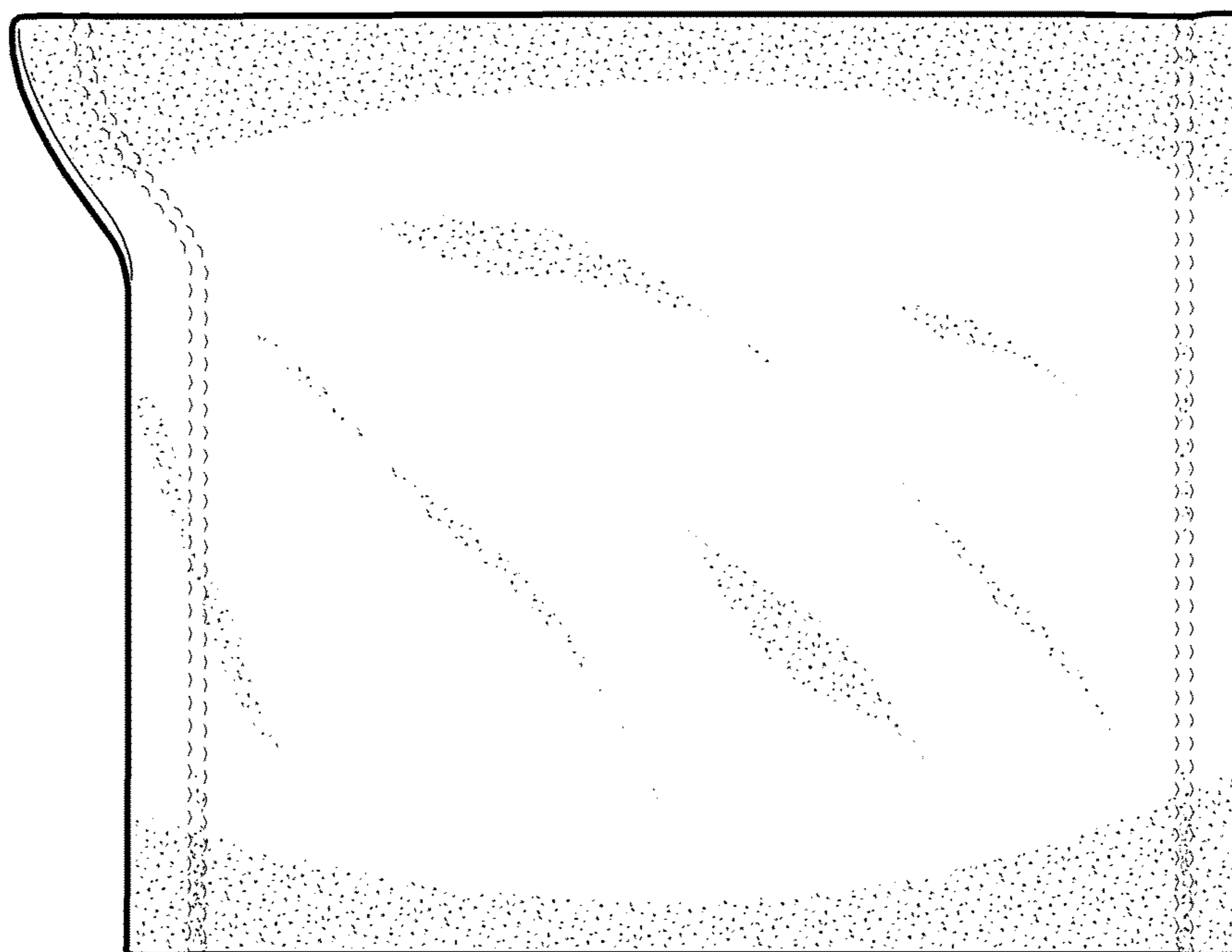

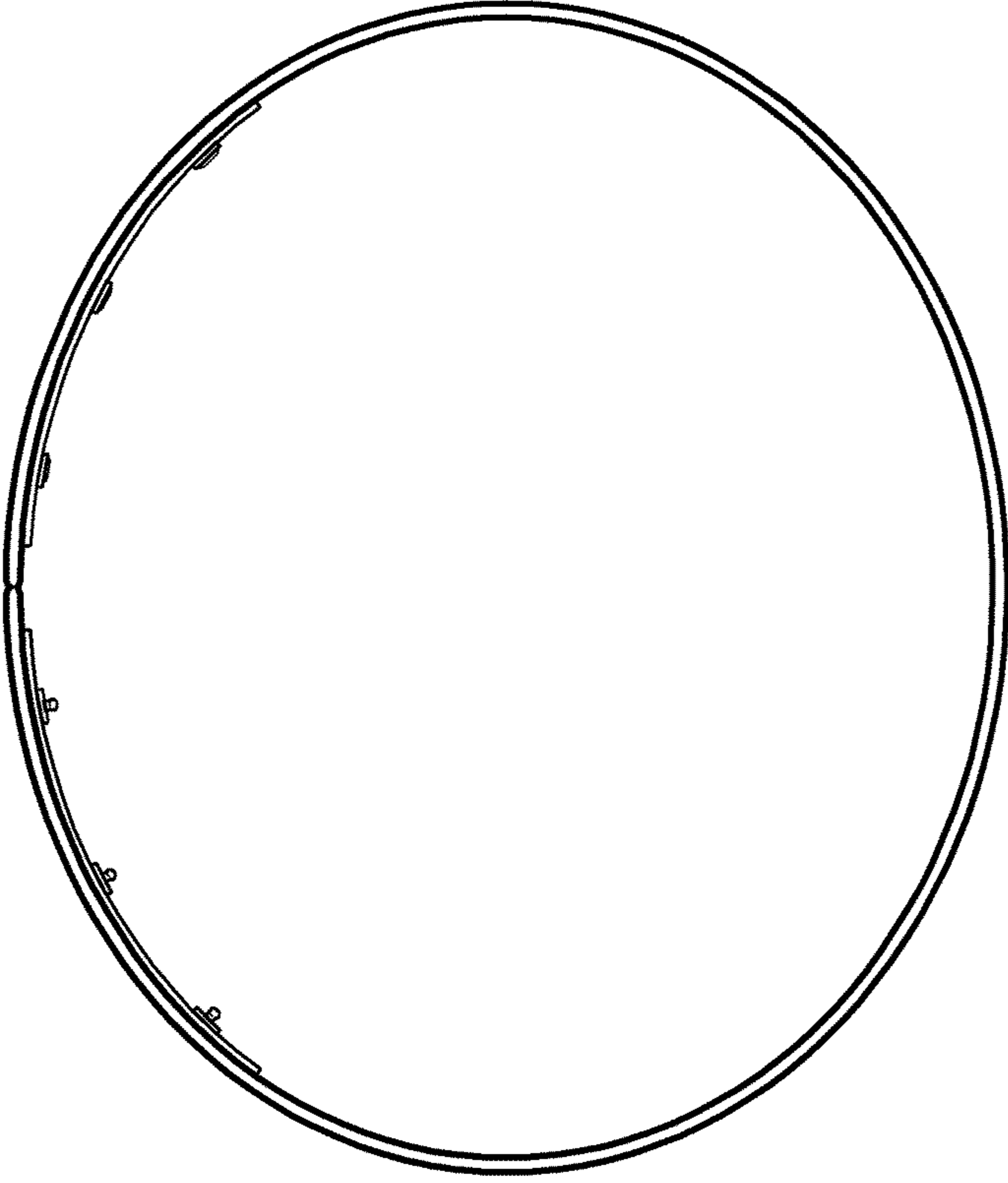

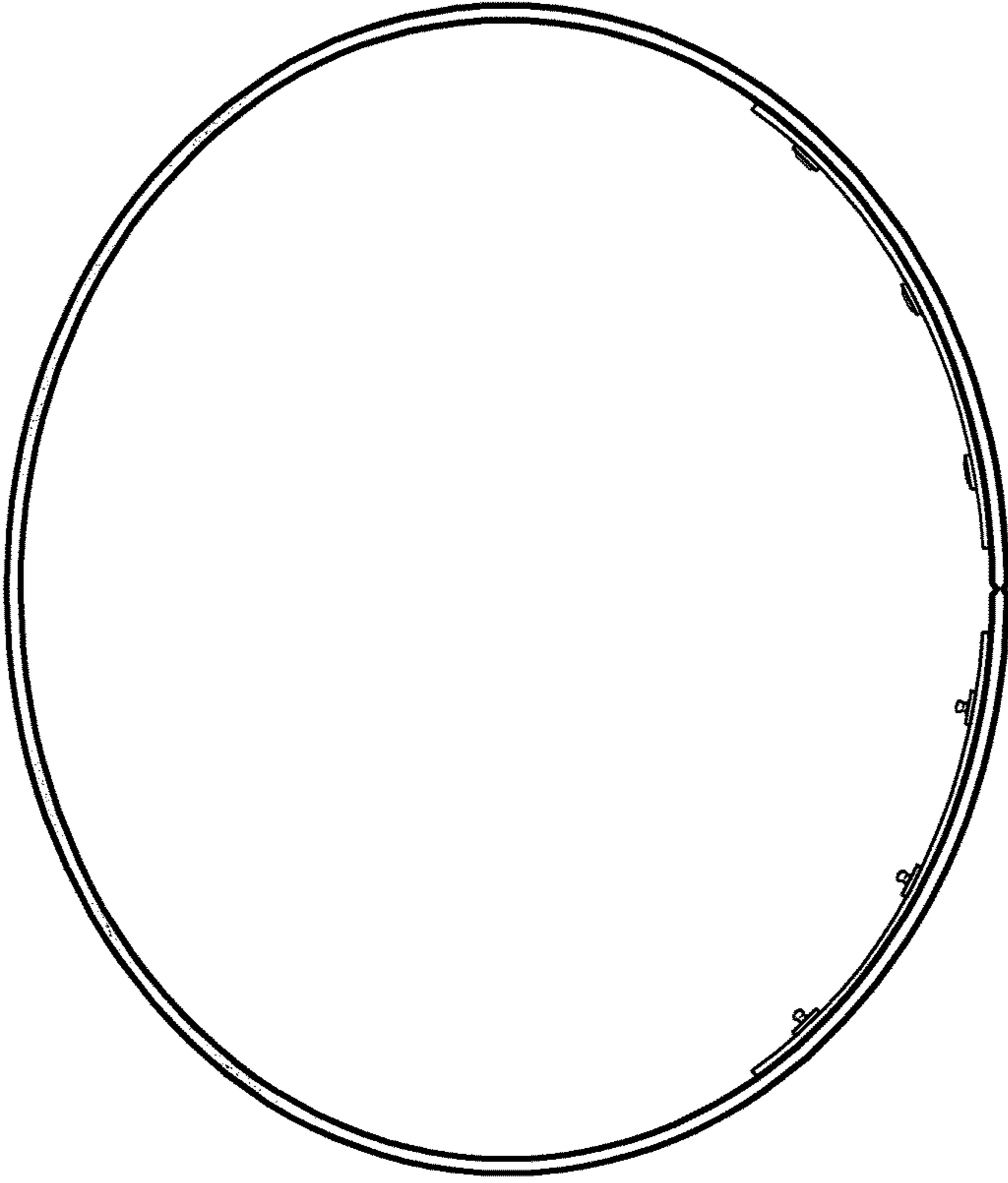

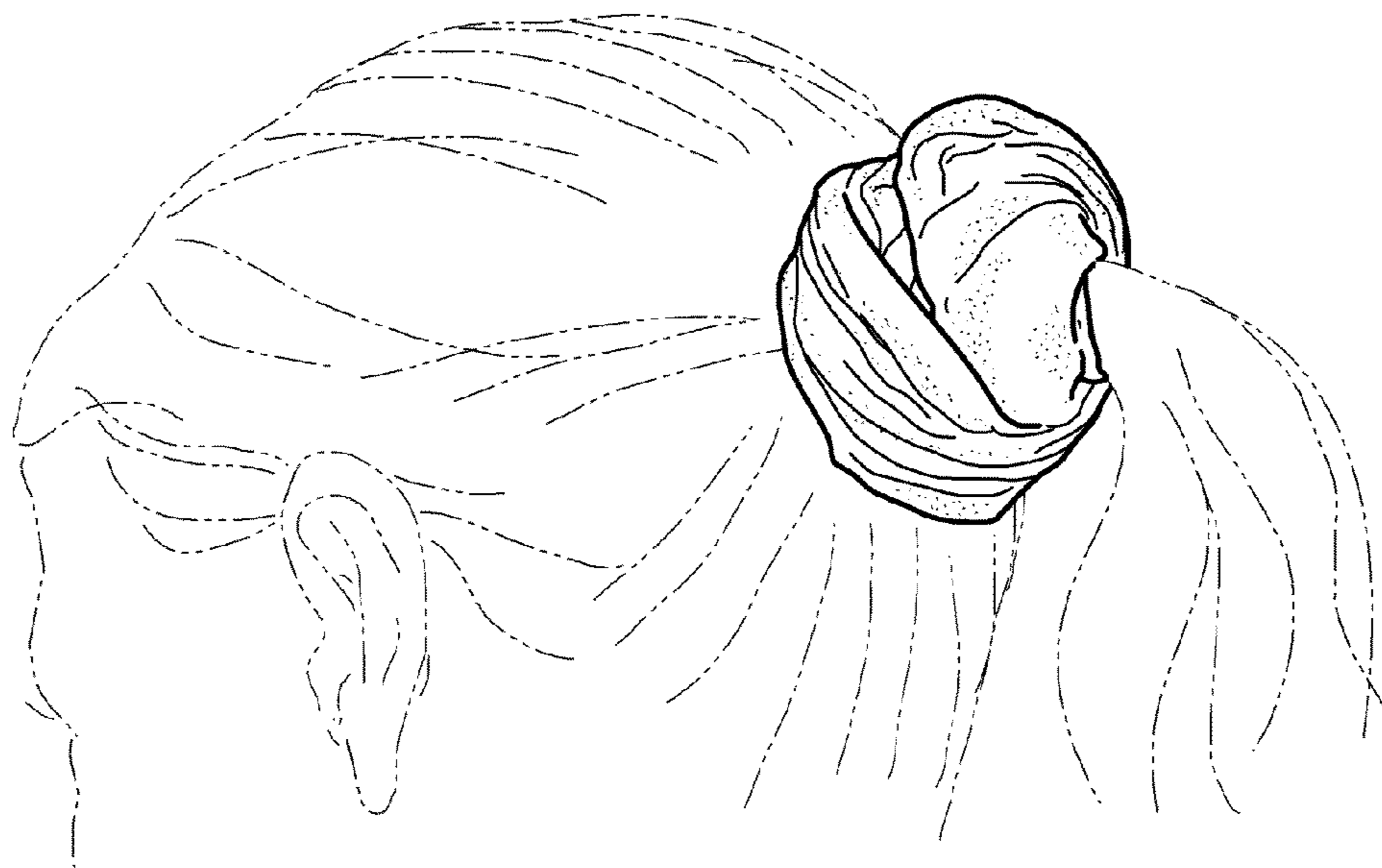

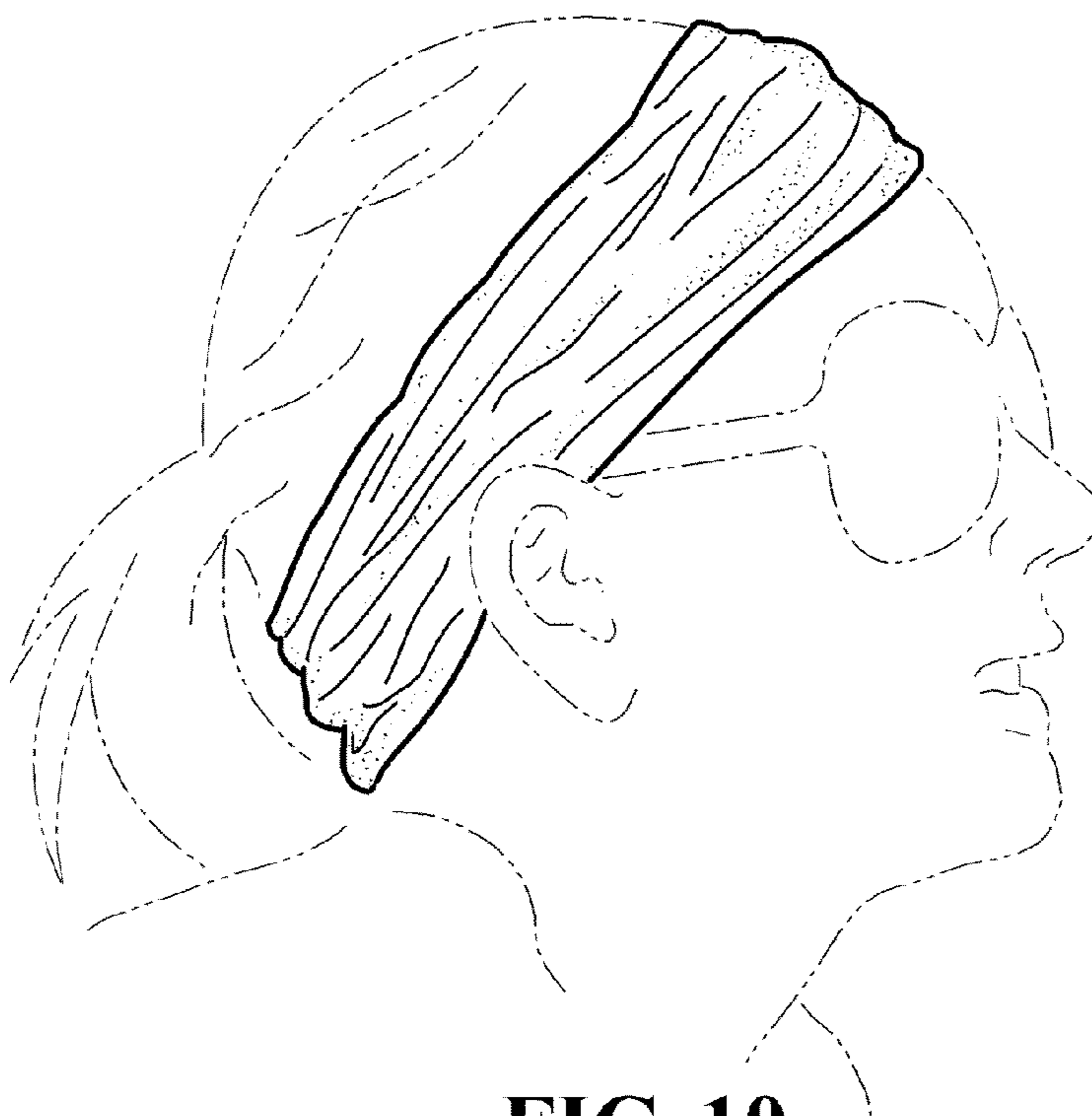

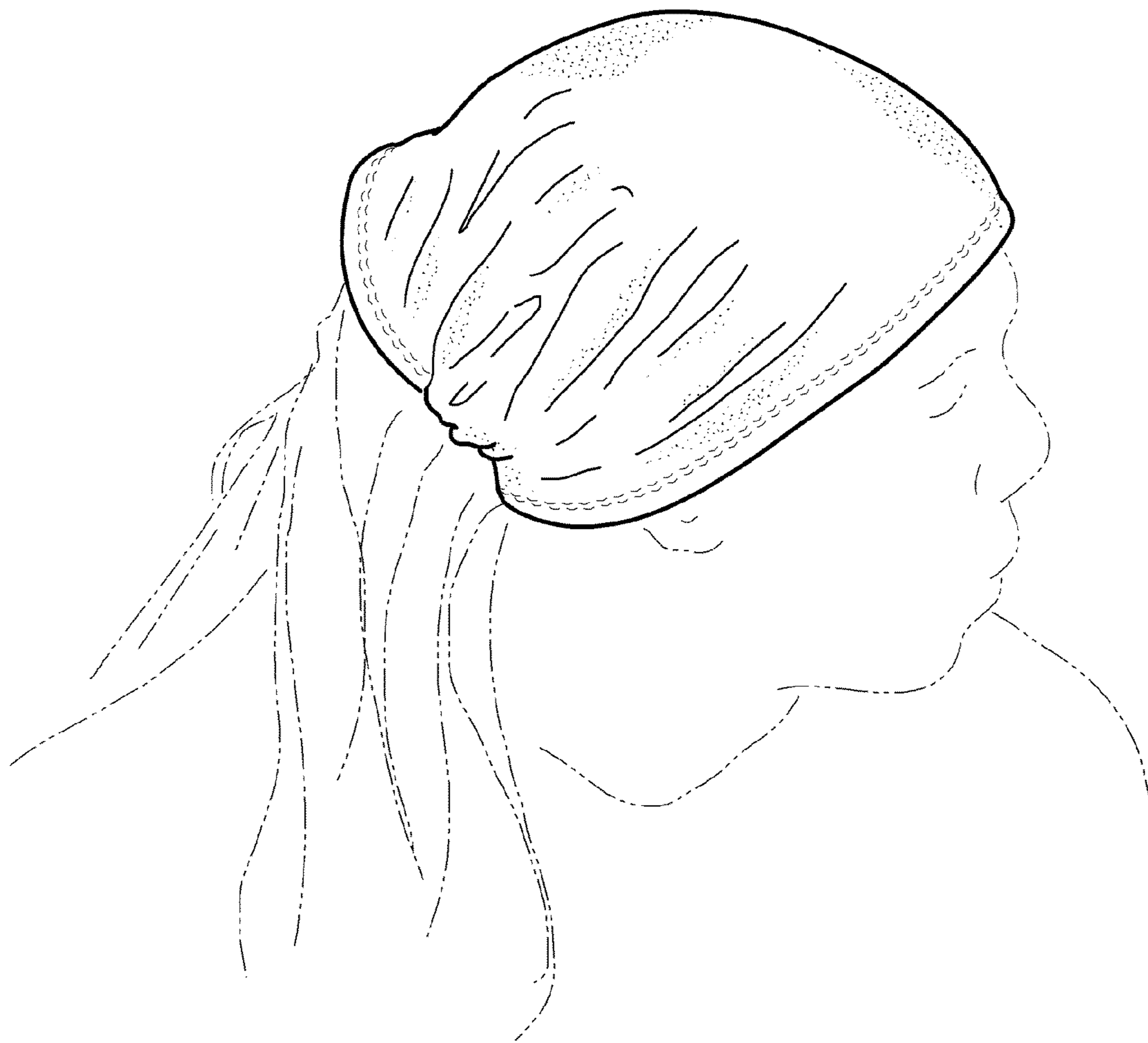
