(57) **CLAIM**

The ornamental design for a pocketbook protective cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pocketbook protective cover in accordance with the invention;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The broken lines shown on the pocketbook protective cover depict decorative stitching which forms part of the claimed design. The interior portions of the cover that are visible in FIG. 6 as two unshaded surfaces bounded by solid lines form no part of the claimed design.

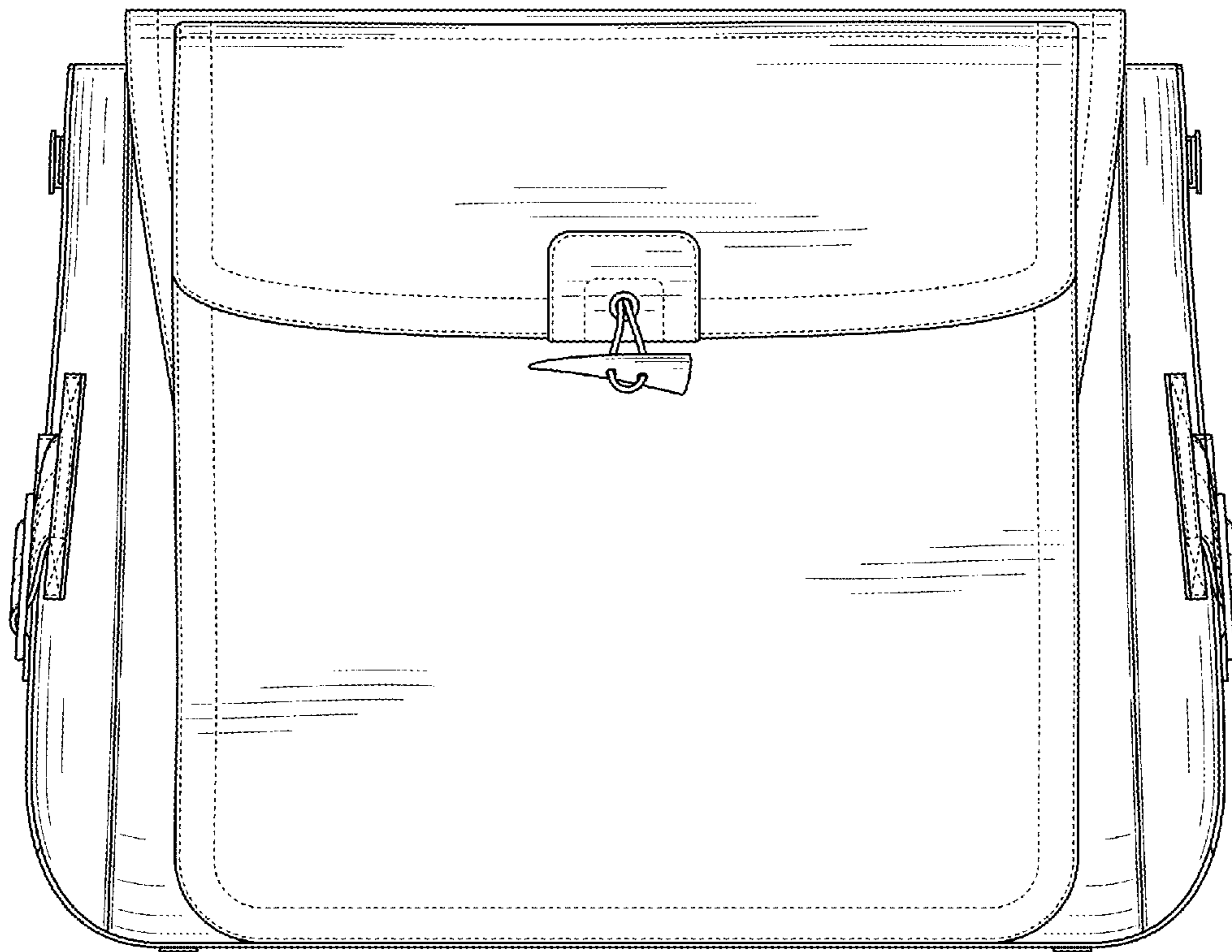

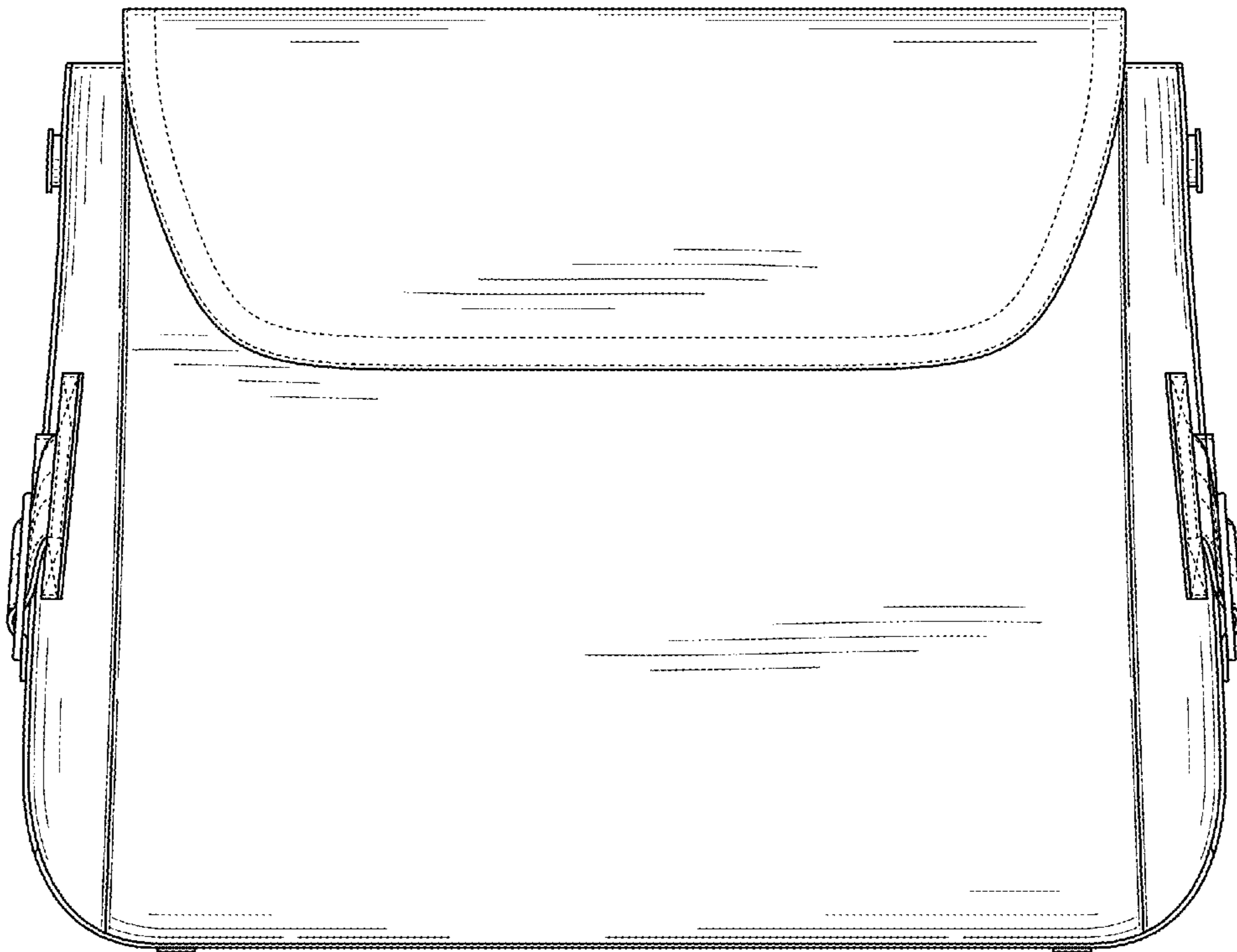

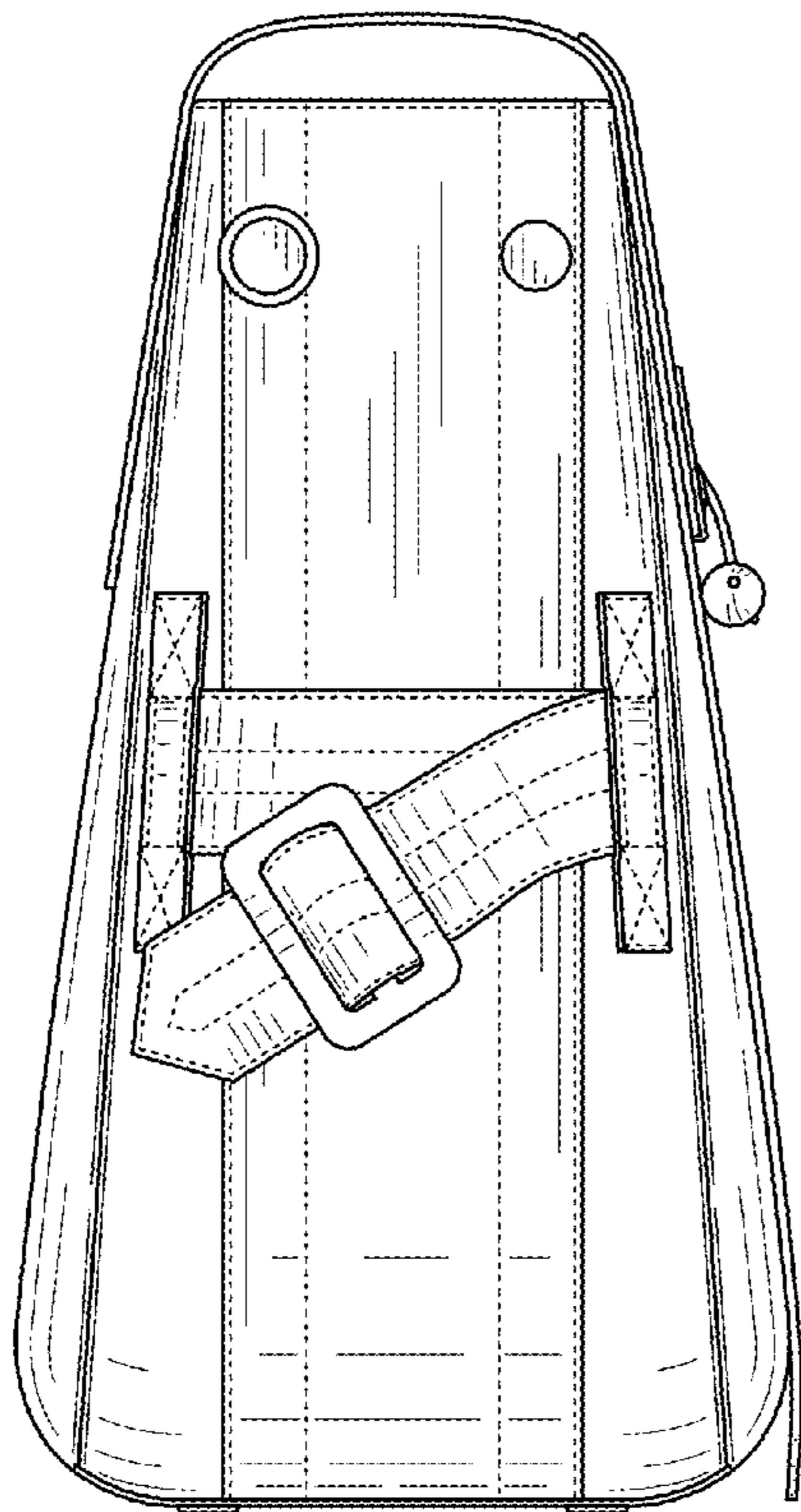

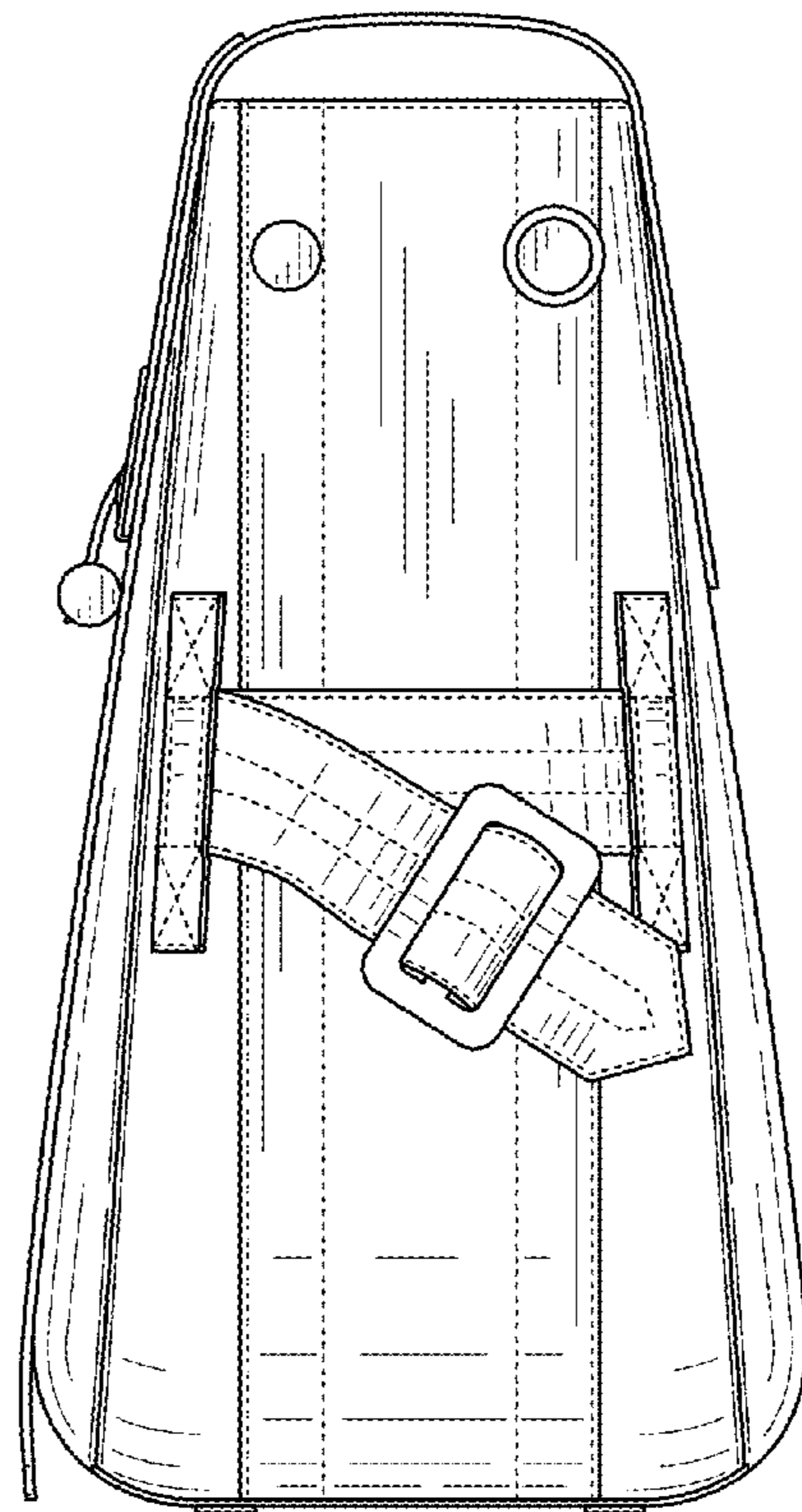

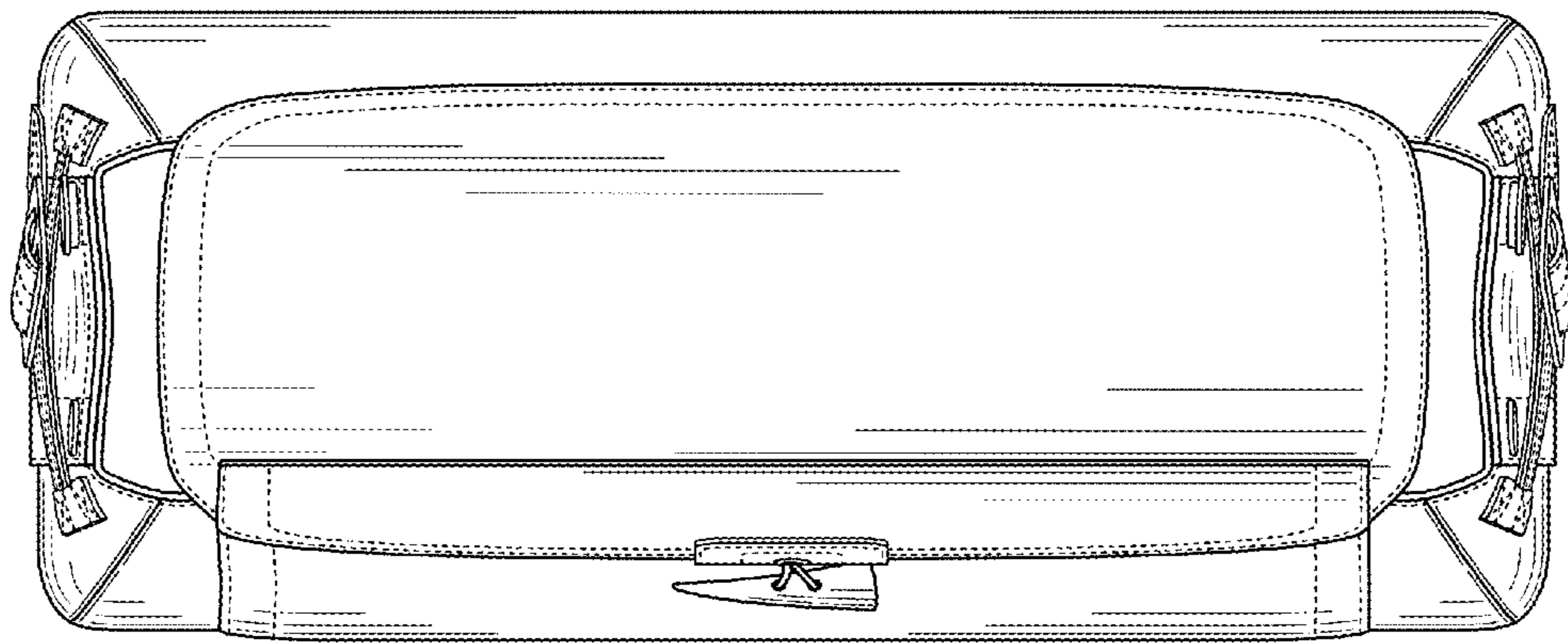

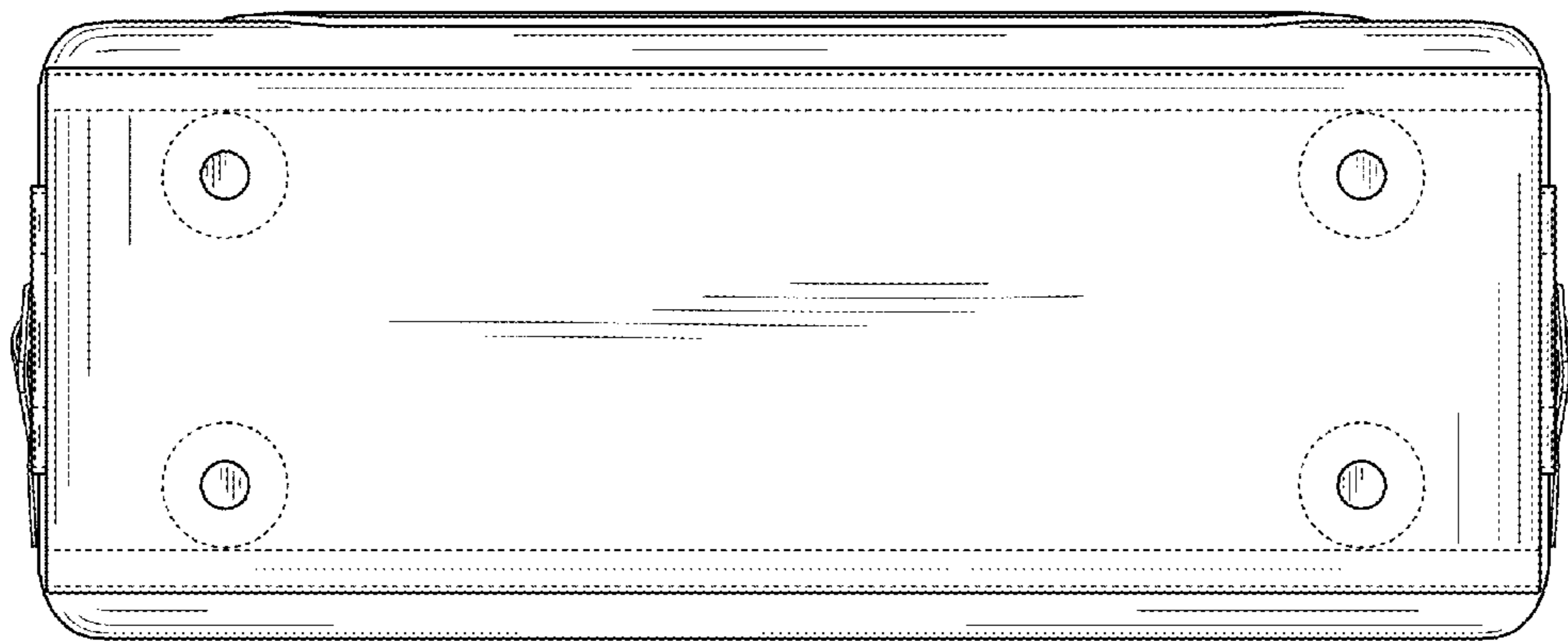
