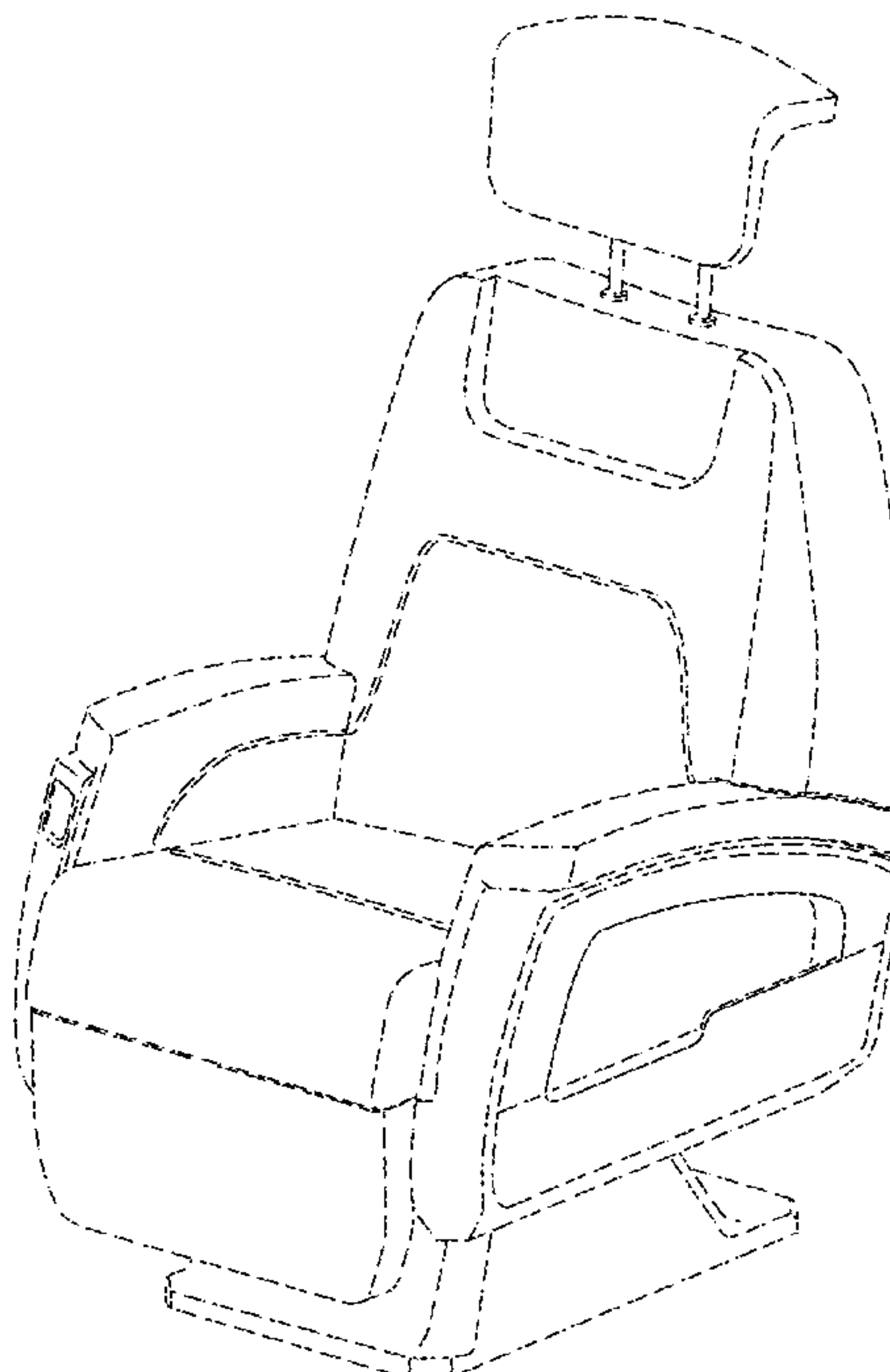
(57) **CLAIM**

The ornamental design for seat components, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of components of a seat according to our design;
 FIG. 2 is a left side view of the components of the seat of FIG. 1; and,
 FIG. 3 is a right side view of the components of a seat of FIG. 1.
 The broken lines that are included in the drawings denote aspects of the seat that form no part of the claimed design. The top, bottom, front, and rear views are excluded, because they are plain and unornamented and, therefore, form no part of the claimed design.

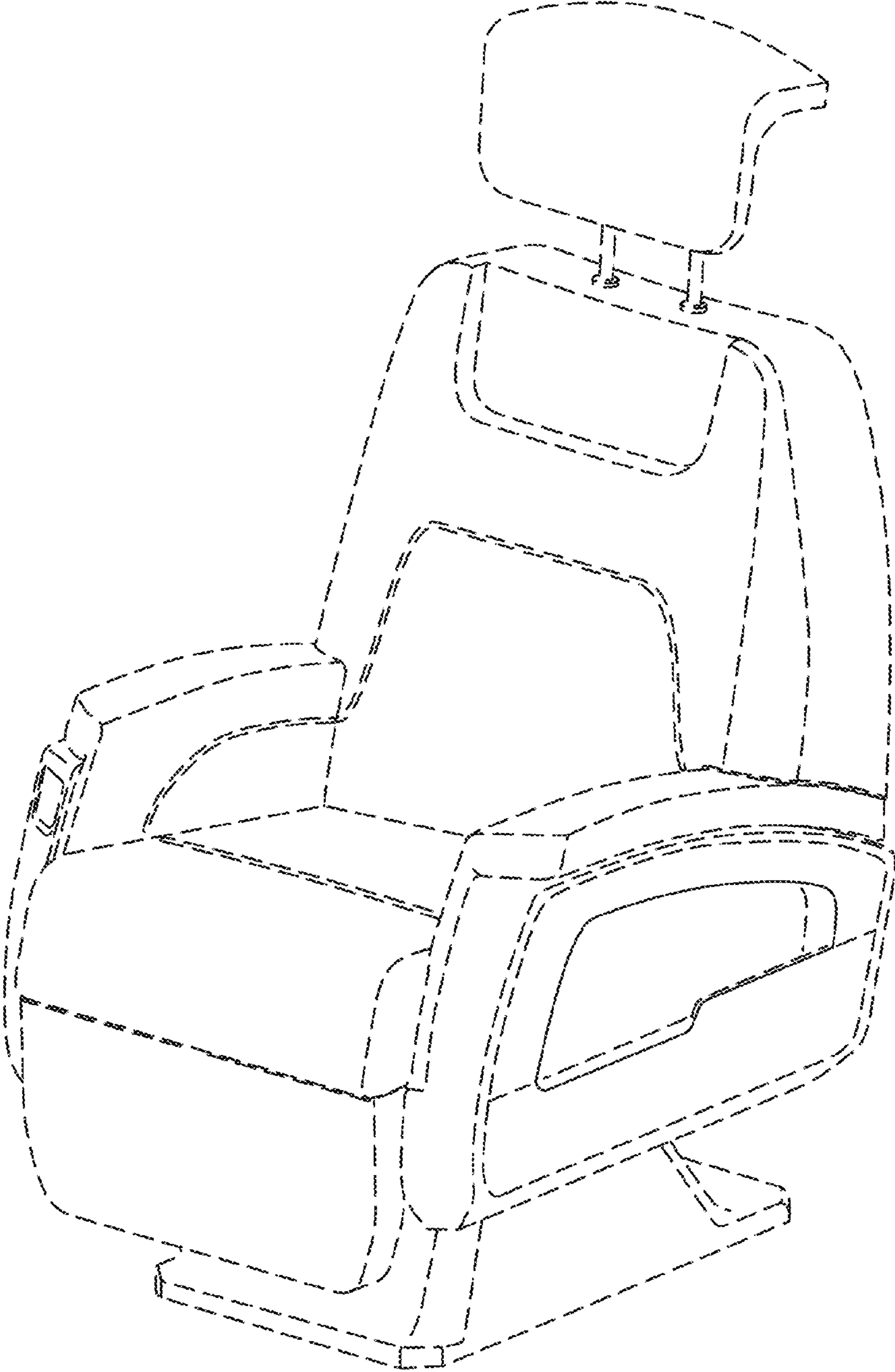

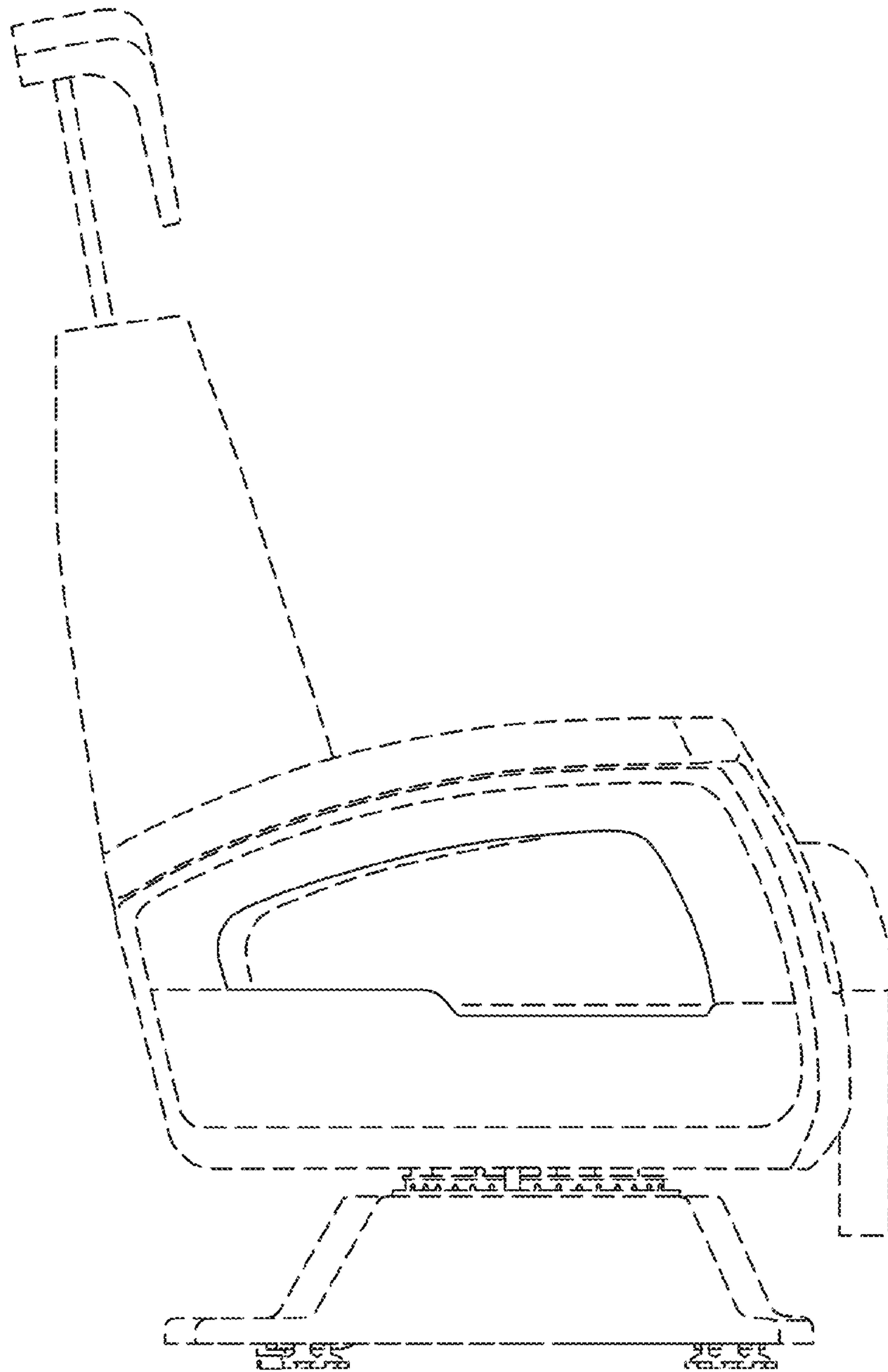

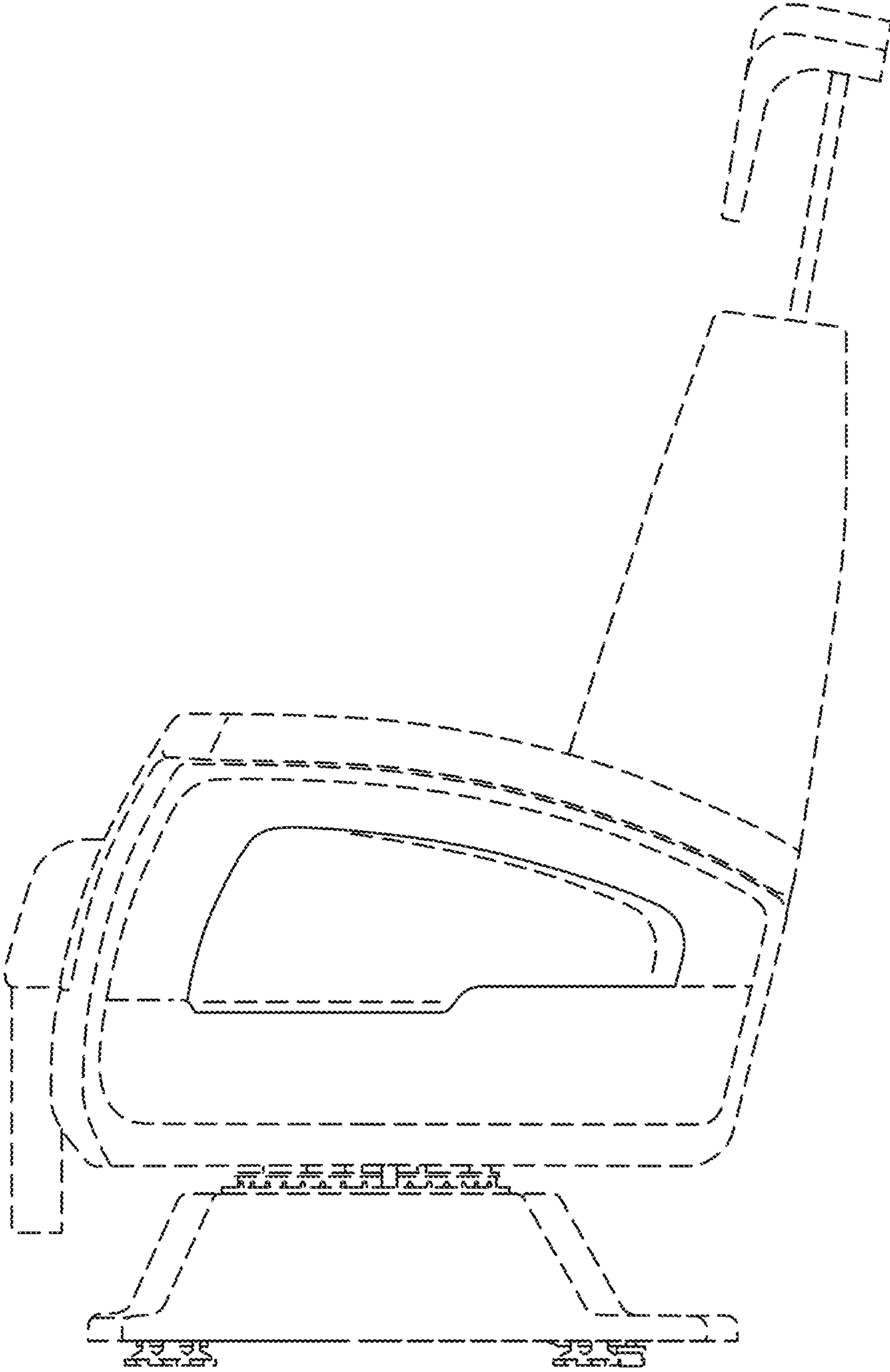
