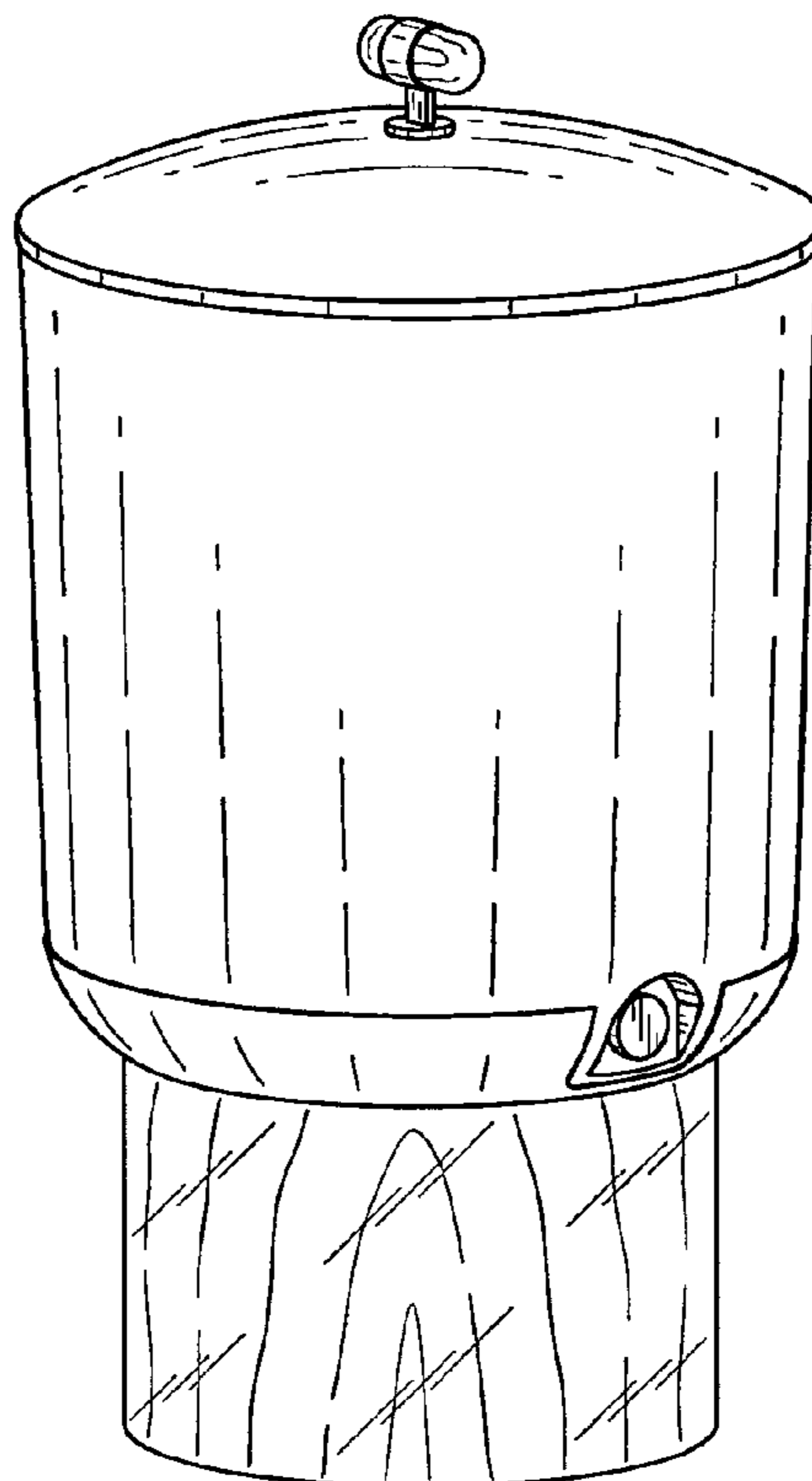
FIG. 1 is a perspective view of the beverage dispenser.

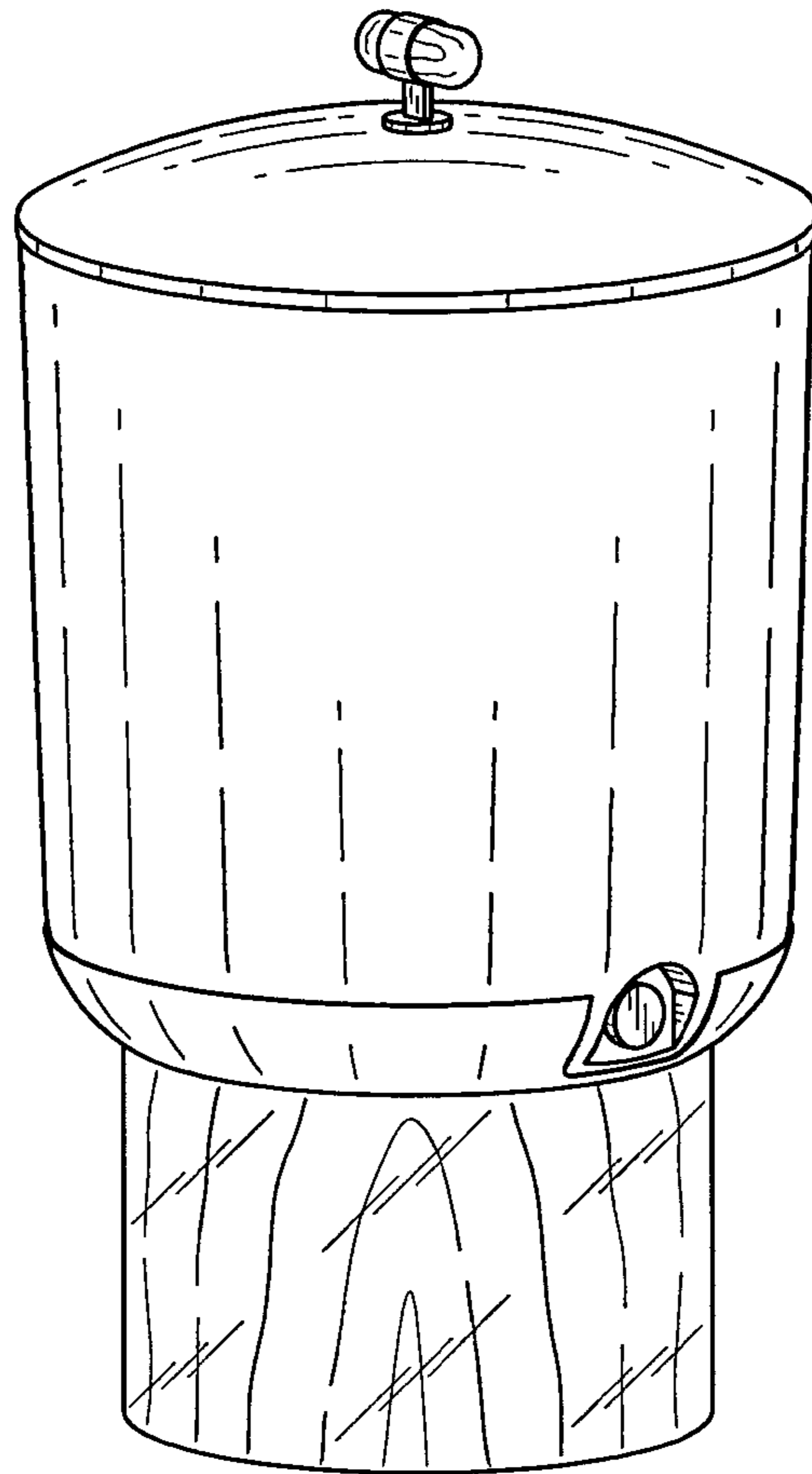

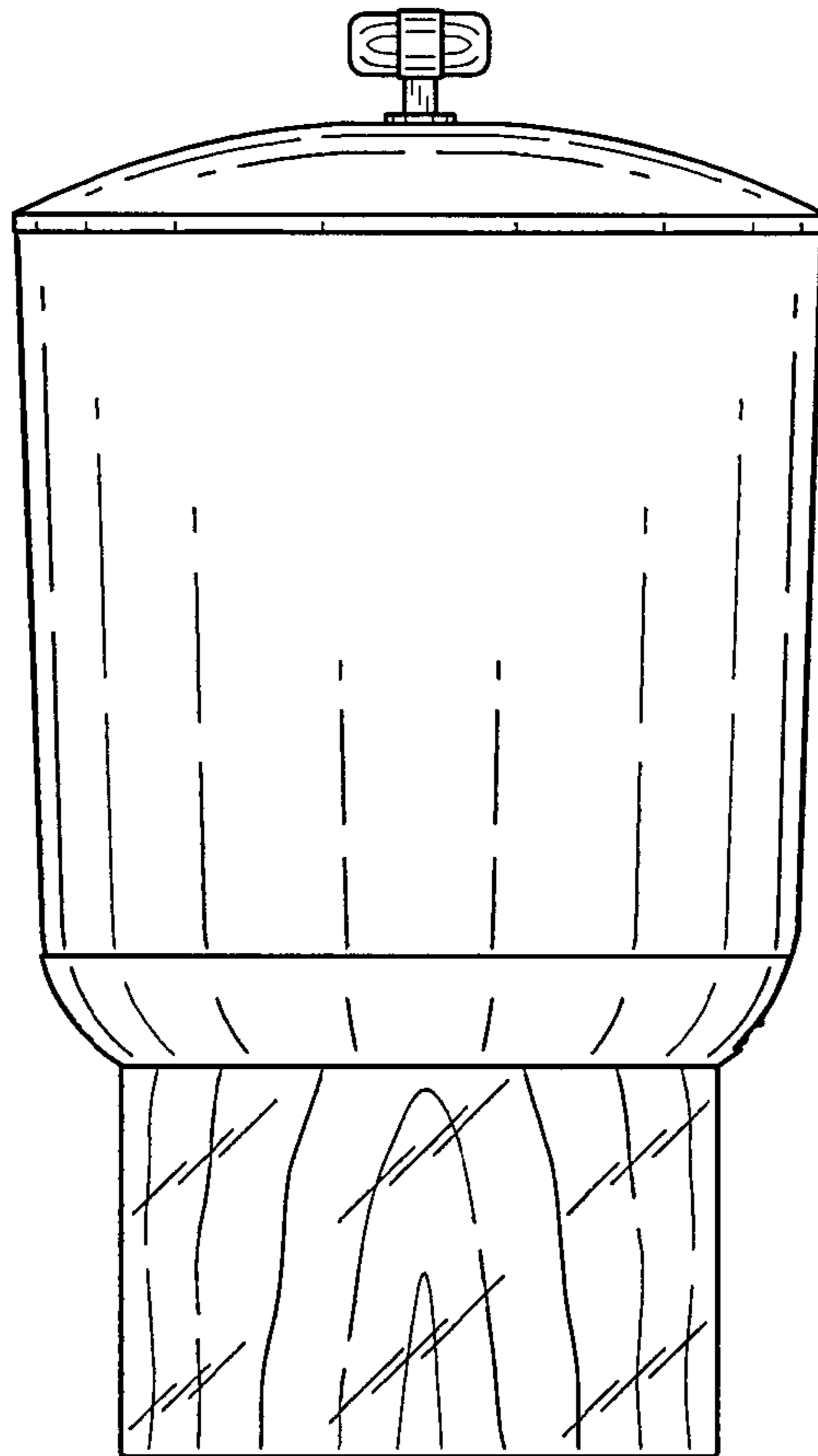

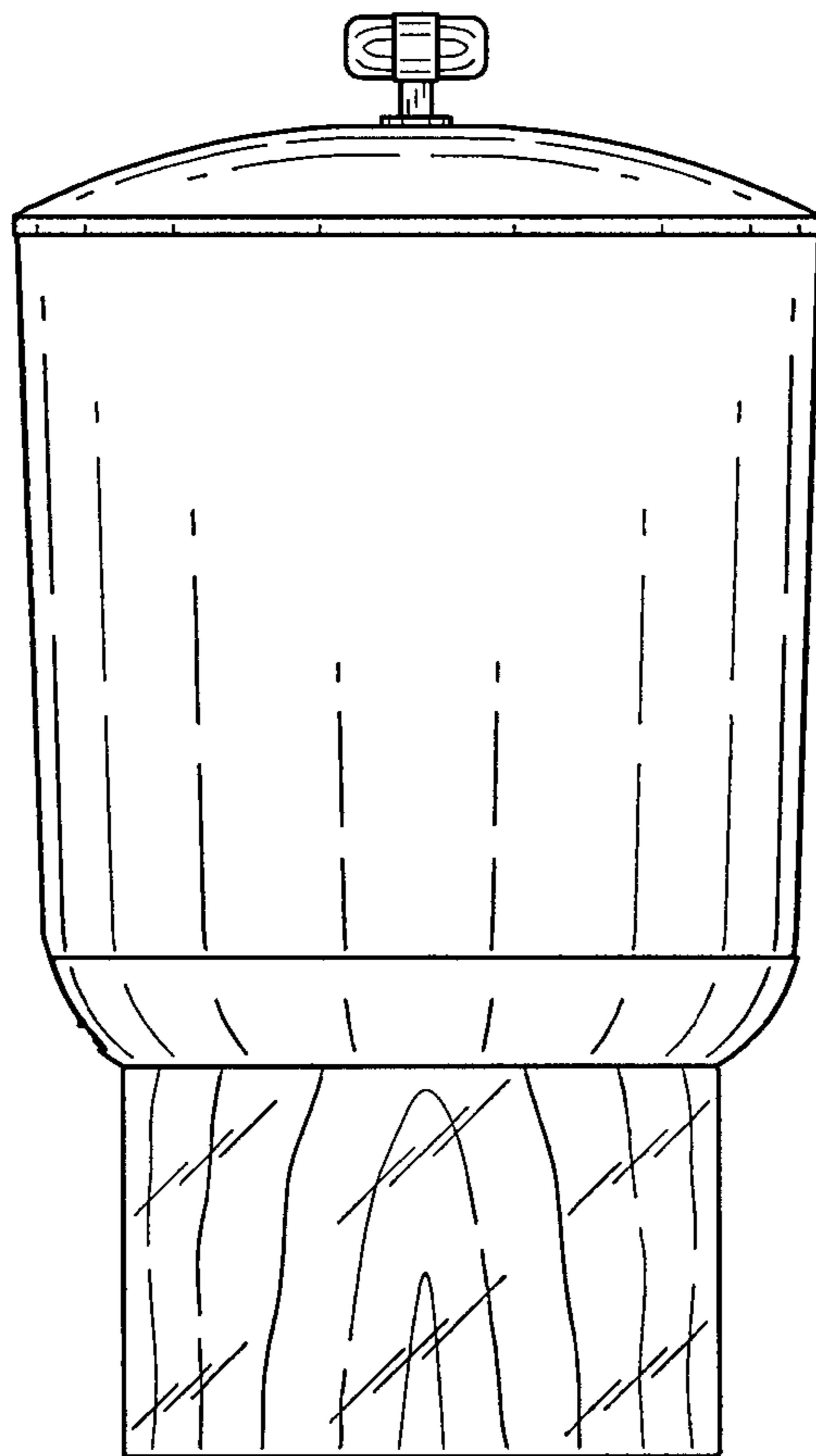

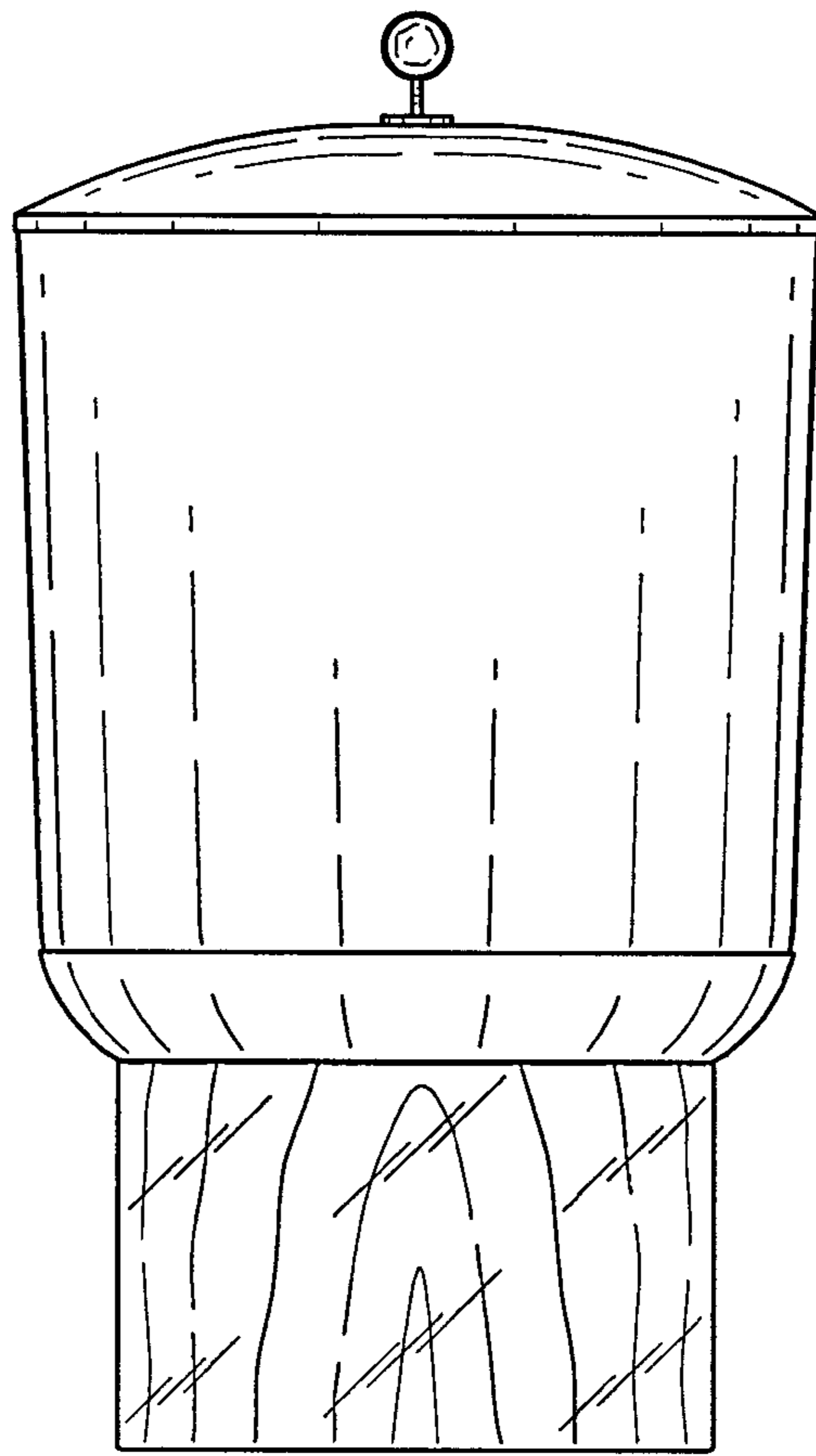

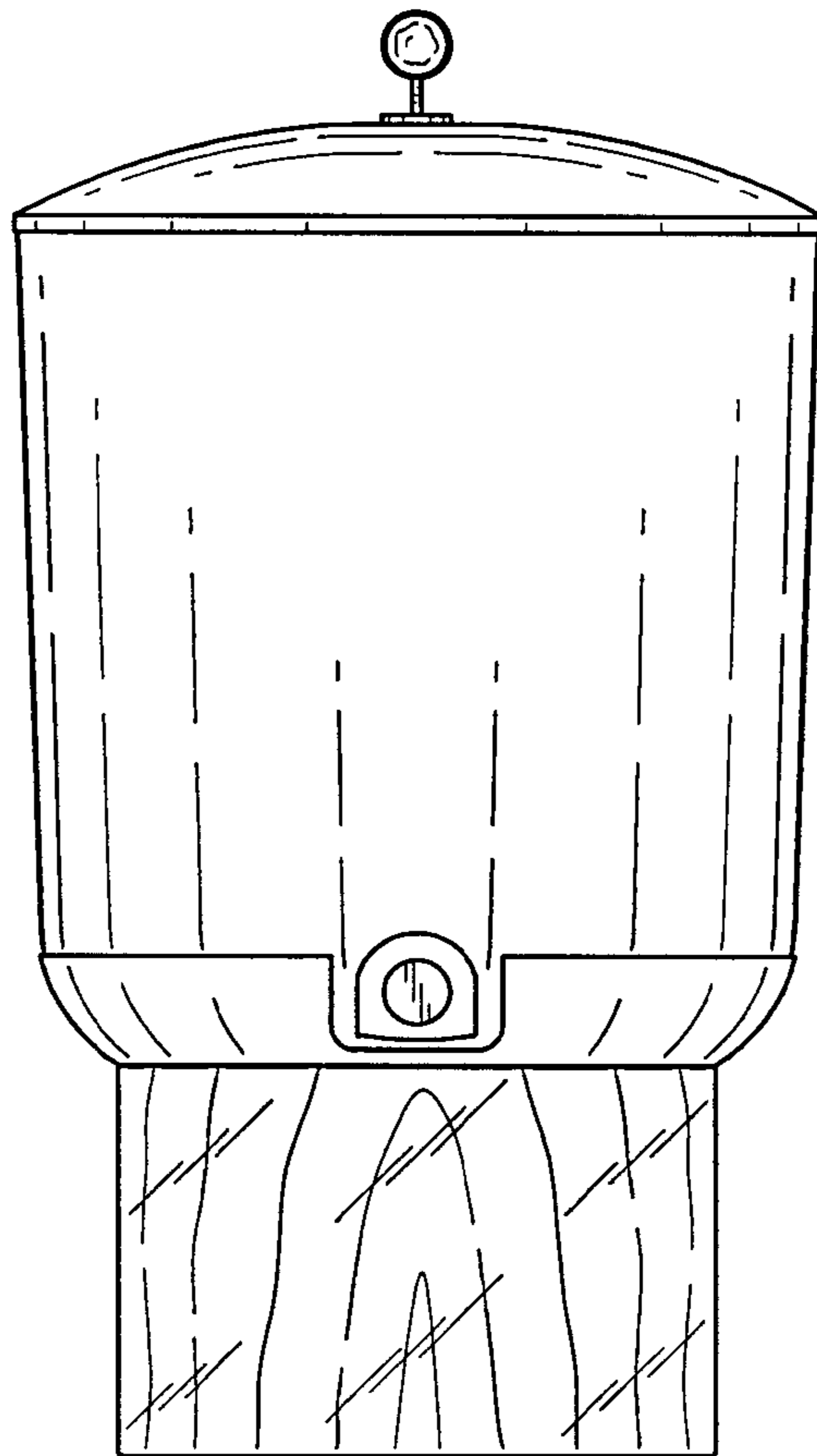

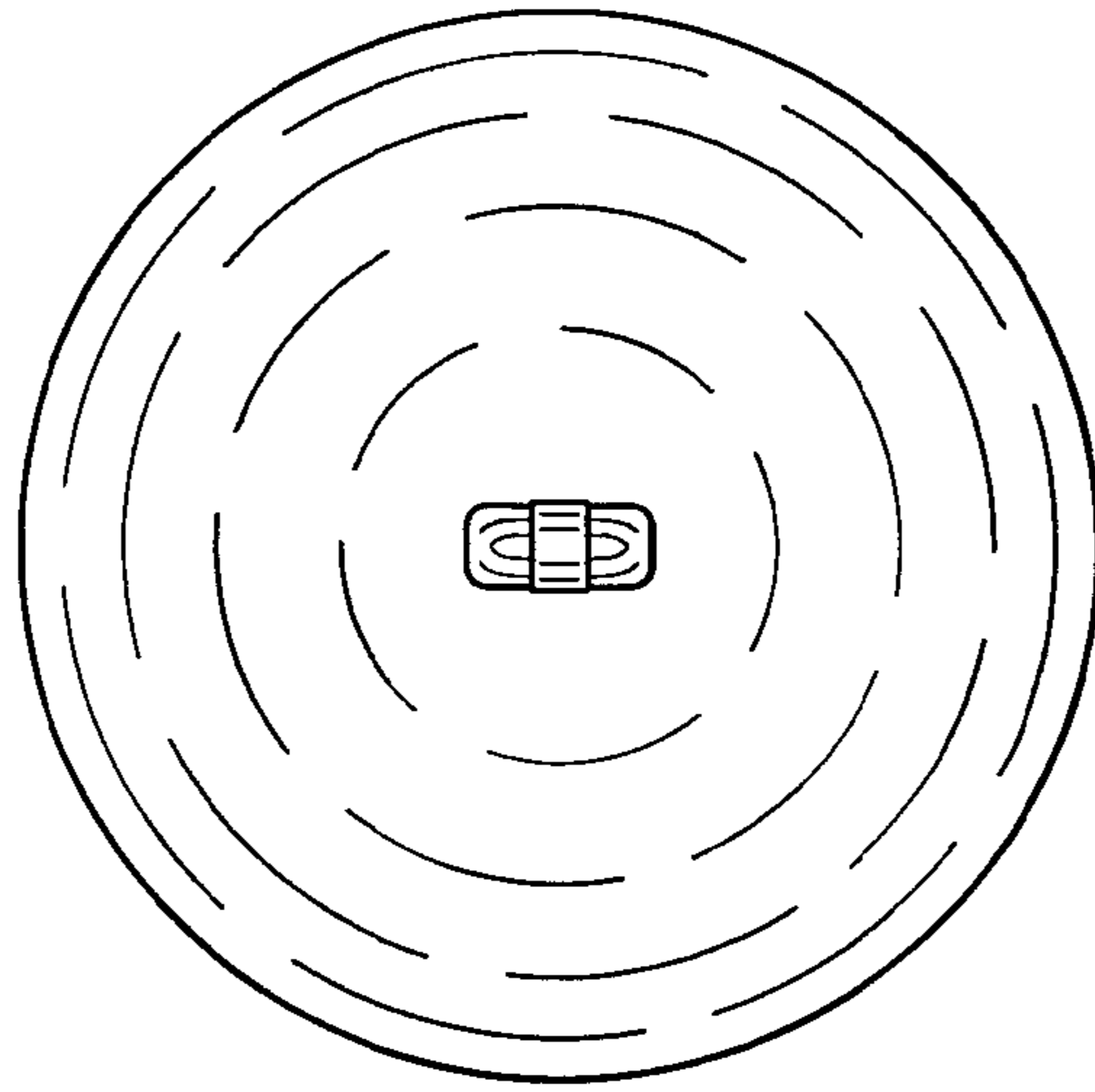

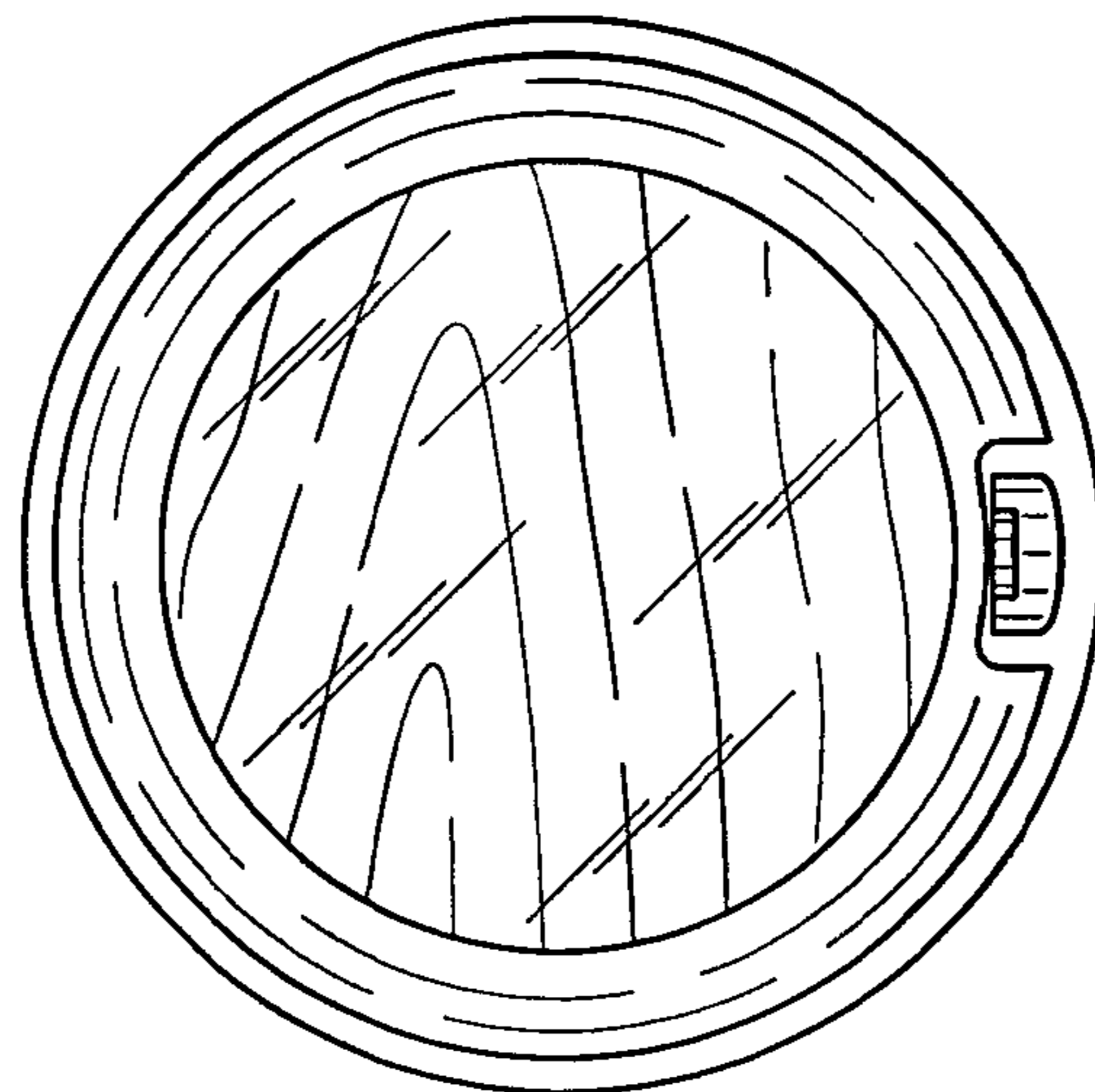
