The ornamental design for a pipe hanger, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pipe hanger showing a plurality of apertures in the environment for illustration;

FIG. 2 is a front view of the pipe hanger;

FIG. 3 is a rear view of FIG. 2;

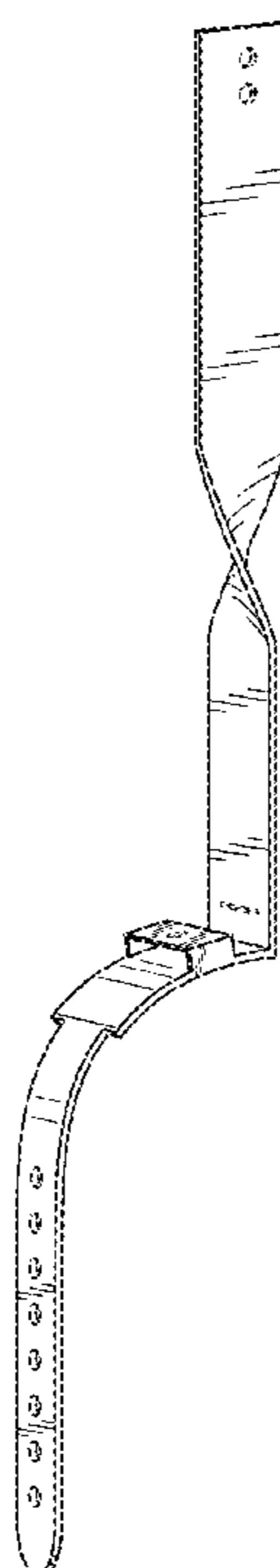
FIG. 4 is a left-hand side view of FIG. 2, wherein a right-hand side view is a mirror image of the left-hand side view;

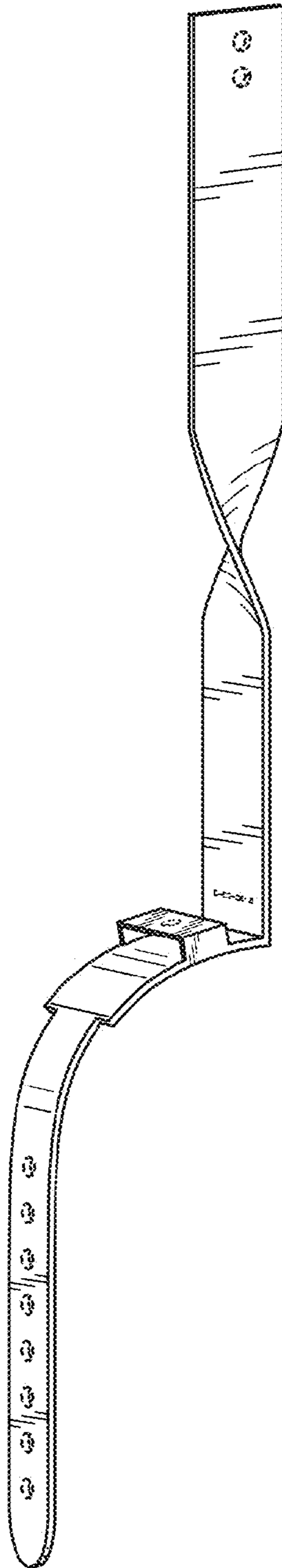

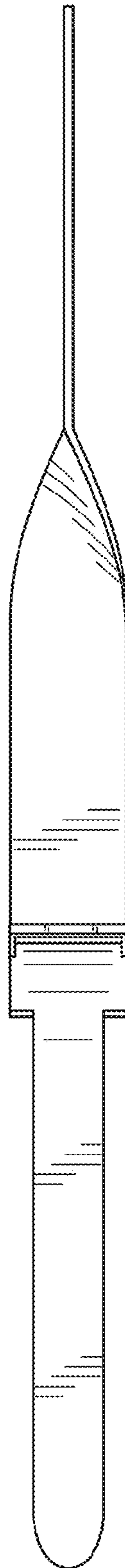

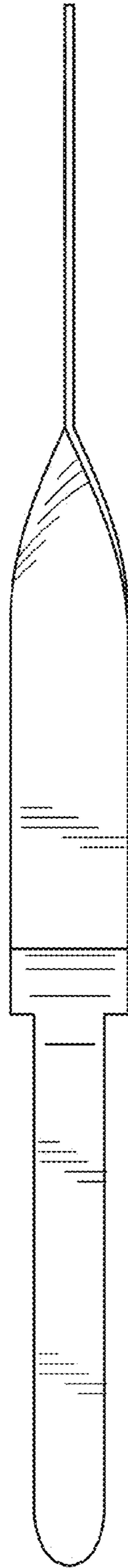

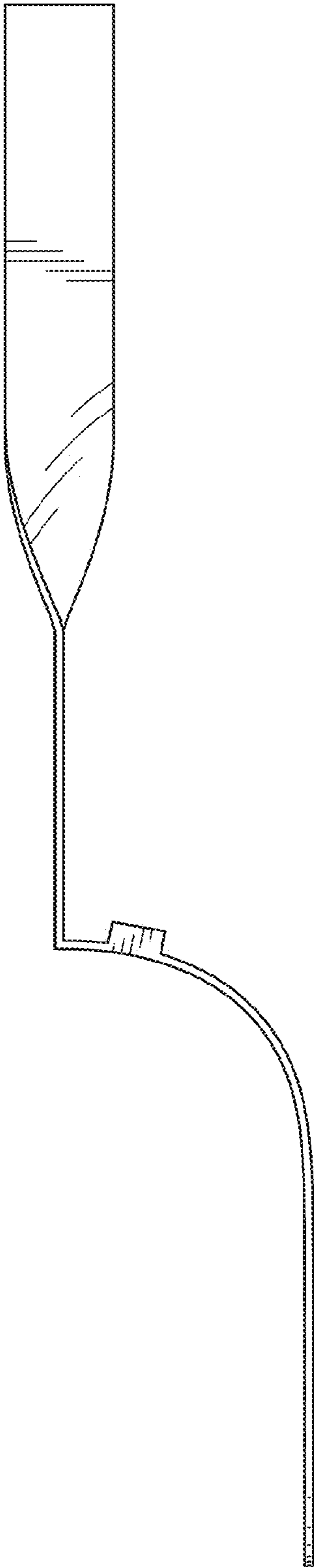

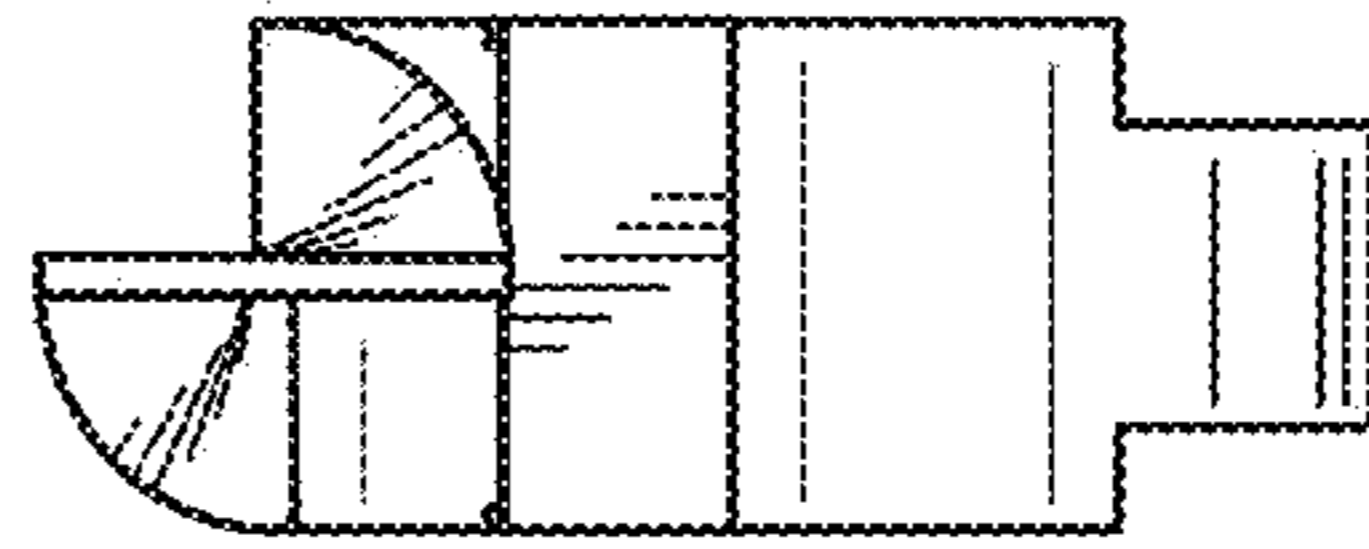

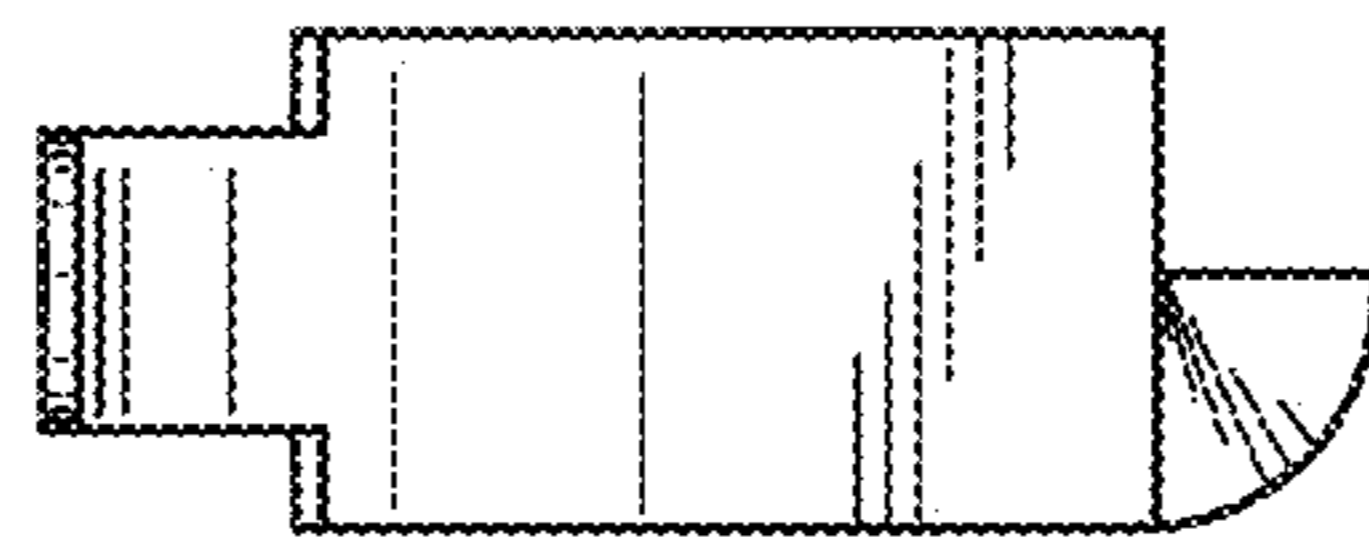
