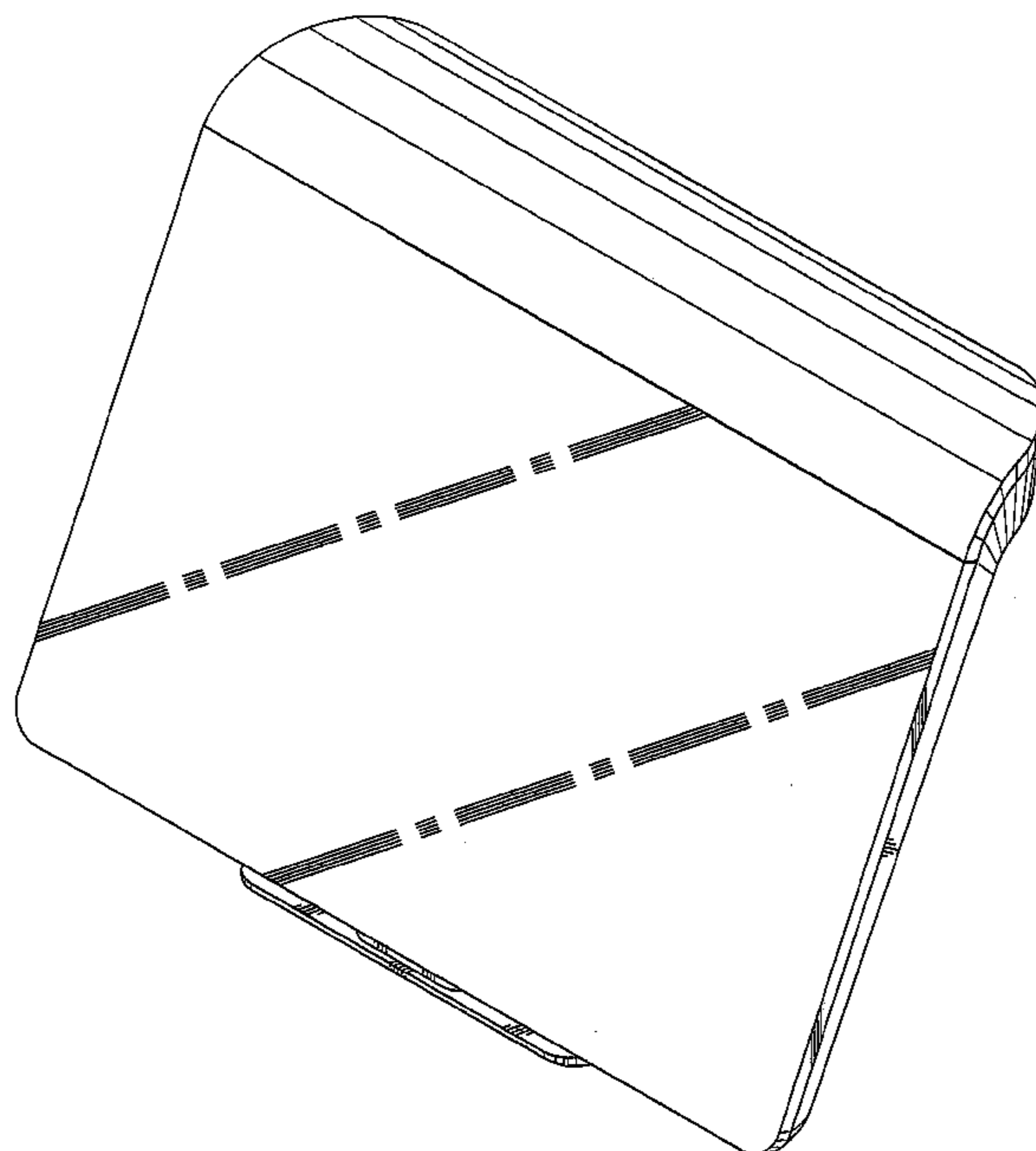
(57) **CLAIM**

The ornamental design for an in-vehicle infotainment device, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of an in-vehicle infotainment device showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a perspective view thereof showing the present in-vehicle infotainment device installed in a vehicle. The broken lines depict environmental subject matter only and form no part of the claimed design.

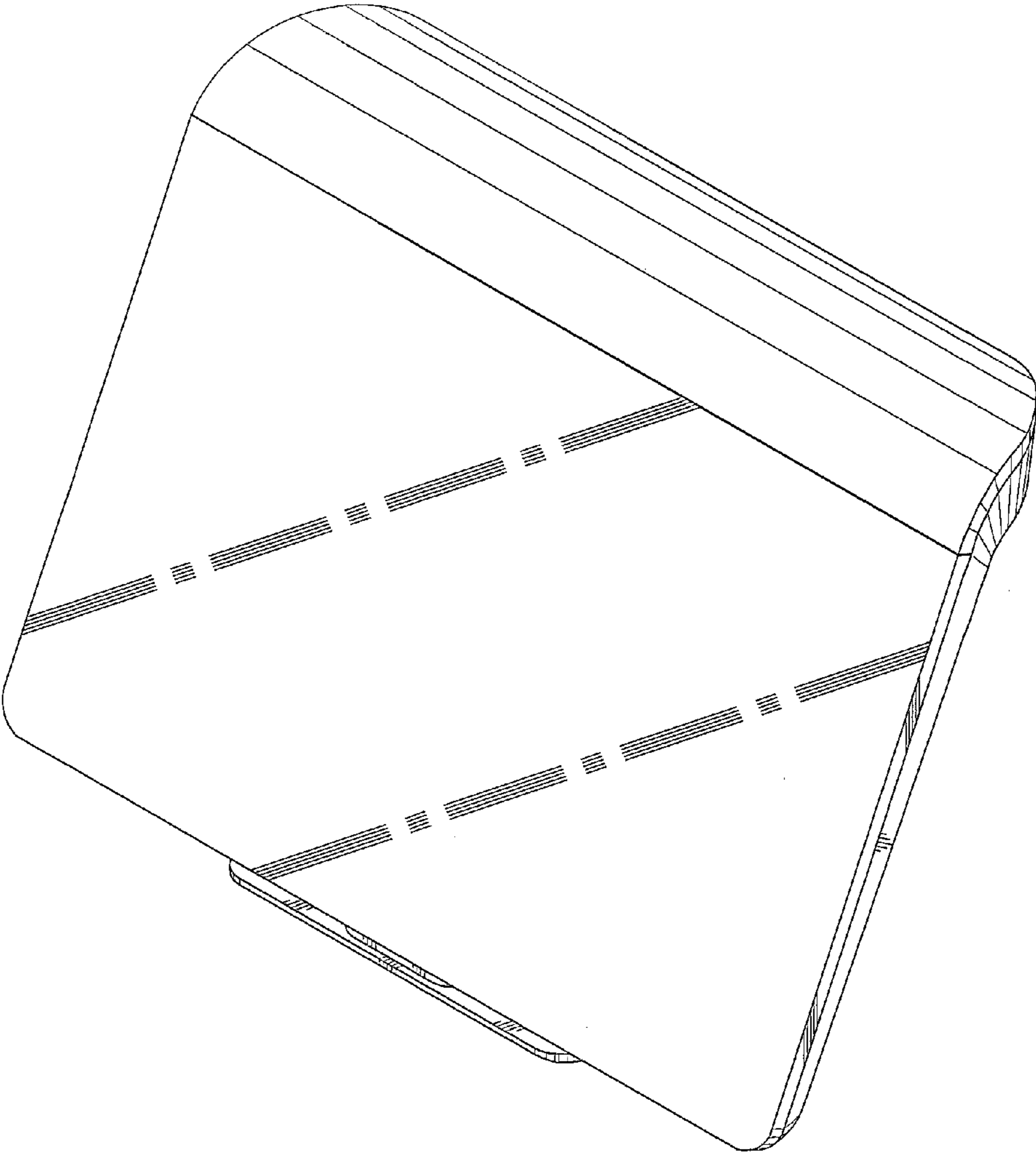

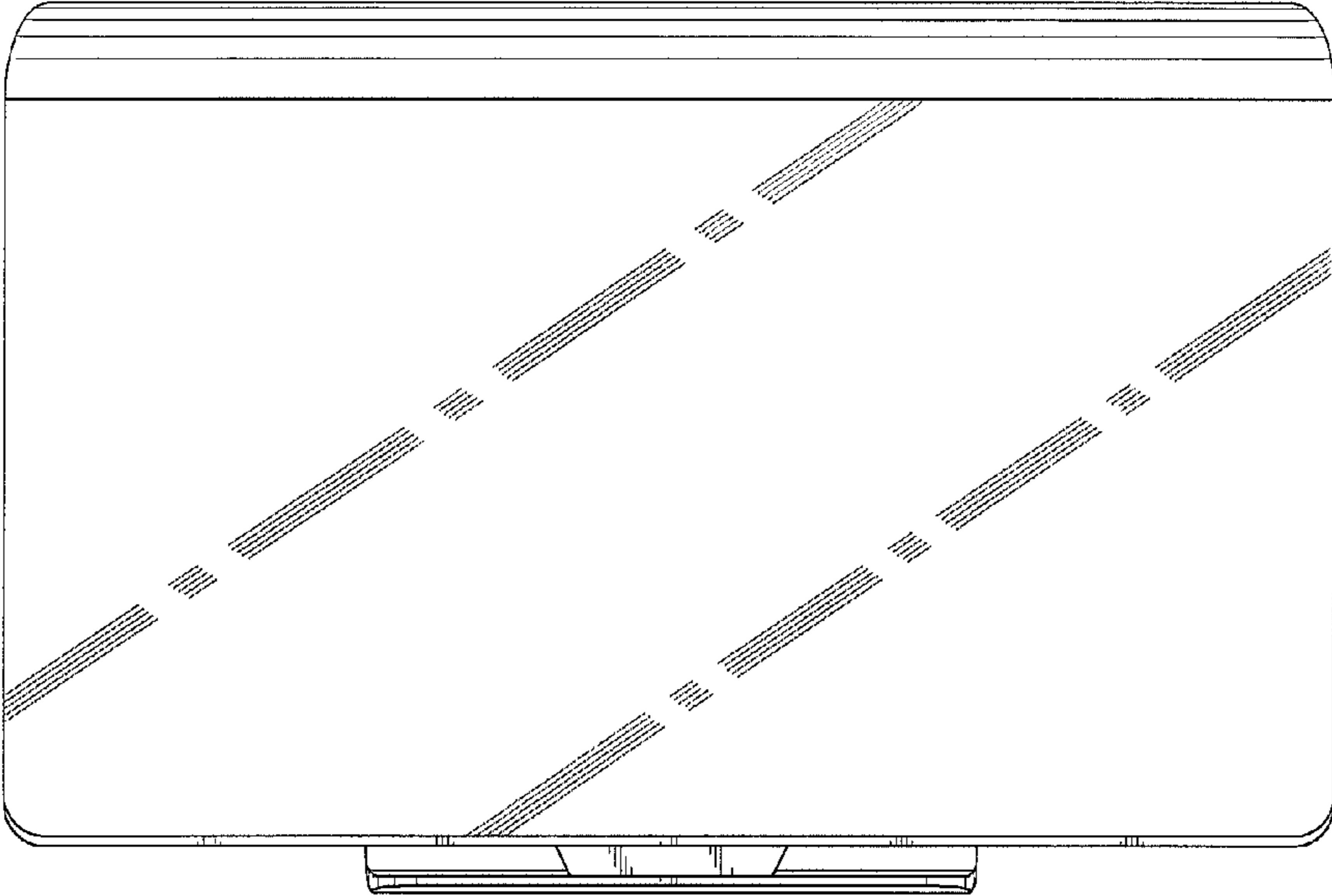

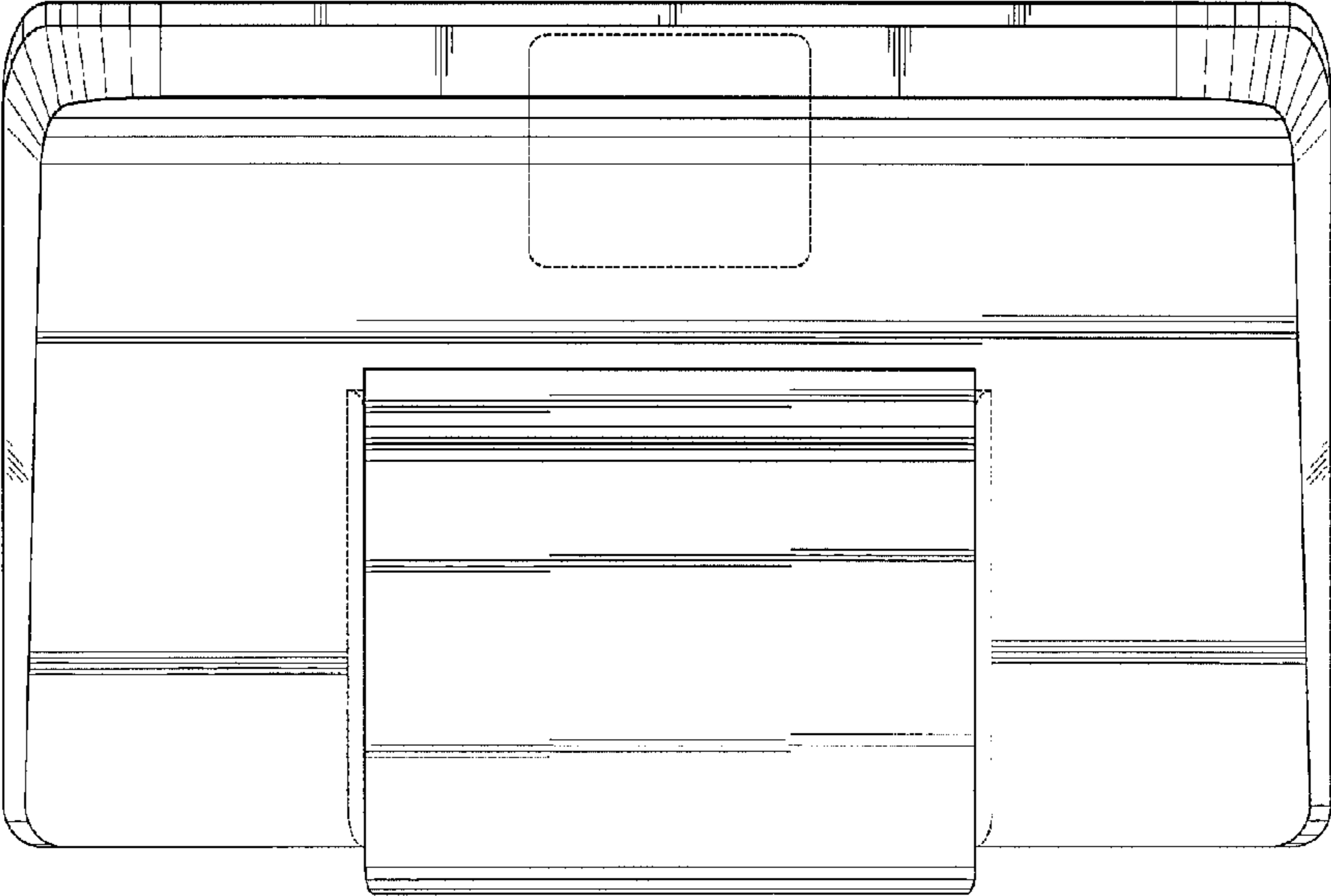

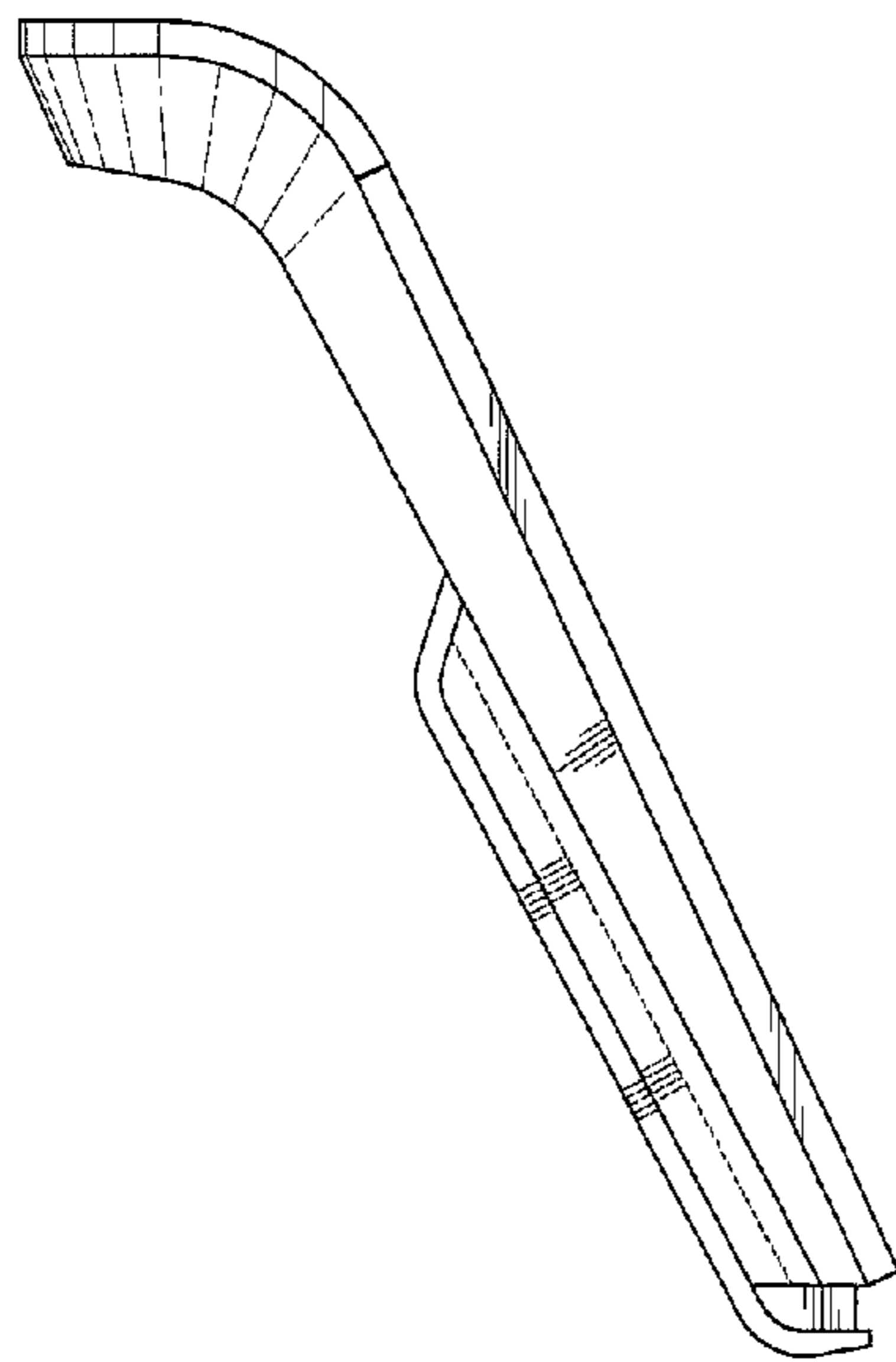

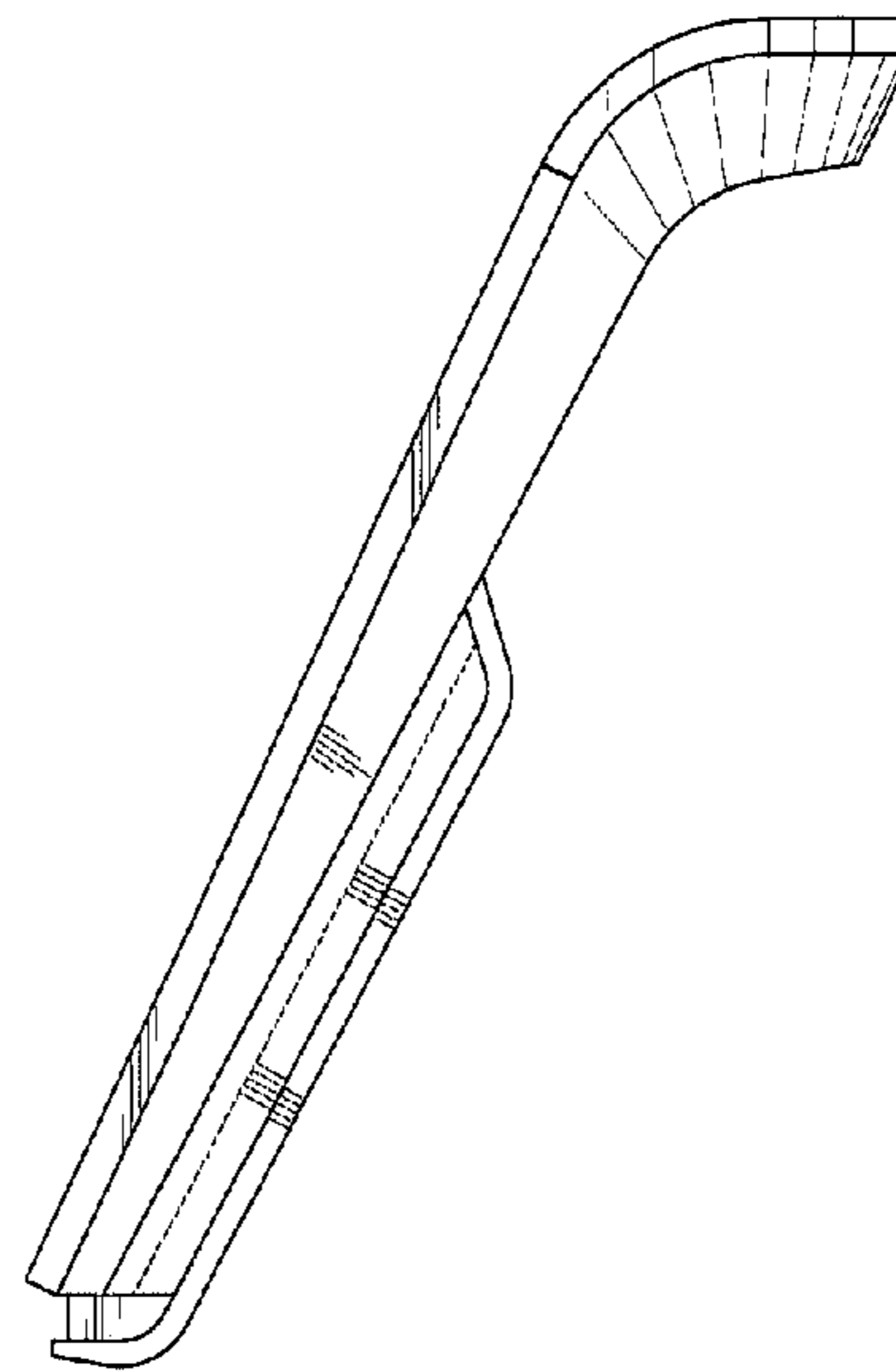

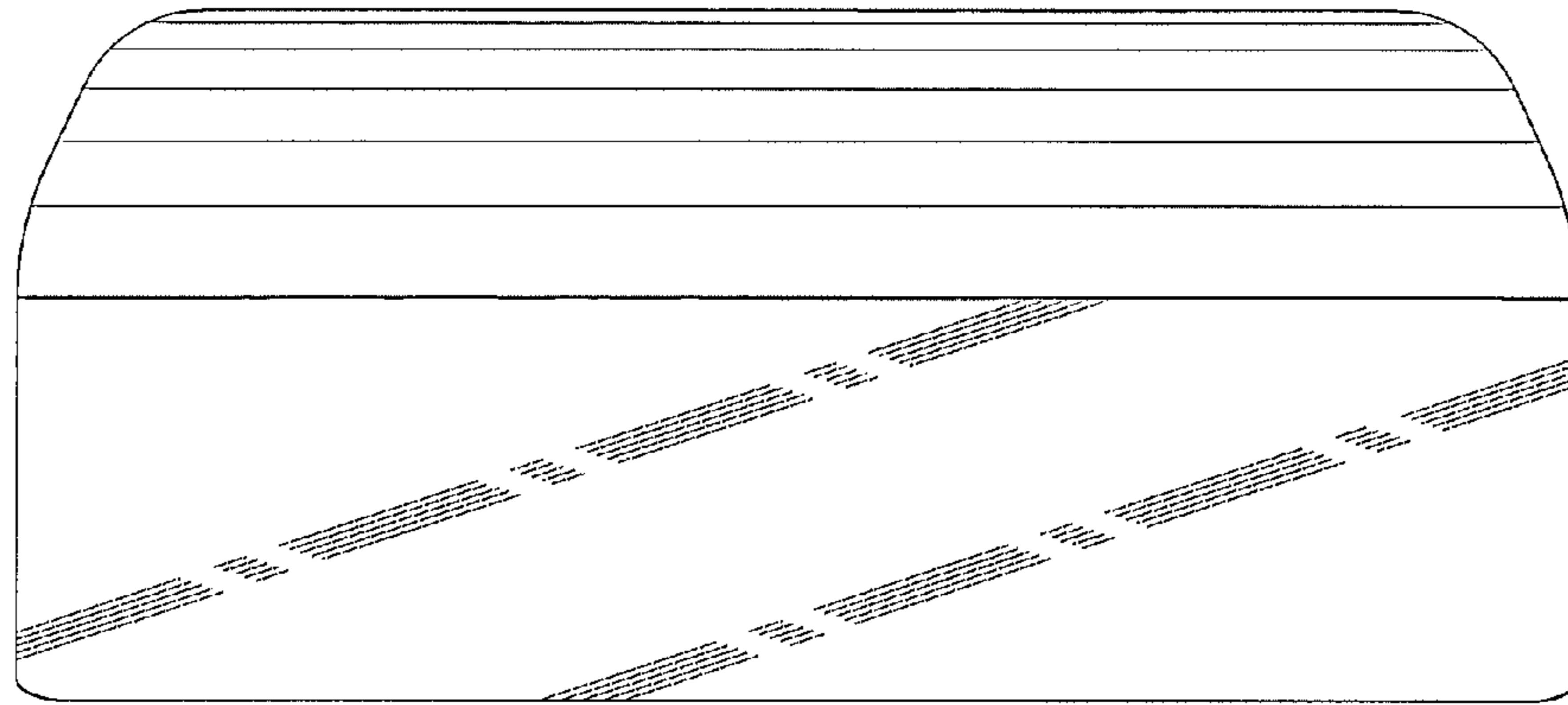

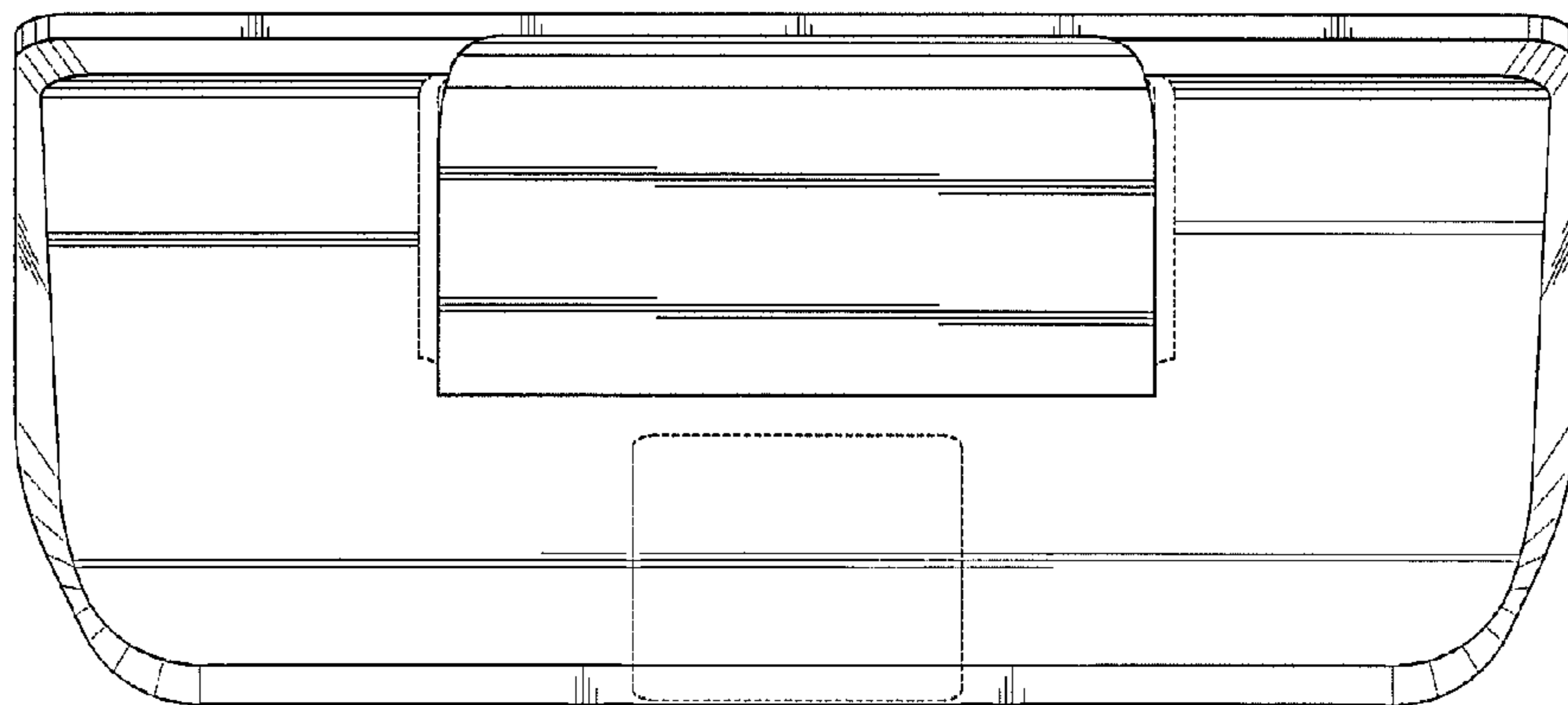

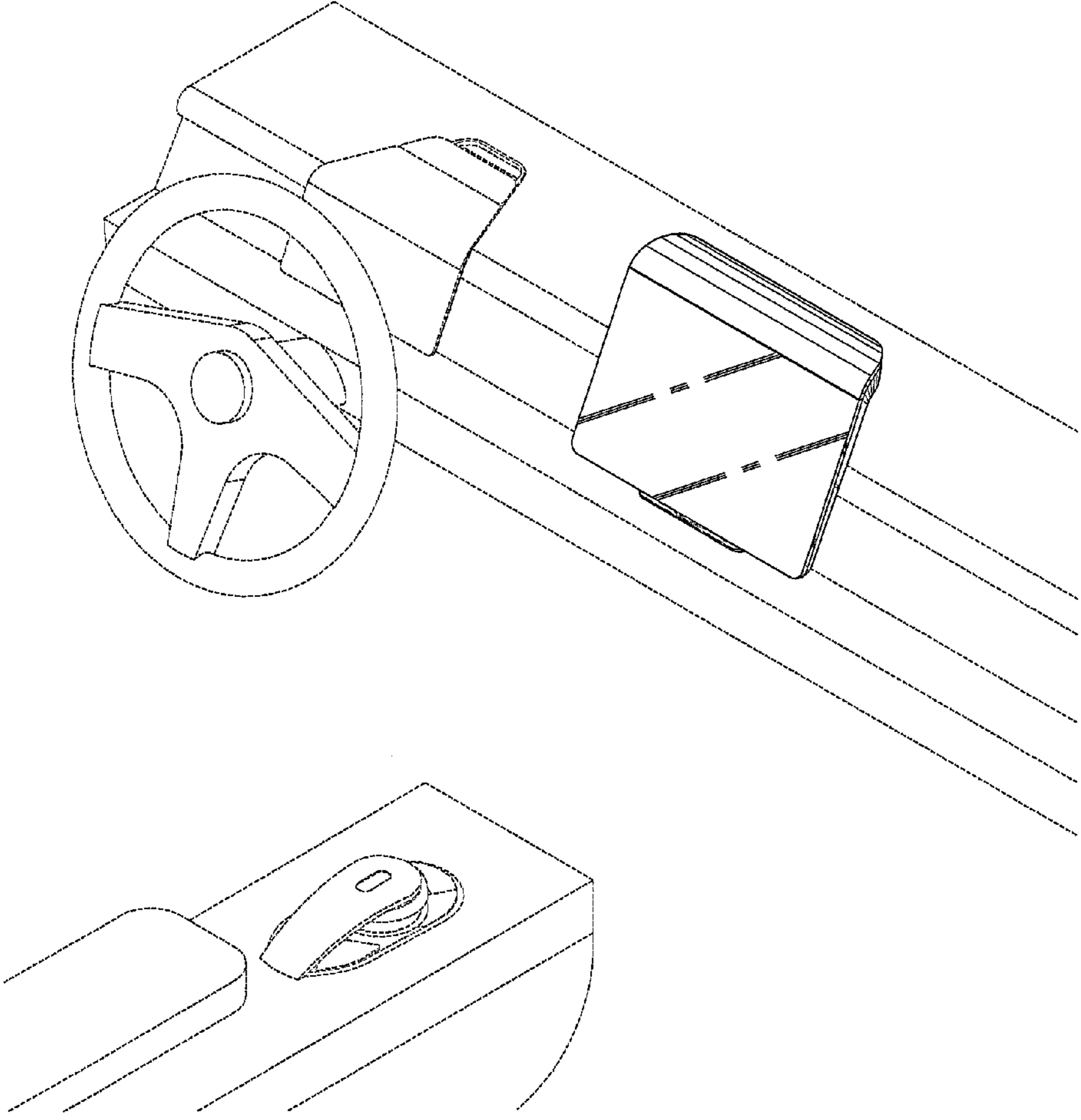
