**DESCRIPTION**

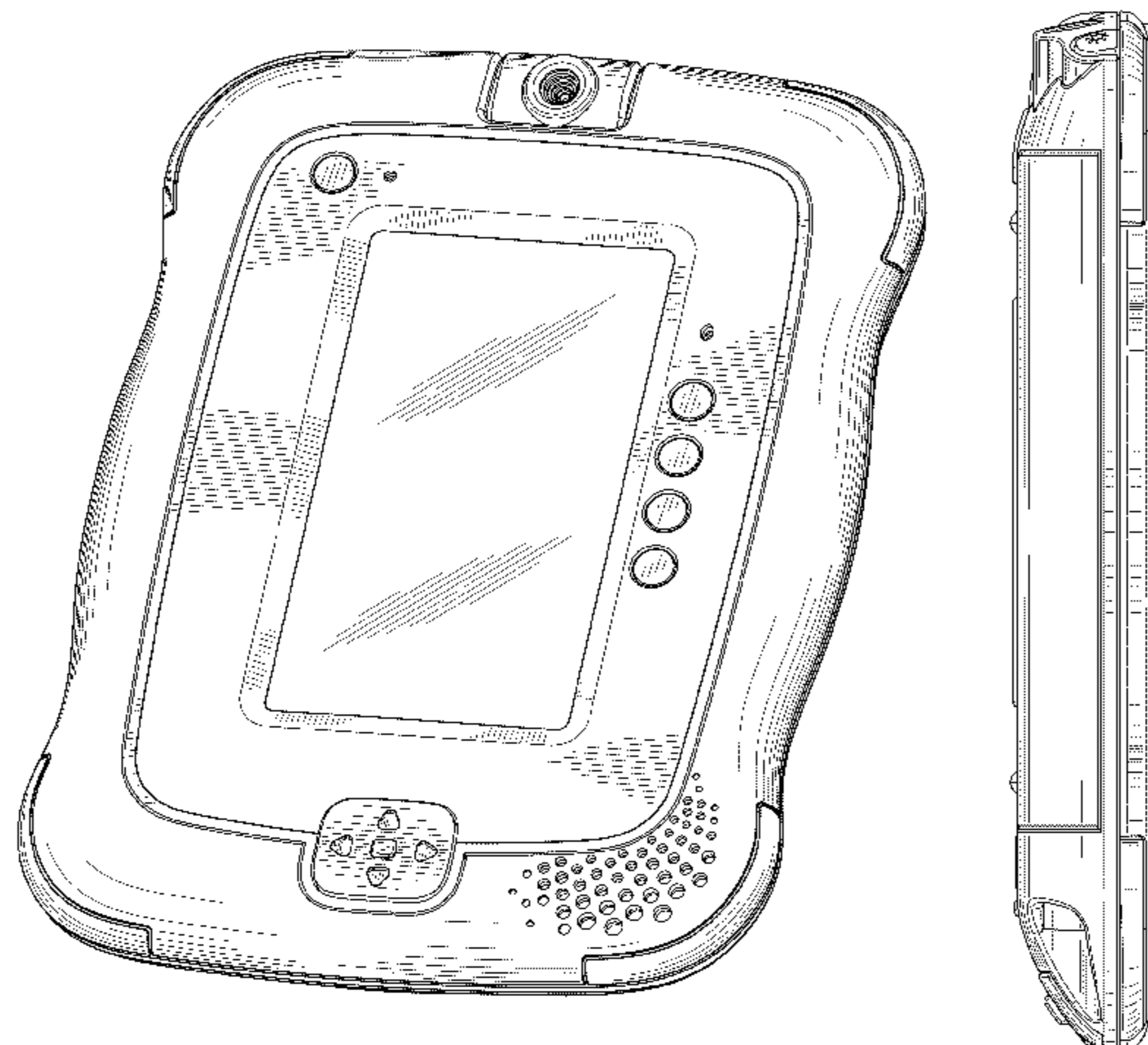
FIG. 1 is a front, right, bottom perspective view of an electronic device showing my new design.

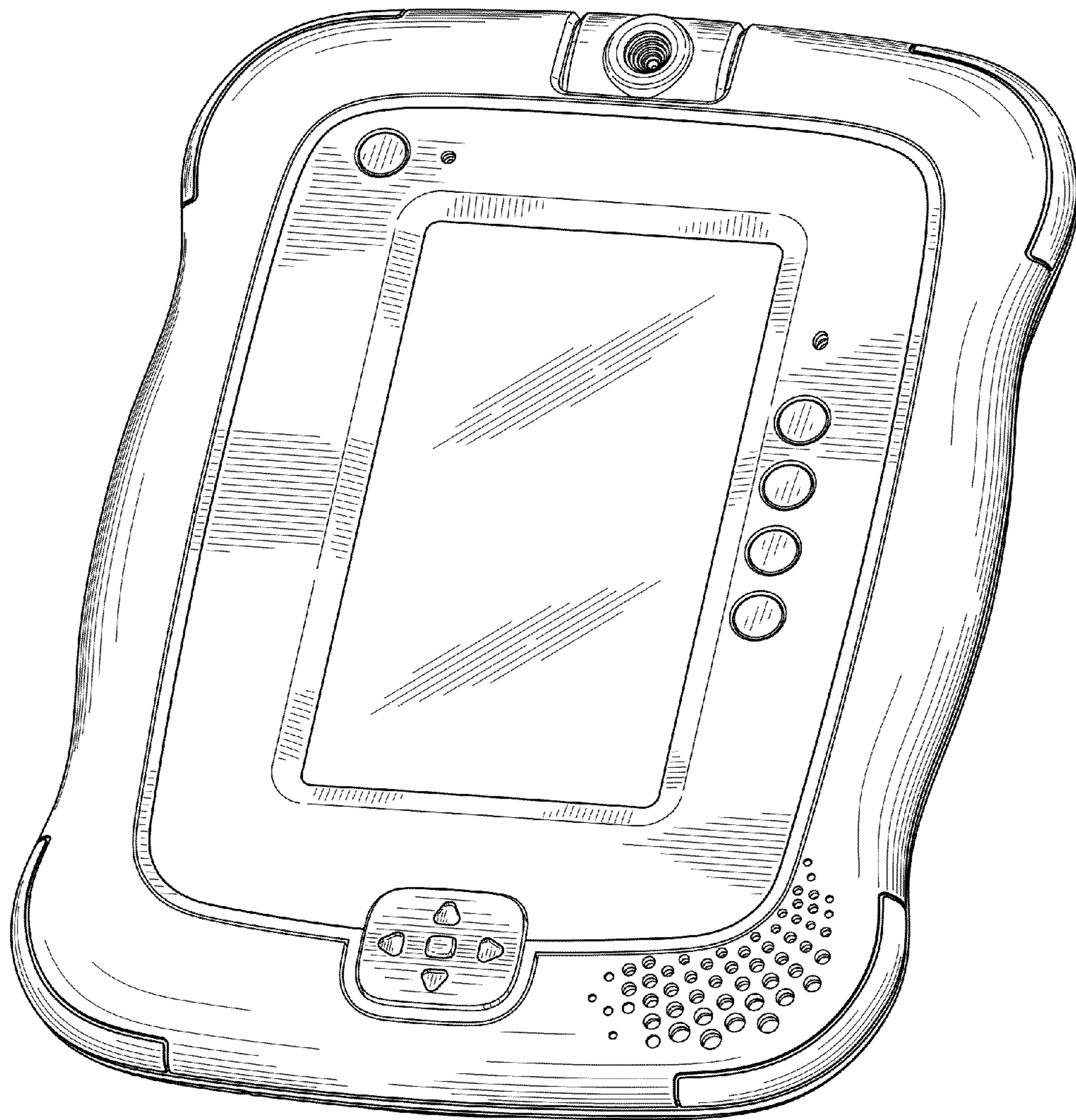

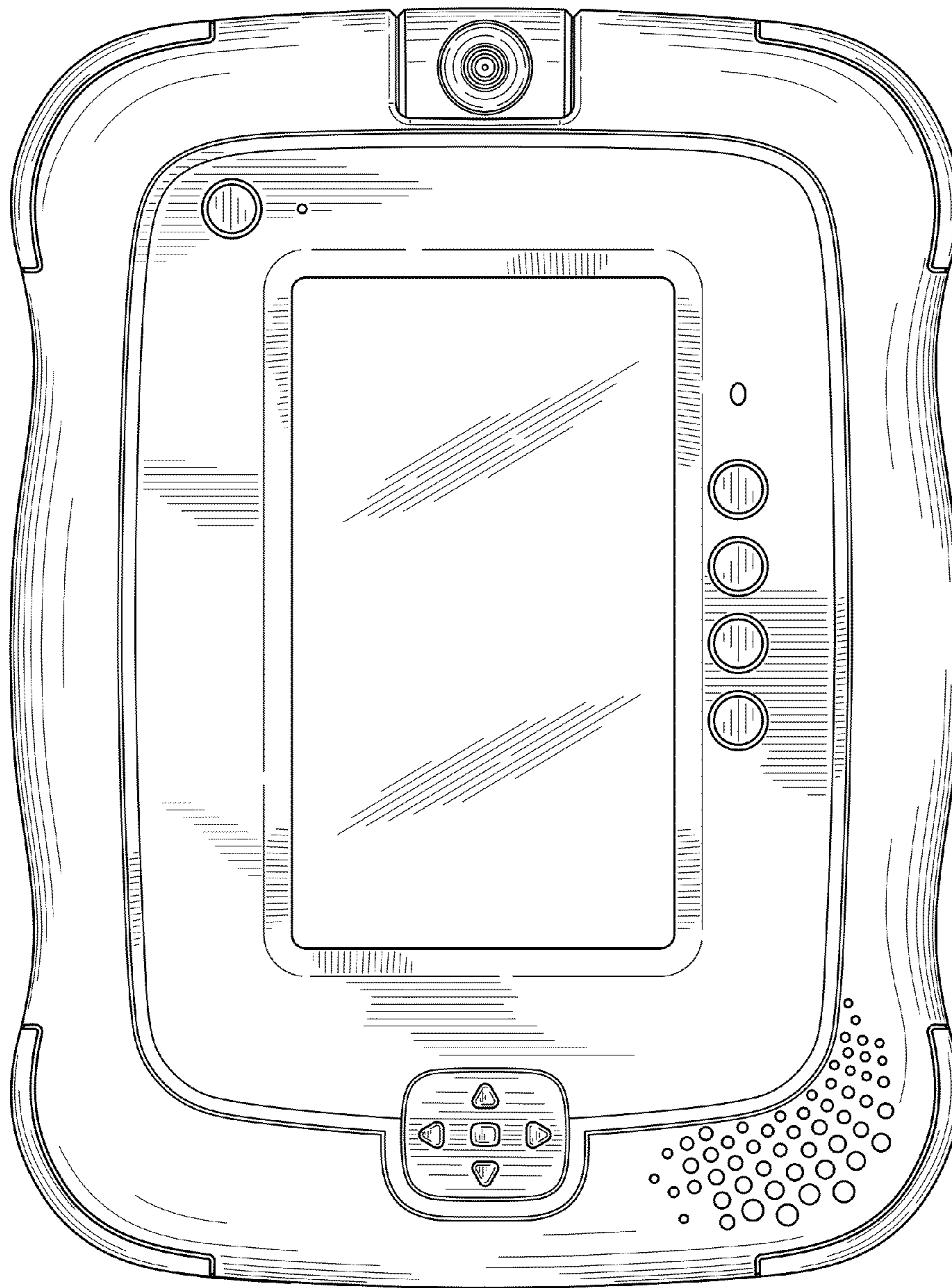

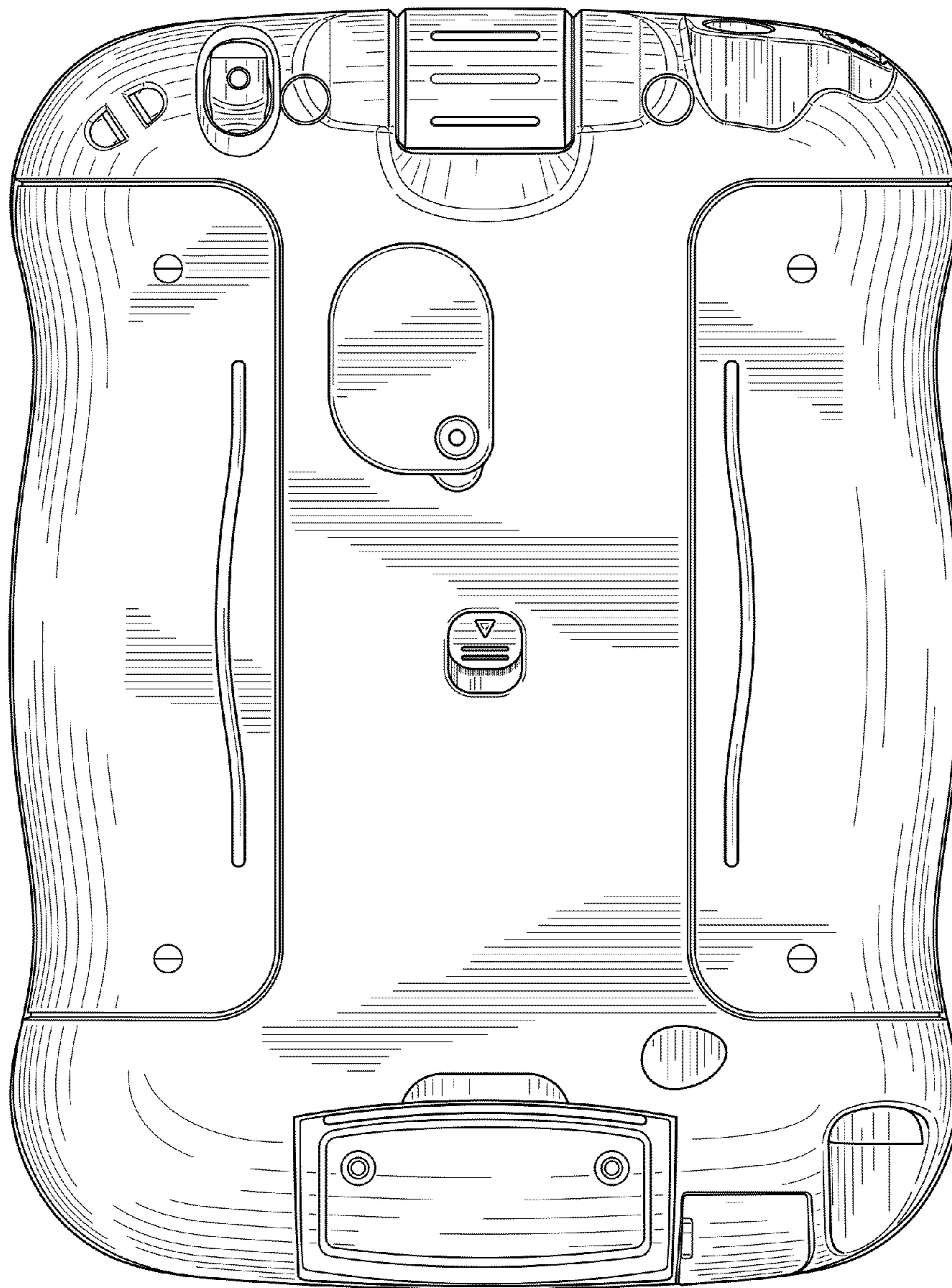

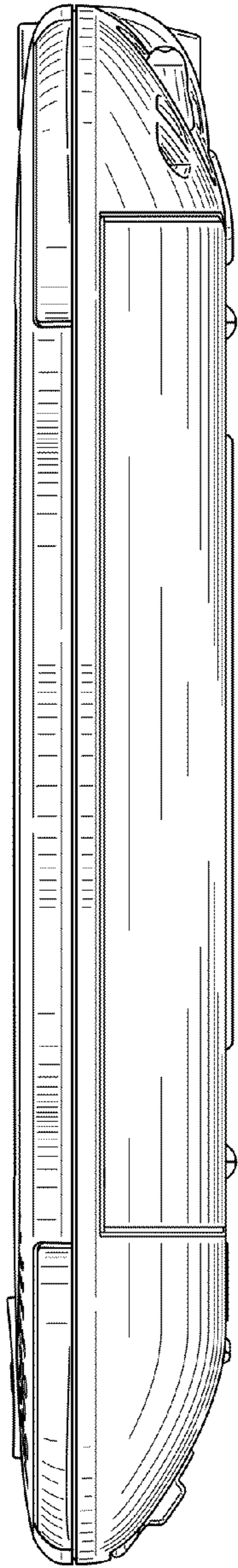

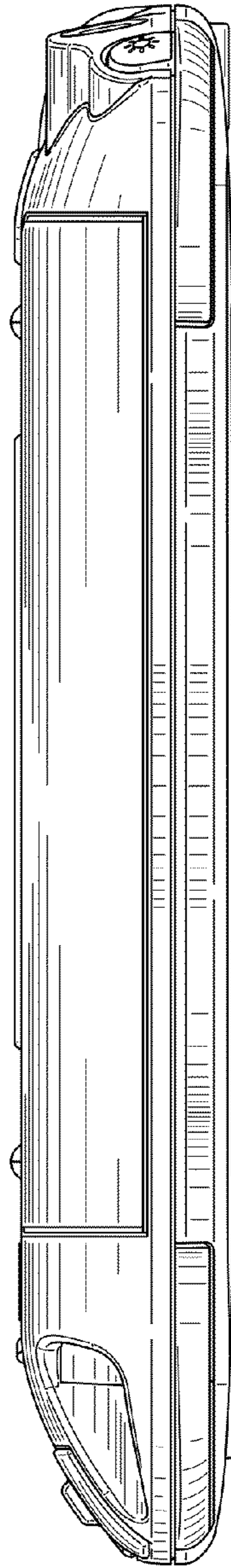

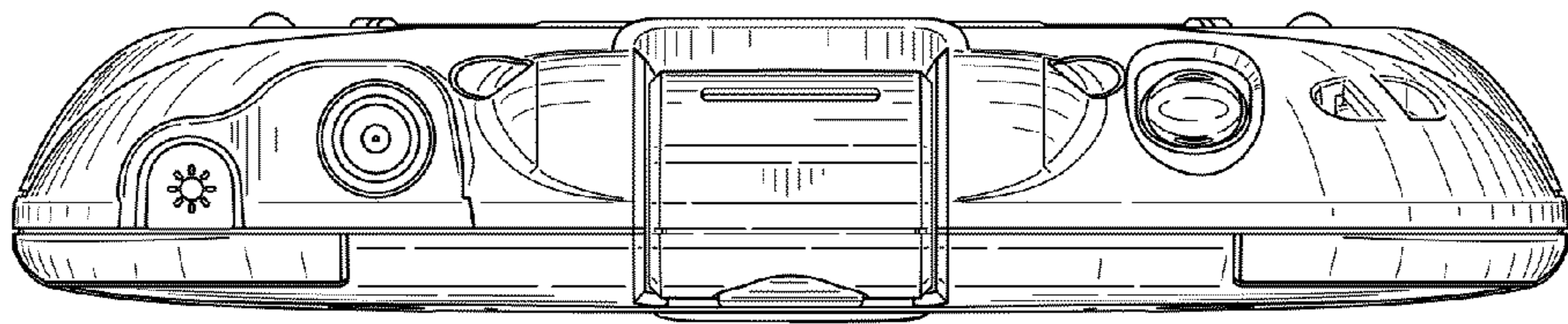

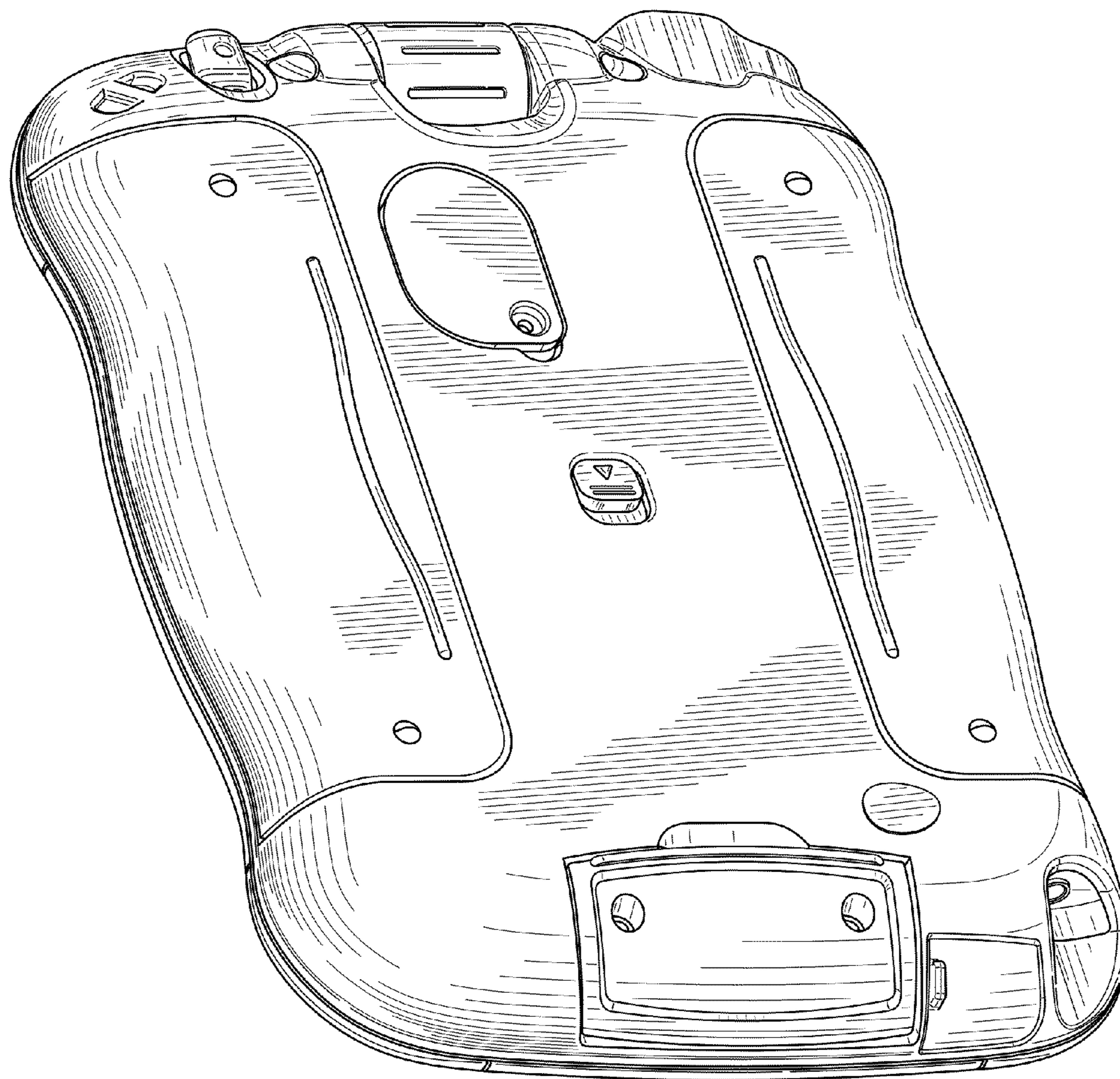
