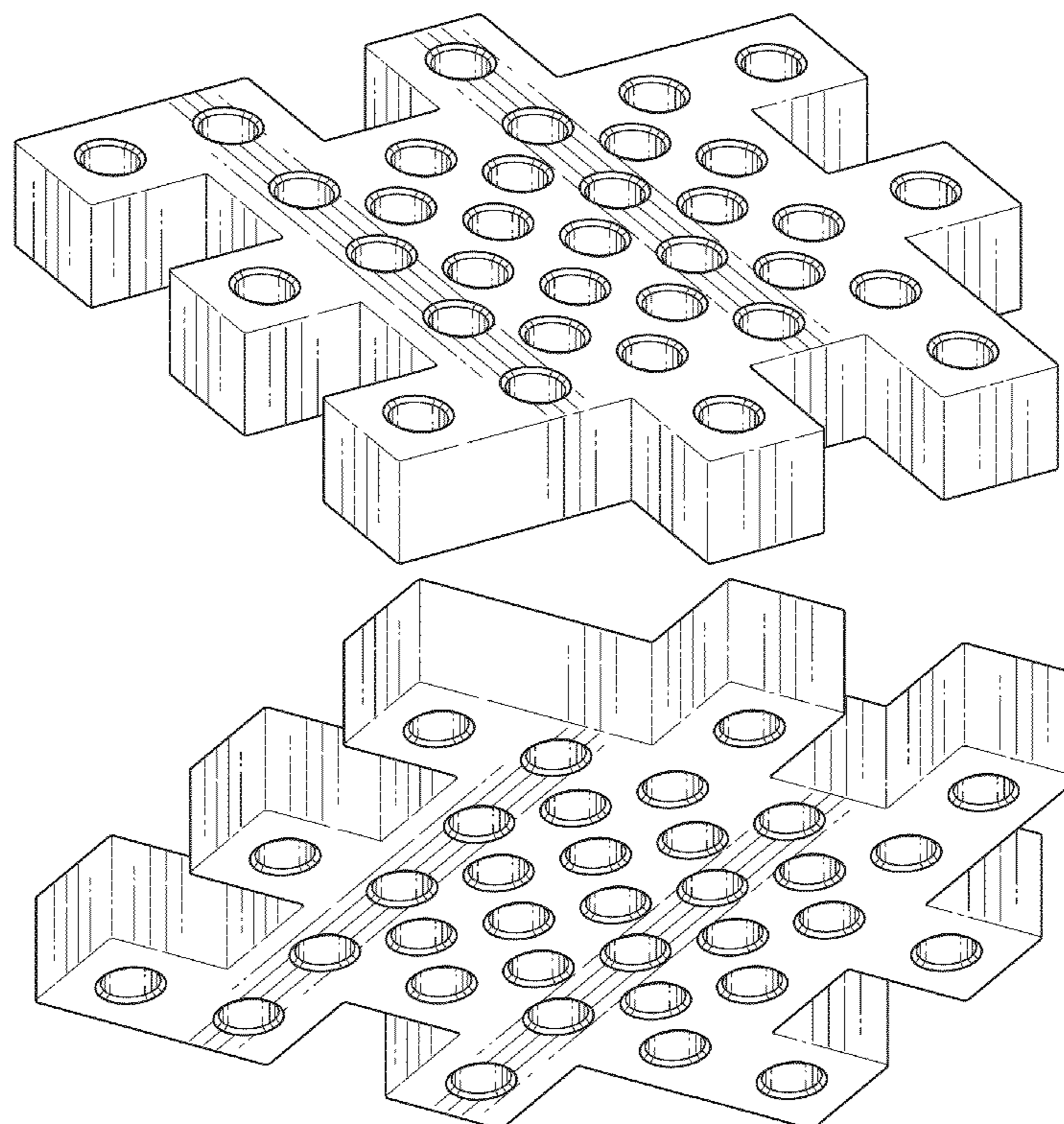
(57) **CLAIM**

The ornamental design for a base block for a toy construction set, as shown and described.

DESCRIPTION

FIG. 1 is an upper front perspective view of a base block for a toy construction set showing our new design; FIG. 2 is a lower front perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a left side elevation view thereof; and, FIG. 8 is a right side elevation view thereof.

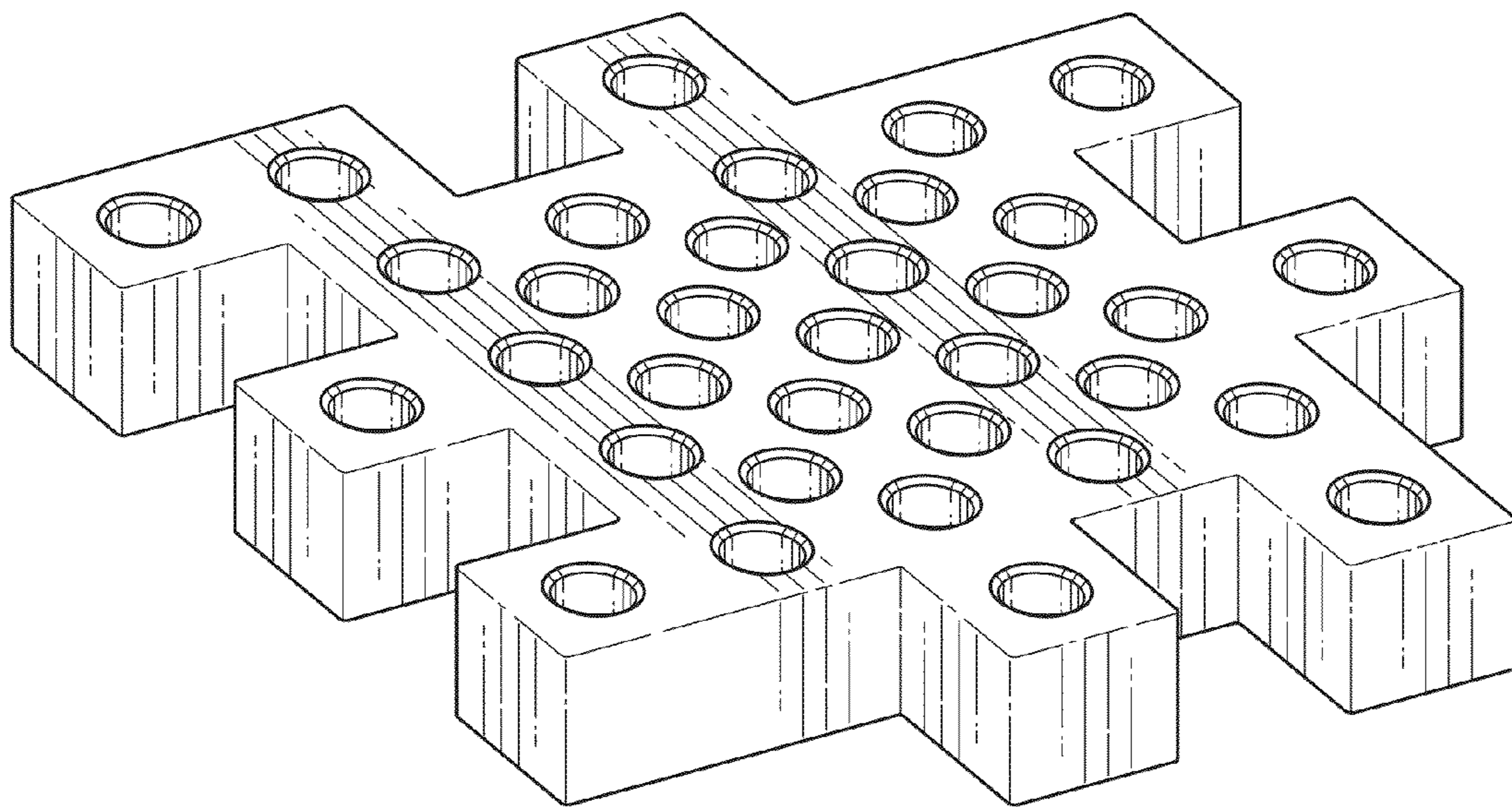

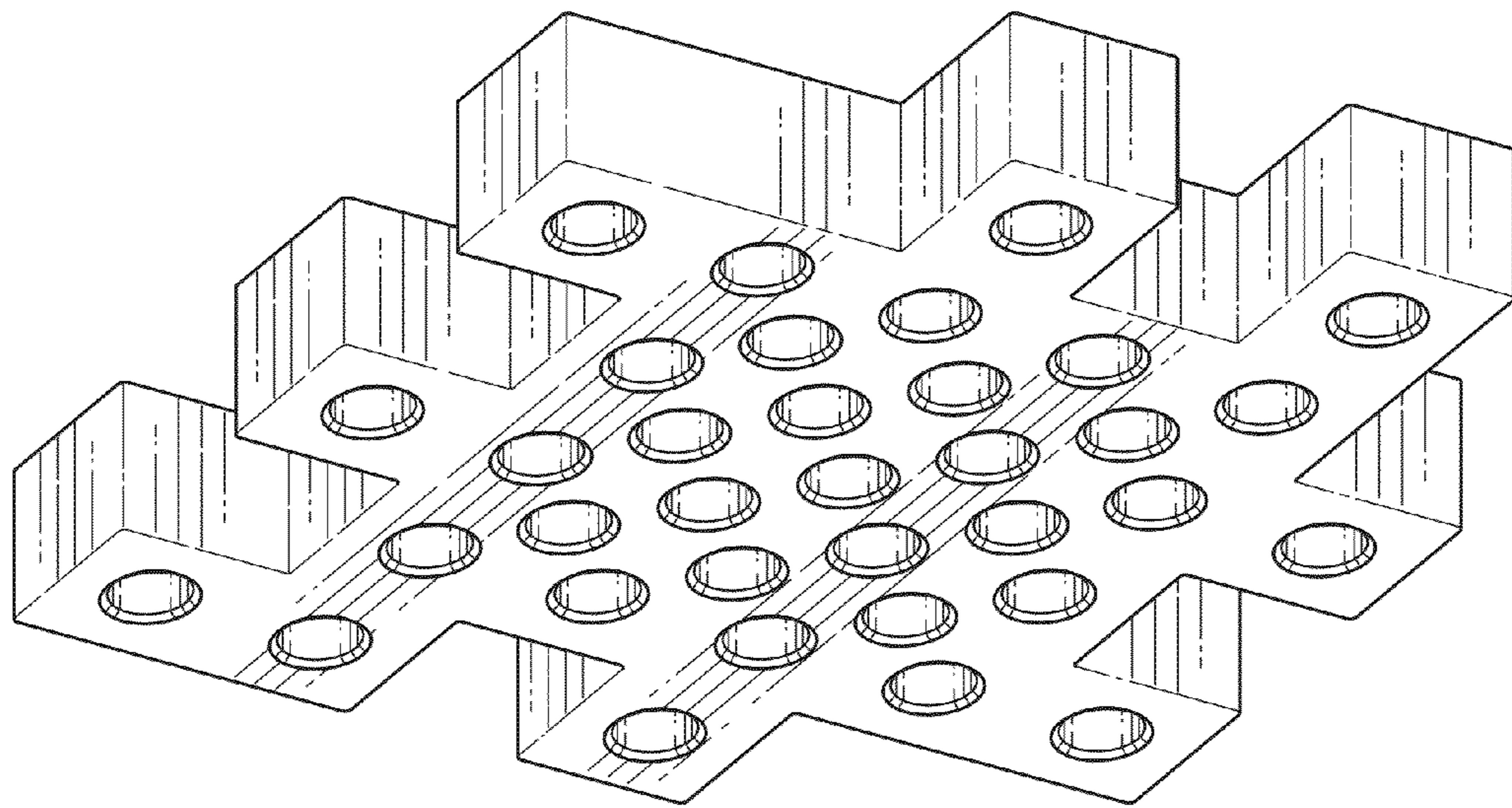

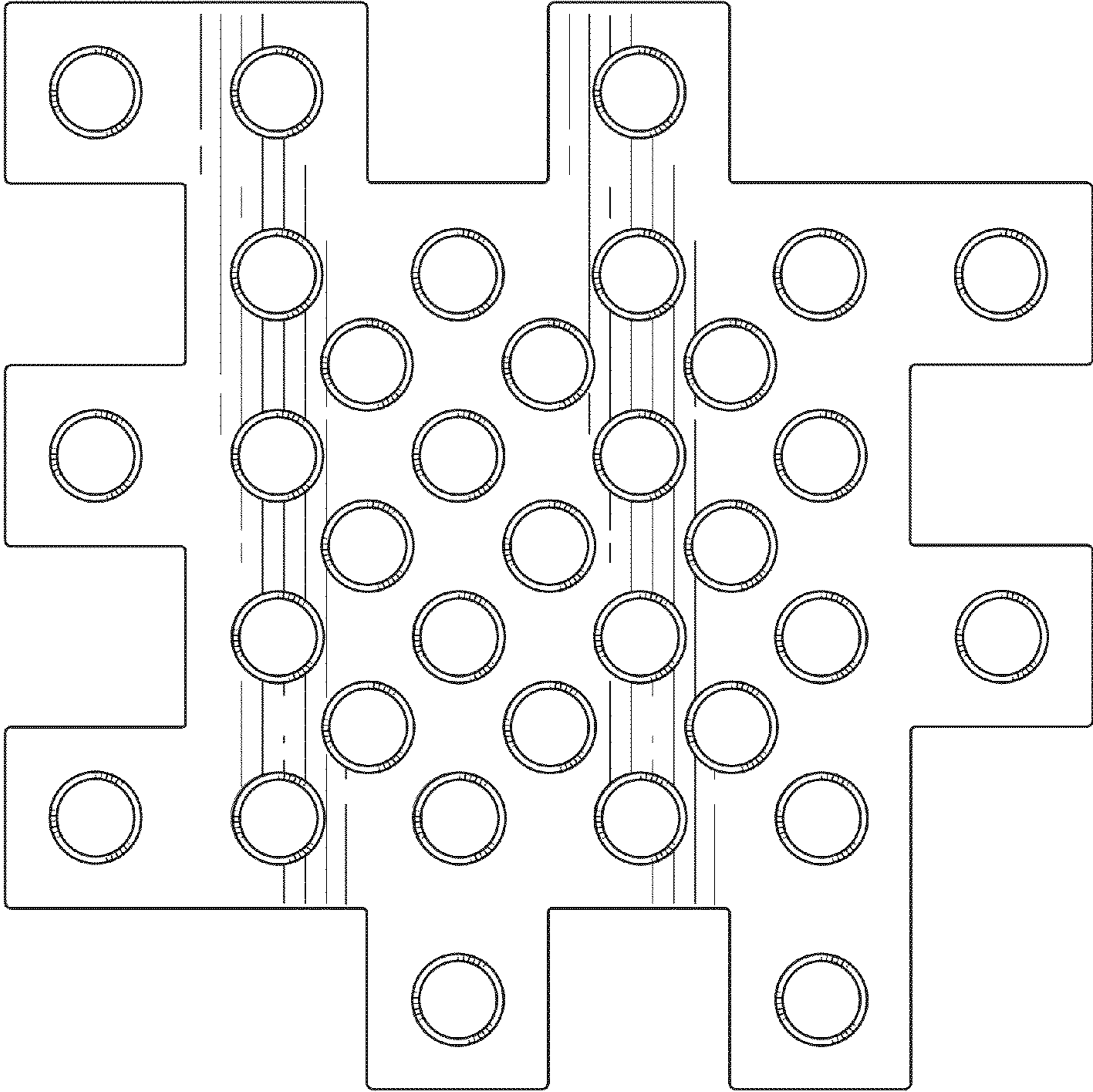

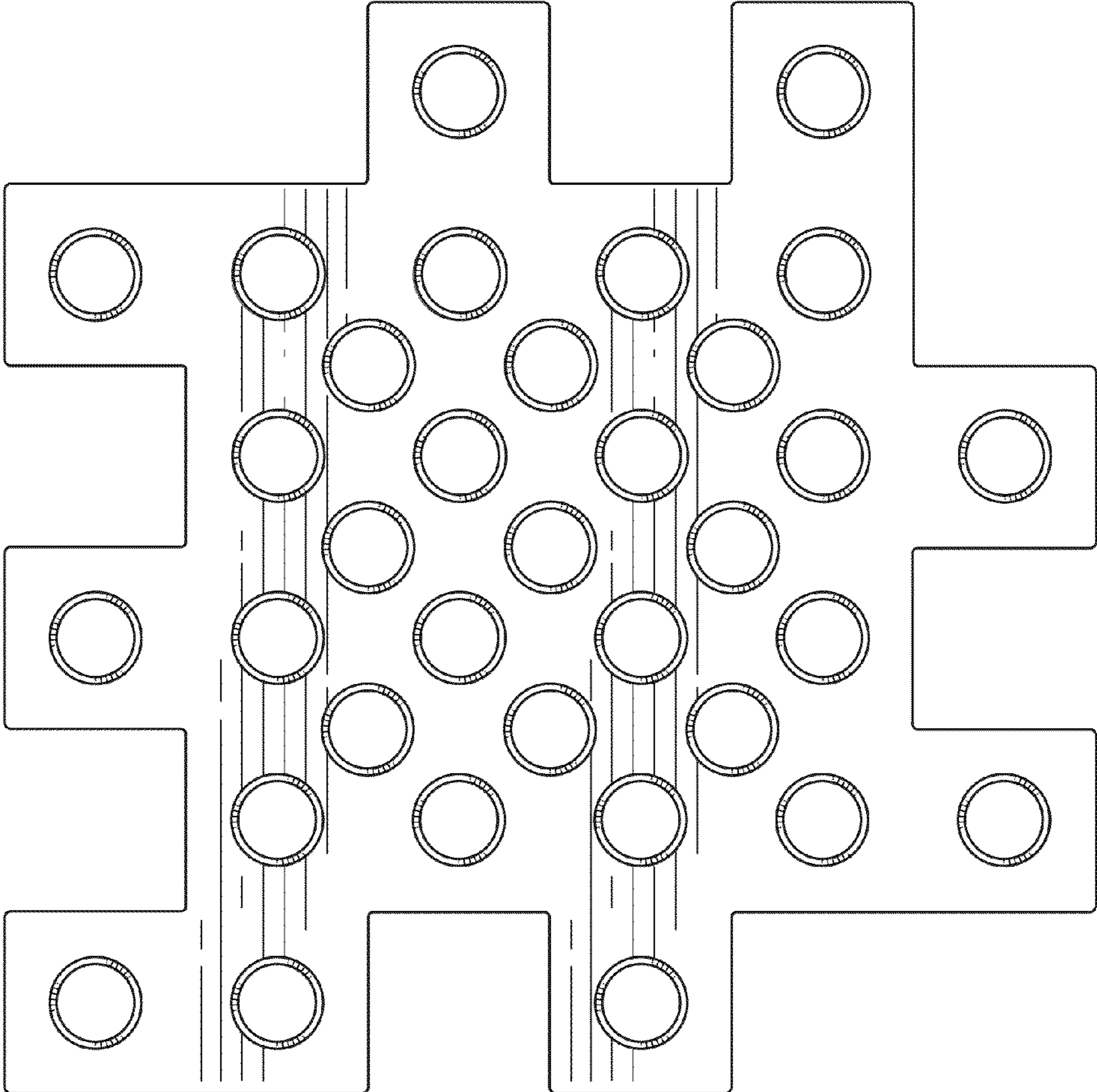

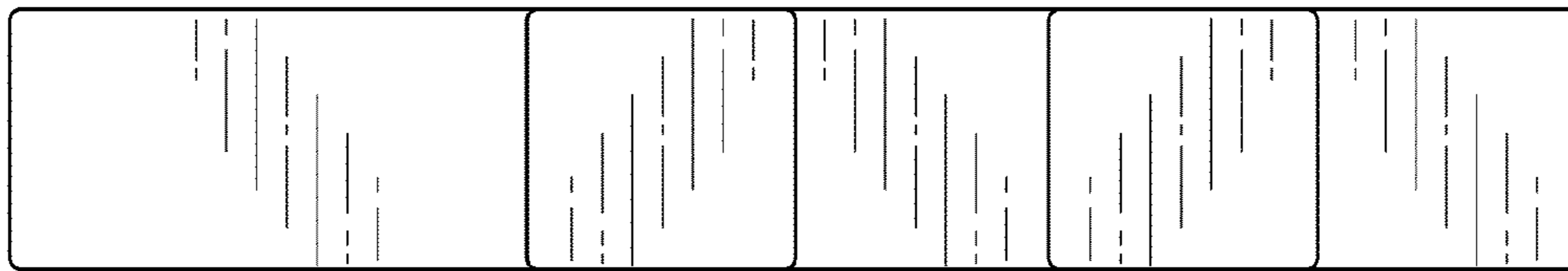

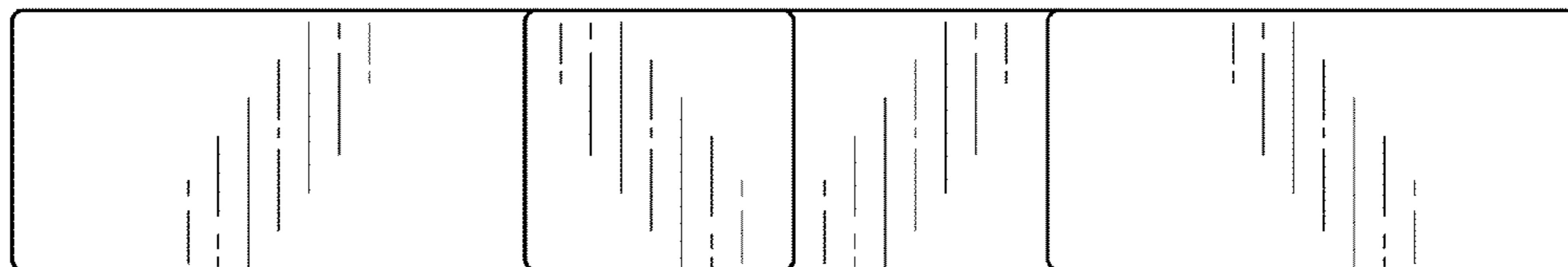

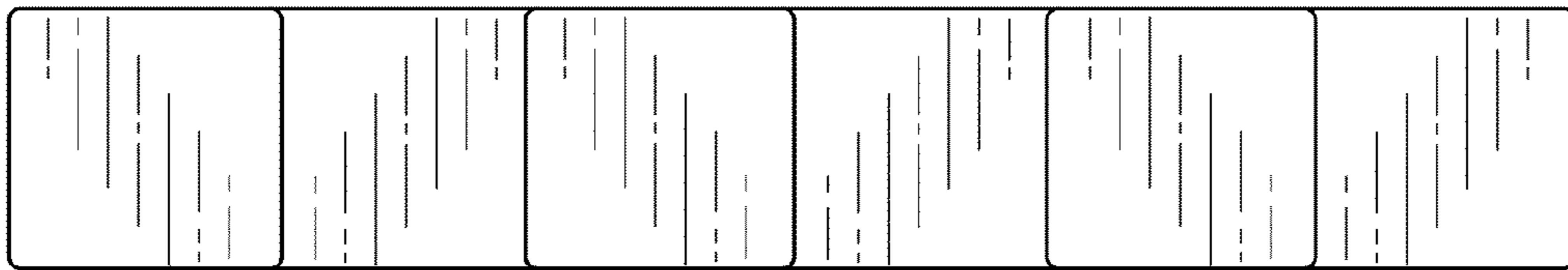

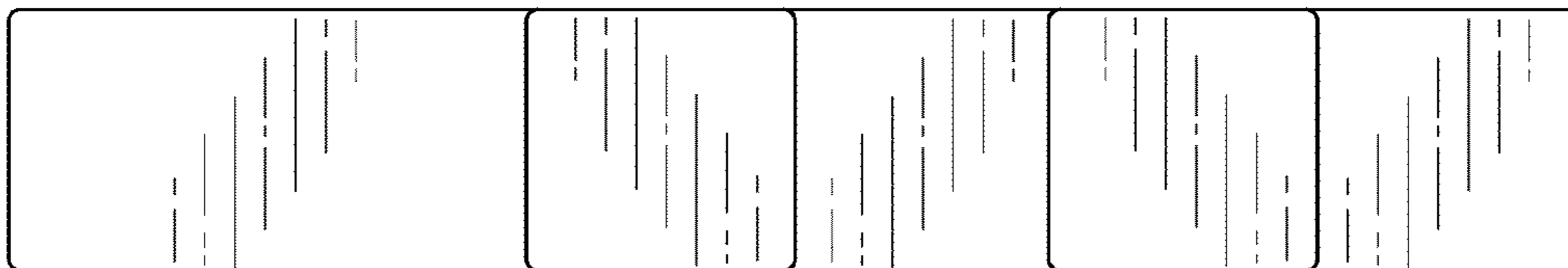
