FIG. 3 is a right side view of the embodiment shown in FIG. 1.

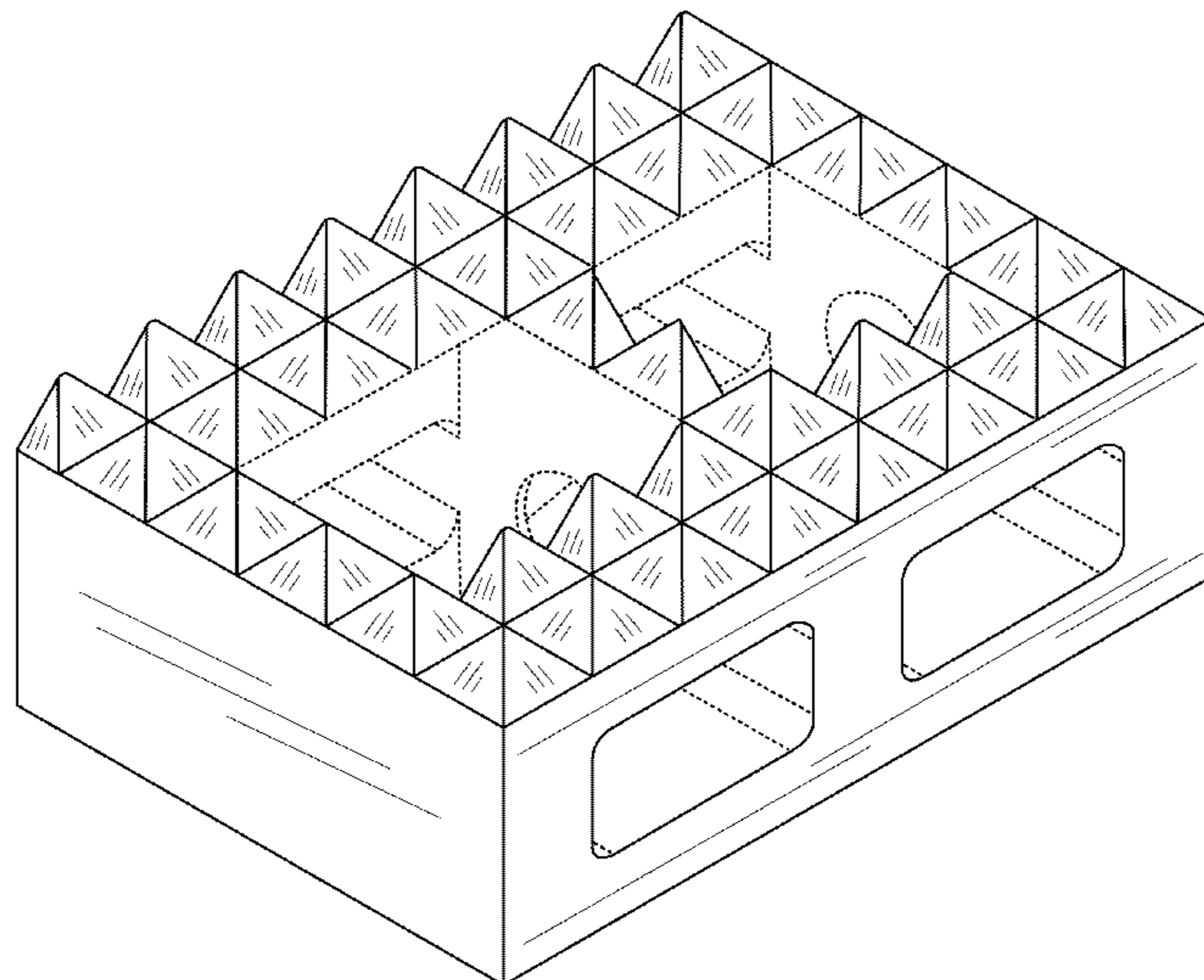
FIG. 4 is a left side view of the embodiment shown in FIG. 1.

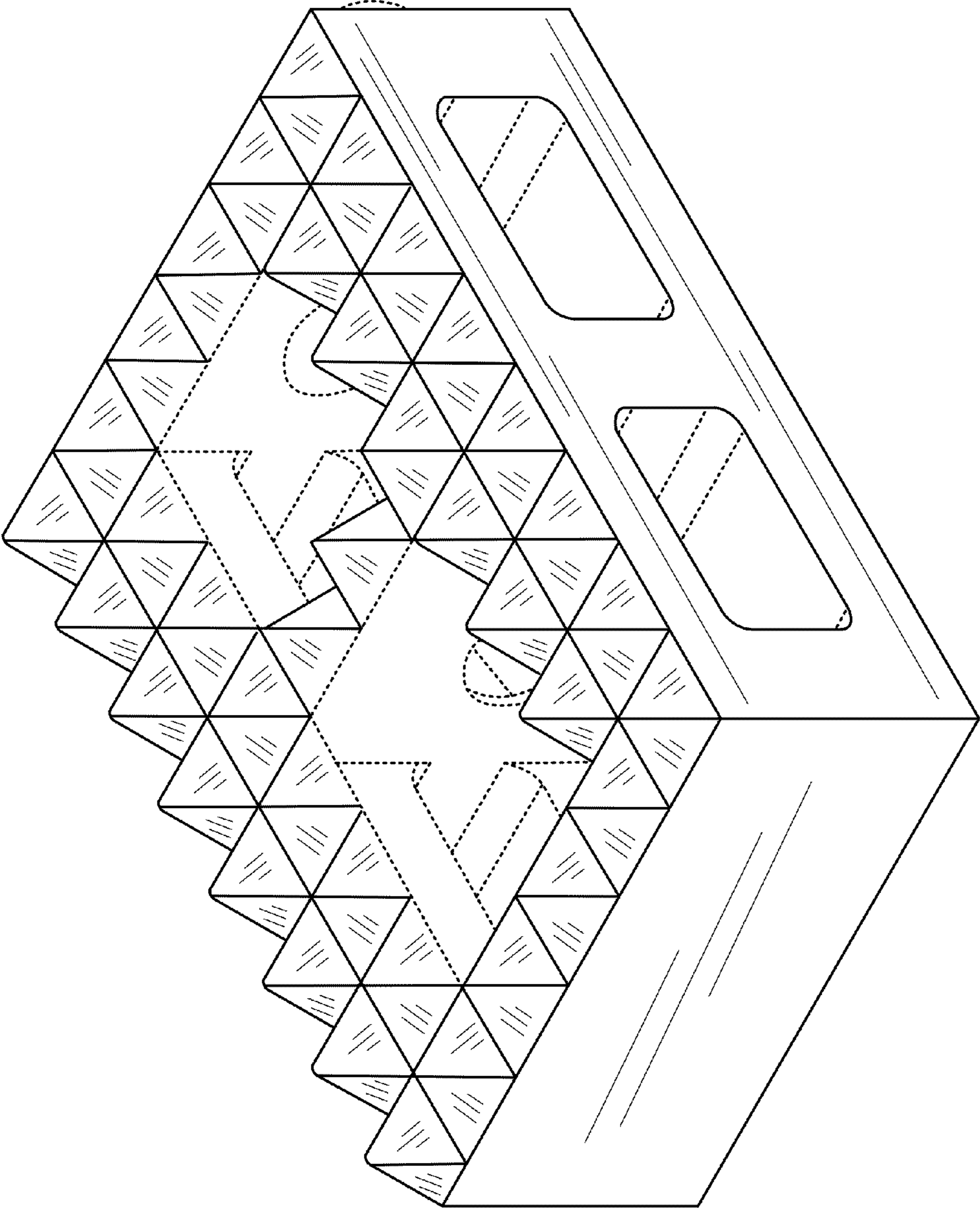

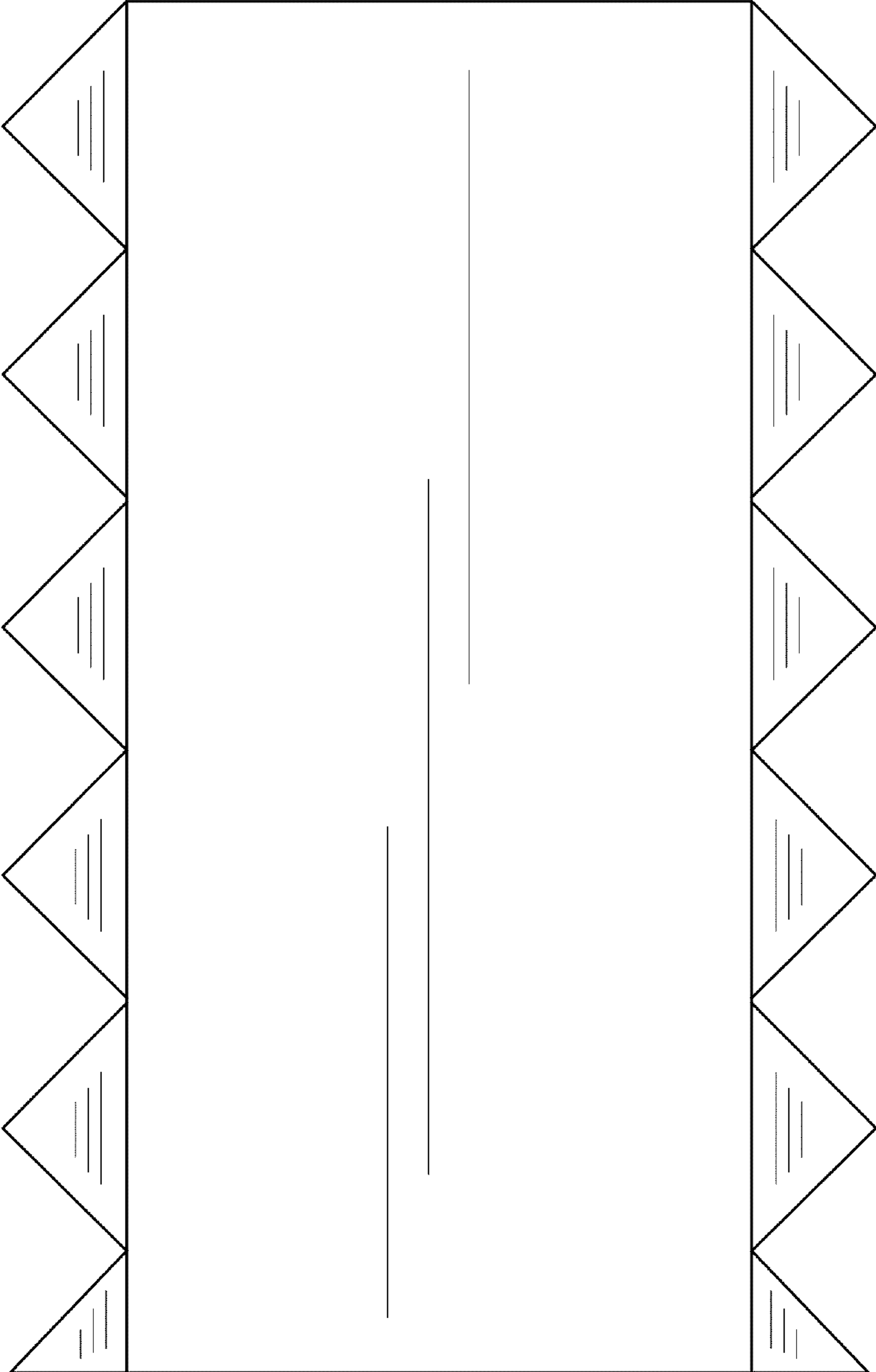

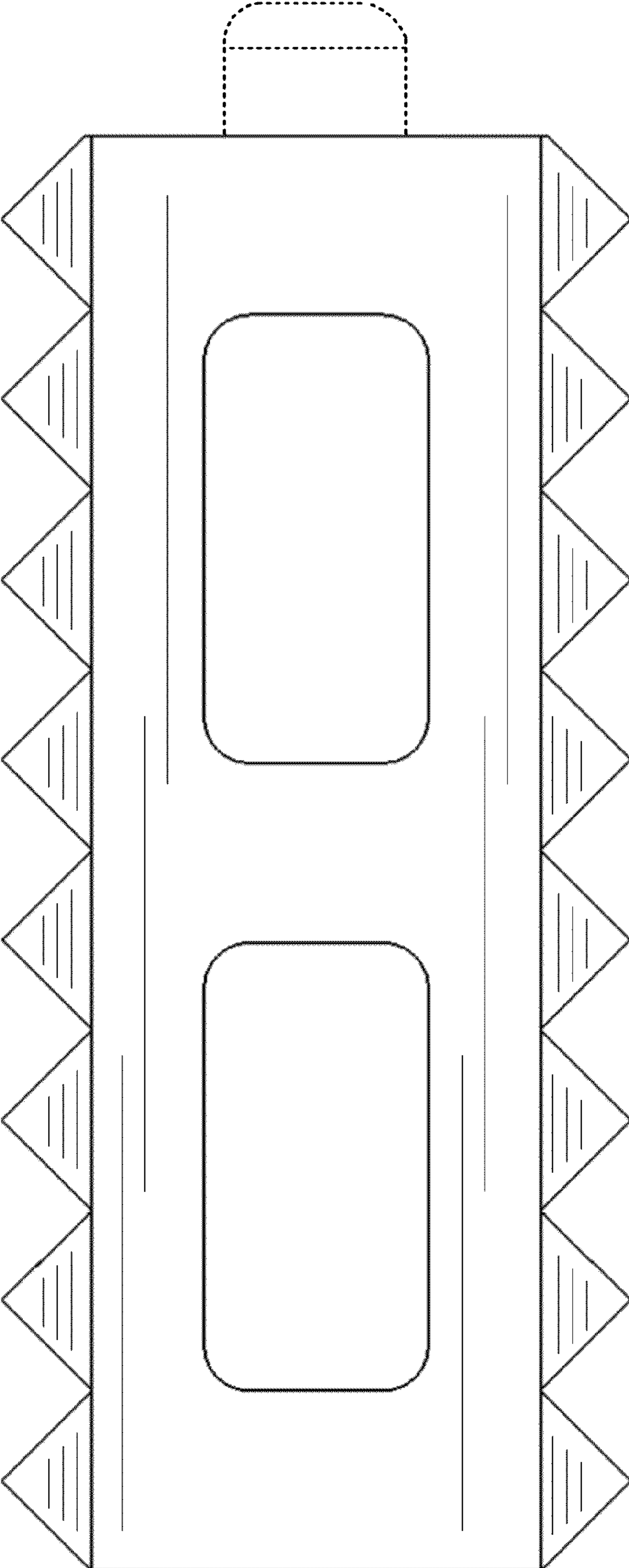

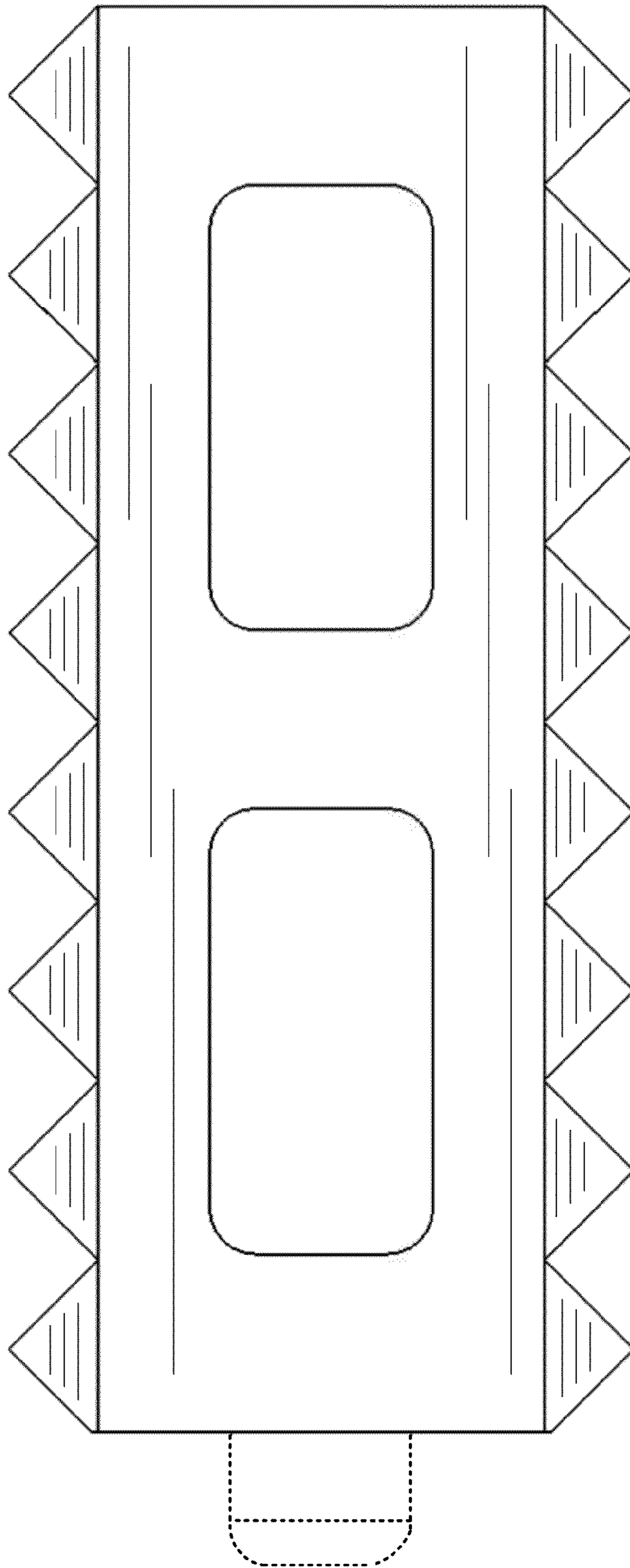

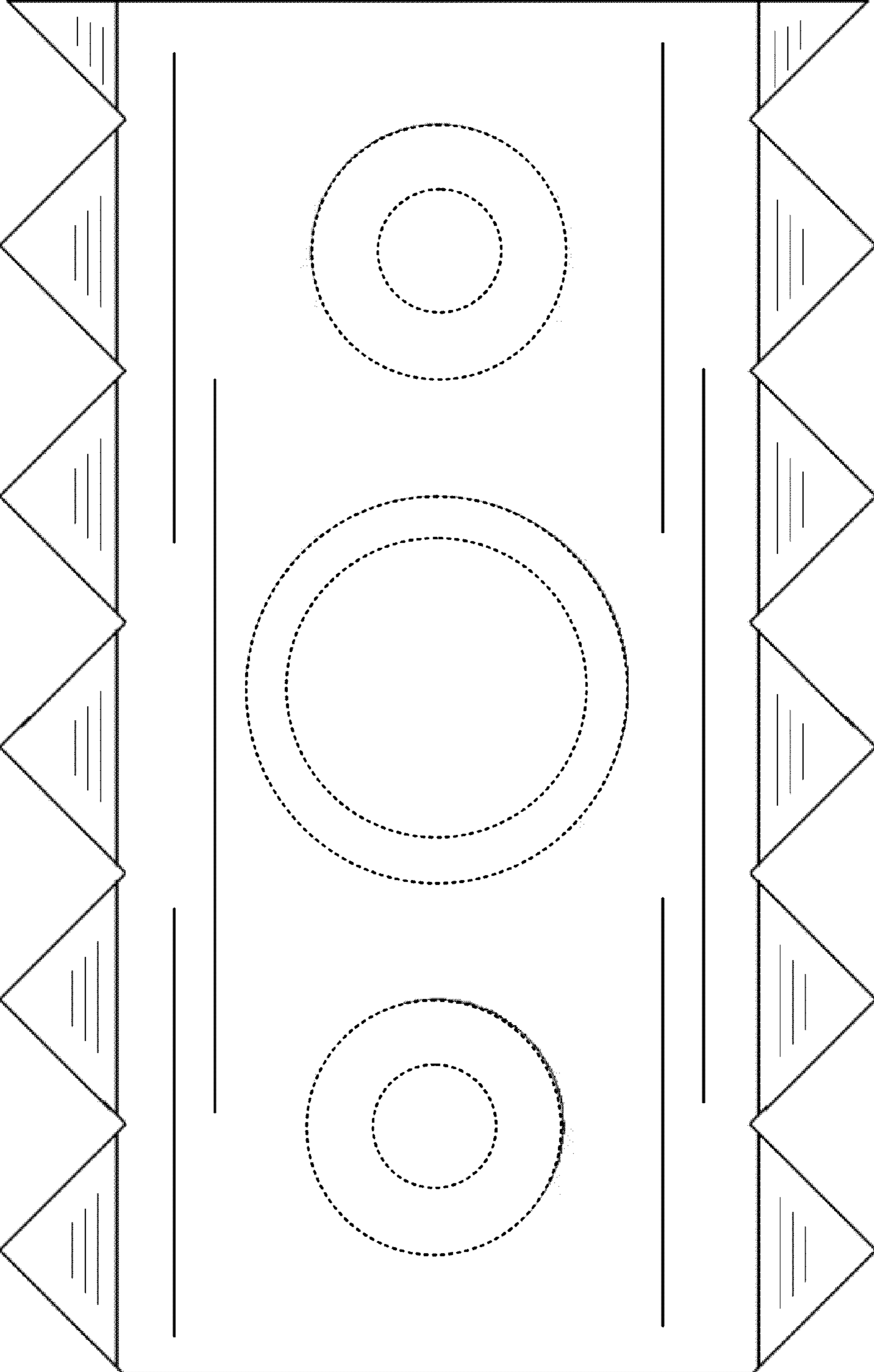

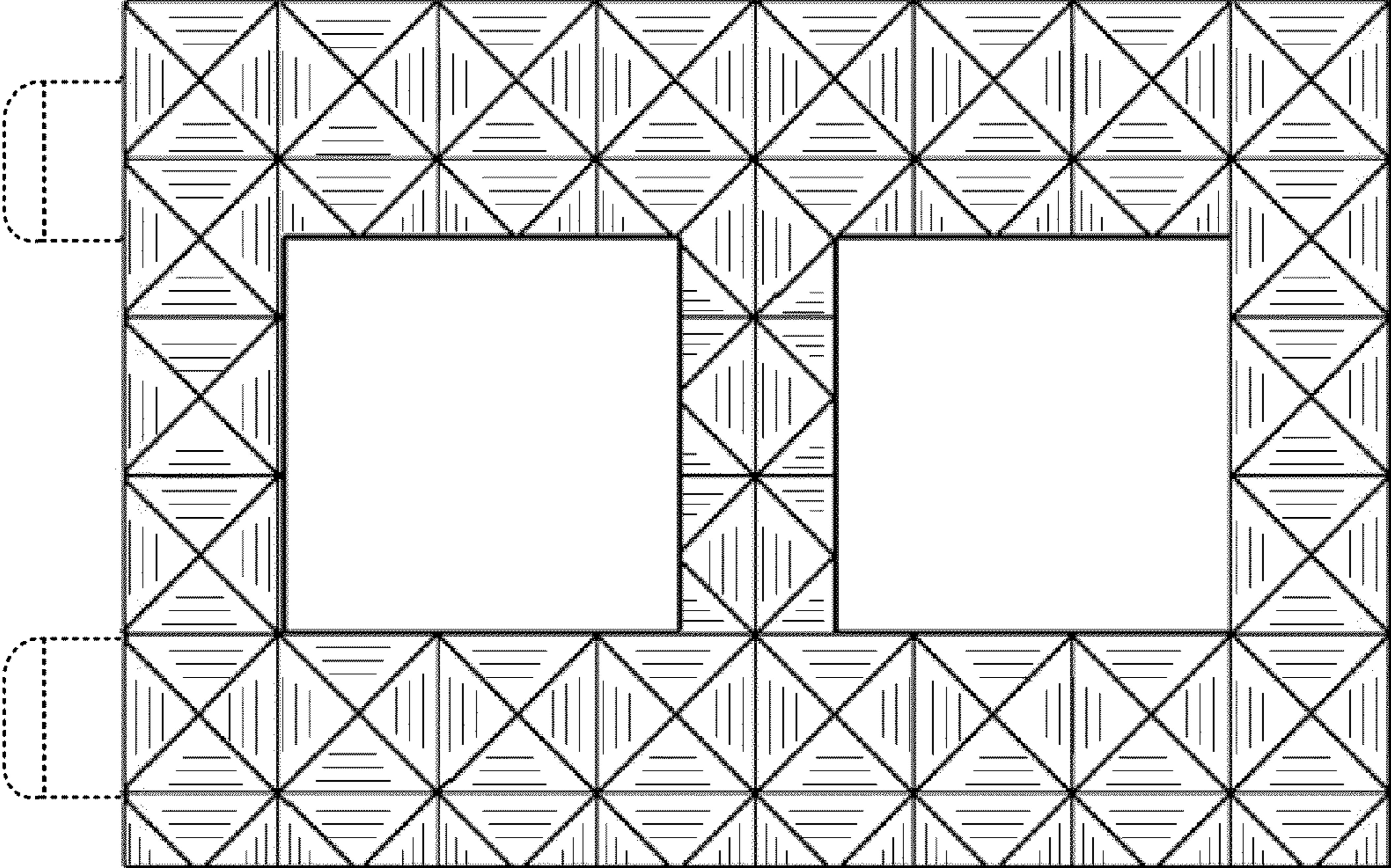
