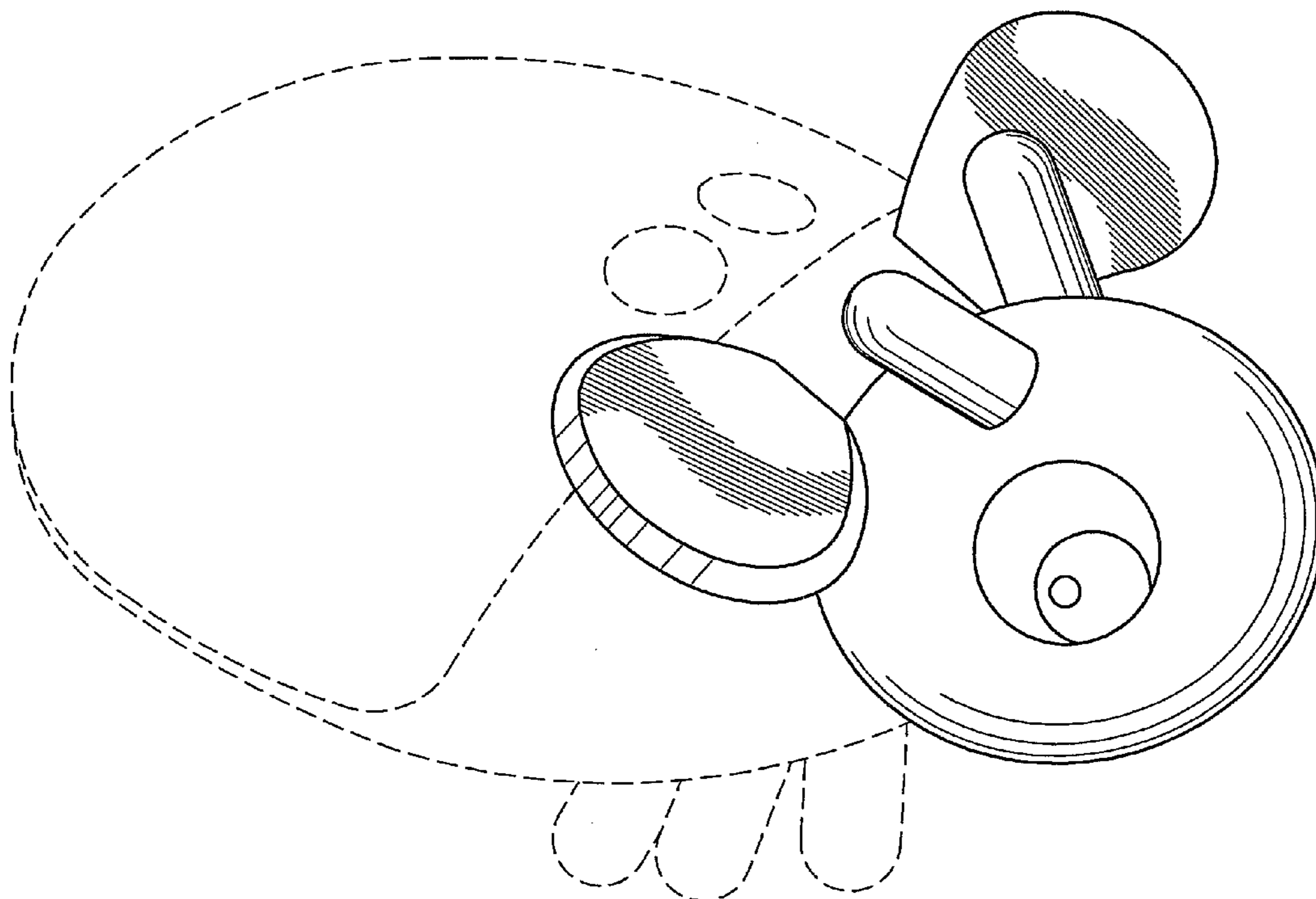
(57) **CLAIM**

I claim the ornamental design for a projection light, as shown and described.

**DESCRIPTION**

FIG. 1 is a side perspective view of a projection light.  
FIG. 2 is a side view of the right side of the projection light.  
FIG. 3 is a side view of the left side of the projection light.  
FIG. 4 is a plan view of the projection light.  
FIG. 5 is a bottom view of the projection light.  
FIG. 6 is a front elevation view of the projection light; and,

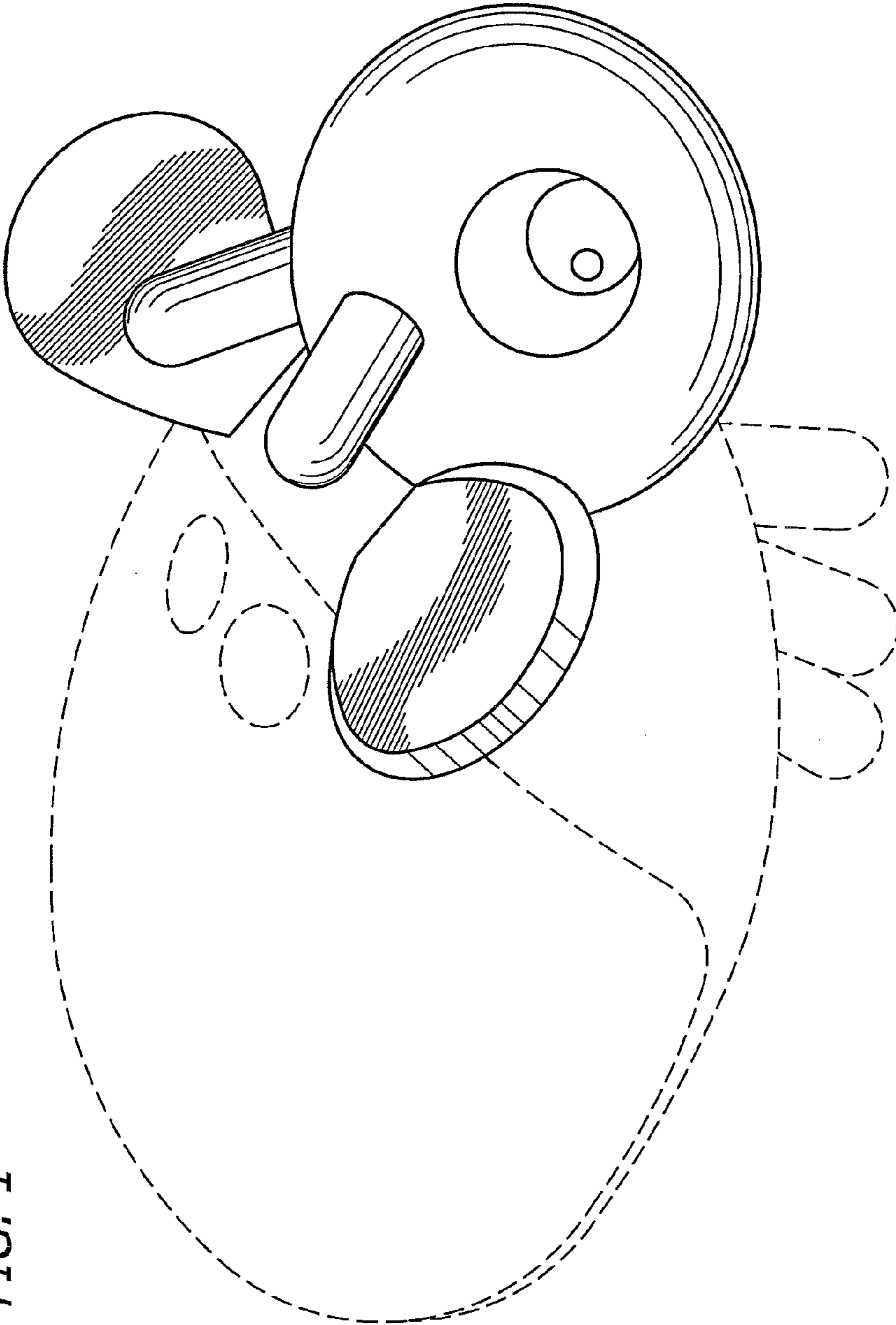

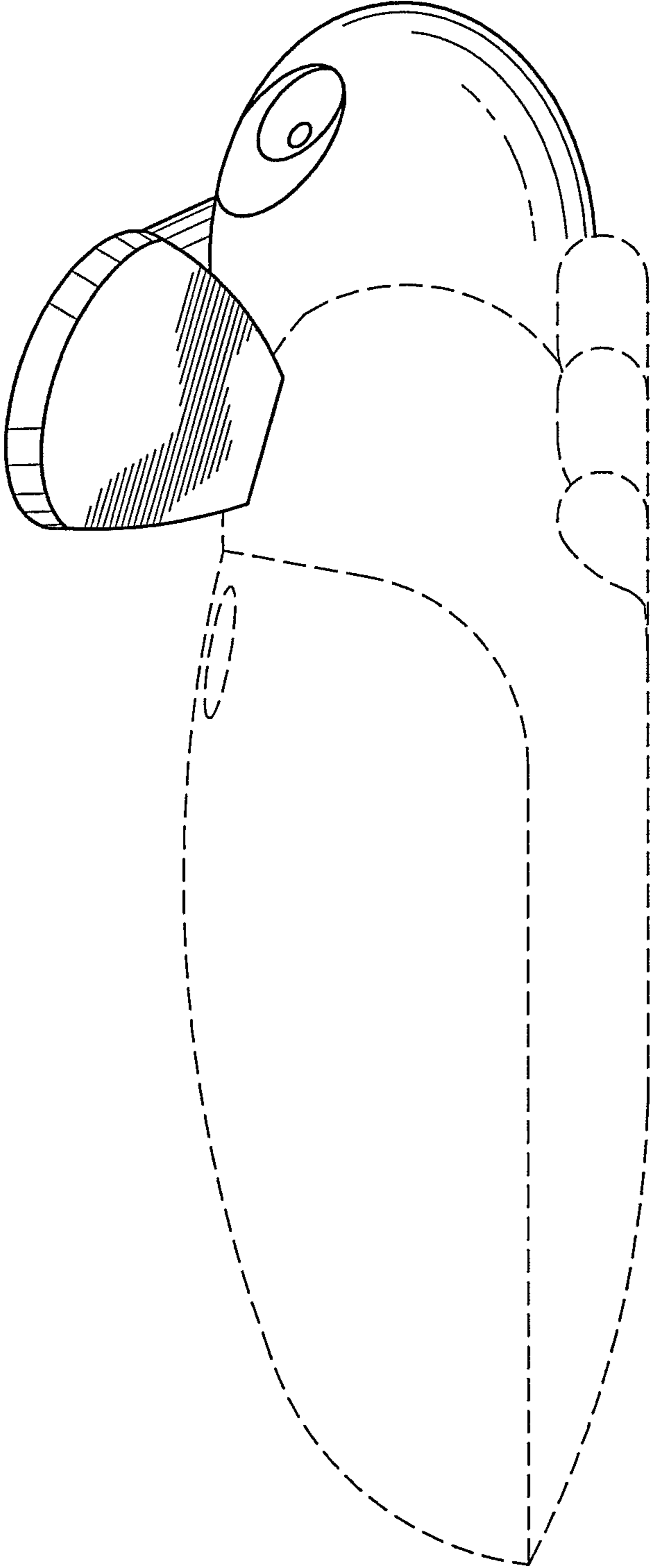
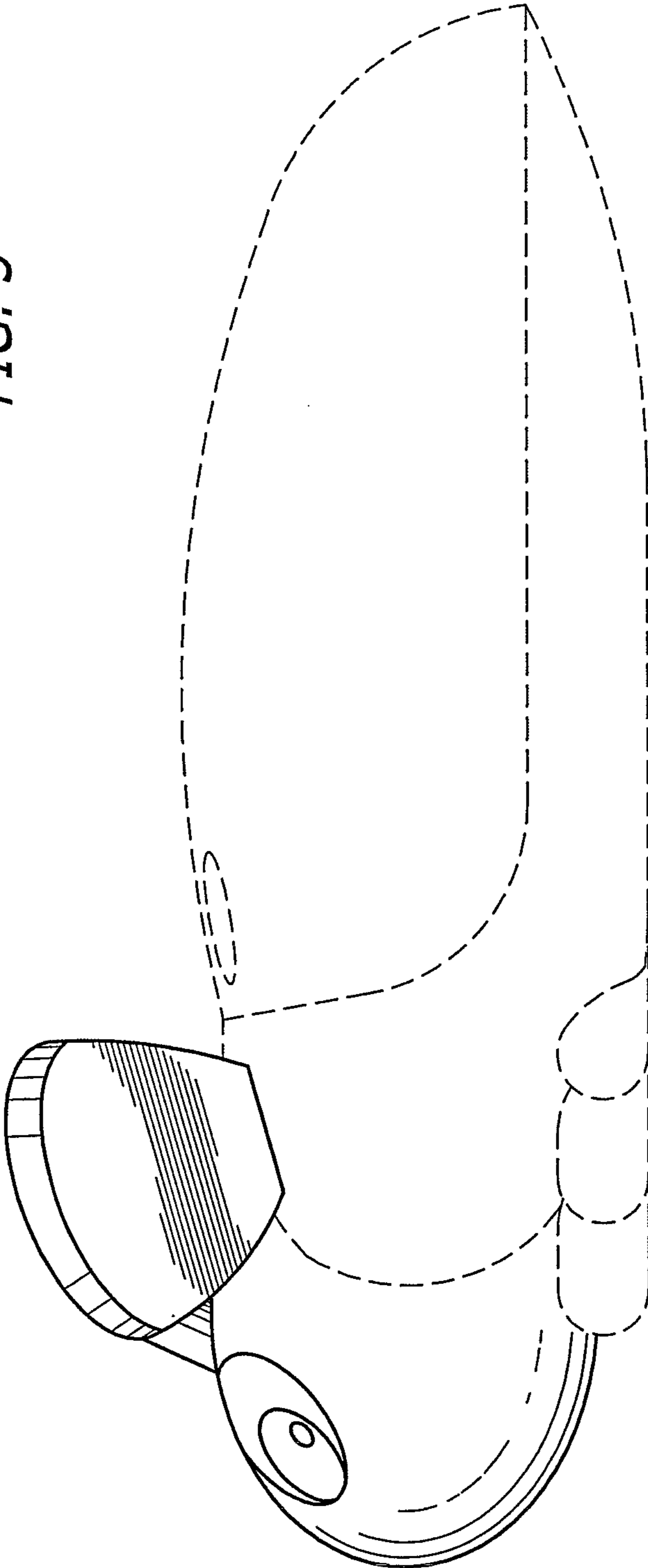

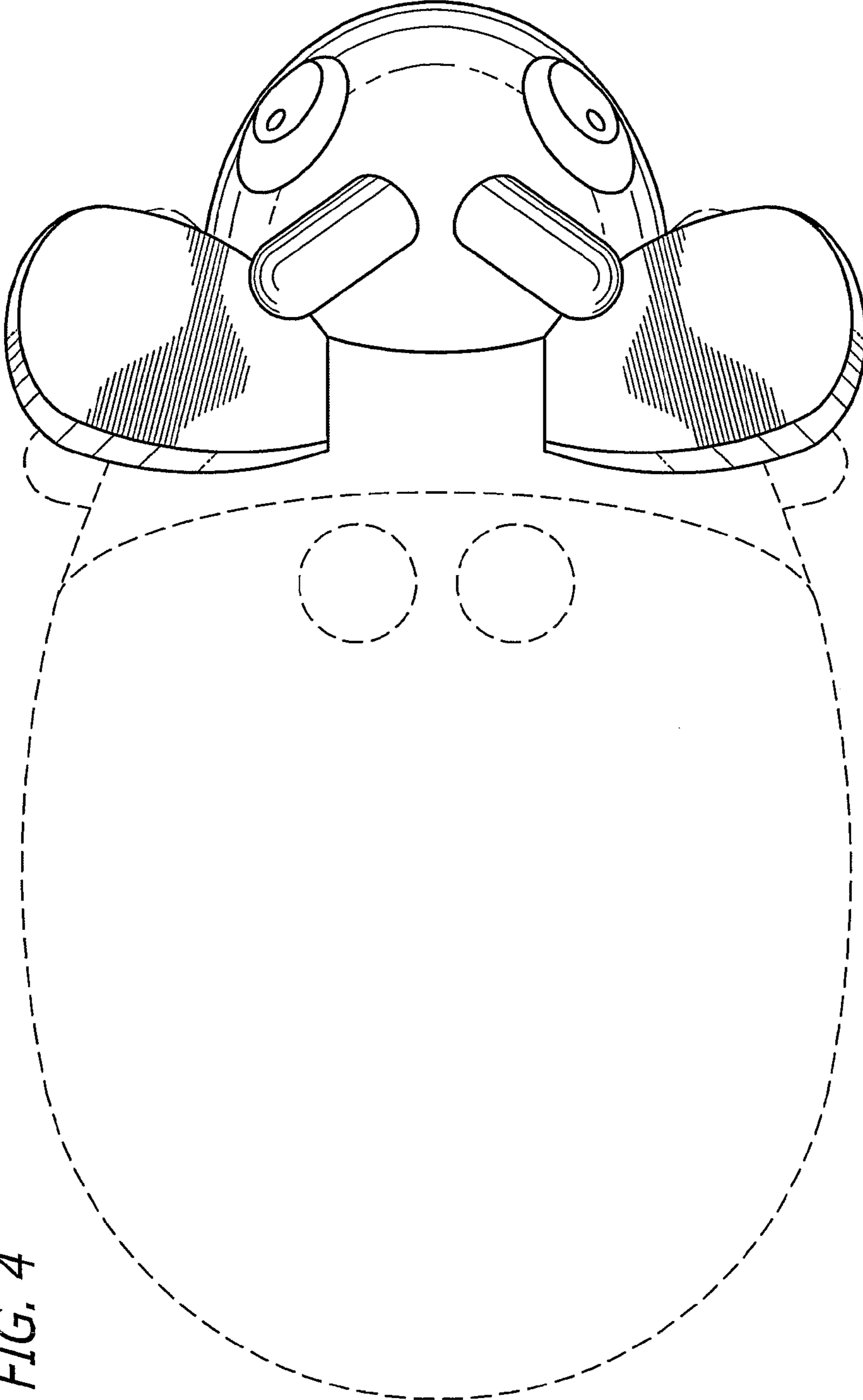

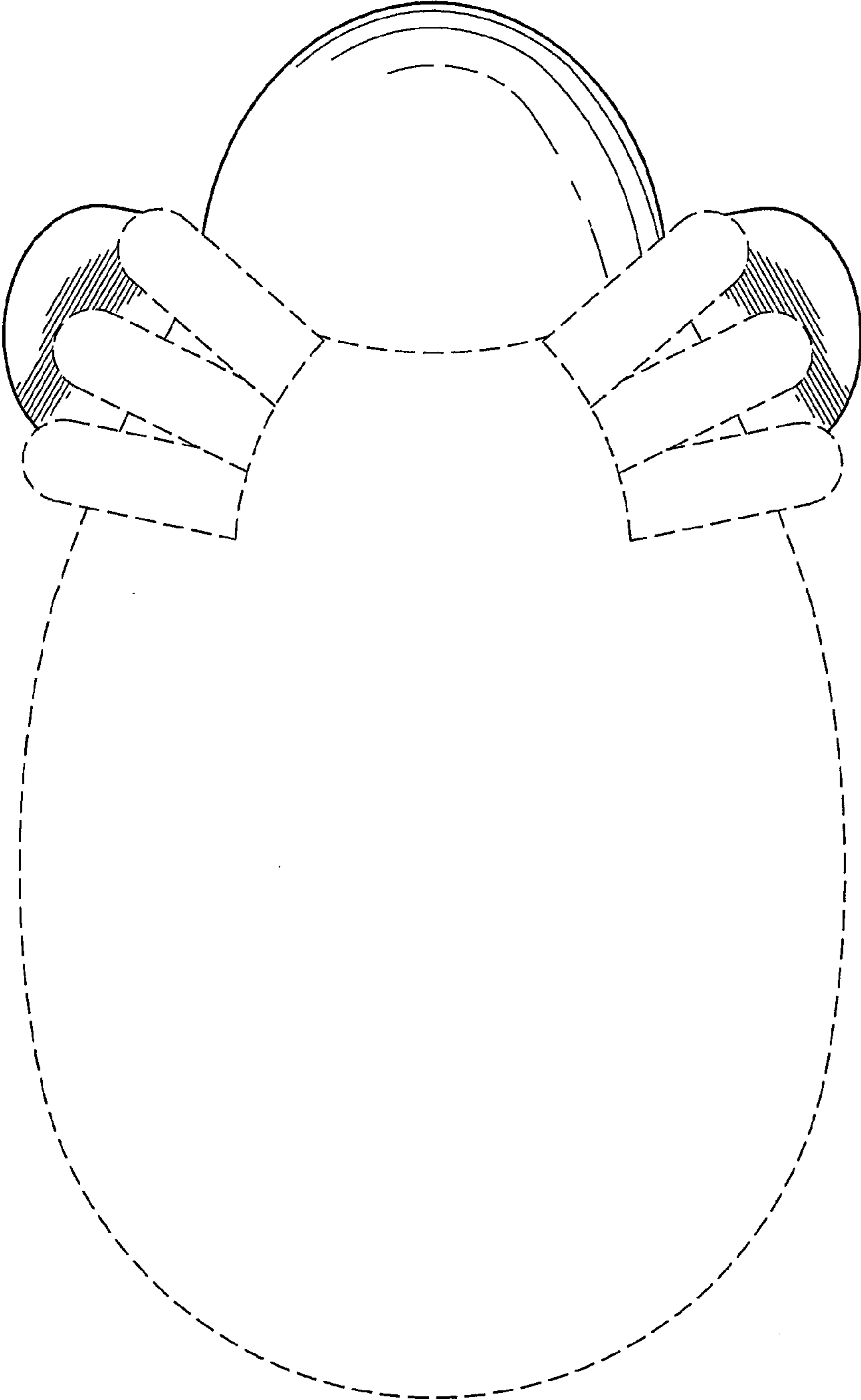

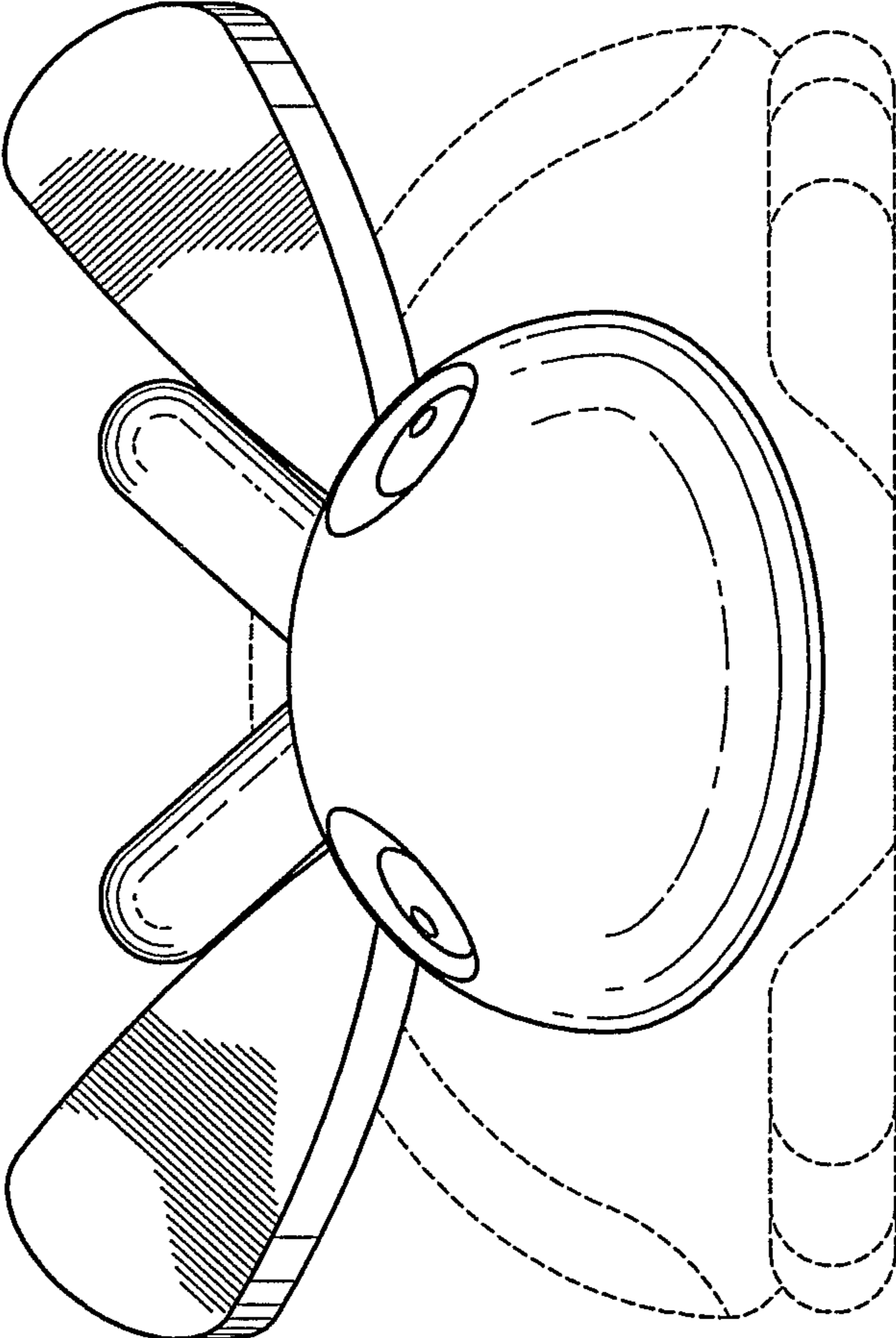

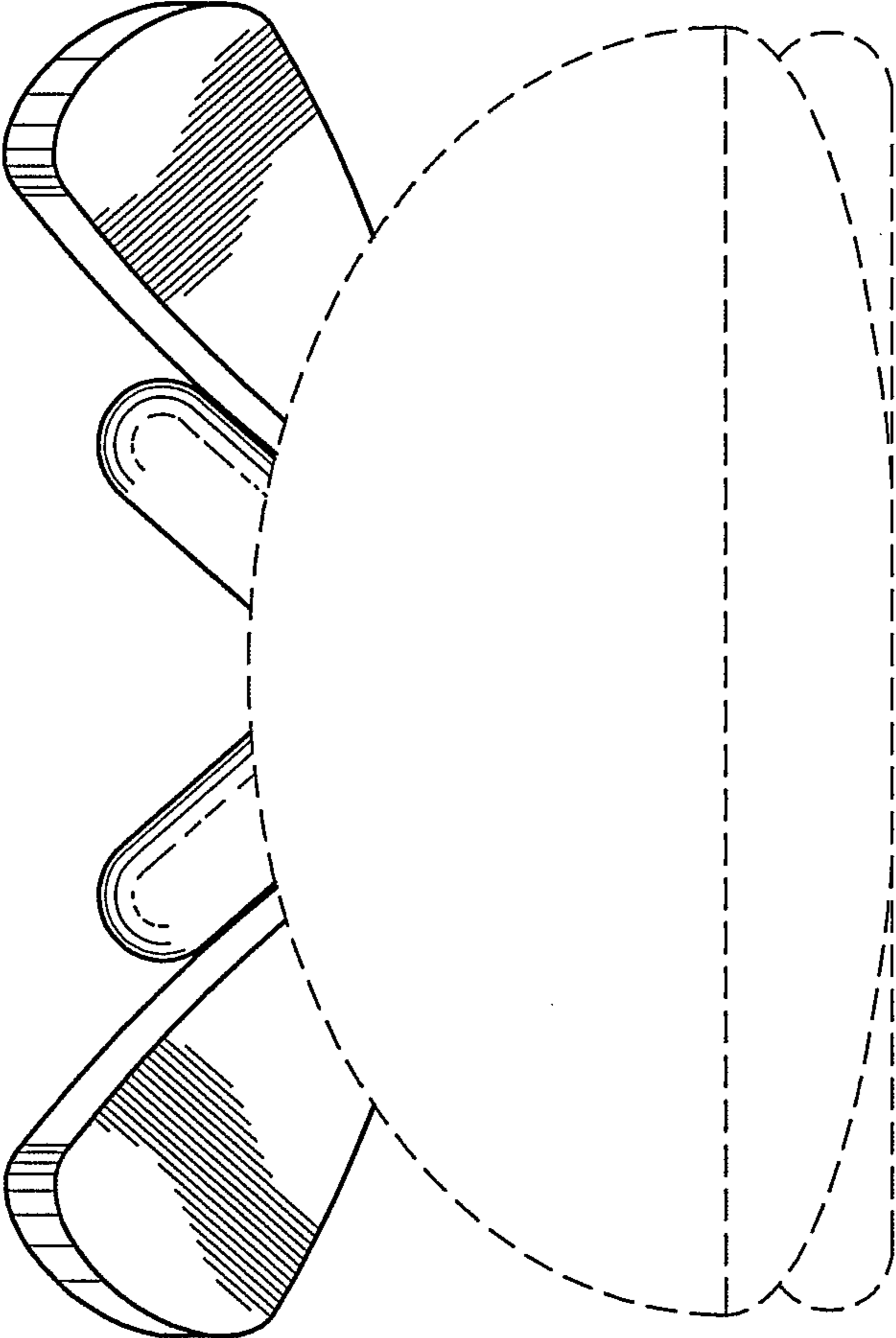
