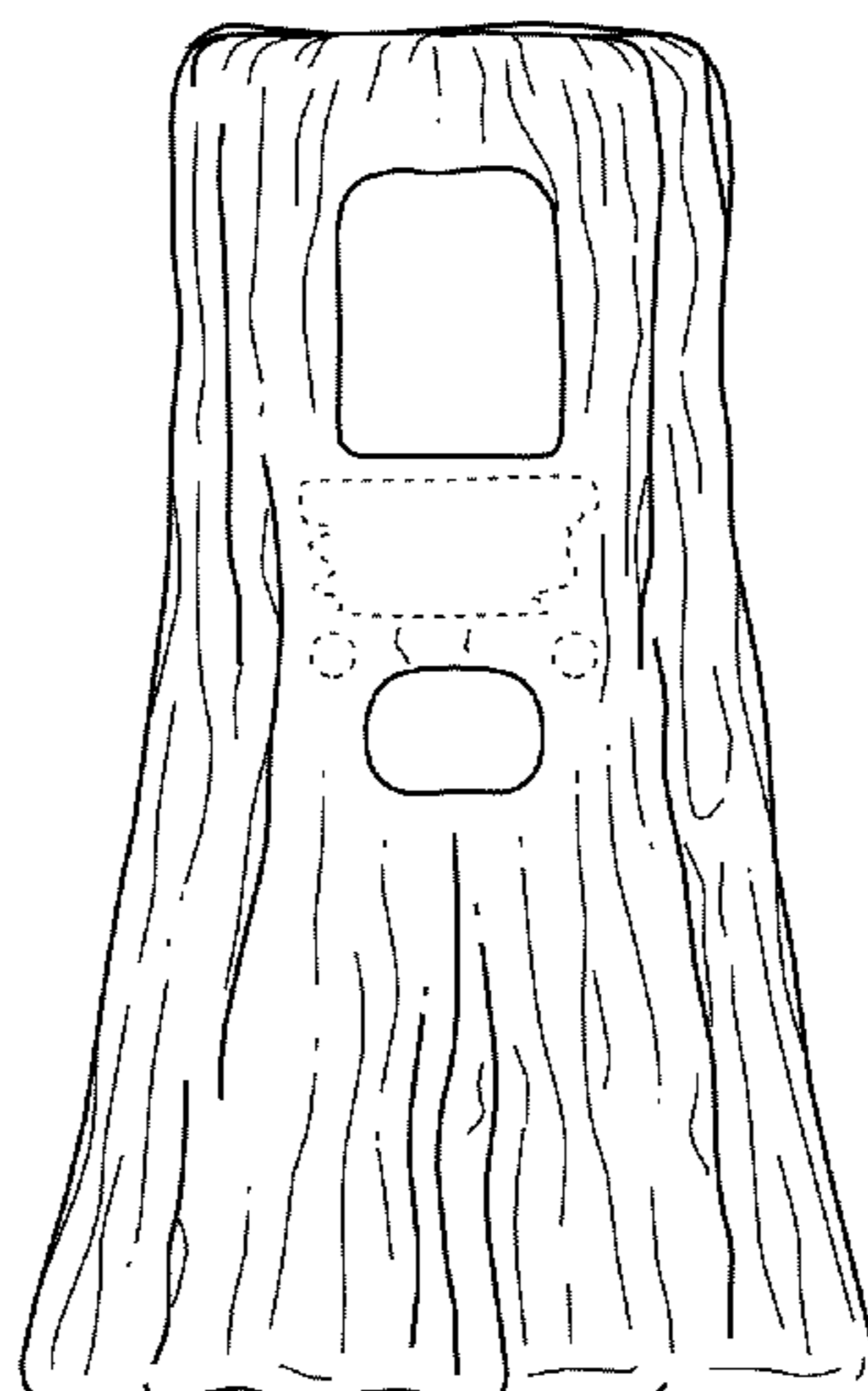
(57) **CLAIM**

The ornamental design for an automatic feeder housing, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an automatic feeder housing showing my new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a left side elevation view thereof;
 FIG. 5 is a top plan view thereof; and,
 FIG. 6 is bottom plan view thereof.
 The right side elevation view of the automatic feeder housing, not shown, is a mirror image of the left side elevation view thereof.
 The broken line elements are not claimed.

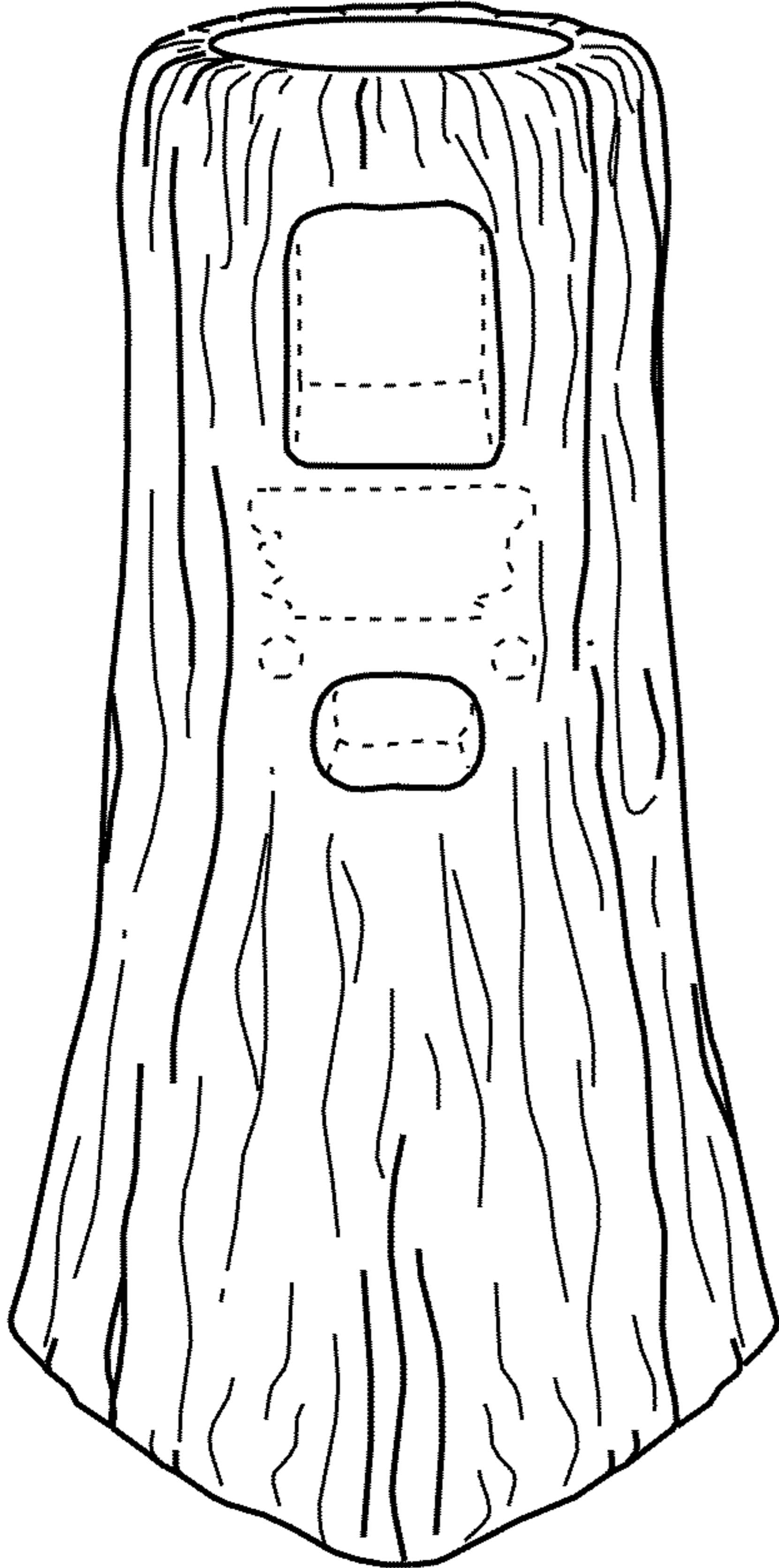

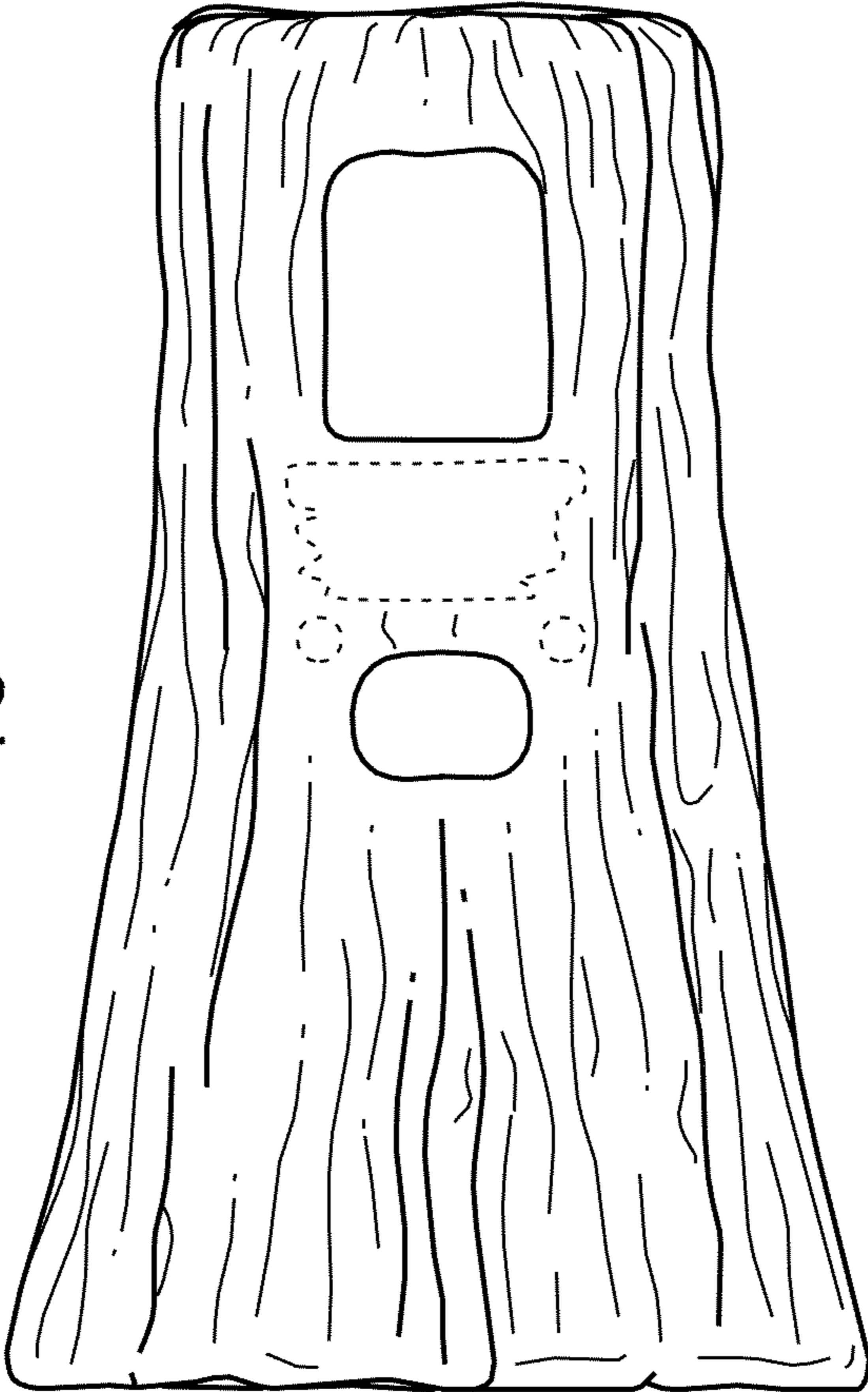

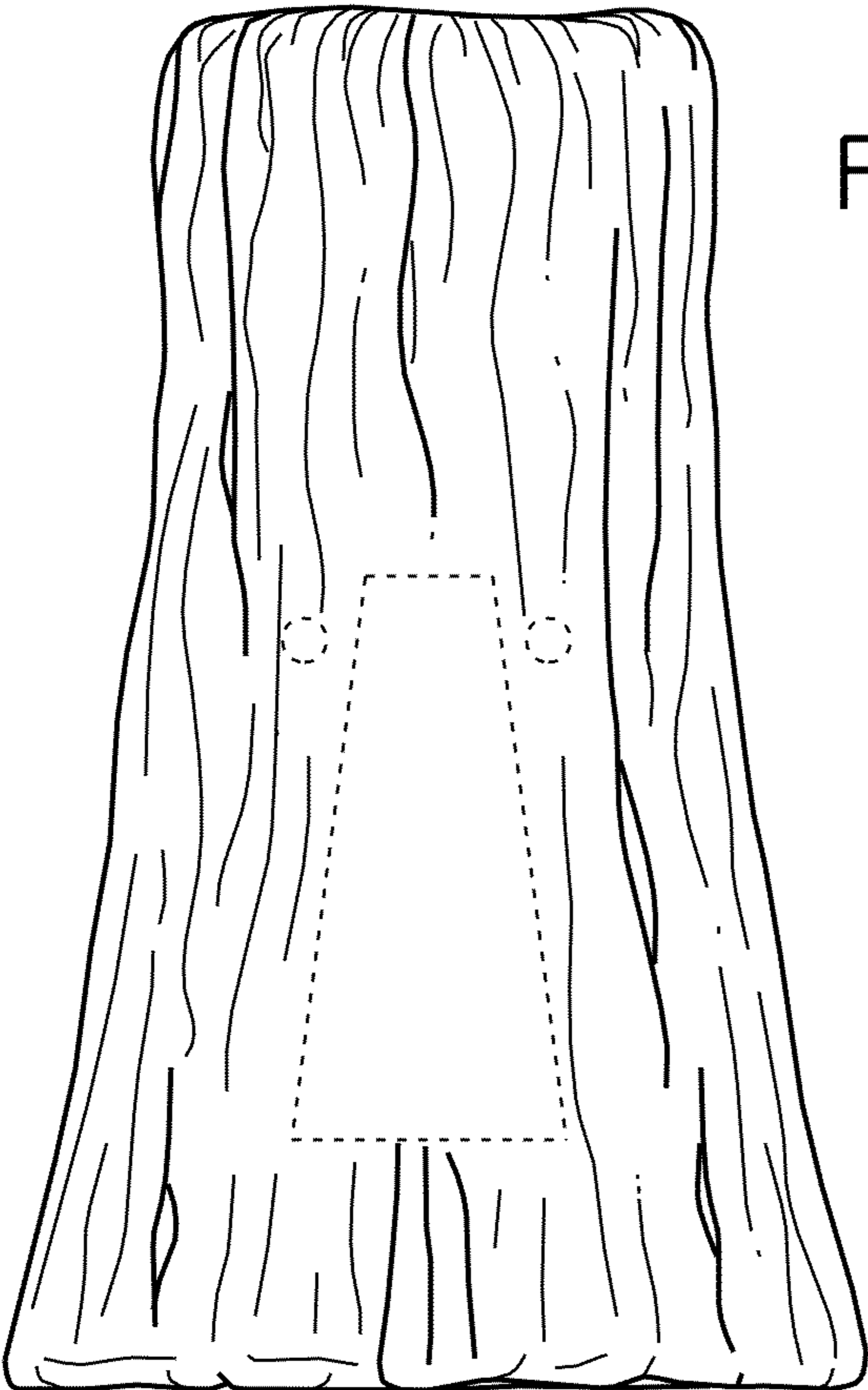

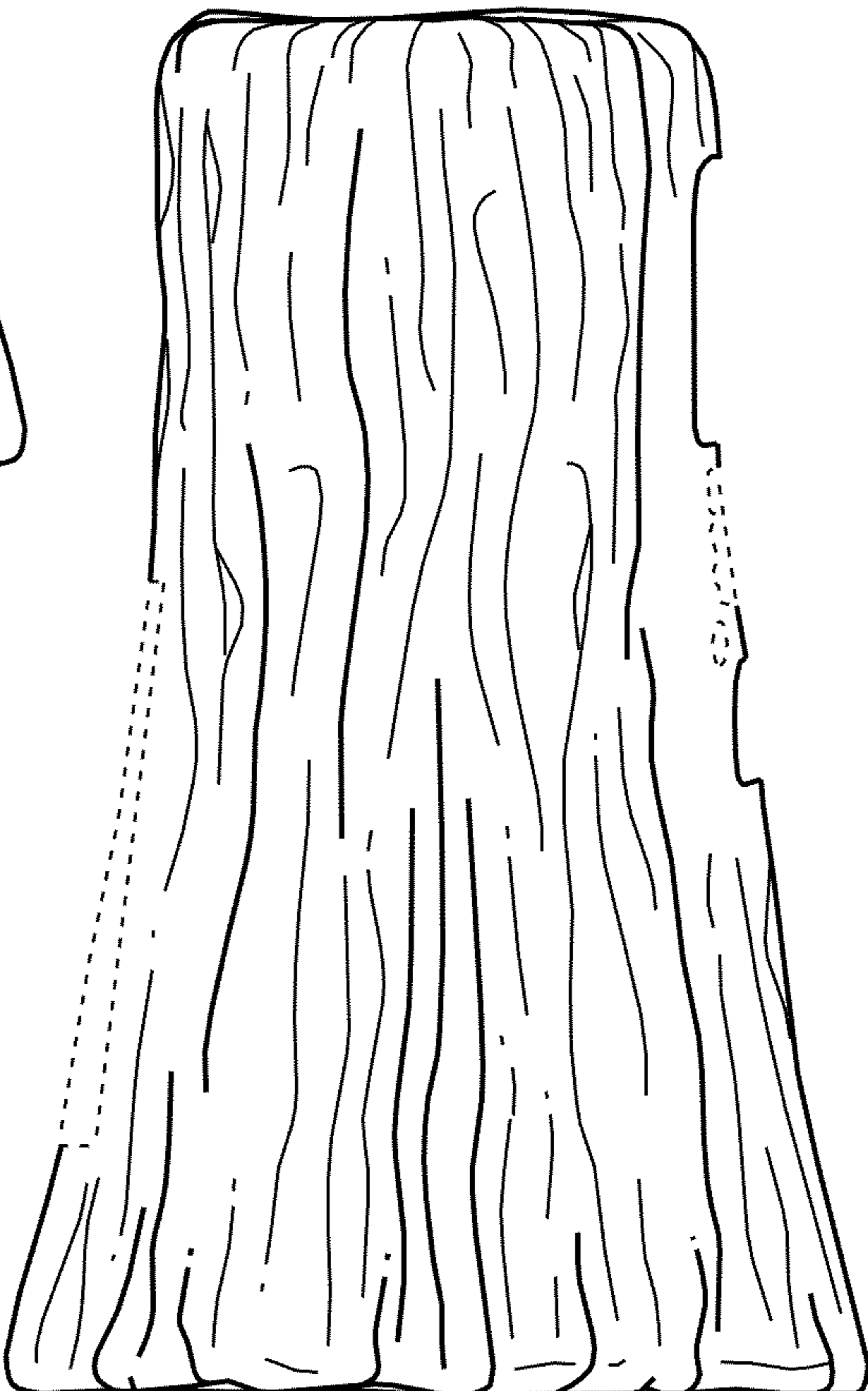

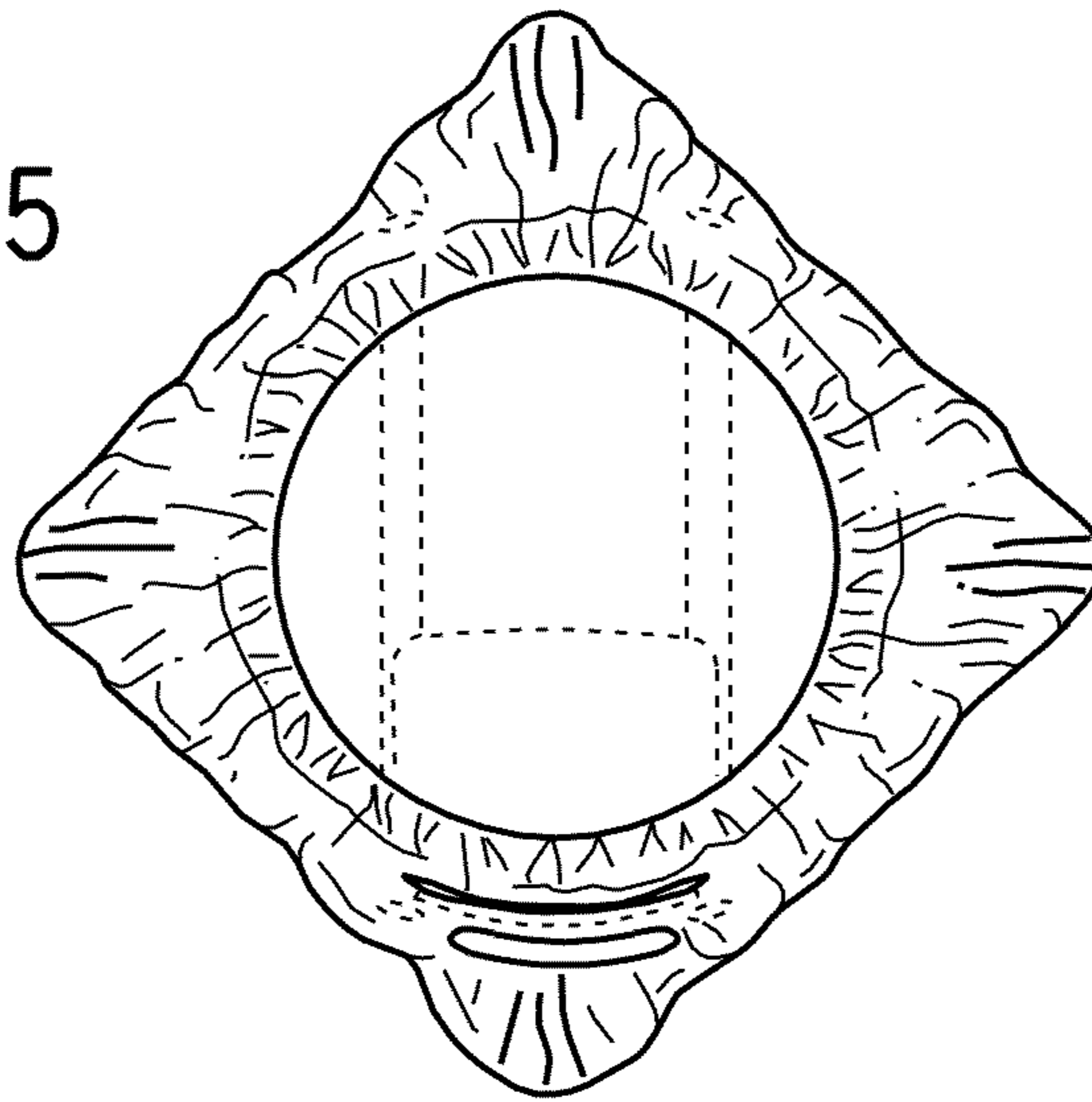
