FIG. 6 is front view thereof.

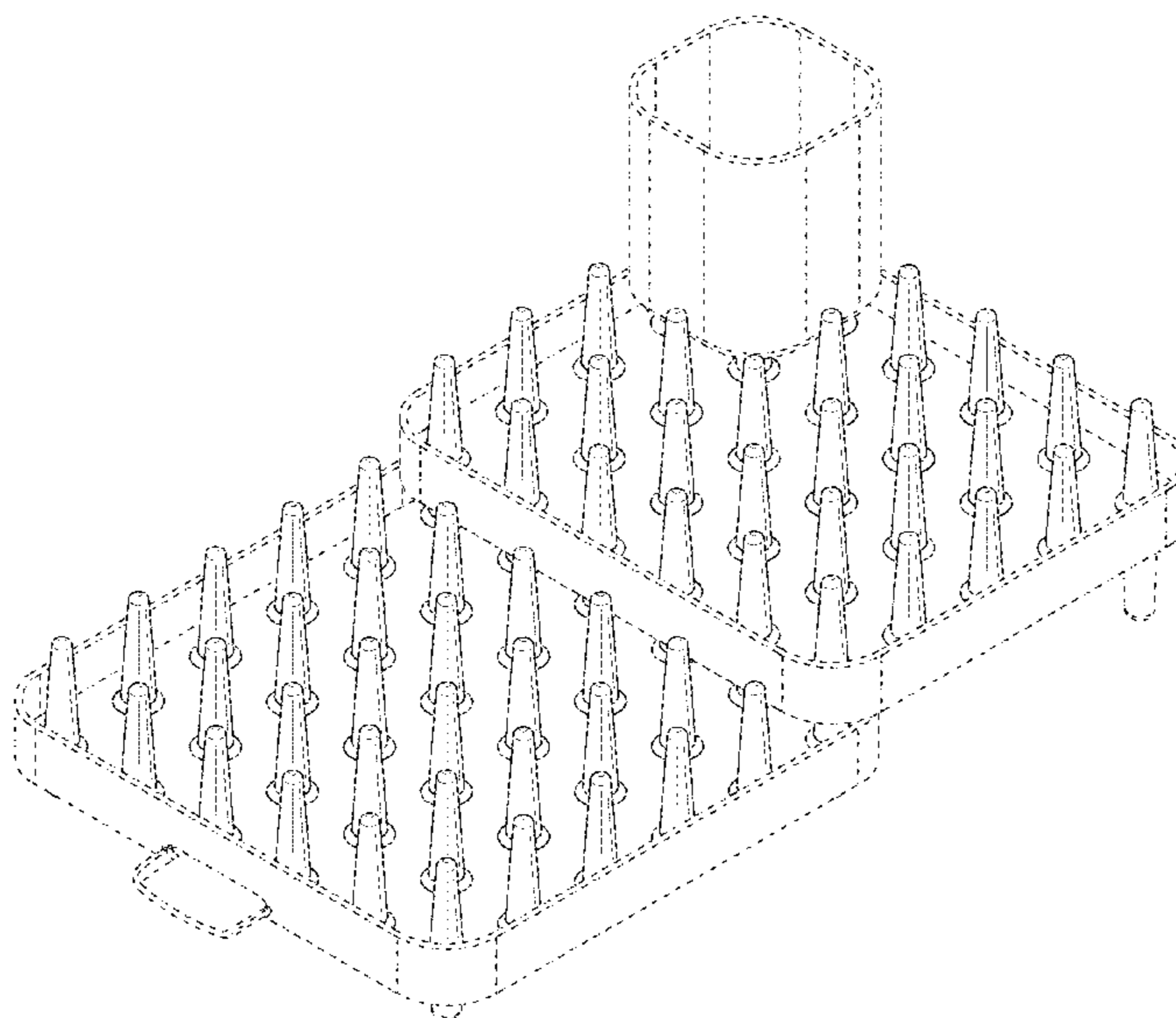
FIG. 7 is a back view thereof.

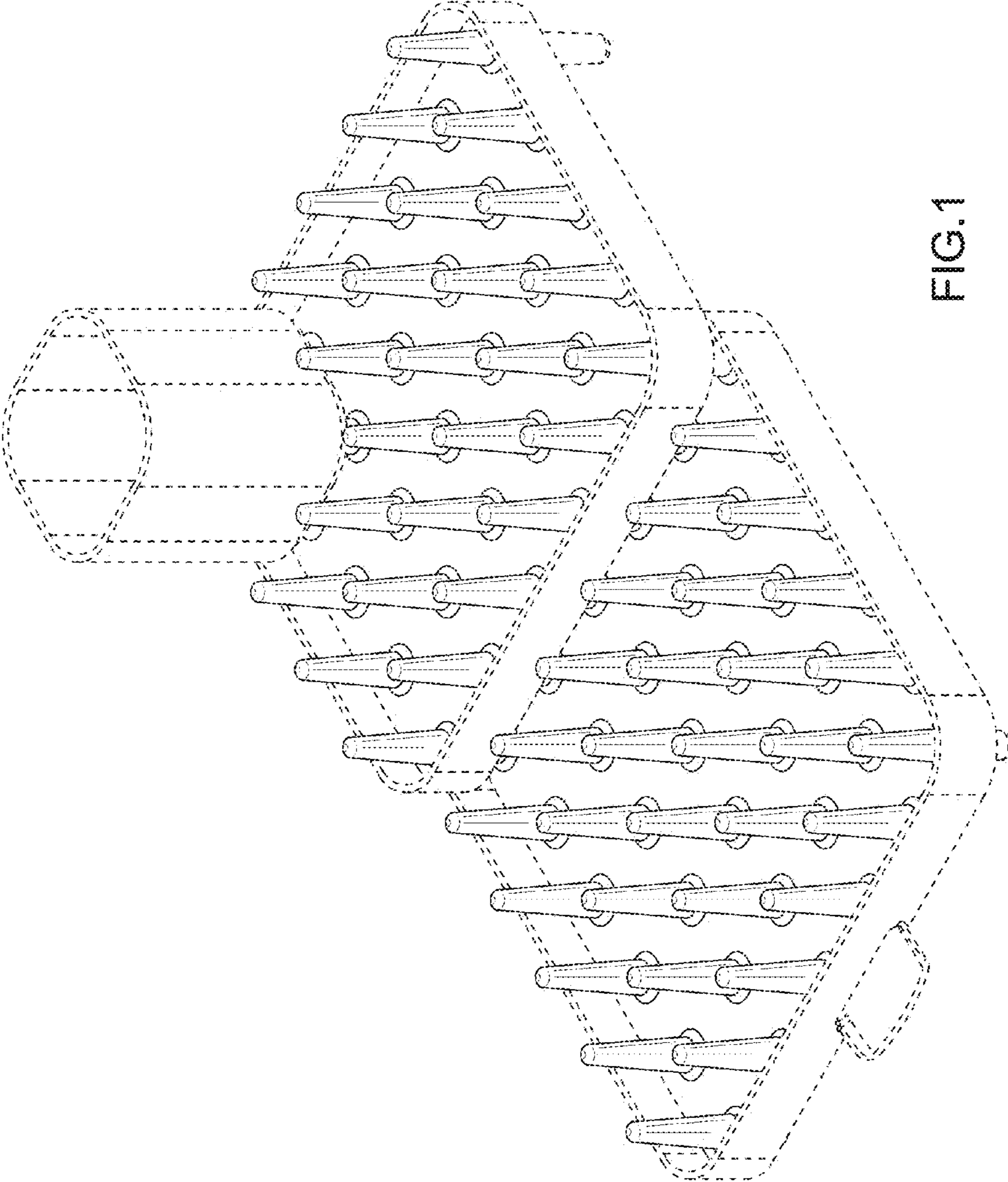

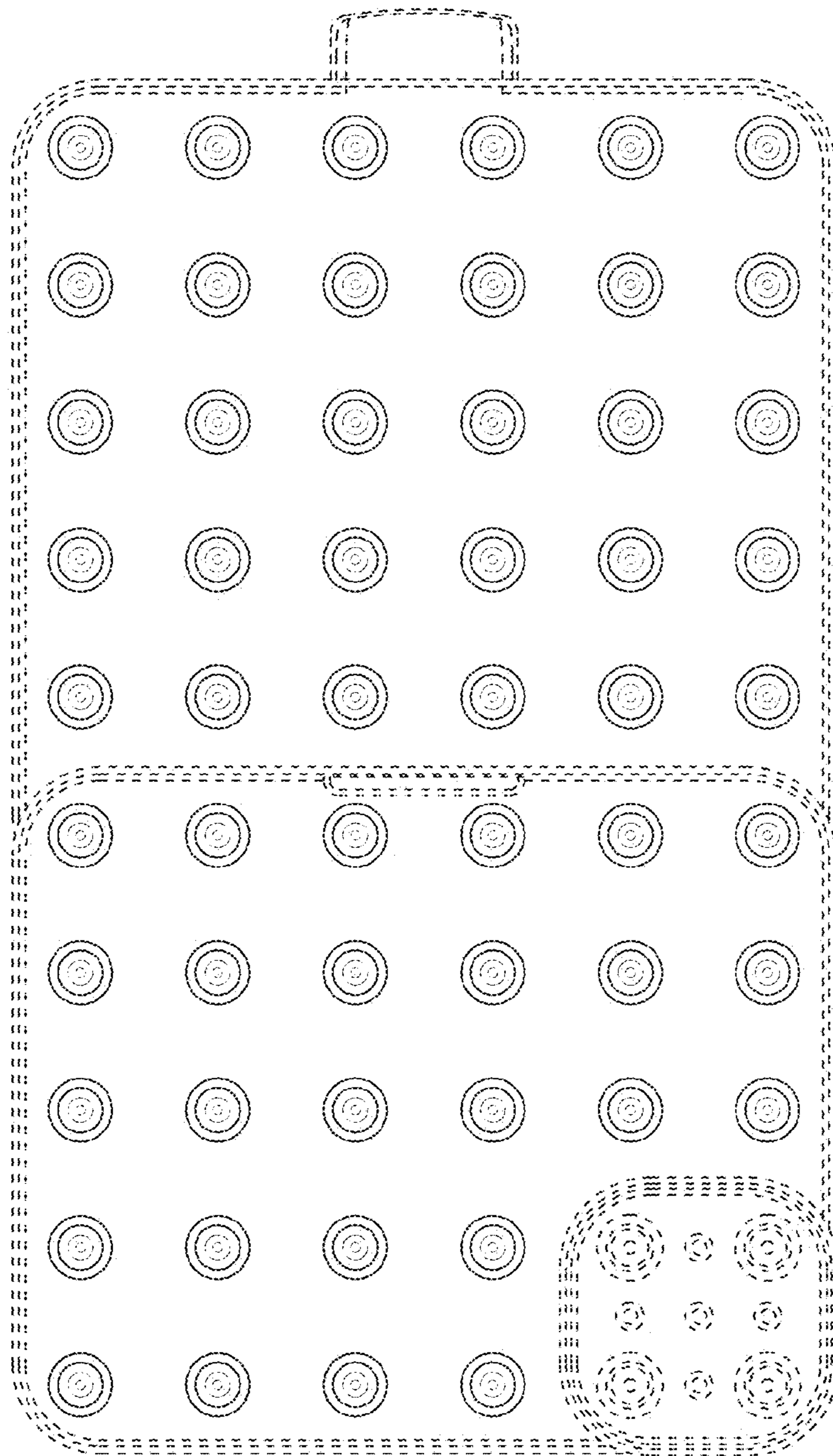

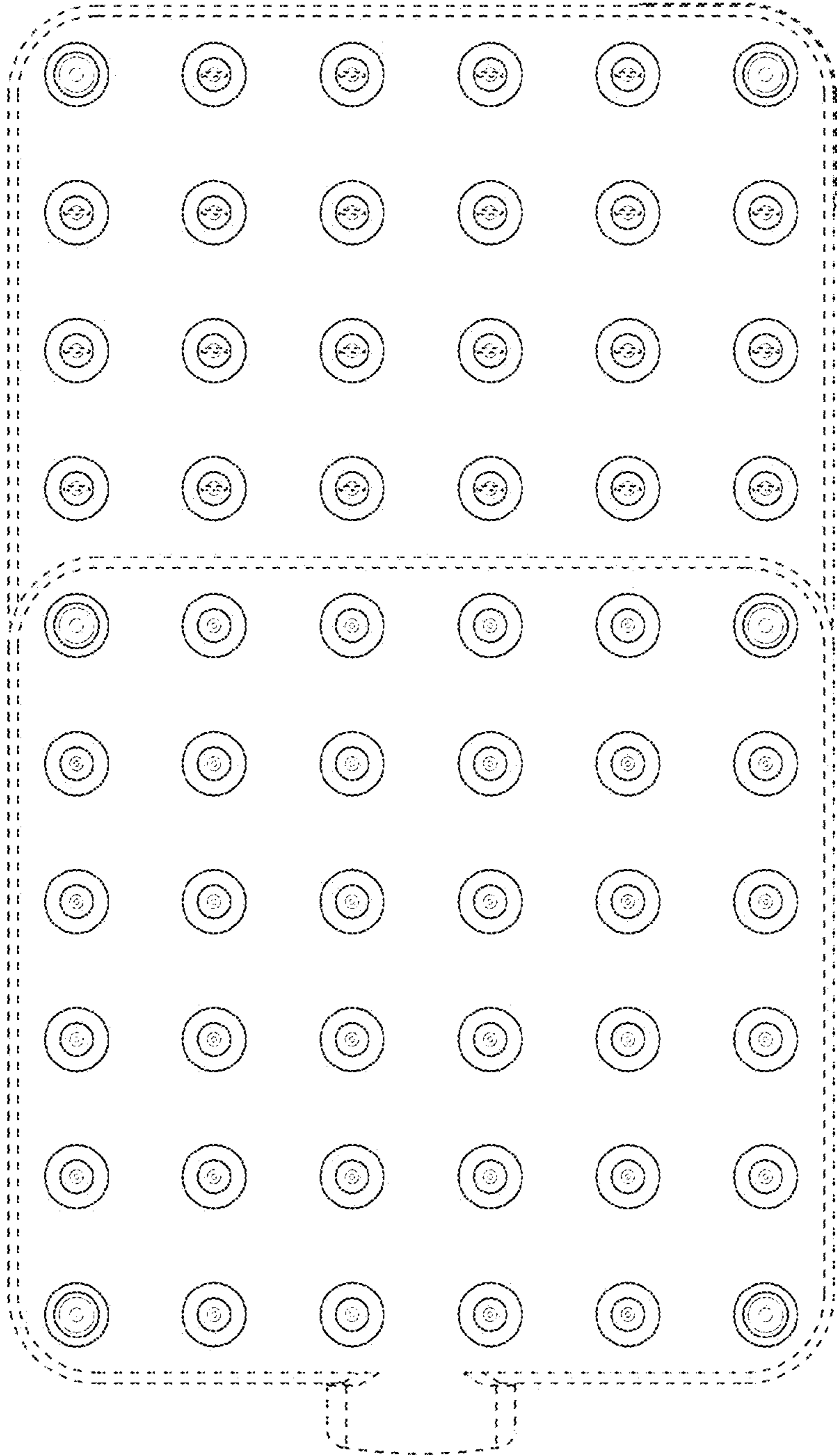

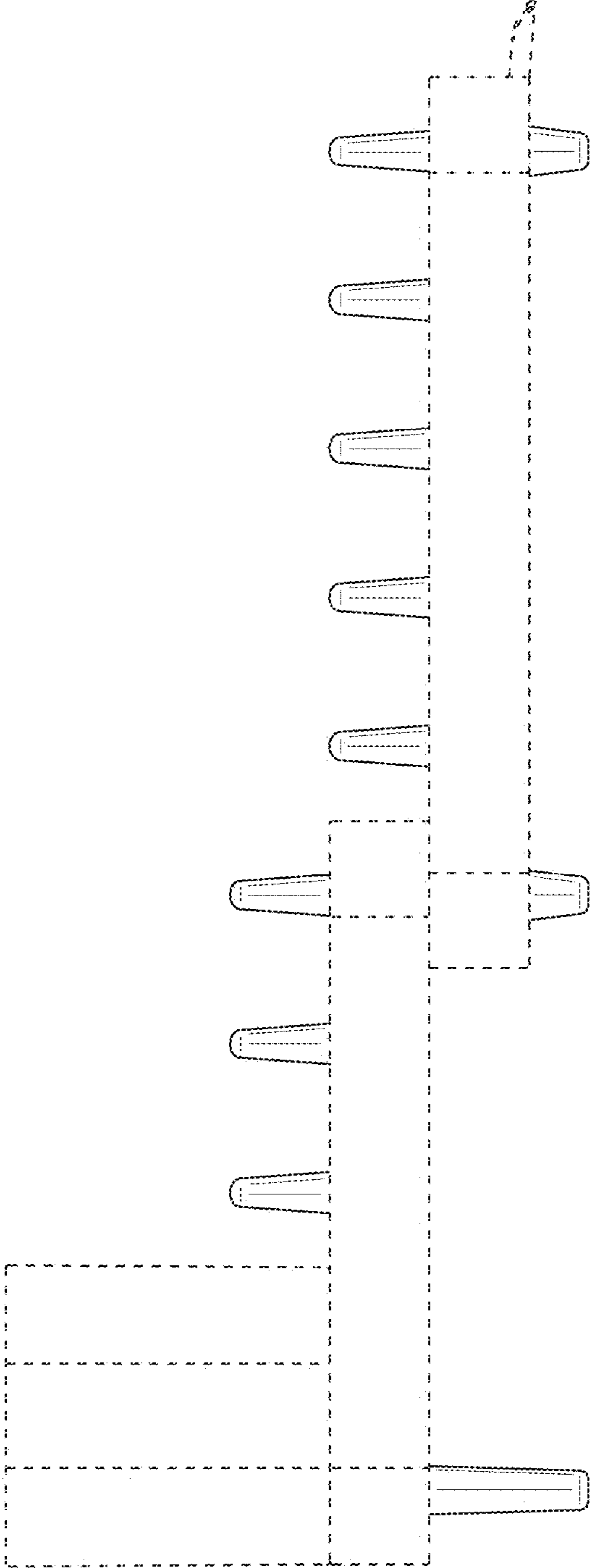

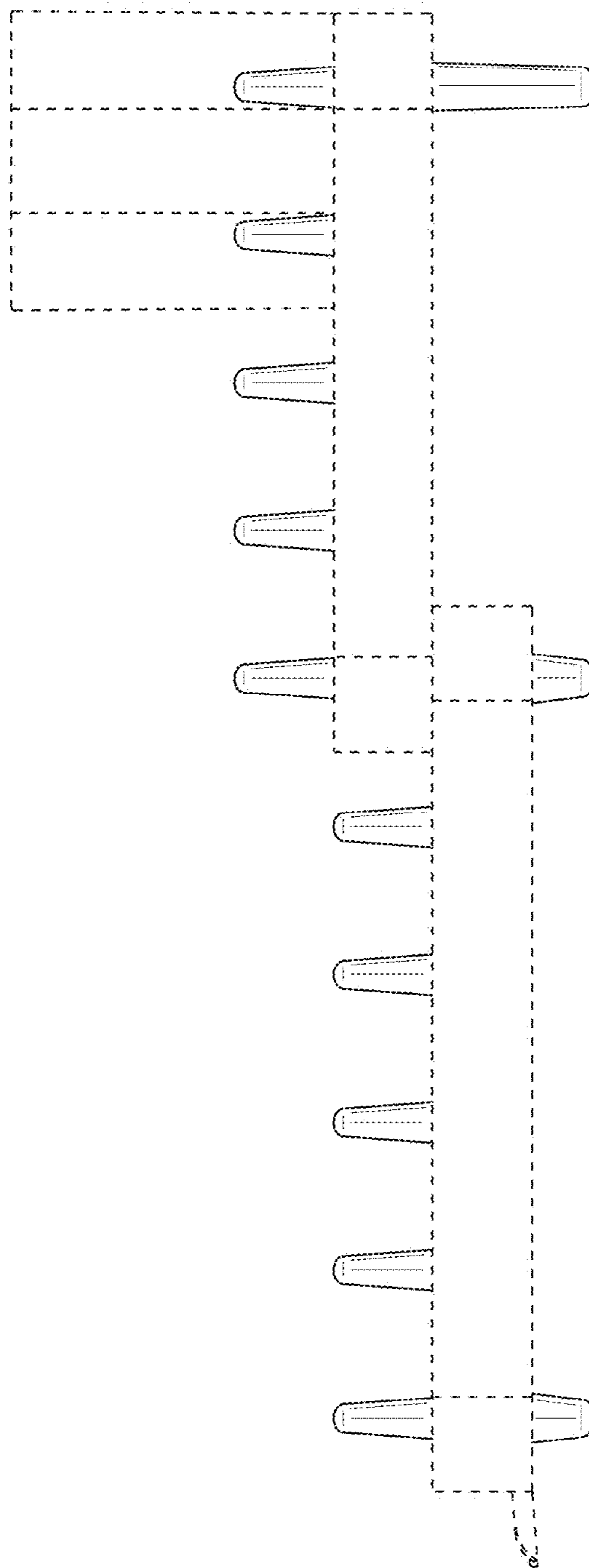

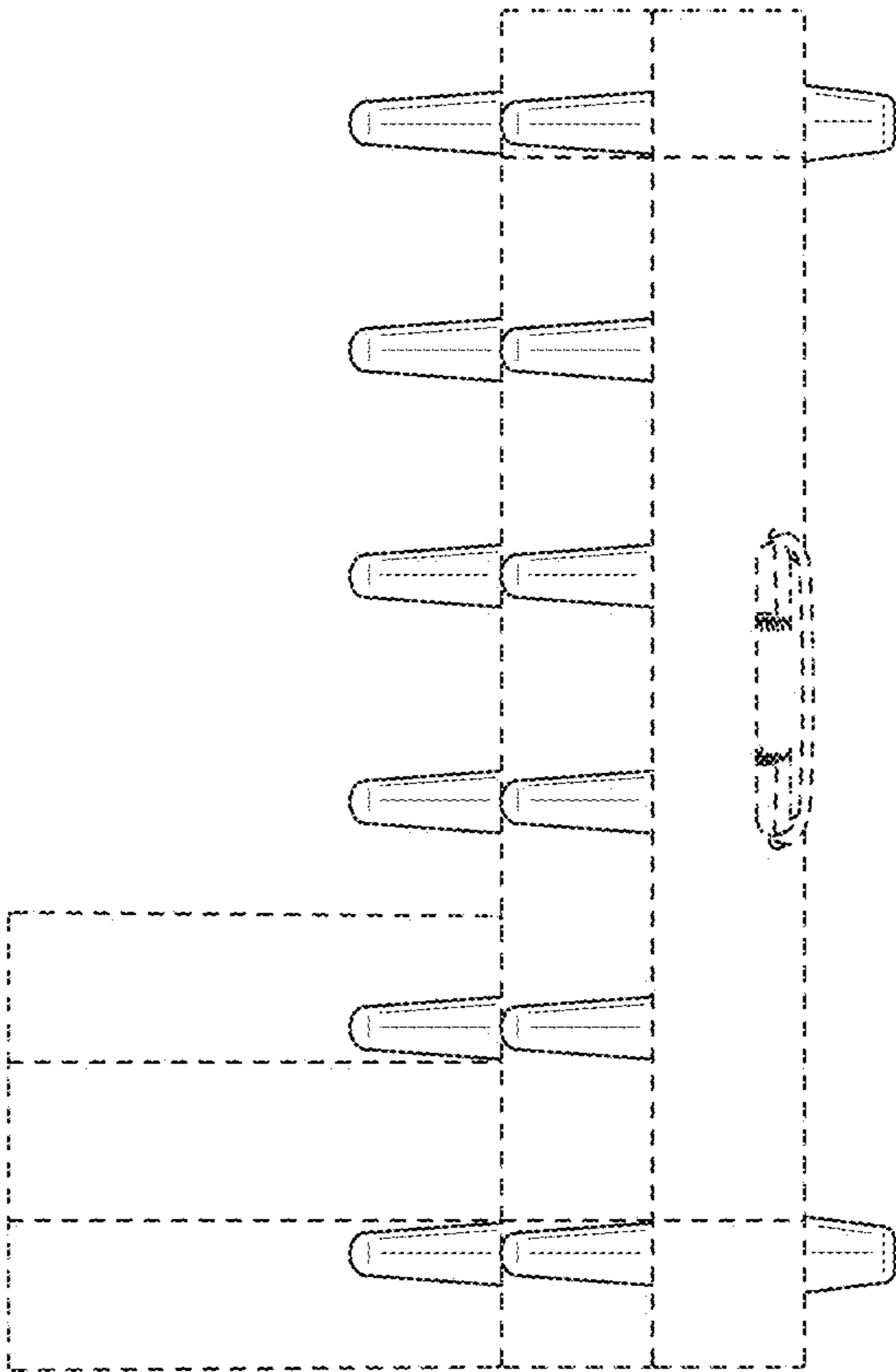

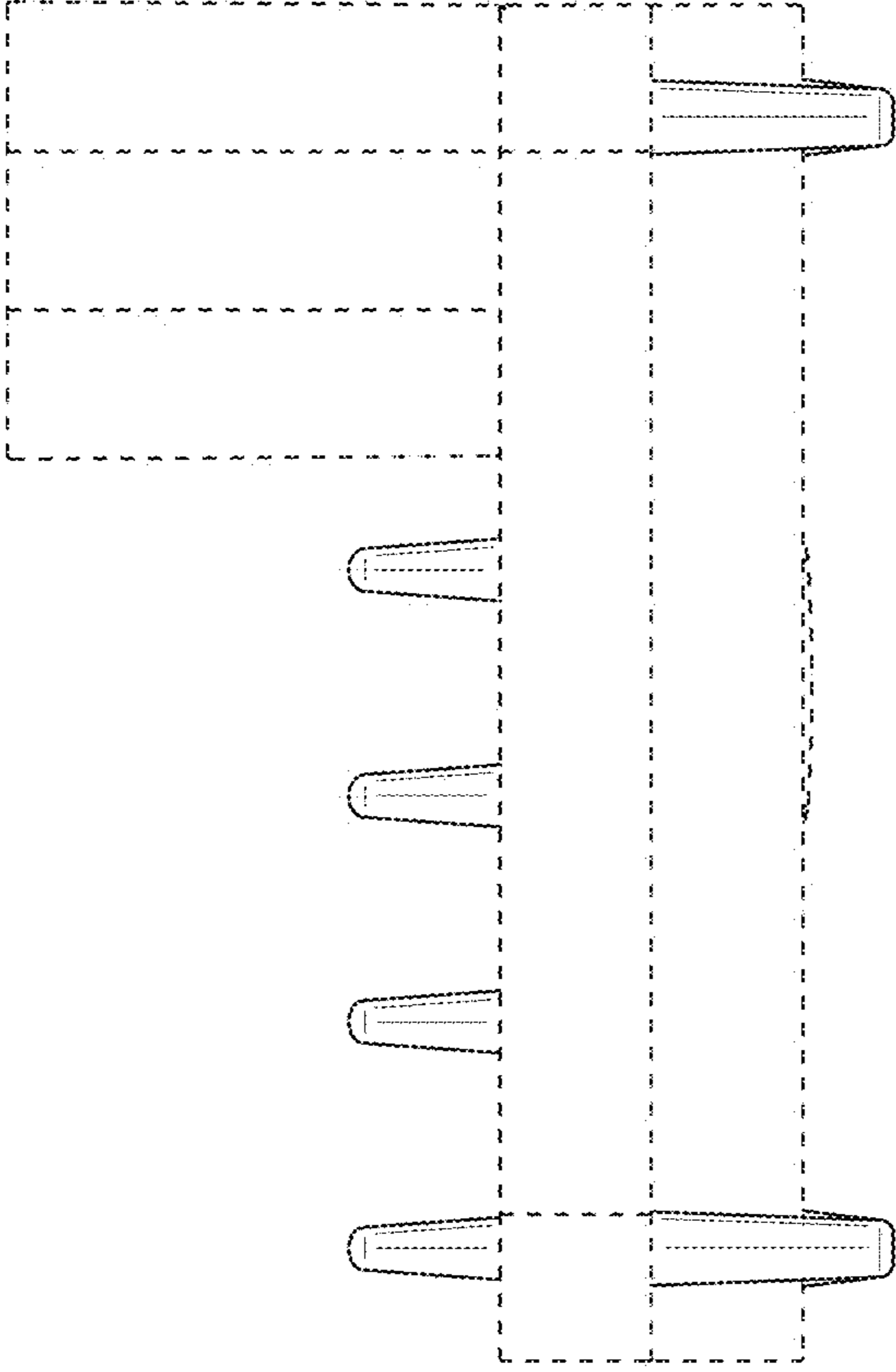

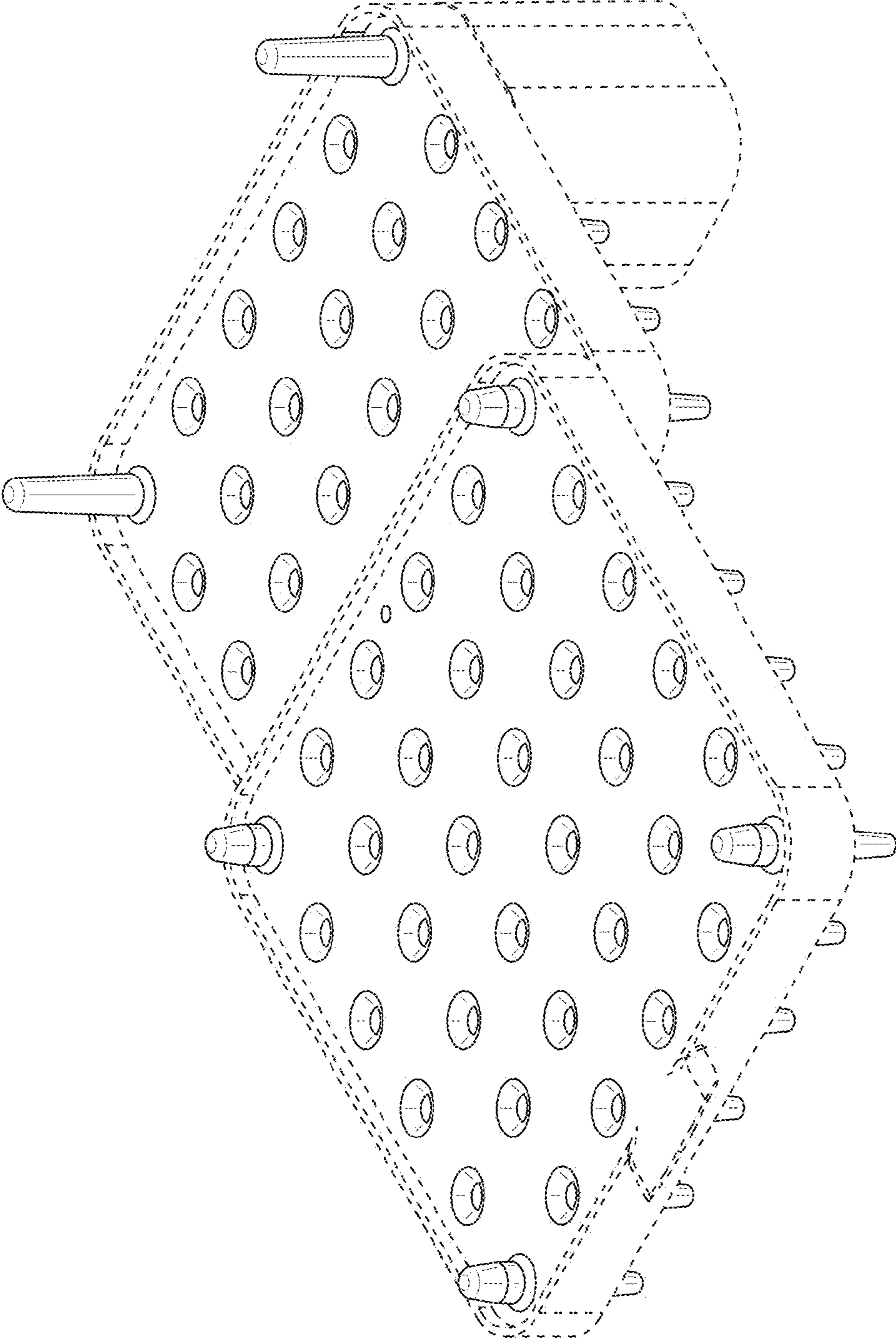

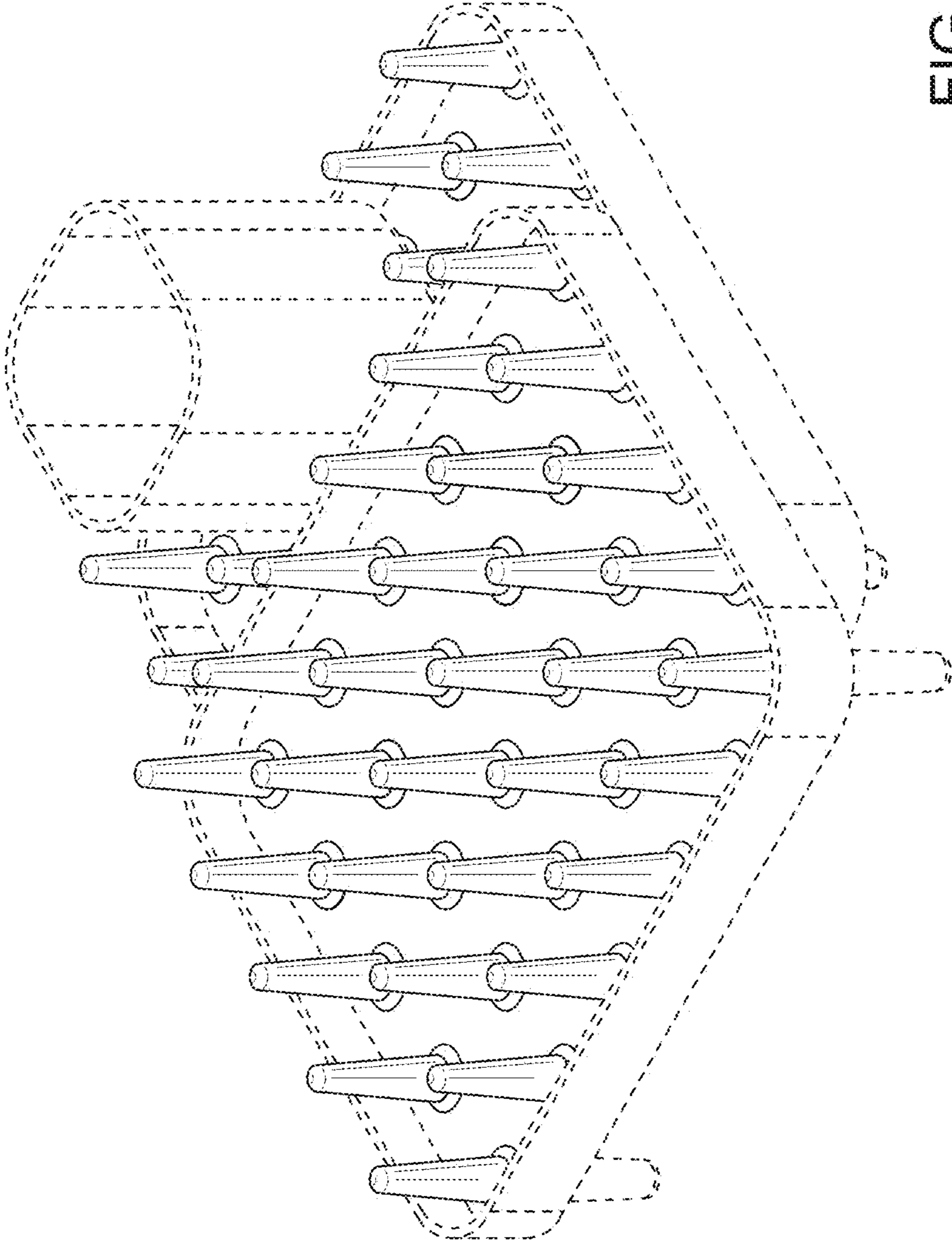
