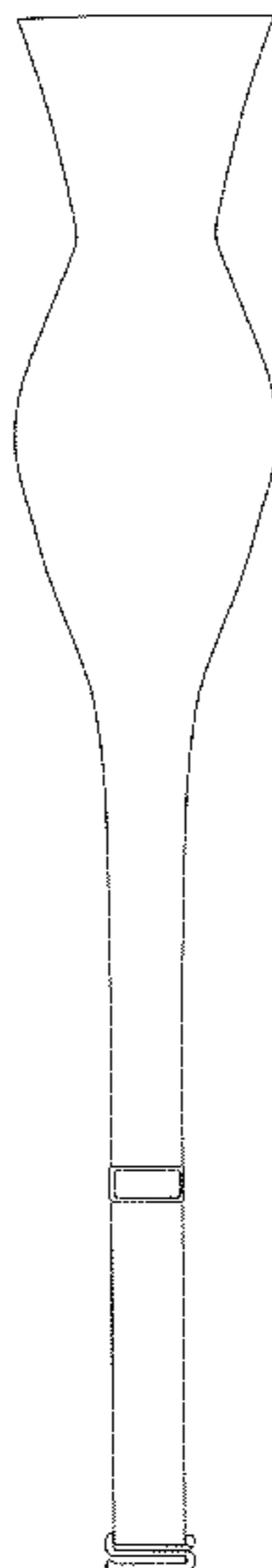
(57) **CLAIM**

The ornamental design for an interchangeable tie, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of the design;
FIG. 2 is a bottom plan view of the design;
FIG. 3 is a right side view of the design;
FIG. 4 is a left side view of the design;
FIG. 5 is a front perspective view of the design; and,
FIG. 6 is a top plan view of the design attached to a second interchangeable tie section.
The broken lines shown in FIGS. 1-6 are included for purpose of illustrating environment of the design, and form no part of the claimed design.

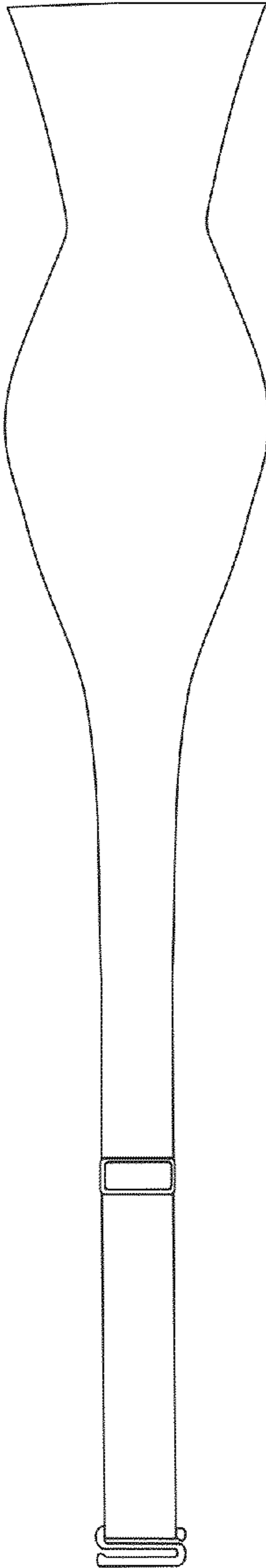

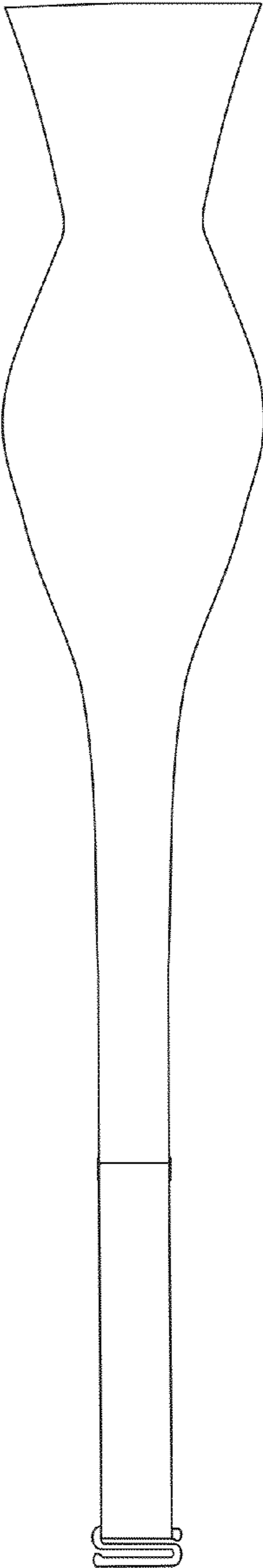

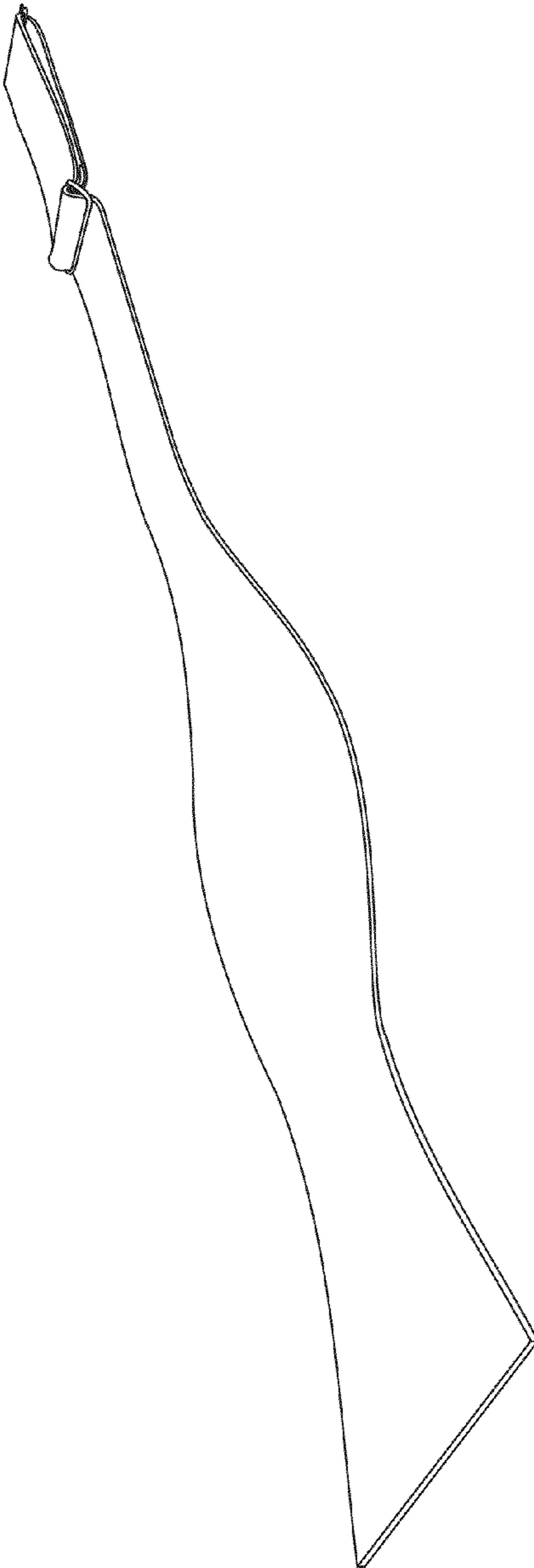

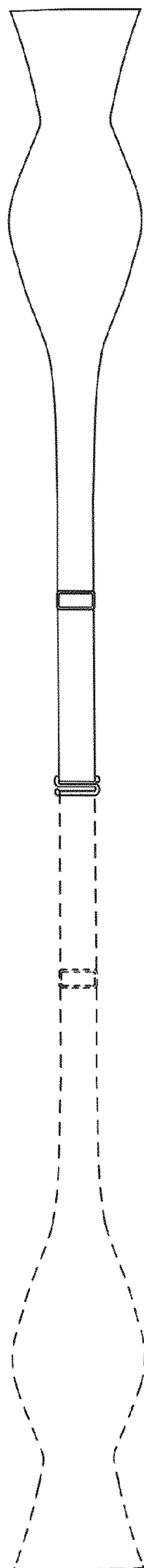
