(57) **CLAIM**

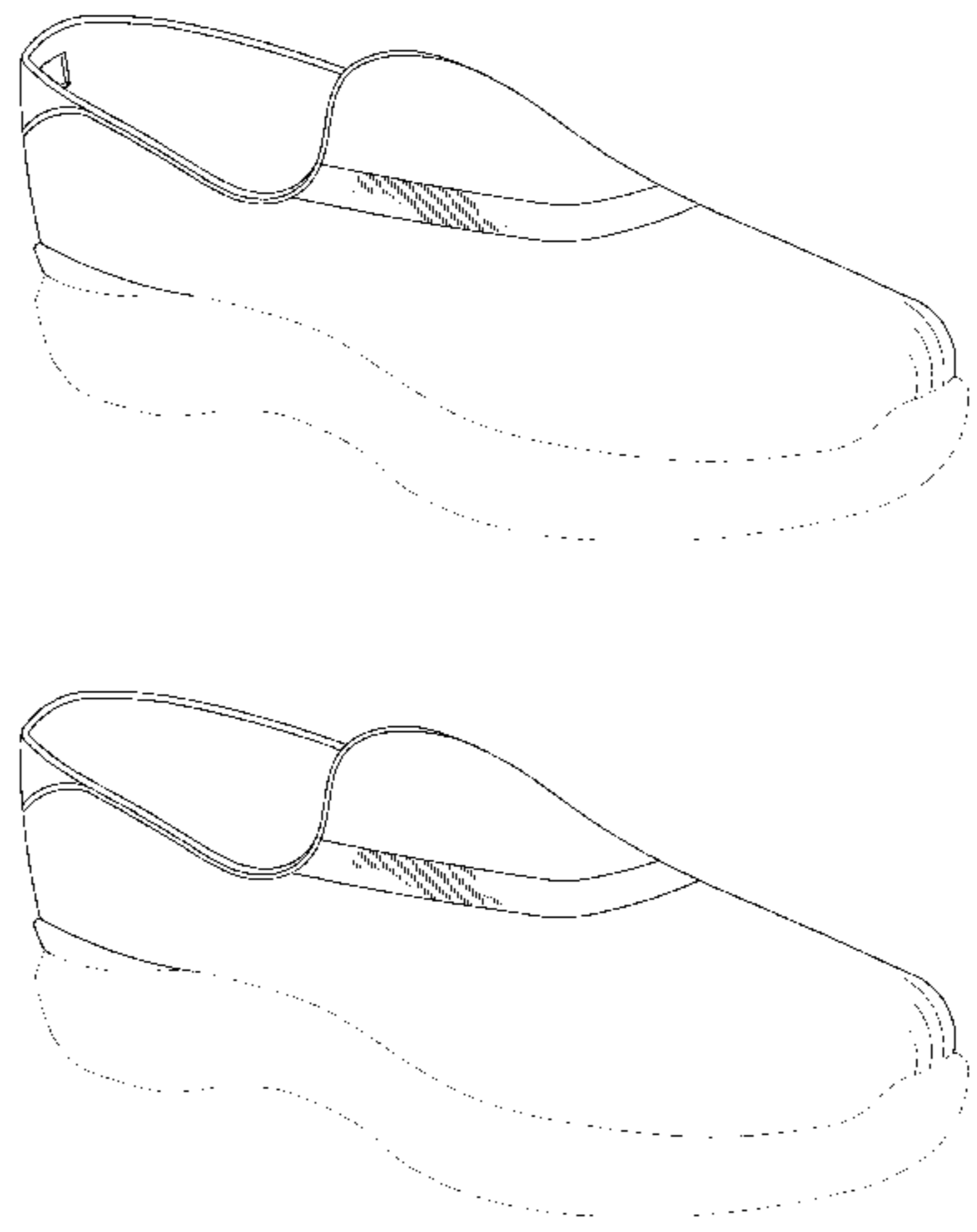
The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first exemplary embodiment of a shoe upper in accordance with my new design.

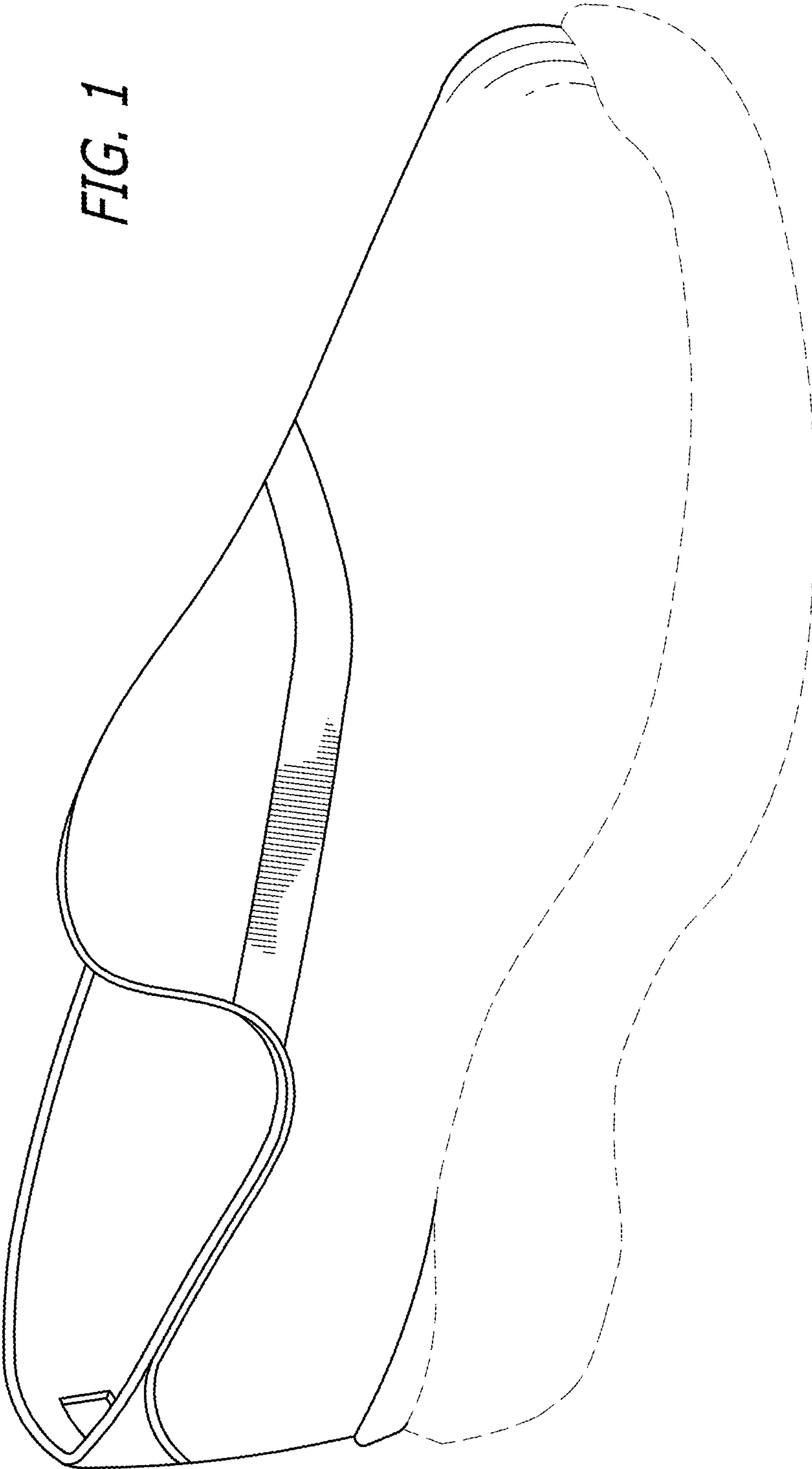
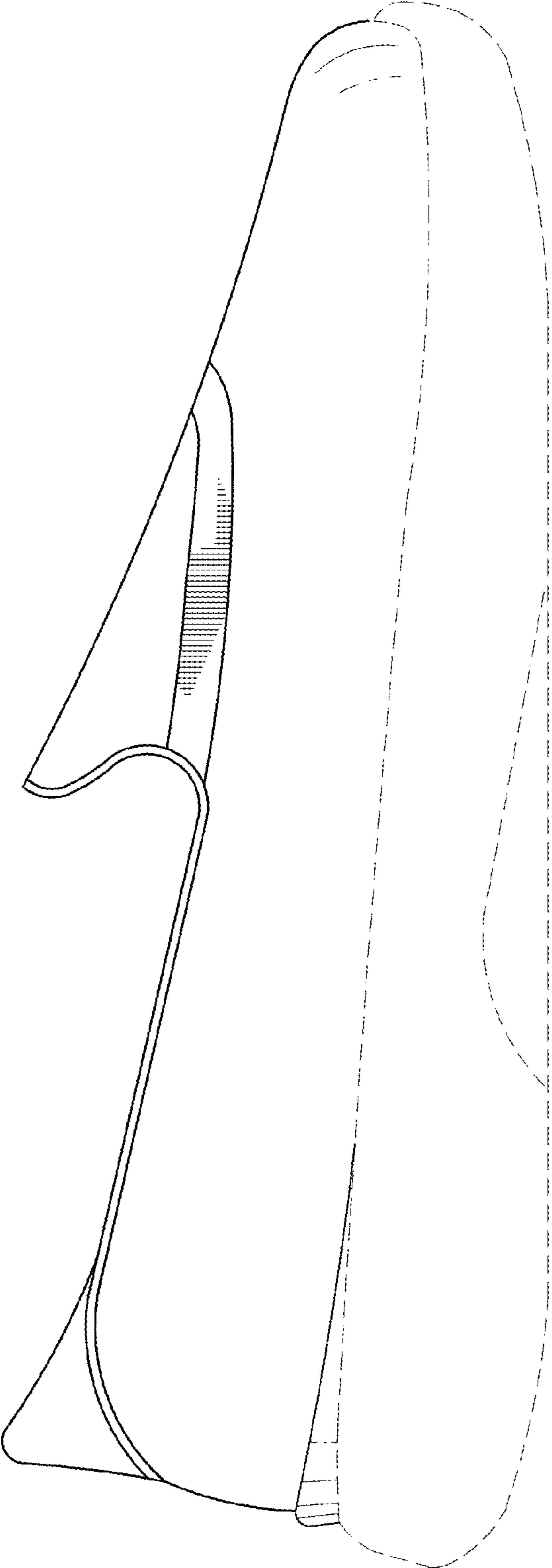
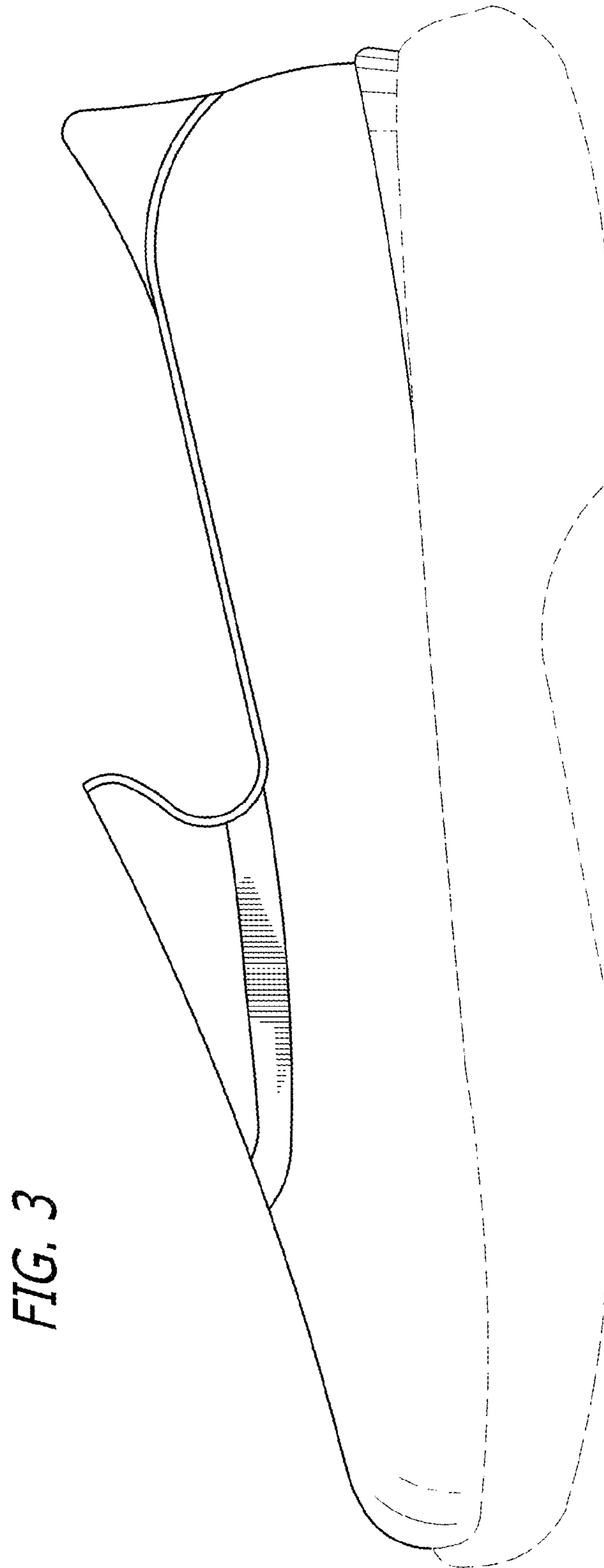

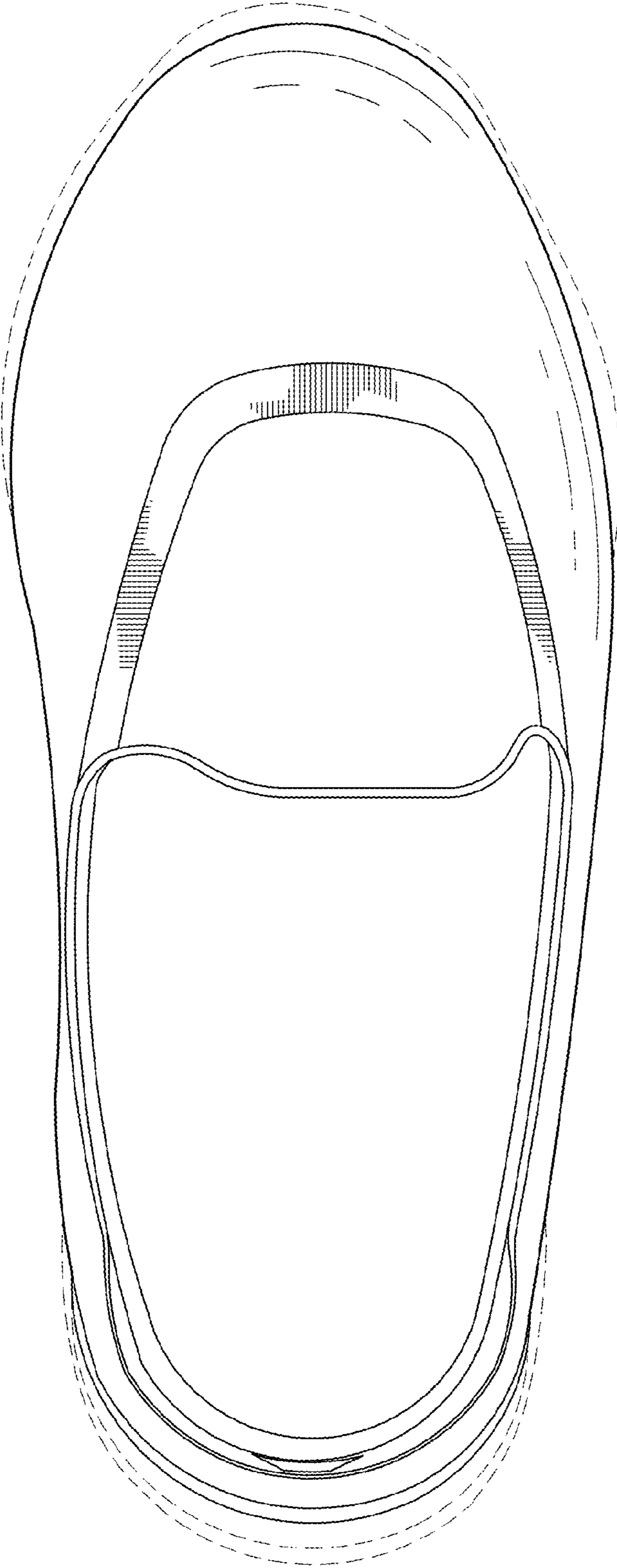

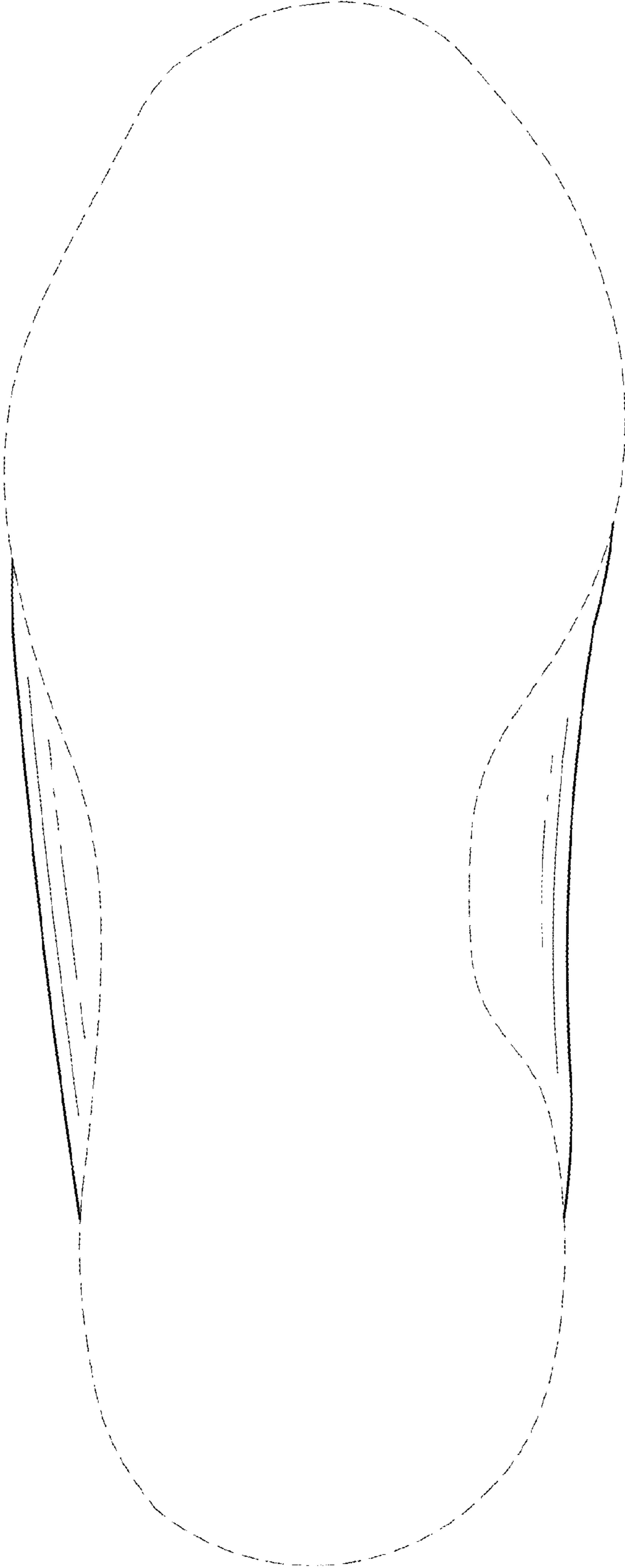

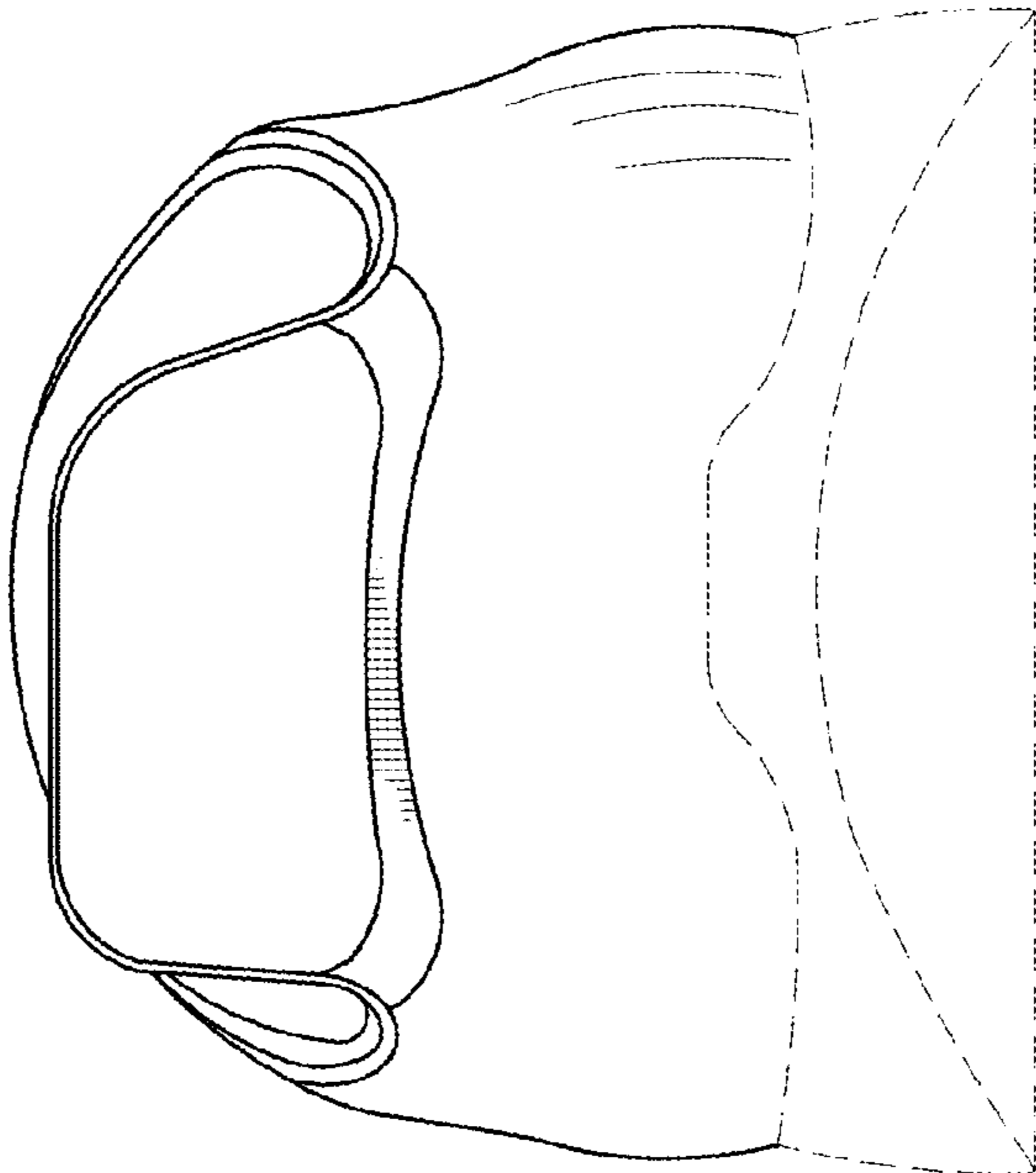

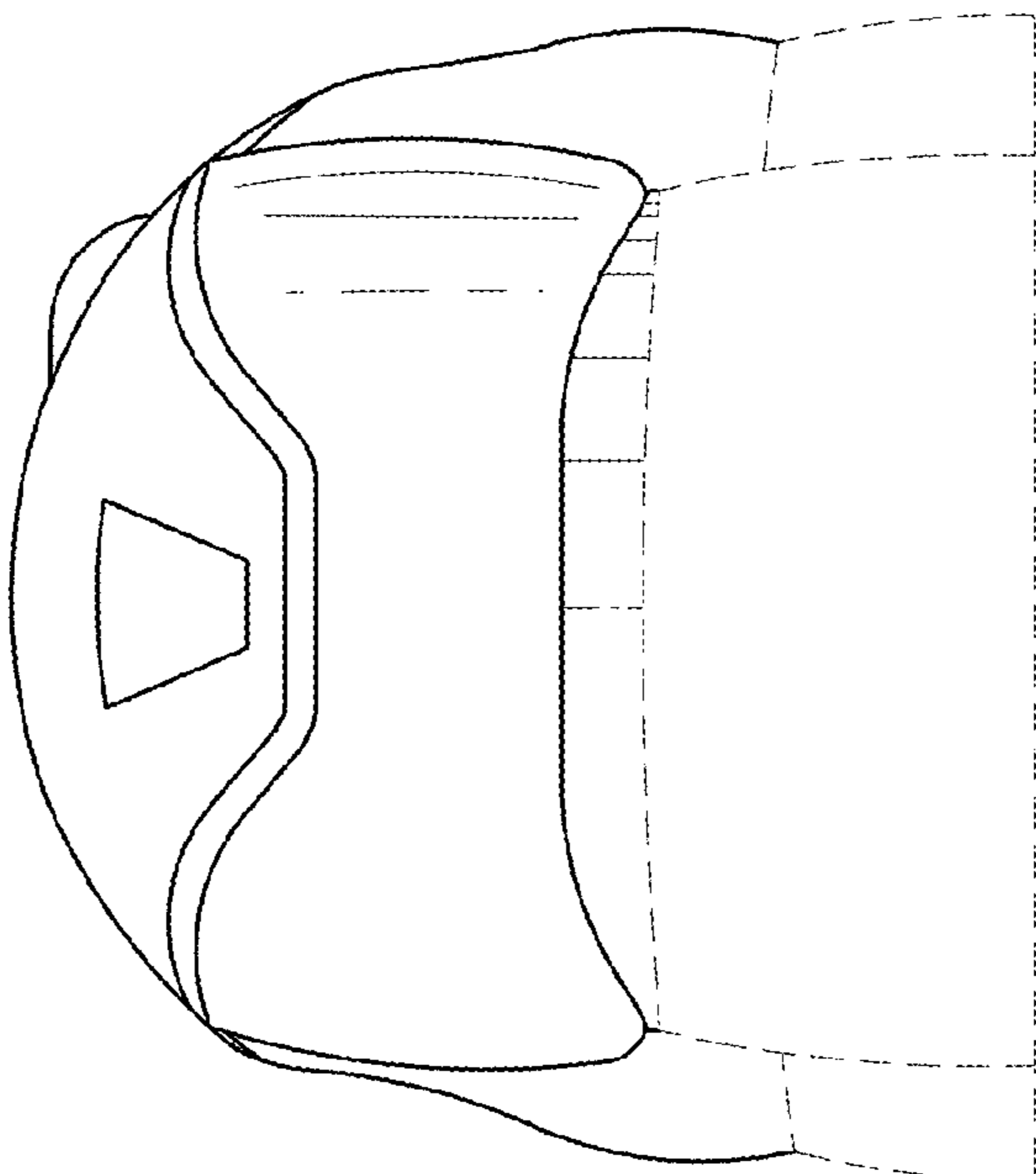

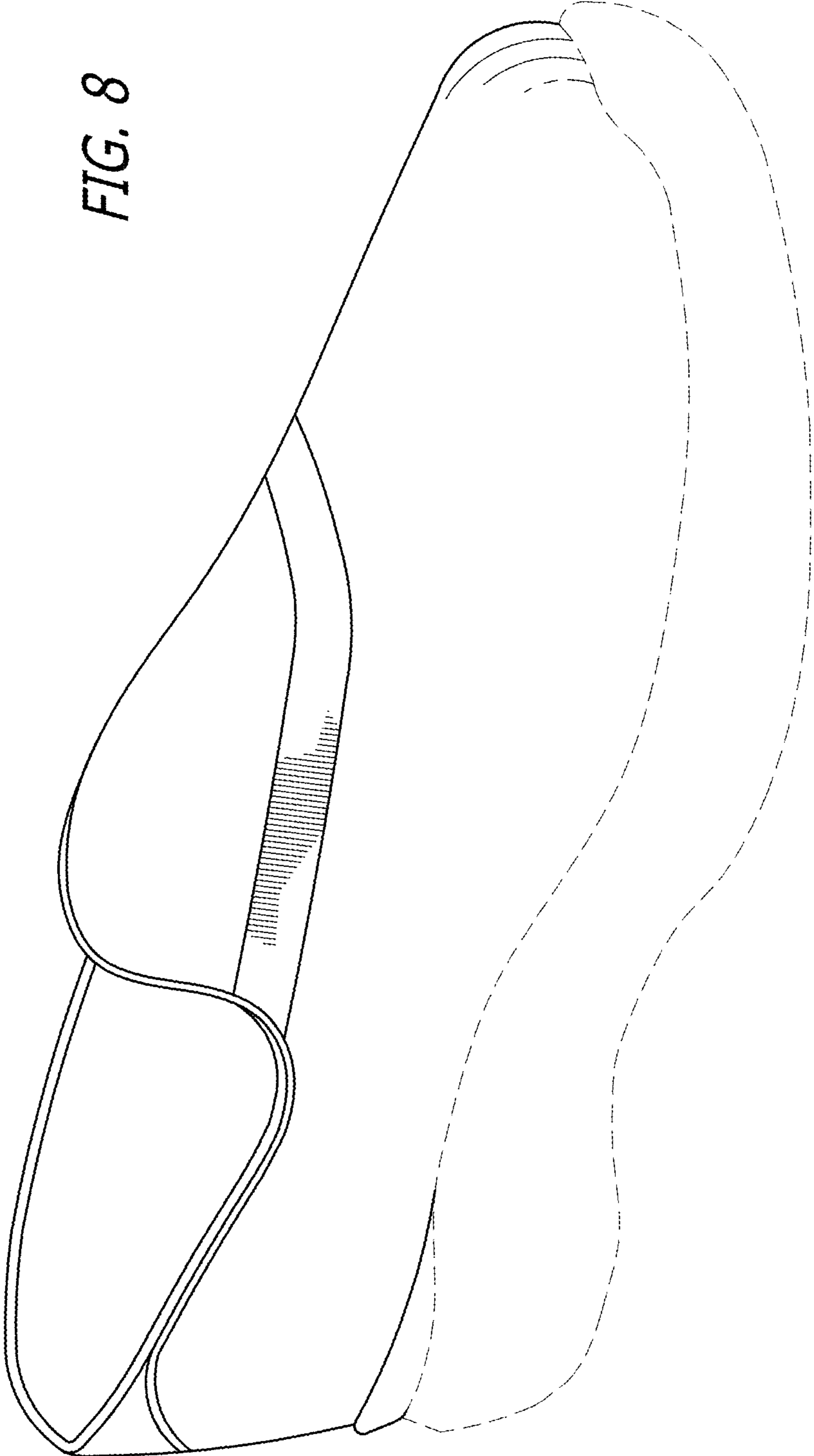
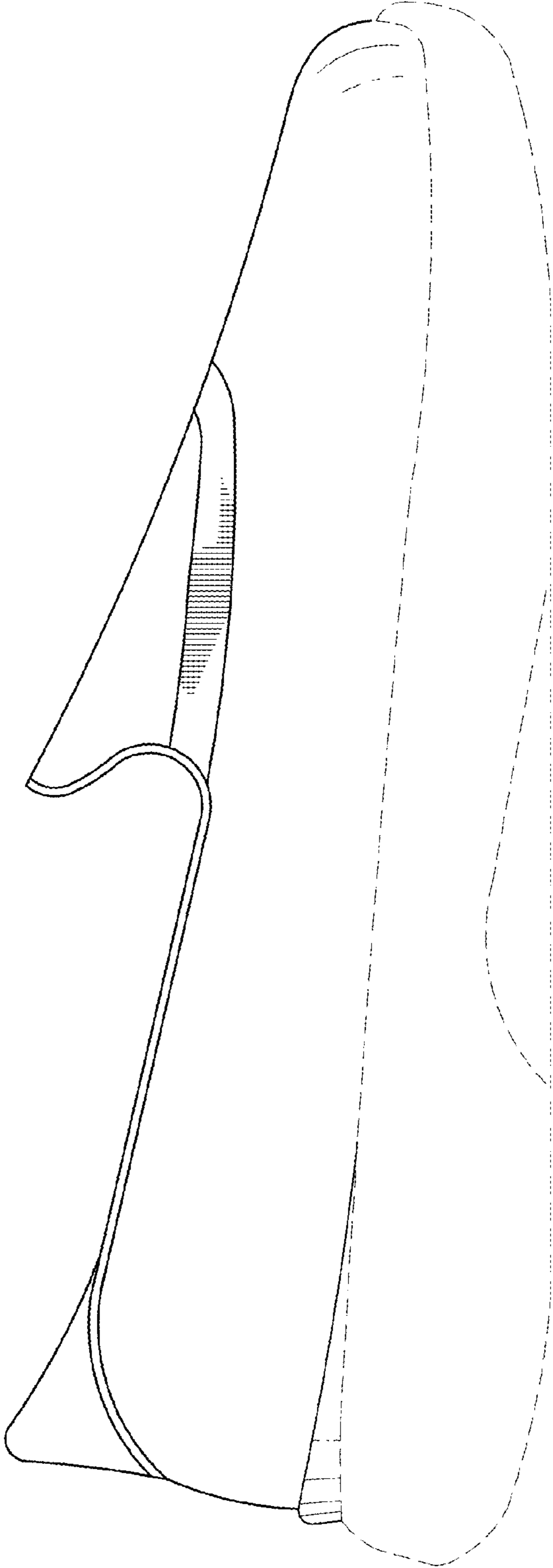

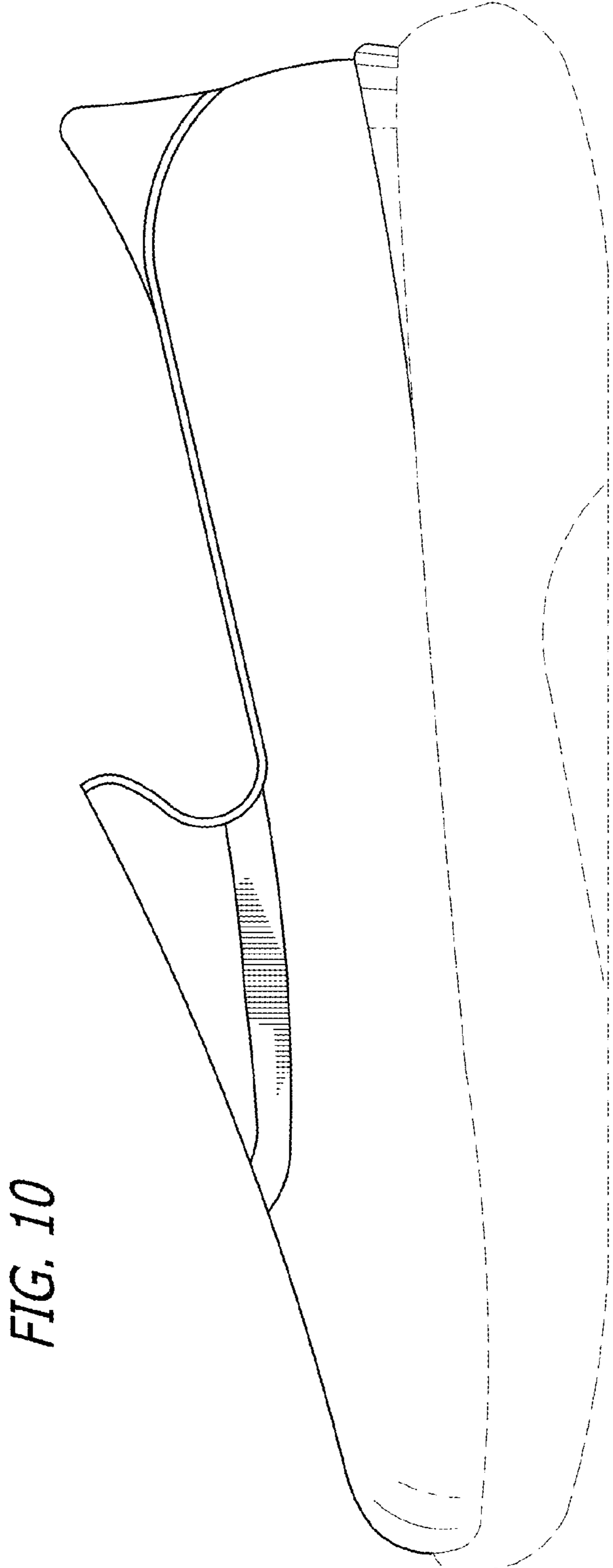

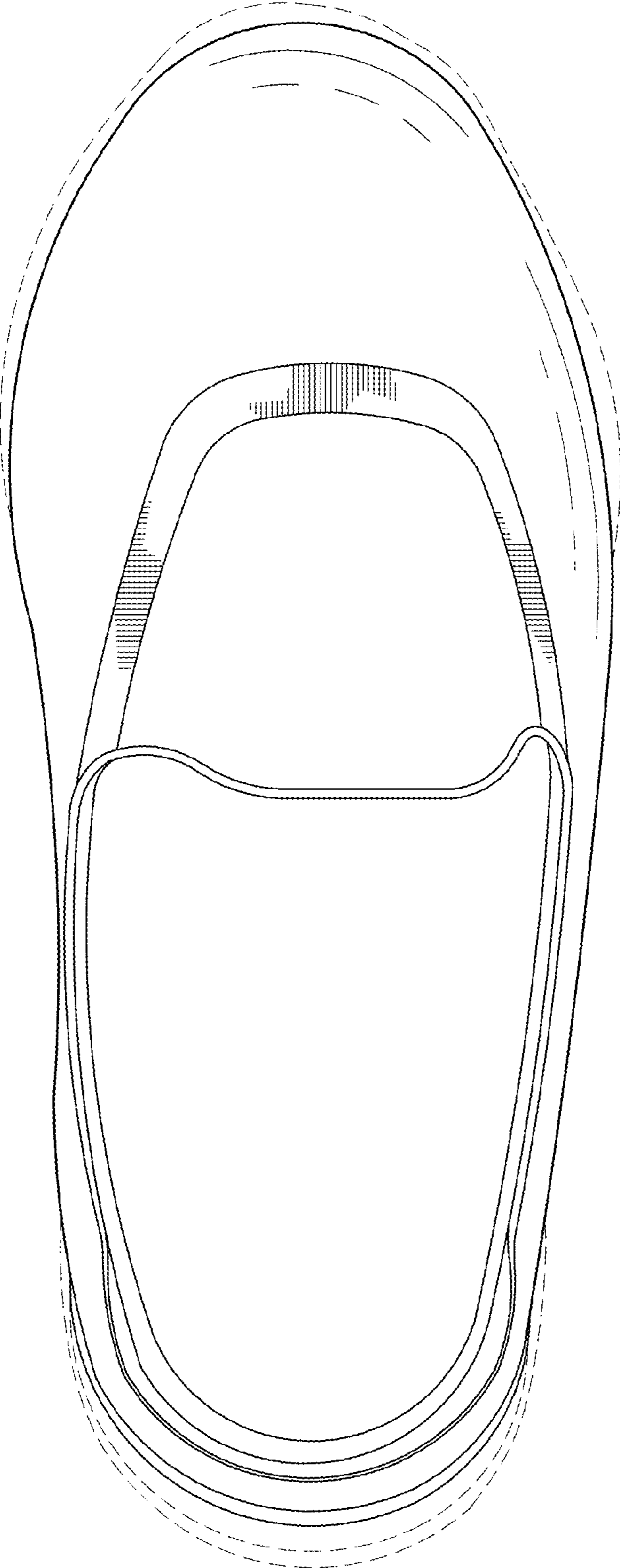
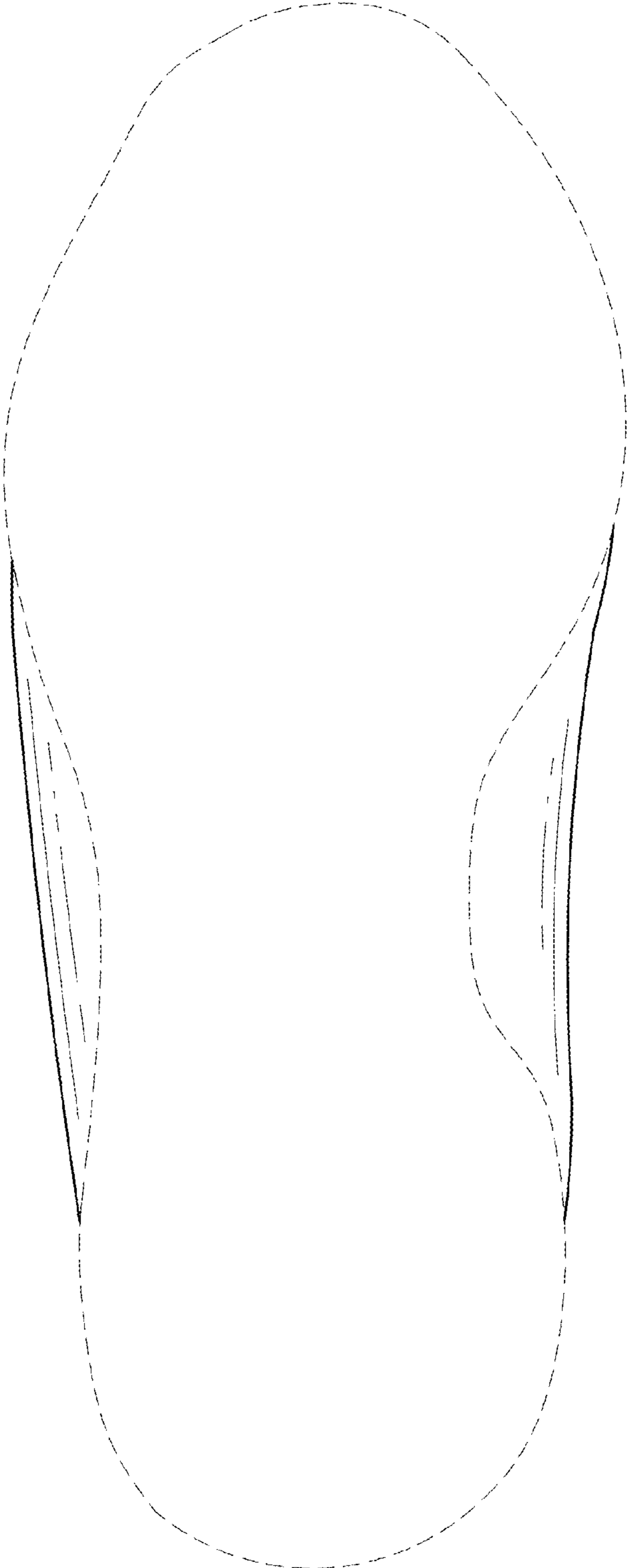

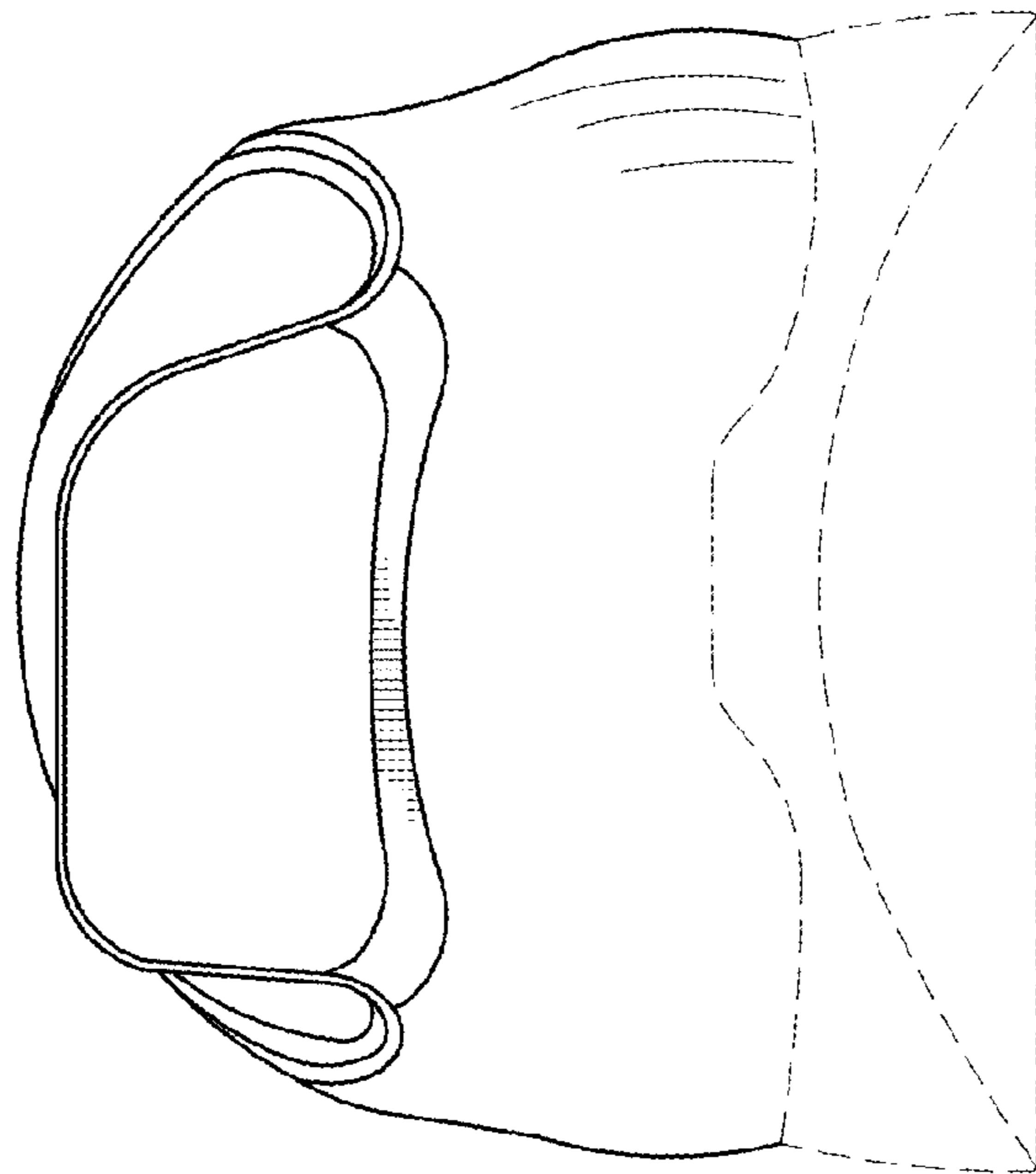

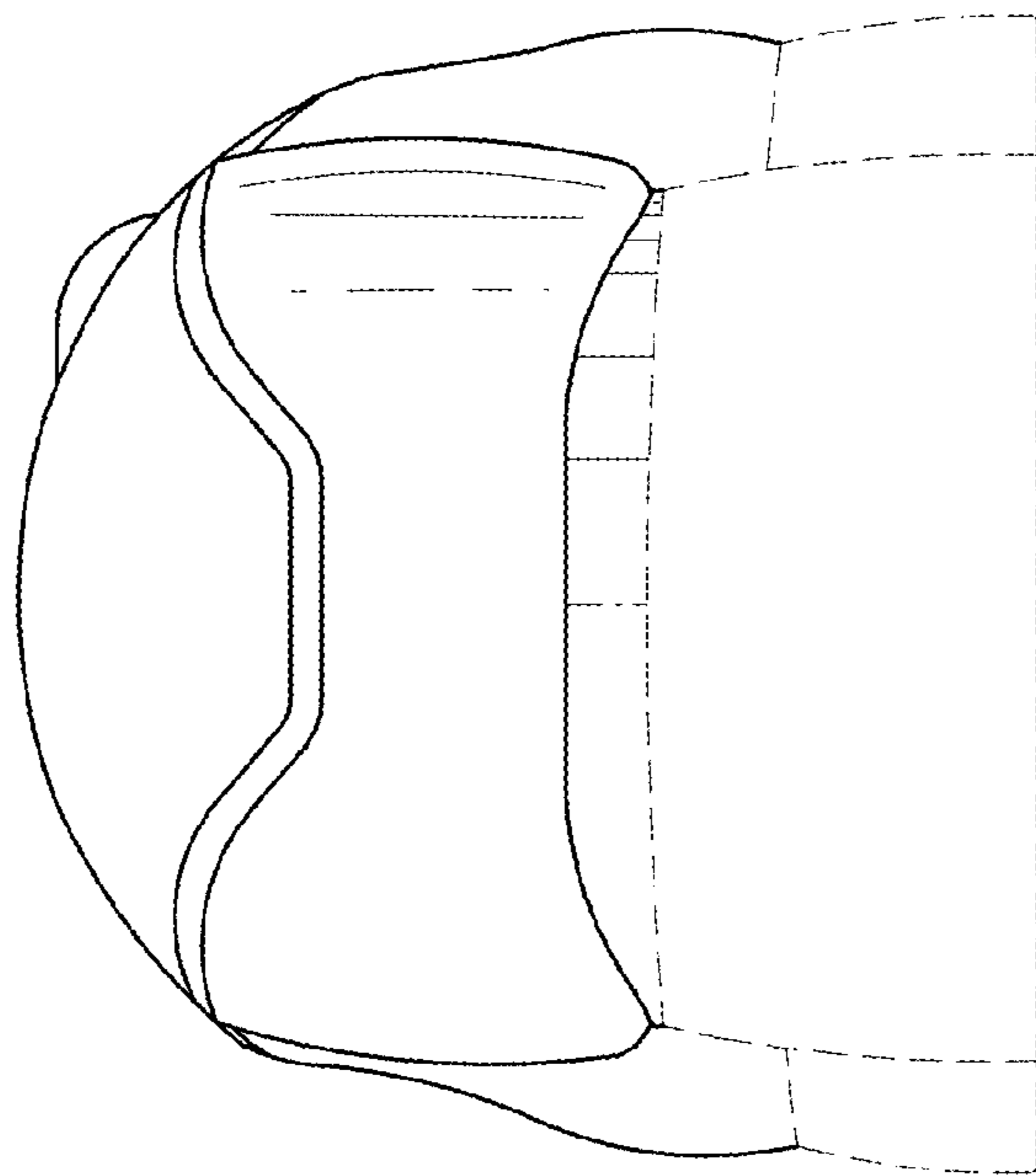
