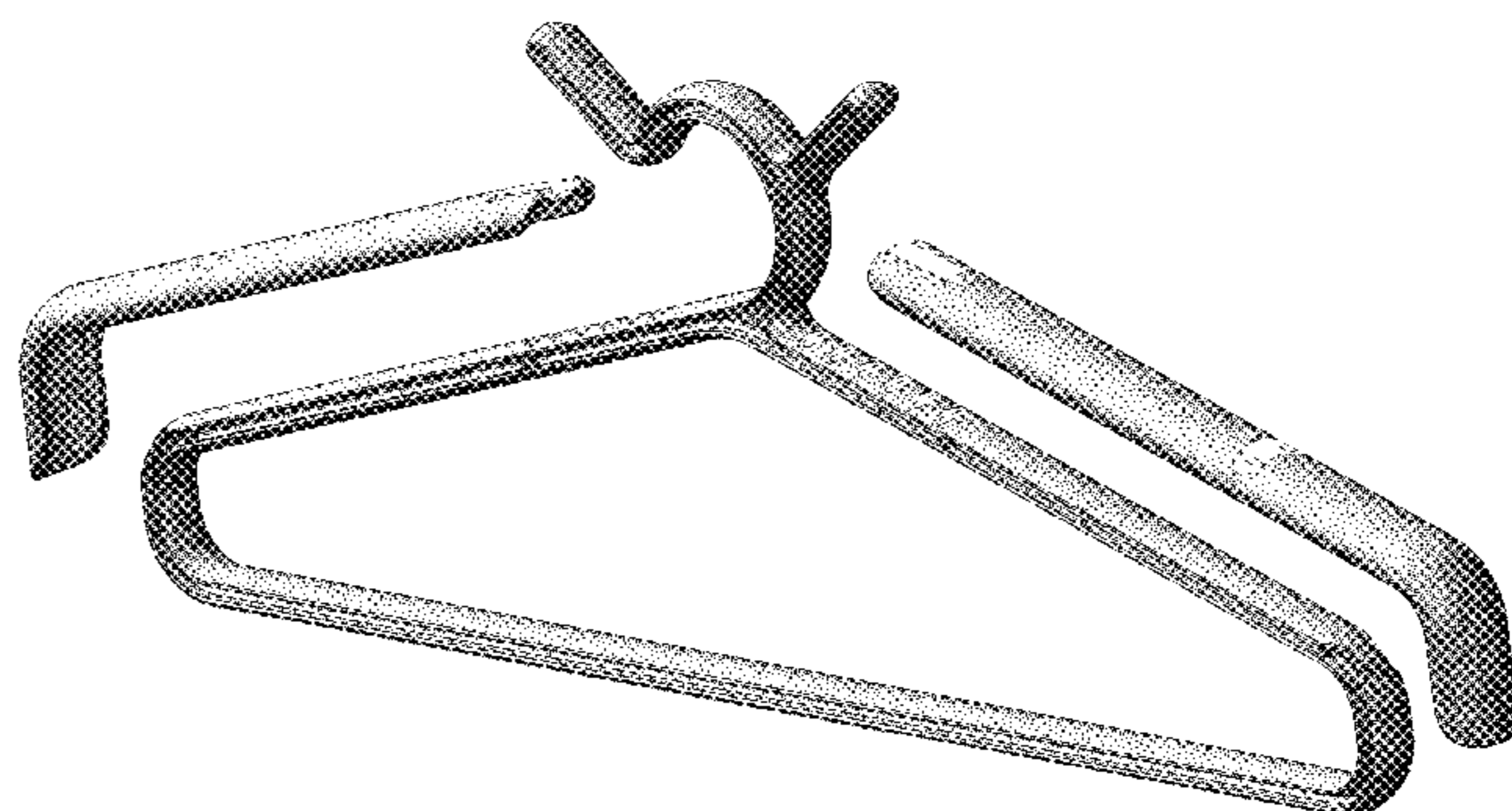
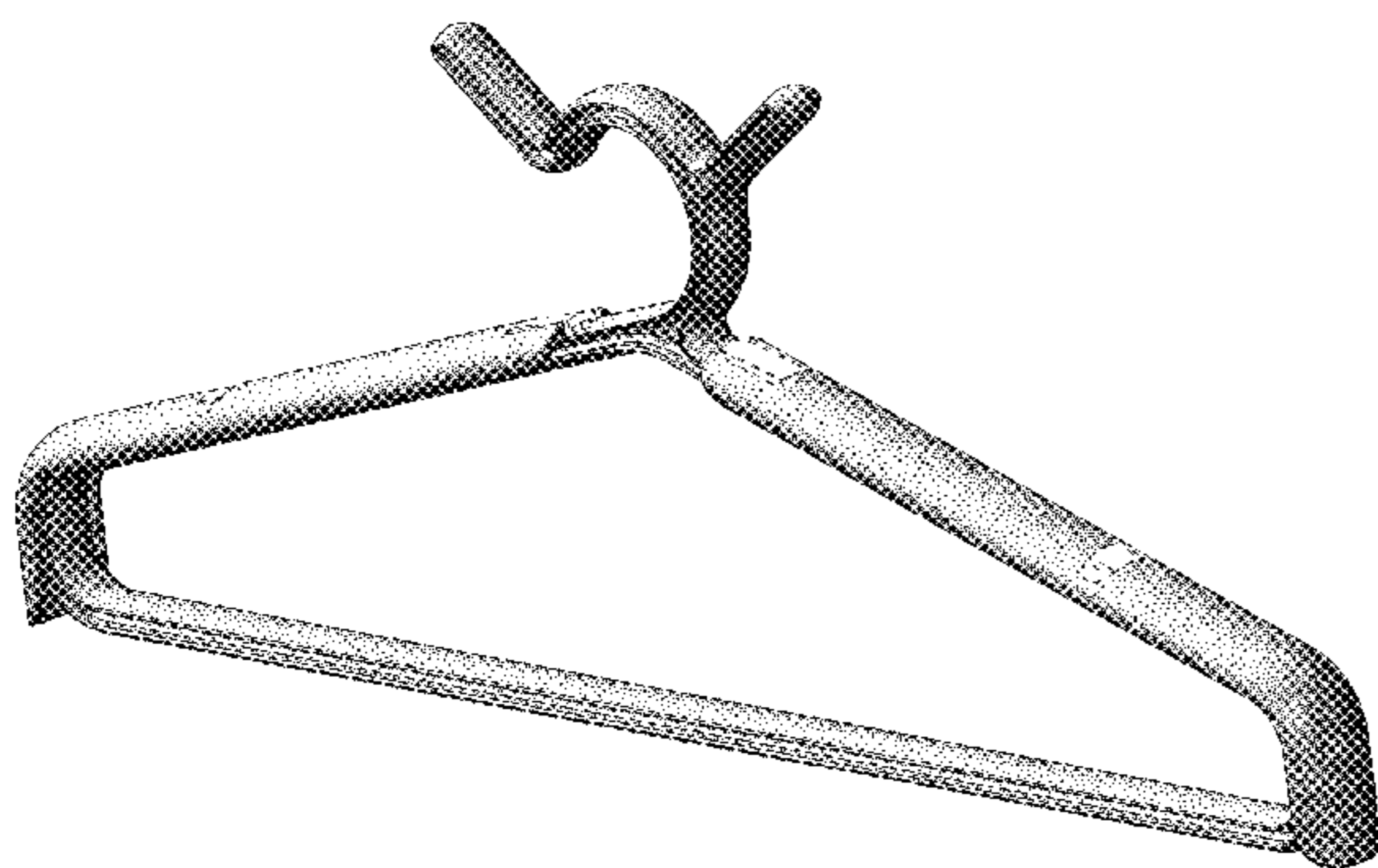
(57) **CLAIM**

The ornamental design for a hanger assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hanger assembly;
 FIG. 2 is one example of an alternate position of the hanger assembly from FIG. 1;
 FIG. 3 is an exploded view of the hanger assembly from FIG. 1;
 FIG. 4 is a front view of the hanger assembly from FIG. 1, the rear view being a mirror image thereof;
 FIG. 5 is a right side view of the hanger assembly from FIG. 1;
 FIG. 6 is a left side view of the hanger assembly from FIG. 1;
 FIG. 7 is a top view of the hanger assembly from FIG. 1; and,

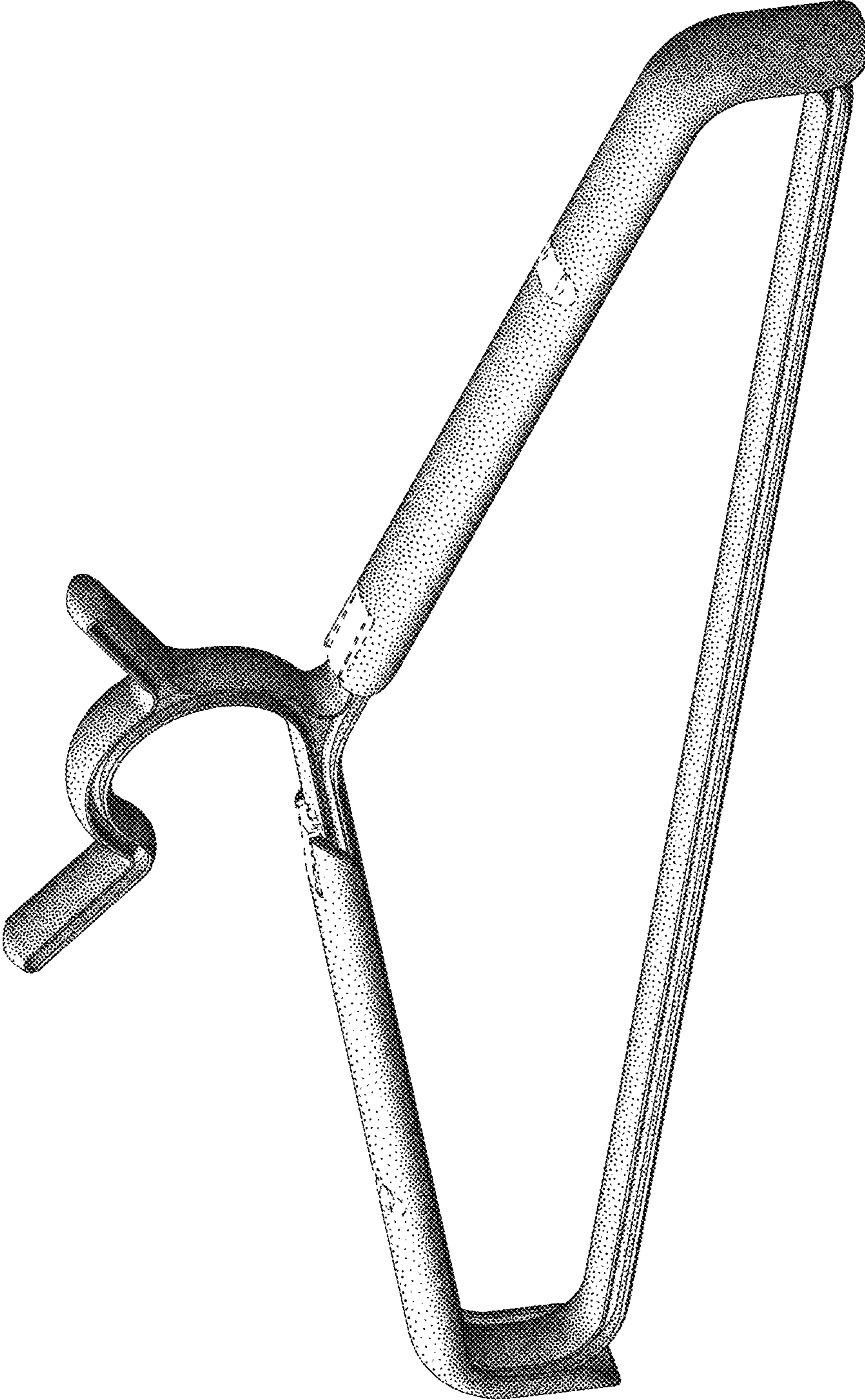

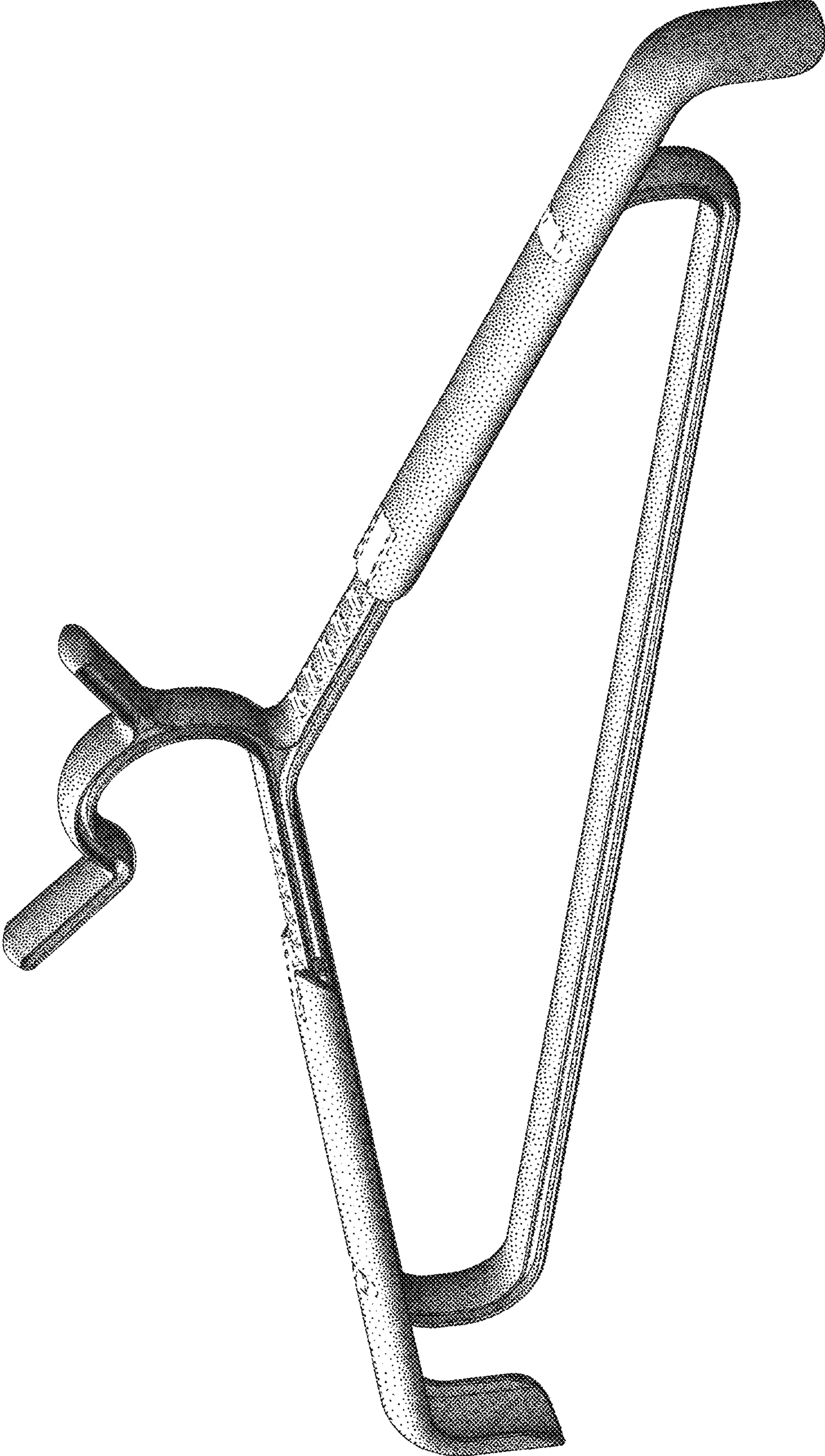

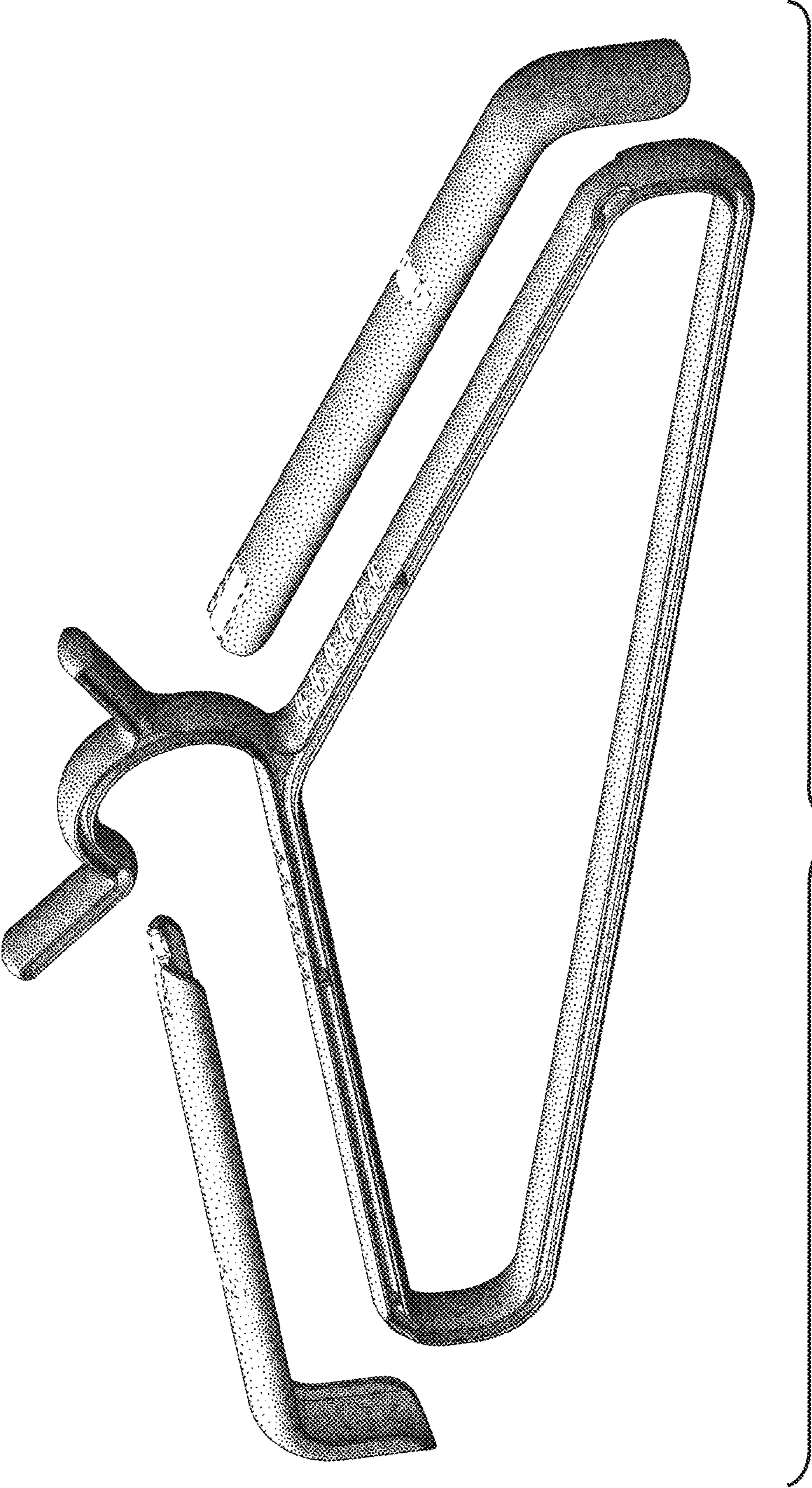

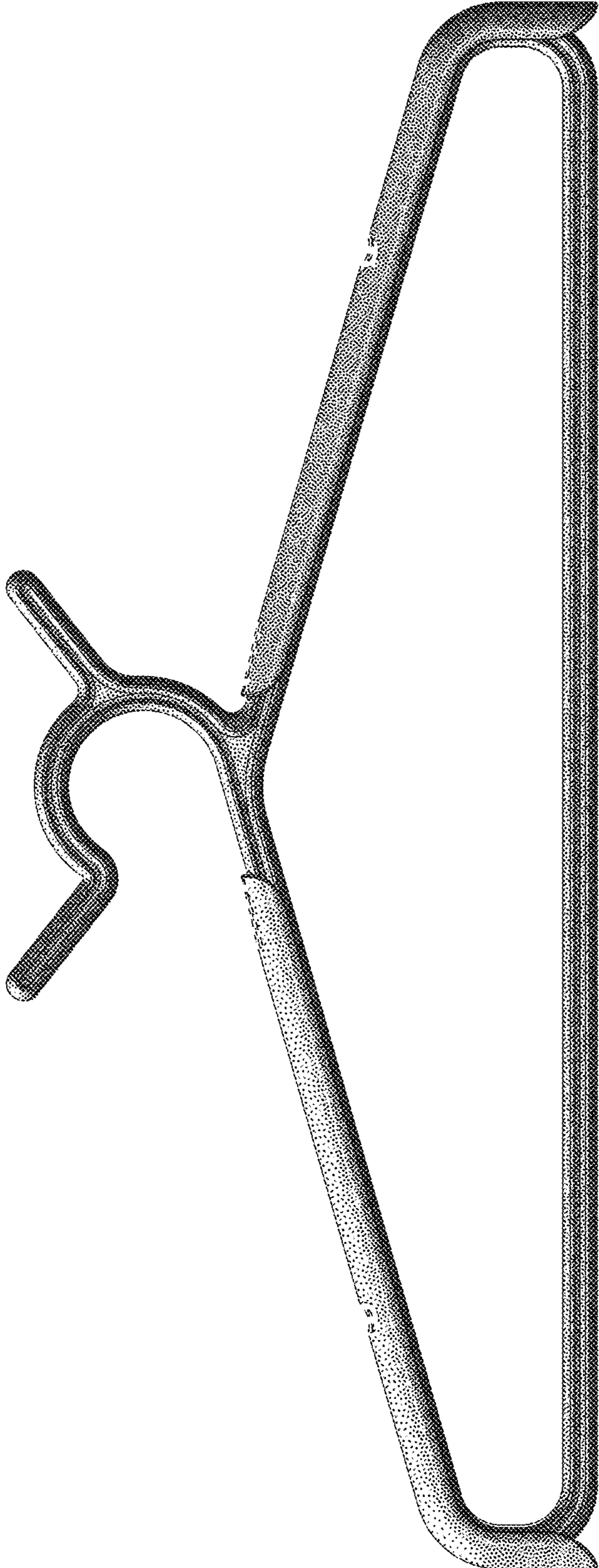

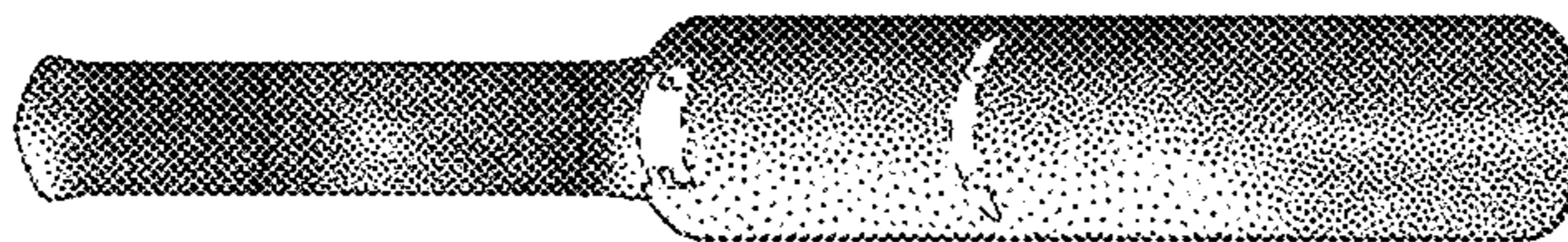

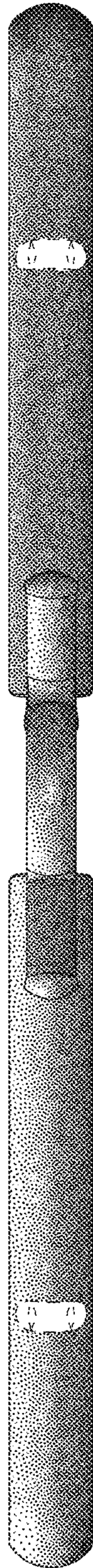

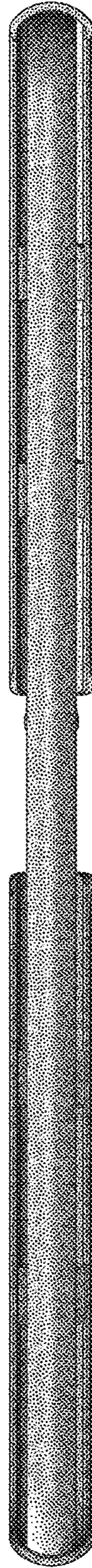
